"Look Magazine" Says America Shares Guilt In Death Of 6 Million Jews Monstrous Plot To Instill Guilt Complex In All Christians To Silence Opposition To Jews

Look Magazine of Nov. 4 carries another headline crying over the so-called 6 million dead Jews of World War II. (Authoritative sources have stated many times that nowhere near this number died in World War II. Most lived to emigrate to America where they are now in business.) But, for the sake of argument let us let that grossly inflated figure stand.

All thorough historians of Communist Russia say that during the implementation of that system upon the free people of Russia, at least 75 million Christians were slaughtered. Millions were the Kulak farmers who resisted the collective farm and were murdered by Khrushchev. The present premier Kosygin was the man in charge of Leningrad who sent 300,000 of that city's people to their deaths in Siberian concentration camps under Stalin. Hundreds of thousands of Volga Germans, White Russians, Latvians, Estonians, Poles and East Prussians perished at the hands of the Communists during World War II.

lion Christians murdered by the Communist beasts? Why is it that month in and month out we are brainwashed with the big lie of the 6 million Jews who are now living in Western countries getting rich off the sweat and blood of their Christian employees.

Could it be that to the big slick American magazines, 6 million Jews are more important than 75 million Christians who really did die horrible deaths? Where are the Christian ministers or politicians who should be reminding our president of crimes when LBJ is working to "build bridges to Russia?"

GUILT COMPLEX IMBEDDED INTO CHRISTIANS

Of course, the answer is obvious to the elite Jew-wise people. The present issue of Look takes the 6 million dead Jews to the ultimate hypothetical theory. The profession of psychiatry was founded by Jews. There are more Jewish psychiatrists than any other race. The Jews are the founders and masters of brainwashing.

A great delusion is being imbedded into the brain of Christians. IT IS THE GREATEST MASS GUILT COMPLEX HOAX OF ALL TIME! Look Magazine

in its Nov. 5 issue stated that not only were the German people guilty of exterminating Jews, but we Americans, too, are actual "ACCOMPLICES" to this 'crime' because we did not do enough during World War II to kill Germans and otherwise free the Jews more quickly. Jews have also viciously attacked Pope Pius the XII, saying he did not protest enough and stop the German persecution of the Jews.

According to LOOK, LIFE, and the POST and other Communist BODY is guilty of some involvement in the death of 6 million Jews.

Book Says U.S. Guilty In Deaths

A new book charging America with complicity in the deaths of 6 million Jews (a mythical figure created by the Jews) during World War II is now being widely publicized and quoted. The book is called, "While Six Million Died: A Chronicle of American Apathy" by the Jew Arthur D. Morse.

Morse is a former executive of CBS-TV, which is run by the Jew William Paley. He quotes Roosevelt's Treasurer Secretary, the Jew Henry Morgenthau as saying that "plain anti-Semitism" in our government withheld aid to Jewish organizations and Jewish refugees that could have saved many of them. Thus the book actually indicts Ameri-

ca with complicity in the fabled 6 million dead Jew hoax.

The World Jewish Congress is supporting circulation of this libelous book and states, "This book confirms a long-held belief." The book even goes so far as to quote the Jew Morgenthau as charging that American even "used governmental machinery to prevent the rescue of these Jews."

Look magazine has featured these charges in its Nov. 3rd issue, which is part of a continuing effort to plant a guilt and inferiority complex in all Christians so that they will forever subjugate themselves to the Jew in penance.

Morgenthau Wanted Destruction Of Germans

Henry Morgenthau, Jr. (Secretary of Treasury 1941-1954) was the most powerful Jew in the U.S. Government during World War II under Franklin Roosevelt. His writings throughout this period were for the destruction of Germany for all time to come after the war. He wanted all German industry dismantled and hauled away to other nations. All mines for coal and iron were to be destroyed. German males were to be hauled away as slave labor for other countries.

This information may have prolonged World War II by as much as two years. When the Germans learned what fate the Jews had in store for them, they decided to fight on to the bitter end -- and who could blame them. The Jews, through Morgenthau planned to leave Germany a divided and mutilated agricultural community which could never again rise to world prominence.

As part of this plan, Morgenthau sent his aid, Harry Dexter White, (real Jewish name Weiss) to work out a plan for a joint occupation currency with the Soviets. Weiss later gave the communists the paper, ink and money plates for our occupation currency. With this, the Russians printed untold billions of Marks.

This is why Russian soldiers could spend \$2,000 for a watch, or pay \$100 for a bottle of beer.

While Morgenthau's plans for the enslavement of all German males and the destruction of all German industry was disregarded after Roosevelt's death, his success in giving our occupation money plates to Russia accounted for the very slow economic recovery of Germany. The German people should remember that the Jews of the world still retain this violent hatred against them. For this reason Germany should turn down all of Israel's requests for economic aid and arms.

Sen. Joe McCarthy and many other Patriots later branded Harry Dexter White (Weiss) as a Soviet agent placed in our government. But records now show that all his actions were at the orders of Henry Morgenthau, Jr., our wartime Secretary of the Treasury.

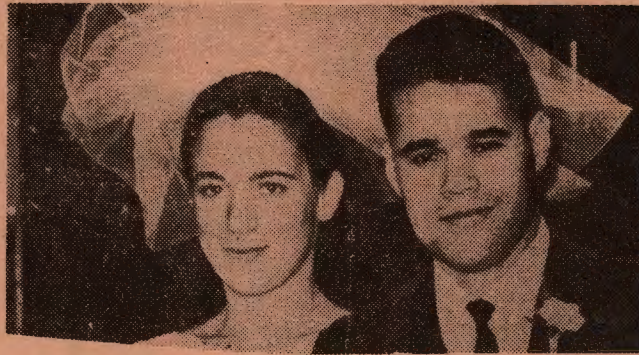
Catholics Especially Accused In 6 Million Deaths

The editor of "The Thunderbolt" have closely compared the pictures of negro Guy Smith (who married Dean Rusk's daughter Peggy) with pictures of him that appeared in the negro press. In the negro press Guy Smith looks as black as any other negro you see on the street.

But, on the cover of Time and in the newspapers his face looked White! There can be no doubt that his face was 'doctored' and made to look light to soften the blow on the public. The fact that the second most powerful man in Washington would give his daughter away to a nigger and allow him to come into his home and begin dating her when she was only 14 years old is clear proof of his perverted stand for the mongrelization and death of the white race.

Communist Party Endorses Carl Stokes

The Oct. 22nd issue of the U.S. Communist Party paper, "The Worker" came out strongly for the election of negro Carl Stokes as mayor of Cleveland, Ohio. They declared that all of Labor in that city was behind Stokes. This is the biggest lie we have heard all year. The truth of the matter is that his main opposition is from the White working class. The rich Whites voted for Stokes in the primary in an effort to appease the Black Power movement and to prove just how 'liberal' they are.

The rich know the negro cannot buy into their neighborhoods

or attend their private schools. They are willing to sacrifice their White middleclass brothers to negro terror in the streets so long as the business machinery of the Chamber of Commerce element moves ahead smoothly.

Money Makes Negroes Hate

The cry of the liberals, the federal government, and even this month's issue of the Jewish Anti-Defamation League Bulletin is that the more money and integration given negroes, the better they will like White people. The NSRP has long held that the more we do for the negro, the more demanding he will be and the more he will riot, kill, burn and loot.

A thoroughly researched report supporting our long expressed beliefs has been issued by Raymond J. Murphy and James M. Watson of the Dept. of Sociology at the University of Calif. The report says that the more negroes mix with Whites the more jealous and envious they become of the Whiteman. This hatred grows and eventually bursts forth in violent riots against White society. The following was quoted from news dispatch in the July 29th issue of "The New York Times" --

Most Negroes Live Life Of Crime

Despite all the Anti-Poverty handouts, most negroes still live a life of crime. The Washington Commission on Law Enforcement has issued a report which says that sometimes during their lives 9 out of every 10 negroes will be arrested for a non-traffic offense.

The 228 page report said that big city street crime was the greatest menace facing the American people today. It said that probably 90 per cent of all urban negroes will commit some type of crime during their lifetimes.

Since these shocking figures indict 90% of the negro race in America, we of the NSRP feel well justified in urging their deportation back to Africa. We believe that the negro is not capable of fitting in with a highly-civilized society. They are so inferior to the Whiteman and so far be-

hind us that they are now in full revolt to take from the Whiteman what they are not mentally capable of earning themselves.

The National States Rights Party would, upon assumption of political power, add an Amendment to the U. S. Constitution stripping them of their citizenship and ship them back to Africa. This would save the taxpayers billions yearly in poverty aid and other welfare now being wasted on negroes.

--But No Cry Over USS Liberty

When the Jewish Destroyer, Elath was sunk on Oct. 22nd, one would have thought it was an American ship when reading the U. S. press. The greatest outrage of our time has been the failure on the part of our government, and this nation's press to protest Israel's deliberate attack and murder of 34 American boys. The biggest disgrace of all was the suggestion by House Republican leader Gerald R. Ford of Mich., that we give the Jews a destroyer to make up their loss of the Elath. Mr. Ford, when are you going to demand an answer and reparations for the dastardly attack upon the USS Liberty?

POLITICIANS ARE CRINGING COWARDS

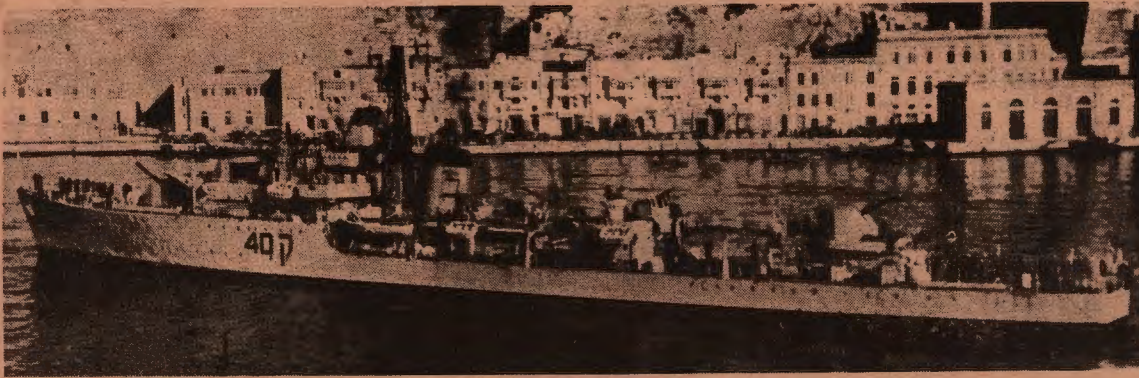
The cowardice displayed by our politicians in refusing to stand up to the Jews on the Liberty attack is beyond excuse. They are now only upset by the Egyptian sinking of the Elath. The arrogant Jews sailed this ship practically into the mouth of the Suez Canal in order to dramatize their power over the Arabs. The Egyptian Navy is to be congratulated on the sinking of the Jewish destroyer. They have a right and a duty to defend and liberate their lands from the hand of the Jew.

The reason our federal government is backing the Jews and turning against our traditional friends the Arabs, is because Jews now dominate Washington. It is because Washington is run by Jews such as Goldberg, Fortas, Katzenbach, Rostow, Goldstein, etc., etc. Needless to say there are no Arabs in our government nor any Christians with guts enough to stand up to the Jew power machine.

WHERE IS OUR VENGEANCE?

When the Elath was sunk, Israeli Prime Minister Levi Eshkol said, "The 50 seamen who perished on the Elath shall be avenged." Defense Minister Moshe Dayan sounded the warning, "We now know what steps to follow." The attack of the avenger came within 48 hours. The Jews attacked and knocked out Egypt's two major oil refineries which lie across the Suez Canal.

Last July the Elath entered Egyptian water and sank two Arab torpedo boats. Yet the Egyptians were not supposed to return any fire when the arrog-

ant Jews once again intruded in home waters. True to form Ambassador Goldberg finds that Israel can do no wrong and blocks any action against her in the U. N.

U. N. truce observer Lt. Gen. Odd Bull of Norway declared that the Jews once again were guilty of the truce violations in the shelling of the Egyptian oil refineries. He arranged for a cease fire (Egypt agreed) which was to go into effect at 3:30. The Jews continued shelling the Arab oil installations until 5:30 -- as usual flouting with impunity U. N. cease fire agreements. Gen. Bull said the Israeli officer in charge had informed him "communications were distorted and we could not confirm the cease-fire time." Despite Gen. Bull being right there to inform him of the cease fire time. During the Jewish attacks in June against her Arab neighbors, they always refused to honor cease fire agreements until their military objectives were conquered.

Yes, Israel achieved her vengeance for the sinking of the Elath, but when are we Americans going to get our VENGEANCE for the Jews' murder of 34 innocent young American boys? Gen. Moshe Dayan says he demands the Biblical "eye for

an eye" extraction for any opposition to his brutal and terroristic forces.

Then we Americans HERE AND NOW DEMAND RETALIATION AND VENGEANCE FOR THE MURDER OF OUR YOUTHS. If the Jews want this fight to be an "eye for an eye," we say let's give them what they are asking for.

MORE PROOF JEWS DELIBERATELY MURDERED THE MEN OF THE USS LIBERTY

It is ironic that just one day after the Oct. 22nd sinking of the Jewish Elath destroyer, a new

report on the USS Liberty attack came to light. On Oct. 23, the magazine "U. S. News & World Report" made the following news available:

"A classified report to the Defense Department, attributed to sources inside Israel, is described as stating that the U.S.S. Liberty, attacked by Israeli aircraft during the Middle East War, was clearly identified three hours before the assault."

This is the fourth such report we have published, all coming from highly qualified and respected sources. The Liberty was traced by Jewish jets for five hours before the attack. The weather was perfect and the extra large American flag was

visible for many miles. The jets first knocked out the ship's communications system. When it appeared the ship was now a guinea pig, unable to call for help, the Jewish P.T. boats came in for the torpedo attack. The Jewish planes killed six of our boys, while the torpedo boat attack killed 25 young men. In all the Liberty took 81 hits from the Jewish attackers.

An Associated Press dispatch from Malta quoted one of the survivors as saying: "We were flying the Stars and Stripes and it's absolutely impossible that they shouldn't know who we were. Israeli planes had kept us under surveillance before the strafing. This was a deliberate and planned attack and the remarkable thing about it was the accuracy of their air fire."

While the Jews have now extracted their vengeance, nothing is done to bring to justice the Jewish murderers of our men in Israel, which reach right up to Moshe Dayan. The American people are sick and tired of our Jew-kissing press weeping over the dead Jews of the Elath! When are they going to demand vengeance for our 34 murdered men of the USS Liberty? Let's bring this vital question up before the politicians and press and demand an answer NOW!

Secret Service Suspected FBI In Kennedy Assassination

Just before the Warren Commission completed its hearings Chief Justice Earl Warren stated to the press that, "There are certain aspects to this case which cannot be revealed during our lifetime." There has been much speculation as to just what secrets are still being withheld.

Most observers say it has to do with just who Lee Harvey Oswald was working for. We of the NSRP have long expressed the belief that there is a strong possibility that Oswald may have been a paid FBI informer.

It is known that Oswald received regular anonymous money orders via Western Union. That he infiltrated and attended meetings of right wing groups while being a member of the "Fair Play For Cuba Committee" at the same time. All this is in line with the operatives of an FBI pimp.

LOOK MAGAZINE CONFIRMS THEORY

On Oct. 3 Look Magazine came out with the review of a forthcoming book by the brother of Lee Harvey Oswald. Robert L. Oswald describes how the U.S. Secret Service suspected that the FBI might have had something to do with the assassination. Perhaps they had information pointing to Lee Oswald as a paid informer for the FBI --- this part is not explained in the interview. But, Robert Oswald does say:

"Despite our complete isolation, I began to realize there was some difficulty between the Se-

cret Service and the FBI. I heard the agents talking among themselves about this, using their nickname for the FBI agents, the 'feebies.'

"They were speculating over the reason for the absence of FBI men at Parkland Hospital where doctors tried to save Kennedy's life, and at the Inn." (Note: During the first two-day period following the assassination, FBI agents were banned from the Parkland Hospital area and the Inn where the Secret Service was protecting Oswald's brother, his wife, two children and his mother.)

"As early as Friday night, I had heard some speculation about the possibility of a conspiracy behind the assassination of the President. On Saturday and Sunday there were rumors in Dallas that the conspiracy might involve some government agency. By Sunday night, I realized that the agency under greatest suspicion was the FBI."

Robert Oswald also said that when FBI agents were finally allowed in to see Marina Oswald, they were extremely "hostile and because of their arrogance, she refused to talk with them" Actually this is their standard procedure of bulldozing anyone they question. It is a method of intimidation to try to obtain information.

We of the NSRP do not believe that the FBI ordered Oswald to shoot Kennedy so that Lyndon Johnson could become President,

or that any other such concoction took place. But we of the NSRP do know that the FBI hires as paid pimps the very lowest of people. They usually pick people with past criminal records, or those in trouble now (who can buy their way out of trouble by helping the FBI frame a political opponent. Teamster sellout Edward Partin of New Orleans has never been tried on the criminal charges facing him since he helped Bobby Kennedy frame Jimmy Hoffa to prison.) They also hire people who take dope, and dealers in pornography (an Atlanta case). Some of these people continue their life of crime, because being FBI pimps gives them protection and immunity against local prosecution (a Charlotte, N.C. case).

Therefore, it is very easy to assume that Lee Harvey Oswald was a paid FBI pimp. They couldn't control him and he killed President Kennedy. If this is how it happened, we can easily see why the Warren Commission would wish to conceal such facts during our lifetime. Yet, we believe that such news cannot forever be suppressed. When it does surface, it could help us break up the system of using criminals as paid pimps to spy upon LBJ's political opposition.

"Time" Admits Elath Guilty

The November 3 issue of Time magazine carried the news of Israel's brazen provocation which led to the attack on the Elath. Said Time: "For more than a day, the destroyer (Elath) had been zigzagging back and forth in the bay of Romani, a niche in the Mediterranean at the entrance to the Suez Canal. In the knowledge that it was being tracked by radar from nearby Port Said, it alternately sped up and slowed down, darted from time to time into Egyptian territorial waters and then backed out again. It did almost everything but stick out its tongue."

Egypt rightfully sunk this enemy intruder, yet the U. S. Press and politicians are shedding many a tear over the poor persecuted Jews who lost 50 on the sunken Elath.

The Death Of A Wealthy Girl

Linda Fitzpatrick was only 18 years old. She was the daughter of very wealthy parents and lived in exclusive Greenwich, Conn. Linda attended the best private schools and her teacher described her as "a normal girl who never caused trouble."

All her shielded life she had been taught by her minister and teachers that negroes were as good as White people, if not better. Her entire family were confirmed liberals. For this reason Linda Fitzpatrick had no qualms about visiting New York's scummy East Village area where the Hippie community lives. She met a young mis-guided White youth (a dope addict) who took her to 26 year old negro Donald Ramsey's Hippie pad. Over the entrance to his basement room were the words inscribed in the wall, "Enter Here For Free Love." Miss Fitzpatrick never left alive. Three negroes were down in the basement, all high on dope. The next morning police found her body and that of the White boy horribly bludgeoned to death. They were nude and she had been raped several times. Not long after that the three negroes were arrested. They

claimed they could not remember what had happened because they were high on an LSD trip. When will parents learn to keep their sons and daughters away from negroes. Yes, they are 'different' from White people, and very dangerous to associate with. When they are drunk or doped they are especially dangerous.

On this page we reproduce a very interesting article on the shooting of Leroy Harrison, 20, by Mrs. Laura E. Daniel, age 61 in St. Louis. Mrs. Daniel lived in an integrated neighborhood and saw that the Black buck Harrison was constantly after her daughter. He would follow the 17 year old Miss Daniel and try to date her on every occasion.

One day Mrs. Daniel told the brazen black buck, "If you bother my daughter any more I will kill you." The negro just laughed! A few months later the frightened blue eyed daughter admitted she was pregnant. She then told her mother the truth. They tried to obtain an abortion, but she was too far along.

When the baby was born it was as black as the ace of spades. Having seen her daughter destroyed, Mrs. Laura Daniels picked up a .38 and walked over to Leroy Harrison's home at 331 Lithia Ave. Harrison was sitting on the front steps and immediately remembered her threat to kill him. But he apparently did not take her seriously because he laughed and said: "Well, I guess this is it. How about giving me time to make funeral arrangements for myself?" The grin on his face became frozen as he noticed Mrs. Daniels hand reach into her purse and come out with a .38 special automatic. She then coolly pumped three bullets into Harrison.

Daniels was rocked by the blasts against the house steps and rolled to the ground. Mrs. Daniels then calmly walked to a phone and turned herself into the police. This shooting took place the day after her beautiful blue eyed daughter had given birth to a black, kinky haired animal. Mrs. Daniels was released the next day under a \$5,000 bond. Harrison lingers near death at this writing. No one believes that any jury will give this poor distraught woman any time.

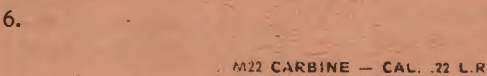

Jew Leaves Millions To "Daily Worker"

It came to light on April 7th that the will of Harry Herman Kaplan of New York City left over \$2 million to the Communist Party newspaper, "The Worker." The money was left in the name of the Jewish intellectual leader of the Communist Party, Herbert Aptheker. It should be noted that the editor of "The Worker" is the Jew Carl Winter.

In order to make this gift, Kaplan cut off his brothers and sister without a cent. They are Louis, Abraham and Max Kaplan and sisters Mrs. Solomon Azbinsky and Mrs. Jacob Rosenbers. His will was drawn up by Atty. Samuel A. Neuburger. He often defends communists, including accused atom spy, Judith Coplon (also a Jewess).

Mrs. Jessie Kaplan was left several million also and said she supports the leaving of millions to "The Worker." It has always interested this editor, that millionaire Jews can support Communism. It was the New York Banker Jacob Schiff who gave the Jew Leon Trotsky some \$30 million to overthrow the Czar of Russia and establish Communism. Jews know that their people control Communism and that this is how their race will eventually gain World Power. Communism is a Jewish movement to mongrelize the White race and wipe out Christianity. Read the "Protocols" advertised on the back page of this paper (\$1 per copy) and you will have your eyes opened for the first time. It exposes secret connections between world communism, and international Jewry.

DEMAND ELECTED OFFICIALS PROTEST

More of LBJ's illegal voting registrars have been sent into the South. One of the first acts of ultra-liberal Attorney General Ramsey Clark was to send voting registrars into Georgia, Louisiana and Mississippi. Lyndon Johnson is in great fear of losing these states to Gov. George Wallace next year and is pulling out all stops in his drive to pack the voting rolls with negroes.

The federal registrars were sent into the Georgia counties of Lee, Screven and Terrell and the Louisiana Parishes of Bossier, Caddo and Desoto. Mississippi counties invaded were Amite, Franklin and Okibbeha. Ramsey Clark said their goal was to register some 50,000 negroes in these districts. FBI guards were provided the registrars to protect them from enraged White citizens.

A South Georgia congressman charged that the federal voting registrars were discriminating against White people. He said that the voting registrars were being installed in vacant store fronts in the middle of all-negro neighborhoods. This makes it easy for negroes to walk over on their way to the store and sign their "X" and become registered voters. The federal voting registrars keep late hours for negroes who might actually hold down jobs.

Whites have to take off during working hours to go to the county courthouse during very limited hours to register to vote. The Georgia congressman said that voting registrars should likewise be installed in the middle of all White neighborhoods so that White working people can register just as easily as the negro.

But Atty. Gen. Ramsey Clark, LBJ, Katz & Goldberg are only interested in registering vast numbers of Black bloc voters. Ramsey Clark says that by the 1968 elections there will be some

one million more negro voters registered in the South than in election of 1964. This entire anti-White plot is aimed against the four Southern states that bolted from the Democratic Party in 1964 and went for Barry Goldwater.

LBJ and his cohorts have vowed that this will not happen again. This is the reason the Civil Rights Bill only applies to La., Miss., Ga., and S. C. The fact that present politicians now in office are not vehemently protesting these additional federal voting registrars is a disgrace to their states. (We are speaking of Ga., Miss., and La. where the new voting registrars have been sent.) White people living in these areas should immediately telephone, wire or write both their senators and local congressmen and demand that THEY protest.

If they do not raise the roof in Washington with LBJ over this new reconstructionist aggression - WE WILL BE IN FOR EVEN MORE OF THESE FEDERAL CARPETBAGGERS! In fact, Martin Luther King has served notice on LBJ that the present federal voting registrars are not enough. He says many negroes are 'too tired' to walk over to the neighborhood store front to sign their "X". He says that the federal voting registrars should go door to door and visit every single negro living in the area. Of course, this special program would not be available for Whites.

STOP THE FEDERAL RECONSTRUCTION

The only way we can stop the devilish federal reconstruction is not to let up. Resistance must include our loudest, strongest - CONTINUOUS protest against this federal intrusion upon the rights of the sovereign states. LBJ and his mobs of Jews and negroes hope that we will forget about the presence of these voting registrars and let down our guard. This is what they are waiting for.

Let's stand up now, openly and publicly, and oppose these voting registrars. Let's let the people of our state and nation know that we will stand like our forefathers against this insidious attempt by the federal government to install Black Power over the White people of this nation. Our forefathers gave their lives so that we might be a White race of people today. We must re-dedicate ourselves to the right to save America from the foul and satanic mongrelizers in Washington.

Local federal voting registrars must not be allowed to do their dirty work unnoticed in our communities. We must awaken our fellow White Brothers to the need for action during this dark hour of our people. We advocate the public picketing of federal voting registrar offices - even in the middle of negro areas. This will point out their presence to the Whites and gain publicity for our drive to rid the South of these vipers. This fight must not be allowed to lag. Join the NSRP and help us to oppose with every means at our command these carpetbagging invaders from Washington. Let's work to send all of them back where they came from as soon as possible. Let them know that we KNOW who they are and that they are not welcome in the South.

Peace Prize Winner King Demands War On Rhodesia

UNITED NATIONS, N.Y.,

April 3 —American Negro leaders called today for military action to overthrow the white-minority government of Rhodesia and said the United States should press Britain "to bring the rebellious racial regime to heel by force."

If Britain fails to act, the Negro leaders said, the United States should urge the United Nations to adopt "appropriate measures of military action designed to overthrow the Smith regime."

The proposals were made in a resolution adopted Jan. 28 in Washington by the American Negro Leadership Conference on Africa and made public today.

Over 40 Groups

The conference is made up of more than 40 organizations, including all the major civil rights organizations. Participants in the conference included Martin Luther King, who has frequently criticized the U.S. military presence in Vietnam; Roy A. Wilkins, A. Philip Randolph and Whitney M. Young Jr.

The government of Prime Minister Ian Smith unilaterally declared independence of Britain Nov. 11, 1965. British efforts to bring down the government and guarantee a representative voice for Rhodesia's black majority have been fruitless. The U.N. Security Council last December imposed economic sanctions on the territory.

Watson Hits UN Sanctions On Rhodesia

By A Special Correspondent

WASHINGTON — Rhodesia is being made the victim of a "preposterous and hypocritical double standard" by its foes in the United Nations, Rep. Albert W. Watson charged here Wednesday.

Some of the same nations most loudly accusing that South African nation of "racism," the Columbia Republican said in a floor speech, are either themselves practicing actual slavery or winking at the practice by others.

Enslavement still exists in a large percentage of the newly-emerging African nations, Watson asserted, but said the U.N. allows the fact to go unnoticed and unchallenged while it presses economic sanctions against Rhodesia.

The racist charge against that nation is in itself "pure rubbish" the South Carolinian further said, contending that Rhodesia has provided a stan-

dart of living and educational advantages for both black and white unequalled anywhere else in the continent.

It also has the most stable government under Premier Ian Smith, Watson continued, while at least ten African countries now claiming it is a threat to peace, have themselves been taken over in military coups within the past two years.

In detailing his defense of the country, Watson renewed his demand for withdrawal of UN sanctions against it and for the United States to end its support of such "illegal" action in any event.

He warned that if that is not done "we could find ourselves in the middle of an African war that would make Vietnam look like a Sunday School picnic."

Recognition of Rhodesia's independence, he said, is right from both moral and practical viewpoints.

LBJ Appoints Two ADL Jews Federal Judges

Here is more news which justifies the NSRP demand that federal judges be ELECTED by the voters in their district - NOT APPOINTED TO LIFE BY A FANATICAL PRESIDENT WHO ACTUALLY IS A RENEGADE WHO HATES HIS OWN RACE.

In two separate actions Lyndon Johnson has appointed the Jew Myron L. Gordon of Madison, Wisc., (a member of the national board of the Jewish ADL) as a federal judge. He also appointed the Jew Alvin Rubin of Shreveport, La. (a member of the ADL South Central regional board) to a federal judgeship.

Readers should keep in mind that the ADL is the political action arm of B'nai B'rith. The ADL is dedicated to the mongrelization of White Christians with the Negro race. While only 2,675 whites were arrested for criminal homicide, there were 3,704 colored gentlemen; white robbery arrests totaled 16,586, but negroes topped this with 22,546; the statistics show 12,643 white arrests for prostitution, but the colored ladies did a lot better with 17,598 arrests; there were 19,842 white arrests and 64,135 negro arrests for gambling. Figures for other crimes could also be quoted. Does this not prove that the black man is superior in such occupations, especially when he is only 12 percent of the population?

The largest city in the world is now in a grip of terror! And the terror is none other than the "easy come, easy go" boys of our first class citizens. Mayor Lindsay is talking about providing auxiliary police and volunteer youths to escort women and the elderly to and from church services. The Department of Housing and Buildings is making plans to try to reduce the incidence of the ever-increasing crime rate. They will enforce such regulations as those requiring lights at entrances, in buildings, and yards; peepholes in apartment doors; mirrors in elevators, etc.

These are the fruits the people of New York are harvesting as the result of electing misfits to public office.

The radical decisions of the U. S. Supreme Court seem to indicate that a black skin is a license to commit crime; e.g., in a New York case of January 20, 1967, where a black rapist who admitted stabbing two men to death, had both charges dismissed because of the decision that a suspect must have the right to legal counsel before interrogation. Charles Wright, 23, 554 West 150 Street, New York, a cook at Columbia University in a 41-page confession told how he stabbed one victim 18 times, and the other 32 times, and how he raped eight other women. On January 9, 1965, Gertrude Mason, 41, of 47 Fort Washington Avenue, and on May 21, 1965, Pauline Lubetsky, 54, (Continued On Page 7)

BOSTON JEWRY AGAINST NON-SECTARIAN SCHOOL PRAYERS

BOSTON (WNS)—A resolution by the Massachusetts legislature calling on the Congress of the United States to amend the Constitution of the United States with the view of "permitting the recital of a non-sectarian prayer in our public schools" has met sharp opposition from Jewish circles. Opposition to the proposed resolution was voiced here jointly by the local branch of the American Jewish Congress and the Boston Jewish Community Council.

URGE SENATE APPROVAL OF CONSULAR TREATY WITH SOVIET

NEW YORK (WNS)—Senate approval of the pending consular treaty with the Soviet Union was urged here this week by the American Jewish Congress and the American Jewish Conference on Soviet Jewry. The two organizations made their views known to Senator J. W. Fulbright, chairman of the Senate Foreign Relations Committee. Both groups stressed that approval of the treaty would, in addition to serving American interests, also facilitate efforts towards the implementation of the recent assertion by Soviet Premier Alexei Kosygin about permitting reunion of Soviet Jews with families abroad.

76,000 JEWS SETTLED IN CANADA SINCE END OF WAR

MONTREAL (WNS)—Disclosure that some 76,000 Jews came to Canada since the end of the war, most of them settling in Montreal and Toronto, was made here by the Canadian Jewish Congress in testimony by one of its officials before a government immigration committee. Testifying before a federal Senate-Commons immigration committee studying the Government's White Paper on immigration, the executive vice president of the Canadian Jewish Congress, Saul Hayes, simultaneously revealed that Canada was now harboring at least six major Nazi war criminals. Mr. Hayes told the committee "we know of at least six major cases where people who were arch war criminals entered Canada," adding that "once they become citizens they are innocent no matter how heinous their crimes."

HUNGARIAN GOVERNMENT HONORS JEWISH LEADER

BUDAPEST (WNS) — The Order of the Knights of the Cross was bestowed here by the Hungarian Government on Dr. Geza Seifert, chairman of the Jewish Communities in Hungary.

Jewish Parents Urged to Step Up Aid to Negroes

Women's Council Head Wants Youth Given an Example

ATLANTA, April 9 — The head of a major national women's organization said today that unless Jewish parents intensified their fight in behalf of the American Negro's struggle for racial justice and

economic opportunity, "their children may be lost to Jewish life."

Mrs. Joseph Willen of New York, president of the National Council of Jewish Women, said "When we teach our children Jewish ethics and then they see us helping to make it hard for a Negro to move in down the street, they learn not to respect us or our values."

Addressing 1,000 delegates at the opening of the council's biennial convention at the theatre Atlanta, Mrs. Willen, in an appraisal of Jewish participation in the civil rights movement, said American Jews were not doing enough to obtain equal opportunity for the underprivileged.

Warns of Loss of Respect If Bias Is Practiced at Home

She said that, like other Americans, Jews were "meeting their obligations through tokens: statements, speeches, proudly pointing out that the rabbis stood on a picket line." In the meantime, she said, "we flee from neighborhoods that begin to be integrated and we pull our children out of desegregated schools."

Later in an interview Mrs. Willen said that last year Jews were part of a general retreat from civil rights efforts.

"She warned that Jewish youths were leaving the organized Jewish community to work outside to help underprivileged people achieve equal opportunity.

"We cannot," Mrs. Willen said in her address, "try to close the door on an open society in order to keep them Jewish. But we can and must do more to prove the worth of the Jewish ethic in this society. Our children ask us to look forward, not backward. We cannot bind our young people to us by reciting past persecutions."

She appealed to the organized adult American Jewish community, including parents,

to set an example for Jewish youth by intensifying efforts in behalf of increased employment for Negroes and to aid antipoverty programs. She said this was the best way to combat white backlash.

Her own organization, she said, "brings Judaism up to date by helping people who need help."

This tradition, Mrs. Willen said, dates back to before the turn of the century when council women were helping immigrants.

"Today," she said, "many Negroes find themselves in the

Stand Hurts U.S. Image, Jews Told

ATLANTA —The chairman of the National Community Relations Advisory Council said Tuesday the U.S. image as "international champion of human rights is tarnished" by refusal to ratify United Nations Conventions against genocide and slavery.

Aaron Goldman, in a speech to the annual convention of the National Council of Jewish Women, asked, "Was there ever a nation so great in power and resources that seemed less able to exert its leadership for the benefit of humanity?"

He criticized the U.S. for not adopting the U.N. conventions on genocide, against slavery, forced labor and for the protection of women's political rights.

He blasted the use of public funds for private and parochial schools under the Elementary and Secondary Education Act. The act allows federal funds for certain private schools on the basis that they are helping children.

"I am sorry to say," Goldman commented, "that experience under the act suggests that the non-public school beneficiaries are laying the groundwork for still larger claims to public funds.

The child-benefit principle is almost infinitely expandable," Goldman said.

He said public money should not go to private schools because public institutions were "already in desperate straits" and need the funds.

Goldman said Jews played a significant part in securing laws for Negroes that guaranteed equality. But he said economic conditions prevented Negroes from actually getting into the mainstream of American life.

"We raised the expectations of American Negroes," Goldman said, "only to leave them frustrated, angry, and desperate as those expectations have failed to materialize."

same position as those immigrants. The same tzedakah [charity] which taught our ancestors to help the Jewish girl is now motivating us to help other girls in need."

1,000 Community Services

The National Council of Jewish Women, a 74-year-old educational and service organization, sponsors more than 1,000 community services for youth, the aging and the handicapped as well as a broad public affairs program for members.

In a message to the convention, President Johnson praised the council's members as "steadfast allies in the war on poverty and vigorous partners in support of the Job Corps." The message was read by Mrs. Leon Marantz of South Orange, N. J., the convention chairman.

Rabbi Discloses Study Findings

'Hatred Of Jews Has Source In Churches'

Rabbi Morris Feldman Friday night told members of Temple Israel a new, scientific study contains proof that the source of hatred and violence directed against Jewish groups may be found in the basic teachings of Christian churches.

He said the study by Charles Y. Glock and Rodney Stark, of the Survey Research Center, University of California, was financed by the Anti-Defamation League of B'nai B'rith after violent outbursts of anti-Semitism in the U.S. only 14 years after the defeat of the Nazis.

"RESULTS OF THE study are shocking," he said, explaining that the book, "Christian Beliefs and Anti-Semitism," indicates that orthodox or fundamentalist Christian groups are the most prejudiced.

Rabbi Feldman said Christian orthodoxy sees its beliefs as the "only" religious truth and when missionary zeal is rejected, a "latent hostility is activated in overt acts of hatred and violence."

He pointed out that not all Christian churches accept this approach nor are all equally guilty of anti-Semitism.

IN COMPILING the report, investigators asked for agreement, uncertainty or disagreement with the remark: "The Jews can never be forgiven for what they did to Jesus until they accept him as the true saviour."

Congregationalists had a low of only ten per cent agreeing while Southern Baptists had 80 per cent agreeing. Catholics responded with 14 per cent agreeing.

The rabbi said general reaction to the book has been mixed. Some found the conclusions convincing, others rejected them, while some saw it unfortunate

that Jews are sponsoring such research since it can only aggravate the situation.

JAMES F. ANDREWS, Notre Dame, Ind., wrote, in part, "We accept their findings and will do everything possible to insure that Christians receive the full Christian view of the Jew and his religion . . ."

Everett Tilson, professor of Old Testament at the Methodist Theological School in Ohio, said there will be wide debate over Glock and Stark's findings.

Rabbi Feldman said Southern Baptist leaders called a special meeting—"an agonizing session," in which many denied the denomination is as prejudiced as the book indicates or that anti-Semitism even exists.

"YET IT WAS evident that a number of influential Southern Baptists are deeply troubled about the book and anti-Semitism, and some of them said so," he stated.

According to Rabbi Feldman, Tilson says the study painfully lays bare the virus of anti-Semitism can and is being spread here and now — "not in spite of Christian teachings but because of it."

He also stated that the book has made an "impressive" impact on fully understanding religious sources of hatred and asked Christian churches to "rise to the challenge which faces them."

of 600 West 162 Street, were both killed in the early morning in the elevators in the buildings where they lived. In 1960, Wright was convicted of assaulting a woman with a knife, served time and was paroled.

On January 30th, ten days later, two black men, Marvin Fitzgerald (eight previous arrests), 35, and Billy Bunche (six previous arrests) 27, both of New York's Harlem, were freed in the same court for the same reason. They were indicted on first degree murder charges on February 14, 1966 in a shooting during

a robbery, of Moritz Weiss, a clothing store owner at 48 Avenue C.

The Court's ruling that a prisoner be informed of his right to counsel was handed down on June 13, 1966. It was hailed by the liberals as progressive, and by the criminal element as an aid to crime. Our first class citizens shouted "Heil, the Supreme Court."

NEGRO IS PAWN, FIELDS CHARGES

Party Editor Speaks to States' Righters

The editor of the official newspaper of the National States' Rights Party, "The Thunderbolt," said in New Orleans Sunday that the Negro is a pawn in the hand of a Jewish chess player who seeks equality for himself.

Dr. Edward R. Fields, a chiropractor from Savannah, Ga., and Thunderbolt editor, was in the city to speak at a meeting of the New Orleans chapter of the NSRP at Holsum Cafeteria.

He told the group that Communists and Jews propose race mixing in order to upgrade Negroes.

"Unfortunately, the reverse will happen," he said. "Instead of uplifting the Negro, the Negro will drag the white race down to his level."

He claimed that the intelligence level of the Negro is "far below" that of whites and referred to a report by the California Bureau of Employment which he said stated that, of all applicants tested in a given period, all Negro applicants showed a lower I.Q. than the white applicants.

Quoting writer Arnold Toynbee, he claimed that the Negro has not contributed toward the development of any civilization.

He charged that the recent decision of the federal courts to follow guidelines set up by the Department of Health, Education and Welfare is the "most dictatorial and insidious plan yet devised by the federal government."

He said, "We of the South are the whipping boys of an entire radical reconstruction movement."

"The HEW guidelines are intended for the South. For example, the government didn't dare withhold funds from Chicago.

"When it was threatened that federal funds were to be withheld from Chicago after the riots there, Mayor Richard Daley telephoned President Johnson direct and got his money.

"Johnson released the funds to Daley because he knew Daley could deliver one of the largest blocs of votes in the country to him."

Leone Charges Threats

Rent-Subsidy Backer Reports Bomb And Shooting Calls

City Councilman Dominic M. Leone (D., 6th), whose surprise vote Monday assured passage of the rent-subsidy plan to assist welfare recipients, said last night his life has been threatened repeatedly since the measure was approved.

Mr. Leone said anonymous callers have "threatened to shoot me" and "blow up the house."

Yesterday afternoon, about 200 persons gathered in the 1500 block Jackson street as 6 or 7 pickets from racist organizations paraded in front of the councilman's house.

"It's Been Wild"

"It's been wild, man," Mr. Leone said last night.

He added that the pickets were "just a bunch of hoodlums."

Police said that all but about 50 of the persons outside Mr. Leone's house between 2 P.M. and 3 P.M. were youngsters. Captain George C. Schnabel, of the Southern district, said 25 uniformed and plainclothes policemen were on the scene.

Among the pickets were Joseph Carroll, a leader of the National States Rights Party, and Charles J. Luthardt, chairman of the Fighting American Nationalists.

The councilman attributed the threats and the demonstration to his support of the rent-subsidy plan.

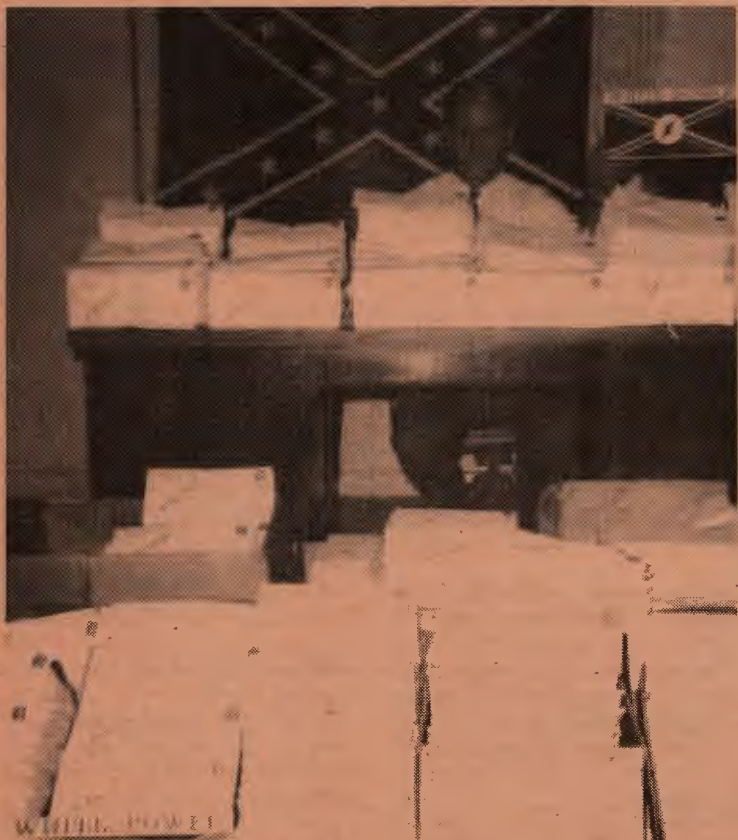

F.B.I. Frameup In Mississippi

On June 21, 1964, two New York City Jews and a Mississippi negro died. They were members of CORE, a pro-communist race-mixing organization run by a Jew named Marvin Rich. The two Jews who died were Michael Schwerner and Andrew Goodman. The negro was James Chaney.

the defendents, otherwise they would never have believed the three FBI pimp witnesses - all were proven either liars or criminals.

THE RECORDS OF THE LIARS

FIRST LIAR: James E. Jordan testified against several of the defendents. Later he admitted he

had lied when he swore Travis M. Barnette was present at the execution of the two Jews and one negro.) He admitted under cross-examination that the FBI paid him \$3,000 in advance and \$100 weekly for his testimony - plus round the clock FBI guards during the years since the execution took place. He also admitted he was a criminal with convictions for bad check writing and grand larceny. (This is the typical pimp the FBI hires to spy on the Right Wing.)

SECOND LIAR: Meridian Police Sergeant Wallace Miller testified he joined the White Knights of the Ku Klux Klan and became a Kleagle. He said he sold out to the FBI and became a pimp for \$2,500 plus travel expenses. (He was bought off the cheapest of the three!) He swore that the Imperial Wizard, Sam Bowers, Jr. of Lurel, Miss., had planned the execution of the two Jews and negro.

On cross examination Sergeant Miller admitted he lied under oath when he signed a marriage license to marry his fourth wife and swore he had been married only once before. (No doubt his wife was told this same lie also.) A fellow police officer on his force testified that Miller was a liar and couldn't be believed under oath.

THIRD LIAR: Rev. Delmar Dennis (of the Southern Baptist Church) testified that Imperial Wizard Bowers had said that the execution "was a job well done, it was something to be proud of. This is the first time Christians have planned and carried out the execution of a Jew." It is doubted that these words were ever spoken because during the first indictments Bowers was not even named in the case. The FBI has long sought to get him out of the way. We believe they concocted this story and had him indicted almost a year after the executions.

Regardless, Rev. Dennis had wormed his way up in the Klan to Kludd (Chaplain) and later Titan in the White Knights. Asked why he had violated his Klan oath of secrecy, sworn before God almighty - he had no answer. But he did admit that the FBI paid him \$15,000 for his testimony. His wife who just recently divorced Rev. Dennis, testified he often beat her and that he was the type of man you could not believe under oath.

FBI AGENTS AND PIMPS ARE TRAINED LIARS
Former FBI agent Normal Ol-

lestad in his book, "Inside The FBI" says FBI agents are trained to lie - so are their pimps! Once an FBI agent dared Dr. E. R. Fields to sock him once on the jaw - another FBI agent stood out of sight to photograph the "assault of a special agent of the FBI." Later after Dr. Fields had the FBI agent arrested and jailed for disorderly conduct and trespassing, he had the gall to stand up in court and swear under oath that he never made such a statement to Dr. Fields!

The jury in the Meridian, Miss. case was not at all justified in convicting any of these men under the testimony by three PROFESSIONAL PAID LIARS! The law states that if there is any doubt, the jury should vote to acquit. The above was the basis for the federal government's case and John Doar's argument to the jury. The defense made this information on these liars available and all should have been acquitted. As it was, seven were found guilty, eight were acquitted and a mis-trial declared in three cases.

We also are critical of Judge Cox who held the jury out over a three day period - in order to force a decision, even after they had declared themselves hopelessly deadlocked. In your editor's opinion these men definitely did not receive a fair trial and a retrial should be granted those convicted.

Courts Free Convicted Negro Rapists

The U. S. Supreme Court is now solidly stacked by LBJ's latest appointments of the Jew Abe Fortas and negro Thurgood Marshall. Back in 1961 two negro brothers, James and John Giles were found guilty and sentenced to death for the rape of a White girl.

This attack took place in Montgomery County, Md. when the girl was only 16. Former negro-loving Gov. J. Millard Tawes commuted the two negroes sentences to life imprisonment when they were only three weeks away from the electric chair. The Supreme Court later ordered a new trial.

By now the girl is over 21, living in Florida and happily married and is pregnant. Being over 21 now and going through the trial again at this age, her name and picture would be placed in the press as, "The girl mass raped by two negroes and one still in prison."

She has refused to again submit herself to this trial and the courts have set the negro brothers free. Once again White people are the victims of another mis-carriage of justice. Of course the courts and the governor would not have leaned over backward to free these negroes if their skin was White. Crimes against Whites will continue to mount until the NSRP takes power in America and roots out the race traitors in Washington.

No Help For John Wayne On Anti-Red Movie

Veteran movie idol John Wayne has long been recognized as a sincere Patriot who wants to help his country fight Communism. We, of course, realize that he cannot take as strong a stand as that of the NSRP, but we do admire his courage in this latest fight.

Finally he gave up and formed "Batjac Productions" to make the movie, and also put hundreds of thousands of dollars - his own money into the movie. It is now being produced in Columbus, Ga. In the movie John Wayne plays Col. Kirby, "a dedicated Army man." He also helps direct the picture. There is plenty of front line action and the co-stars are David Jansson, Jim Hutton, Aldo Ray and Raymond St. Jacques. One film maker turned down the film because it portrays "dissenters to United States Viet Nam policy as pinko-creeps."

It is interesting that Jewish Hollywood can't make one single anti-Communist movie. Yet they have for 28 years produced Anti-German movies that continue to this day, despite the fact that West Germany is our most loyal ally in Europe. Yes, the Jews will continue to promote the hate Germans on T.V. and in the movies. They will not attack Communism, because they are a part of it themselves.

How Jew Land Gougers Operate

Jews are the largest owners of rental property in the major cities. In making a study of this problem, your editors discovered the Jews grow rich renting both integrated and segregated housing. Here are the facts in our survey showing just how they do it.

Out in Denver, Colo., there are very few negroes. Yet, they are still considered un-desirable as neighbors by Whites. There are two brothers named Lew and Larry Rosenberg in Denver who specialize in building cheap, low income apartments.

They purchase old homes, tear them down and squeeze in three, six and nine unit apartments on the former single dwelling properties. At first they will rent to White families, after three or four move in, the Jewish brothers announce the remaining apartments are available to negroes. Most of the Whites are too poor to move out. Whites owning respectable single unit homes in the area are shocked by the ghettoing of their neighborhood.

By allowing negroes to have the unrented apartments, they stay filled up and the two Jews have become rich. Yet, in their spare time they are school teachers in Denver and state they place "great emphasis on human relations" in their instructions to White Christian students.

THE BIG MONEY IN
NEW YORK

Rents in New York City are

the highest in the nation. Unless you know someone who has tried to live there, you wouldn't believe it. Negroes and Puerto Rican negroids have taken over vast sections of the city. Middle class Whites have been squeezed into smaller and smaller areas.

One of the excuses given tenants for the fantastically high rents is that: "Legally we cannot refuse to rent to negroes under New York law, but if the rents are high enough they cannot AFFORD to move in with you." As an example of how fast a huge apartment can turn all negro was told in the New York Times. The city built a cooperative along the White area of Central Park. It was in the \$150 a month range. At first they did not want it to go all negro and restricted the ratio to 60% White and not more than 40% negro. After the 40% negroes grabbed their 'low' rent apartments, Whites would not move in--that was 40% too many negroes for them. So, the city eventually rented 80% to negroes, and a city official was quoted: "By next year it will be all Black."

The same article said that another giant city owned cooperative sold 30% of its apartments to negroes. The rest is vacant because not enough negroes can afford them, and Whites will not consider moving in. (In New York you can buy an apartment and pay a monthly 'service' charge

for maintenance.)

HOLD ON TO YOUR HATS

All the giant high-rise Apartments sprouting up in the still White oasis of the city are Jew owned. We now quote the very interesting news statement from the New York Times on this problem:

"Few landlords conceal their glee at the current situation and larger profits are another major cause of higher rents. As Alan B. Friedberg, vice president of Charles H. Greenthal and Company, Inc., said, "There is a so-called captive audience in good housing (Whites who can't run away) without penalizing the tenants or taking advantage of them we find ourselves in an excellent position. We have 4,500 leases expiring on Sept. 30 and we are asking increases from 10 to 22 per cent. And we are getting them with no trouble." "

The truth is, as the article further points out, THE TENANTS ARE SHOCKED. Better apartments in New York City rent for \$75 to \$100 PER ROOM AND UP. A typical co-op two bedroom Apartment on Fifth Ave. or Park Ave. sells for \$35,000 and the so-called maintenance fee is 'only' another \$350 per month. AND THIS IS CONSIDERED A BARGAIN. In Central Park South, almost all two bedroom apartments sell from \$45,000 and up.

Others, for businessman range from \$50,000 to \$150,000, and monthly maintenance from \$350 to \$1,000. Of course this is for the rich. But, the first figures are typical.

miles to the suburbs to find lower prices, but they pay for this with two and three hour trips to work in the morning and the same thing again that evening on the way home. Of course, jobs pay a lot more in New York, but that city also has the highest taxes in

America, due to its highest Welfare rate in the nation. So, you can't win in New York City, and half a million Whites have moved to other cities and other jobs during the past 10 years. But, the Jew landlord is going to make money either way.
