JIMMY CARTER'S STRANGE FAMILY

There is perhaps a "Black Sheep" in every family which does not necessarily mean that other relatives have inherited the same traits. At the same time we know that when there are a number of insane people in a family it is possible a certain percentage of that family tree will also suffer from mental illness. Criminal traits in families can be traced from one generation to another and genetecists believe that our entire lives our predestined by our genetic makeup. Our potential accomplishments and even the diseases we suffer from in the future may well be those that have been common among members of our family tree.

No man has ever reached the presidency who had a family more strange than that of Jimmy Carter. Let's look at some of them and then Carter himself.

Carter's Mother Lillian was a left winger way back when most all White Southerners were conservatives. She ran the campaign office for Sen. McGovern when he ran for president. McGovern was the most hated man in Georgia. She also was one of the oldest women to ever join the Peace Corps and serve in India.

William Carter Spann is Jimmy Carter's first cousin. He is the son of Carter's sister, Gloria Spann. William Spann, 29, has been in and out of prison for years. He is now in prison in California for two armed robberies. Since 1969 he has gone to prison for such crimes as car theft, burglary, possession of weapons while on parole, etc. Recently it was revealed that he was carrying on a homosexual relationship with a negro prisoner named James Yarborough in San Quentin. This so angered White prisoners that he was threatened with death by the White Supremacist prison group known as the "Aryan Brotherhood." They fight to save young White prisoners from being enslaved by negroes for homosexual purposes. William Carter Spann has violated their rules of conduct by consorting with negro homosexuals.

James Earl (Chip) Carter, 26, is the heavy drinking son of Jimmy Carter. During the campaign, Chip joined in the annual homosexual "Great Tricycle Race" sponsored by the "One" organization. The queers cheered for him over the eight mile course. Later he retired with them to a bar called "The Mint" where he promised that his father would support Bella Abzug's "gay rights" bill. It was later at another drinking contest in Seattle's Comet Tavern where photographers got a shot of young Chip drinking Tequila straight out of the bottle while puffing a marijuana cigarette.

Ruth Stapleton, 46, Carter's sister is another case in question. She has joined the Behold Inc. sect which operates out of Camp Fartherest Out, N.C. Miss Stapleton claims healing powers and also provides a sort of religious counseling service and therapy for people with sexual problems. She has become wealthy as a result of the new clients who now come to her as a result of her brother's publicity.

One must admit that Jimmy Carter has a very strange family to say the very least. Carter has a halting speech pattern which worries psychologists. It indicates an erratic train of thought. We have the most unpredictable president serving in the White House in our nation's history.

Carter's Love For Negroes

Jimmy Carter's family at one time was the only family to vote to integrate the Plains, Ga., Baptist Church. He sent his daughter to a majority black local public school while most of the Whites sent their children to a private Christian Academy. Carter today sends his daughter Amy to the mostly black Thaddeus Stevens school in Washington, D. C. The school was named after the tyrant who imposed reconstruction on the White people after the Civil War. It has a low scholastic rating and the Secret Service must be present in

CARTER'S NEGRO APPOINTMENTS

Minorities now control most of the highest echelons of government. Last month we documented the large number of Jews who were appointed to the Cabinet and number two positions in government. They included the Jewish ADL member Harold Brown as Secretary of Defense and Michael Blumenthal, Secretary of the Treasury.

This month we shall make a study of the many negroes Carter has appointed to sensitive positions within the government. Patricia Harris

is the first black woman in history to serve in the Cabinet. She heads the Department of Housing and Urban Development. (HUD) the Harris woman says her goal will be to abolish "ghettos" and see to it that all minorities have good housing.

Drew S. Days, III has been named to a powerful post as head of the Justice Department's Civil Rights Division. This is the secret police outfit which seeks to force Whites to accept negroes in housing, schools and on the job. He formerly worked for Jew Jack

Greenberg, head of the NAACP Legal Defense Fund. Greenberg says that Days is "thoroughly versed in all aspects of civil rights law and policy." Nathaniel Jones, general counsel of the NAACP says that Days is "resolute, thorough, and committed." In other words the second Reconstruction is now well underway.

Clifford Alexander, Jr., represents the steepest promotion in the annals of U.S. military history. While serving a six month hitch in the army in the 1950s, Alexander left the service as he

the room at all times to protect Amy.

Carter went to extraordinary lengths to have murderess Mary Fitzpatrick released from prison in Georgia so that she could move into the White House as Amy's personal maid. The Fitzpatrick woman was serving a life sentence for the 1970 murder of her girl friend's boyfriend, negro Johnny Bynum. She worked in the Governor's Mansion as a maid under the Carter Administration. Secretary of the State Parole Board, Rob Haworth, said that the release was unusual because the Fitzpatrick woman had not served the minimum time required. This was waived at the president's request. She was earlier granted a 3 day pass to attend the inauguration in Washington and was a special guest of the Carters. They will now have the convicted murderess looking after their child on an around the clock basis. How could anyone of sane mind place their own child in such a danger when negroes are known to revert back to their primitive ways when they merely lose their temper. It is said that she shot and killed Bynum during an argument when she was drunk!

Carter's Preacher Had A Negro Baby

The Plains Baptist Church tolerated Rev. Bruce Edwards as their pastor because he was the choice of the Carter family. The first crisis came when Georgia negro Rev. Clennon King of Albany tried to join the Church. Both Carter and Rev. Edwards favored his membership. Edwards said to keep blacks out of the church was immoral. But the deacons of the church objected. They agreed to accept black members but only on an individual basis with each applicant required to have separate approval. To this date no negro has been approved.

When the Playboy interview of Carter broke, Rev. Edwards, financed by the Carter Campaign, sent out thousands of letters all across the country justifying Carter's controversial interview. This irritated the congregation.

When all black applicants for church membership were turned down, Rev. Edwards and his wife adopted what they called a "non-caucasian child." The Thunderbolt found out that the baby was a mulatto negro and his photo is reproduced on this page. This was the last straw. Jimmy Carter knew what was coming and quickly transferred his church membership to a Baptist church in Washington. The irate Plains congregation then voted to oust Edwards and he resigned as a face saving move. Later he charged that there were "Racists" in the Plains Church and they would not accept his adopted son.

In another inside look at the Carter family attitude toward race we must study the extremist statements by Carter's brother Billy (the town drunk) who said: "Some of these Christians should be fed to the lions." It should be noted that the Jewish Bantam Books firm is going to print Billy's Wit & Wisdom to be ghost written by the Jew Jeremy Rifkin.

Hugh Carter, cousin of the President and a State Senator said that Rev. Edwards had been "crucified" and that the President "would be deeply hurt. This was the blackest and bloodiest day in the history of the Plains Baptist Church."

This case gives you some insight into just how extreme the Carter family is when it comes to their personal fanatical view in support of race mixing. This is the kind of tyrannical thought which will be used in creating a "Second Reconstruction" of forced race mixing upon the entire nation under the Carter regime.

Does Carter Tell The Truth?

CARTER: "I WILL NEVER TELL YOU A LIE"

Remember the famous statement by Carter during the campaign when he stated that: "I will never lie to you, I will never mislead you." Well, we have made a short study, on some matters which must make one wonder about the truthfulness of the President.

Back in August during the campaign, Carter told a sad story of how poor he was as a child and how humble his hometown of Plains was. Those in the audience included negro Sidney Poitier, Diana Ross, Carroll O'Conner, Jewish drug addict Louise Lasser (Mary Hartman) and others. Carter told them that:

"In the county where I farm we don't have a doctor, we don't have a dentist, we don't have a pharmacist, we don't have a registered nurse and people who live there who are very poor have no access to preventive health care."

The truth is that Sumter County, which includes Plains, boasts 29 physicians, eight dentists, and a large hospital.

During the campaign one of his chief speech writers resigned because of the "deceptive nature of this campaign." Robert Shrum accused Carter of telling one thing during a speech and another to his staff. Carter told Shrum that he knew that he could not cut 15% out of the military budget. Other times Carter would say: "We have to be cautious. We don't want to offend anybody." Carter was an expert at telling one audience one thing and the opposite to another.

While claiming to be a "born-again Christian" Carter is a defender of homosexuals and has stated that he would sign any "gay rights" bill which might come across his desk. Tests made by Roger McLaughlin with a special "stress machine" during the Ford-Carter debate showed that Carter was lying. Mr. McLaughlin said this was especially pronounced when Carter promised that

he would cut the defense budget by \$15 billion. **Carter Ruthless, Says Sen. Tower**

Sen. John Tower of Texas has made some of the sharpest statements to date on his opinion of Jimmy Carter. He states: "Jimmy Carter is a man devoid of convictions and a ruthless man bent on gathering power."

These statements were made on the "Face The Nation" CBS-TV show in which Tower said Carter is a man "who aspires to power and perhaps has the idea, the messianic idea, of creating a benevolent dictatorship. He is a man who smiles with his mouth but not with his eyes. People ought to be terrified at a man like Carter being President."

Last but not least is a statement by former bank robber and newborn author Willie Sutton who has known a lot of con men from his underworld days. Sutton says of Carter: "I've never seen a bigger confidence man in my life, and I've been around some of the best in the business."

Negroes Breakdown Chicago Transit

CHICAGO "L"

CRASH CAUSED BY NEGRO MOTORMEN

Chicago police have revealed that the last three major crashes involving the elevated transit system involved negro motormen. The most serious was the February case in which four cars left the track at the sharp turn on Wabash Ave. Negro motorman Stephen Martin ignored the fail-safe warning system and moved his train forward until it smashed into the rear of another train. The impact threw two huge cars into the street and left two others dangling from the track. The worst accident in recent years left 11 persons dead and 180 injured. A contributing factor is the fact that Martin had been smoking marijuana while operating the train. Four hand-rolled marijuana cigarettes were found in his possession. He is

now under investigation for criminal negligence.

Since our government began forcing so-called "affirmative action" hiring programs, the quality of work and efficiency on the job has gone down. This is one reason we see so many call-backs of automobiles by Detroit. Now that Chrysler has an over 50%

black assembly line the quality of their product has gone down. The same with the other auto manufacturers. As more and more blacks are forced into the job market the greater this antipathy to work affects Whites. When they see the negro loafing on the job or not doing his work properly, they say — "Why should I work hard to get things done right when they get the same pay as I do?"

This is the attitude which is spreading throughout the American labor movement and it will not change until men are hired on the basis of who is best qualified for the job and who is more proficient. Hiring of blacks by quota means a system of unjust job discrimination against Whites who are not able to find positions they are entitled to. This tragic situation must be reversed if America is to be preserved as a first rate civilization.

Immigration Flood Threatens America

ILLEGAL IMMIGRANTS

The Tides of The Future

At present, there are 6-10 million illegal immigrants in the United States. The spread in those figures is merely one indication of the extent to which the problem has slipped out of control.

About two-thirds of these illegal immigrants are Mexicans, and most of the rest come from the birth-explosion countries of the Caribbean and elsewhere in Latin America.

Just before it recessed, Congress passed a \$3.5 billion jobs bill designed to create 300,000 new jobs. At least half that number of Latino immigrants slip into the U.S. each year looking for work.

Two years ago there was published here an extraordinary novel by the French writer Jean Raspail, a European prize-winner, entitled "The Camp of the Saints." Set in the near future, it depicted a "peaceful" invasion of the southern coast of France by a million starving beggars from Calcutta. They arrived on a fleet of decrepit transports. The French could not muster the will to oppose this invasion, and so the million illegal immigrants simply arrived. Subsequent waves of such immigration inundated Europe, and extinguished it.

Mexico

What is now happening along the U.S.-Mexican border is clear enough.

American per capita gross national product is around \$6,000. For a Mexican, it is \$740.

Mexico also has one of the highest birth rates in the world, its population doubling every 20 years. Population growth in the U.S. is a meager 0.9 per cent. The world rate is something like 1.9 per cent. Hold your breath: in Mexico it is 3.2 per cent.

According to responsible demographic projections, the Mexican population, doubling every 20 years, will reach 132 million by the turn of the century — not that far away.

Current political and social turmoil in Mexico has not, generally speaking, been put in menacing terms by the media here. When outgoing Mexican President Luis Echeverria suddenly expropriated 1.5 million acres and turned them over to landless peasants he did not do it out of the goodness of his heart or even out of ideology. He did it because population is beginning to burst Mexico at its seams.

The border between the U.S. and Mexico is now patrolled by 1,700 men, able to stop, according to best estimates, one out of every three or four illegal entrants.

According to the Census Bureau, Spanish is now by a wide margin the leading foreign language spoken in the United States.

Looming Problem

Nevertheless, given the mounting population pressure in Mexico and elsewhere in the Latin American world, an enormous problem looms. Clearly, it is going to become more and more desirable to wade across the Rio Grande River, even if you have to work for nickels and dimes. At least you won't be working for pesos — recently devalued, naturally.

During the 19th century, the U.S. seized by force large sections of the Southwest and West from the Spanish empire. Now a kind of reconquista seems to be taking place.

Given the population explosion and incompetent politics south of the border, the Carter administration faces some clear choices. No matter how many border patrol personnel are added to the present thin line, the incentives will remain great to slip into the U.S. illegally. It would take an enormous force to patrol the U.S.-Mexican border from Baja California and all along the Gulf Coast.

The way to discourage illegal immigration — which now amounts virtually to an invasion — is to make it impossible for an illegal immigrant to be employed. Severe penalties should be imposed upon employers who use these people. The very illegality of an alien makes him or her easy prey to an employer who would avoid the usual regulations regarding compensation.

Tax Strike Leader In Prison

BUDDY TUCKER IN PRISON

Rev. Buddy Tucker is the Tax-Strike leader from Knoxville, Tenn. Since 1974 he has been fighting a conviction and one year prison sentence for failure to pay income taxes over a three year period. Rev. Tucker's income of close to \$100,000 per year was from an inheritance.

The tax strike method he now advocates is to file a W-4E form listing additional deductions so that no tax would be due. Tucker also

stated that the income tax violated his right not to incriminate himself under the Fifth Amendment. The case went all the way to the U.S. Supreme Court. Rev. Tucker lost after all the courts which heard the case ruled in favor of the I.R.S.

Marvin Cooley Free From Prison

Probably the top Tax Strike leader in America is Marvin Cooley. His advice on how to stop paying taxes has

been presented in lectures from coast to coast. Mr. Cooley was convicted and served two years in the federal penitentiary in Mesa, Arizona. After two years of imprisonment he was finally released last month. He now hopes to obtain permission from his parole officer to begin holding tax strike seminars again. Mr. Cooley also advocates the same tax strike technique similar to that of Rev. Buddy Tucker who has just begun his prison term.

Tucker Surrenders to U.S. Marshal

Dewey (Buddy) Tucker, Dandridge, convicted in late 1974 in Federal court of wilful failure to file tax returns on income of \$296,000 over a three-year period, was placed under formal arrest yesterday afternoon by U.S. Marshal Bruce Montgomery. He was taken to Sevier County Jail and will be transferred to a Federal prison.

Tucker, pastor of Temple Memorial Church on N. Broadway, was convicted in December 1974 after a trial that lasted about two days. It took the jury three minutes to convict. He had conducted his own defense and told the court he had not filed the tax returns because he thinks filling out a Form 1040 is possible self-incrimination, in violation of the Fifth Amendment to the Constitution.

He appealed the case to the U.S. Sixth Circuit Court of Appeals and lost.

He was charged with failing to file returns on income of more than \$296,000 in 1968, 1969 and 1970.

INVASION OF AMERICA UNDERWAY

President Carter has just announced that he is going to appoint a Mexican to head the immigration service. The Supreme Court has ruled that illegal aliens cannot be denied the opportunity to take the Civil Service jobs.

A presidential commission has recommended that illegal aliens now residing inside America be granted amnesty and allowed to stay here permanently.

Attorney General Griffin Bell leans toward this position and on Feb. 16 stated that massive deportations of illegal immigrants would be "inhumane and impractical." He said that many have "built equities in our country by virtue of their long residence and must be given particular consideration."

A federal judge in New York has ruled that some 2,000 negroes from Haiti are "political refugees" and cannot be deported. As of today the Justice Department has not decided whether or not to appeal. Their case was fought with lawyers provided by the National Council of Churches.

With the Mexican population explosion doubling every 20 years (highest birth rate in the world) there is great pressure from our Southern borders. Most of the illegal immigrants are either from Mexico or South America. Henry Felchlin of the El Centro border patrol station says twice as many are coming across the border as last year. He said a total of 870,000 were apprehended last year and 9 out of 10 were Mexicans. But this is a losing fight because for each one caught three more get through. Mr. Felchlin says that in Mexico they might

earn \$4 a day while here it is \$16 to \$20 per day. More than one third of the Mexican population is unemployed.

While White Americans are being asked to cut down on the number of children they bear so that the so-called utopian goal of "Population Zero" can be reached the country is being flooded with non-White who have large families. Our laws do not allow the Social Security Administration to have those applying for a Social Security card prove that they are citizens. Thus they are quickly able to join the nation's work force. President Carter has requested an emergency \$3.5 billion public work bill to provide 300,000 jobs. Three times that number of illegal aliens enter the country each year. If we soften our stand as advocated by Carter and company there are millions of additional aliens awaiting the opportunity to enter this nation illegally from South America, Africa, Hong Kong and Mexico.

The invasion will quickly be overwhelmed and will melt away. Lax immigration enforcement simply means opening the door even wider to the flood tide awaiting the chance to pour across this land. Illegal immigration is perhaps the gravest problem now facing the country and it is almost totally ignored by the Congress. Write your representative today to support the Rodino Bill which would make it an offense for an employer to knowingly hire illegal immigrants. This measure has twice passed the House in the past but has died in the Senate where Teddy Kennedy and his allies have successfully been able to bottle such measures up. We must act now because, another 20 years of this and the White Race will be the true minority in our own country.

High U.N. Head Charged With Slavery

U.N. OFFICIAL KEPT SLAVE GIRL IN NEW YORK

Mr. Intrapased Patel, an Asian from India, has been charged with Slavery in New

York State. Patel imported a Philippine girl named Perlita Diza to work as a servant in his home. She could not read English and was paid only \$8 per week. She was forced to work 14

hours a day 7 days a week. For six years she has served Patel and his family as a cook, laundress, and cleaning woman. She had to cut and water the lawn, take care of the dog, care for the

Patel children, paint, repair plumbing and wash the car as well as serve guests.

Patel would not let Miss Diza eat the same food as did his family but only permitted her to eat eggs, potatoes and milk with chicken added once a week. The girl was found to be malnourished by state investigators. Patel heads the U.N. Development Agency which spends \$600 million a year to help backward and undeveloped countries each year. Yet, he is too selfish and greedy to help take care of his own servant. This despicable individual even deducted from Miss Diza's wages the cost of her food and medical bills. When she married and left his employment after six years of hard work, she discovered only \$2,-

Colorado Black Lt. Gov. In More Trouble

NEGRO LT. GOV. STOLE GASOLINE

Colorado's negro Lt. Gov. George L. Brown seems to keep his name in the news and most often to the discredit of the state. Brown drove up to the Vickets Dividend service station at 5455 E. Colfax Ave in Denver. Attendant James W. Burgett filled up his car with gas. Brown told him to put the bill on his state credit card. Mr. Burgett told the negro that they no longer accepted such credit cards. With that Brown said he would no longer be insulted at such a "crummy station" and drove off without paying.

A complaint was filed but Denver Police Chief Art Dill, made no arrest because he said there was no "intent to thievery" present. Brown sent an aid to pay the \$5 for the gas and again said this was "harassment" because he is black.

Many are amazed that Brown has not been forced to either resign or be impeached by the state legislature. He has been proven to have used state funds on many occasions for vacations and other travel expenses in which there was no state business involved. Two years ago he told a Lt. Governors con-

ference a shocking story that during World War II his plane crashed in Alabama. He claimed he was captured by a "redneck" farmer who chained him in a barn and branded him with the letter K. Later his fellow negro fraternity brothers from his college days said they all were branded with a K during a fraternity ritual, and it had nothing to do with persecution in Alabama. Lt. Gov. Brown apologized to the Lt. Governors who attended the conference for his false story. Trouble was that the daily press carried the lie nationwide but his retraction was only printed in the newspapers of Colorado and Alabama. The rest of the coun-

try was left to believe the outrageous first story.

In the meantime we must await the voters decision in next year's elections as to whether or not they want to keep their negro Lt. Gov. Most experts say that the electorate are eagerly awaiting the opportunity to toss Brown out on his ear. You will be able to read the election results right here in THE THUNDERBOLT.

Dying Sen. Humphrey Confesses

HUBERT HUMPHREY'S DEBT TO THE JEWS

Sen. Hubert Humphrey is dying of cancer. He almost became President in November of 1968. Humphrey is an extreme leftist and his political philosophy is not far removed from that of the Communist Party. Who made Humphrey such a great power and influence all across the land?

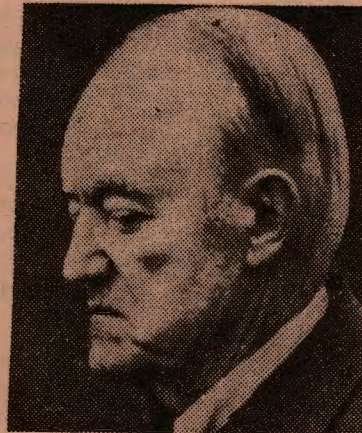

TWO CHURCH GROUPS BACK HOMOSEXUALS

Two of the nation's largest church denominations have endorsed so-called "civil rights" for homosexuals. Both the United Church of Christ and Episcopal Church are well known for their extreme left-wing stance. The United Church of Christ at its recent national convention in Minneapolis declared that "a person's sexual preference is not legitimate grounds for denial of civil liberties."

The New York Episcopal Diocese has ordained a lesbian as a priest in their church. Bishop Paul Moore, Jr., called this a "healthy attitude" on the part of the church. He said the ordination of self-avowed lesbian Ellen Barret was a credit to her "honest openness of courage and compassion in her identification with the gay community." Embarrassed Episcopalians in Georgia voted 138 to 30 for a resolution declaring homosexuals unfit to be ordained as priests. Bishop Paul Reede said that the Holy Bible had declared "homosexual action to be immoral." He was opposed by Fr. L. Powell Gahagan of Valdosta, Ga. who declared that he knows "homosexual priests whom I find to be very good priests" and condemned delegates to the Georgia convention for "casting stones at homosexuals." At least now that the issue has been brought to the surface we can determine by such votes which church leaders are pro-perversion and against God's law which specifically condemns homosexuality.

The Episcopal Church, in another step demonstrating just how far left they are, announced last month in Washington that they had ordained the first negro woman priest. She is the Rev. Pauli Murray, 66, who has been active in civil rights causes for many years. One good bit of news was the recent statement issued by the Roman Catholic Pope that women cannot be priests. This has caused organized lesbians to call for Catholics to stop contributing to their church. Most likely it will have the opposite effect.

The 1.8 million member body also called for affirmative action hiring programs to guarantee an increase in non-Whites employed by church operated institutions. This of course means fewer jobs will be made available for more qualified Whites.

MALE TEACHER CHARGED WITH PROSTITUTION

Melvin K. Hendrix, 33, chairman of the minority studies department at Moorhead State University has been charged with five counts, all felonies, involving prostitution laws. The Moorhead, Minn. man dressed as a woman and sought to sell his services to unsuspecting men. The university professor was released on a \$1,500 bond. Here is a case in point with Miss Anita Bryant's argument where a teacher might be instructing children on minority studies (always debasing the White majority) but no doubt brainwashing them on the so-called rights of queer perverts at the same time. These degenerates are always after the young and can be found in schools, summer youth camps, Y.M.C.A. activity, etc. They pose a great danger to our impressionable youth and must be stopped.

Soviet Arrests 12 Of German Origin

MOSCOW, Feb. 25 (AP)—Twelve Soviet citizens of German origin were arrested today during a demonstration demanding permission to emigrate to West Germany.

Policemen arrived 12 minutes after the 12—five women and seven men—started demonstrating outside the West German Embassy. The 12 were believed to be from Latvia.

"We are tired of being treated like third class citizens all our lives," one of the demonstrators shouted to newsmen.

There have been two other demonstrations in the last month by Soviet citizens of German origin who want to emigrate. Sixteen persons from Estonia were arrested Feb. 11th outside the headquarters of the Central Committee of the Soviet Communist party. On Jan. 30 six persons demonstrated outside the West German embassy. After the police broke up the protest, two took refuge in the embassy but came out the next day and were arrested.

About 40,000 more have applied for exit visas.

in America. This news was suppressed because the kept news media want everyone to be filled with concern over the demand by some Jews to emigrate from Russia. Up to 1500 Jews each month are allowed to leave Russia. A majority of these Jews change their point of destination from Israel to America once they leave the Iron Curtain. (It must be noted that the vast majority of Russia's 5 million Jews do not want to leave and have advanced to high positions within the communist system.

Only the powerful and influential Jews are allowed the privilege of leaving Russia. The Volga Germans in Russia number over 1 million people and some 40,000 of them have applied to immigrate back to their native homeland. (All would if allowed.) PANAMA CANAL IS PART OF AMERICA

The Panama Canal was opened to traffic on August 15, 1914.

United States influence in Panama and the Canal Zone remained unimpaired until 1936 when the Hull-Alfaro Treaty was signed. Because of opposition in the U.S. Senate this treaty was not ratified until July 25, 1939. This new treaty came about as a result of ideologies of super-nationalism which took hold of a generation of Panamanians schooled to believe in the fiction that their "founding fathers" actually won their independence.

New generations of Panamanians have been under the impression that the whole province was up in arms for the revolution. The truth is that there was only a handful of Panamanians who planned the revolution at our request with heavy U.S. military support.

Panama history books have not told Panamanian youth that only a handful of their leaders knew that a "revolution" was even planned. As a result Panamanians believe that their forefathers fought long and hard for independence, and that they are therefore entitled to complete sovereignty over the entire canal isthmus.

The 1936 treaty was the result of the pressures of this new generation of misinformed Panamanians as well as their sympathizers in the U. S. This treaty was the first step in a long line of concessions which has led to their present unreasonable demands for a complete takeover of our canal.

The 1936-1939 treaty ceded U.S. rights, which had been guaranteed in Article II of the 1903 treaty, to select and retain (without payment) sites outside of the Canal Zone which would be used for defense of the Canal.

So when World War II came we had to bargain with Panama over how much we would "pay them to rent" yet undeveloped pieces of ground. Thus we were "allowed" to mount guns and build air-strips, in order that we might protect the Canal, the most vital contributor to the economy of Panama.

We built 130 defense sites during the war outside of the Canal Zone, among them, what was then the largest air base in the world, Rio Hato. By 1948 the Panamanian Government would not even allow us to pay them to keep defense forces on a few of these bases; we were forced to abandon them all! We left behind a million dollars worth of buildings and improvements.

The 1936-1939 treaty also completely eliminated Article I of the 1903 treaty, which reads: "The United States guarantees and will maintain the independence of the Republic of Panama." We had been good enough to make them independent back in 1903 but now they didn't need us any more.

Also eliminated in the 1936-1939 treaty was the right of the

satisfied with the status of the Canal. In November of 1952 the Panama National Assembly voted unanimously to demand another revision of the treaty. In 1953 top secret negotiations began which resulted in the Eisenhower-Romon treaty, ratified by the U.S. Senate on July 29, 1955. Concessions granted to Panama in this treaty included: increased annuity to \$1,930,000, gave Panama property within the Zone valued at \$24,300,000 and agreed to build a bridge over the Canal at the cost of \$27,000,000. In return the U.S. was granted the right to use the Rio Hato base for training purposes for 15 years.

On July 26, 1956 President Nasser of Egypt seized the Suez Canal. This caused another outburst by the Communists, who called for "internationalizing"

Marxist spokesmen now call for Panamanian Sovereignty over the Canal, since Torrijos and his henchmen are Communists. It is further of considerable significance that Torrijos' wife, Raquel Torrijos Pausner, is a Jew. (Their daughter just graduated from the Albert Einstein Jewish Day School, reports "Jewish Week.") Thus it is not surprising that all Jewish organizations in America favor surrendering the Panama Canal.

Torrijos had also been a frequent guest of Castro, and in late April of last year 3,000 Cuban troops landed in Panama.

If it is not enough that Panama is being run by Communist agents, we have but to look to our own State Department.

First we had the Jew Kissinger down there negotiating; he has already signed a treaty that would give away the Canal in 25 years. Now, because they're apparently not sure whether or not Ellsworth Bunker is serious about giving it all away, they thought they would make sure by sending along Jew Sol Myron Linowitz, of Rochester, New York. Jew Linowitz is not only presently a registered agent for the Government of Colombia, but was a registered foreign agent of the communist government of Chile under the late Salvadore Allende. This is an outrage to the American people.

But our Congress can still save us. The Kissinger treaty or any other treaty which renounces sovereignty over the Panama Canal will have to be approved by Congress: The Senate and the House of Representatives. According to Section B of Article IV of the U.S. Constitution: "The Congress shall have the power to dispose of . . . the territory and other property belonging to the United States."

And the Congress has consistently shown that it is opposed to a give-away treaty: In 1974 a group of 37 Senators, enough to block ratification of a treaty, sponsored a resolution demanding that the government "in no way cede, dilute, forfeit, negotiate, or transfer any of these sovereign rights in the Canal and its Zone." In June 1975 the House, by a vote of 264 to 164, passed an amendment denying funds to "negotiate the surrender or relinquishment of U. S. rights in the Panama Canal. This amendment was taken out by a Senate-House conference committee, but the vote was a clear warning of where the House stands.

Torrijos has apparently spent so much time in international scheming that he has neglected his own country. He alienated the business community which has now lost confidence in him; business has cut back strongly on private investment. This coupled with a world recession has slashed what was a respectable economic growth rate of 8% per year to a meager 1.7% in 1975. As a result inflation is rising sharply and unemployment

United States to maintain public order in Panama if the Panamanian Government could not do so; and the annuity of \$250,000 paid by the United States for use of the canal strip was increased to \$430,000 — on account of the Roosevelt devaluation of the dollar.

Then came a period of overt undermining of our interests in Panama from within the U.S. In 1946 Alger Hiss, the convicted Communist spy, sent to the United Nations a list of U. S. "occupied territories." On that list was the Panama Canal Zone. What's more, Dean Acheson, then Acting Secretary of State, backed Hiss up. The Assistant Secretary of State for Latin America, Spruille Braden, first found out about this move by Hiss through the Jew operated Washington Post, by the way — (Sound familiar?) This incident started a whole deluge of outcries by Communists and their sympathizers about internationalizing the Canal.

But Panama still was not

all strategic waterways.

Despite the many concessions, the Panamanians received from the 1936 and 1955 treaties, they pressed for still more.

In 1958 a partially Communist inspired flag raising spree by Panamanian students in the Canal Zone resulted in confrontations with the National Guard. There were only minor incidents until 1964 when four Americans and twenty-three Panamanians lost their lives in rioting.

In October 1968 a coup d'etat saw Omar Torrijos take power. President Torrijos sports a populist image in the style of Cuba's Communist leader, Fidel Castro; he wears army fatigues and chomps on a large cigar. But, more important, Torrijos is an open supporter and collaborator of the Communist movement.

Upon seizing power he outlawed all political parties except the Communist Party.

With Torrijos in power the whole approach to gain control over the Canal, has changed.

THE ORIGINAL PANAMA

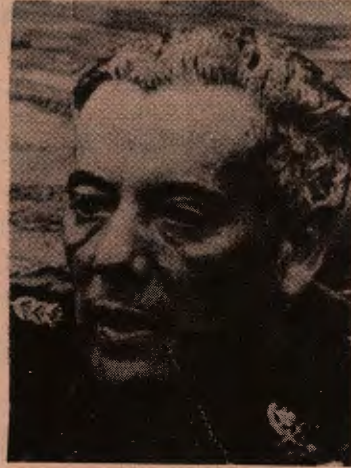

History Of Panama Canal

How U. S. Founded Nation Of Panama

Panama had only enjoyed brief periods of independence before 1903, the year that the United States of America instigated and supported its revolution against Colombia, in whose realm it was a province.

Prior to the revolution the U. S. had been dealing with Colombia for a canal treaty across the isthmus province. But the Colombian Senate had refused to ratify a canal treaty which had been signed by both countries and ratified by the U. S. Congress, Colombia claimed they would not have been compensated for relinquishing rights of sovereignty.

President Theodore Roosevelt, Philippe Jean Bunau-Varilla, the head of the New Panama Canal Company (which would eventually build the canal) and William Nelson Cromwell, a New York lawyer, would not be discouraged by Colombia's stubbornness: they staged a revolution.

bornness: they staged a revolution.

The Panamanians, who had everything to gain and nothing to lose, were eager to consent to this strategy. The following is an account of how the plan unfolded:

The canal treaty with Colombia was rejected by the Colombian Congress in Bogata on August 12, 1903.

Colombia had proposed nine amendments to the treaty including one which called for the retention of sovereignty by Colombia over the canal. President Theodore Roosevelt and W. N. Cromwell decided that the only way they would get canal rights on favorable terms would be to make Panama independent and deal with a newly formed Republic of Panama. The order of the day was that the revolution was on.

At the same time the U.S.S. "Dixie" was put under orders to sail from League Island by the 23rd of October with a force of 450 marines.

On the 24th the U.S.S. "Nashville" was ordered to load supplies and to proceed to Kingston, Jamaica.

On the Pacific the U. S. Navy ships "Marblehead" and "Boston" were ordered to head south from San Francisco.

November 3 was the planned date for the revolt since elections in the U. S. would be held on November 2 and the revolt would therefore escape conspicuous publicity in competition with election news.

By October 28 some of the Panamanian supporters for the revolution, unsure about promised United States military support, started getting cold feet — they said that they were old and did not want to be hanged by the Colombians. In order to keep them from defecting, an encoded cable with false claims of approaching Colombian forces was sent to Washington — the panicky revolutionaries pleaded for military support.

Washington, of course, was well prepared. On October 30 the answer came: "Thirty-six hours Atlantic, forty-eight Pacific."

Thirty-six hours later, on November 2, 1903, at 5:30 p.m., the U. S. warship "Nashville" tossed in the waters off Colon. The U.S.S. "Dixie" was under way from Kingston. The commanders of both ships, however, had no specific orders regarding action toward Colombian warships.

At 11:30 p.m., on that same day, the Colombian gunboat "Cartegena" made way into the harbour of Colon, docked, and 500 Colombian troops disembarked. When this news was wired to Panama City, some of the Panamanians again were on the verge of backing out.

It was, however, decided that the two commanding generals of the unexpected Colombian

anti-communist patriots were about to storm the presidential palace.

In addition, McDonald said, Linowitz is still an "active" registered foreign agent for the government of Columbia, which borders Panama on the east. Linowitz is a partner in the Coudert Brothers law firm here.

"How can our country be properly represented in negotiations with a Latin American state, by a person who is actively promoting the interests of a more powerful neighbor state—and, in particular, by one who served as a foreign agent for a communist dictator?" asked McDonald.

Linowitz has been sent to Panama to conclude a new treaty that will turn over control of the canal to Panama's pro-Castro military dictator, Omar Torrijos.

"The leftist dictator of Panama would like to control the canal," McDonald concluded, "but clearly we should have a negotiator who will ensure that the Panama Canal will remain open to international shipping."

Many nationalists have already written to their senators and congressmen, urging that registered foreign agent Linowitz be withdrawn from any canal negotiations.

School busing would draw its fire

While South Bay school districts try to cope with the problem of desegregation, a small racist group threatens to swing into vocal protest if busing is the chosen solution.

The racist white-supremacy National States Rights Party (NSRP) claims 18 members or interested persons in the South Bay.

ONE OF the main cogs is Chula Vista Robert Rhoady, 34, county organizer for the NSRP. He says he has been meeting with small groups to promote interest in the party, and he claims response has been good.

Rhoady said 18 people in the South Bay are either members of the NSRP or subscribe to the Thunderbolt, a monthly party publication out of Marietta, Ga., billed as "the white man's viewpoint."

The lead headline across a recent edition reads "Interracial marriage is busing's goal."

Party literature explains the NSRP as "a patriotic political order that stands for the rights of the White people and the repeal of all civil rights (and gun control) laws."

Invoking the name of Jesus Christ, the NSRP calls for white power and preservation, only white Christian immigration and sending Africans in America back to their homeland, among other things.

Blacks are a particular target, but other minorities, including Jews, don't go unscathed.

THE ORGANIZATION claims about

300 members countywide, Rhoady said.

Members are from every walk of life, he contended, but the bulk of membership is "working people." And unlike the Klan and some other white racist groups, he added, the National States Rights Party is not interested in keeping a low profile. But it is not violence-oriented, he said.

Of particular concern to the groups was school busing for integration, "and the South Bay could be next," Rhoady said.

WHILE THE group decided on rallies and picketing to protest school desegregation, Rhoady has begun his own local protest.

He says he has approached several local school principals to discuss busing and make known the NSRP viewpoint. Some, he says, are turned off by it. Others agree they are against busing.

SOUTH BAY School boards, he said, "say they are against busing, and they mean what they say. But they are two-faced about it.

The group is against integration because it claims it leads to mongrelization of the white race," Rhoady said, "even if it's a 20-30 year plan."

Non-whites, and particularly blacks, he contends, "cause most of the major crimes in this country, but the news suppresses it.

"And once you let them (non-whites) start taking a little," he said, "they're going to take more and more."

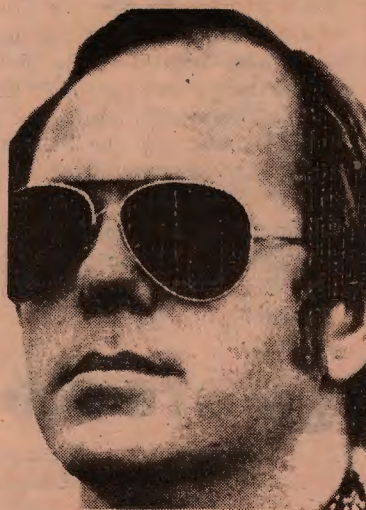

History Of Panama Canal

guests would be put on a short train to Panama City on the Pacific side of the isthmus, and instructed that their soldiers would follow in another train.

Meanwhile, on the Pacific coast, the U.S.S. warships "Marblehead" and "Boston" located at Acapulco, Mexico and San Juan del Sur, Nicaragua, respectively, had been ordered on October 30 to "proceed with all possible dispatch to Panama." All four warships now had orders to prevent any landings that would precipitate conflict.

Back in Panama the two Colombian generals reluctantly agreed to leave their troops behind in Colon; they arrived in Panama City at noon, were innocently welcomed and entertained until 5:30 p.m. at which time they were surrounded by fixed bayonets and told they were prisoners of the revolution.

At this point, on November 3, Panama proclaimed its independence from Colombia.

The commander of the 500 stranded troops in Colon first threatened to burn the town, but then agreed to take a bribe of \$8,000 for himself and a guarantee of passage for him and his troops back to Colombia.

When the commander of the

Colombian gunboat "Bogata," which was in Panama harbour, learned that the generals were prisoners, he had his men fire five or six shells, then threatened to bombard the city if the generals were not released — he, however, soon changed his mind.

On November 4 an unofficial ceremony and parade was held in which a Panamanian representative carried the Panamanian flag while the Acting United States Consul General carried the Stars and Stripes.

On November 6 the United States recognized the Republic of Panama.

Also on November 6 the Provisional Government of Panama cabled Washington that they had appointed P. J. Bunau-Varilla, the Frenchman, (the former chief engineer for Ferdinand de Lesseps, who had built the Suez Canal and who had started the Panama Canal in 1880, but stopped work in 1889) as "Envoy Extraordinary with full powers to conduct diplomatic and financial negotiations." The leaders of the newly formed Panamanian Provisional Government trusted Bunau-Varilla from the very beginning. He had played a role in hatching the plans for in-

struction of the Panama Canal.

dependence. The leaders of newly founded Panama authorized Bunau-Varilla's signing of the deed of sale for an isthmian canal over to the U. S. Bunau-Varilla was the sole author.

On November 7 there was a formal celebration. The new flag of the Republic was hoisted by an American, Major William Murray Black, of the United States Army.

The crowd cheered, so writes Earl Harding in his book, "The Untold Story of Panama," "Viva la Republica!" Vivan los Americanos!"

On November 18, 1903, the Hay-Bunau-Varilla canal treaty was signed.

The new Provisional Government of Panama recognized that just as their republic was founded with U.S. military support, this same support was necessary to protect them from possible reprisals by Colombia. They were wise enough to assure themselves of this protection in Article I of the canal treaty, which reads quite simply: "The United States guarantees and will maintain the independence of the Republic of Panama."

Thus it was America which created the nation of Panama in order to make possible the construction of the Panama Canal.

I've tried very often to get along with the black in the neighborhood and I've gone out of my way and done things that I normally wouldn't have to do with normal, sane people. I guess it is true what your paper has to print. I have found that dealing with a black man is unprofitable and unwise.

I might add that my wife was mugged by two black youths at a drive in grocery in front of 37 witnesses, none of which offered to help. Witnesses being black. So, recently I've had a good taste of what the black issue amounts to.

I hope that other readers will reap from my experiences and find that as a businessman, 39 years of age, that tries to see the good and the bad of all concerned I find it hard to recognize the fact that the black man wants to be equal. I think he only wants to be superior with a life of crime and hatred as well as revenge.

Jews Are Russian "Khazars"

MORE ON THE "KHAZARS"

Editor, The Thunderbolt:

The Koestler book, *The Thirteenth Tribe*, is most welcome for its detailed documentation and for being

straight from the horse's-mouth, as it were. The information is not entirely new, however. The editions of H. G. Well's *Outline of History*, first published 56 years ago, affirmed the Khazar origins of the Ashkenazim Jews quite explicitly. Interestingly, in the revised editions published after World War II, and in the prevailing climate of Judophilia, the original statement was watered down to the claim that the Jews won many converts among the Khazars.

There is still one vitally important matter that needs clearing up. The Khazars were, indeed, a ruling Turkish people. But their empire while it lasted included an original mixed population with Gothic, Scythian, Sarmatian, Greek, and Finno-Slavic peoples. The area covered, not only the Crimea, but most of the Ukraine and the Kuban area north of Caucasus. Large numbers of slaves, both Caucasian and Negro were imported. The inevitable racial mixing took place and the end product was not a case of a pure Turkish race with an adopted religion of Judaism but a vile racial stew. Twelve centuries of intensive inbreeding have produced a distinct and recognizable Jewish type, both physically and psychologically, and the Ashkenazim (Khazars) now represent about 90% of World Jewry.

Jews Claim Germans Owe More "Reparations"

Are Germans Fair To Jewish Victims?

★ THE astronomical figures of German compensation to those who were stripped of their possessions give the impression of generous reparations

The vast volume of goods and machinery sent to Israel and the friendship shown to that country by Germany, help to foster the image of a true penitent giving adequate recompense. Has Germany made up for the losses?

The Germans have undoubtedly paid back huge sums of money to the survivors of their extermination policy, but this serves only to hint at the mind-boggling sums of which millions of Jews were really robbed.

In fact, German compensation, it is estimated, covered an insignificant portion of the spoils — amounting to about two per cent!

Moreover machinery was stolen from Jewish factories and carried off to the Reich which was sorely in need of it. And

Israel's Tuvia Friedman, the Director of the Nazi War Crimes Documentation Centre in Haifa, believes that the Germans stole more than 1,000 billion dollars of Jewish property.

There has been no final settlement by Germany as yet. When there is, there must be a proper evaluation of the looted goods and money assessed by an independent international tribunal.

Time To Stop Apologizing For Speaking The Truth

ATTACKED FOR TELLING THE TRUTH

Recently there has been a rash of cases in which prominent people have spoken out on the racial subject only to be attacked by organized minority groups for simply exercising their freedom of speech. Everyone is familiar with Gen. George S. Brown's statement saying that the Jewish lobby has too much influence and our military supplies have been drained by Israeli demands. Former Secy. of Agriculture Earl Butz said that blacks were more interested in sex, wearing loose shoes, and a warm place to go to the bathroom than they were in serious politics. Both men were denounced and asked to resign. Butz did lose his job.

Other cases which did not receive as much publicity include the following:

Dallas Police Chief Don Byrd at a meeting with other police heads said: "The niggers have to wear badges to keep themselves from killing each other. In Dallas most of our murders are committed by blacks." The statement was true but negro Atlanta police head Reginald Eaves demanded a retraction.

Washington, D. C., police set up a dummy fence operation to trap negro thieves trying to unload stolen merchandise. They used a man with a Jewish name to run the front; "because most fences are Jews and the blacks would be more easily taken in." This enraged "The Jewish Week" publication which charged that this police stereotyping of Jews was the worst slur they had ever heard — yet it is still THE TRUTH!

editor of a Philadelphia negro paper, "Nite Life," on several occasions has accused Jewish businessmen of ripping off blacks. Searles wrote that during the 1960's when blacks were crying "Burn, Baby, Burn," Jews sold their shops "and took off to the hinterlands. Now there is an all out scheme shaping up to return the Jews to North Philly, aided of course by their political connections, to re-inhabit this lucrative area."

On another occasion he charged that a move to oust Rep. Robert Nix, Sr., was "strictly a case of Jewish money, Jewish power being used to take over this city." Searles has also charged that Jews "take from a community and don't put anything back." Local Jewish Anti-Defamation League head Samuel Gaber attacked the Philadelphia Human Relations Commission for honoring Searles for his "fearless outcries against crime and for stability and improvements of negro neighborhoods." With the Jew parasites gone, there must have been some improvement but the fact is that the Jew can stand no criticism of any kind regardless of how factual the statement is.

More "Reparations" For The Jews?

On this page we reproduce a shocking statement from "The Jewish Telegraph" published in London, England. To date, the West German government has paid so-called Israel over four billion marks in so-called reparations. This has included the establishment by the West Germans of some 1,300 factories and businesses for the Jews in Israel. All are owned by Israel's giant Marxist Histadrut union. America also gives Israel some \$3.5 billion in aid each year.

Without all this flood of outside money, Israel would collapse — as she may still do anyway! Remember during the depression of the 1920s when a 100,000 German Mark was worth only 43 cents? That is when the Jew, using international finance, bought up billions of Marks on very small investments. They, in turn, bought property, business, buildings, newspapers, etc., etc. The rising tide of anger against

the Jews at the end of the depression had nothing to do with Hitler.

The German people realized that their nation had simply been bought up wholesale by Jewish finance. The German people lived in dire poverty while the Jews rode around in chauffeur-driven limousines and "lived high off the hog." Interracial Couple Opposed

(From Front Page Of "Daily Mail")

There is some apprehension and a good deal of speculation in Schell City following a rash more than a week ago of racist signs that were pasted to several buildings, including two churches.

The antiblack signs, printed on orange cards about the size of notecards, contain slurring comments about Negroes and provide an address where further information on "racial differences" can be obtained.

The Vernon County Sheriff's Department and Schell City's marshal are "looking into" the incident, but so far no one has filed a formal complaint about the signs.

The signs appeared on several buildings the morning of Sept. 27. The small orange cards read:

"Warning. Racially mixed couples pollute white race. Negroes have a low IQ. Negroes have small brains. Negroes never created a single civilization. For facts on racial differences, write Thunderbolt Inc., P.O. Box 1211, Marietta, Ga. 30061."

The orange cards were pasted in pairs on the Methodist and Baptist church buildings, on Farmers State Bank, on the Schell City Post Office and on the front door of a cafe. At another cafe, the cards were mixed in with napkins used by customers.

Several persons discussing the matter have directed speculation about who put up the signs toward the Church of Our Christian Heritage, a splinter quasireligious group located at Halley's Bluff west of Schell City. However, City

Marshal Thomas said he has no hard evidence of this.

The Church of Our Christian Heritage is a racist group that advocates white supremacy.

"We don't know they did it," said one Schell Citian who asked not to be identified for fear of reprisals, "but I'll bet you someone — maybe even some outsiders — from that bunch put up the signs."

Outsiders have been attracted to Halley's Bluff — an area of historical significance in Vernon County because of its connection with the Osage Indians and early French traders — by an academy operated by the racist sect that provides training.

Discourage Mixed Marriage

Since then, individuals connected with the Church of Our Christian Heritage are reported to have made racist remarks to and against blacks in Schell City. But residents said the pasting of the orange cards was the first incident of that type.

Among the speculation heard frequently in Schell City is what prompted the signs to be pasted up in the first place.

The most prevalent opinion is the fact that a racially mixed couple has attended the Methodist Church in Schell City.

"Most everyone here knows about the couple and accepts them," said another Schell Citian who asked not to be identified. "Some of us have our own ideas about that, of course, but we certainly wouldn't harrass them or try to keep them from going to church. It's that Halley's Bluff bunch that's stirring everything up."

Whites with negroes. Many people have been led to believe that there are no differences between the races. Of course, just the opposite is the case. Negroes have a much lower intelligence and have never created a single civilization. When they intermarry with Whites, their offspring favor the negro parent because their genes are dominant over a White person's genes at a 4 to 1 ratio. In Schell City, Mo. there is an interracial couple which has been attending the Methodist Church there. We hope that this incident has opened the eyes of the White girl involved and that of her parents so that they will stop this interracial debasement of the White race and eliminate this threat to the continuation of their White family line.

We congratulate our supporters in the Schell City area and hope that their activity will encourage others throughout the nation to order more of these effective anti-race mixing stickers. We receive letters from new people daily requesting free literature on "racial differences." Thousands of new people are thus being reached. You can carry these stickers in your wallet or coat pocket and easily stick them up where they can be viewed by many people without calling attention to yourself. Let them contact us and we will rush those interested free literature.
