Secret Behind Bakke Case

Boycott Polaroid

Polaroid Corp. Stabs South Africa in Back

The Polaroid Camera Corp. of Cambridge, Mass. is the very first firm to bow to the demands of black militants and and National Council of Churches and cut off all sales to South Africa. The huge film company is giving up its \$4 million per year business with South Africa in protest against the White government.

This is the first firm to voluntarily initiate its own embargo against White people in order to make life harder for our racial kinsmen there. To make sure this is not the beginning of a trend, we urge all *Thunderbolt* readers and members of all White organizations to join with members of the National States Rights Party in a total boycott of all Polaroid film products. You can also write the firm in Cambridge, Mass. and tell them what you think of their treachery.

TV Networks Ban South Africa Ads

The flagship TV stations of ABC, CBS and NBC have all agreed to stop running paid ads for the South African Krugerrand gold coin. Many thousands have been purchased by Americans as a hedge against inflation and the devaluation of paper money. WABC-TV stated that the ads were "offensive" to certain viewers. The Marxist American Committee on Africa has long been urging a ban on the sale of the coin. It should be noted that the heads of all three TV networks are Jews: NBC president Herb Schlosser, CBS chairman William Paley and ABC head Leonard Goldenson.

National Council of Churches Takes Anti-Christian Action

The National Council of Churches (NCC) represents 30 Protestant denominations. They are demanding that the 350 major U.S. corporations doing business

with South Africa cut all ties with that nation. Their action is to destroy two White Christian republics in order that atheistic communism can prevail.

The NCC charges that such giants as General Motors, Ford, Mobil Oil, Goodyear and General Electric have an investment of \$1.7 billion in South Africa. Such banks as Citibank, Bank of America, Chase Manhattan and others have loans and credits amounting to \$2.2 billion.

Andrew Young addressed the NCC meeting which adopted the "pull out of South Africa" resolution. Young screamed: "Lord have mercy for the hell which falls on John Vorster, not after death but in the day to day sinful life that he has adopted as national policy in that government." Thus spoke the big mouth of the Carter administration.

On Nov. 21 Young joined a U.N. Security Council committee in issuing a report calling for legal action against Mobil Oil and Royal Dutch Shell for allowing their products to reach Rhodesia. A Judas Iscariot named Bernard Rivers from London had traced \$100 million a year in oil to Rhodesia from South African oil subsidiaries.

We must demand that White Rights be protected and not be sacrificed by Carter and Young to the communists. What can you do? Boycott Polaroid, expose the TV networks to your friends and by all means DEMAND that your church pull out of the National Council of Churches. Do not contribute another dime until your church quits the Council. Order and distribute extra copies of *The Thunderbolt* so your friends will also know the truth about what is going on against the White Race and that these things are directed from Washington and New York City.

John S. Buckley charged that his uncle, William F. Buckley, is "gravely mistaken" in supporting the giveaway of the Panama Canal. The young Buckley is national chairman of Young Americans for Freedom.

Jewish lawyer Reynold Colvin, representing Allan Bakke before the Supreme Court, is quoted in the *Southern Israelite* of November 7 as stating that results from the Bakke case should not disrupt "previously aligned civil rights activities" of negroes and Jews working together. Colvin is chairman of the American Jewish Committee in San Francisco.

Jewish Anti-Defamation League National Chairman Burton Joseph is quoted in the *Dallas Times-Herald* of October 22 that: "The ADL takes the position that race cannot be made the basis for college admission. We have always opposed quotas that kept us out of the system."

Larry Lainsky of the ADL is quoted by columnists Evans and Novak as saying that "racial, ethnic and religious identification of student applications violates the right of privacy and poses the danger of discrimination."

Jewish Week of November 6 states that the American Jewish Committee supports "affirmative action programs" for low level job openings, but opposes college racial quotas.

Charles Wittenstein, lawyer for the Southeastern ADL said that "no one should be denied admission to school on the grounds of race."

American Jewish Congress leader Mark Schickman is quoted in the *San Francisco Chronicle* of October 13: "We support affirmative action in employment, making race a college entrance requirement would impose an economic disadvantage on a certain racial group."

Jewish Groups Finance Bakke Case

Allan Bakke is the student whose case is now before the Supreme Court seeking to overturn the University of California Medical School program of granting 16 out of every 100 spaces to coloreds. Bakke has a grade point average of 3.51 (out of a possible 4.0) compared to the coloreds average of 2.88. Bakke was, in turn, denied admission and the 16 coloreds were accepted.

At first glance we would agree with many who support Bakke and shout foul, that this is a perfect example of "reverse discrimination." But then we notice that the eight largest Jewish organizations in America have filed briefs supporting Bakke. His long and expensive appeal to the Supreme Court has been financed and publically supported by the Jewish Anti-Defamation League, American Jewish Committee, and the American Jewish Congress. Why are the Jews so totally involved in this important case?

Jews constitute about 4% of the total population of America. White Christians are something over 75% of the population, with negroes and Asian and Hispanics making up the balance. (Illegal immigrants are not included in these figures.) An astounding 80% of all Jews get into college, as opposed to less than 20% of all White Christians.

The Jews have jammed our nation's professional schools which produce doctors and lawyers. All of our "Ivy League" colleges in New England have been overrun by Jews. They make up from 25% to 50% of all medical students in some schools. At Emory Medical School in Atlanta, the Jews make up 30% of the student

body. Look in your phone book and count the number of Jewish names in the lawyers section of the yellow pages.

In the professional schools, from 15% to 40% of the faculty are Jews. Over half the presidents of the "Ivy League" colleges today are Jews. The hordes of Jews in New England, Chicago, Cleveland, Philadelphia and Miami overflow the local colleges and spill over in large numbers at schools throughout the nation. Friends at the University of Georgia and the University of Alabama tell us that their campuses are overrun with New York Jew students.

If the U.S. Supreme Court should decide that colleges can legally admit students by race and nationality, this would be a tremendous blow to Jews, who today dominate our professional class. Remember that a medical degree guarantees even a mediocre doctor an income of over \$100,000 per year!

If we were given nationality and racial quotas, the Jews would be kicked out of the nation's colleges by the thousands. There would be far more spaces for White Christians. Negroes who got in would soon flunk out and we would have an all-White university system again.

It was not too many years ago that many of America's leading colleges and universities limited the enrollment of Jews. They used their money power for years in fighting such restrictions and eventually won. To go back to a quota system would be a major disaster for the Jews. Here is the real story behind the Bakke case - a story which the daily press has totally suppressed and the general public is allowed to know nothing whatsoever about. Let us bring these facts to the attention of the vast majority of our people so they will realize that White Christians are the most discriminated against people in this land and the Jews are America's most privileged.

The Supreme Court is expected to rule for Bakke in a narrow decision that will only benefit the Jews and not help White Christians. We must demand that the Court go all the way and stop all discrimination against White people in employment, education and all other fields.

No Race Mixing For Politician's Children

Children of Washington Officials in Private Schools

All U.S. Senators and Representatives in Washington have their children in private schools. This includes those who are strong advocates of forced busing for children of White working people. Most Whites who cannot afford private schools for their children believe that those who favor such should set an example for the rest of us.

Those with children in private, mostly White schools, include Sec. of Agriculture Bob Bergland, Sec. of Labor F. Ray Marshall and Sec. of H.E.W. Joseph A. Califano. Vice Pres. Walter Mondale has his son in St. Albans, where the tuition averages \$2,850 per year. As a Senator, Mondale was known as "Mr. Busing" in Washington.

Sec. of Transportation Brock Adams took his two daughters out of a Washington negro school in the sixth grade. He found his children one year behind the scholastic levels of children in private schools.

Mrs. Betty Adams was quite frank in admitting the reasons for the change to private schools: "I

believe in public education, but cannot allow my children to be used as guinea pigs. We felt that the educational system was collapsing and that the teachers were spending more and more time trying to maintain discipline."

This is the complaint of ALL parents in America who do not have the money to place their children in private schools. This means that our children are made the "guinea pigs" in a social experiment which is a proven failure.

Others who still have young children and have placed them in private schools in Washington include the following in the exclusive St. Albans school: Rep. Lawrence Coughlin, R-Pa.; Sen. H. John Heinz III, R-Pa.; Sen. Charles Mathias; Vice Pres. Mondale; Rep. Newton Steers, R-Md.

Attending the National Cathedral School for Girls were children of Sen. Ted Kennedy; Sec. of Transportation Brock Adams; Rep. Clarence J. Brown, R-Ohio; Rep. Butler Derrick, D-SC; and Rep. Paul G. Rogers, D-Fla.

Billions for U.N. World Bank

Last month Congress approved \$1.3 billion for the U.N. World Bank. This money is given as "easy credit loans" to backward countries of the world. Of the 3.9 billion people on this earth, 3 billion of them earn less than \$300 per year.

While our tax dollars cannot do much to alleviate poverty on such a vast scale, we do make the directors of the World Bank wealthy. The bank sets its own salaries and the directors representing each member nation are paid \$84,000 per year. Robert McNamara, World Bank president, receives \$111,570 per year. (Secretary of State Cyrus Vance is paid \$60,000) When all the wages, costs and travel expenses are paid, there is much less to give the poor. McNamara's recent weekend flight to Paris cost \$10,900.

Shocking Interview With New Immigration Chief

Mexican Leonel J. Castillo was chosen to replace General Chapman as head of the Immigration and Naturalization Service because most illegal immigrants are from Mexico. Carter said that Castillo could deal with the problem since they were his own people. Well, that does not sound like much protection for the Americans when the solution to this problem is a life and death matter for the future of the White race and America.

Stephen S. Rosenfeld published an interview with Mr. Castillo which was printed in the Washington Post on November 25, 1977. Rosenfeld wanted to discover whether or not it was true that Castillo was "soft" on those who are now called "undocumented aliens." Formerly they were referred to as "illegals" but now they are "undocumented."

Castillo, 38, stated that he "likes" such immigrants and is awed by the fact that many of them have walked 100 miles in order to get into this country. He added: "Many of them would be good Americans. They have the work ethic that so many of us have lost. They are so keen and competitive. They never refuse to work overtime."

He sidesteps the question of how many go on welfare once they become citizens (and eligible) as do other minorities. Castillo says that he supports Carter's plan to grant amnesty to all illegals who arrived here before 1970 and grant 5 year legal residence to those who arrived before 1977 (meaning they could then apply for citizenship after the 5 year work period.)

Castillo says he hopes that Congress will adopt Sen. Cranston's proposal to give Mexico the unused portion of Canada's

20,000 yearly immigrant quota. We say why not give this to some White European nation such as Ireland or Germany which have been all but cut out of the immigration quota since the passage of the Kennedy Immigration Law of 1965. Kennedy favors colored "Third World" nations. Write your Senator opposing the Cranston proposal.

Castillo says that amnesty would be a net "economic gain" as these people would begin paying taxes. Right now illegals claim between 10 and 20 dependents so that they have no income tax deductions taken out of their pay checks.

Castillo said that the McCarran-Walter Act allowed refugees from communist countries into America as political refugees. Amazingly he proposes that this "right" be extended to all dictatorships in general.

This means that all the dissatisfied negroes in Africa would be able to enter America as long as they did not like their current dictators. All of Asia and South America would be eligible to move to America to get away from "dictatorships." This statement by Castillo alone should be cause enough for the Congress to remove him from office. There can be no doubt that this nation is presently in very great danger because of lax enforcement of our current immigration laws. This single problem is the most severe crisis facing America today. It is much more important than any other issue now being talked about over TV or in the daily press. Let's get busy and awaken the nation now while there is yet time to close the immigration flood gates. Remember, we are still a majority in this nation. Place one of our "Send Illegal Aliens Home" bumper stickers on your car and help get people thinking in the right direction.

"Dishwasher" Rips Off Maddox

Former Gov. Lester Maddox ran ads in the Atlanta Newspapers last month warning his friends not to contribute to something called the "Lester Maddox Heart Fund." He is recovering from a heart attack suffered in September and charged that a certain "entertainer and musician" was collecting money in his name but without his consent.

It turns out that the culprit was negro Bobby Lee Fears, an ex-convict who had worked as a bus boy in Maddox's restaurant. Maddox made Fears famous when he co-starred with the young negro in a nightclub act which he called "The Governor and the Dishwasher."

Maddox said he was "out of the entertainment business" and had not been in contact with Fears recently. Many Patriots felt the act was in poor taste and Maddox was surprised when Fears reverted back to his nigger behavior.

Schlitz Sales Down

Beer Boycott is Effective

White workers at the Schlitz brewery in Memphis have urged a nation-wide boycott to dramatize job discrimination against Whites at their plant. Schlitz has been guilty of promoting low seniority blacks over whites and hiring negroes almost exclusively as new employees. The Thunderbolt encouraged its readers to boycott Schlitz beer because of their anti-White bias. At the same time we warned that Budweiser gave large sums of money to the NAACP and the Urban League. Also, that Miller Beer was bought by Jew-owned Philip Morris cigarettes. Schlitz, Budweiser and Miller represent over 75% of the beer industry and are fast putting all their competition out of business.

The strike by White workers at Schlitz has had its effect. Sales for the last quarter declined from \$49 million to \$29 million, a 14% drop from the same quarter 1976. In the wake of this news, Schlitz president

Eugene B. Peters was forced to resign at the Milwaukee headquarters. We believe that this will serve as a beacon for other White workers who refuse to accept blatant job discrimination.

Truth In Packaging

Gay Legislation

Negro homosexual California State Representative Willie Brown's bill to allow transsexuals to have their birth certificates sealed by court order was adopted by a 40 to 11 vote and signed into law by Gov. Jerry Brown. This will allow so-called transsexuals to conceal their sex designation and even to marry unknowing normal people. This is supposed to be part of the "Gay Rights" proposals. What we want to know is how the rights of "straights," or heterosexuals are going to be protected from such frauds.

How Baxley Framed Bob Chambliss

Another Innocent White Man Is in Prison by Dr. Edward R. Fields

Robert Chambliss did not bomb the Sixteenth Street Church in Birmingham, Ala. He has been sacrificed on the altar of Bill Baxley's political ambitions. If there was any significant evidence to convict the 73-year-old Chambliss in the 14-year-old case, that could have been done years ago.

Bill Baxley has been Attorney General of Alabama for 7 years now and he waits until he has launched his campaign for Governor, to succeed George Wallace, before he had the elderly Chambliss indicted. Over 30% of the voters in Alabama are negroes and in a five man race Baxley knows that this solid bloc vote will be enough to get him into the runoff.

The evidence presented by Baxley during the trial was not sufficient to justify a guilty verdict. Baxley was able to muster tremendous pressure from the press and TV media which had an impact on a jury which thought it was compelled to "solve" this old case.

Mr. Chambliss' lawyer, Art Hanes, Jr., said that the jury was not made up of the defendant's peers. When they were picking the jury, the defense was shocked to discover that 21 of the 42 members of the jury panel were negroes. Blacks make up just 30% of Jefferson County from which the jury is chosen and that percentage of blacks should not have surpassed the Whites on the jury panel.

Mr. Hanes had to waste all of his strikes on blacks while Bill Baxley used up all of his strikes to eliminate White working class men from the jury. The jury was made of 3 negroes, 7 White women and 2 White males. Baxley knew that the negroes would vote "guilty" and that the 7 White women could be emotionally influenced against Chambliss with the grisly photographs of the four dead negro girls. One was decapitated. White males would be more interested in the evidence of a man's innocence or guilt and not influenced by such photographs.

The Evidence Was A Sham

The evidence against Bob Chambliss was a farce. It consisted mainly of three highly questionable witnesses. Here is a summary of their testimony and character.

1) Mrs. "Rev." Elizabeth H. Cobbs, Chambliss's niece on his wife's side, testified that Chambliss said negroes would regret forcing their way into White schools. She claimed that he said after the bombing that something must have gone wrong because no one was supposed to get hurt in such bombings. There had been some 50 bombings and no one was ever hurt. It was talk of the town at that time that the explosive must have malfunctioned and accidentally went off at a later hour when the negroes were in the church.

Mr. Chambliss shook his head in disbelief that his niece could tell such stories about him. Talking to this editor over the phone before the trial Chambliss said: "Dr. Fields, I swear on my mother's grave that I never did bomb that church." If you could have heard the sincerity in his voice you would know that he was telling the truth. Also Mrs. "Rev." Cobbs is not an ordained minister of any recognized Methodist Church. The Southern Methodist Church does not ordain women and Mrs. Cobbs is affiliated with an off-beat church using the name Methodist. It supports race-mixing and takes in negro members, as well as racially-mixed couples. Is it any wonder that she must have dearly hated her uncle for his past Klan affiliations!

2) Mrs. Yvonne Young was another Baxley witness who was once a neighbor of Chambliss. She testified that she once saw a bundle which looked like firecrackers in the Chambliss home. She said she later thought it might have been dynamite. Attorney Hanes brought out on cross examination that she had once been committed to an insane asylum. Her testimony should not have been considered by the jury.

Macon Weaver, the U.S. Attorney in charge of the bombing investigations in 1963 said that "There never was enough of a case to require a decision on seeking indictments." He told the Birmingham News on December 1, 1977 that "we never felt there was enough evidence to go to the grand jury." Mr. Weaver, now an attorney and U.S. Magistrate in Huntsville, Ala., said that their records did not show either "Rev." Mrs. Cobbs or Mrs. Yvonne Young coming forward during his exhaustive investigation to testify. Was it to collect the \$10,000 reward offered for witnesses in the case? Macon Weaver stated that even with their statements, "I still think the case was weak."

Indeed it was, and there was not enough evidence to justify the verdict of first degree murder.

Negress Kirthus Glenn of Detroit was the other witness who influenced the jury. She testified that she was out on the street near the church at 2am in the morning of the bombing and saw Mr. Chambliss in the dark of the night in a car with three other men. She was not sure how many were in the car. She picked his photo out of an FBI file of suspects two months after the explosion. In the meantime, Chambliss' photo had appeared in the press and over TV nationwide and he was well-known as an active segregationist.

There you have it - THIS IS THE FLIMSY EVIDENCE WHICH MADE UP BAXLEY'S CASE.

We believe that defense attorney Art Hanes, Jr. made a tactical error in not placing Bob Chambliss on the witness stand to deny the

Third Class Mail Dumped Norwalk, California

Residents were concerned because their third class mail was not being delivered. A group of them went to the post office and found a large trash bin filled with third class mail correctly addressed to them as well as to their neighbors. The mail was deliverable, but several negro mailmen did not want to bother with it.

At a Norwalk city council meeting they dumped the mail on a table. It included 2,000 brochures from Republican Congressman Del Clawson, grocery "best buys" from the Market Basket, and other items including a brochure requesting funds for Notre Dame.

Postal Inspector A. Greene promised an investigation, but local postmaster Julian Grembla said the allegations were "vague." Mr. Jim Griffin, 1143 Liggett Street, Norwalk, heads the protest committee. They returned to check out the post office trash bin and found it locked with a "No Trespassing" sign posted. Rep. Clawson said that was "too much" and he personally demanded an investigation.

lies which had been directed against him. At the same time he was presumed innocent and there was certainly reason to doubt the heresy and circumstantial remarks which made up all of Baxley's case. One White juror did hold out for an innocent verdict for 5 hours. Since he believed Bob Chambliss not guilty, he should have stood by his convictions and never allowed the disgraceful guilty verdict to be returned.

Bob Chambliss' wife could not testify because she is seriously ill in the hospital and may not recover. Chambliss is now sealed in prison while his case is being appealed, but he has stomach cancer and is not expected to live but a few years. Your editor has never been more convinced of a man's innocence than I am of Bob Chambliss.

He was operated on for cancer four years ago and it has returned. We want to see him freed while his case is being appealed. Actually, Gov. George Wallace should investigate the methods used by Alabama Attorney General Bill Baxley and the perjury which is self-evident in this case. Mr. Chambliss is deserving of a pardon, but with the minority and media pressure, this is probably unlikely. Under Alabama law, one convicted of first degree murder cannot remain free pending an appeal. What Gov. Wallace could do is commute the sentence to a term of 10 years and this would automatically make Bob eligible for bond pending appeal.

This would give him the opportunity to be by his wife's side in the hospital and receive adequate medical attention at the same time. This will also allow additional time for more revelations concerning Baxley's false witnesses along with news revealing evidence of illegal activities on Baxley's part which show him to be a total political animal. He is willing to frame innocent men and work with the underworld in order to gain his ambitious goal of becoming governor of Alabama. We will continue to dig out the facts behind this vicious frame-up of a sick, elderly, Patriotic Whiteman who deserves justice. We will not rest while Bob Chambliss, a totally innocent man, remains behind bars of the vicious and unprincipled act of the race-mixing scoundrel Bill Baxley.

White Prisoner "Not Guilty"

Stoner Wins Prisoner Case

The Thunderbolt has carried numerous articles detailing the atrocious conditions existing within the nation's prison systems. Forced race-mixing has brought violence and intolerable living conditions for White prisoners. Since negroes commit most of the crimes of violence in America, they constitute a majority of the prison population in many state correctional institutes.

Young Whites are often made the target of homosexual attacks by blacks. We have many letters from prisoners which detail such episodes whereby negroes actually try and enslave Whites for the practice of sodomy and other depraved acts. Most of the violence which takes place in prisons revolves around Whites who must defend themselves from such advances.

The Georgia State Penitentiary at Reidsville has been the scene of many such confrontations in which Whites had to defend themselves. White prisoner James Dobbins was likewise set upon by several blacks who were illegally carrying knives. In a brutal fight for his life, Mr. Dobbins was able to wrest one knife away from a negro attacker. He quickly stabbed both the blacks and the rest ran away.

For defending himself, James Dobbins faced a maximum of ten years added to his current term

Attorney J.B. Stoner defended him in a trial which began Dec. 5. In his defense, Mr. Stoner did not deny that Dobbins did

indeed actually use the knife. Stoner argued that he was the victim of a deadly attack in which the negroes

sought to kill him out of their hatred for the White Race. Self-defense was the main defense argument. The conditions under which Whites are forced to subsist were vividly described to the jury. After deliberating only 10 minutes they returned a "not guilty" verdict.

This was an important victory and we hope that prisoners who usually plea bargain for a guilty verdict (which still adds about 4 years to their terms) will see this as a precedent. The proper defense explaining prison conditions which the general public has never read about in the daily press can and will win acquittals. Whites must stand up for their rights and should not be punished for so doing.

Courts Free Many Black Killers

The stuntman was sentenced to spend weekends in jail for the next six months. Evel said it was worth it, and that he would do the same again in order to defend his honor.

Sounds like good old-fashioned pioneer justice, doesn't it?

A Dim View Of German TV Image

Ottawa

West German Chancellor Helmut Schmidt quietly suggested to Canadians yesterday that World War II is over and it is time to dispense with the "ridiculously negative stereotypes" of Germans portrayed in U.S. television programs shown in Canada.

Speaking at a news conference at the end of a two-day official visit to Ottawa, the chancellor said, "One must be permitted to say 34 years after the war that we have built a new Germany.

"Let us use our imagination and exchange actual information about each other. As far as I am concerned, I do believe the German of 1977 no longer fit into the image of 'Hogan's Heroes' and outdated wartime cliches," he said.

Beleaguered Ethiopia Uses Dynamite For Executions

A report out of Addis Ababa, Ethiopia, says officials in that West African country are using dynamite for executions because of a shortage of ammunition.

A Swedish official, Stefan de Vylder, says another common method of execution is cutting

throats.

The troubled, Marxist government of Ethiopia has been battling insurgents in the province of Eritrea since Haile Selassie was toppled as head of the country.

De Vylder said most of the 655 youths officially admitted to having been executed in May were found with their throats cut.

Negro Killers Find Courts Lenient

There have been a string of court decisions where negroes have been released despite a preponderance of evidence against them. One of the chief reasons for the current rise in crime is that many members of minority groups know that they will receive a light sentence or even release from serious charges including murder and rape.

Columbia, S.C. negro Reginald McCants, 16, was found not guilty by a jury of 11 blacks and one White. He was charged with rape and murder of Josephine Richardson, 25. He had made a confession. The jury found him innocent after his Jewish lawyer, Harry Levy, argued that McCants was tricked and a "man's life is at stake."

Levy charged that jurors should take into consideration McCants "tender age." After the trial one negro on the jury said: "I hear he wants to become a counselor. Maybe this case will have some positive effects on him." There was some delay in releasing McCants because in the meantime he had been charged with raping a young White youth in their jail cell. Since he was still a 16 year old juvenile, he was freed on his personal recognition.

Uganda's girl pilots 'hopeless'

UGANDA girl pilot-trainees at an air training school in Scotland are hopeless, according to instructors.

Staff at the Air Service Training School in Perth believe that President Amin will recall the nine girls to save them failing ignominiously.

One instructor said: "A couple might eventually get a private pilot's licence, but they have no chance of passing the Civil Aviation Authority's tests — and the preliminary exam on instrument knowledge is coming up soon".

Chicago, Ill., David Rodriguez, 22, was charged with the rape of a 15 year old White girl and the robbery of her father. The court psychiatrist, Dr. R.A. New York City Ronald Timmons was indicted for the beating and robbing of an 82-year old White woman. He was released on a \$500 bond. He then fled the city to avoid prosecution. Caught, he was returned and placed under a \$50,000 bond. This time, Judge Maurice W. Grey of the State Supreme Court heard an appeal from Jewish lawyer Martin Gotkin protesting the "excessive bail." Gotkin said the high bail was set during an "atmosphere of hysteria." Judge Grey did not lower the bail but sent Timmons to a mental hospital for psychiatric examination. His reason: "Anyone who allegedly commits such a crime against an 83 year old woman should have a psychiatric examination."

It is a shock that the judge does not realize that elderly Whites are the main targets of cowardly negro criminals and there is nothing unusual about this case. The time has come for White Americans to awaken their fellow men to exactly why violent crime is skyrocketing in America.

"They quite obviously fall well below our normal standards of acceptance and, as such, damage the morale and reputation of what is regarded as the world's top air university," said another instructor.

dept. State Atty. Dennis Cooley said that the Rodriguez case is an example of how defendants in Illinois slip through loopholes in the law. The defendant was released in the care of the court psychiatrist.

Knoxville, Tenn. Negro Buel Wilson, 30, has been given a new trial in the murder of young Larry Jackson, 23. The Jackson youth was a former University of Tennessee cheerleader and was voted the most popular boy at Overton High School and vice-president of his senior class.

Wilson said he got into an argument with Jackson at the parking lot where the White youth worked. Wilson said he shot Jackson because he got down into a "karate stance" and he felt menaced. The Tennessee Supreme Court ruled that the prosecution erred when they allowed Wilson's previous record to be introduced at the trial. It brought out that Wilson had been involved in a prior shooting, arrested on drug charges, once pistol whipped his girl friend, and drew a gun on a policeman. The high court ruled that this prejudiced the jury against the negro.

Detroit, Mich. has really become a jungle with negro dominated juries refusing to convict black killers and rapists. A good example is the case of Rutherford Massenberg, 17, charged with killing a White businessman in a city-owned parking lot near Olympia Stadium. He signed a confession. Negro Judge George Crockett said, "there was no doubt in my mind that he was guilty." Still a jury of 8 blacks and 4 Whites found him innocent.

The so-called Cobo Hall gang was tried for the rape and robbery of two suburban women. A jury of 11 blacks and 1 White found the 6 negro youths innocent despite a confession and positive identification by the victims.

A jury of 10 blacks and 2 Whites found 4 negro youths innocent in the rape of an 89 year old White woman. She had phoned in a 911 emergency call but the negro operator refused to send out a squad car when the victim said negroes were breaking into her home. Again there were confessions. White Judge George T. Ryan said: "I'm convinced the confessions were good. I would have found them guilty."

White jurors have said that they went along with the black majority out of fear of physical violence while they were locked up during deliberations. Thus the creeping menace of African terror is taking over our judicial system. There is a growing break down in law and order with negro juries refusing to convict their own kind regardless of how strong the evidence against them is.

Carter-Young Sabotage South Africa

Great Rhodesian Victory

A few months ago a 6 month old White baby was snatched from her maid by communist guerrillas. The child was Natasha Glenny and she was brutally bayoneted to death. Later the black insurgents ambushed the little girl's parents in their car, but were repulsed without any further loss of White blood. The baby was the 107th White slain during the 5 year war. More than 1,000 black servants of Whites have been slaughtered.

A week later, Rhodesian Rangers cornered and killed 45 black terrorists who were thought to be the cowardly killers of children. Last month the greatest victory of the war was won by White settlers. Two communist guerrilla training bases were located deep in Mozambique. Striking with vintage Mirage fighter bombers, helicopters and paratroop drops, Rhodesian commandos blew up ammunition dumps, buildings, and vehicles. Some 1,200 black guerrillas were killed.

This meant that one-fifth of the ZALNA forces under Soviet-trained negro leader Robert Mugabe were wiped out. It is said that this is part of Ian Smith's policy of "Talk - Talk, and Fight - Fight" for peace. The fiendish murder of little Natasha Glenny and the other Whites was partially avenged. The United States State Department condemned the Rhodesian raid. To date there has yet to be any American condemnation of outright murder of innocent Rhodesian civilians.

On November 7, Andrew Young attacked South Africa's Prime Minister John Vorster as "very much over the hill intellectually and in every other kind of

It should be noted that Young's only visit to South Africa was at the invitation of the Jew Harry Oppenheimer in whose home he stayed. Oppenheimer is the mongrel who controls South Africa's diamond and gold mines and is one of the world's richest men. He and his wife work openly for black rule and race-mixing.

U.S. Begins Embargo Against South Africa

SOUTH AFRICA IS OUT OF PATIENCE

The seriousness of Mr John Vorster's warning that South Africa would reach a point where it would no longer be prepared to accept the further application of double standards or outside pressure, has apparently not completely penetrated the outside world, because, according to Dr Kurt Waldheim, the general feeling at the Lagos conference was that the time was ripe to decide on a programme of action against South Africa.

At the same conference Mr Andrew Young compared South Africa's internal policy with a cancerous disease which could quite possibly be lethal. He believed, however, that the "disease" could be cured and that it was not necessary to destroy the "patient" in the process. But in the same breath he added that he had never condemned a man's right to resort to armed violence for his freedom.

The only difference between Young and the more militant in reaching the eventual goal of Black majority rule in South Africa, is in the methods and

tactics to be used. It is also the only difference between the approach to South Africa of the West, the Afro-Asians and the communist countries.

The one group wants to destroy South Africa in a civilised manner, while the other wants to do it by brute force. Young impresses nobody by saying that no one in the UN or the OAU has asked that the 4-million Whites in South Africa be destroyed. After all, an Egyptian spokesman at the UN's sub-committee on the prevention of discrimination has just questioned the right of White South Africans to remain in the country and the American representative on the committee said that there must be continuous pressure to introduce one-man-one-vote in South Africa.

Dr Connie Mulder repeated Mr Vorster's warning yesterday, and he added that if the world wanted to force certain things on us, it would experience the strongest resistance yet from a small nation. It is time that the world realised that the South Africans are out of patience and that they are looking for an honest reply to Mr Vorster's question: what right does the world have to apply such pressure on South Africa?

Colored Immigration Skyrocketing

Study very closely the chart on this page prepared by the Zero Population Growth organization (ZPG). It shows that under present immigration of 400,000 legals and 800,000 illegals total 1.2 million new residents in America each year. Over the next 47 years our overall population will increase by more than 100 million people. Over 95% of all illegal immigration is non-White and nearly 80% of the legal immigration is non-White.

Note that without any immigration at all our population will jump by 50 million... Next take into consideration that the White birth rate in America is today at an all time low. We are averaging less than 1.6 children per family. It takes an average of three children per family just to replace our own kind. Two children to replace the father and mother and the third for couples who cannot have children or those who do not marry.

The white race in America is not reproducing its own kind. At the very same time the colored segments of our population are growing rapidly. Negroes, Puerto Ricans, Asiatics, Mexicans and others have very large families. The illegitimate birth rate among blacks and Puerto Ricans is at an all time high. Our government rewards those who bear illegitimate children with free medical care, higher welfare payments, more food stamps, and lower public housing fees. White working people are discouraged from having children. The dependent tax exemption is far too low, hospital maternity ward costs are over \$1,000 per child and the expense of raising children for White working people are up.

Unless the White birth rate increases, the outlook for the future of the White Race is very dim indeed. At the same time our overall percentage of the U.S. population is shrinking rapidly. The White Race is below zero population, yet the chart on this page shows a dramatic growth of the people living in our country. ALL 10 MILLION IN THIS INCREASE WILL BE COLOREDS!

He is a Jew, from the Legal Services Center for Immigration, run by the Legal Assistance Foundation of Chicago. Resnick said that, "there should be an immediate moratorium on all expulsions until Congress decides what to do with the Carter amnesty plan." 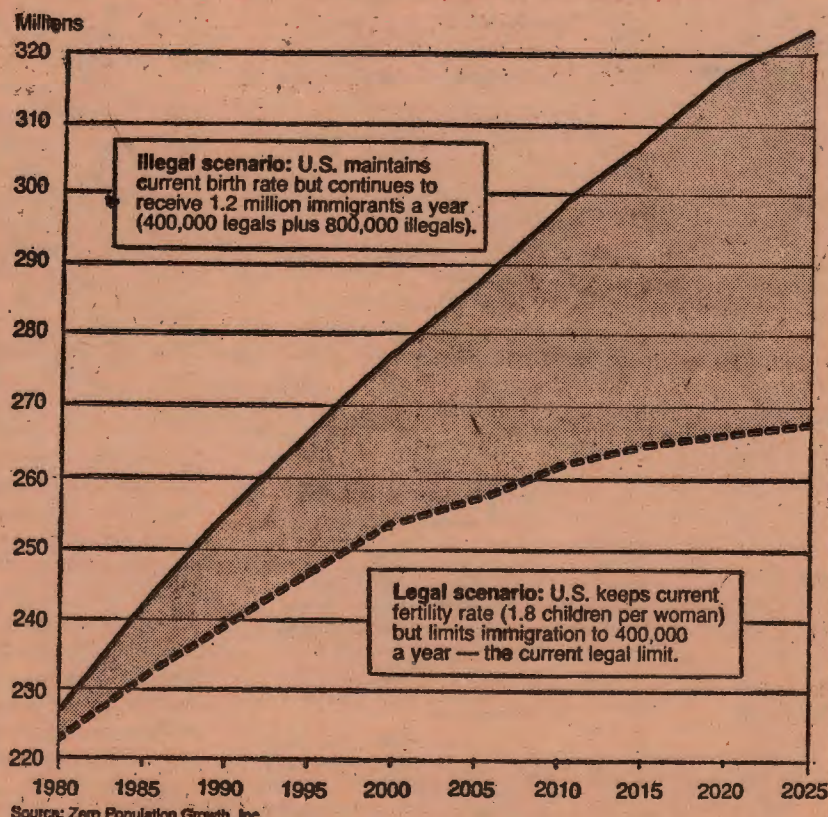

still time to change this dangerous invasion of our shores. We must reverse this trend and adopt the immediate solution proposed by the National States Rights Party and that is to stop ALL immigration from all nations. Since almost no Whites are being admitted under the Kennedy Immigration Act of 1965, we might just as

Mexico is one of the world's fastest growing nations. At their current phenomenal growth, their numbers are expected to almost triple from the present 62 million to a whopping 175 million by the year 2000. One problem is that Mexico has an unemployment rate of 40% and all of them would like to come to America. The World Bank is offering Mexico \$40 million for a national birth control program. The government is said to be "considering" this, but may reject the program due to opposition from the Church and Mexican traditions of having large families. Prevention of famine, disease and non-White population explosion is far more important.

"Parole Authority" Opens Immigration Floodgates

The Justice Department has abandoned a 4 year court battle in the federal courts to deport 900 illegal negro immigrants back to Haiti. They have long claimed that they are "political refugees" from an oppressive regime. The Haitians wanted to be automatically granted refuge and eventual citizenship just as were the Cubans who fled Castro. But, in this case Haiti is regarded as a friendly, anti-communist government.

Carter's new Immigration Commissioner, Leonel J. Castillo, a Mexican, has dismissed the defense and granted the blacks political refuge. U.S. Solicitor General Wade McCree, Jr., says that this entirely changes our deportation procedures. We now must study the form of government the illegal immigrants have left to determine if the aliens can be allowed to stay in America as "political refugees." There is no doubt that these negroes were not persecuted in Haiti and this is a ruse which will be used in the future by hundreds of thousands of illegal immigrants. Most of the world's backward colored nations are dictatorships.

President Carter has now ordered the Coast Guard to "rescue" and bring to America all black refugees they find on rafts or stranded on uninhabited islands in the Caribbean. On November 9, some 55 negroes were found on a tiny island 12 miles from Cuba. They were brought to Miami where civil rights lawyers told them that they were "political refugees." Another group

of Haitians were found floundering in a sinking fishing boat near our Naval base off Guantanamo on the tip of Cuba. They too will be flown to America to increase our already rapidly growing negro population.

New Hordes From Asia Coming

President Carter has signed a new decree granting "emergency admission" to 10,000 more Vietnamese so-called "boat people" who have fled their country recently. They are made up of over 100,000 Vietnamese, Cambodians and Laotians who have moved to Thailand. None of the Southeast Asian countries want these people who are their own racial kinsmen. Instead, the White Western nations are expected to take them in.

Vietnamese are leaving their country at the rate of more than 1,800 per month. They have heard it is possible for them to come to America and this nation is their main goal.

Just the Beginning

Sen. Alan Cranston says that there are some 160,000 Vietnamese refugees now in America and that 50,000 of them reside where they have become a burden on the welfare system. To alleviate the problem, Congress has authorized \$319 million in assistance to certain state and local governments which must support Asiatic refugees. California will receive some \$107-million.

Other White Nations In Danger

Thousands of Asian "refu-

gees" are now being allowed to enter White nations throughout the world. It seems that none of the Indo-chinese want to go to another Asian nation with their fellow asiatics. All give the higher standard of living in the White world as their primary motivation for immigration.

Sam I. Feldman, a Jew, is director of U.S. immigration in Hong Kong. His office is in charge of processing Vietnamese for transfer to America. Feldman also is directing the program of dispersing these people and their families to other White nations. His goal is to place ALL Asian refugees in White countries.

Thus far Vietnamese "heads of families" have been accepted under this program by the following countries: Australia, 1,800; Canada, 450; New Zealand, 700; West Germany, 200; Belgium, 150; Denmark, 52; and France is taking 1,000 per month. Note that these are "heads of families" and their offspring and parents are usually 8 to 12 additional breeding people are combining with other coloreds to challenge the White native born for control of our own lands.

Sen. Cranston, an ultra-liberal, says that "it is right that our nation has opened its doors to these people." He then let the cat out of the bag in revealing that he expects another 75,000 Vietnamese to be admitted to America over the next four years and 25,000 of them will settle in California.

Illegals Now Strike, Sue, Demonstrate

Brazen Illegals Sue & Strike

Brooklyn, NY found six illegal aliens "coming out of the closet" in filing an action with the National Labor Relations Board to have their jobs restored. The group had been fired when their employer had discovered that they falsely obtained Social Security cards. The NLRB ruled for the illegal aliens who had taken jobs from American citizens. The firm was ordered to reinstate the illegals and give them \$125,000 in back pay.

Rep. Mario Biaggi of the Bronx stated that this was an outrage against Americans who could not find work. He said, "What we find is a situation where six persons here in this nation illegally will be rewarded for their illegal status."

What we want to know is: Where are the labor union and NAACP leaders who claim that

there are not enough jobs for the unemployed in America. Here we have our government ordering a firm to hire people who have broken the law and who have no right to be here in the first place.

Aliens Strike Goldwater Ranch

Four months ago *The Thunderbolt* revealed that Jew Robert Goldwater worked illegal Mexican aliens almost exclusively on his vast ranch. They are paid substandard wages and are forced to live in squalid misery. His brother, Sen. Barry Goldwater, has consistently opposed legislation which would make it an offense for employers knowingly to hire illegal immigrants.

History was made on October 27, when 200 citrus workers, all illegals from Mexico, walked off Goldwater's vast 5,000 acre Arrowhead Ranch near Phoenix and manned picket lines. They are being represented by the

Maricopa County Organizing Project. The MCOP is out to organize the 10,000 illegals working on ranches in Central Arizona. This is a labor front exclusively for illegals and is quietly sponsored by the United Farm Workers.

The illegals are demanding that Goldwater provide them with decent living conditions, latrines, showers and medical care. They want a raise from below the minimum wage they are now paid (\$2.20) to \$3.00 per hour. All are modest requests, but this is an example of what greedy and selfish big business operators have brought upon this country. The Jew Goldwaters and their ilk have flooded America with cheap labor which has displaced American workers. Now this element has become so strong that they can strike openly and know that they will be protected from deportation by the Carter minority-oriented administration. What this means is that citi-

zens are losing control of their own country to the growing millions of illegals in our midst who are now taking to the streets and courts to demand rights that were formerly the prerogative of citizens only.

Aliens Sue for School Rights

Houston, Texas has been hit with a suit by 8 illegal Mexican families who claim that the U.S. Constitution guarantees their children the right to attend public schools. The case is bound for the Supreme Court because the losing side will surely appeal.

Attorney Carlos Hernandez contends that thousands of Mexicans illegally in the U.S. have a right to "equal protection" of the law and a free education. Federal Judge William Justice has ordered the records of the case sealed to protect the identity of the illegals so that they cannot be deported. The Houston school board says that there are some 187,000 illegal aliens residing in their district and they have brought with them some 6,000 school-age children. To provide them an educa-

tion would cost taxpayers in the district an additional \$8.3 million.

Who would ever believe that we would see the day when illegal aliens could strike, sue the government, and sue their employers for citizens' jobs? The day foretold so brilliantly in *The Camp of the Saints* is now here at hand staring us right in the face. Unless the American people rise up and demand that this vast invasion army of millions of aliens be deported out of America, then we will soon find them in the driver's seat and running this nation. We will be tilling the soil and paying all our wages in taxes so that the destitute of the earth can live off the backs of White workers. We must place the blame on two elements and they are the government and big business who have profited by exploiting such workers.

The time has come to make immigration the most important issue in America. We must demand that every politician or political hopeful take a stand on this vital issue. Unless we solve the problems of immigration, the White people in America are going to be lost in a sea of color.

ALL MARXIST TERRORIST LEADERS ARE JEWS

Jews Head Weatherman Terrorists

We have shown in some detail the predominance of Jews in the "above ground" Marxists, Socialists, and ultra-liberal left-wing organizations in America. Now what about the secret, underground, illegal Marxist terrorist organizations? First, we find that ALL of the leaders and most of the activists in this area are also Jews.

Below we document their background and violent attacks against our White Christian society.



Susan Saxe

Susan Saxe was an honors graduate from the Jewish Brandeis University when she joined the radical underground. During her spree on Sept. 1, 1970, she is charged with robbing the Bell Savings and Loan Association in Philadelphia. She carried a gun and an unlit Molotov cocktail.

On Sept. 23, 1970 she robbed the State Street Bank in Boston of \$26,000. She was accompanied by three other radicals. Bank guard Walter A. Schroeder was shot in the back and died. Miss Saxe was also charged with stealing weapons from the Massachusetts National Guard Armory. Both the money and the guns were to be used in a scheme of violence which was to lead to the overthrow of the U.S. Government. Believe it or not, she was given 2 years on the first bank robbery and 6 years on the second bank robbery, in which a man was murdered. After her conviction she vowed to "fight on, as a lesbian, a feminist, and an amazon."

How do these sentences compare with the 10 years given Bob Miles on a framed-up charge of burning buses used in forced busing in Pontiac, Mich. An offense which a dying man confessed to. Miles has not been able to obtain parole, despite his excellent prison record and no prior conviction of any kind.



Jane Alpert

Jane Alpert used the name Clara Weinstein and for two years successfully hid out at the Beth Jacob Orthodox Jewish school for girls in Denver, Colo. She worked as a counselor to the students and was described as a "militant feminist" who was "dead set against marriage."

Miss Alpert firebombed a Fed-

eral Government building in New York for the Weathermen. She was given a 27 month prison term and will be eligible for parole after nine months.

How does this compare with the 10-year sentence given to White Patriot Leroy Gibson who was convicted of bombing a communist book shop which was used to subvert our servicemen at Camp Lejune, N.C.? Mr. Gibson was framed on the most flimsy evidence, but still remains in Atlanta's federal penitentiary and thus far has been denied parole.

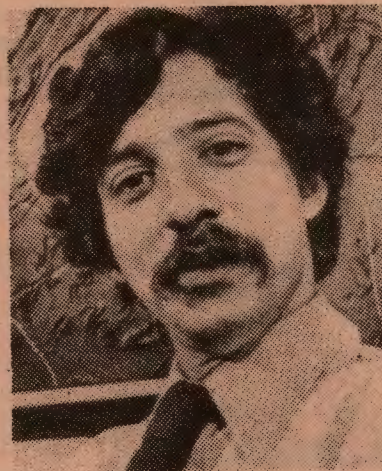


A manacled David S. Fine, 24, gave a clenched fist salute Friday as he left the courtroom in Madison where he was sentenced to seven years in prison.

David S. Fine is a Jew who led the bombing of a building at the University of Wisconsin. After 4 years flight, he was finally captured in California. Unknown to the bombers, a researcher named Robert Fassnacht was working late in the building and was immediately killed in the blast, which did \$14 million in damage.

David Fine plea bargained and pled guilty to third degree manslaughter. Fine was sentenced to 7 years in prison. His Jewish lawyer, James Shellow, said that Fine was a "tragic" figure who has merely been an "idealist." Seven years for murder during a communist inspired bombing!

How does this compare with life imprisonment for Klansman Robert Chambliss in Birmingham? Where is the equity in these cases? Communist revolutionaries out to destroy this nation are patted on the wrist while Christian Patriots are all but "buried under the jail." More proof of the dual system of justice which exists in America where the minorities rule over our state and federal governing bodies.

Mayor Soglin Helped Fine

An interesting sidelight to the David S. Fine case is the controversy which took place over Fine's bond. Madison, Wisc., is the city where Fine's bombing took place. Its Mayor is the avowed Marxist Jew Paul Soglin. The city is so left wing that he has been elected Mayor three times, with slim majorities provided by the huge U. of Wisc. student body. Fine was himself arrested during violent anti-war demonstrations while a student there. Soglin has traveled to Cuba and personally visited with Fidel Castro who Soglin said had formulated a true "socialist democracy."

When David S. Fine was arrested, Soglin had his top aid, James Rowen, sign for \$30,000 of the \$75,000 bond. Rowen is also a radical whose father is financial editor of the Washington Post. Rowen is also married to the daughter of Sen. George McGovern. The Madison City Council demanded that Soglin

fire Rowen but he refused. In the meantime David Fine was having trouble making his bond so the judge simply allowed him to sign a personal recognizance bond and remain free until his later conviction. How does this treatment by the courts compare with the \$200,000 bond Robert Chambliss had to post in Birmingham, Ala., before his trial, and the \$100,000 bond awaiting J.B. Stoner if extradited?

Other Wanted Marxist Radicals

Yes, there are misguided non-Jews in the Weathermen, but all the leaders are Jews and over 50% of its members. Below we list some of the most wanted people in the Weathermen group. They are all fugitives from justice mostly accused of bombing government institutions. They include Bernardine Dohrn, the Jewess who presently heads the Weathermen. Other top Jews now being sought by police are Michael Spiegel, Howard Machtinger, Lawrence Weiss, Robert Roth, David Klaffer, Leonard Handelsman, John Jacobs and Terry Robbins. They are all presumed armed and very dangerous. They are organized and pose a threat to our national security. They operate through hippie and lesbian communes and others on the far out fringe of society. They claim that they walk the streets of our cities thumbing their nose at the law. Some of those captured have been recognized by citizens who had them arrested. Keep your eyes and ears open because your identification might help in their apprehension.

From there, Rudd flew to Chicago to face riot charges. A judge set a ridiculously low bond of only \$4,000. Rudd flew back to his parents' comfortable home in New Jersey. During the same hearing in Chicago, Rudd's two companions in revolutionary activities pled guilty in the same "Days of Rage" riots. They are Robert Roth and Phoebe Hirschyes, both Jews. They received fines of \$1,000 each and were put on 2 years probation.

Rabbi Raps Vatican for Israel View

One of the leading Orthodox rabbis in the country today denounced the Catholic Church for "lacking the moral courage" to recognize Israel and called for a reassessment of Jewish-Catholic relations.

In what may be the strongest stand taken to date by a Jewish group, Rabbi Fabian Schonfeld, president of the Rabbinical Council of America, assailed the church for "yielding to Arab pressures" today and to anti-Semitic forces in the past.

"We wish," he said, "that the Vatican had shown its resoluteness and the courage of its convictions during the Nazi Holocaust as it did recently in its manifesto regarding sexual morality. Thousands of Jews would

have been saved from gas chambers by its forthright intervention."

Msgr. Eugene Clark of the New York Archdiocese responded to Schonfeld's statement by accusing the rabbi of "poisoning the well of Catholic-Jewish understanding" and perpetuating "the wholly discredited lie that Pope Pius was not anti-Nazi."

Schonfeld's comments—on behalf of 1000 Orthodox rabbis in the U. S. and Canada, nearly half of them in New York—came in the wake of last week's release by the Vatican of a 688-page report on the church's role during World War II. Among other things, the document included papal correspondence over the years warning of dangers of the establishment of the state of Israel.

The Vatican has never formally recognized Israel.

Schonfeld also called upon "the Christian leadership of communities throughout the world" to recognize what he termed the bond between Judaism and Zionism.

"Carter Country" — Vicious Anti-White Show

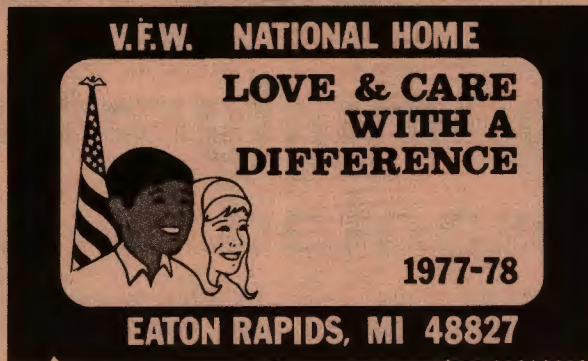

Our Backs Up Against The Wall

My son, who had gone to Inglewood, California schools, had to live with his aunt in Covina when the blacks became the majority race at Morningside High School. Four blacks tried to rob him of his lunch money in the hall one day and when he resisted, and through the use of karate disabled three, he had to call me and have him come to school and take him home. When school ended, I had told him to come out the front way and I would be around. When he came out, he was followed by several "brave" blacks. Some had short clubs in their hands, which they had been keeping in their lockers.

I stepped from my car as my son approached and said, "Over here, Tiger." Seeing that I had a 38 and a 32 caliber revolver in my belt, they left him alone, though one just had to say, "Later, mutha." I knew they could gang up on him during the day - so I sent him to live with his aunt.

I had two more house payments to make and my house would be paid for. I was one of the last three White families to move when I was forced out. Forced busing was to start and, as I still have three children of school age, I had to move. I made inquiries and found Tujungga had no forced busing. I found a house out here and have been here for five years. Next year, we are to have integrated schools.

Though I had stood up for the laws in all of my 56 years, I will have to resist the busing proposal to the utmost. I have a blonde, blue-eyed daughter who is 11 years old. I found when the Inglewood schools integrated, the blondes are the ones the nigger boys run ragged.

If a white girl doesn't go with nigger boys, all the black boys pick on her and if she does go out with one of these apes, the nigger girls gang up on her.

Doctor Fields, what are we going to do?
