## Senate Majority Opposes Jordan Arms

Seventy-two Senators—46 Democrats and 26 Republicans—are sponsors of a legislation opposing a major new arms sale to Jordan "under present conditions in which Jordan continues to oppose the Camp David peace process." The sense of the Senate resolution, S. Res. 177, offered by Sens. JOHN HEINZ (R-Pa.) and EDWARD KENNEDY (D-Mass.), stipulates that the United States "should not sell advanced fighter aircraft, mobile and anti-aircraft missiles, or any other advanced arms to Jordan."

### Jews Give Orders To U.S. Government

Israel's Justice Minister Moshe Nissim ordered the U.S. to bear no expense in searching the world to find Dr. Josef Mengele and turn him over to the Israeli hangman! U.S. Atty. Gen. Edwin Meese instantly declared the Justice Dept. would do anything the Jewish Lobby wanted. The Jew Neal Sher, head of the OSI, which spends its full time persecuting anti-communist East Europeans took 6 men off his bloated staff of 50 and sent them into the jungles of South America to look for Mengele. On May 10 Sher boasted, "there is no doubt Mengele is alive and we will capture him and deliver the war criminal to the Israelis!"

Mrs. Elizabeth Holzman stated that the U.S. Government had the "legal obligation" to hunt down Mengele. Ed Meese, whose nomination to Atty. Gen. was almost blocked by the Jew Sen. ## Hunt For Mengele Hysteria Conspiracy

Dr. Joseph Mengele is dead from a drowning incident on a Brazil beach. Jews around the world expressed sorrow because they had hoped to find him alive for a big televised show trial and hanging in a Tel Aviv kangaroo court. Denied this vile orgy by Mengele's death professional holocaust survivor, Simon Wiesenthal, declared on TV, don't worry there are thousands more Nazi war criminals we can turn our attention to. After years spent vilifying Mengele as a "monster" his death leaves a propaganda void the Jews will have a hard time filling with a new evil "war criminal".

## The Truth About Mengele

Dr. Josef Mengele was born on March 16, 1911 in Gunzburg, Germany of a prominent family which is well known for building farm machinery and providing jobs for hundreds of people. Mengele became a Doctor in genetic research. During the war he volunteered for the Waffen SS and fought on the Russian front. He was wounded and awarded the Iron Cross and retired to the vast industrial complex of Auschwitz. There the world's most successful process of turning millions of tons of coal into oil required thousands of laborers.

Dr. Mengele was given the task of performing genetic tests on twins and other people in order to seek scientific ways of upbreeding racial groups. It

has been charged that he personally ordered the murder by mass gassings of from 400,000 to 700,000 people. He only worked in Auschwitz from May 1943 to Dec. 1944. Everyone admits he spent a majority of his time studying twins, etc. Thus, with no time off during this period and working a 10 hour day he would have had to kill or order killed from 200 to 400 people every working hour every day of the week

This, of course does not sound possible especially in light of the fact that no gas chamber has ever been found at Auschwitz nor any witness who ever claimed they saw one!

No one has ever actually presented any evidence that Dr. Mengele ever killed one single person. A number of these twins have come forward about 180 of them and none have stated they saw him kill anyone nor do they have any permanent injuries or illnesses resulting from that period. Jew Marc Berkowitz and his twin sister are "survivors" of Dr. Mengele's tests and reported, "He was capable of being very nice, very gentle, and very sympathetic."

Many twins have told lies, Pearl and Helen Herskovic said an "evil Nazi" told them "our mother was in the smoke bellowing from the crematorium and her ashes were coming down as we smelled burning flesh." (NOTE: Cremation leaves no smoke, no ashes go up in the air and there is absolutely no smell at all!)

## Even Some Jews Defended Mengele

Hans Sedlmeier, a long time friend of the Mengele family states that Dr. Josef Mengele was a geneticist adding, "the newspapers will not print the truth, because it's not in the interest of the Jews." Mengele's wife Martha said he never conducted any experiments on inmates which would harm them in any way.

The Chicago Tribune of June 9, reported a Jewish woman helped Mengele escape from Auschwitz at the end of the war. One of the most intriguing points that prove Mengele could never have persecuted Jews is the fact that Gitta Stammer (now age 65) took Dr. Mengele into her home beginning in 1961 and lasting for 13 years until 1974 and she is a Jew. Her husband made Mengele a foreman to run their farm and they enjoyed a long standing friendly relationship with Mengele who was like a member of the

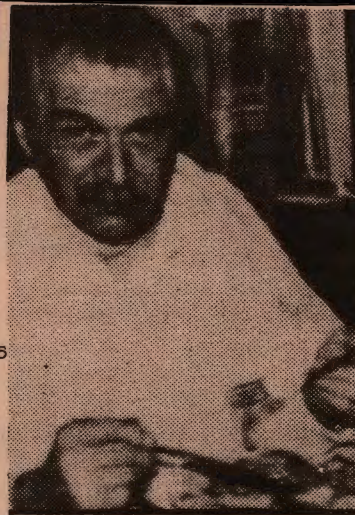
## Reagan must track down Mengele

NEW YORK (JTA) — Brooklyn District Attorney Elizabeth Holtzman believes that "The President of the United States must take personal steps" to make sure that the government of Paraguay understands that the American people want Nazi war criminal Josef Mengele, the Auschwitz death camp doctor, brought to justice.

Holtzman, a member of Congress until 1981 and of the House Judiciary Committee, was instrumental in getting the Justice Department to crack down on war criminals living in the United States after obtaining entry and in many cases citizenship by lying about their Nazi past.

Meanwhile, the Los Angeles-based Simon Wiesenthal Center, in another step in its efforts to track down Mengele, announced that it will place full-page "Wanted" poster ads in major newspapers in Argentina, Bolivia, Paraguay, Brazil and Chile.

# Jews Use U.S. Government To Persecute East European Patriots

None — or almost none — of this amazing hoopla about Mengele is news, of course. That is, it's not *real* news; it's much more fantasy than fact. What's amazing about it is that even the most obvious inventions are reported matter-of-factly and without a trace of scepticism, so long as they serve to further blacken Mengele's name and magnify his standing as a monster of iniquity.

The more-or-less sober *Washington Post*, for example, reported without blinking an eye that Mengele "routinely tossed babies into ovens alive" and "ordered pregnant women onto their backs, then stomped them until they aborted."<sup>1</sup> Mostly he sent Jews to the gas chamber (400,000 of them, according to the *Washington Post*; as many as 700,000, according to some Jewish writers), but sometimes he sent the gas to the Jews instead by piping it into their barracks at Auschwitz and wiping them out in droves. When he wasn't busy doing that, claimed the same newspaper, he spent his time castrating Jews, shooting them in the knees (followed by a bullet into the brain as a *coup de grace*), or killing them painfully by injecting dye into their eyes.

Actually, a few facts about Mengele are known, and sometimes they are even printed in American newspapers, along with the fantasy. He was born in 1911 to a wealthy Bavarian Catholic family of industrialists (farm machinery). He studied anthropology and zoology at German universities and graduated from medical school in 1938. For only 19 months during the Second World War he served as the chief physician in the labor camp at Auschwitz, Poland, where the Germans used prisoners, many of them Jews, as factory workers to manufacture synthetic rubber and industrial chemicals.

## Lies Against Dr. Mengele

Dr. Josef Mengele may have conducted medical experiments on some of them. One thing he certainly did not do was toss live babies into ovens. Nor did he stomp on pregnant women until they aborted. German physicians, whether serving in labor camps or in private practice, did not do such things — ever.

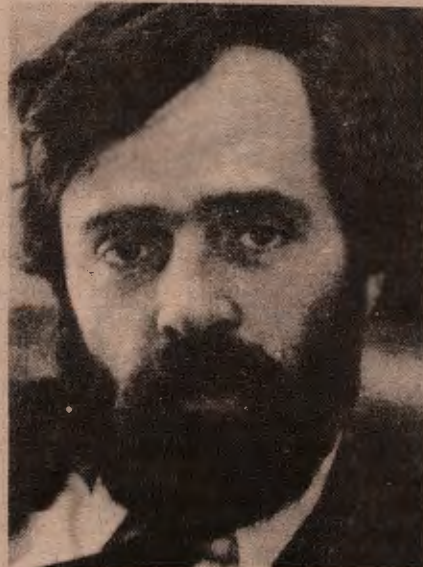
Only Jewish minds could have invented the atrocities attributed to Mengele. And only a Gentile public so conditioned by Jewish lies that it has lost all sense of discrimination could believe them. Just imagine: the highly educated scion of one of Germany's best families, a professional entrusted with serious medical and administrative responsibilities by the German government, amusing himself by tossing live Jewish babies into ovens and stomping on the bellies of pregnant Jewesses, presumably while other German physicians, German nurses, and German orderlies watched! Routinely! For four years! Is that really credible?

Any adult American with a reasonable degree of sophistication and the capacity for independent thought knows that it is not. Yet, how few raise their voices against the Jewish liars! Sanctimonious frauds like Elie Wiesel and Simon Wiesenthal appear before television audiences of millions of people to make utterly absurd claims about the "Holocaust," and almost no one has the gumption or the courage to challenge their lies, or even to laugh at them.

Certainly, the politicians and the newspaper scribblers — all of them without exception — accept every Jewish tale of persecution, no matter how farfetched, at face value. For them to question any Jewish claim about the "Holocaust" is unthinkable. If America's political, religious, and cultural leaders had even a modicum of backbone or honesty, creatures like Wiesel and Wiesenthal would be out of business in a hurry. So would a truly horrifying agency of the U.S. government, the Office of Special Investigations (OSI).

The OSI grew out of a special Justice Department task force on "war criminals" in 1979. The task force itself had been set up two years earlier, in response to strenuous agitation by two Jewish members of the House Judiciary Committee, Joshua Eilberg and Elizabeth Holtzman. (Eilberg [D-PA] dropped out of politics late in 1978, when he was convicted of taking bribes; Holtzman [D-NY] remained chairman of the Judiciary Committee through 1980, when she failed to win re-election.) The Jewish legislators had complained long and loudly that the government was failing to

do everything it could to hunt down and prosecute Germans, Poles, Latvians, Lithuanians, Ukrainians, and other Europeans who had engaged in anti-Jewish activity during the Second World War.

The chief investigator at OSI, Neal M. Sher, is a Jewish lawyer, as are virtually all of the other investigative personnel — although the group was headed by a *shabbos goy*, Allan Ryan, from 1980 until 1983.<sup>2</sup>

<sup>2</sup> Allan Ryan was one of the most shameless scramblers for Jewish favor in government service during his tenure at the OSI. A man who would say or do anything to win Jewish approval, he made numerous television appearances and gave hundreds of newspaper interviews in which he vilified the targets of OSI investigations and magnified their supposed "war crimes," often timing his publicity efforts to coincide with Israel's grabs for more U.S. aid. In a 1983 speech to the Anti-Defamation League of B'nai B'rith Ryan described the "Holocaust" as "the central moral question of our time," referred to "Holocaust" huckster Elie Wiesel as "a visionary," and unblushingly told his Jewish audience: "Yours is an awesome faith and a magnificent tradition whose love for God and justice and the brotherhood of man nourishes the best aspiration of humanity."

## Persecution of Frank Walus

The controlled media can be counted on to collaborate enthusiastically in these character assassinations. One in which they outdid themselves was that of retired Chicago factory worker Frank Walus. In 1977, even before the OSI had been formally established, the Justice Department charged the Polish immigrant with being a former member of both the SS and the *Gestapo* and killing Jewish civilians in Poland during the Second World War. More than two weeks prior to the filing of charges against Walus, however, the Justice Department began priming public opinion by "leaking" news to Chicago newspapers about Walus' supposed wartime atrocities.

During his denaturalization trial, presided over by Jewish U.S. District Court Judge Julius Hoffman, the prosecutors continued to provide the media with previews of coming testimony from prosecution witnesses. The circus atmosphere was heightened by the Jewish

demonstrators screaming for vengeance outside the courtroom and by the Jewish spectators inside. The latter cheered the prosecution witnesses, glared at Walus, and gave interviews to the press during the intermissions, showing their tattooed concentration-camp serial numbers to reporters, telling how their families were gassed at Dachau, etc.

The witnesses against Walus included ten Jewish "survivors," obligingly supplied by the government of Israel. They had responded

to an advertisement in Israeli newspapers seeking persons willing to testify that they had seen Walus tormenting and killing Jews in Kielce and Czestochowa, Poland, 37 years earlier. An all-expenses-paid trip to the United States for the trial was part of the lure. In the courtroom they all positively identified Walus.

"I will never forget that face," emotionally declared one Israeli witness, Josef Koenigsberg. "This is the face who killed an innocent man whose only crime was the fact that he was a Jew," he said, pointing at Walus.

Another Israeli, Sara Leichter, marched dramatically up to Walus in the courtroom and charged: "Here sits the murderer!"

Interestingly enough, one of the crimes of which Walus was accused by the Jewish witnesses was stomping on the bellies of pregnant Jewesses. There must be something strange indeed in the Jewish mind to account for this fascination with stomping on fetuses!

Although Walus proved that he was only 17 years old at the time of his alleged atrocities, that he was four inches too short for admission into the *Gestapo*, and that he had been a farm laborer in Germany throughout the war, Judge Hoffman dismissed the evidence in his favor as "irrelevant," condemned his witnesses as "Nazis," stripped him of his citizenship, and turned him over to the Immigration and Naturalization Service for deportation proceedings. The controlled news media, which had largely ignored Walus' defense and had focused instead on the Jews' lurid accounts of his alleged crimes, cheered the verdict.

# Secret Data Proves OSI Framed Fedorenko

Using forged documents obtained from the Soviet KGB, coached "eyewitnesses" flown in at U.S. expense from Israel, and other prosecutorial tactics reminiscent of Tomas de Torquemada at his worst, Ryan, Sher, and their OSI colleagues have driven men to bankruptcy, to exile, and to suicide, and they have boasted about it publicly, as if it were the most praiseworthy of activities. Standard OSI practice, when an effort is begun to strip a "war criminal" of his citizenship, is to call a press conference and describe his alleged crimes in imaginative, gory detail, painting him as a sadistic monster deserving neither sympathy nor a fair trial.<sup>3</sup>

<sup>3</sup> In this regard the OSI lawyers follow a pattern set by the principal instigator of their group, Elizabeth Holtzman, who while in Congress customarily used shockingly intemperate and prejudicial language in describing to the media the persons she demanded the Justice Department investigate for "war crimes." More recently, in a February 1985 letter to the National Aeronautics and Space Administration (copies of which also were sent to news media), she described German-American space scientist Dr. Arthur Rudolph as "this notorious Nazi murderer" and "this bestial killer," because he had worked on a German V-2 rocket program during the Second World War, and forced laborers — some of them presumably Jews — had been employed in the factory which produced the rockets. The OSI had forced Dr. Rudolph to renounce his U.S. citizenship and go into exile, but that was not enough for Holtzman; she was demanding that NASA strip the 78-year-old space pioneer of the Distinguished Service Medal which he had received from NASA in 1969 for developing the Saturn V rocket for the United States.

Frank Walus, however, was more fortunate than most accused "war criminals." A few attorneys in Chicago had been disturbed by the blatant irregularities in his trial: Judge Hoffman had been so openly hostile to the defense that his conduct drew criticism even from the law journals. One observer of the trial remarked that the Jewish judge's behavior was that of a man who "needs a visa to get into the human race."

## OSI Tactics Illegal

Walus' attorneys appealed, and in February 1980 the Seventh Circuit U.S. Court of Appeals restored his citizenship and reprimanded Hoffman for his conduct. By this time Walus had exhausted his life's savings, suffered five heart attacks, and become an embittered man.

Even after the successful appeal the Justice Department — now operating through the OSI — refused to exonerate Walus. The OSI waited nine more months before it finally dropped its charges against him, and even then it would not declare his innocence. Instead, it merely stated that it doubted it could obtain a new conviction of Walus. It was clear that the OSI's primary concern was to avoid putting its Jewish witnesses in jeopardy of prosecution for perjury. To this end it issued a statement saying: "We have no doubt that the

witnesses who testified on behalf of the government — the survivors of the Nazi persecutions of Czestochowa and Kielce — testified sincerely and honestly."

An investigation of the OSI prosecution of Walus by an independent law journal, the *Chicago Lawyer*, turned up two shocking facts. First, it was admitted by a Justice Department official that the reason for waiting nine months after the appeals court reversal to drop the charges against Walus was to avoid doing so before the 1980 Presidential election, which would have cost Mr. Carter Jewish votes.

Second, the *Chicago Lawyer* learned that the OSI statement which was released to the news media in November 1980, when the charges against Walus were dropped — the statement which was far more solicitous of the reputations of the government's perjured witnesses than that of the falsely accused defendant — had first been submitted to the leaders of a number of Jewish organizations for approval. These organizations insisted that the statement not exonerate Walus and that it uphold the perjured testimony of the Israeli witnesses. Allan Ryan, then heading the OSI, adjusted the wording of the statement to suit their demands.

At the same time the Justice Department had been prosecuting Frank Walus in Chicago, it had been conducting another circus trial in Miami, this one against Feodor Fedorenko, an anti-communist Ukrainian immigrant and retired factory worker who was accused by Jews of having committed atrocities against them as a World War II concentration-camp guard. As in Walus' case, the Justice Department had flown in "eyewitnesses" from Israel to testify against Fedorenko.

Unlike Walus' case, however, there was no Judge Julius Hoffman to prevent the defense attorneys from cross-examining the Israeli witnesses and exposing the inconsistencies in their stories. In September 1978 the court acquitted Fedorenko of all charges, and the judge commented that the witnesses' testimony against him appeared to have been invented and systematically coordinated.

The Justice Department was in favor of dropping its prosecution of Fedorenko at that point. An internal Justice Department memorandum admitted that there never had been any evidence against him to justify the charges on which he was tried, and it concluded: "The fact is that we do not know today for sure if Fedorenko [sic] is a war criminal or not."

## Jews Demanded Conviction

Jewish pressure on the Carter administration for the continued prosecution of Fedorenko was intense, however. As soon as he learned of the Justice Department's intention not to appeal Fedorenko's acquittal, Alan Dershowitz of the American Jewish Congress wrote to Carter's solicitor general, Wade McCree, demanding that the government continue its efforts to deprive Fedorenko of his U.S. citizenship.

I thus think we are at a dead end in this case. To be sure, there is a very limited category of cases where appeal, even if foredoomed, must be taken to show the flag—to demonstrate the government's indignation at the judgment below and its determination to reverse, even when the chances of reversal are almost nil. If we had extrajudicial evidence that Fedorenko was in fact a war criminal, such a pyrrhic appeal might be worthwhile. But we do not. The fact is that we do not know today for sure if Fedorenko is a war criminal or not. He may be, or he may be the unfortunate victim of innocently mistaken identification, or indeed he may be the target of a group of Treblinka survivors who saw family and friends slaughtered and who are determined to bring vengeance on any Treblinka guard, guilty or not. We simply do not know.

SECRET MEMORANDUM, written by Justice Department prosecutor Allan Ryan, was leaked and published in the weekly *National Law Journal* (issue of October 27, 1980). The 15-page memorandum, from which this excerpt has been photographically reproduced, was written September 12, 1978, immediately after Feodor Fedorenko's acquittal by a U.S. District Court in Miami of trumped-up "war crimes" charges. Despite the lack of credible evidence against Fedorenko, Jewish political pressure forced the continuation of his prosecution and his eventual deportation to the Soviet Union.



Fedorenko Deported To Russia

The Jews feared that Fedorenko's acquittal, if allowed to stand, would be an indictment of their whole program to use the highly publicized prosecutions of "war criminals" as a means of reminding the world about the "Holocaust" — and generating more support for Israel. Furthermore, just as in the Walus case later, an acquittal exposed the perjured Jewish witnesses — and those who had told them what to say — to the jeopardy of prosecution.

Jimmy Carter's Justice Department obediently carried its charges against Fedorenko to the appeals court, despite the recommendation of its own prosecutors. The media campaign against Fedorenko was stepped up, with horrifying accounts of his alleged atrocities appearing in newspapers and Sunday-supplement magazines across the country. And the campaign had the desired effect: the appeals-court judges overturned the lower court's decision and declared Fedorenko a "war criminal," ineligible to be a naturalized American citizen.

## Jews Inhuman Orders

After the Supreme Court issued a similar ruling, he was denaturalized. And in 1984, while Ronald Reagan was winning Americans' votes by taking a strong stand against communism and denouncing the Soviet Union as an "evil empire," 77-year-old anti-communist Feodor Fedorenko, after 35 years as a law-abiding American citizen, was handed over to the late Mr. Chernenko's KGB agents by Mr. Reagan's FBI agents, hustled aboard

an Aeroflot airliner bound for Moscow, and deported to the Soviet Union — and certain death.

Jewish organizations and individual Jews all over America chortled with glee. Every true American should have blushed with shame.

An even more shameful perversion of the U.S. judicial system is now in its final stages in Cleveland, where another retired Ukrainian factory worker, John Demjanjuk, is fighting for his life after similar treatment by the OSI and its media clique.

Charged in 1981 with killing 900,000 Jews in 1942 and 1943 at the Treblinka concentration camp in Poland (an amazing record for someone who only celebrated his 21st birthday in 1943), Demjanjuk has been exposed to non-stop atrocity propaganda against him in the controlled media, noisy demonstrations and demands for vengeance by Jewish "survivors" outside his home and the Federal courthouse in Cleveland, and the histrionic accusations of carefully coached witnesses flown in from Israel. His citizenship was taken away from him on the basis of these witnesses' testimony and KGB-supplied documents "proving" that he had become a concentration-camp guard during the war, following his recruitment by his German captors from among a group of Red Army POWs.

## Israel Runs OSI

After losing his citizenship Demjanjuk has spent more than three agonizing years fighting the Reagan administration's efforts to deport him to the Soviet Union. This year the OSI decided on a crueler fate for him. Neal Sher and his colleagues put their heads together with their kinsmen in Israel and asked the same judge who had denaturalized Demjanjuk to order him extradited to Israel, so that he could be made to stand trial for "crimes against the Jewish people."

What could not be accomplished in three years in the case of a

deportation order to the Soviet Union took place overnight in the case of Israel. On April 15 U.S. District Court Judge Frank J. Battisti ordered 65-year-old John Demjanjuk's immediate arrest and scheduled him to be handed over to Israeli secret police agents. Judging from the grisly reports of Israeli interrogation techniques used against captured Palestinian freedom fighters — reports verified by the International Red Cross and Amnesty International — he would have had vastly more merciful treatment by a Soviet firing squad, as in the case of Feodor Fedorenko.

## Hundreds More Face Prosecution By OSI Jews

The OSI has a list of more than 300 other "war criminals" in the United States, it says, and it intends to deal with them the same way it has dealt with Frank Walus, Feodor Fedorenko, and John Demjanjuk.

This utterly despicable and shameful activity by an agency of the U.S. government — an activity which dishonors every taxpaying American who fails to protest it — is finally eliciting some organized opposition, but only from Baltic and Slavic immigrant organizations, whose members resent the fact that the OSI's witch-hunt is directed against their ethnic groups. Latvian, Lithuanian, and Ukrainian publications are calling for donations to legal defense funds for the OSI's victims, and they are rousing their readers to lobby against the OSI by writing letters to members of the Congress. They also are reminding their readers of what *really* happened in Eastern Europe during the Second World War, when anti-communist Balts and Slavs were more often the victims of communist Jews than the other way around.<sup>4</sup>

<sup>4</sup> At the beginning of the war, the active communist elements in Poland and the Baltic countries were overwhelmingly Jewish. When the Soviet Union invaded those countries in 1939 and 1940, local Jewish communists became commissars and directed a frightful repression of Gentile anti-communists and potential anti-communists. When the Germans drove the Red Army out in 1941, the relatives of murdered anti-communists often took their revenge on those Jews who were not quick enough to get away with their Soviet protectors.

And in the Ukraine the people remembered who the commissars and Party bosses had been during the early 1930s, when more than five million Ukrainians were starved to death in an artificial famine or murdered outright. Again, when the Germans broke the grip of the Ukraine's Soviet rulers in 1941, a number of Jews received a well-deserved retribution from the long-suffering Ukrainians. After the Germans were forced to retreat later in the war, however, the Jews once more had the upper hand, and anti-communist Ukrainians were butchered *en masse*.

The leaders of mainstream America have remained silent in the face of the OSI's outrages, however, and the lonely efforts of a few Eastern European immigrant groups have done little to curb the OSI or remove the dark stain it has made on the American judicial system. to challenge the "Holocaust" mongers today is to invite the equally dreaded charge of "anti-Semitism."<sup>5</sup>

<sup>5</sup> Predictably, the Reagan Justice Department, speaking through the controlled news media, has characterized as "anti-Semitic" the Baltic and Slavic organizations and publications which have

taken a stand against the OSI. One unnamed OSI lawyer told the *Washington Post* ("East European Emigres Are Accused of Impeding Hunt for Nazis in U.S.," April 6, 1985): "Their efforts are to close us down.... They are very active, and it's fraught with anti-Semitism."

The same *Washington Post* article quoted Israel Singer, executive director of the World Jewish Congress, who charged that the reason for the Eastern Europeans' opposition to the OSI is their "fear that the Justice Department's prosecutions are exposing the American public to the historical fact that Hitler's annihilation of 6 million Jews was carried out not by the Germans alone, but rather with the extensive collabora-

tion of Lithuanians, Latvians, Ukrainians, Estonians, and other Europeans." (Of course, Singer was careful to give no hint as to *why* all of these Eastern Europeans hated the Jews.)

## Wake Up Americans

And when the people with the ability to think and question — the ones who have grave doubts about anyone actually being able to fly through the air on a broomstick or about German doctors routinely tossing live babies into ovens — do not have the courage to speak out, to demand proof, then the masses, who never have had much in the way of either thinking ability or moral courage, will take their cue from the inquisitors.

Today we are horrified that in the 15th century crowds of ordinary people used to watch without protest while the authorities burned innocent women at the stake. We ought to be just as horrified that in 1985 millions of ordinary Americans read stories in their newspapers every day about their government's equally savage and fanatical persecution of elderly Germans and Eastern Europeans accused of utterly unbelievable acts, without protest.

It is this lack of public morality which allows the Office of Special Investigations to exist and to continue to engage in what can only be described as a witch-hunt — one which is proceeding with the same vindictiveness and cruelty, the same self-righteous zeal, and the same disregard for truth and justice as the witch-hunts organized by its predecessor, the Office of the Inquisition, 500 years ago. □

## How Jews Stole Thomas Edison's Motion Picture Invention

Thomas Edison is called the greatest inventor of all time. He patented over 2,000 inventions but the most famous were electric light, the phonograph and the motion picture machine. Jews quickly saw the tremendous future potential of moving pictures but Thomas Edison formed the General Film Co., and patented the device.

Benjamin Warner brought his family from Poland in 1887 and they settled in Baltimore. He had four sons, Harry, Albert, Sam and Jack. In 1903 Jack Warner bought a used Edison Kinetoscope projector for \$1,000 and learned how to repair it. The four brothers took the machine to beer halls and carnivals projecting magic lantern shows on the wall. They next opened up "The Bijou" theatre in New Castle, Pa., and began the distribution of one-reelers to theatres in Pittsburgh, Baltimore, Norfolk and Atlanta.

## Edison Company Wins Suit Against Warner Brothers

In 1909 Edison's General Film Co., sued Warner brothers over violation of their patent rights. They won the suit and the Warners were forced to sell their operation to General Film Co. This did not discourage the Jew brothers at all. In fact the Edison Company had private detectives investigating the numerous Jewish film companies which set up business in Brooklyn illegally using Edison motion picture equipment. Thus the Jewish movie Colony packed their bags and moved lock stock and barrel to Los Angeles. There they were able to escape suits and thus was born the Hollywood Jewish film colony which today dominates the world production and distribution of movies.

Of the Warner brothers Sam and Jack built their first film studio in Los Angeles on Sunset Blvd. Harry and Albert remained in New York City where they arranged financing and distribution of the California movies. It is of GREAT interest that the first feature film turned out by Jack Warner in 1918 was, "My Four Years In Germany." This was an "atrocities melodrama" which accused the Germans of committing atrocities during World War One and were not very different from the unending stream of anti-German hate movies the Jews crank out today. For some reason the Jews have always harbored a vicious hatred for the German people!

Just as Thomas Edison's invention of the motion picture machine was stolen, the same happened to the Christians who invented the film sound system. They were Lee De Forrest and Theodore Case. The Jews soon got control of the "talking machines and millions of dollars have been flowing into their coffers ever since. Actress Betty Davis has stated that "Jack Warner held the power to decide just who would become a star and enjoyed the glory bestowed upon him by those who catered to his whims. Still Jack was mainly in this business to make money!"

Moving over into the realm of the producers and directors, Tugend says the "majority . . . are Jewish, while the Writers Guild is practically a Semitic closed shop with Jews making up roughly 70 to 80 per cent of the membership." Tugend then asks, "How Jewish is the new generation of Hollywood Jews?" and quotes Charles Powell, an MGM vice-president who says, "They are not self-conscious about being Jews. Now the screen name remains George Segal, where 20 years ago it would have become George Simpson, and the same goes for Richard Benjamin, Elliott Gould, Ron Leibman and others."

# Money Hungry Jew-Parasites Attack Christian Corporations—Disney World Investors Lose \$60 Million

## Buying of America By Modern Day Money-Changers

Who are "The Corporate Raiders" working day and night to buy up America so that the wealth of this great nation can be diverted to the political use of a small group of "self-chosen people?" Each time this question arises the names which spill out are the same, Saul Steinberg, Victor Posner, James Goldsmith, Carl Ichan and Asher Edelman. They are all Jews!

In other words they purchase, say 20% of a companies stock at \$100 a share and announce they are seeking to buy the firm paying other stockholders as much as \$175 a share. This causes the stock to rise near that figure - say to \$165 a share. Then the money-changer sells his stock at \$165 and announces he has lost interest in the company and will not buy it. Those who bought at \$100 and prices on the rise up to \$165 lose because the withdrawal of the money-changer will cause the stock price to crash down to usually below the original buying price of \$100. Therefore if you are not "in the know" and able to sell-out at the high mark **YOU LOSE AND THE JEW MAKES MILLIONS.**

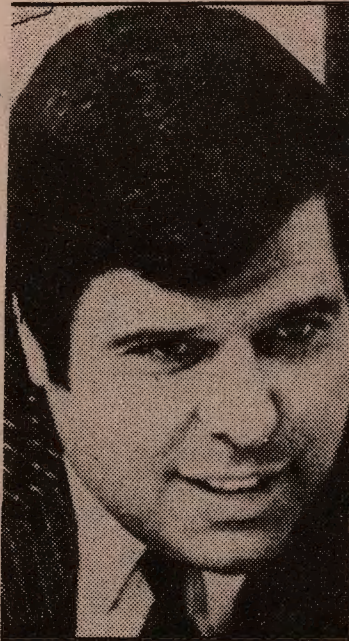

## The Man Who Robbed Disney World

**Saul P. Steinberg's** name is enough to send shivers through the officers of any company he buys stock in. They know he can liquidate the corporation, sell off its assets, merge it with another company and/or fire all the officers and replace them with New York Jews as he has done in the past. Steinberg is only 45 and for over two decades has risen to be rated in Forbes Magazine as one of the richest men in America with a personal worth of around \$200 million.

Disney World became Steinberg target last Summer when this Reliance Holding Co., began buying Disney stock at \$50 a share. Soon he owned 12% of Disney's stock and announced plans to buy 25% giving him controlling interest. Shocked Disney officers saw their jobs in danger and warned stockholders the company would be damaged under Steinberg control. The stock then rose to \$66 a share and Disney officials offered to buy Steinberg out at \$67.50 a share. The deal was worth \$970 million if Steinberg would promise not to buy Disney stock for 10 years. The crafty Jew said he would agree if Disney payed him an additional \$28 million in expenses for his takeover conspiracy cost. Disney agreed and this netted Steinberg the additional \$32 million for his stock for a total profit of \$60 million — **FOR JUST A COUPLE MONTHS CONNIVING!**

This is a perfect example of diabolical Jew money-changing at its worst. Disney stock dropped \$16 to \$49 a share in five trading days. Large stockholders lost hundreds of thousands of dollars. Time Magazine quoted a stockholder saying, "It's like watching your mother getting ravaged by New York thugs." They call this "greenmail," a Wall Street term for "Blackmail."

Steinberg is called the youngest and richest of the Jew "Greenmailers". His robbery and destruction has inflicted great harm upon many honest Christian owned businesses.

## Who Is Saul Steinberg?

Saul Steinberg graduated from the prestigious Wharton School of Finance. He founded Leasco Computer Leasing Co., and then took control of Reliance Insurance Corp., a huge insurance, real estate, petroleum and gas distribution conglomerate. Using its capital Steinberg raids firms with undervalued stock and strong cash flows. He usually takes a 20% stake in a company and threatens a takeover unless he is brought out with multi-millions in profits for himself.

## How Steinberg Destroyed Imperial Savings & Loan

Imperial Savings and Loan owned 97 branch banks with assets of \$6.8 billion. Its stock was priced at \$25 a share but had a book value of \$35. Through Reliance Insurance Co., Steinberg bought 25% of the stock. He then fired Imperial Savings treasurer, Bruce McDonald, who stated "we made efforts to warn other stockholders." Steinberg forced Imperial's founder, V.L. Viskas into "early retirement" at age 54. Then Steinberg sold off the company at \$55 a share. With this liquidation of the company hundreds lost their jobs, but Jew Steinberg made more millions - off the misery of others.

## Steinberg Steals Atlanta's "Days Inns"

**Days Inns** are headquartered in Atlanta with 322 motels with assets of \$700 million and revenues of \$234 million last year. The clever Steinberg approached Mrs. Deen Day Smith after her husband, Cecil Day, Sr., died and bought her entire 72% of the stock for \$300 million. This prevented the 40 founding franchisees from buying the company when they were willing to pay \$310 million for her stock. Steinberg immediately fired Days Inn chairman, Richard Kessler (a German) and replaced him with the Jew Henry Silverman of New York City. John Burton of Bossier City, La., a franchisee said, "Mr. Cicel Day would turn over in his grave if he knew Steinberg now owns his company. We have been taken - changes in the policy of Days Inn may be damaging."

Thus another good Christian company has fallen into the hands of the Jews. The wealth of America as a whole is coming under the domination of the money-hungry Jew. Benjamin Franklin warned our founding fathers against allowing Jew immigration stating it will lead to our offspring all working for slave wages while the Jew sits counting our money. Thus it has come to pass!

## Companies Destroyed Through Merger

Miami financier Victor Posner who is personally worth over \$200 million has controlling stock in at least 40 companies including Royal Crown Cola. Recently he sought to seize control of National Can paying \$77 million for 3,630,900 shares of stock. One of his companies, Sharon Steel lost \$36 million last year and Evans Building Materials lost \$58 million. Thus Posner sought to merge National Can with these two money losing firms in order to "bail them out."

This was successfully fought off by National Can president Frank Considine who warned stockholders that Posner was attempting to "raid" National Can to save his "eroding empire." Posner then turned around and sold all his shares to a fellow Jew, Nelson Peltz, of Triangle Industries Inc. Posner bought National Can at \$21 a share and sold out to Peltz at \$41 totaling \$149 million (or a profit of \$72 million.) As usual the price of the shares fell drastically after the "battle" was over. Jews usually will turn their interest in a company over to a fellow Jew if possible to keep the wealth in Jewish hands.

## VIEWING THE NEWS Bush Restates Policy

Vice President George Bush has restated his views on the Middle East in a speech before Bar Ilan University supporters in New York. Speaking on June 5, he said that the United States will not negotiate with the PLO unless "the PLO explicitly" accepts U.N. Resolutions 242 and 338 "and recognizes Israel's right to exist."

Bush, who was instrumental in the implementing of the airlift that rescued hundreds of Ethiopian Jews this spring, pledged that "never again will the cries of abandoned Jews go unheard by the United States government. . . . If the Soviet leaders want to signal a sincere desire for improved relations, they know where to start: Let the refuseniks go."

Bush defended the right of the Jewish community to speak out on matters of concern. "I've heard some people criticize the Jewish community for its vocalness on issues it believes in. Well, I don't go along with that. I believe that citizen advocacy is the greatness of America. It's what strengthens and gives vitality to our country. Let no one tell you that support for Israel and efforts on behalf of Soviet Jews is special interest politics. It is your right and duty as Americans. . . ."

**Sen. Robert Packwood** says he always carries a shekel in his pocket. When the shekel (Jewish money) was minted it was supposed to equal the value of a U.S. dollar.
