

Jewish Spy Got 6th Fleet Secret Code

Is Israel Really "Our Best Friend?"

Strange Case of The Jewish Spy Who is Jonathan Pollard?

Jonathan Pollard, 31, was an analyst for U.S. Navy Intelligence. He has been charged with treason for transmitting highly secret information to a foreign power - ISRAEL. Pollard is from a prominent Jewish family in South Bend, Ind. His father, Dr. Morris Pollard, is a professor at Notre Dame University. The family rabbi said: "Jonathan is an outstanding scholar and the prototype all-American boy."

Jonathan Pollard, an ardent Zionist, spent a lot of time living in Israel including a stint as a volunteer in a Marxist Kibbutz Communal. As a student at Stanford University in the mid-1970s Pollard told classmate J. Marshall that he was being groomed by Israel's secret police agency, MOSSAD, to work in the U.S. government. Today, Marshall is editorial page editor of "The Oakland Tribune." Pollard told Marshall he was already on the MOSSAD payroll as a colonel and had received "military training in Israel."

On Nov. 21st, Pollard discovered that he was under 24-hour surveillance by the FBI. He phoned his control agent, Ilan Ravid, at the Israeli Embassy in Washington. He wanted to be granted asylum in the Embassy building and flee to Israel for protection under the Jewish "Law of Return" which grants Jews automatic citizenship. When Pollard arrived at the Israeli Embassy he drove his car right past the gate, jumped out, and ran up to the entrance.

Screeching to a stop right behind him at the gate were two FBI cars. Jew MOSSAD agents were shocked. They had earlier told Pollard they would hide him out in the Embassy only if he could "shake" his FBI surveillance. Thus they faced a predicament and no doubt received an instant communication from Israel to turn him away. Pollard was carried off the Embassy grounds and handed over to the FBI. The next day Pollard's wife was arrested while carrying secret documents and charged with espionage. She was an employee for the National Rifle Assn. (NRA) and providing MOSSAD with information on the Pro-gun organization. (NOTE: Jews want all Americans disarmed.) Pollard has confessed that for the past 18 months he has received \$50,000 for spy activities.

What Secrets Did Pollard Steal?

Pollard was able to give Israel the secret military code of the U.S. Sixth Fleet, which is stationed in the Mediterranean, primarily to protect Israel. The Jews also learned the radar jamming techniques and electronic capabilities of true U.S. allies such as Saudi Arabia, Jordan and Egypt. Pollard obtained secret information on joint U.S.-Egyptian military exercises. Of course, the truth about the full extent of the damage caused by

Jewish Spies Steal Our Uranium, Krytrons, and Secret Tank Cannon

Israeli Spy Scandal Spreads Jews Steal Atomic Trigger Device

Atomic Bombs require a tiny 2 inch long device called Krytrons to set off the reaction. Some 8,100 Krytrons have been stolen by Jewish spies. Richard Smyth of Huntington Beach, Calif., was charged with selling the Krytrons to Heli Trading Co., in Tel Aviv. This firm is a front for Israel's spy agency called the Science Bureau. Heli is owned by film producer Arnon Milchan who made such Hollywood movies as "Once Upon A Time In America," which starred Robert De Niro. On the eve of the trial last August, Smyth and his wife, disappeared and are believed to be living in Israel today.

Israeli Front Steals U.S. Uranium

Admiral Hyman Rickover (Jew) bestowed a lucrative Navy nuclear contract with the NUMEC Co. in Apollo, Pa. This firm was headed by Zalman Shapiro. The job was to process uranium, the product from which Atomic Bombs are made. Some 752 pounds of uranium vanished while Shapiro headed the project. This is enough to make 38 Hiroshima sized Atomic Bombs. The CIA believes it was diverted to Israel which all of a sudden was able to develop Atomic weapons.

Shapiro was also half owner with the Israeli government in the Isorad Co., which made nuclear equipment. One federal document in the investigation

of Shapiro quoted a NUMEC employee who wandered on to the loading dock late one night. He stated: "I was met with an armed guard who ordered me to leave the area. Another official of NUMEC warned me to keep my mouth shut concerning the loading of a truck and that I could be fired."

While denying shipping uranium to Israel NUMEC eventually paid the U.S. Atomic Energy Commission \$1 million for the "lost" uranium. Today Zalman Shapiro works for the nuclear fuel division of Westinghouse Electric in Pittsburg, Pa.

Superior U.S. Tank Process Stolen By Israel

The U.S. Army is five years ahead of other nations in the development of the 120mm tank cannon barrel whose chrome plating process makes the gun last longer and shoot straighter. U.S. Customs

agents raided firms in Penna, N.J. and Conn., seeking cannon barrels and their plans which were to be shipped to Israel. The Jew Herbert Fishman, president of the raided Napco Co., in Plymouth, Conn., denied the charge, but a former president of the firm said they were working for Israel. The new weapon was developed at the U.S. Army Arsenal near Albany, N.Y. NBC-TV news cameramen accompanied the agents in the raid and reported the material was about to be shipped to Israel by the G & B Packing Co., of Bayonne, N.J.

Israel's Prime Minister Peres responded: "Allowing NBC to televise this matter is evidence that some U.S. agencies are undertaking a private crusade against Israel. That's very severe and is something you just don't do to a friend."

The Jews of Israel have taken this "friendship" business too far. The time has come to recognize the simple truth that Israel is no ally and no friend of America. No Arab nation has ever stolen any military secrets from us! Arab nations oppose Marxism which is a philosophy that has been adopted by many segments of Israeli society, the Marxist Kibbutz Communes being a prime example. There is no reason for America to treat Israel any better than we do the Arab states whom we have much more in common with than we do with Marxist Israel. The time has come for us to reconsider just who are our real friends in the Middle East.

Pollard's treachery may never be known. Actually, Israel itself is guilty of betraying the U.S. hand that feeds her.

It is said that Jews are guilty of a "dual loyalty" to both America and Israel. This is a false presumption. Pollard and other Jewish supporters of Israel owe their total loyalty to Israel and hold this nation in utter contempt.

Israel not only receives a free ride on U.S. foreign aid but is guilty of stabbing America in the back at the very same time. Is Israel our "friendly ally" or a dangerous enemy? Who Did Pollard Work For?

The question of exactly which Israeli Leaders knew about the secret spy activities of Pollard has raised eyebrows. Tracing this gang of spies may well answer the question. Pollard has confessed to working for Israel's secret police (MOSSAD) through the front called, "Science Bureau." This cover has agents operating out of the Israeli Embassy in Washington, D.C. and the Israeli Consulates in New York, Boston, and Los Angeles.

Pollard passed secret U.S. data on to Science Bureau representatives Ilan Ravid in Washington and Yosef Yagur in New York City. The very next day after Pollard's arrest both Ravid and Yagur were "recalled" to Israel. When this leaked out Israel Ambassador Meir Rosenne denied what was open knowledge, saying, "Nobody has left!"

The science bureau is part of Israel's Defense Ministry headed by Moshe Arens. Thus he must have known about the spying. The head of the Science Bureau in Israel is Rafael Eitan. He is the former chief of operations for MOSSAD and directed the kidnapping of German Gen. Adolph Eichmann from Argentina to Israel in 1960 for a staged show trial which was followed by Eichmann's murder.

Rafael Eitan is a member of the Likud Party of Prime Ministers Begin and Shamir. He served as advisor on terrorism to both Begin and Shamir. (Shamir is scheduled to become prime minister again next summer as part of the rotating agreement with Peres in their current coalition government.) When Peres became Prime Minister in Sept. 1984 Eitan stepped down to operate the world-wide spy network known as the Science Bureau. Thus Arens, Begin and Shamir must all have known the true role of Jonathan Pollard and officially approved this spy operation against America.

We Should Not Object to Jew Spying???

Jewish Leaders of the Israeli Government have done all within their power to stonewall the U.S. investigation into the Pollard spy case. Despite the fact that Israel is totally dependent upon U.S. foreign aid for its very existence they have thumbed their noses at our requests for an official explanation as to exactly who in the Jew government was responsible. The Jewish Lobby in Washington, (known as the American-Israeli Public Affairs Committee or AIPAC) brags that they control 74 U.S. Senators and 280 House members. They believe our elected officials fear Jewish money power enough to insure their open end access to the money in the U.S. Treasury.

***Jerusalem Post** of Dec. 7th "Israeli officials stressed that the information acquired by Pollard was not harmful to U.S. security and should have been transmitted to Israel through normal channels."

***New York Times** of Nov. 30th quotes an unnamed "high Israeli official" - as saying "The information Pollard turned over to us was vital. It was the kind of information we expected to be given to us by the U.S. as part of our general exchange of intelligence - but the Americans weren't giving it to us."

***Israel's belligerent Gen. Ariel Sharon**, who led the bloody invasion of Lebanon, said on Dec. 4th; "Israel has given the U.S.

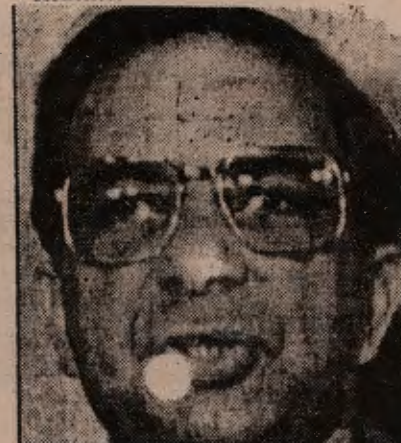

Man in Israel Spy Case Is Chosen for New Post

JERUSALEM, Jan. 8 — The Israeli Ministry of Industry and Trade announced today that it was nominating Raphael Eitan for the position of chairman of the board of Israel Chemicals.

Israel Chemicals is the country's largest Government-owned industrial organization.

Mr. Eitan, a former senior intelligence official and adviser to the Prime Minister on terrorism between 1978 and 1984, was identified by the Israeli press as the man who ran Israel's purported espionage operation in Washington.

It was Mr. Eitan, according to Israeli sources, who oversaw the activities of Jonathan Jay Pollard, a Navy intelligence analyst accused of spying for Israel.

\$82 billion in intelligence information over the past three decades and is an asset to the U.S. The data acquired by Pollard should have been given to us in the first place." ***The New York Times** of Nov. 30th, "American perfidy has prolonged this affair. Mr. Pollard delivered mounting evidence of U.S. spying against Israel. Stealing secrets about non-American subjects isn't really spying." (NOTE: U.S. State Dept. spokesman Charles Redman replied, "There have been reports that our assessments of Israeli defense capabilities have been obtained covertly or illegally. That's not the case. We have asked the Israeli Government to return all the Pollard documents. We regret their delay."

***Israel's Insulting "Apology"** came with Prime Minister Peres statement which included the following self-serving words designed to sweep the affair "under the rug" stating...an action of this kind, if indeed it did take place, was mistaken!"

Response by Cowardly U.S. Political Leaders

The Washington lackies of the Jewish Lobby were quick to seize upon Peres backhanded, so-called, "apology." Sen. Daniel P. Moynihan, (D-N.Y.) thundered on the TV show, This Week with David Brinkley: "We should start pulling out the fingernails of these spies to prove it won't be tolerated." But when asked about Israel's spy Pollard he purred, "They've offered us a very handsome apology. We can straighten this out in no time."

***The Atlanta Constitution** of Dec. 3rd: "The State Dept., influential congressmen, even two former heads of the CIA have all expressed satisfaction with Peres' apology. Washington is keen to get this over with. It seems prepared to believe that secret information was passed on without the knowledge of the MOSSAD or Israeli government leaders."

***Secy of State, George Shultz** on Dec. 1st, "The apology by Peres is welcomed and is an excellent statement. I am satisfied with it."

Whitewash of the Pollard Case

Jew Named To Investigate Pollard Case

In an astounding development Secy. of State George Shultz named the Jew Abraham Sofaer to head the team sent to Israel to question those who were Pollard's "controllers" in the MOSSAD. Sofaer is a former New York judge and now is the legal advisor to the State Dept. When Shultz spokesman Charles Redman announced the Sofaer appointment at a press conference one courageous reporter shocked all by daring to ask the sensitive question, "Is it true that Judge Sofaer is a Zionist Jew and a frequent visitor to Israel. Would he have a difficult time being impartial in such an investigation?"

Redman was shocked and gave no direct answer. Has anyone ever heard of a Jew being fair in such a case? Their real bible, "The Talmud," expressly instructs Jews to always favor a fellow Jew in any conflict between a Jew and a Gentile. It should also be noted that Sofaer was the judge who presided over the libel suit of Israel's Gen. Ariel Sharon against Time Magazine. Sharon won the case after many rulings by Sofaer in his favor. Time had charged that Sharon was involved in the massacre of Palestinian civilians in the refugee camps outside Beirut.

No Punishment For Spy Chief

Official spokesmen in Israel stated that "heads would roll" when they discovered exactly who was in charge of Pollard's spy activities. The U.S. demanded stiff punishment and the press said someone would be fired in disgrace and blackballed from government work forever. The trouble is that Israel's top leaders including Defense Minister Arens and Vice-Prime Minister Shamir must have known of Pollard's activities and granted full approval.

Thus, on Jan. 9th, a tiny article appeared in the Jewish owned New York Times announcing that Pollard's spy chief, Raphael Eitan, had just been appointed to the high paying position of Chairman of the Board of Israel Chemicals. This does not sound much different than the Science Bureau. Thus, very little changes, and the enemies of America continue to submerge our best interests beneath those of Zionism. Is Israel really America's best friend and ally??? With "friends" like this we don't need any enemies!

Disloyal Jews Infiltrate U.S. Government

The Conference of Presidents of Major American Jewish Organizations is the powerful group which coordinates the activities of every local Jewish community group in America. Their day to day operations are directed by the world Zionist leadership based in Israel. The head of the Conference is Kenneth J. Bialkin. He recently stated:

"Politicians should keep in mind that the nature of the secrets obtained (by Pollard) do not go to elements of U.S. defense and U.S. preparedness. Long Term Mole Stephen Bryen

American businessman, Michael P. Saba of North Dakota, overheard a shocking conversation while eating in an exclusive Washington hotel coffee shop. The date was April 13, 1979 when Mr. Saba overheard Stephen D. Bryen offering classified U.S. intelligence information to two men suspected of being Israeli MOSSAD spies. Bryen, who is Jewish, referred to Jews as "us" and Americans as "them."

Mr. Saba took this information to the Washington office of the FBI. He passed a lie detector test and gave the Justice Dept. a sworn affidavit on what he heard. Bryen, at that time was a senior staff officer for the Senate Foreign Relations Committee. The Justice Dept. amassed a 632 page file on Bryen which included information that his "controller" is the known Israeli spy Zvi Rafiah who operates out of Israel's Washington, D.C. embassy.

More on Bryen Case

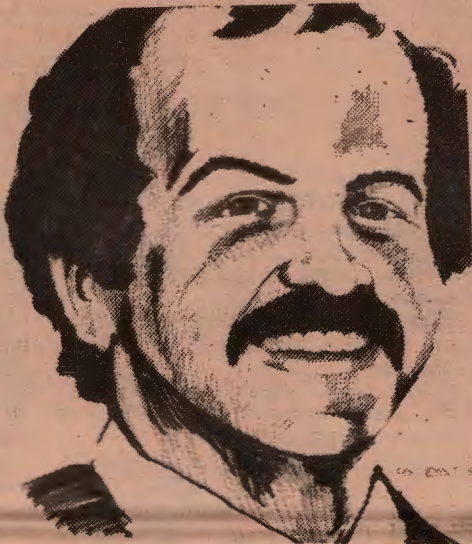
The Wall Street Journal of Dec. 18th reported that Bryen appeared to show his Israeli diplomat luncheon guest a Pentagon document with the location of military bases in Saudi Arabia. The Justice Dept. file included one memo stating Bryen had a "highly unusual relationship" with Israeli diplomats, including one who visited his Senate office regularly and appeared to be "giving him orders on more than one occasion."

Another memo stated there were "unanswered questions" regarding Bryen's efforts to obtain sensitive information unrelated to his Senate job that would have been of "inestimable" value to the Israelis.

There was a great deal of pressure brought by wealthy Zionist Jew businessmen and pro-Israeli lobby Senators on the Foreign Relations Committee to have the investigation of Bryen stopped.

The Wall Street Journal ends its story declaring:

"Former U.S. intelligence officials state there have been

several other FBI investigations of alleged Israeli spy activity, most of them attempts to steal U.S. technology. The FBI says it cannot disclose how many such cases exist. Cases of alleged Israeli spying during the past 20 years have been accompanied by missing witnesses and evidence, and occasional instances of strong political pressures to close investigations without bringing criminal charges."

"The Spotlight" Breaks Sensational Story

The Spotlight, Washington, D.C. investigative newspaper, revealed that the Jew Richard Perle, obtained an appointment for Bryen as Assistant Secretary of Defense for Economic Trade and Security Planning. Perle himself is U.S. Assistant Secretary of Defense For International Security Policy. Thus Bryen works directly under Perle! The two became personal friends having met while attending a Washington synagogue.

It is also of interest to note, that during the summer of 1983 Perle came under press criticism for accepting a \$150,000 fee from an Israeli government armaments firm. He had urged the U.S. army to grant them military contracts.

Claudia Wright unravels a network of US-Israeli arms trade connections and explains who's pulling the strings

ISRAEL HAS ALWAYS had well placed friends in the US Administration and Congress; but, when the Reagan Administration came to power, an unprecedented transformation occurred in the network of Israeli-American contacts.

Through connections with Israeli defence and intelligence officials, and lucrative ties with Israel's defence industries, this network has devised a new strategy for Israel's relations with the US, and has won official US approval over powerful domestic corporate opposition. The strategy aims to supplement the already high levels of cash assistance to Israel with American purchases of Israeli weapons for the army and marine corps. This multi-million dollar trade in Israeli arms for the US is to be built on co-production arrangements with US defence manufacturers, financed by subsidised loans and grants from Congressional appropriations for Israel. The arms trade - the Israeli economy's last chance of staving off bankruptcy - is also dependent on export permits to release the classified US military technology on which Israeli weapons designs are based.

The leading Pentagon officials in this strategy are Richard Perle, Assistant Secretary of Defense for International Security Policy, and Stephen Bryen, Deputy Assistant Secretary for International Economic Trade and Security Policy. According to public information provided by Perle, before he joined the Pentagon in March 1981, he received at least \$140,000 in consulting fees for advising the Israel weapons company, Soltam, on marketing their products in the US (see NS 22 April). According to files of the FBI and Justice Department, Bryen has been under investigation for espionage on Israel's behalf, and for failure, when he was a staff member of the Senate Foreign Relations Committee, to register as an agent for Israel (NS May 6).

Perle and Bryen are responsible for the Pentagon's technology transfer policy. They play a key role in deciding what military technologies can be released to foreign states and companies. By the appointment of staff and consultants who are favourable to Israel requests, they can tip the balance of Pentagon thinking in their favour.

They can also play an indirect but influential role in the appointment of pro-Israel officials to positions in the research and development and procurement bureaus of the military services. Through associates on Senate and House committees, in defence consulting firms and academic think-tanks, pressure for pro-Israel decisions can be adroitly stimulated and directed.

Perle and Bryen refuse to respond to questions about their relationships with Israel. However, a list of consultants to Perle and Bryen, provided by a Pentagon source,

reveals strong links with Israel's defence establishment, with Israel lobby groups in Washington and with a network of pro-Israel officials well placed to influence weapons development and procurement decisions on Israeli request.

One of the consultants, according to Pentagon files, is retired general John Vogt. A second is Clement Caditz. Both are associated with the Jewish Institute for National Security Affairs (JINSA). This Washington-based group was directed by Bryen between 1979 and 1981, before he

went to work for Perle at the Pentagon. It was then taken over by his wife, Shoshana Bryen. According to JINSA literature, its purpose is 'explaining the link between US national security and Israel's security, and assessing what we can and must do to strengthen both'.

A Washington defence analyst says that JINSA operates 'like a front for the Israeli embassy'. He says that he has received briefings by JINSA from officers of the Israel defence forces attached to the embassy. Defence analyses published in JINSA's newsletter promote Israeli weapons, as well as US weapons sales to Israel.

IN ADDITION TO Vogt and Caditz, several others associated with JINSA are involved in administration policy making. Rudy Boschwitz, one of JINSA's advisors, is chairman of the Senate subcommittee on the Near East and South Asia. Max Kampelman, another advisor, is chief of the US delegation to the Conference on Security and Cooperation in Europe, meeting in Madrid. Michael Ledeen, a member of JINSA's board of directors, was special advisor to Secretary of State Alexander Haig. Gordon Zacks, a Cleveland shoe manufacturer and JINSA advisor, was recently asked by Vice President George Bush to organise a national Jewish Republican coalition for President Reagan's re-election campaign. Eugene Rostow, the former arms control director, is also a JINSA advisor.

The Boston Globe described Perle as an "adroit, noiseless manipulator of U.S. national security policy." He first entered government under the Carter Administration and has long had the reputation of being a radical Israel Firster.

The Justice Dept. 632 page file on Bryen was conveniently "lost" when he obtained his Defense Dept. appointment. Then "The Spotlight" reported that the missing file was found on May 16, 1983 but had been heavily censored. A Washington law firm issued a new 180

page report on evidence of Bryen's spy activities but the Justice Dept. announced "there is not enough conclusive evidence of espionage activity thus the case is closed."

The reason the Jew spy agency MOSSAD is so effective is that it can count on Jew businessmen for spying in every single Jewish community wherever they reside in the entire world. That is why they have a World Jewish Congress and in each country a Conference of Presidents of Major Jewish Organizations. It

is all part of combining the money influence and resources of prominent Jews toward the goal of building Zionism into a world power.

All the efforts of the local Jewish community are aimed toward advancing political Zionism and this extends right down to the meetings and deliberations in local synagogues and in the neighborhood Jewish Community Centers. Israel Receives One-Third of U.S. Foreign Aid

Last year Israel received a whopping \$4.5 billion of U.S. Foreign Aid. This year they will receive \$3.8 billion and Egypt will be given \$2.7 billion out of a total foreign aid budget of \$15 billion. The balance is

distributed to the 110 other poor nations of the world who overall receive very little compared to what the Jews receive. It should be noted that aid to Egypt is actually the same as aid to Israel because this was part of Jimmy Carter's Camp David Accord. Egypt was blackmailed with U.S. Foreign Aid money to sign a peace treaty with Israel. They were told in no uncertain terms that this money will be cut off anytime they have a falling out with Israel. Jew Sen. Arlen Specter of Penna., is already threatening such a cutoff because Egypt is again on friendly terms with her Arab neighbors.

Aid to Egypt is supposed to equal that given to Israel but this is not the case when you consider that there are fewer than 3 million Jews actually living in Israel and some 43 million people live in Egypt.

Already the IMF is threatening Egypt because of its \$1.3 billion payments deficit for 1985. The IMF says Egypt's exports are "virtually stagnant" because the price of oil has crashed and this is their main export. Israel is far worse off but owes the IMF nothing since the U.S. gives them all the money they need free of any repayment requirement. What lucky people these Jews are to have Uncle Sap to feast on!

He says he supports Israel because "I am convinced that it is in our best, national interest to make sure that a strong, viable Israel continues to exert its influence in that part of the world." The Israelis are "the only reliable ally we have in that part of the world," he asserted.

'A Residue of Anti-Semitism'

He has strongly opposed the sale of aircraft such as AWAC's and F-15's to the Saudis, and he says that any Is-

raeli Government that gives away the West Bank or Golan Heights "deserves to be impeached." He says he does not understand why "administration after administration, Republican and Democrat, puts the squeeze on Israel." The only possible explanation, he adds, is that "there's still a residue of anti-Semitism, people who mutter under their breath, 'those damned Jews.'"

When the Democrats controlled the chamber, Mr. Inouye headed the intelligence committee and an appropriations subcommittee. He says he remains the ranking Democrat on the subcommittee mainly because it enables him to work for funds for Israel.

At George Washington Law School in Washington after the war, Mr. Inouye came under the influence of two friends, both Jews. The father of one was the chairman of the Israel bond drive, and Mr. Inouye became a bond salesman. "In those days, when a country was born it was a big event," he said.

Mr. Inouye then immersed himself in Jewish studies under the guidance of a rabbi and considered converting to Judaism.

He worries that the United States repeatedly sends the Israelis "strange messages that heighten their paranoia." That is how he described giving the AWAC's and F-15's to Saudia Arabia. "The justification was evenhandedness," he said, "but it was simply anti-Israel."

To send another kind of message, he plans to introduce legislation to lower the interest rate on United States loans to Israel, reducing it to 8 percent from its current average of 11 percent.

Cut Israel's Interest In Half

WASHINGTON—A bill that would reduce Israel's foreign debt by slashing the hefty interest rate levied by the U.S. on all loans to Israel has been drafted by Sen. Daniel Inouye (D-Hawaii)

Inouye, the ranking Democrat on the subcommittee on foreign operations, told the 150 participants in the 1985 Washington mission of the New York UJA-Federation of his proposal to cut the interest charged by the U.S. from the present 15½ percent to 5 percent—a measure that could save Israel more than \$8 billion a year.

"Israel will continue to pay the U.S. the principal, but the interest will be cut down to 5 percent," Inouye, who recently returned from a

congressional mission to Israel, told the group of leading Jewish philanthropists.

"To say we are saddened by the state of Israel's economy is an understatement," Inouye continued. "Inflation hovers at 800 percent. Israel is now in a state of jeopardy. We must help Israel. Otherwise, it may be vanquished, not by her neighbors but by the economy."

According to Inouye, serving his fourth Senate term, 70 percent of Israel's foreign debt—which hovers near \$24 billion—is owed to the U.S. for military and defense assistance.

"I think it's a bargain to forgive Israel 6 to 8 percent of the interest owed. I have no qualms about forgiving Israel," said Inouye.

Cutting Israel's Interest Will Cost Half Billion

Sen Robert Kasten (R-Wisc.) and Sen. Daniel Inouye (D-Hi.) have gained notoriety as two of the most groveling pro-Jew Senators. They have angered many fellow senators by introducing a bill which would "forgive" Israel of having to pay \$531,719,682 in interest owed on their debt by transferring this amount onto the backs of the American taxpayers. Israel is paying 11.5% interest on loans from this country. This is the same amount other nations pay in interest for U.S. loans. Seeking to ingratiate themselves ever more deeply with the Jews Senators Inouye and Kasten want the U.S. taxpayer to "buy down" the interest the Jew state has to pay from 11.5% to only 5% interest. THIS WOULD COST AMERICAN TAXPAYERS NEARLY HALF-BILLION DOLLARS!

This pair attached the amendment to an obscure export-import bill. Sen Mark

New York Lawyer Had a Key Role in S.C.L.C. Efforts to Further Civil Rights Movement

Stanley David Levison, a New York lawyer and businessman, who was a key adviser to the Rev. Dr. Martin Luther King Jr. and an important behind-the-scenes figure in the Southern Christian Leadership Conference, died Wednesday at his home after a long illness. Mr. Levison, who lived at 85 East End Avenue, was 67 years old.

As a lawyer, Mr. Levison played a prominent role in civil rights, peace and labor causes. He was known for his strong support of the S.C.L.C., the non-violent group that Dr. King headed and forged into a powerful arm of the civil rights movement in the 1960's.

Andrew Young, former chief United States delegate to the United Nations, who is now in Douala, Cameroon, said of Mr. Levison:

"Stan Levison was one of the closest friends Martin King and I ever had. Of all the unknown supporters of the civil rights

movement, he was perhaps the most important. He never pushed his own views on us, but was always willing to be critical and to think through ideas with us. Stan and his wife and his son have been part of my family."

Tribute From Coretta King

From Atlanta, Dr. King's widow, Coretta Scott King, paid tribute to Mr. Levison, saying:

"I was deeply saddened to learn of the death of Stanley Levison. Stanley Levison was more than one of my husband's most

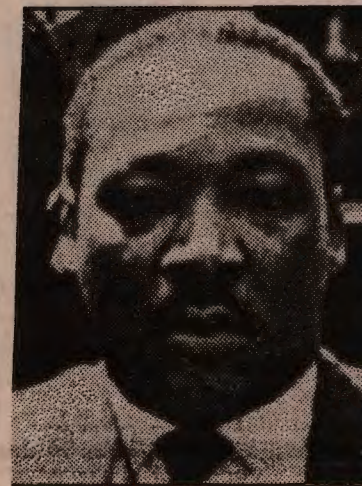

In 1954 Jews Bombed U.S. Buildings in Egypt

The Infamous Lavon Affair: Israel Sought To Blame Egypt For Attack

Egypt had a new nationalistic leader in 1954-Col. Gamal Nasser. Great Britain was ready to turn the Suez Canal over to Egypt. Pres. Eisenhower was on very friendly terms with the Arab states whom he considered valuable anti-communist allies. The Jewish secret police, MOSSAD, was determined to divide us and bring war against her Arab neighbors.

MOSSAD established an espionage underground in Egypt using wealthy members of the Jewish community. Dr. Moshe Marzuk, of the Jewish Hospital was made head of the terrorist cell in Cairo and Samuel Azar, a teacher, headed the cell in Alexandria. Some young Zionist members of the network left for France for a "vacation." From there an Israeli ship took them to Haifa. They were trained in the use of explosives, micro-photography, coding, and how to manufacture explosives from chemicals easily obtainable in any drugstore. They also were taught how to commit acts of sabotage.

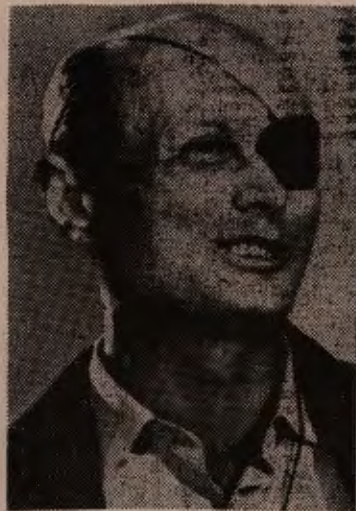
Attack on U.S. Ordered

The Jewish terrorists returned to Egypt with short-wave receivers and commenced a regular exchange of messages with Tel Aviv. Israel's Defense Minister, Pinhas Lavon and Commander in Chief of the Army, Gen. Moshe Dayan decided that drastic action had to be taken to disrupt the friendly relationship developing between Egypt and America and England. MOSSAD sent the Jews living in Egypt orders to commence, "Operation Egypt." This was the code to initiate the plan to

bomb libraries, cultural centers, embassies and consulate buildings belonging to America and Great Britain. The scheme was to throw the blame on the Egyptian followers of Col. Nasser.

Jewish Terrorists Captured

The night of Jewish treachery took place on July 14, 1954. Young Jewish saboteurs set off fire bombs in

American information centers and consulates in both Cairo and Alexandria. On July 16th, the Israeli newspaper "Ha'aretz" reported the attacks stating that violent Egyptian nationalists were seeking to drive the Americans out of Egypt. Many of the world's newspapers repeated the story.

On that very same day Tel Aviv sent a message that British buildings should next be attacked. On July 23rd another attack was launched at five new targets. This time a fire device in Philip Nathanson's pocket went off and he had to be rescued by an Egyptian policeman.

Nathanson talked and 11 spies were quickly rounded up. Their maps, radio transmitters, etc., were seized. One spy, Paul Frank confessed and became a

double agent for the Egyptians. The trial began on Dec. 11th but the night before two defendants committed suicide, including Max Bennett, head of the spy ring. Two other sabotage leaders were condemned to death, six were given seven years to life and two were acquitted.

Brings Down Israeli Government

The scandal shook the Western world. It became known as "The Lavon Affair" which is still discussed to this day by experts studying the reasons why the Jews attacked the U.S.S. Liberty. Defense Minister Lavon was forced to step down to save Leaders higher up. Later, even David Ben-Gurion, the "father" of the Zionist state had to resign from office after he was implicated in The Lavon Affair.

Paul Frank moved to Europe where he lived four

years. He was then enticed back to Israel on the pretext that sick relatives wanted to visit him. Frank was then arrested by Israeli police. He was given a prison sentence of 10 years for "collaborating" with the Egyptians in order to save his own neck.

Jews Cast Blame

The head of MOSSAD, Iser Harel, as late as 1972 called Frank a "traitor" for confessing to the Egyptians the political purpose of the plot. This was to make the British and Americans believe the Egyptians were attacking our diplomatic buildings in order to turn our people against Egypt.

Another member of the conspiracy, who personally bombed some of the American buildings, was Avri El-Ad. He escaped back to Israel and testified before a military tribunal that even David Ben-Gurion was in on the conspiracy. While this helped

bring about the resignation of Ben-Gurion El-Ad was given 10 years in prison for revealing such top secret information. Upon leaving prison he disappeared.

Today's Jew Terrorists

Avri El-Ad's name popped back into the spotlight when he was arrested in Los Angeles for manufacturing counterfeit Jordache designer jeans. (Jordache Jeans are owned by another Israeli Joe Nakash.) There were two assassinations of Christian Patriots by Zionist Jews in America last year. Also, we have had numerous bombings of offices of American-Arab groups. There have been two attacks against the office of the Institute For Historical Review and the homes of its supporters. They question the validity of the holocaust claims. Could ex-saboteurs such as Avri El-Ad who have already bombed U.S. property in Egypt now be working with the Jewish Defense League which the FBI says they believe is behind such acts of terrorism in America?

The attack on the U.S.S. Liberty and The Lavon Affair were both designed to cast blame for these acts of terrorism on the Egyptians. Jewish terrorism must be exposed and smashed once and for all in America.

Jews Approve Nicaragua

New Jewish Agenda is an organization which checks on alleged anti-Semitism in overseas countries. Recently it was charged that Jews in Nicaragua were being discriminated against. New Evidence Proves Israel Deliberately Attacked USS Liberty Killing 34 U.S. Sailors

Jews Knew Liberty Was U.S. Ship

The Jews have always claimed they thought the Liberty was an Egyptian war ship and that is why they sought to sink her. The facts band this a treacherous LIE! The Israeli invasion of Egypt and Jordan was in its fourth day when Jew pilots, flying U.S. Jets began their surveillance at dawn on that fateful morning of June 8, 1967. It was a bright sunny day and the Liberty was sailing in international waters 14 miles off the Egyptian coast.

The Liberty was flying a 5x8 foot American flag and had 10 foot high U.S. numbers "GTR-5," painted on its stern. Later the Jews claimed the ship flew no flag at all! After 9 hours of circling the U.S. ship the Jews attacked the 10,000 ton, 459 foot long Liberty. This was an electronic surveillance ship and armed with only four .50 caliber machine guns. The crew at first paid little attention to the Jew jets flying overhead. They were caught leisurly cruising at just 5 knots while many crew members were sunbathing on the decks.

Washington Covered-up Sneak Attack

What was the bloodiest 20th Century peacetime attack on a U.S. Navy ship?

* Was it the 1937 Japanese bombing of the U.S.S. Panay Gunboat in Chinese waters?

* Was it the 1968 North Korean attack on the U.S.S. Pueblo?

* Was it the 1975 Cambodian seizure of the freighter Nayaguez?

If you named any of the above you were WRONG. The bloodiest peacetime attack upon a U.S. naval vessel was the June 8, 1967 Israeli attack on the U.S.S. Liberty which left 34 U.S. sailors dead and another 170 wounded. The total 317 member crew had been assigned to their deaths by Israel's Defense Minister Moshe Dayan!

The Treacherous Sneak Attack Begins

The Israeli jets attacked and hit the ship with rockets. They shot down the American flag and our boys quickly put up another huge 7x13 foot flag. The Jews had their orders direct from Israeli Defense Minister Moshe Dayan - they were to "SINK THE LIBERTY AND KILL ALL ABOARD!"

Again and again they attacked jets screaming in at low levels firing every weapon available. Jewish torpedo boats came in for the final kill. The Jews used U.S. radar equipment to jam the Liberty's S.O.S. "Mayday" cry for help. Thus they struck the Liberty again and again hitting the ship with 821 rocket and cannon blasts. BUT, THE LIBERTY PROVED TO BE UNSINKABLE AND REFUSED TO GO DOWN!

Then all of a sudden the Liberty was able to get through a "Mayday" distress call. The U.S. Sixth Fleet, some 600 miles away instantly dispatched two flights of four U.S. jet fighters to save the Liberty. The Jews intercepted the message and immediately pulled back. Tel Aviv quickly notified Washington that the attack had been called off claiming it was all a mistake. Pres. Lyndon Johnson had the U.S. rescue jets return to their carriers. The Jews then claimed that before the attack they had signaled the Liberty to identify herself and received no reply. The ship's commander, William L. McGonagle, branded this a brazen lie. He said there was no message from the Jew jets before the attack because they knew for certain that this was a U.S. ship!

Why Did The Jews Attack The Liberty?

Just as official Washington denied any knowledge of the Jews invasion of Lebanon, (when they had full knowledge), the Johnson Administration claimed total surprise by the Israeli sneak attack against Egypt and Jordan. In fact, the U.S. constructed an ultra-secret air base manned by Americans in the Negev Desert of southern Israel. From it America's most advanced reconnaissance aircraft flew over Arab military positions to give the Jews full information for their surprise knockout blow. (Shades of Roosevelt's advance knowledge of the Japanese sneak attack against Pearl Harbor!)

At the same time the Jews had promised not to take the entire Sinai Desert. The U.S. had agreed to a secret plan limiting the Jews to seizing the West Bank from Jordan. Washington was deliberately misled, but as usual the Zionists correctly believed, that the pro-Israeli lobby was so all-powerful that no one in the White House or in the Congress would dare to raise their voice in protest when the world would realize how extensive their plans were.

On June 7th the Israeli ambassador in Washington was told the invasion of Egypt must stop. It was eight hours later when Moshe Dayan gave the orders to sink the U.S.S. Liberty. When the fighting ended on June 10th the Jews were the masters of the Sinai, occupying even the Eastern banks of the Suez Canal, all of the West Bank of Palestine and finally Syria's Golan Heights. A Santa Barbaran who commanded the Navy intelligence ship Liberty when it was attacked by Israeli jets and torpedo boats during the 1967 Six-Day War, says now that many of his crew felt that the attack was deliberate.

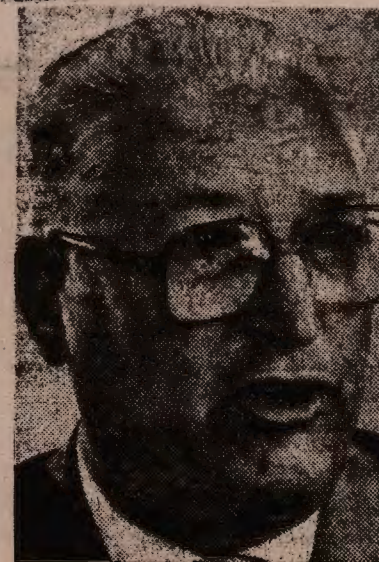
A new book says Israel warned the U.S. of the impending attack — in which 34 crewmen were killed and 170 wounded — the day before it occurred.

William L. McGonagle, who has lived here since 1974, says Israel called it a case of mistaken identity, but some of his crew called it deliberate.

A 25-year Navy veteran at the time of the attack, McGonagle received the Medal of Honor, the nation's highest military award, for gallantry during the action and the 17 hours immediately following it.

A United Press International story in Sunday's News-Press reported that a new book, Stephen Green's "Taking Sides," charges that the U.S. ignored Israel's one-day warning that it was going to attack the Liberty off the Sinai Peninsula because the ship was eavesdropping on Israeli radio transmissions — which revealed the Israelis were breaking a cease-fire in their war with the Arabs.

Marxist Revolutionaries Given Probation-Aryan Warriors Given Harsh Sentences

Communist Revolutionaries Freed - Book Thrown at Patriots

There is a two tier system of justice in America. In two recent cases the so-called RICO Act has been used to prosecute Patriots. This allows the government to give "double" punishment sentences. In both the Seattle, (trial of members of "The Order") and Hot Springs, Ark. (Rev. Ellison, Covenant of the Sword Church), case the White Christian Patriots were charged under the RICO Act. This means engaging in organized crime to raise money to be funneled either to illegal or even legal businesses. Upon conviction a defendant can receive a "double penalty" and the "business" may be confiscated. RICO was originally designed to be used against Mafia crime families! There have been no cases where any Communist revolutionaries are let off with extremely light sentences.

Black Revolutionaries Sentenced To "Community Service"

Coltrane Chimurenga and six other members of the Black Liberation Movement were found guilty in a New York State court on Oct. 16th of numerous acts of violence. They included plotting to aid two communists escape from prison who were convicted in the 1981 Brink's Armored truck robbery in which three police officers were killed. The charges against them included conspiring to carry out robberies and jailbreaks. They were convicted for illegally possessing arms including sawed-off shotguns, semi-automatic rifles and explosives.

The defendants could have received up to 10 years in prison. Courtroom observers were shocked when Federal Judge Robert L. Carter (a Negro) sentenced the seven defendants to do 10 hours a week in community service work for 3 months. He also ordered that during this period they "avoid weapons of any kind." The courtroom was filled with cheering blacks who are supporters of the Black Liberation Front. All were wearing red sweaters.

There has never been a case where White Patriots, even those charged with much lesser offenses, were given such a light sentence. There can be no doubt that we have a double standard of justice in America. Excessive punishment for White Christians and wrist slapping for radical leftists!

Light Sentence For Marxists

7 Radicals Must Do Community Service In 'Interim Sentence'

By ARNOLD H. LUBASCH

A judge yesterday imposed an unusual "interim sentence" on seven black revolutionaries, ordering them to do community service for three months.

The judge, Robert L. Carter of Federal District Court in Manhattan, said he had a "problem" choosing between the Government's view that the defendants were a "menace" and their own view that they were struggling to "liberate the black masses."

"You can't take the law into your hands," Judge Carter admonished the defendants, telling them that their struggle must be lawful and "can't be with guns."

The judge said a probation officer would pick separate community programs for the defendants, who must each work 10 hours a week in the programs and avoid "weapons of any kind."

The charges grew out of an investigation of the 1981 Brink's case in Rockland County. The defendants were not accused of taking any part in the robbery and shootout, in which three people were killed. They were charged with conspiring to free two men who were imprisoned in the Brink's case.

The prosecutors, Kenneth Roth and Lorna G. Schofield, advocated "stiff prison terms" at yesterday's session. They noted in a letter to the judge that the defendants had obtained sawed-off shotguns, semiautomatic rifles and explosives.

"As the trial evidence abundantly

demonstrated," the prosecutors said, "the defendants amassed their criminal tools in a calculated pursuit of violence."

At the sentencing session, which took place in a courtroom crowded with defense supporters, the defendants and their lawyers made statements to the judge.

Mr. Chimurenga has a master's degree from Harvard University and is a candidate for a doctorate. Mr. Hinds said, as he called for a sentence of probation or community service.

Acting as Own Lawyer

One of the defendants, Omowale Clay, said the Government had tried to gather intelligence about their political activities and intimidate them. He added, "We beat the Government's case."

"We are not terrorists, Judge Carter," Mr. Clay said, acting as his own lawyer, as he did in the trial.

"We are freedom fighters," he asserted, adding that the education attained by the defendants was meaningless without "the liberation of our people."

In their trial, they portrayed themselves as Marxists and political activists in the black liberation movement, and they accused the Government of oppressing blacks.

All the defendants, who wore identical red scarves around their necks at the sentencing session, could be sentenced to a maximum of 5 or 10 years in prison on each charge against them.

Judge Carter said he would decide on the "final sentence" on Jan. 16, after the defendants had completed three months of community service under the supervision of a probation officer. The judge said he wanted to determine if they would "adhere to the rules of society" and "give service to the community."



Convicted Revolutionary To Be New York Lawyer

Weather Underground leader, Bernardine Dohrn (a Jewess), has been called one of the most "violent terrorist leaders in America" by police. She was a kingpin in the Students For a Democratic Society which rioted in Chicago during the Oct. 1969 "Days of Rage" anti-Vietnam War protests. That year she went underground as a leader in the violent Weather Underground and made the FBI's "Ten Most Wanted" list.

Miss Dohrn "surfaced" in 1980 and was tried only for aggravated battery and bail jumping. She was fined \$1,500 and granted probation. In 1982 Dohrn refused to testify before a grand jury on what she knew about the 1981 Brink's truck robbery in which 3 police officers were killed. She was sentenced to 7 months in jail. After Dohrn's release she was given a job with the prestigious Chicago law firm of Sidley and Austin. Later she applied to take the New York Bar Exam. Jewish attorney Donald H. Reuben testified that Miss Dohrn was a "sterling character." Still, in 1982 she defended the bombing of U.S. Government buildings while she was in the underground, stating "We should have escalated the level of such tactics." Thus the New York Bar Assn. turned down her application to take the exam at this time - BUT SAID SHE COULD REAPPLY TO TAKE THE EXAM AT A LATER DATE!

Over 500 Patriots March Against King Holiday

March and Rally In Raleigh

Raleigh, N.C. was the site of the first national day of protest, against the federal holiday honoring the communist Negro, Martin Luther King.
