### Innocent Ukrainian Faces Hanging In Israel

A brave and courageous John Demjanjuk faced his accusers after being illegally kidnapped to Israel with the aid of Secy. of State George Shultz who approved the extradition. ### Trial to Keep Holocaust On Front Page

## Want Buchanan Fired

### The Plot to "Get" Pat Buchanan

Pres. Reagan's "Communications Director" is the well known Right-Wing columnist and TV talk show host Pat Buchanan. He has risen through the White House ranks to become one of Pres. Reagan's closest advisors. Left-Wing liberals and Jews are doing all they can to undermine Buchanan. Ex-Congresswoman Elizabeth Holtzman, (Brooklyn District Attorney), demands that he be fired. The following are but a few of the accomplishments of Pat Buchanan. They explain why the enemy wants him removed from all spheres of influence.

### Buchanan Backs South Africa

The strongest voice in the Reagan Administration favoring U.S. support of South Africa has been Pat Buchanan. On Dec. 21, 1984 Buchanan wrote that if we let South Africa fall to the communists it would be a betrayal similar to that dealt anti-communist Pres. Thieu in South Vietnam, the Shah of Iran and Somoza of Nicaragua.

Buchanan asked why black and liberals demonstrating in front of the South African Embassy had not protested the hundreds of thousands massacred in Ethiopia and Mozambique. He said liberals picket with Negro Randall Robinson of Trans Africa who supports the Soviet operated African National Congress guerrilla war against "racist" South Africa. At the same time Robinson sings the praise of Castro and the growing communist insurgency against U.S. interests in Central America.

### Buchanan: "Keep America Christian"

Pat Buchanan, on Feb. 26, 1984 wrote, "for 18 decades the creed that served as foundation for American law was Christianity." He wrote that the de-Christianization of America began under the Warren Supreme Court. Bible instruction, prayer, Christmas and Easter celebrations were expunged from the schools. THEY WERE REPLACED WITH A NEW AND ALIEN CREED!

The Jew Sidney Hook in his book "Humanist Manifesto" of 1977 wrote that Christianity held "intolerant attitude toward the new relaxed sexual conduct." Buchanan said Bible based moral values have been dismissed thus opening the door to the acceptance of pornography, drugs, prostitution, homosexuality, the undermining of the family, work ethic habits and the very lives of individuals. Buchanan wrote that "Humanism" is allied with such sects as feminism, equality cults, pacifism and socialism. He added, "Christians have a right to counter-attack and recapture their occupied schools to re-establish the legitimate moral foundation of American Society."

### Jews Blame Buchanan For Reagan's Bitburg Visit

It was Pat Buchanan who strongly urged Pres. Reagan to go ahead with his state visit to Bitburg, Germany after organized Jewry has screamed "Nazi soldiers are buried there."

## Buchanan Fought OSI Persecution of East Europeans

Ex-Congresswoman Elizabeth Holtzman, browbeat Congress into establishing the so-called Office of Special Investigations (OSI). Its purpose is to strip anti-communist East European refugees of their citizenship and deport them to Russia or Israel FOR DEATH! 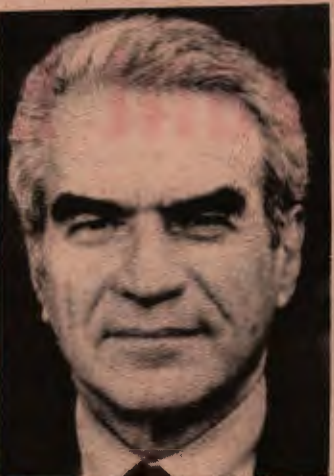
## Buchanan's Enemies Forced Out

## Buchanan was asked to help deported Nazi scientist to the U.S.

NEW YORK (JTA) — The World Jewish Congress has expressed its "deep concern" over a reported meeting White House communications director Patrick Buchanan had with a German colleague of former NASA scientist Arthur Rudolph, who was last year forced to leave the United States to avoid prosecution for brutalizing slave labor at a Nazi rocket factory in World War II.

Furthermore, the WJC said it found the meeting "especially troubling" in view of Buchanan's published remarks, as a syndicated columnist prior to joining the Reagan administration, in which he advocated the abolition of the Justice Department's Office of Special Investigations, the unit that tracks down war criminals in the United States.

Buchanan reportedly met on June 25 with Eberhard Rees of Huntsville, Alabama, a German rocket team member who succeeded Wernher Von Braun as

director of NASA's Marshall Space Flight Center. Kalman Sultanik, WJC vice president, charged that a "multiplicity of efforts" were underway to rehabilitate Rudolph and to whitewash the atrocities committed by the Nazis.

In addition to the Rees meeting with Buchanan, Sultanik pointed out that retired Maj. Gen. John Medaris, who at one time supervised Rudolph and other German scientists brought here after World War II to help in the Army's missile effort, had written President Reagan and Sen. Strom Thurmond (R-SC), chairman of the Senate Judiciary Committee, in support of Rudolph. Also, the WJC said Rudolph's colleagues in the missile program addressed a letter to Reagan asking for his return "in honor."

Rudolph, who is reported living in Hamburg, was director for production of V-2 rockets. He had become an American citizen in 1954 after having come to the U.S. in 1945.

## Buchanan's Jottings Cited 'Pressure' of Jews, NBC Say

At a recent White House meeting in which aides discussed President Reagan's visit to the German war cemetery at Bitburg, White House communications director Patrick J. Buchanan could be seen repeatedly writing the phrase "succumbing to the pressure of the Jews," NBC News reported last night.

NBC said it reached Buchanan to ask about this incident and, according to anchorman Tom Brokaw, Buchanan said it was "utterly absurd to believe that something he wrote on a piece of paper represents his views."

An attempt to reach Buchanan for further comment after the NBC

broadcast last night was unsuccessful.

The NBC account of Buchanan's meeting note was reported by the network's State Department correspondent, Marvin Kalb.

Kalb gave no source for the story that Buchanan had repeatedly written "succumbing to the pressure of the Jews." Kalb recounted the story in a report on political problems that the Bitburg visit has caused for Reagan and West German Chancellor Helmut Kohl.

Despite pleas from many Jewish and veterans organizations and most members of Congress, Reagan has repeatedly reaffirmed his plan to visit the cemetery, which includes the graves of 49 soldiers who served in the Nazi SS.

The letter "B" was the common and approved style in 1942. This view was confirmed in court by Prof. Z. Michael Szaz, a fluent German speaker and quoted in The Chicago Tribune of Sept. 14th.

Did this help save John Demjanjuk - NO! The only other evidence was hysterical crying Jews from Israel who swore up and down that Demjanjuk was the man who gassed hundreds of thousands of their friends. - (But by Luck they escaped?)

### The Truth Must Win Out

JERUSALEM, Feb. 28 — John Demjanjuk, a 65-year-old retired automobile worker from Cleveland and accused Nazi war criminal, was delivered by United States marshals to Israeli justice today at Tel Aviv airport.

He will be tried on charges that he operated the engines that killed by exhaust gas untold thousands of Jews in the German extermination camp of Treblinka in Poland in 1942-43. Israeli law provides for a maximum penalty of death.

For the first time since Adolf Eichmann was tried and hanged in 1962 as a principal organizer of genocide — and for the second time in Israel's history — a man charged with crimes against Jews in World War II is to face Israeli judges. The case is being treated by the Government and press as an event of exceptional magnitude, once again confronting Israelis directly with a subject that haunts the nation.

placed under arrest and taken in an armored van to the maximum-security prison in Ramla where Eichmann was confined and executed.

Isolated from the 600 other inmates in a specially prepared cell, Mr. Demjanjuk will be watched by three guards during the day and two at night and constantly observed on closed-circuit television. Mr. Demjanjuk will face a three-judge, nonjury tribunal.

There are divided minds also about what to do with Mr. Demjanjuk if, as expected, he is convicted and sentenced to death. Israel reserves capital punishment for perpetrators of the genocide of Europe's Jews

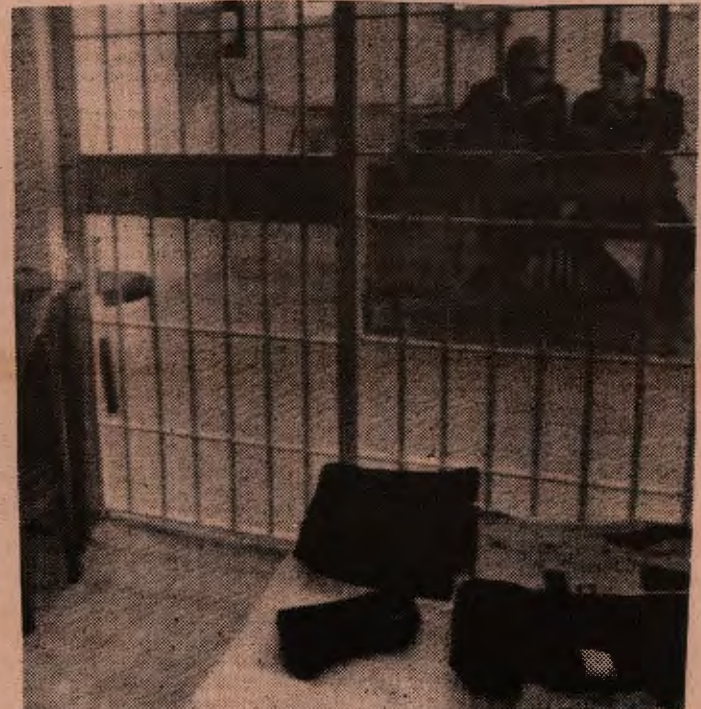
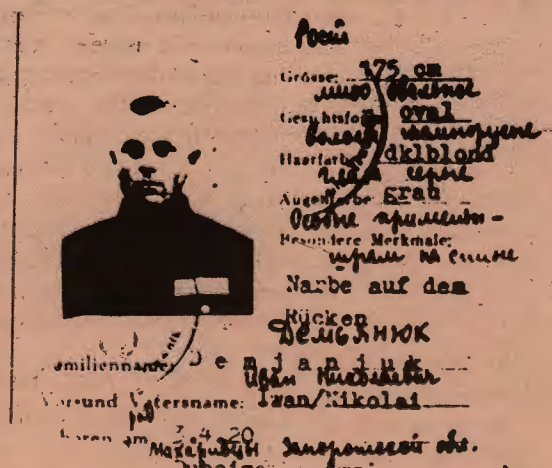

## Polish Frank Walus Innocent

Responding to efforts by Eastern European emigré groups to discredit the Justice Department's Office of Special Investigations (OSI) and terminate its activities, six Congressmen have asked their colleagues to sign a letter to President Reagan urging him to publicly support the office that prosecutes Nazi war criminals. By early last week 45 Representatives had signed on.

The Congressmen note that "the values of our great Nation dictate that we preserve our moral commitment never to forget the horrors of the Holocaust. The vital work of the Office of Special Investigations demonstrates that the United States government will not tolerate Nazi war criminals living in this country."

The sponsors of the letter are JOHN PORTER (R-Ill.), GARY ACKERMAN (D-N.Y.), BARNEY FRANK (D-Mass.), HAMILTON FISH, JR. (R-N.Y.), JIM MOODY (D-Wis.), and SILVIO CONTE (R-Mass.).

For the past five years, some members of the Ukrainian, Latvian, Lithuanian and Es-

tonian communities have been attacking OSI. It was created in 1979 to initiate denaturalization and deportation proceedings against those who participated in war crimes during the Second World War. The opposition groups have recently focused on the agency's use of evidence obtained in the Soviet Union which, they claim, is fabricated or otherwise unreliable, and, they charge, plays too large a role in Federal prosecutions.

A report by the Anti-Defamation League of B'nai B'rith noted, however, that "no American judge has concluded that any documentary evidence obtained from the Soviet Union was fabricated. Nor has any witness made available by the Soviet Union been found to have lied in connection with his testimony." The report also stated that OSI opponents "have raised funds to defend war criminal suspects" and reportedly convinced some Ukrainian and Baltic community members not to cooperate with Justice Department investigators.

## Extend Canadian Nazi-hunt by six months to investigate in E.Europe

TORONTO (JTA) — The Cabinet has extended by six months the official inquiry into Nazi war criminals living in Canada, conducted by former Quebec Superior Court Judge Jules Deschenes who was named a one-man commission by the government a year ago.

The commission has so far identified 600 alleged Nazis in Canada, including 15 against whom serious charges have been made. No names have been made public. Deschenes was to have submitted his final report and recommendations last month. The extension of his mandate un-

til the end of June, 1986, will give him the opportunity to send two aides to the Soviet Union and four other Eastern European countries to gather further evidence.

Ukrainian and Baltic emigre groups in Canada have protested vehemently, maintaining that any evidence obtained from Communist sources would be "tainted." Many war criminals exposed to date in the U.S. and Canada are not Germans but Ukrainians or Latvians who worked for the Nazis during World War II.

The Jewish Anti-Defamation League has issued a report that Jews must do all within their power to overwhelm those who expose the holocaust

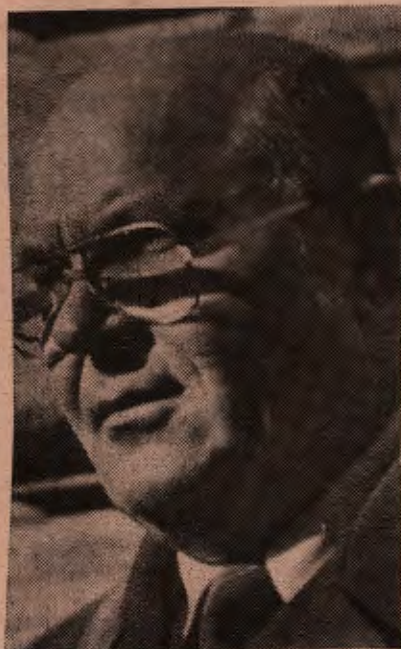

## Nazi Faces Execution

### By HANS LEBRECHT

TEL AVIV — The Nazi John Ivan Demjanjuk, known as "Ivan Grozni" or "Ivan the Terrible" — an executioner in World War II in the Treblinka concentration camp — arrived in Israel Friday after extradition from the U.S.

Demjanjuk, now 66 years old, is accused of commanding and activating the death camp's gas chambers in 1942-43. During this period approximately 800,000 to 900,000 people were killed. Most of them were Jews from Poland, the Soviet Union, Greece, Austria and other countries under Nazi occupation.

Survivors of Treblinka now in the U.S. point out that Demjanjuk not only pushed his victims into the gas chambers and activated the poisonous motor exhaust gas, but he also beat people to death and killed others by pushing them into the high-tension electric fences.

He was known to tear babies and toddlers from their mothers' arms and trample them to death before their eyes. He sadistically raped young girls before murdering them.

Like many other Nazi criminals, Ivan the Terrible found a haven in the U.S. after World War II. As rabid anti-Communist and anti-Soviet forces, they were welcomed during the Cold War hysteria orchestrated by Secretary of State John Foster Dulles and Sen. Joe McCarthy.

In violation of international law, the U.S. refused to extradite the Nazi criminal to Poland, where he committed his crimes, or to the Soviet Union, which also demanded extradition. He was instead extradited to Israel, a state that had not yet been established at the time of the crimes and where at the most half a dozen Treblinka survivors are living.

### Others Hounded By The Jews

Czechoslovakian Karl Blach, now living in Los Angeles, has been accused of being a "war criminal" by Neal Sher's OSI. They claim he was a "dog-handler at Dachau." An interesting point here is that even Jew holocaust advocates do not claim Dachau as an "extermination camp."

Ukrainian Serge Kowalchuk, a Philadelphia tailor, was charged by Neal Sher on Feb. 24 with being a war criminal. He was a member of The Ukrainian militia. He is said to have fought against communist guerrillas in the Ukraine.

Dec. 22, 1983 the Georgia Parole Board rejects the demands of the three powerful Jewish organizations that they grant Leo Frank a pardon. Board chairman Mobley Howell issues this statement:

*"After an exhausted review and many hours of deliberation, it is impossible to decide conclusively the guilt or innocence of Leo Frank."*

March 11, 1986 the Parole Board rules: *"In recognition of the state's failure to protect the person of Leo Frank thereby preserve his opportunity for continued legal appeal of his conviction...the board hereby grants to Leo Frank a pardon."*

In Georgia a pardon cannot be legally granted unless NEW EVIDENCE has come to light which proves conclusively that a man is innocent. In this ridiculous ruling the board clearly is in contradiction with itself because inspite of their own "strict guidelines" for a pardon they grant it adding - "without attempting to satisfy the question of guilt or innocence." ## Board Held Secret Meetings With Jews

One of the most shocking admissions of this parole board scandal is that at the request of wealthy Jew businessman, Louis Kunian, the board agreed to hold secret meetings with representatives of the three Jew organizations: (B'nai B'rith-the secret Jew businessmen's fraternity, the Jew Anti-Defamation League-a highly financed group which defames opponents and the Atlanta Jewish Federation.)

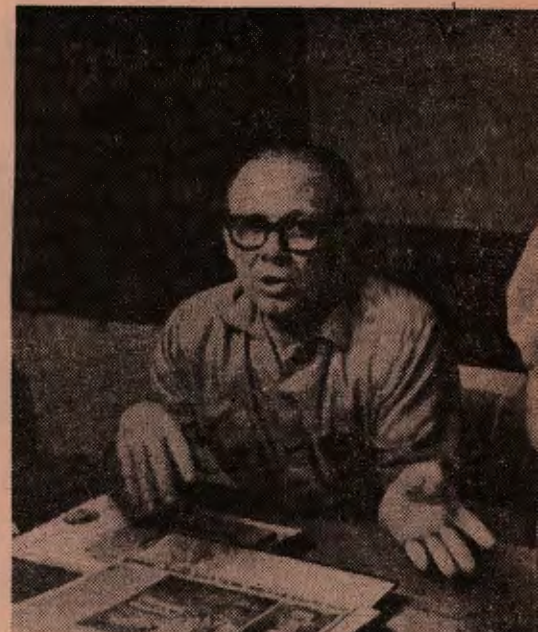

### Facts On Leo Frank Case:

Leo Frank's trial lasted 5 weeks which up to that time was the longest trial in Georgia history.

Leo Frank is the first individual in Georgia history to be granted a pardon after his death. Would this be granted to a Protestant, Catholic, White Christian, Negro - or anyone else who did not have the limitless money power of the Jews working secretly behind the scenes???

Jews in New York, London and Paris all contributed money to buy Frank the best lawyers in America. They worked on his case through the trials and appeals. This was the most costly defense trial up to that time in U.S. history.

### Evidence Proves Leo Frank Murdered Mary Phagan

The Georgia Parole Board granted Leo Frank a pardon in the most heinous sex murder in the state's history. The reason why organized Jewry worked so unrelentingly for a pardon is that Leo Frank was president of the Atlanta Chapter of "B'nai B'rith" - meaning "Sons of The Covenant" - the secret Jewish businessmen's fraternity. Frank was of Russian Jewish descent who came from Brooklyn to run a Jew owned pencil factory. The parole board stated they were not ruling on Frank's "guilt or innocence." Still the Jews quickly saw to it that the story was carried in every newspaper leaving that part out. They now indignantly declare, this "poor innocent persecuted Jew" was lynched by "bigoted Southern rednecks." Here are the true facts from the trial record itself which prove Frank was indeed guilty as charged!

1) Confederate Memorial Day, April 26, 1913, little Mary Phagan age 13, went from her home in Marietta, GA., to the National Pencil Factory in downtown Atlanta. She wanted to collect her sweat shop wages of \$1.20 before viewing the Confederate Veterans parade.

2) At 12 noon, she entered the factory never to be seen alive again.

3) 12:05, another employee came for her pay. Miss Monteen Stover called out for Frank. No one answered and she left. During the trial the Negro janitor Jim Conley testified that Frank sought to force Mary Phagan to allow him to sodomize her. She resisted and Frank strangled her.

4) Exactly 1:10 Frank locked the factory and went home.

5) 3:20 PM Frank returns to the factory and waited for the night watchman, Newt Lee, to arrive. 4:00 PM Lee arrives for work. He testified that Frank appeared nervous and sent him away telling him to return at 6 PM.

6) Conley testified that Frank gave him \$200 to carry the child's body to the basement and cremate her in a furnace after dark. Conley, being an alcoholic left, got drunk and failed to return. That is why Frank wanted Newt Lee to start work at a later hour.

### Phony "Black-Jewish Coalition" Formed

The Leo Frank Case placed Jews in an awkward position. By holding that Frank was innocent they were saying that negro Jim Conley was guilty! This drew objections from Atlanta City Councilman Hosea Williams and other black leaders. Thus the cunning Jews formed the so-called "Black-Jewish Coalition" which only has about one Negro member-John R. Lewis.

It is interesting to note that local Jew businessmen are supporting Lewis for Congress against Julian Bond. The Jews always know which man they have control of. Lewis did his work for the Jews by signing a statement written by Jews

declaring, "Georgia will not be pardoned by people of goodwill until Leo Frank is pardoned. This case is a source of continuing shame to Georgia."

But Tom Watson Brown, an Atlanta attorney who has long studied the case, came away from his investigation convinced that Frank was "guilty as charged."

"Frank was convicted after a five-week trial - the longest trial at that point in the state's history," he said. "He had the best lawyers in the city of Atlanta. His conviction was appealed three times to the Georgia Supreme Court and twice to the U.S. Supreme Court and the conviction was always upheld."

Brown said he has read all the trial testimony and at no time was an issue made of Frank's religion.

"The only person who ever brought it up was Frank's mother when she called a prosecutor a 'Gentile dog,'" he said.

Brown is the great-grandson of famed populist Tom Watson, who served in the U.S. Senate and House and was William Jennings Bryant's running mate in the 1896 presidential election.

At the time of the trial Watson was publisher of The Jeffersonian in Thomson, Ga. The newspaper, Brown said, launched a vigorous campaign to show Frank's guilt after his conviction in response to a

Earlier Frank had dictated several notes to Conley to leave on the young girl's body throwing the blame on Newt Lee. Every investigator we have talked to states that no black who has ever murdered ANYONE and hung around to write notes attempting to make someone else appear guilty!

7) 7 PM and 7:30 PM Frank phones the factory to ask Newt Lee if everything is O.K. He had never done that before!!!

8) Frank's in-laws hold a card game party that night but Frank is too upset to play and retires to bed early.

9) 3:00 AM, Newt Lee goes to the basement to use the restroom. In the dim grey of his lantern he sees a horribly twisted body in the corner. He screamed and phoned the police.

10) The police find the body of little Mary Phagan. She is only 4'10" and weighed just 105 pounds. Her under-clothing had been ripped and her body smeared with blood and urine. A doctor testifies she "suffered violence to her sex organs."

The coroner testifies she was hit in the head with a blunt instrument. A piece of her undergarment was twisted around her neck so tightly that her eyes bulged and her tongue protruded one and-a-half inches out of her mouth. It was sadistic torture followed by strangulations. A sex fiend had committed the most grisly murder in Georgia history.

11) The autopsy examination by Dr. Harris set the time of death between 12:15 and 12:30 PM when Miss Stover could not find anyone in the building. But Frank admits he was in the building during this period!

At the trial Frank's lawyers try to claim the notes prove Newt Lee was the killer. When this fails during the 5 week trial they try to cast the blame on Jim Conley. Two prostitutes testify they were paid by Frank to meet him during off-hours. He would sodomize them and Conley would act as a "lookout" knocking on the ceiling if anyone entered the building.

### Justice Finally Prevails

A group of Christian Patriots decide to avenge Mary Phagan after Gov. John Slaton commutes his sentence from death to life in prison. On Mary Phagan's grave stone inscribed the words, "May God bring the man guilty of the terrible crime to Justice." The Patriots cut the lines to the Milledgeville, Ga. prison, seize Frank and drive to Marietta to face the judgment of hanging as demanded by the trial jury. The site today is located about 100 yards South of where Roswell Rd., goes under I-75, next to the K-Mart.

During his final moments with the hangman Frank was asked to make a confession. He replied he did not want to bring shame upon "his people." Frank did say, "the Negro told the story," which was the next thing to a confession as Jim Conley told the truth about Leo Frank's perversions and the murder. Frank's last words before he was hanged were, "God forgive me."

F. Phagan Durham, 71, a lifelong Cobb resident who was Mary Phagan's cousin, is also certain Frank had a hand in the girl's death.

"There is no doubt in my mind about it based on some of the things I have been told about Leo Frank," he said. "I'm convinced he was the murderer."

Born the year Frank was lynched, Durham never knew his cousin, but remembers his mother talking about the incident.

"My mother was very emotional about it," he said. "At the mention of Mary's name she would get very upset."

"The body was cut down, and unanimous expression to let the body be sent back to Frank's wife and parents as it was resulted," the reporter wrote. "This is certainly a credit to the people of Cobb County. It shows that they are not blood thirsty and that they are satisfied with the decree of the law having been carried out."

## Pollard refusing to plead guilty

Fears are growing that Jonathan Pollard, arrested in Washington by the FBI on November 21 on suspicion of being an Israeli spy, will refuse to submit a guilty plea, and will thus force a trial that neither Washington nor Israel wants.

The Jerusalem Post has learned that efforts to extract a guilty plea have failed, and a trial is almost certain.

In a series of unprecedented contacts between December 11 and 17, Israel cooperated with an American delegation representing the FBI, the Justice Department and the prosecution, headed by the Legal Adviser to the State Department, Judge Abraham Sofaer, to provide the prosecution with enough material to extract a guilty plea from Pollard. But Pollard was apparently undaunted and, on the advice of his lawyer, intends to fight in court.

Both Israel and the U.S. are extremely concerned about Pollard's

decision, since a court battle will both reopen newly-healed wounds.

Wolf Blitzer adds from Washington:

The U.S. Attorney for the District of Columbia has not yet entered into any plea bargaining procedures with attorneys representing Pollard and his wife, Anne Henderson-Pollard.

Both are still in the District of Columbia jail awaiting the outcome of a secret U.S. Grand Jury which is taking evidence related to the case.

James F. Hibey, attorney for Mrs. Henderson-Pollard, last week told *The Post* that the Grand Jury is to issue indictments "within the next week or two." But he noted that the U.S. Attorney may seek yet another extension in advance of any formal indictments.

Pollard, a civilian analyst for the U.S. Navy, has been accused of providing Israel with numerous secret documents in exchange for payment of some \$1,500 dollars a month for a year and a half.

In Washington, the U.S. has announced that it is resuming normal intelligence cooperation with Israel in the aftermath of a visit to Israel by a team of U.S. officials investigating the Pollard spy scandal.

It also said that Israel has returned to the U.S. all of the classified documents which Pollard had allegedly stolen.

**Spy Chief's Punishment Turns Out To Be A Reward**

A New York Times dispatch from Jerusalem of Nov. 25 stated that when the Jew leaders in Israel "found out" who authorized Pollard's spying "heads will roll." Well the problem was that the top leaders in the Israeli government knew all about it including Arens and Shamir. (Note: They are not about to place their own heads on the chopping block). Shortly after it was revealed that Jew Raphael Eitan headed the spy mission - he was dismissed. Then on Jan 8 Eitan was rehired as chairman of the board of Israel Chemicals - at a far higher increase in pay. HE WAS REWARDED BY HIS FELLOW JEWS!

## Heads Will Roll

JERUSALEM, Nov. 25 — Israeli officials said today that an unidentified "senior Government figure" was conducting an intensive secret investigation of charges of an Israeli espionage

operation in Washington and that it was likely that some "heads will roll" soon. Because of the sensitivity of the affair, officials said they could not predict when a conclusive explanation of Israel's conduct would be released.

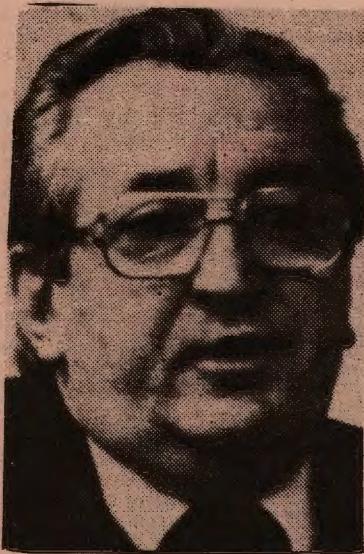

**Restaurant Goes Bankrupt**

Mr. Denis Rety, a Frenchman, was kicked out of the Miami Beach Chamber of Commerce by the majority Jew membership. His business fell as dozens of organizations cancelled their periodic luncheons at La Belle Epoque. Rety sued Green and his company for \$20 million. To the surprise of all the jury came back with a record breaking \$22.5 million judgment against Green who fainted in the courtroom.

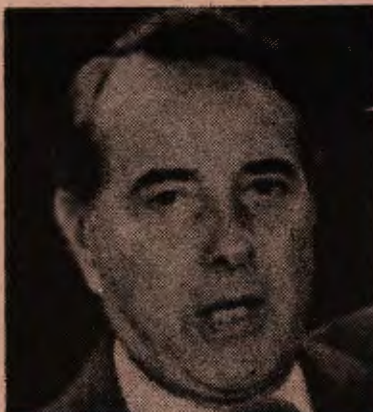
**Incitement to Racism** - Amendment No. 24 defines "racism" as any act causing persecution, hatred or humiliation directed against a racial or religious group.

**Prohibition of Publishing Racism** - No. 144-B. Anyone who publishes any incitement to, whether it contains truth or not, can be sentenced up to five years in prison.

**Possession of a Racist Publication** - No. 144-D. Anyone who possesses a publication with intent to distribute it to incite racism can be sentenced to one year in prison and confiscation of the publication.

**Racist Spoken Words** - No. 144-E. Any spoken words of racism which may be heard by persons, or the display of writings, drawings, pictures intended to be seen by persons - one year in prison and confiscation of the literature.

"A new wave of anti-Semitism is sweeping Europe" warns the Simon Wiesenthal Center. A report published by the center, which is named after the famed hunter of Nazi war criminals, Simon Wiesenthal, notes the gravity of the situation:

"There's something particularly frightening about this rise of organized hatred abroad. It is being fueled by Americans who are supplying both leadership and materials to rebuild Nazism in Europe" (emphasis in the original).

The Wiesenthal Center reports that this latest rise in anti-Semitism it is not a question of "isolated incidents, (but) it is spearheaded by networks of neo-nazis which reach out all over the country. Indeed, all over the world."

Spread by the racist and fascist underground in Western Europe is the publication Thunderbolt, issued by the National States Rights Party of Georgia. Its leader, Edward Fields, is known to be tied to the neo-nazis in England, West Germany and Belgium, and to the fascists in Reagan's strongest ally, apartheid South Africa.

Says the Wiesenthal Center report: "That same intense, U.S.-originated hatred that feeds these Nazi groups in Europe also sparks neo-nazis in the United States. Hatred and anti-Semitism are shockingly on the rise here, being boldly scrawled across our entire nation, threatening all that we hold dear."

The dissemination of racist and anti-Semitic propaganda is outlawed under provisions of the United Nations Convention on Genocide and the UN resolutions outlawing racism, adopted by the UN 35 years ago.

## Dispute Reveals Soviet Spokesman Is A Jew

Pres. Reagan finished a speech on U.S. defense strategy. Rep. Jim Wright went on the radio and gave the response for the Democrats. Then a third voice was heard—that of Communist Russia! David Brinkley suddenly followed Reagan's talk with an unannounced interview with Radio Moscow spokesman Vladimir Posner. Dr. Daniel Thursz, executive vice president of B'nai B'rith International, said Dornan's description of Posner is "a classic anti-Semitic slander which should never befall the chambers of Congress."

Dornan, Thursz said, could resent Posner for his role as defender of Soviet policy "and the American Jewish community would probably agree with him. But to call attention to Posner's Jewishness in a defamatory manner is totally reprehensible."

Rep. Barney Frank (D—Mass.), who had tangled with Dornan a year ago following a TV appearance by the Californian, said that Dornan's remark was an outrage: "I don't accept his notion it was an accident. He meant not to say it but I think he thought it."

Following Frank's criticism last year, Frank said, Dornan told him the trouble with "you New York guys is that you only care about Israel." Frank said he had replied, "Since I represent Massachusetts, not every Jew in America lives in New York."

Dornan, a New Yorker by origin, also was criticized by Rep. Sidney Yates (D—Ill.), dean of the 30 Jewish members of the House.

## The Life of Posner

(Reproduced from press reports.)

MOSCOW, Dec. 29 — Since Vladimir Posner first appeared on American television in 1978 speaking flawless English with a Brooklyn accent, he has become one of the most visible spokesmen the Soviet Union ever put in front of a microphone.

In dozens of appearances on ABC's "Nightline" and other American programs, Mr. Posner has, by satellite from Moscow, defended the Soviet position on everything from the shooting down of Korean Air Lines flight 007 in 1983 to Moscow's current objections to President Reagan's development of a space-based missile defense.

Because of his idiomatic American English, stylish appearance and friendly demeanor, Mr. Posner has played a key role in making Soviet propaganda more polished and persuasive, Western diplomats said.

"He sounds exactly like an American," one diplomat said.

He added, "Posner fits perfectly into Gorbachev's effort to project a more appealing, modern image for the Soviet Union." Mikhail S. Gorbachev is the Soviet leader.

Mr. Posner spent his adolescence in the United States, living in Manhattan for nine years when his father worked as an executive for M-G-M.

How a family of Russian Jews who converted to the Russian Orthodox Church but were fervently pro-Communist ended up living like wealthy capitalists in a duplex apartment at 24 East 10th Street is a story Mr. Posner likes to relate.

Relaxing in his comfortably furnished Moscow apartment on Chisty Prospekt last week, he described the odyssey between puffs on a Cuban cigar, one of the benefits, he noted, of living in the Soviet Union.

The bookcase in his study was filled with English works, including "The Final Days" by Bob Woodward and Carl Bernstein, "World of Our Fathers" by Irving Howe and "War and Remembrance" by Herman Wouk. A small American flag hung from a desk lamp with a button stuck in it that denounced censorship.

"Practically All-American" at 15

Mr. Posner said his father, Vladimir Alexandrovich, was born in St. Petersburg, now Leningrad, in a Jewish family that had adopted the Russian Orthodox faith.

"My father, as a boy, was caught up in the revolutionary fervor in 1917," Mr. Posner said, "and always had great memories of those times."

The family, however, moved to Berlin and Paris in the 1920's. In 1929 his father, by then a young man, started work at M-G-M and married a French woman. Mr. Posner, whose full name is Vladimir Vladimirovich, was born in Paris on April 1, 1934.

In 1940, considered more Jewish than Russian, the family slipped out of Nazi-occupied Paris with false passports and sailed for New York via Marseilles and Lisbon, Mr. Posner said.

By the time the family left the United States nine years later, he said, "I was 15 and practically an all-American boy."

Settled in Moscow in '52

During the years in New York, Mr. Posner learned English, picked up his Brooklyn accent — "I don't know how" he said — and attended the City and Country School and Peter Stuyvesant High School.

"I was a rich kid from New York with my own bedroom, a playroom, and my family had a cook, two maids and a summer house on Long Island," he said.

But influenced by his father, who dreamed of returning to Russia to join in the development of Communism despite his sizable income from M-G-M, Mr. Posner said he admired the Soviet Union and never felt completely at home in New York.

"Dad had a big map of the Soviet Union on the wall," Mr. Posner said, and during the war he outlined German advances in black and the Soviet counterstrikes in red, "predicting from the start that the Nazis would never conquer Moscow or Leningrad."

In 1949, after Mr. Posner's father was fired by M-G-M and blacklisted

because of his pro-Soviet views, according to Mr. Posner, the family moved to the Soviet-occupied zone in Berlin and in 1952 settled in Moscow. He became a Soviet citizen that year.

After studying biology at Moscow State University, improving his Russian, his third language after French and English, and working as a translator, Mr. Posner became an editor and writer in 1961. His broadcasting career began in 1970 as a commentator for the North American service of Radio Moscow, a job he still holds.

"Vladimir Posner's Daily Talk," a five-minute radio commentary in English, is beamed daily by short wave to North America.

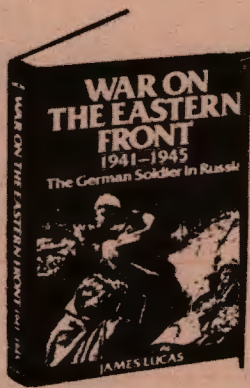

### Race And Reason TV Show

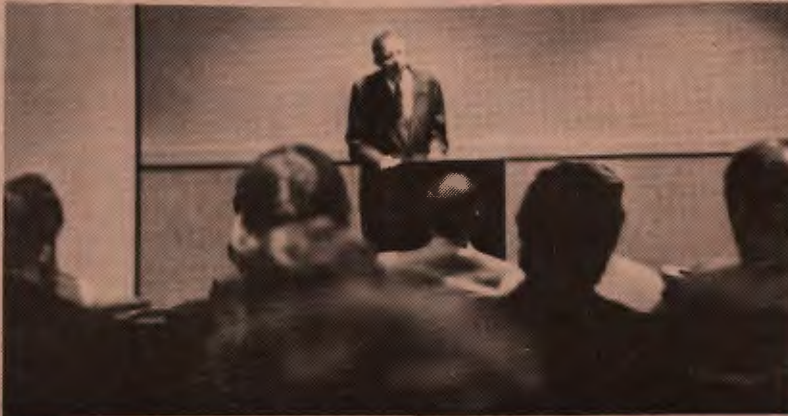

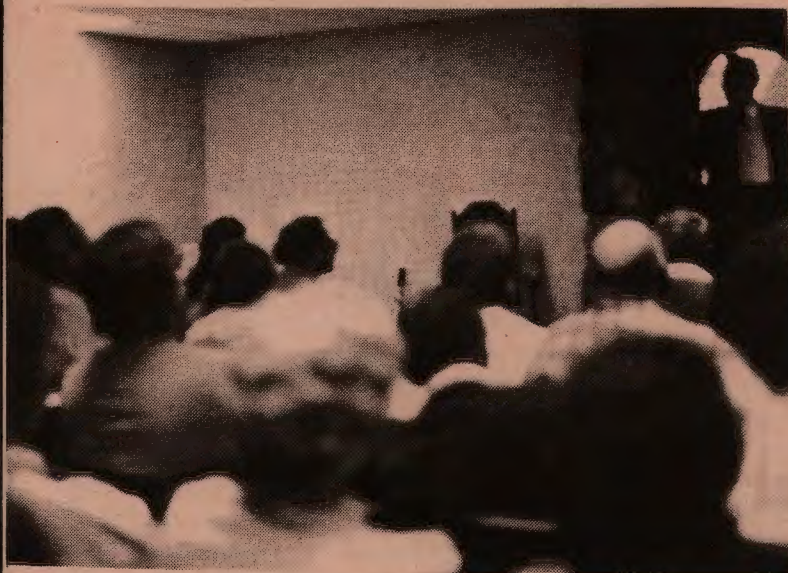
On the set of the "Race And Reason TV Show," host Tom Metzger, right and Dr. Fields seated at left.

## French Victory

### Patriots Win Great Victory In France

The breakthrough finally came for Jean-Marie Le Pen when his French National Front won some 34 seats in Parliament. Other Right-Wing parties won 4 seats thus bring the total to 38. Le Pen formed his party 14 years ago and it took long years of hard work to win just 3% of the vote four years ago. This time the National Front polled 10% of the vote which entitles them to a voice in setting Parliament's agenda, free TV time and the other rights accorded to major parties.

The taste of victory for Le Pen was sweet because he actually outpolled the once powerful French Communist Party whose fortune has declined from a one time high of 25% of the vote to 10% this year. In Marseilles the Front received 25% of the vote making it the second most powerful party in the city with 5 elected officials.

Some 6,000 supporters packed the Heliport auditorium for the victory celebration. The champagne flowed as Le Pen announced, "The National Front has won its primary objective; we've beaten the Communist Party. Now they can't call us an extremist group but a serious party." A band played patriotic songs and people cheered as each new vote tally was flashed across a giant screen. The party's main theme is to deport all Africans back to Africa. Their motto is **FRANCE FOR THE FRENCH!**
