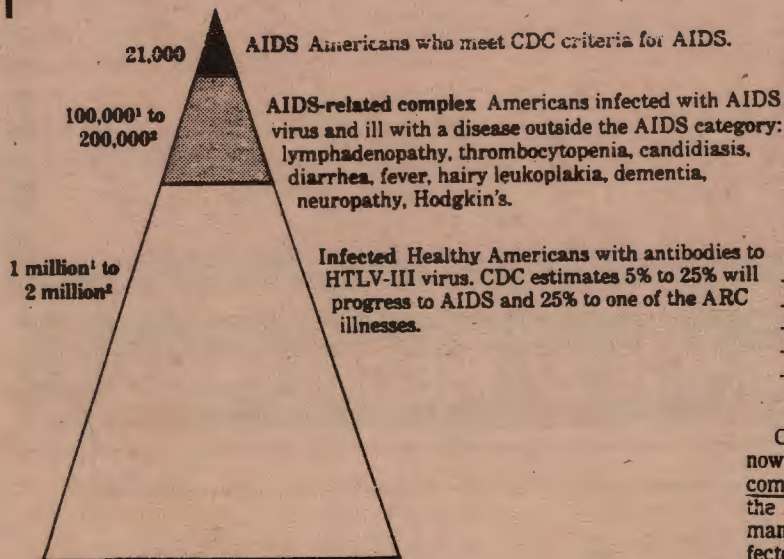

AIDS Located In Black Cities

AIDS cases appear mainly in heavily populated Negro areas of our major cities and in

Blacks make up 40% of Prince George's County, Md., but comprise 70% of the AIDS cases.

Baltimore, blacks are 55% of the city's population but 66% of AIDS victims.

Philadelphia is just under 40% black but they constitute 50% of the AIDS sufferers.

New York City, of the women reported to have AIDS, 85% are black.

AIDS—often called a tip-of-the-iceberg phenomenon—is causing far more real illness than official figures convey. About 21,000 people, mostly homosexual men, have met the technical definition of AIDS, and more than half of those have died. But like an iceberg's unseen bulk, ARC patients like Mr. North outnumber AIDS patients by an estimated five to 10 times. Between 10% and 25% of them are expected to develop full-blown AIDS. An additional one million to two million Americans, also mostly homosexual men, are estimated to be infected with the AIDS virus but as yet have no symptoms. A quarter of these may progress to ARC, according to conservative estimates.

Clinicians from Boston to San Francisco now realize that AIDS is a hydra-headed complex of diseases, embracing not only the narrow syndrome first described, but many more infections and cancers. Infected people are appearing with tuberculosis, regular pneumonia and hemophilus influenzae (a bacteria that can cause everything from pneumonia to meningitis).

"Are there 20,000 cases?" he asks. "Well, if that's true, and there are 200 million Americans, some people might say that's no big deal. But if they understand there are 250,000 people with active disease, and another 750,000 to one million cases brewing, then they'll understand we've got to start planning."

Worst AIDS City

Belle Glade - AIDS Capitol of U.S.

Belle Glade, Fla., is a city of 20,000 people with 61 confirmed cases of AIDS. Only half are homosexuals - ALL ARE BLACK! This is the highest ratio for any single city in America. These victims are all located in a 10-block section of the southwest side. Most are Haitian migrant laborers who, in some cases, live 20 to a room. The streets are unpaved and sewage is not available. Insects and rodents are common. The buildings are in disrepair with many about to crumble to the ground. In the midst of this squalor AIDS is festering and spreading. While the CDC has removed Haitians from the official list of high risk AIDS groups Scripps Howard News Service reports: "people in Palm Beach County don't necessarily share that belief."

Transvestite Black Prostitute Keeps "Working"

Denver, police are in a quandary over what to do with Negro, Kevin Blanton, 24. Five months previously he had been diagnosed as a carrier of the AIDS virus. (He has not yet come down with the full disease.) Still he has given AIDS to at least three of his known customers among the over 20 he admits having since contracting AIDS.

Detective Terry Ball says, "He does not care. He told me he wished he could give me AIDS." Blanton has 33 arrests for male prostitution. His explanation is "I have got to make a living." Dr. Seymour Sundell of the corrections dept. of the Denver Hospital said:

"He is an extreme danger to public health but all we can do is hold him for 90 days in the hospital isolation ward. Then he is free to go back out on the street."

Officer Ball added, "What we need is a law whereby such people can be prosecuted for reckless endangerment but none is on the books today." Thus the wildfire of the AIDS disease continues to spread through the homosexual, bisexual and Negro community without any restraints.

Kenya, with the highest birth-rate of any nation in the world and a rapidly deteriorating economy has 18% of its people infected with AIDS. In Zaire 16% have AIDS. The figure is 20% in both Rwanda and Uganda. In the rural areas where promiscuity is accepted as a way of life the AIDS epidemic rate is even higher than in the cities. Dr. Robert J. Biggar of the National Cancer Institute in Bethesda, Md., is in Africa with a special research team on AIDS. He said he was shocked to find that the highest frequency of AIDS was among the Turkana tribe living in a remote area in northern Kenya - 50% TESTED POSITIVE

CDC Answers Questions on AIDS

Q. Is AIDS spreading among heterosexuals?

A. Only 1 percent of AIDS cases in the United States are attributed to heterosexual intercourse, and this percentage has remained constant for years, according to Dr. Harold Jaffe, the chief AIDS epidemiologist at the Centers for Disease Control in Atlanta.

He said the rearrangement of reporting methods reflected improved information on heterosexual transmission, especially as it affects Haitians in this country.

Dr. Jaffe said studies of the disease among Haitians in Florida, conducted by the agency and by researchers at the University of Miami, produced "strong evidence" that the disease among Haitians was predominantly transmitted by heterosexual contact.

In cities where intravenous drug users are a major source of the disease, he added, blacks are a high proportion of the addicts. Moreover, AIDS has thus far been heavily concentrated in a handful of cities where blacks may comprise a high proportion of the urban population.

The category in which heterosexual AIDS victims are listed will now include foreign-born people with the disease. More than half of those now in the revised category are Haitians, officials said.

Dr. Gallo, an American expert, is one of many researchers who have speculated on a Haitian connection: the fact that several thousand professional people went from Haiti to work in Zaire in the 1960's and 1970's and brought it home with them.

Q. Can women transmit the virus to men?

A. The evidence of female-to-male sexual transmission of the virus remains sketchy, but Dr. Jaffe said, "We have to presume it occurs." If so, it has occurred only rarely in the United States: sex with an infected woman has been strongly implicated as the source of AIDS in only 16 men. In scores of other unexplained cases, intercourse with women is the suspected source. In Africa and Haiti, many men with AIDS report numerous sexual partners or frequent visits to prostitutes.

In New York City, 447 women have been reported to have AIDS, as of Oct. 18. Of these, a highly disproportionate 85 percent are black and Hispanic women, a reflection of the ravages of drug addiction among minorities, city officials say.

New Listings Mostly Haitians

The new heterosexual category now lists 862 AIDS sufferers, according to the Federal Centers for Disease Control in Atlanta. Of these, 379 were previously listed in the "heterosexual" category and 483 were shifted from the "none of the above" category.

Of those 483 cases, all "but a handful are Haitians," reported Dr. Harold Jaffe, chief of the epidemiology branch in the centers' AIDS program in Atlanta. The others were born in central Africa, he said today in a telephone interview.

Most of the Haitian victims are in south Florida and the New York metropolitan area, Dr. Jaffe said.

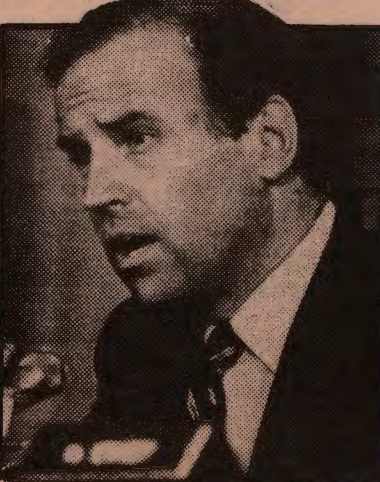

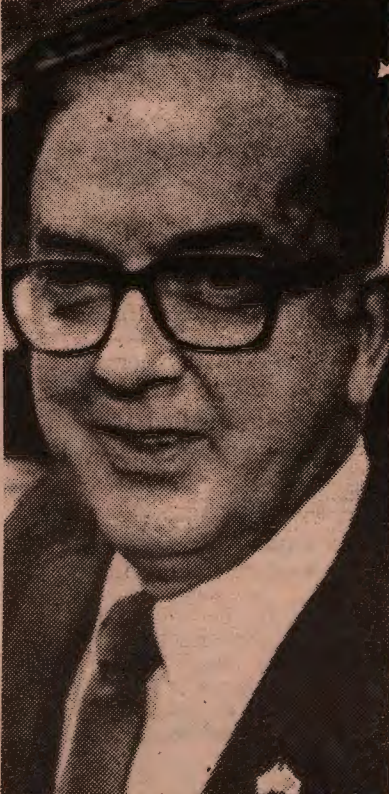

Congress Votes Harsh Sanctions Against South Africa

Both the U.S. House and Senate have passed radical sanctions aimed at bringing down the White government of South Africa. The end result, should they succeed, would bring to power the African National Congress (ANC) which is totally controlled by the South African Communist Party. The ANC is both financed and armed through aid from the Soviet Union. Still U.S. security interests in this part of the world are tossed to the winds by our Congress who only see the minority bloc vote as their only goal in life.

The House passed bill would ban landing rights to South African Airways and ban all U.S. investment. It would prohibit all U.S. exports to South Africa and would only permit imports of strategic materials such as Platinum, Chromium and Manganese. It should be noted that Rep. Mark Siljander (R. Mich.) led the fight against the measure which passed by a disgraceful 380 to 48 vote.

In the Senate the Kennedy-Cranston anti-South African bill was adopted by the disgusting vote of 84 to 14. It would ban South African Airways from landing in the U.S. along with all imports of steel, iron, farm products, coal, textiles and restrict new loans. Strategic materials would be admitted. Sen. Joe Biden (D. Del.) a presidential candidate, urged stricter mandatory sanctions.

What If South Africa Boycotted The U.S.?

South Africa produces 43% of the world's supply of Platinum (Russia 50%) - this is used in U.S. refining processes and electronic systems. We obtain 55% of our Platinum from South Africa. South Africa produces 31% of the world's supply of Chromium, (Russia 41%) which our steel industry is heavily dependent on to harden and toughen steel and increase its

resistance to corrosion. Some 80% of our Chromium comes from South Africa. Over 295,000 Americans work in basic steel production and 900,000 in the automobile industry. We receive 80% of our Manganese from South Africa. Also, 90% of Vanadium and 30% of flour we use in industry comes from South Africa. All our cobalt comes from Zaire and Zambia which must be shipped through South Africa. (This is used as an alloy in cutting tools and in building jet engines.) What about the 24,000 U.S. and European ships which stop at South Africa's deep water ports as they round the Cape of Good Hope annually.

U.S. Wants Minerals

THE CONGRESS SAYS WE DARE NOT CUT OFF THESE PRODUCTS AND SERVICES. South Africa could wreck the U.S. economy tomorrow if they adopted sanctions against America. This country could not buy all these products from Russia because they already have a world market for most of what they can produce. The Soviets could triple the price! The U.S. is more dependent on South Africa than they are on us. The daily press has suppressed these vital truths.

The left-wing liberals have also forgotten our anti-communist European allies. They are even more dependent on South Africa's minerals than we are. Only a 30% short fall in chromium imports would result in a 25% decline in the gross national product of every European nation.

Blacks Average 15 I.Q. Points Lower Than Whites

Negro I.Q. Far Lower Than Whites

Every conceivable type of I.Q. test has been especially designed to help blacks pass civil service exams and for job promotions. In every single test, given by any and every city, county, state and federal governmental agency **WHITE WORKERS HAVE ALWAYS SCORED HIGHER THAN BLACKS!**

Study the chart of this page which was made from a random sampling of 1,800 black children and compare to a national survey of White children. A person having an

"average intelligence" should score between 90 and 109. Note that most White children do score within this range with a third being above the 109 range meaning they are of superior intelligence. Now, look at the black score pattern.

The vast majority of Negroes are mentally below average with only a tiny minute number scoring above 109 - in the superior range. Even more important is the fact that those classified as mentally limited score under 75. Very few Whites score that low, BUT A THIRD OF THE BLACKS ARE MILDLY RETARDED

TO THE SEVERELY RETARDED RANGE.

It should be kept in mind that I.Q. is an inherited genetic trait and even expensive "special education programs" have accomplished very little in altering this test pattern.

"The Harvard Educational Review" presented study by Dr. Arthur Jensen of the University of Calif., at Berkeley which stated:

"Based on I.Q. tests Whites may be naturally smarter than blacks. During two generations of I.Q. testing blacks have consistently scored 15 points lower than Whites. No one has

JENSEN'S REBUTTAL

Arthur Jensen has grown accustomed to life in the vortex of an academic cyclone. Blacks, he has long argued, are less intelligent than whites, and that is why they perform poorly on IQ tests (chart). Even more startling, the psychologist suggests that the phenomenon may result from genetic inferiority. When the prestigious Harvard Educational Review published the University of California, Berkeley, professor's heresy eleven years ago, his ideas touched off impassioned scholarly rebuttals—and brought him death threats in the mail. Since then, many of his critics have fastened on flaws in tests to explain why blacks get lower IQ scores. Now Jensen has rigorously responded to those

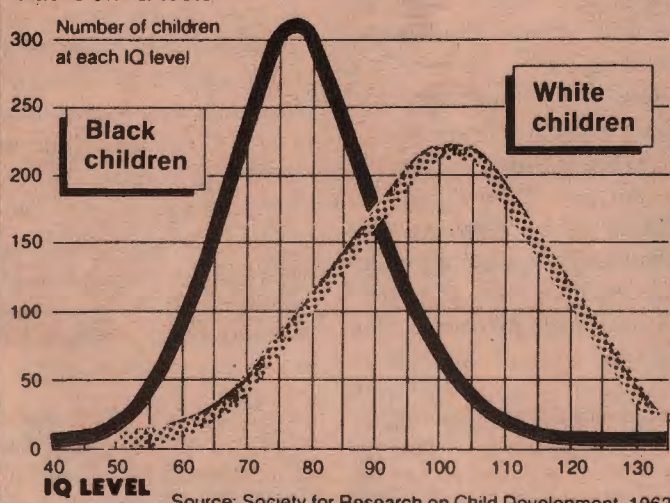
■ The difference in test scores stems from the average black's lower ability to reason conceptually. Blacks have a harder time grasping how objects are related. For example, they cannot solve puzzles, analogies or ratio problems as easily as whites. Blacks do compete equally or favorably with whites on tests of memory and dexterity, such as number recall and counting groups of dots.

■ There is a developmental lag between black and white children. The average black 10-year-old performs at the mental level of the average white 8-year-old. But unlike the tortoise and the hare, blacks never catch up with whites.

Jensen and a study cited in his book: *Bound to renew the debate over genes and intelligence*

charges, publishing an encyclopedic review of testing—a book that promises to stir still another stormy debate over racial intelligence and the value of tests.

Jensen's new survey* gives IQ testing an essentially clean bill of health at a time when testing faces unprecedented public hostility. It also buttresses his old genetic arguments. While the report steers clear of trying to prove heredity-based intelligence, it concludes that IQ tests are valid measurements of natural ability. Jensen rejects test bias to account for the average 15-point IQ gap between blacks and whites of all backgrounds. Says the 56-year-old psychologist: "There is a true difference in the general intelligence between blacks and whites, and at this time it is impossible to devise a reasonable test of mental abilities which does not show that difference."

Among his controversial conclusions:

unjustified. Blacks do better on items that refer to white culture, such as "The Iliad," than they do on "culture-free" items, such as the number of days in a week.

Yet on any count, the implications of Jensen's book are grim. His work suggests that attempts to raise the educational success rate of all black youngsters to parity with whites are ultimately doomed to fall short. If black test results derive overwhelmingly from inherited traits, Jensen's message is bleak indeed: blacks should resign themselves to a role of intellectual inferiority. Jensen's ideas are so radical that they are bound to renew the debate over race and genes. An uglier prospect is that they may lend themselves to those who would chip away at the fundamental principle of equal opportunity.

yet been able to design a reputable test on which blacks do as well as Whites. I estimate that 20% of this gap is due to environmental and cultural differences and 80% is due to genetics. Even American Indians, who are in the most socially deprived and ignored group, still score on the average 7 points higher than blacks.

Dr. Jensen discussed his testing of twins who had been separated and raised by foster parents in totally different social and economic atmospheres. He found that in most cases - TWINS WITH IDENTICAL GENES HAD THE EXACT SAME I.Q. SCORES!

Dixon - The Forgotten Writer



Thomas Dixon was one of our most famous writers from 1900 until 1925. He was the author of ten best selling novels. They were read by over 5 million people. They actually saved Doubleday Publishers from the brink of bankruptcy.

"Education, sir, is the development of that which IS. Since the dawn of history the Negro has owned the continent of Africa—rich beyond the dream of poet's fancy, crunching acres of diamonds beneath his bare black feet. Yet he never picked one from the dust until a White man showed him its glittering light. His land swarmed with powerful and docile animals, yet he never dreamed a harness, cart or sled. A hunter by necessity, he never made an ax, spear or arrowhead worth preserving beyond the moment of its use. He lived as an ox, content to graze for an hour. In a land of stone and timber he never sawed a foot of lumber, carved a block or built a house save of broken sticks and mud.

With league on league of ocean strand and miles of inland seas, for four thousands years he watched their surface ripple under the wind, heard the thunder of the surf on his beach, the howl of the storm over his head, gazed on the dim blue horizon calling him to worlds that lie beyond, and yet he never dreamed a sail! He lived as his fathers lived—stole his food, worked his wife, sold his children, ate his brother, content to drink, sing, dance and sport as the ape. And this creature, half child, half animal, the sport of impulse, whim and conceit, 'pleased with a rattle, tickled with a straw,' a being who, left to his will, roams at night and sleeps in the day, whose speech knows no word of love, whose passions once aroused are as the tiger—they have set this thing to rule over the Southern people...Merciful God—it surpasses human belief.

What is our condition today?...If we attempt to move forward we are chained to the body of a festering Black Death! Our governments are debauched by his vote. His insolence threatens our womanhood, and our children are beaten by Negro toughs on the way to school while we pay his taxes. Shall we longer tolerate Negro inspectors of White schools, and Negroes in charge of White institutions? Shall we longer tolerate the arrest of White women by Negro officers and their trial before Negro magistrates?

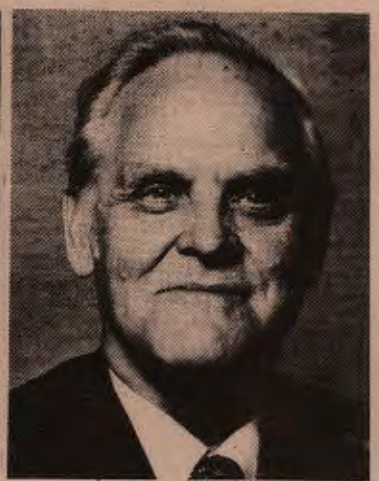

Francis Meli, editor of the African National Congress magazine Sechaba and a member of the ANC Executive Committee, greeted the birth of a new paper that will advance the struggle against imperialism and develop solidarity with the liberation forces of Southern Africa.

He noted most media coverage of South Africa creates pity, rather than building solidarity. "You see one standard picture on TV — the powerful racist army killing Africans who are running

away," he said. "This cannot be otherwise because the cameramen stand behind the white army. They never stand behind advancing Black people."

Meli pointed out that apartheid robs U.S. workers of jobs, encourages racists everywhere and threatens world peace by providing minerals for the development of nuclear weapons. "By helping us you are not helping a people far away from your daily lives," he said. "In South Africa we are fighting, we are dying for your cause."

Ilias Papadimitriou, a member of Greece's parliament and the Central Committee of the Greek Communist Party, brought greetings from Rizospastis, newspaper of the Greek CP. In March, Rizospastis had the highest circulation of all morning dailies in Greece.

Teens Stab Bible Teacher

Torture Crimes Shock Americans

Gary, Indiana is a majority black city as is the neighborhood where Mrs. Ruth Pelke, 78, lived. Mrs. Pelke was a Bible teacher and had befriended negress April Beverly, 15, after her mother died. She would prepare meals for the girl and give her friends candy and Bible lectures.

Last summer April came to Mrs. Pelke's home with three black girls, Paula Cooper, 15, Karen Corders, 16 and Denise Thomas, 14. They even used the brutal African custom of pushing the butcher knife all the way through the woman's chest and out her back - "just to see how it would feel" - one confessed. One agreed to hold the knife in her body so she would not wake up while the others ransacked her house. They robbed the kindly elderly lady of all the money she had - ONLY \$10 - and took her 1977 car.

an "upper class" section of Gary where doctors, lawyers and professional people lived.

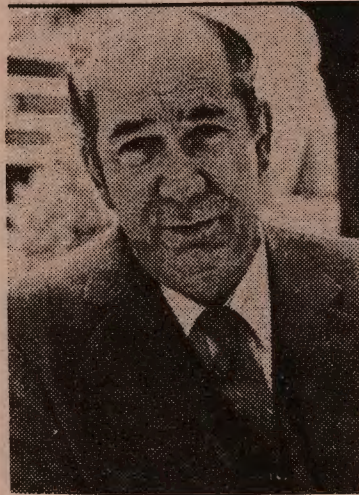
Police state that such young criminals often attack elderly people because they view them as weaker and unable to resist. Mrs. Pelke's home had been burglarized five times since the neighborhood became "integrated." All of the girls have been in trouble with the police before and one is pregnant. They have been given 30 year prison terms but because they are juveniles their sentences will be greatly reduced. Prosecutor Jack Crawford said: "Most of us would not think twice about opening our front door to such young visitors. What we have here is a stark reminder that you don't know who you can really trust today!"

Federal Court Gives Alday Killers New

Georgians Want Judges Impeached

Bainbridge, Ga., businessman Curtis Strickland has taken up 80,000 signatures from outraged citizens demanding the impeachment of three Federal Judges who sit on Atlanta's 11th Circuit Court of Appeals. They are Judges Lanier Anderson, Thomas Clark and the notorious Frank Johnson. It was Johnson who handed down all the racial integration orders in Alabama. Just recently it was a Johnson federal panel which ordered the Alabama Democratic nomination for Governor be taken away from state Attorney General Charles Graddick who got the most votes. Later it was given to Bill Baxley who was the candidate endorsed by all the black voter organizations as well as by the U.S. Communist Party!

The three judges ruled that the interracial gang which murdered six members of the Alday family did not receive a fair trial because of "bad publicity" and the case should have been moved to a different city.

This was a clear cut case in which the guilt of the defendants was not in question. They are Negro George Dungee, Carl Isaacs, Wayne Coleman and Billy Isaacs. The first three all received death sentences and Billy Isaacs got 40 years for pleading guilty and agreeing to testify against the others. As the members of the Alday family returned home from work - one at a time - they were accosted, taken to a room, and shot in the

back of the head. Mrs. Mary Alday, 25, was forced to watch the killings. After murdering 5 of the Alday's they stripped Mary nude, tortured and gang raped her. Then they took her into a nearby wooded area and shot her to death. THE FEDERAL APPEALS COURT HAS REVERSED THEIR DEATH SENTENCE!

There will be another trial - BUT THIS HORRIBLE CRIME TOOK PLACE 11 YEARS AGO! Justice cries out for vengeance. Former Lt. Gov. These judges ought to be required to go down to Seminole County, lay down on the Alday family graves and apologize."

Kicks 3 Women To Death

Karate Killer

Smashes Their Hearts

McKees Rock, Pa. was the scene of one of the most vicious killings we have ever heard of. The bodies of three prominent women, all in their eighties, were found in an abandoned mine covered with tires. The police had never seen anything like it before. Mrs. Lucille Horner, 88, and Mrs. Minnie Warrick, 87, had been smashed in the chest by a powerful blow which lacerated their hearts and killed them. Mrs. Sarah Knutz, 84, died of a lacerated liver.

The three women, all widows and avid bridge players, had just left a social club luncheon. The assailant apparently jumped into their car when they stopped for gas. Police charged Negro Roland Steele, a Karate expert, with the crime. They say he smashed two of the ladies to the heart area with his elbow and

kicked the other in the liver area with such force it killed her.

Farrell Jackson said, "This is the most hideous crime in my 29 years as Coroner." Steele, 38, had four previous burglary convictions. He once was arrested for ramming a car into Civil War headstones in the Allegheny Cemetery. Police said he held a hatred for White people.

severs woman's finger for ring

Confronted by a knife-wielding burglar an elderly widow tried desperately to slide the rings from her swollen finger, but in an instant of bloodcurdling horror the punk grabbed the woman's trembling hand and hacked off her ring finger with his knife.

The grisly nightmare crime took place in a peaceful neighborhood near the University of Missouri campus in Kansas City.

Sgt. Jim Treece told The

NEWS that three elderly women were in the two-story house when the burglar broke in through the garage about 9 a.m.

"As the burglar was going up the stairs the victim, a 76-year-old widow, was coming down to see what all the commotion was," said Treece. "He demanded her rings, but she couldn't get them off."

"Then the intruder just grabbed her hand, pulled it around in front of him and with his knife removed the ring finger of her left hand," Treece said. "Then the assailant fled with the jewelry and the victim's finger."

Several days after the attack Treece said an anonymous tip led detectives to arrest 17-year-old Gary Lovelady for the crime.

"He was wearing three stolen rings on a chain around his neck at the time of his arrest," said Treece. "He didn't offer any resistance."

"I Didn't Like Nobody"



Henry Brisbon

On the night of June 3 1973, a Chevrolet Caprice, driven by a woman, was forced off Interstate 57 in southern Cook County, Ill., by a car carrying four men. One of them pointed a 12-gauge pump shotgun at her, ordered her to strip and then to climb through a barbed-wire fence at the side of the road. As she begged for her life, her assailant thrust the shotgun barrel into her vagina and fired. After watching her agonies for several minutes, he finished her off with

a blast to the throat. Less than an hour later, the marauding motorists stopped another car and told the man and woman inside it to get out and lie down on the shoulder of the road. The couple pleaded for mercy, saying that they were engaged to be married in six months. The man with the shotgun said, "Kiss your last kiss," then shot both of them in the back, killing them. The total take from three murders and two robberies: \$54, two watches, an engagement ring and a wedding band.

The man ultimately convicted of the "I-57 murders" now sits confined in the Menard Condemned Unit, the official name for death row in the Illinois prison system. Yet Henry Brisbon Jr., 28, does not face execution for those three killings nearly ten years ago. Illinois' death penalty was invalidated in 1972 and was not restored until 1977, the year that Brisbon was finally brought to trial. At that time, the judge sentenced him to a term of 1,000 to 3,000 years in prison. It took Brisbon less than one year to kill again, this time stabbing a fellow inmate at Stateville Correctional Center with the sharpened handle of a soup ladle. At the trial for this murder, Will County State's Attorney Edward Petka described Brisbon as "a very, very terrible human being, a walking testimonial for the death penalty." The jury agreed.

Brisbon's eleven months on death row have been quiet, compared with his Stateville years, when he took part in 15 attacks on inmates and guards, instigated at least one prison riot, trashed a courtroom during a trial and hit a warden with a broom handle. "I'm no bad dude," he says, "just an antisocial individual." The third of 13 children, Brisbon thinks that his upbringing by a strict black Muslim father made him different: "I was taught to be a racist and not like whites. As I grew up, I decided I didn't like nobody."

Brisbon has 90 well-supervised minutes each day outside his small (7 ft. 7 in. by 5 ft. 10 in.) cell. He works out with weights, keeping his 155 lbs. (on a 5-ft. 9-in. frame) in shape. He complains about his confinement: "Can't take two steps in this cage. It's inhuman. And that dull-ass color blue on the walls in no way brightens my life." He has devised a novel idea about judicial reform: "All this talk about victims' rights and restitution gets me. What about my family? I'm a victim of a crooked criminal system. Isn't my family entitled to something?" The shadow of the death penalty does not faze him: "I don't see that happening to me. What would killing me solve? Isn't that just another murder? If I got to die, it's going to be of natural causes." The state of Illinois thinks otherwise. Says Michael Ficaro, who prosecuted the I-57 case: "On the day he dies in the chair at Stateville, I plan to be there to see that it's done. Nobody I've heard of deserves the death penalty more than Henry Brisbon."

Prominent Georgia Lady Murdered

Phyllis Dixon, 57, and her son, Madison Dixon, 31, were found slain in the family home at Swainsboro, Ga. They had been stabbed and beaten with a

blunt object. Mrs. Dixon was a volunteer worker at the county hospital and was preparing to attend a luncheon of Exchange Club members that day. Her son, Madison, was a graduate from Georgia Southern College with a degree in journalism and had just completed requirements for a degree in psychology.

Arrested was Negro handyman Willie Gamble, 31, who lived in a public housing project. He did odd yard jobs for the Dixon family. Gamble took what money was in the house and Mrs. Dixon's 1977 Mercury Marquis. Here is another great loss to productive White society which cannot be replaced.

Victim Raped - Dressed - Slain

New Orleans has seen many senseless killings of White people and the murder of beautiful Kathy Newman, 25, was one of the worst. She was a student at Tulane University studying to become a medical doctor. While returning to her apartment she was accosted upon getting out of her car. The killer forced Miss Newman back into the car, robbed her at gunpoint, and forced her to drive to a wooded area. There she was raped. She was allowed to get dressed and then was shot in the back of the head execution style. Arrested is Willie Watson, Jr., 25, occupation - unemployed. 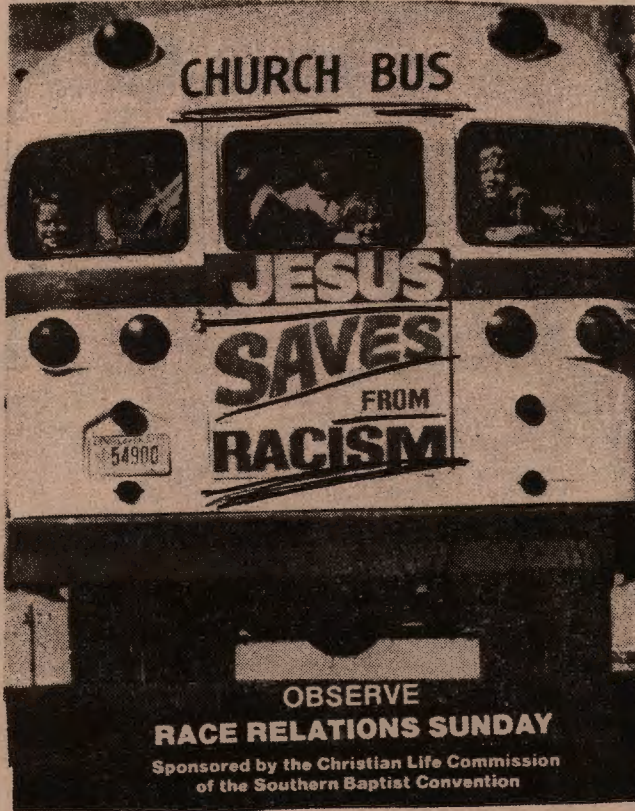

What this church forgets is that every I.Q. test ever given by any and all U.S. government agencies (on both the local and national level) always show White people testing higher than blacks. THIS IS A SIMPLE UNDENIABLE TRUTH OF LIFE!

They preach that the black man is black because he has been out in the sun so long. They refuse to acknowledge that there are numerous mental, physical and genetic differences which themselves divide the races just as nature keeps the various species of the animal world "each unto their own kind."

Only 2% have ever lived as long as five years. Thus far no one has survived AIDS and there is NO CURE IN SIGHT!

Cornelius Vanderbilt created the family fortune through his shipping empire. He was one of

Gloria has long flaunted her relationship with live-in Negro boy friend, jazz pianist Bobby Short. Gloria made a \$100,000 down payment on 1.1 million apartment in the exclusive River House. (Henry Kissinger lives there.) She expressed surprise when the deal was cancelled.

Communists Promote Anti-White Hate Campaign

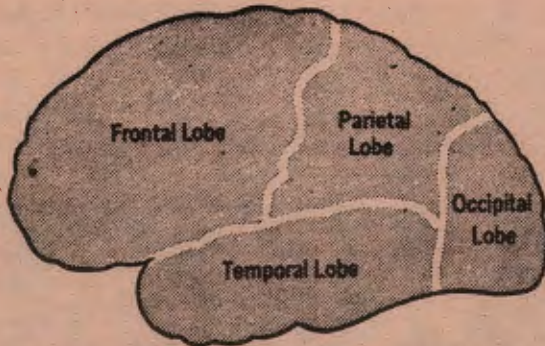

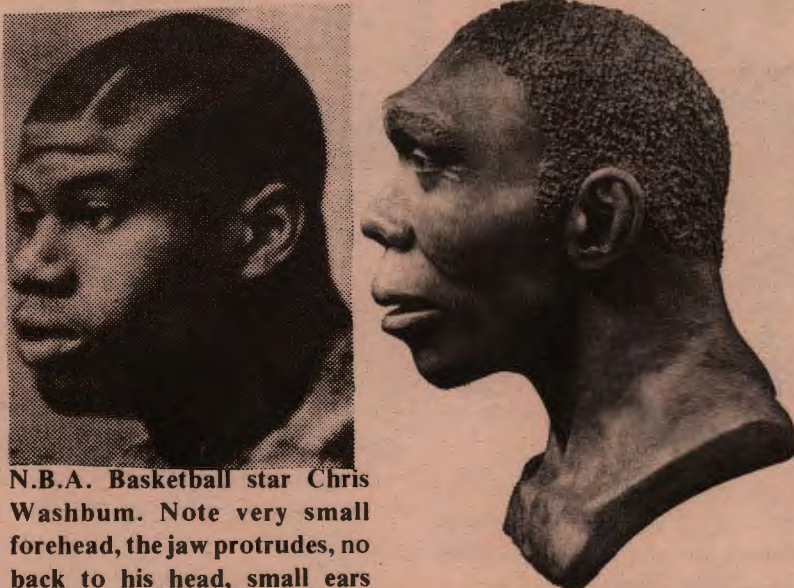

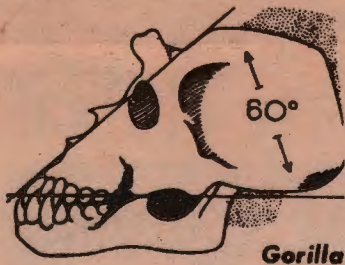


The forebrain of the Negro is much smaller than the White. This is the area effecting intellect, self-control, reason, judgment, orientation, etc.

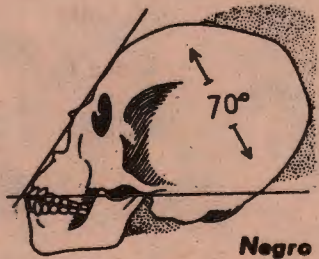

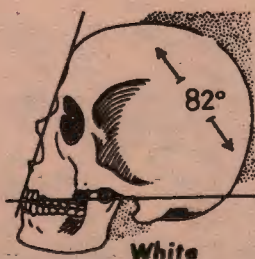

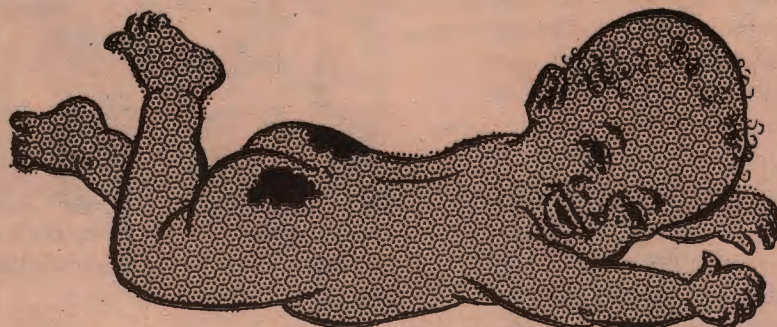

Racial Differences

- 1) The Negro facial angle of the skull is 70 degrees compared to 82 degrees for the White.
 - 2) The sutures of the Negro skull unite at an earlier age than in Whites thus retarding development.
 - 3) The Negro's hair is flat without a central core or duct -unlike White peoples' hair.
 - 4) The eyeball of the Negro is tinged with yellow as is that of the ape.
 - 5) The Negro nose is concave at the bridge as is the apes. The nostrils turn up and show the red inner lining.
 - 6) The lips are everted and show the red mucous membrane.

WHAT ARE SACRAL SPOTS?

90% of Negro and Mongolian babies have on their backs when they are born, dark brown spots varying in size. These are known as "Mongolian" or "sacral" spots. They disappear in three or four months. What these spots are and what causes them nobody knows. Can it be that they are atavistic, reverting to a primitive type—similar to the white spots which we see on the backsides of monkeys at the zoo?

Differences Between The Negro and White Brain

The brain is the most important organ in the human body. It is only 2% of our total body weight but it consumes 25% of all the calories we intake. The brain never sleeps, it works around the clock keeping the body functioning. It operates the heart, thinking process, digestive system, our every movement, enacting resistance to disease, etc., etc.

Even more important, the brain has stored knowledge which has been passed on to us by our parents, grand-parents and hundreds of generations of ancestors going back to the beginning of time. The breeding of a new embryo baby from the melting together of the genetic inherited traits of the White brain with a Negro brain can destroy in a split second thousands of years of White brain development.

The Development of The Brain

Prof. Carleton S. Coon, once president of the American Association of Anthropologists, wrote his epic book, "The Story of Man" which was published on May 15, 1962. He wrote that the Negro race is 200,000 years behind the White race in brain development. Prof. Coon says the weight of the White brain is 100 grams more than the average adult Negro brain.

The weight of the brain is highest in the Caucasian White, the Chinese and Japanese are next followed by the Malay, then the Negro with the Australian Aborigine being the lowest.

The weight of the average White brain is 1380 grams.

The weight of the average Negro brain is 1249 grams.

The cubic capacity of the Negro brain is 1316cc which is 165cc less than the White.

White Brain More Advanced

Dr. H.C. Gordon of the British Medical Assn., is his "Study of The East African," wrote:

A native socially efficient in his own simple environment may, without change in him, prove to be inefficient or even dangerous in the complex environment of a higher Western society," this no doubt explains why the blacks commit a majority of all violent crime in America while still being only 12% of the total population!

Prof. Coon reports that the cortex of the Negro brain is less grooved (wrinkled) on the outer surface, and less complex than the more advanced White brain. The cortex of the Negro brain is thinner and development ceases at an earlier age in the Negro child which limits their advancing to a higher intellectual level.

The Negro Crime Rate

Dr. J.C. Carothers spent his entire life administering to the health needs of blacks in Africa. He wrote:

"With the Negro, emotional, momentary and explosive thinking predominates. The Negro has but few gifts for work which aim at a distant goal and require tenacity, independence and foresight. Projects for the future occupy him but little. Unlike more civilized peoples, his governed more by emotions than intellect."

Society Suffers From Primitive People

The fact that Negroes commit over 70% of all murders in America is no doubt the result of his primitive and underdeveloped brain. Thus we understand why over 50% of all black births in America are illegitimate. Negroes commit 10 times more murders than Whites, 6 times more robberies and 7 times more rapes. The drug scene dominates black neighborhoods which results in a growing overall threat to the White community.

Dr. Carlton Coon writes that the White man in Europe moved out of the "Homo Erectus," (primitive man stage), when our brain attained a size weighing 1250 cubic centimeters. Thus we became "modern man" (Homo Sapiens) some 200,000 years ago. But, Dr. Coon says that the Negro race only moved from the Homo Erectus stage to the Homo Sapien just 10,000 years ago!

Nothing in the world could be more destructive to the development of the White Race than the injection of black genes into our racial genetic pool. Civilizations would be set back at a time when the advancement of the world is dependent upon the brain power of a dwindling number of White people on this planet.

Integration wrecked schools, senator tells Westwego club

Forced integration of schools has destroyed our educational base, an outspoken state senator said Monday.

Public education in Louisiana has not recovered from federally required integration, Sen. Elwyn Nicholson, D-Marrero, told the Westwego Rotary Club.

The club, which is in Nicholson's district, invited him as part of a series of addresses by state officials on problems facing Louisiana.

Nicholson spoke without notes. His speech was mostly a series of loosely linked observations that touched on education more than other topics.

"Two years ago, Boston had riots because they weren't integrated and all that stuff," Nicholson said. "They (finally) had to bus students."

The disturbances over integration by busing in Boston flared in the mid-1970s.

"They hadn't integrated those

(northern) schools, but here we had to do it," he said. "They destroyed our educational base, and nobody's doing anything to the federal government to get it back."

Along with integration, Nicholson said, the federal government ordered that poor students be promoted and graduated despite their grades.

"When they threw in social promotion, they destroyed everything," he said.

"A guy could be stupid and he'd pass. He could be stupid and he'd graduate, and he graduated from high school and he graduated from college. ...

"What about a teacher who writes a note home and says about a little kid, 'He be's bad?' ... It was the federal government that destroyed us."

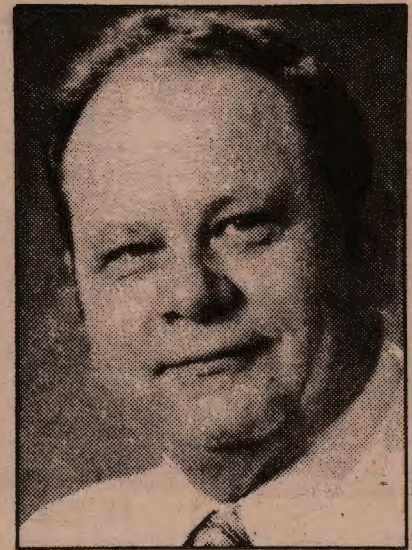
In Louisiana, criteria for promoting students are determined by local school boards, and social promotion has been largely absent in Louisiana for years, said Anne Stewart, the state's associate superintendent of education.

Nicholson said he remembered an aunt, a teacher, who told him she was required to pass certain students despite their performance.

"They automatically had to pass them," Nicholson said. "You couldn't fail anybody. Nobody. ... You had to promote them ... because it gave them an inferiority complex (if you didn't)."

At one point in his speech, Nicholson noted that some officials believe the state's poor public schools discourage new industry from locating here.

He disagreed with that assessment: "They talk about we don't

have the education. That's baloney. You take and put the white population separate from the colored, and let's match the thing up and see if we have educated people."

Officials say blacks slipping in education

TALLAHASSEE — The education of blacks in America is declining rapidly and will soon reach crisis proportions, a leading educator said Thursday.

Dr. Adrienne Bailey, vice president for academic affairs at the national College Entrance Examination Board, said that blacks are slipping in education indicators "across the board."

Ms. Bailey made her remarks at the Summit Conference on Equality, sponsored by the National Human Relations Task Force and Florida State University.

"There is a racial cancer that is before our eyes destroying black America, and that cancer is the rapidly escalating disintegration of minority talent in America," Ms. Bailey said. "Some progress has been made, but on overall terms, by almost every major barometer, blacks have fallen behind in the last decade."

Among the factors that indicate that educational decline, the percentage of blacks taking college-preparatory classes in high school is considerably lower than that of whites (40 percent of white high school students are assigned to college-prep; only about 33 percent of black students). Non-college prep students do not get access to top-quality equipment, such as scientific lab materials and computers.

"Black students are exposed to less challenging academic programs, which do not allow for increased cognizant abilities," Ms. Bailey said. "The results of that educational inequity are devastating, not only in their educational plans but in their professional careers."

She said black enrollment in colleges dropped 1.3 percent between 1975 and 1980, even though the number of blacks graduating from high school was at an all time high.

Also, she said, the percentage of black students in post-graduate degree programs has dropped steadily since 1981 and is "disproportionately small." Only about 4 percent of the blacks who graduate from high school complete graduate school, compared to 9 percent of white high school graduates.
