

Marxists Hail Coca-Cola Divestment

Coca-Cola Stabs South Africa In The Back

The Communist "Daily World" of Sept. 20 hailed Coca-Cola's decision to sell all its holdings in South Africa. Randall Robinson of the Marxist TransAfrica organization is quoted as saying this will, "step up the pressure on other U.S. companies to leave South Africa." Thus far only 20 of the 247 firms doing business in South Africa have left but Coke is the largest.

Coca-Cola's South African bottling plant has 460 employees and it is supposed to be sold to an interracial group. The problem is no blacks have that kind of money. Coke President Donald Keough said the divestment was a "moral protest against apartheid." The irony of all this is that Keough and his ultra-liberal board of directors want to have their cake and eat it too.

Wants Whites To Keep Drinking Coke. Keough said South African sales constitute 3% of their business!

The sale of syrup concentrates amount to \$50 million a year and Coke products make up 75% of all soft drink sales in South Africa. Keough said Coca-Cola will continue to be sold in South Africa and hopes Whites will keep drinking their products!

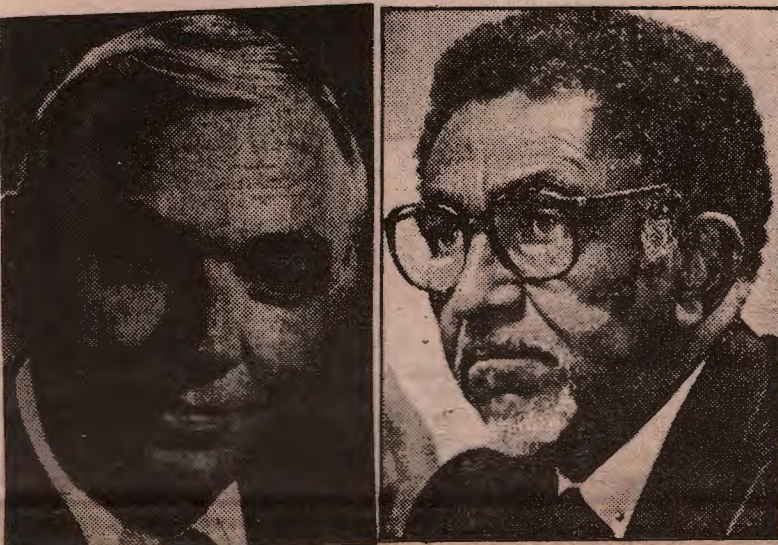

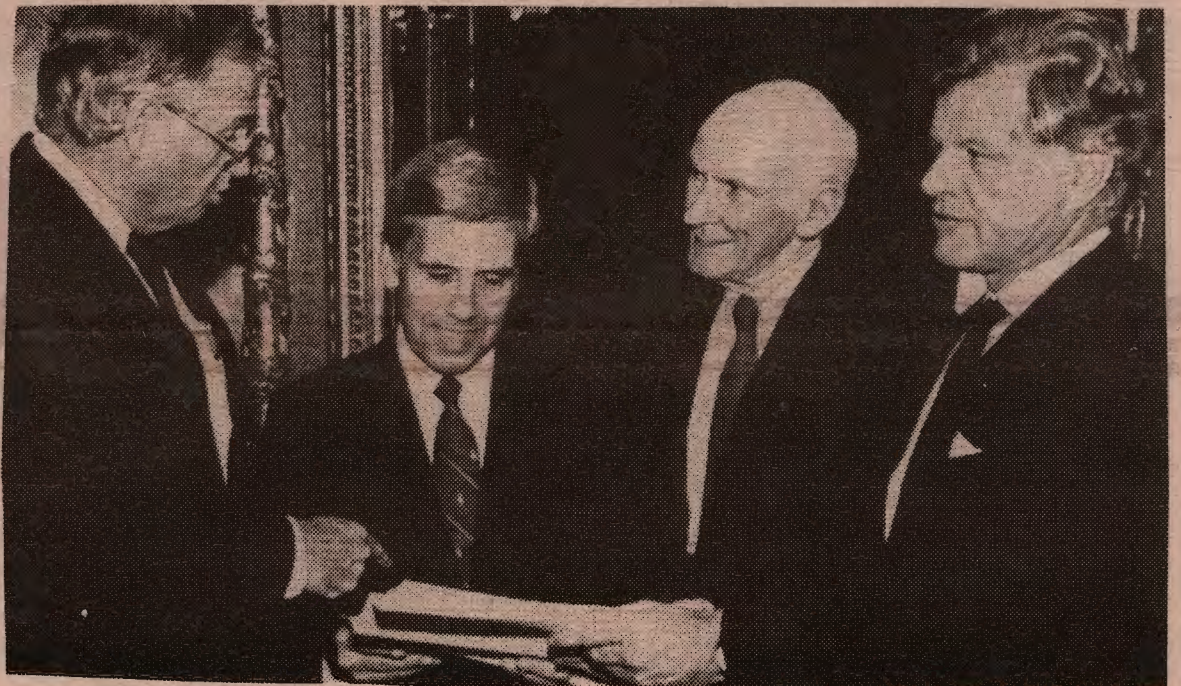
Congress Betray's South Africa

The New York Times praised Coca-Cola's action stating this was not really new because this divestment policy actually began in 1976 when they began quietly selling their other investments. Thus Coca-Cola was working toward this final phasing out of all operations in South Africa long before the current "divestment" campaign even began! Still they want White Americans and White South Africans to continue to drink their swill! We say, let's teach this giant a lesson and cut their profits with an international White people's boycott of all Coca-Cola products. There are plenty of other soft drinks we can buy.

The Senate voted 78 to 21 to override Pres. Reagan's veto and impose economic sanctions against South Africa. Presidential candidate Sen. Joseph Biden stated: "It is time for the world to understand that Pres. Reagan does not speak for the American people on this issue."

Biden was way off base - THE LATEST NBC-NEWS POLL SHOWS ONLY 26% OF THE PEOPLE SUPPORT SANCTIONS! Sen Malcolm Wallop of Wyoming strongly opposed sanctions and stated: "This is an appeal to domestic racial politics. What we are looking at is middle class, comfortable White senators playing up to the black population of America, the liberal population!"

Sen. Mattingly and Nunn Vote For Sanctions

A number of so-called "conservative" Senators voted for sanctions including Sen. Mattingly and Nunn of Georgia along with Kasten of Wisc., Zorinsky of Nebr., and others. Just prior to the vote South Africa's Foreign Minister, R.F. Botha, phoned several Senators asking them to uphold Pres. Reagan's earlier veto of sanctions. In an unbelievable turn-about Sen. Richard Lugar charged Botha's call was a "despicable act of intimidation and bribery, and an affront to the decency of the American people." (Lugar does not speak for us it is he who is indecent and a disgrace).

What Is Banned From South Africa

The House and Senate sanctions ban landing rights for South African airlines, bars all new investments and bank loans. Censored by the press is the section giving \$40 million of the taxpayers money to help South

Africa's black neighboring countries who will also suffer from the sanctions. All of these are Marxist nations!

LANSING — Over 700 people joined the governing of Michigan and over 20 state legislators

in a "Hands Around the Capital" demonstration here earlier this month demanding divestment of state funds from South African connected businesses.

The action was sponsored by over 30 organizations, including the United Auto Workers union, the American Federation of State, County and Municipal Employees' union, District Council 25, the NAACP, the National Organization of Women, the Women's International League for Peace and Freedom, and the Free South Africa Movement. Many travelled from every corner of the state to support two divestiture bills.

Addressing the rally on the steps of the capital building, Gov. Jim Blanchard said, "Our state pension system has more than \$3 billion invested in companies doing business in South Africa. We must sell off those securities . . . to add Michigan's strong voice to America's cries of outrage against apartheid."

Blanchard continued, "Passage of the divestiture bills by the senate . . . will send an important signal to South Africa and to our leaders in Washington who must be told they cannot waffle on this critical international question."

The rally turnout far exceeded expectations of the organizers, given the short amount of time for planning, said Akua Budu of the Free South Africa Committee in Detroit.

Roll-Call in the House on Imposing Sanctions on South Africa

WASHINGTON, Sept. 12 (AP) — Following is the roll-call vote of 308 to 77 by which the House of Representatives today agreed to accept the Senate version of a bill imposing economic sanctions against South Africa. A "yes" vote was a vote in favor of the Senate version. A "no" vote was against it. Voting "yes" were 218 Democrats and 90 Republicans. Voting "no" were 4 Democrats and 73 Republicans. An "xxx" denotes those not voting. "Present" denotes those who voted they were "present" at the time of the vote but did not vote "yes" or "no" on the issue. There are three vacancies in the 435-member House.

Jane Fonda Backs Woods Missouri Senate contest between Republican former Gov. Kit Bond and liberal Gov. Harriett Woods had Patriotic Veterans up in arms. Actress Jane Fonda publicly endorsed Woods and gave her a \$2,000 campaign contribution. The Veterans of Foreign Wars, (VFW,) with 49,210 members in Missouri voted unanimously urging Ms. Woods to return the donation. She refused!

Veterans are aware of Jane Fonda's record which the VFW called, "treason which caused American prisoners of war hardship and torture." Ms. Fonda made two trips to North Vietnam during the war. 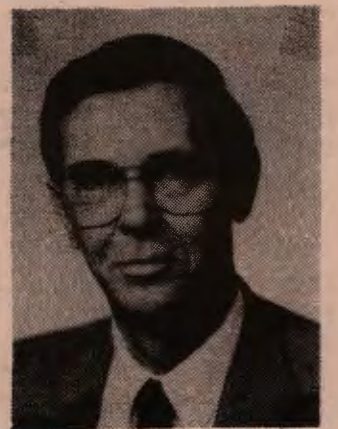

Sher of OSI - "KGB Never Lies!"

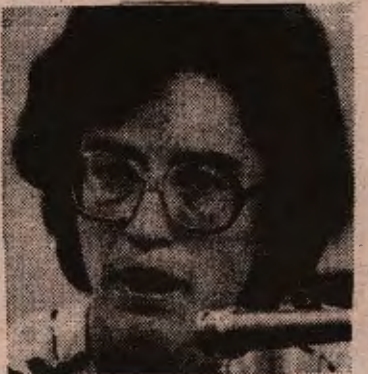

LOS ANGELES—Justice Department draft documents indicate that U.S. Nazi hunters are preparing for an onslaught of criticism from conservatives and liberals as they move to deport an accused Nazi collaborator to the Soviet Union.

According to documents provided by sources in the Eastern European immigrant community, Justice Department officials have become particularly sensitive to suggestions that they are using fraudulent Soviet evidence to identify Nazi war criminals in the United States.

With some exceptions, U.S. courts have usually accepted Soviet depositions and documents as valid evidence in denaturalization and deportation cases. OSI Director Neil M. Sher has said that in West German war crimes trials, "not once to my knowledge" has a court "found that the Soviets supplied forged documents or suborned perjury."

The documents indicate that U.S. officials fear the Soviets will stop assisting in the search for Nazis if the United States fails to deport Estonian immigrant Karl Linnas, 66. Several U.S. courts have ruled that Linnas may be deported.

Linnas' family has denied the charges and argued that he has had no opportunity to confront his accusers or receive an American jury trial. In 1962, he was sentenced to death in absentia by a Soviet court whose verdict reportedly was announced three weeks before the trial.

KGB Uses "New York Times" To Spread Lies

Ex-KGB Agent Says They Plan Lies

"KGB and Soviet Disinformation" is a book written by Ladislav Bittman. He was a KGB agent in Czechoslovakia who escaped to freedom in the West on Aug. 21, 1968. Bittman writes that the KGB has a special section which does nothing else but manufacture faked evidence against innocent parties and "spread rumors and lies as part of an on going campaign to demoralize and subdue the West."

His prosecution has been steered by the KGB

Evidence Proves Demjanjuk Innocent

Israel extradited Ukrainian John Demjanjuk to Israel for trial nine months ago. Now they claim to have found enough "eye witnesses," (professional holocaust survivors), to try him in the very same glass cage which held Adolph Eichmann. Zionist leaders say much rides on the outcome of this trial in convincing the world this man is guilty. Then more East Europeans can be hustled off to Israel for more "war crimes" trials. This helps promote holocaust remembrance events world-wide which stir up sympathy in support of the massive foreign aid Israel receives from America and West Germany.

President Reagan's Communications Advisor and one of his top aids is Patrick J. Buchanan. Despite the wrath of the Jews his action will doubtless bring down upon him, Buchanan has written a lengthy article proclaiming his firm belief in John Demjanjuk's innocence. It appeared in The Washington Post. The only other newspaper to carry it to our knowledge was the Cleveland daily (which is in Demjanjuk's home town.)

Because of its length we will only quote from the article in part touching the highlights. It took a courageous man in public life to write the following words:

Nazi Butcher or Mistaken Identity by Patrick J. Buchanan

White House Communications Director

"I have come to believe that John Demjanjuk is not the bestial victimizer of men, women and children of Treblinka but a victim himself of a miscarriage of justice. Hence this article."

...John Demjanjuk, a naturalized American came to the U.S. in 1952 as a displaced person, a church-going family man from Cleveland, and retired auto mechanic from the Ford Motor Co....the Nazi-hunting Office of Special Investigations at the Justice Dept., opened its investigation of Demjanjuk and in Feb. 1981 he was stripped of his citizenship and ordered deported...In an area smaller than 50 acres, 1 million Jews were done to death between July, 1942 and Aug. 1943. (Dr. Fields Note: This means over the 54 weeks this camp existed some 20,000 Jews had to be gassed each and every day. Could such a gigantic system of huge gas chambers exist in a small prison camp quickly thrown together? While the Germans left detailed plans of the buildings in all camps not one single gas chamber has ever been proven to have existed in ANY GERMAN CAMP DURING WORLD WAR II.)

...There are reasons why a growing number of people believe the 66-year-old man is innocent - a decent and honest family man whose life has been destroyed by Soviet malice and American gullibility.

Could it be that five survivors of the Holocaust are as mistaken in identifying Cleveland's John Demjanjuk as the Butcher of Treblinka as the 11 Holocaust survivors - and even Simon Wiesenthal - were in identifying Chicago's Frank Walus as the Butcher of Kielce, Poland? For six years, Walus' life was a living hell because of the testimony of each eye witness. Finally overwhelming proof turned up that all were dead wrong, that Walus had spent the entire war in Germany as a farm laborer, that he was too short (5 feet 4), too young and of the wrong nationality (Polish) even to belong to the Gestapo in the first place.

Here are the grounds for doubting Demjanjuk's guilt:

1) **Elijah Rosenberg**, was the first survivor to pick Demjanjuk's picture out - but in Dec. 1947 he testified that 'Ivan' had been killed in the Treblinka uprising in Aug. 1943. During the trial, that cost Demjanjuk his citizenship, Rosenberg alleged that 'Ivan' personally murdered his two cousins - a charge he oddly left out of his Dec. 1947 affidavit.

2) **Pinchas Epstein**, who agreed with Rosenberg's identification, also submitted an affidavit in 1947 and never even mentioned the existence of any 'Ivan'.

3) Several Polish survivors, shown the same photographs of Demjanjuk deny they are those of the man known as "Ivan The Terrible." They were never allowed to testify at the Cleveland deportation hearing nor will the communist government of Poland allow them to travel to Israel to testify in Demjanjuk's behalf.

4) **Kurt Franz**, presently still in prison as a leader of the Treblinka guards says there never was any "Ivan The Terrible" and the only Ivan he knew was about age 40 with grey hair. Demjanjuk was 22 at the time.

5) **Jean-Francis Steiner**, author of the book "Treblinka" wrote in 1966 that 'Ivan' was knifed to death by Jewish inmates on Aug. 2, 1943.

6) **Avraham Goldfrab**, who died last year, wrote in detail how Jewish inmates stabbed 'Ivan' and threw his body into a fire. Some five books have been written about Treblinka by survivors and while they all tell different stories about the camp all agree that 'Ivan' was killed.

7) **The OSI** interviewed 17 Treblinka survivors and 12 could not identify Demjanjuk from his photographs. Some could not even remember any one known as "Ivan The Terrible" at the camp.

In brief, as many Treblinka survivors claim 'Ivan' was killed in 1943 as say he survived the war. And the number who do not identify Demjanjuk as 'Ivan' far exceed the number who do. Upon such testimony, should this man be sent to his death?

Is the KGB card a forgery?

Consider:

First, one expert who examined the card found that an "umlaut" was missing on a word on the ID card. Also the card used, instead of a separation letter, a combination of letters not common in German until about 1960 is found.

Second, the former paymaster at Treblinka claims he never saw a card like this at the camp: "Missing is the date of issue, missing is the place of issue, missing is the officer's signature."

Third, the photograph of Demjanjuk on the card has been tampered with; parts are blocked out. Demjanjuk is wearing a Russian tunic. (Would the Germans allow one of their guards to wear Russian army clothing?)

Fourth, the photograph was obviously stapled to some other document before being placed on the card.

Fifth, the seals on the card are misaligned-as though separate documents were put together.

Sixth, the ID card gives Demjanjuk's height as roughly 5 feet 9, he is actually 6 feet 1. Would the Germans make such an error?

Seventh, we have no ID card - the Soviets have only provided a photostatic copy to the OSI. The original card was taken back to Moscow. They will not allow it to be used as "evidence" at the trial in Israel.

Other questions arise.

It is plausible that this 22 year old Ukrainian conscript, captured in the Crimea in May, 1942, could have become, within a few months, the legendary monster at Treblinka, 1,000 kilometers away, operating a vast system of gas chambers?

"News From the Ukrainians" is the communist publication the KGB used in an effort to frame another Ukrainian American, Ivan Stebelsky of Denver as a Nazi war criminal. IT IS THIS PUBLICATION WHICH FIRST CHARGED DEMJANJUK!

The OSI assigned Norman Moscowitz to the Demjanjuk case. He cabled Moscow (Russia) to ask if the Soviets had any records of Treblinka. Did any mention a man named Ivan Demjanjuk?

By an incredible coincidence, not only did the Soviet Union have the old forgotten files of Treblinka but they just happened to find a training camp card of the very Ivan Demjanjuk Moscowitz wanted -AND IT HAD DEMJANJUK'S PHOTO ON IT!

Thus far, the Soviets have refused to turn over the original card to Israel for the prosecution of Demjanjuk. Why? Unless the card is a KGB forgery that would blow the 7-year Demjanjuk case to smithereens - and turn press attention upon those who forged it, and those taken in by it.

In the last nine years, John Demjanjuk's life has been utterly, totally, destroyed. He has been humiliated, disgraced, vilified as virtually no other American of his time' bankrupted, imprisoned, extradited to stand trial in the same cage as Adolf Eichmann. A stigma has been placed on his family and name forever. He is going down in history as one of the great sadistic monsters of the greatest mass atrocity in human history. If John Demjanjuk is "Ivan The Terrible" he deserves it all. If not he is not, then - in this writer's judgement - John Demjanjuk may be the victim of an American Dreyfus case.

The North Carolina trial of White Patriot Party leaders Glenn Miller and Steve Miller will go down as one of the most outrageous miscarriages of justice in history. This entire trial is the result of a scandalous conspiracy between a so-called "Reagan conservative Justice Dept.," and the radical left-wing Morris Dees, of the Southern Poverty Law Center in Montgomery, Ala.

1) Glenn Miller and Steve Miller were only charged with a minor contempt of court citation for allegedly violating an agreement settling an earlier harassment suit filed by Morris Dees. Glenn Miller agreed not to operate any secret paramilitary group.

BUT, during the trial they were accused of stock piling illegal weapons and plotting to overthrow the government!

2) These charges are felonies and require Grand Jury hearings and a legal arraignment. They were denied these legal protections and charged with contempt of court, (a minor misdemeanor!)

3) The Reagan Justice Dept. brought in FBI agents from around the country who brazenly lied under oath alleging the two were connected with The Order organization in Seattle, Wash.

4) Morris Dees filed the original suit against Miller and has viciously attacked him in his newspaper. Why was Dees appointed by the Reagan Justice Dept., as a Special Federal Prosecutor in a case in which he had both political and financial interests at stake?

Millers Not Charged With Evidence Presented!

Your editor (Dr. Fields), attended the trial and has first hand knowledge on what occurred. The two main witnesses used against the Millers are both criminals currently in prison.

Robert Jones testified for the government that he sold Glenn Miller "heavy duty" explosives including dynamite, 200 pounds of C-4 plastic explosives, mines, rockets, hand grenades, anti-tank missiles and automatic weapons. (No one has ever found such weapons.) He swore Glenn paid him \$50,000 in cash!

Jones is an admitted drug dealer and is in prison now for stealing guns. When first arrested by the FBI he was given a lie detector test about these accusations against Miller. Jones failed the test and was told by the FBI agent in charge that he was a LIAR! Jones was promised a transfer to a better prison and protection for his testimony. The Reagan Justice Dept. knew all along that Jones was lying. YET JONES WAS STILL USED TO DELIBERATELY FRAME MILLER.

Former U.S. Army Captain William Roberson, Jr., testified that he knew about Jones dealings in the sale of arms but said none involved "illegal explosives or automatic weapons."

Glenn Miller testified that he never in his life ever met Jones nor ever had any \$50,000 to give him.

A Convicted Murderer Testifies For Dees

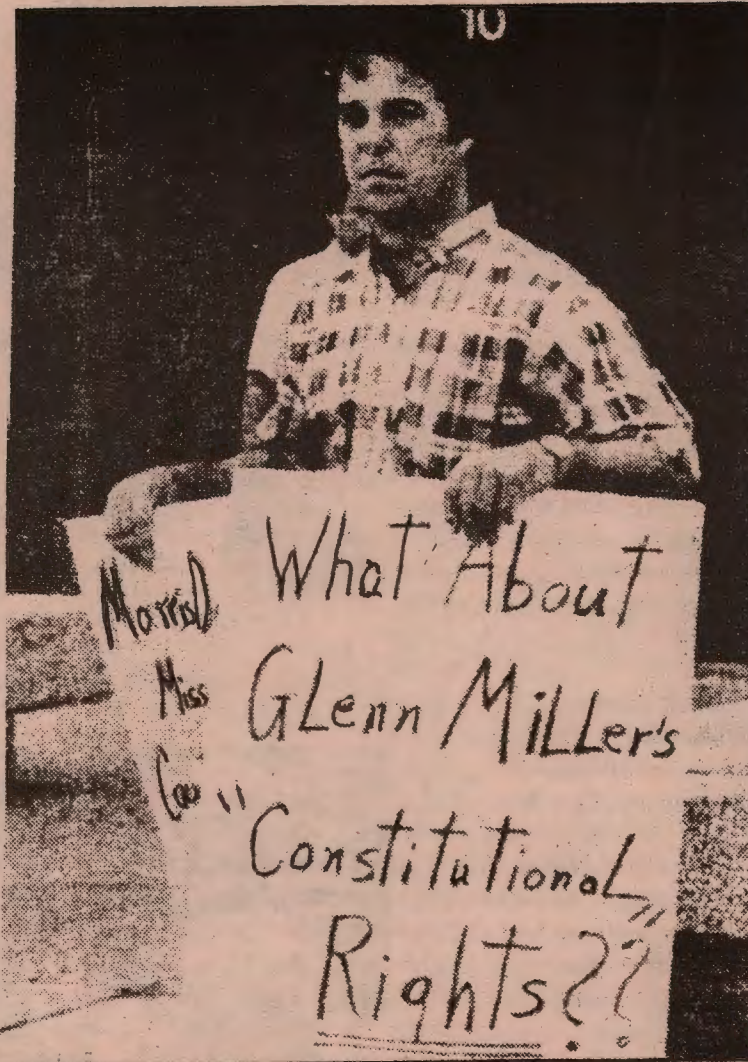
James Holder testified that Glenn Miller sought the "overthrow of the U.S. Government." He claimed WPP members were trained in hand-to-hand combat and river crossings. Holder is presently in prison convicted of a murder which took place in his hometown of Sanford, N.C. in Nov. 1983.

Glenn testified their training was strictly for self-defense and mainly target practice. He said one political goal was the establishment of an independent White Southern Nation.

Dees Uses Mentally Limited Prosecutor

Samuel T. Currin is the U.S. Attorney for the Eastern District of N.C. He claims to be a "conservative" and was once an office aide to Sen. Jesse Helms. In fact it was Helms who got him this job. A number of political leaders opposed his appointment, one stating Currin has a "third rate mind!" Indeed, he was not the real prosecutor in the case and had little to say. He seemed slow and dim-witted. The show was really run by Morris Dees.

Dees should never have been appointed a federal prosecutor because he had a FINANCIAL INTEREST in the outcome of this case. Dees mailed out two fund raising letters asking for money to help him prosecute the Millers when in fact the Reagan

FBI Agents Twisted Story

Butte, Montana has an FBI office where agents are sent who are deemed inefficient or in need of "chastisement" for not doing their job correctly. From this office came FBI agent Donald R. Wofford. He said, "Glenn's organization was like the group in The Turner Dairies. A TOTAL UNTRUTH AS KNOWN BY ANYONE WHO HAS READ THE DIARIES."

RALEIGH — The trial of White Patriot Party leader Glenn Miller on criminal contempt charges opened in U.S. District Court today as picketers supporting Miller handed out leaflets in front of the courthouse.

"We're concerned because Glenn Miller hasn't been indicted, hasn't been charged with any crime, yet he's on trial," said E.R. Fields of Marietta, Ga. Fields supports Miller.

Three jurors told U.S. District Judge Earl Britt they had been given leaflets by the pickets outside, and two said they had "skimmed" the handbills. The leaflets attack Morris Dees, the director of the Southern Poverty Law Center in Montgomery, Ala., which petitioned for the contempt charges.

Britt told the jurors to disregard anything they had read and ordered them not to accept any more handbills.

"It's my opinion that this will be more harmful to your effort than beneficial," Britt told Miller. The judge urged Miller to have the picketers leave.

Constitution Upheld

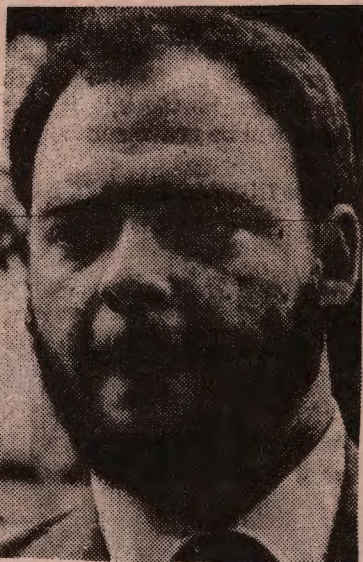
Even Liberal Press Opposes Miller "Gag"

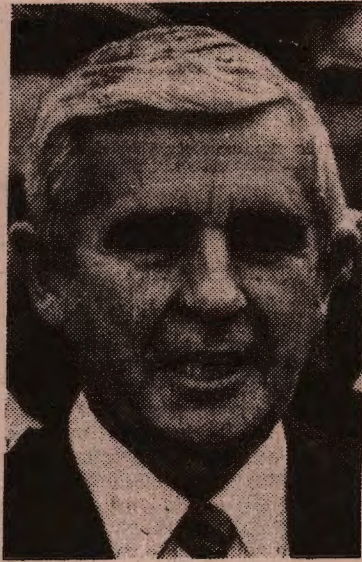

Horror

Lemberg was the first of the many places where, during their advance, the German troops came across the terrible traces of the Ogo

She still cannot realize that these fearfully mangled bodies, which she managed to identify by the fragments of clothing, were her relations

This group was made up mainly of non-German Europeans and Ukrainians. They collected statements from over 200 witnesses who all accused the Soviets of the crime.

When the war ended Moscow newspaper "Isvestia" and the Red East German newspaper, "Neue Zeit" charged that "Nachtigall", a Ukrainian battalion which fought the Soviets under the command of German officer Theodor Oberlaender, were responsible for the slaughter at Lemberg. They published KGB documents which were supposed to "prove" the guilt of Prof. Oberlaender. Even the West German magazine "Der Spiegel" and "Rheinischer Merkur" repeated the communist slander!

Professor Demands Investigation of Himself

Prof. Oberlaender then came forward and sought to distribute the 1941 brochure exposing the mass slaughter of innocents by the Reds in the Ukrainian and especially at Lemberg. Believe it or not, the Socialist Party head, Carlo Schmid, then acting President of West Germany, ordered distribution of the 1941 brochure banned as "Nazi

propaganda!" Both East and West German leaders wanted the issue dropped and the Soviets stated they would not demand a war crimes trial for Prof. Oberlaender.

To the surprise of all Prof. Oberlaender demanded that he be investigated! A new Board was established which took statements from 232 witnesses, mostly Ukrainians and Poles from Lemberg, who now live in the West. The Board came to the unequivocal conclusion that the Soviets and not the Germans were guilty of the atrocities committed in the Ukraine stating in part:

Soviet Mass Murder Proven

"The accusations against the battalion 'Nachtigall' and Prof. Oberlaender lack every foundation...Immediately after the Nazi campaign against the Soviet Union, on June 22, 1941, the security agents of the Soviet secret police, NKVD, (Today the KGB) started with the imprisonment of elements in western areas that were, to their minds, untrustworthy. Thousands of people of numerous nationalities were deported or imprisoned. When the transport department broke down and it became impossible to ship the prisoners to inner Russia and Siberia, the commanders of the NKVD were instructed by radio to release the criminal prisoners and to liquidate the political prisoners.

In the Ukraine, and as such in Lemberg, the NKVD groups were responsible to the General Secretary of the communist party in the Ukraine, Nikita Khrushchev (later to become dictator of Russia). The commanders of the NKVD received the instructions to liquidate the political prisoners from Khrushchev, who resided in Kiev. He personally, by radio, on June 24, 1941 ordered the mass murder."

"Upon this order, a massacre followed in the overfilled prisons of Lemberg and all West Ukrainian districts. According to the trustworthy findings of the American 'Kerstern-Ausschuss', at least 80,000 to 100,000 people were murdered in the Ukraine by the special commandos of the NKVD troops. Responsible commander was the Gen. Secy., Nikita Khrushchev."

Study The Pictures Closely

Additional proof that these pictures were taken in Lemberg (and not Poland) is that Ukrainian refugees in the West were able to identify some of the people's faces in these

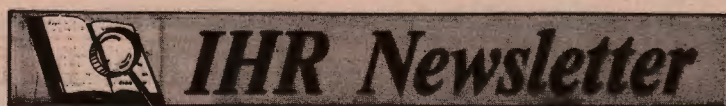

WARNING ANTI-RAPE WEAPONS

A SCOTLAND YARD booklet warning against the carrying of handbag arsenals by women to defend themselves against sexual attack, was condemned yesterday by the leading women's campaign against

rape.

The 20-page free booklet, "Positive Steps," which has incensed Women Against Rape warns that women must not carry knives and sharpens combs in handbags because they are offensive weapons and against the law.

Hairsprays, umbrellas and car keys, however, can be used legally as a means of self-protection because they are considered normal items which women may have to carry. Women are also encouraged to carry personal alarms.

But a spokesman for Women Against Rape said: "Umbrellas or hairsprays may be the least effective defence. Women will and do decide what they will carry with them. It may be their life that is at stake."

"We conducted a survey in London and 90 per cent of women, said they felt they should be allowed to carry such so-called offensive weapons. They wouldn't do so if they weren't frightened."

The booklet follows a Home Office survey showing a growing number of reported rapes. In 1984, there were 1,433, an increase of more than a third on 10 years previously and the number is rising.

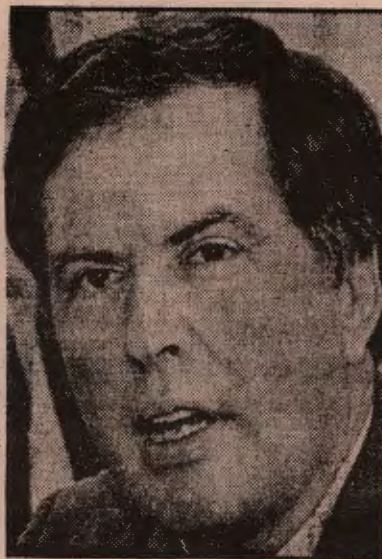
Ted Kennedy News
