3,000 White Patriots March In Forsyth



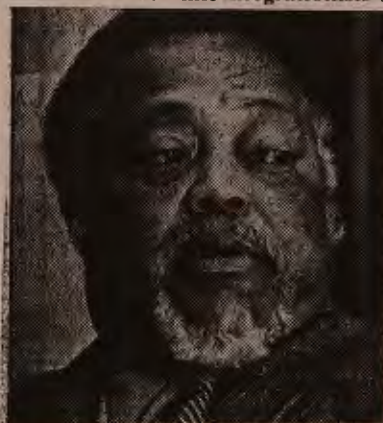

Huge White Forsyth County Victory 3,000 Whites March For White People's Rights

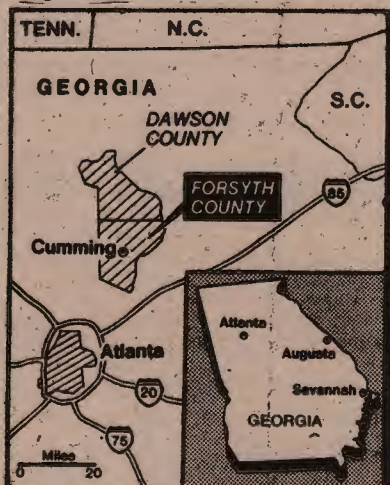
The News Media from throughout the world descended on Forsyth County, Ga. They came to broadcast the story of the biggest integrationist march in two decades led by old time radicals, Rev. Hosea Williams, Coretta Scott King, and Rev. Joseph Lowery. The big shock to the liberal TV crews was the huge number of White counterdemonstrators who turned out. This proved we are not going to be overrun by communists, race-mixers, black power advocates and their cowardly puppet politicians now in office who have totally surrendered to their outrageous demands.

It was an historic day, Saturday, Jan. 24, 1987 when the sun rose over snow covered Forsyth County. White people gathered early to "greet" the onslaught of some 15,000 left-wing integrationists, which included the Revolutionary Communist Party, Atlanta Gay Men's Chorus, Gary Hart for President Committee members, NAACP, SCLC, etc. etc. The White counterdemonstrators heckled the radical invaders, waved protect signs and Confederate flags. The White crowd grew along the highway across from the shopping center taken over by the racially mixed radicals as they began their invasion of this quiet, peaceful, nearly crime free community.

It was then that David Duke, of the New Orleans based National Association for The Advancement of White People (NAAWP) stepped forward. He heard shouts of, "why can't we march too?" Thus Duke said, "O.K. - follow me!" Down the street he walked and an estimated 3,000 Whites fell in line behind him! The left-wing news media were shocked. Whites flocked into the street as the march headed off toward the courthouse. There were so many thousands of White people that no end of the line could be seen!

Youths Majority Of The Counterdemonstrators

When the White Patriotic marchers reached the courthouse the entire street was jammed with people. David Duke addressed the crowd briefly, until he was stopped by a GBI agent. Then a man came up and told Duke he could lead the people to a nearby parking lot for a meeting. There he spoke from the back of a truck about what a great march this had been which has proven to the entire world that the White Movement is alive and growing. Others who spoke at this meeting were Don Black of Birmingham, Frank Shirley of Cumming, Ga., Attorney Richard Barrett of Jackson, Miss., and your editor, Dr. Fields.

The biggest surprise to the liberal media which they reported over and over again was the fact that a majority of the White counterdemonstrators were in their teens and twenties. For years the ultra-liberals have claimed the Segregationist movement was made up only of older people and after they died race-mixing would be accepted by all. The White resistance movement in Forsyth has fired a shot heard around the world. It proves beyond a shadow of a doubt that more and more youths, both North and South, are accepting the premise that Preservation of the White race is the most vital issue of the hour. This is a good and healthy trend which should encourage more and more White people to rise up out of the masses and join the ranks of the elite and enlightened.

Special Rights For Blacks Are Denied Whites

Grand Dragon of the Invisible Empire, Ed Stephens, applied for a permit to hold a march in College Park, Ga. He was told by the mayor that the Klan could not march unless they paid for the police security in the amount of \$3,000! Thus the march was cancelled after Gov. Joe Frank Harris said the state would not pay it. (NOTE: Gov. Harris sought the votes of the KKK when he

was in a tight race for Governor with Rep. Bo Ginn in 1982. Today he has totally turned his back on those White Patriots who elected him.)

The cost of Hosea Williams' "Brotherhood" March is now estimated at OVER \$1 MILLION! The press stated Gov. Harris didn't blink an eye in approving this expenditure. Does anyone think the bill will ever be sent to Hosea Williams?

Gov. Harris said he wouldn't participate in the march because it would be "grandstanding." It was a disgrace for Georgia when the phony "Conservative" Sen. Sam Nunn was there with the left-wing Sen. Wyche Fowler to greet the radical marchers. Sen. Gary Hart, a presidential candidate for the far-left faction of the Democratic Party, was one of the leaders of the march. White American voters will long remember this sell-out of the interests of White people and if either of these political prostitutes, Nunn or Hart, receive the Democratic nomination for President **THEY WILL BE DEFEATED!**

Conspiracy To Frame David Duke

GBI Agents asked David Duke, Don Black and Frank Shirley if they would like to step through the police line to discuss with GBI officials whether they could hold a rally on the opposite side of the Forsyth County Courthouse from the black rally. They agreed and stepped into a trap. After they passed under the police line the three White Patriots were told they were under arrest! They were handcuffed and taken away at 1 p.m. in the afternoon.

Two White counterdemonstrators shouted protests against the arrests. A flying wedge of GBI agents charged into the crowd and grabbed them. One was Jerry Brown, 26, and a paraplegic. He was knocked out of his wheel chair and hauled away with another man who objected. **BOTH WERE CHARGED WITH INCITING TO RIOT!**

It should be stressed that David Duke, over and over again, requested that all White counterdemonstrators act in a peaceful manner and not break the law in any way. The only violence your editor witnessed was on the part of the GBI. They looked like the communist secret police in Poland attacking members of the Solidarity Workers Union.

Secret Police Dirty Tricks

WSB Radio "Soundoff Talk Show", late in the night of Jan. 24, told of the arrests of David Duke and 56 White counterdemonstrators. A caller stated that he monitored police radio calls during the day and caught a GBI order to, "arrest David Duke on any charge at hand to get him off the streets."

"The Atlanta Journal", Jan. 25 in an article by Mike Christensen, on page 14 stated: "The (civil rights) march started down Old Buford Rd., behind a curtain of state troopers and Guardsmen. By then, GBI agents had tried to pull the sting from the courthouse protesters by singling out and arresting several White supremacist leaders who had been haranguing the crowd through bullhorns. Arrested were David Duke, Don Black and Frank Shirley."

Your editor, (Dr. Fields), later went to the jail to help bond the three out. We were told they had been arrested for parading without a permit and blocking a highway in a 30 minute march. Of course, it was alright for the pro-race-mixing demonstrators to parade and block a highway for over three hours! This embarrassing question forced the authorities to change the charge against Duke, Black and Shirley to "obstruction of a highway and reckless conduct." They were released on a \$2 thousand bond each at 11 p.m.

Inhumane Treatment of Duke, Black and Shirley

David Duke, Don Black and Frank Shirley were taken to an open air pen by GBI agents behind the county jail. It was surrounded by soldiers watching them at all times through the barbed wire fence. They were told the jail was already filled with other political prisoners. They were held standing in mud and snow in the freezing cold for over 7 hours! There was no bench for them to sit on - **THEY HAD TO STAND AT ALL TIMES!**

Some who fell were left lying in the snow until other prisoners held them up. When supper time arrived they were given a plain hot dog with nothing to drink. Finally, at 9 p.m., totally exhausted, they were allowed into a jail cell (which felt like heaven after 7 hours of forced standing in the snow.) Now they were interrogated and finally were the last to be bonded out at 11:30 p.m. Could conditions be much worse in the KGB jails of the Gulag prison system in Russia!

Black Students Score Lower In SAT Tests

Scholastic Aptitude Test given by the Southern Regional Education Board found that Atlanta area White schools scored some 300 points higher than black schools. Sandy Springs Riverwood High, White pupils scored 984 on the SAT. That is 78 points higher than the national average of 906. In the same county (Fulton) an all black school, Lakeshore High, scored 327 points lower for an average score of 657.

In Atlanta, the half-White school of Northside High scored 843 while the all black Price High pulled a score of 532. This compares interestingly with the difference between the highest and lowest scoring schools in the nearly all-White Gwinnett County school district. The difference



Don Black addresses the people between the highest and lowest scoring White schools was only 62 points. In DeKalb county the average score in a mixed school was 649 while mostly White Lakeside High scored 957.

Mark Musick, director of the SAT testing said: "Basically you can translate that into black and white. Those scores generally trace the racial makeup of the school."

Maddox scorches marchers

Former Gov. Lester Maddox, who rose to political power as a staunch segregationist during the mid-1960s, called today's Forsyth County civil rights marchers racial agitators who are "socialists and anti-capitalists."

"Those racial agitators were up there (last Saturday) just for the purpose of creating racial strife," said Maddox in an interview Friday. "They got what they went after, unfortunately."

Maddox, 71, now lives in east Cobb. He has gotten away from the city of Atlanta where he became a nationally recognized opponent to integration during the racially torn 1960s.

Maddox was an obscure but feisty local restaurateur when he wielded a pick handle to drive blacks from his business. After his election as governor in 1966, Maddox became a national symbol of segregation.

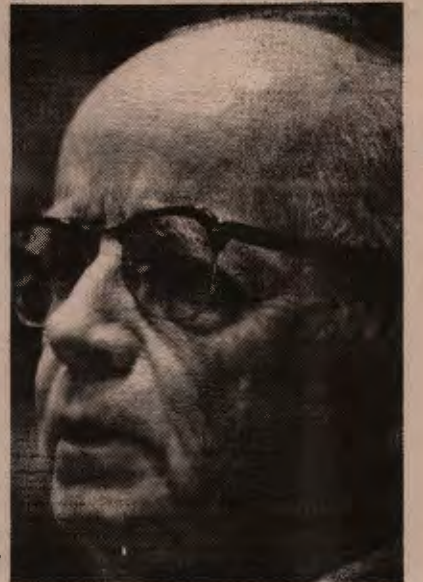
"I'm not surprised to see Gary Hart, Dick Gregory and a various assortment of draft card burners marching in and invading Forsyth County as they plan on Saturday," he said.

"They can't stand to find peace and tranquility anywhere," he said. "They have to go in and destroy it."

Maddox accused one of the key civil rights groups sponsoring last Saturday's march, the Southern Christian Leadership Conference, of being a front for anti-democratic elements.

"I know them to be socialists and anti-capitalists," said the former governor. "That puts them in the category of being anti-private enterprise and anti-Americans. There's nothing Christian about the group."

To back up his claim, Maddox pointed to Nicaraguan President

Daniel Ortega's visit to Atlanta some months ago at the invitation of SCLC President Joseph Lowery.

"Lowery brought Ortega up here to denounce our country. Lowery wants to make Atlanta the Third World capital of the world," he said.

Maddox said Forsyth County residents are being unfairly portrayed as bigots.

"We can't punish people in 1987 for what happened in 1912 — how stupid. The people of Forsyth County were born white in a white county. We must have 1,000 white counties in this country. Are they going to invade them all?" he asked.

Forsyth Reenactment of Civil War
Flanking Tactics Defeat Integrationists

Civil War battle reenactments are growing in popularity and can be witnessed near many of our National Battle Field Parks. Forsyth County, Georgia held a very successful simulation of such events on Jan. 17, 1987. This was the occasion of a "Brotherhood March" by blacks and leftists led by Rev. Hosea Williams. They were going to integrate Forsyth whether the local residents liked it or not.

Rev. Hosea Williams' SCLC and NAACP have fallen on hard times financially. Thus Hosea decided to bring a bus load of Negroes up to Forsyth County to cause trouble and disorder. "The Committee to Keep Forsyth County White" scheduled a rally at the beginning point of the route Hosea was to march. He could easily have avoided the area where the White people had gathered for their counterprotest rally. But no, Hosea demanded the bus stop directly in front of the White rally. Here is where the trouble began. (Note: all photos were taken by Dr. Fields.)



Rev. Hosea Williams arrives and sees the Confederate forces. Defying common sense he orders the bus to stop right in front of the Confederate lines. The integrationists get off the bus to rub the noses of the Confederates in the race-mixing slime. The march, including interracial couples, begins.



Confederate supporters gather carrying their flags and protest signs to the front defense position. Most of the protesters are youths in their teens and twenties.



Now comes the Confederate counterattack. Shot and shell crack through the air. Here we see Rev. Williams (looking backwards) doing a quick side step jig as a missile crashes at his feet. Even your editor had to keep his head down to escape the shrapnel in order to bring you these close up action shots!



Confederate forces display their flags and a huge banner declaring "Abolish The King Holiday." The integrationist invasion troops of Rev. Williams deliberately chose the weekend of the King holiday to grab national headlines. The news media was there in large numbers.



Next the Confederate forces charge down the line on both sides of the Brotherhood Bus. Battle flags flying the troops swing in front of the bus. The marchers are walking in front of the bus. They are outnumbered and a very worried group who now realize their leader Hosea has marched them right into a trap!



All is quiet along the lines with Confederate battle flags waving and protest signs in hand. The integrationist invaders of Hosea Williams were 45 minutes late and many counterdemonstrators feared they might not show up at all.



The Brotherhood Bus is now surrounded by Confederate forces. They have been outflanked and cut off from the rear. The white helmets in front of the bus are the last line of police taking a defensive position. The integrationist invaders wisely decide to surrender and return to safety aboard the bus. A truce is called and the Confederates graciously agree to allow the Hosea Williams forces to retreat back to their base in the ghettos of South Atlanta.

Another victory for Confederate forces fires a shot heard around the world that the White people's resistance movement is alive and well!

Demands Millions From Forsyth

Blacks Plan Land Grab in Forsyth County

Cumming, Ga., the county seat of Forsyth, found Mayor Henry Gravitt and local banker Roger Crow actually welcoming the integrationist marchers to town. They had shocked looks on their faces when Rev. Joseph Lowery, head of the SCLC, turned to them and said: "In 1912, black people ran off and left their land in Forsyth County. I believe that if you mean what you say, then let's give those people money and compensate them."

The following day Lowery outlined his plans with a well known pro-communist lawyer at his side. The attorney is Brian Spears, head of the Georgia branch of the National Lawyers Guild. The Guild was cited by the U.S. House Committee on Un-American Activities as a Communist front. Spears also has represented homosexual "Gay Bath-houses" where anonymous acts of sex perversion are performed. Spears has fought attempts by the state to close such bathhouses as a threat to public health due to the AIDS epidemic. Spears also is a close legal associate of the notorious bi-sexual lawyer Morris Dees of Montgomery, Ala. This is the sort of team Rev. Lowery has lined up to file land grab suits against property owners in Forsyth County.

"Give Them An Inch and They Will Demand A Mile"

When the foolish Cumming "city fathers" welcomed this armed invasion and cooperated with them, little did they realize a Pandora's box had been opened to threaten local home owners. Rev. Lowery and Hosea Williams say they are going to sue Forsyth County for alleged, "injustices of the present and past" including lawsuits attacking job and housing discrimination, and most important of all suits for land they claim was abandoned in 1912.

That was the year three blacks raped and tortured a White girl, named Mae Crow, age 18. She lived long enough to identify her attackers. Outraged Whites took one of the blacks out of the jail and hanged him. The other two were tried and given a public hanging before over 10,000 local citizens. After that Whites

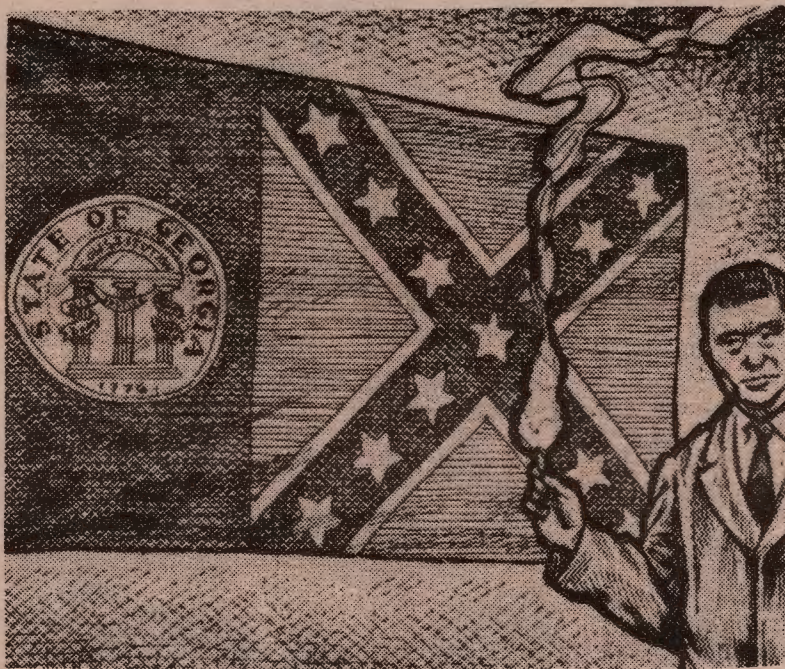

gave the 1,000 blacks living in the county notice to move out. All quickly packed up and left and no black has ever returned to Forsyth County.

Still blacks can work and travel through the county as long as they leave by sundown. This long standing policy, (75 years), has made Forsyth one of the most peaceful, law abiding, crime free counties in the South. Here is a beautiful land with rolling hills, forests, a grand front on Lake Lanier - it is a heavenly place Whites from many distant areas move to so they can live quiet, pleasant lives with their own kind of people in a healthy atmosphere.

Radical black agitators and communists do not want to allow these White people the right to live in peace. The Marxist lawyer, Brian Spears, told the press that he would file suits to obtain "compensation for displaced black families." He said they will have to be "creative," (tricky) to win lawsuits on behalf of the descendants of such blacks. Most Negroes at that time were tenant farmers and did not own the land they lived on. Others were servants of Whites. There is no telling what kind of devilry Spears will come up with in filing suits against White people who have long owned their homes and farms. It will also effect those who bought property in recent years which the blacks now claim is "rightfully" theirs.

Brian Spears says he can find it through examination of ancient tax records, (which should be burned now to stop such witch hunting!) Spears says he will seek volunteers from law students at Georgia State University in Atlanta, (where a majority of students are not from Georgia and many pro-communist organizations exist on campus.)

Would Ban Dixie-Flag

Rev. Lowery Wants Confederate Flag Banned
SCLC president Rev. Joseph Lowery is always demanding concessions from Whites. Recently he demanded that the Fort McPherson U.S. Army Band cease playing "Dixie." He also wants the state to remove the Confederate flag from the Georgia flag.

The Ft. McPherson band is one of the most famous military bands in America. Last Aug. 30th the band director announced a new tour beginning in Memphis with "Dixie" included in its repertoire. Rev. Lowery asked Lt. Gen. Theodore Jenes to ban the song stating:

"Playing Dixie is almost synonymous with the terror of racism, segregation and discrimination. Maybe

when there are no longer racism or racist practices, Dixie can be dusted off and played sometime on historic occasions. This song is a civil religion to Southerners holding on to a lost cause. It has been a rallying tune for segregationists and Ku Klux Klansmen."

When the band director refused to delete Dixie Rev. Lowery requested they also play M.L. King's favorite song, "We Shall Overcome." The band director rejected this demand and Lowery charged "he has added insult to injury."

Editor's Note: Historians tell us that Dixie was written in 1859 by Daniel D. Emmett of Ohio. The song was a favorite of both Pres. Abraham Lincoln and Confederate President Jefferson Davis. The tune remained popular in both the North and South during the Civil War!

Stone Mountain, Ga., is the historic site of the great monument to Gen. Robert E. Lee, Gen. Stonewall Jackson and Pres. Jefferson Davis. Unfortunately there is a Stone Mountain teacher, Thomas Malone, who backs Rev. Lowery's campaign to have the Confederate flag removed from the Georgia state flag. Segregationist Gov. Marvin Griffin, in 1956, had the Confederate flag made a part of the state flag.

Malone wrote the "Atlanta Constitution," that - "The Georgia State flag is a racist symbol that is an embarrassment to this state. As a high school teacher of Georgia History I have to teach my students the unfortunate facts about our state flag. The Confederate flag was chosen as part of Gov. Marvin Griffin's defiance against integration in 1956.

"This flag has been used by vicious, angry Whites who demonstrate their opposition to an integrated society. The message is loud and clear - the Confederate flag is a symbol of White supremacy. Why should this flag, which was only used during the five year existence of the Confederacy be our symbol today?"

"The Confederate flag can no more be separated from its racist connotations.

Symbols are powerful

Police Brutality Charged GBI In Forsyth

GBI Brutality In Forsyth

Many Georgians now refer to the GBI as the KGB because of their vicious and brutal treatment of White counterdemonstrators falsely arrested in Forsyth. Your editor didn't see Forsyth County police, or Cumming City police or members of the State Patrol mistreat anyone - BUT WE DID SEE MANY BRUTAL GBI ATTACKS ON INNOCENT PEOPLE!

On page 2, we reproduce an article from The Atlanta Journal of Jan. 26, by writers Charles Walston and John Brady. They describe the vicious arrests of two young men in two totally separate cases. They are much like those of the 56 others arrested on frivolous charges OR TOTAL FRAME-UP CHARGES!

Already described are the false arrests of David Duke, Don Black and Frank Shirley. Here are other cases witnessed by your editor. Jerry Barrett, 35, was watching the integrationists when yet another flying wedge of GBI agents charged into the crowd of Whites to arrest some innocent man. Apparently they bumped into Jerry and then just grabbed him too! He suffered a bruised and cut shoulder. He has long suffered from brain seizures from an earlier injury which is worse now. His little Daughter, Tiffney Barrett, age 9, ran after her daddy and was smashed in the face with a billy club wielded by a brutal GBI agent. Her face was bleeding as they dragged her father away. It looked as if the little girl's nose had been broken.

Other women in the crowd took Tiffney to the hospital. Someone called her grandmother and she rushed to the hospital. A black was brought in who had been hit by a brick. The elderly Mrs. Barrett was shoved aside and pushed out of the hospital to make way for the Negro. The GBI wanted to make sure no White person was in the hall while he was walking through.

More GBI Atrocities Against Whites

Angela Brown, 14, was also grabbed by a flying wedge GBI squad. One brutal GBI agent placed his knee in her back and pushed her face into the street curb as he used what is called "plastic nylon strip" to tie her arms tightly behind her back. This plastic strip cuts into the arms and is considered a very savage way to treat people.

Little Angela's arms were bent back so far her shoulders looked as if they were twisted out of socket. The use of plastic strip to tie people up like hogs should be outlawed! It is the most vicious thing we have ever witnessed. Can you imagine the outcry by black leaders if any of their people were treated so cruelly?

One of the real pug-uglies in this outrage was the GBI's so-called "Anti-Terrorist Squad" head, Bill "Frogface" Padgett. This despicable little creep is so ugly that he has gained the nickname "Frogface." Padgett personally took delight in binding Frank Shirley's arms so tight behind his back that circulation was cut off and his hands turned purple. Blood dripped from the wounds caused by the plastic strip. The strip cannot be unwrapped but must be cut off after the GBI agents get their victims to jail.

We are going to demand that the state legislature investigate the GBI as also requested by Atlanta Journal editor Jim Minter and House Speaker Rep. Tom Murphy. What we saw in Forsyth on the part of the GBI was COMMUNISM IN ACTION!

You do not have to go to Russia or Poland to view police barbarity. We have it right here in Georgia! We do not want nor need a secret police agency in Georgia. The State Patrol (Troopers) can take over any legal work of the GBI. This contemptible outfit is so corrupted it cannot be reformed. We call upon the Georgia State Legislature to investigate this situation and make sure such savage acts of violence by the GBI are never allowed to happen again. Vigilance is the price of liberty. Remember, this could happen in any state, so be on the alert. We praise young Dennis Ralston, 19, of Stockbridge, GA., who said (after similar treatment) "I got rights just like they got. If there are more marches I plan to attend...Next time I will be one of these people shouting."

Blacks Resist Convicting Their Own Kind

Why Blacks Should Not Serve On Juries

San Diego prosecutors thought they had an open and shut case. Negro Sagon Penn was stopped by officer Donovan Jacobs, 29, making an illegal U-turn in the all black suburb of Encanto. Penn, a martial-arts expert, wrestled Jacobs gun away from him and shot him. Then officer Thomas Riggs, 27, drove up and Penn shot and killed him. A civilian woman, Sarah Pina-Ruiz, 34, was in Riggs car. Penn shot and wounded her claiming he thought she was a police woman who might shoot at him. Penn then stole Jacobs patrol car and ran over Jacobs to try and "finish him off" before racing away. Penn confessed to all this but claimed it was "in self-defense because Jacobs was a racist cop out looking for trouble."

The death penalty was expected but this case was tried before an all-black jury! (Shades of the Reconstruction Era in the South!) Penn's lawyer, Milton Silverman, knew how to work this jury into a frenzy against "racist cops" charging both officers were "brutal racists." Penn, 24, had been in jail over a year, under a \$250,000 bond. The jury found him innocent on all counts. Penn walked out of the courthouse a free man. Silverman said, "justice has been done."

FBI's Secret Files On King Exposed

Exclusive: The Thunderbolt Looks Inside The Secret King Files

The FBI Wiretaps on Martin Luther King were sealed by a federal judge in 1977 until the year 2027 (50 years.) Many observers believe had these files been made public the King holiday would never have been approved. We now know that the tapes reveal King as being under the control of communist agents, addicted to alcohol, and sexual debauchery.

The Thunderbolt editors have been able to learn more about exactly what has been sealed in these files. There are 845 pages in length but there are some 64,000 other pages of FBI reports which have been heavily censored. They cover King's activities between 1963 and 1968. King's office and hotel rooms were "bugged" during this period by orders from then U.S. Attorney General Bobby Kennedy. This was after President John F. Kennedy told King in the Rose Garden of the White House, "Some of your associates are Communists. You've got to get rid of them."

The King holiday was approved by a Senate vote of 78 to 22. Sen. Jesse Helms said, "if its passage in the Senate had been by secret ballot it would not have received 20 votes."

It took the Congress 80 years to approve a holiday honoring George Washington, the father of our nation. The only other man so honored, King, will be exposed for what he really is in 40 years. Then shocked Americans will wonder why Congress ever voted for such an insane bill.

There is one entire volume in the secret King files labeled "obscene." Another is marked, "Top Secret - Communist Controlled."

King's Underground Red Contacts

King is revealed to be under the control of Soviet spy Stanley Levison who once was a Vice President of the American Jewish Congress. Levison worked under Victor Lessivsky, a top Soviet KGB official at the U.N. The late Congressman John Ashbrook of the Internal Security Committee stated:

"Lessivsky, until recently the personal assistant to the Secretary General of the United Nations, is one of the highest ranking KGB officers ever to serve in the United States. His relationship to Levison shows that the advisor to King remained under KGB control even after leaving the Communist Party financial operation."

The Soviets entrusted Levison to be the "paymaster" who slipped \$1 million a year to the U.S. Communist Party to underwrite their subversive operation. Levison advised King to call for Negro Thurgood Marshall to be appointed to the Supreme Court, advised King on his taxes, organizing, fund-raising and even wrote his speeches.

King Works For Communist Party

The wire taps quote King as telling Levison, "I am a Marxist." Levison directed King to hire Communist Party officer negro Hunter Pitts O'Dell as his executive assistant. It reveals King's continued association with Clarence Jones, King's secret contact with Levison.

Another file is entitled, "Communist Influence in Racial Matters/Internal Security - C-1."

This section reveals that King embezzled civil rights funds and placed them in foreign bank accounts. King promised his communist control agents that he would one day give them "a Soviet America."

FBI Director J. Edgar Hoover called King, "the most notorious liar in America" and "Martin Luther King is under communist discipline," also - "King has a numbered foreign bank account of over \$1 million."

King even spoke at a testimonial dinner for Communist Party vice-chairman Henry Winston. He denounced those who are anti-communist as "irrational and obsessive."

King spoke openly against the American war effort in Vietnam at an anti-war meeting in New York's Riverside Church. He attacked South Vietnam. King praised Communist North Vietnam as an innocent victim of American, "capitalism and imperialism." He warned that, "the deadly Western arrogance has made peaceful revolution impossible because capitalists refuse to give up their profits."

King A Hero

NEW YORK — Several hundred people celebrated the life of Dr. Martin Luther King, Jr. Sunday in a program at Unity Auditorium here that blended music, poetry and an address by James Steele, secretary of the Legislative and Political Action Committee of the Communist Party, USA. The program was sponsored by Black Liberation Journal.

"It is a great achievement for our nation to win King Day as a national holiday," said Jarvis Tyner, New York State chair of the Communist Party and the emcee of the program. "King believed in democracy and human progress and his death may have slowed the process but it did not stop it."

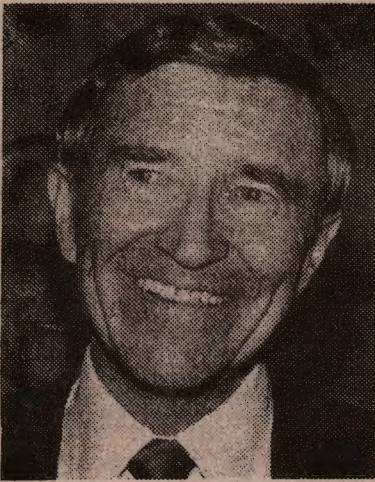
Arizona First State To Repeal King Holiday Other States Will Soon Follow

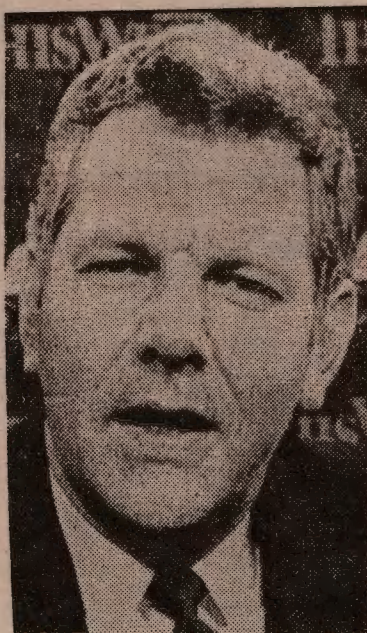
King Holiday Doomed

Why Forsyth Is White

CUMMING, Ga. (AP) — It was 75 years ago when Forsyth County whites forced more than 1,000 blacks to move from the county.

Today, Forsyth and neighboring Dawson remain the only Georgia counties with no black residents.

"The forces of violence that have kept Forsyth County the way it is are still in control," he said, "and the people here are apparently still satisfied with that."

Forsyth County, where the population has increased from 28,000 to about 35,000 since 1980, was home to more than 1,000 blacks in the autumn of 1912.

Old newspapers in Dahunega and Gainesville tell the events that began Sept. 8, 1912, the day when Mae Crow, an 18-year-old farm girl, was raped and murdered. Before she died, she named three black men, Ernest Knox, Ed Collins and Oscar Daniel as her assailants.

Collins was taken to jail in Cumming where a mob pushed past the state militia, pulled Collins onto the street, killed him and hung his mutilated body from a telephone pole. Knox and Daniel were taken to jails outside the county, tried and found guilty, and hanged Oct. 25, 1912, before a crowd of some 10,000 people.

The Dahunega Nugget newspaper reported: "The conduct of those Negroes in Forsyth County has caused the organization of White Caps, who have notified the blacks to move out, and where they acted slow about it their homes were destroyed."

Left-Wing Suits Against FBI Paid Off Big White Patriots Can Win Against GBI

Left-Wing groups have filed successful suits against the FBI for violating their First Amendment rights. In every case we have heard of to date they won large judgments. Since the people of Forsyth have been treated far worse than any Marxists there is no reason why we can't win large judgments also! Remember it is the jury which determines how much money you should be given.

The Socialist Workers Party sued the FBI for \$40 million. A jury handed down its verdict in August 1986 in New York granting the SWP \$264,000 in damages. The FBI used informers at a great cost to the taxpayers and burglarized the SWP headquarters. Still the FBI never found any evidence at all of illegal activity. This is one reason the Marxist group won their case.

Individual GBI Agents Can Be Sued

The Washington Peace Center was a left-wing group opposed to the Vietnam war. Five of its officers sued individual FBI agents accusing them of unlawfully "tarnishing their reputations, using paid informers, intimidation through FBI interviews, etc."

The original jury ruled in their behalf and granted damages totalling \$711,000. The FBI agents appealed and a higher court reduced the amount to \$50,000 plus

\$300,000 for their legal fees.

Again the chief issue was whether or not their First Amendment rights to free speech had been violated.

White Police Win Huge Verdict

A Chicago jury found that 13 White policemen had been discriminated against by black Mayor Harold Washington. They were awarded \$4 million by the jury - which is \$1.04 million more than they asked for. Mayor Washington was found guilty of "reverse discrimination" when he transferred these veteran police officers, holding prestigious positions, to insignificant posts. They were replaced by blacks.

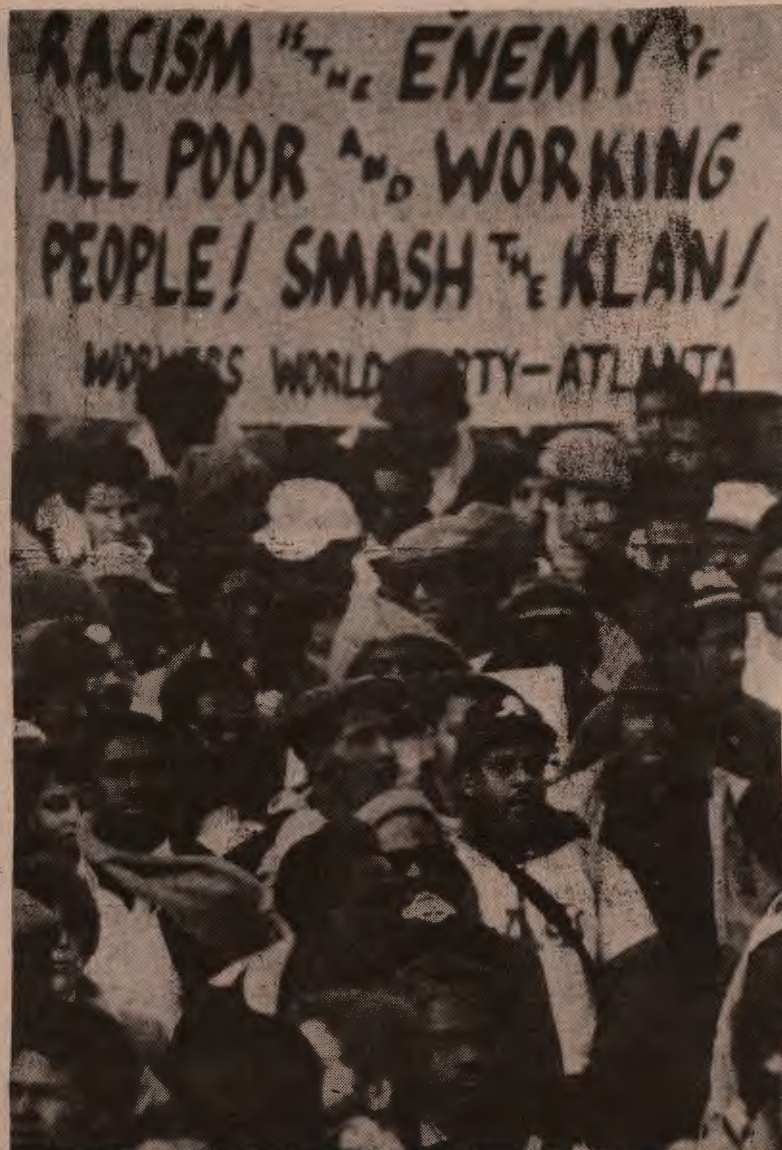
The transferred officers were called "political spies" "political hacks" and "racists"

by blacks working for Washington. It is of interest that the Jewish judge in this case, Judge Milton I. Shadur, later dismissed the judgment. The police officers have appealed, asking a higher court to reinstate their money.

"Atlanta Journal" Reports On Three False Arrests Made By GBI Of White Counterdemonstrators.

(Below from "Atlanta Journal" 1/29/87)

Two people who were arrested said Sunday that they had not planned to attend the demonstration.

Dennis Scarboro, a 17-year-old Forsyth County paving contractor, said he and his brother Virgil were going to a K mart store about 10:30 a.m. when GBI agents approached and asked to search Virgil, who was wearing overalls.

Virgil Scarboro, 27, was charged with carrying a concealed weapon because he had a pocket knife with a 2½-inch blade in his pocket, his brother said. "Everyone standing there probably had a pocket knife in their pocket," he said.

Scarboro said he went home but returned to the courthouse area around noon and began telling people about his brother's arrest. He was talking to a television crew, with about 75 people looking on, when two GBI agents approached and charged him with inciting to riot, Scarboro said.

He said he did not shout at any of the

marchers. "The closest I ever got to the march was when the GBI arrested me and dragged me through the march to the paddy wagon," he said.

Dennis Scott Ralston, 19, of Stockbridge said he was visiting a friend's sister in Forsyth County when he and his friend decided to attend the demonstration Saturday.

Ralston said he told some of the marchers to "go home," but did not use profane or provocative language. He said he began to leave when people near him began to throw stones but was pulled over by GBI agents and charged with carrying a concealed weapon, a hunting knife he had in his back pocket.

Ralston said he didn't regret going to the march. "I got rights just like they [the marchers] got," he said. He added that if there are more marches in Forsyth County, he might make it a point to attend. "I probably would after this, and I'd be one of the people shouting."

"It does get kind of cold out at times," said Greg Dilbeck, 21. "It's a nice jail. The food's pretty good. The people in Forsyth County were pretty nice to me."

Dilbeck, a Forsyth County native, was bonded out of jail early Thursday by a cousin who learned he was in jail by reading his name in the newspaper.

He said he had gone to Cumming on a bus with the brotherhood marchers but left the march once he got there. He said he was standing near the Confederate flag-waving hecklers on the town square when a police officer ordered the crowd to clear the streets. He said he stepped back onto the sidewalk but was arrested and later charged with obstruction of an officer.

Dilbeck said he didn't think his family would bail him out, so he didn't call them. A cousin posted bond for him about 3:30 a.m. Thurs-

day, he said.

Dilbeck said he did not participate in the chanting or rock and bottle throwing by counterdemonstrators and thought he would be found innocent of the charge against him because he didn't believe he had obstructed any officer.

"I didn't touch them. They said clear the streets, so I stepped on the sidewalk," he said.

Dilbeck said he thought he was locked up because police wanted a large number of arrests. Dilbeck also said he didn't think the marchers understood Forsyth County residents.

Noting that blacks often patronize the area of the county around Lake Lanier without incident, he said, "It's not a question of black or white, it's who you are." But, he added, "I don't know of many blacks who want to go to Forsyth County."

Rep. Tom Murphy Says GBI Is Like A "Gestapo"

GBI Framed Commissioner Hugh Hardison

Cedartown, Ga., is the home of Hugh Hardison who was our Public Safety Commissioner until last September. He was forced to resign after a vindictive investigation by the GBI into his sex life. GBI agent Robert Ingram questioned Faye Murdock about who paid the bills when she and Hardison took vacations together. She worked as a secretary for the State Patrol. Ingram promised her job protection in return for any derogatory information she could give on Hardison. (It should be noted that Hugh Hardison is single.)

GBI agent Sherry L. Norris questioned a female contractor who did business with the state. She asked whether female employees were sent to Hardison's apartment for sex and if she was also involved. The lady said the questions were ridiculous. Mr. Hardison, in resigning as Public Safety Commissioner said:

"The GBI's questions reached the point of accusing casual acquaintances of winning favors from the GSP in return for sexual favors...I would not have believed that the GBI would have stooped so low."

Georgia House Speaker On The GBI

Speaker of the Georgia House of Representatives, Rep. Tom Murphy, blasted the GBI stating:

"It appears to me that we have created a Gestapo in the form of the Georgia Bureau of Investigation (GBI) for the attorney general and Tom Perdue. It appears that no official is safe. If they don't like you, they can destroy you."

The Atlanta Journal's former editor, Jim Minter wrote on Sept. 7th:

"The GBI's fascination with romantic liaisons, which caused Atty. Gen. Bowers to catch himself in a public lie, normally would be associated with the National Enquirer, or something lower. The attorney general's sleuths failed dismally in attempts to paint the bachelor Hardison a rogue Don Juan..."

"Some day we appear to be dealing with the Gestapo, other days the Keystone Cops...Speaker Murphy's charges are serious, and deserve answers. Gov. Harris would serve the citizens of this state well by appointing independent counsel to determine if the GBI is, or is not, being manipulated for political purposes and punishments."

GBI Harrassed Foe of Georgia Power Co.

Atlanta Constitution writers David Morrison and Steve Ricks exposed the case in which GBI agents harassed members of an investigative group called *Campaign for a Prosperous Georgia*. Their purpose is to try and control runaway rate increases demanded by the Georgia Power utility. They plan increases of 50% in electric rates. The poor and elderly simply can't afford such hikes. Many people will suffer if their plans are approved.

Georgia Power is by far the most powerful lobby in the state. GBI agents followed, photographed and questioned officers of the group and told one man he should resign from the consumer organization. The organization has never been accused or even suspected of any criminal activity!

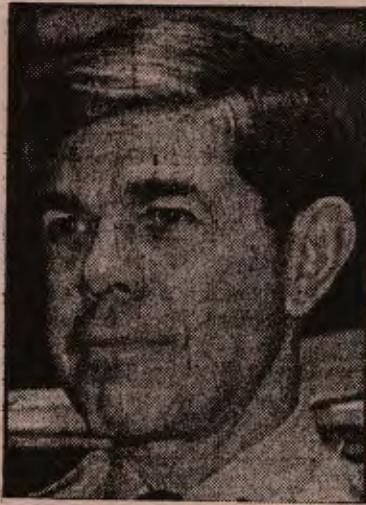

Keyvin Jones, age 13, is charged with the murder of Barrow County elementary school principal Murray O. Kennedy, who was married, and the father of two teen-age sons.
