

# Israel Behind Iran Arms Scandal

**Secret Arms Sale To Iran — An Israeli Plan — They Initiated It — Promoted The Scheme — Made Millions — Halted Release Of Our Hostages To Continue Arms Sales.**

The Iran Arms scandal is a puzzle which can only be understood by putting all the pieces together. The following news flashes taken as a whole tell the story.

The **New York Times** of April 1, 1986 reports Israel was involved in a multi-billion arms sale to the late Shah of Iran code named "Flower." This included surface-to-surface missiles which could be fitted with nuclear warheads. Iranians are not of Arab racial stock. They have long been at odds with their Arab neighbors. After the fall of the Shah in 1979 Israel continued "business as usual" with the Ayatollah.

President Jimmy Carter went into a rage when he learned that an Argentine plane was shot down along Russia's southern border returning from Iran after delivering another load of Israeli arms. American hostages seized at the U.S. Embassy in Teheran were being held captive at the time. Even Britain was betrayed by the Jews as they continued to sell arms to Argentina right through the Falkland Island war!

## How Israel Undermined U.S. Arms Embargo

The tiny state of Israel is one of the world's largest arms dealers earning over \$1 billion annually. While all nations have sought to bring about a peaceful settlement of the tragic Iran-Iraq war Israel has used every possible scheme to keep it going. The Jews totally wrecked and destabilized Lebanon with their invasion. Now they seek to permanently weaken all of the Arab states promoting the endless no-win Iran-Iraq war which has now claimed over one million lives!

Israel's top leaders came up with a trick to even have America violate its own embargo laws against arms sales to Iran. They sold leaders in the Reagan Administration the idea that hostages held by extremists in Lebanon could be freed by allowing Israel to sell U.S. arms to Iran! Thus the clever Jews automatically legitimized their own double-dealing with Iran.

## Israel's Arms Sales Never Stopped

The **Boston Globe** Oct. 1982, in a little noticed article, quoted then Israeli Ambassador to the U.S., Moshe Arens, saying: "Israel, in coordination with the U.S. at almost the highest levels has been supplying arms to Iran." The article goes on to say that government officials, Haig, Shultz, Weinberger and James Baker back in 1981 and 1982 all knew about such arms and not one dared to object.

**Washington Post** reporter Edward Walsh wrote: "The Senate Select Committee on Intelligence findings on the Iranian arms sales contradicts Israel's claim to have played a minor role in the affair. It portrays Israeli officials as key players in launching the initiative, keeping it alive through periods of growing skepticism in Washington and suggesting that funds from the sales be diverted to the Nicaraguan Contras."

**Admiral Poindexter** of the National Security Council told Pres. Reagan, "The Israelis are convinced that the Iranians are so desperate for military, expertise and intelligence that providing arms to Iran will result in favorable long-term changes in personnel and attitudes within the Iranian government. Israel will continue selling weapons to Iran as long as the U.S. provides assurances they could repurchase U.S. replenishments for what they sold."

## Pollard Spy Linked to Israeli Bonds

U.S. Court documents filed in the Pollard spy case reveal that he was first recruited by the wealthy New York stockbroker Steve Stern (Jew). Pollard was "discovered" by Stern who then made secret arrangements for him to meet Israeli Air Force Col. Aviam Sella. At the time Sella just happened to be a "student" at New York University. Stern is a fundraiser for the Israeli Bonds Organization.

The Jerusalem Post last summer said many insiders believed that Stern would eventually be indicted along with Pollard. For some reason this did not occur. The meeting between Stern and Sella on the recruiting of Pollard as a spy was held in a Manhattan synagogue during an Israel Bonds meeting. U.S. Justice Dept. records in the past have referred to Stern, not by name, but as "the unnamed associate!"

## Israeli Bonds Ripoff Insurance and Pension Funds

Canadian billionaire, and one of the richest men in the world, is William Belzberg who owns First City Trust. Some say he owns Canada! Along with his brothers, Samuel and Hyman they are into real estate, oil, gas development, and corporate takeovers of Christian owned companies. William Belzberg is National Chairman of the Israeli Bonds Organization.

The Jews first began selling these low interest bonds in 1951 and since that time have raised \$7.6 billion for Israel. Ordinary people do not buy these so-called "bonds." They are purchased by banks, pension funds and employee insurance funds. Professional Jew fund raisers like Steve Stern approach such Christian funds and explain that if they want to continue to do business with the Jewish community they must buy Israeli Bonds.

It is interesting to note that Jews have never promoted U.S. Bonds, but only Israeli bonds, which shows where their

loyalty really lies. Also, no other nation in the world is allowed to sell such bonds in the U.S. - only Israel enjoys this special privilege. Now that the Israeli Bond Organization has been officially tied in with the recruiting of Jewish spies in America that "special right" to sell bonds here should be revoked.

## Pollard In Iran Arms Scandal

**Jewish Week** of Jan. 2 reports that U.S. government documents filed against Pollard reveal that his control agent, Yosef Yague, the MOSSAD agent operating out of the New York Israeli consulate asked Pollard, "to work on potential Israeli arms sales to the Teheran regime. Israel at the time reportedly was deeply involved in trying to strengthen Iran's air-defense systems around Kharg Island their oil shipping base. This area was coming under heavy air attack from Iraq."

At the time of his arrest according to Justice Dept. documents, Pollard had just completed a letter to Yagur concerning the missile systems,

### Jews Sabotaged Their Own Plan To Free Hostages

Israel arranged for a huge arms shipment to Iran in Nov. 1985 which was supposed to bring about the release of all the hostages. But, the Jewish leaders and arms dealers knew if they were released there would be no need for further sales to Iran and a valuable source of easy money would be lost. Arms dealer Jacob Nimrodi came up with a cunning idea. They would ship the Iranians obsolete anti-aircraft missile parts which could not be used.

The Washington Times ran this headline: "Defective Arms Sank Hostage Deal."

For one brief moment Col. Oliver North stood on the verge of triumph. It was Nov. 1985. A ship loaded with arms sailed from the port of Talamone, Italy for the Israeli port of Ashdod. The cargo consisted of Hawk missiles. In Israel they were to be placed aboard a plane of the CIA airline, "Southern Air Transport" and flown to Iran. That night a team of Israeli MOSSAD agents switched the cargo and replaced it with obsolete and defective Hawk parts which was supposed to be junked.

In the meantime Col. North and Pres. Reagan in Washington were preparing to announce to the world they had secured the release of our hostages. The White House flew secretly to Wiesbaden, West Germany teams of doctors and intelligence experts to examine and debrief the freed hostages. They were told to expect them at any moment. Then they were told to wait!

In Iran, Col. North's contacts were furious. The Iranians rejected the junk shipment and in outrage denounced the Americans as tricksters and the hostage release was cancelled. The Israeli leaders shrugged their shoulders and lamely explained that some low level careless load-master must have switched the high quality U.S. Hawk missiles for the junk. The Iranians returned the shipment in Feb. 1986.

The Jews said the arms sales to Iran had to continue over a longer time period and in greater volume to make things right with the Iranians! They cared not one centillion about the endless sufferings of the hostages. Thus their ordeal has continued down through this very day! Arms shipments through scheming middle-men ended just a few months ago. The ordeal of the hostages drags on while a few Jews grow richer.

### "Israel Will Continue To Sell Arms To Iran"

The Chicago Tribune ran the above headline on Nov. 30, 1986 stating Jewish leaders would wait for, "the U. S. sideshow to end before reopening the pipeline. Israel will continue weapons sales to Iran. Israel will not allow the pursuit of their strategic objectives to be side-tracked (meaning the destabilization of all Arab states by helping to continue the Iran-Iraq war. Members of Israel's Foreign Security Committee spoke openly recently of the wisdom of selling arms to Iran to prolong the Gulf war and maintain the deep, debilitating rift in the Arab world over the conflict."

"Israel must continue to make decisions on its arms sales in light of its national interests," said committee member Pinhas Goldstein after a secret discussion of Israel's arms-sales policy toward Iran. "It happens to be in our interest for the Iran-Iraq war to continue!"

Hundreds of thousands of men, women and children have been exterminated in this senseless fighting yet the Jews insist it be continued!

### U.S. Arms Going To Iran

Israel holds the right to declare any U.S. weapon we have given them obsolete after a three year period. They then say they have the right to sell it to another country such as Iran whether or not Americans like it. The Jewish Lobby, (AIPAC), is so all powerful in Washington that few politicians dare to protest against the mischief and grief the Jews have created in the Middle East. If enough individual Americans understood these suppressed truths this tiny minority empowered only through great wealth could — BE STOPPED OVER NIGHT!

U. S. Attorney General Edwin Meese told the Senate Intelligence Committee that the Jews gave us three options, "One was for us to use Israel as a conduit for money to the Contras. The second was to use Israeli money. The third was to overcharge the Iranians and use the profits for the Contras. Col. North ultimately adopted the third plan."

Meese also said the U.S. released some \$12 million in weapons for Jewish middle-man (arms dealers) to sell to Iran for a profit of \$40 to \$50 million. The Jews promised to place the money in Swiss bank accounts from which the Contras could make withdrawals. It still has not been revealed exactly what the Jews did with the money. Most accounts state the Jewish middle-men, (money changers), skimmed off most of it. Meese reported that it was Amiram Nir, aide to then Israeli Prime Minister Peres, who first suggested to White House officials that profits from arms sales to Iran could be secretly funneled to the Contras.

The first plan to sell arms to Iran to free American hostages held in Lebanon came from David Kimche, Israel's expert on terrorism, in July 1985. He approached then National Security Adviser Robert McFarlane with the plan which was approved. The first U.S. arms for hostages shipment to Iran took place in September, 1985.

### Portrait of A Jewish Arms Dealer

The Washington Post, Jan. 1, 1987 reported; "Israeli arms merchants secretly have been selling weaponry and spare parts to Tehran in violations of a U.S. embargo for several years."

The Wall Street Journal stated, "One suspects that the middlemen in the deals on both Iran and Nicaragua may have skimmed off the fat fees customary in the murky world of international arms traffic."

The Washington Times reports that then Israeli Prime Minister Peres told his partners to push U.S. arms sales to Iran he added; "handle this for Israel's interests and pick up any money to be made."

The Washington Post of Dec. 12, 1986, reported, "Seven million in Israeli spare parts and military hardware were sold to Iran in 1985 by Israeli middlemen seeking the release of hostages. Money from those sales went into a Swiss account for which Israel had withdrawal rights."

### The World of Jacob Nimrodi

Israel's most notorious arms dealer is Jacob Nimrodi. Today he resides in the luxury of his \$2.5 million white stucco mansion, known as "The White House" on Tel Aviv's beach. Nimrodi was born into a family of 10 children in Jerusalem. He

joined the Jewish anti-British underground in 1946 at age 16. Later he signed on with the Palmach spy network which specialized in infiltrating Arab countries.

Nimrodi joined the MOSSAD spy agency in 1948 and became a close friend of Gen. Ariel Sharon, (now known as the butcher of Beirut). Nimrodi won the admiration of David Ben Gurion after he entrapped an Egyptian officer into a compromising situation with a Jewish prostitute. The man was forced to become an informant for Israel against his own people.

In 1960 Nimrodi was sent to Iran on a secret mission. It was to arrange arms sales to the Shah. This continued for 14 years and unofficially for 10 years thereafter to the Ayatollah. But Nimrodi was able to work both sides of the fence at the same time. He recruited a senior Iraqi military commander as an Israeli spy and arranged for an Iraqi pilot to defect to Israel with an advanced MIG fighter. He also helped Iran by sending U.S. arms to Kurd rebels in northern Iraq to help weaken Iran's ancient enemy. Nimrodi oversaw the annual sale of \$500 million in arms to Iran.

The Chicago Tribune, Dec. 1, 1986, "Jacob Nimrodi, a former colonel in Israel's military intelligence (MOS—SAD)...earned millions of dollars from the arms-for-hostages swap that he initiated." Thus the question of some of the missing millions may now be answered!

## Pollard's wife appeals to Israel

### New Revelations In Pollard Spy Case

Israeli officials were shocked when U.S. Judge Aubrey E. Robinson, Jr., sentenced Jewish spy Jonathan Pollard to life in prison and his wife Anne to five years. Prosecuting Attorney Joseph E. diGenova said the damage to our national security was worse than the Walker spy case.

Among the new evidence Pollard sold to Jewish MOSSAD agents were details of U.S. ship and troop movements, information on Pakistan's nuclear facility, data on Iraq's military defenses, (which the Jews passed on to Iran), details of Yaser Arafat's PLO headquarters in Tunisia. This enabled the Jews to launch a sneak attack killing many innocent people. Arafat luckily survived.

While some people felt sorry for Pollard's young, 26 year old wife, she admitted hiding secret U.S. documents for her husband. Also, she used some of the secret material, (which was of interest to Red China), in a scheme to obtain a public relations contract from the Communist Chinese. She promised them more secret information in the future. It has now been revealed that she too is a Jew!

Prime Minister Shamir still claims this was a, "low-level unauthorized spy operation," which Israel's leaders didn't know about! He must take Americans for fools. Israel's top Air Force, Army and Navy officers sent Pollard requests for specific information!

Americans must awake to the fact that no other U.S. Ally spies on us. It should be remembered that after the arrest of the Pollards, then Prime Minister Peres said, all involved in Israel would be "held accountable for their actions and punished." Their "punishment" has been handsome financial rewards. Still certain Gentile politicians blabber praise for Israel on every occasion calling it "our most loyal and trusted friend in the entire world," ad nauseam!

### Israel Secretly Defending Pollard

Israel has consistently disavowed Pollard's espionage activities after his arrest inside their embassy grounds in Washington. Prime Minister Peres said his spying was "unapproved." Today Jews in Israel and America have criticized Jewish leaders for "abandoning" Pollard. They cite the little known fact that Pollard's wife, the former Anne Henderson is Jewish. She borrowed \$100,000 for her own legal fees from relatives. Many Jews feel that the Israeli government has not shown "loyalty" to its own spies.

Thus we learn that Israel's Ambassador Meir Rosenne invited Pollard's parents, Dr. & Mrs. Morris Pollard of South Bend, Ind., to the embassy to inform them of help to come. He is very close to several top Israeli leaders and met with both Dr. Pollard and Bernard Henderson (fathers of the defendants.) Charney has signaled that Israel wishes to find a way out for their two Jewish spies. The suggestion is, that whatever punishment the U.S. court gives the Pollards, that they be allowed to serve the sentence in Israel.

"As far as I am concerned I am as much a loyal son of that country as anybody has been. I did my best. I am sorry if it wasn't the most effective thing from a long-range standpoint, but I really did my best."

Wearing the khaki short sleeve shirt of a prisoner, Pollard expressed hope that he and his wife, Anne Henderson Pollard, would some day make aliya. "I fully intend to become a useful and productive member of Israeli society," he said. "That's home. That's my homeland."

WASHINGTON. - Anne Henderson-Pollard, the wife of convicted spy Jonathan Jay Pollard, has appealed to the Israeli government to intercede with the U.S. on behalf of her husband.

"I would beg the Israeli leadership - for all that my husband has done for the security of Israel - to grant citizenship to my husband and to let him return to his homeland so that he can become a productive citizen in Israel." Israeli Air Force Colonel Aviem Sella, who, according to U.S. Court documents, served as his first "handler" in Washington. In June 1984, Sella was a graduate student at New York University.

She said that both she and Pollard "loved" Sella and had developed an extremely close personal friendship with him and his wife, Yehudit, whom they called "Judy."

She said that she and Pollard were also very fond of Yosef Yagur, the Science Counsellor at the Israeli Consulate in New York, who later replaced Sella as Pollard's chief U.S. contact. She said she never met Rafael Eitan, the head of the Lekem scientific-intelligence gathering unit in the Defence Ministry.

She said that Pollard never hid his deep ideological commitment to Israel from her. "I knew his politics," she said, recalling the start of their relationship in 1981. They were married in August 1985.

We're also strongly supportive of the existence of the State of Israel."

Henderson-Pollard, whose mother is Jewish, wore a small Star of David around her neck.

After he started providing Israel with the information, she said, he "felt good about himself. He felt that he was making a good contribution to both Israel and the U.S. because by strengthening Israel, he believed that he was strengthening the U.S. - given the special relationship that both nations share."

Henderson-Pollard said that her husband had been instructed not to inform her of his activities. That was why the Israeli agents had concocted a cover story about Pollard's having a rich uncle in Paris who paid for their overseas trips. The "uncle" also gave her a diamond ring.

She recalled that on Monday, November 18, 1985, Aviem Sella and his wife happened to be in Washington when Pollard was first stopped and interrogated for several hours by FBI agents as he left his office. "The four of us were supposed to have dinner that night," she said.

But Pollard called around 7:30 that evening and said: "Go see our friends, give them our cactus, and send them my love."

The night before, according to Henderson-Pollard, Pollard had told her that the word "cactus" would be a signal to remove the classified documents which were then in the house. He had become concerned that Sunday night after failing to retrieve some documents from the apartment of Irit Erb, an Israeli embassy secretary, who routinely photocopied the documents he would deliver on Fridays. It was the first time that Erb had failed to appear at the door of her apartment.

"I heard the word 'cactus' and I knew that something was wrong," she said. "I gathered up the documents in the house - all the documents. I got nervous."

The Israeli government, meanwhile, appears to be revising its hands-off attitude toward Pollard. "There's no doubt that he did a lot for Israel," a minister in the Israel's inner cabinet said. "We do owe him."

There are strong indications that top Israeli leaders may even be prepared to negotiate with the U.S. government in an effort to bring the Pollards to Israel and avoid potentially lengthy prison sentences for them in the United States.

But when she walked down the stairs, she quickly noticed that the apartment building was surrounded by FBI and Naval Intelligence Service agents. She left a suitcase full of documents in a hall stairwell before leaving the building.

Later, from a pay telephone booth, she called Sella at his hotel. "I called Avi," she said. "I asked him to meet me at a restaurant - alone. I didn't want Avi to know that I knew (about Pollard's activities) so I talked around the issue. I told him that Jay was in very serious trouble, and that I had to remove certain items from the house which should not have been in the house. I begged him to help Jay. I said, 'Please help Jay. He's in terrible trouble.'"

Sella promised to help. He first asked her to walk around the streets for two hours before returning to her apartment. "I understand now that this was his time to get out of the country," she said. Neither Sella nor his wife had diplomatic immunity.

On the Wednesday, Pollard was instructed by an Israeli embassy security officer in Washington that the embassy's driveway would be open the following morning at 10:00 and that they should drive through then. "We'll take care of you from then on," the security officer said.

From there, they drove to the embassy, unaware that more than a dozen FBI cars were following them. In the car were her family photo album and their cat, Dusty.

"The gate was open," she said, "and we drove down the driveway ramp. Two guards were there and said to Jay, 'Welcome home. You're safe now. Everything is fine.'"

But within a few moments, the embassy was surrounded by FBI agents, cars, trucks and vans. The embassy's security officer went inside for about "10 or 15 minutes," according to Henderson-Pollard. "We were waiting in the car, on the embassy grounds, in the driveway, but not inside the building."

"The security officer was angry when he finally came out," she continued. "He said, 'Get out. You have to leave.'"

"Jay asked, 'Do you know who I am? Do you know what I have done?' The officer simply looked at us and said again, 'Get out.'"

"At that point, Jay said that we wanted to invoke the Law of Return and claim our right to Israeli citizenship. 'We're Jews,' Jay said, pleading with the officer. It didn't help. They kicked us out."

Pollard was immediately arrested by the FBI. Henderson-Pollard was arrested the next day. But while they had "stalled" for time earlier that week, Sella, Yagur and Erb had fled the country for Israel.

## Soviets Demand Ukranian War Criminals

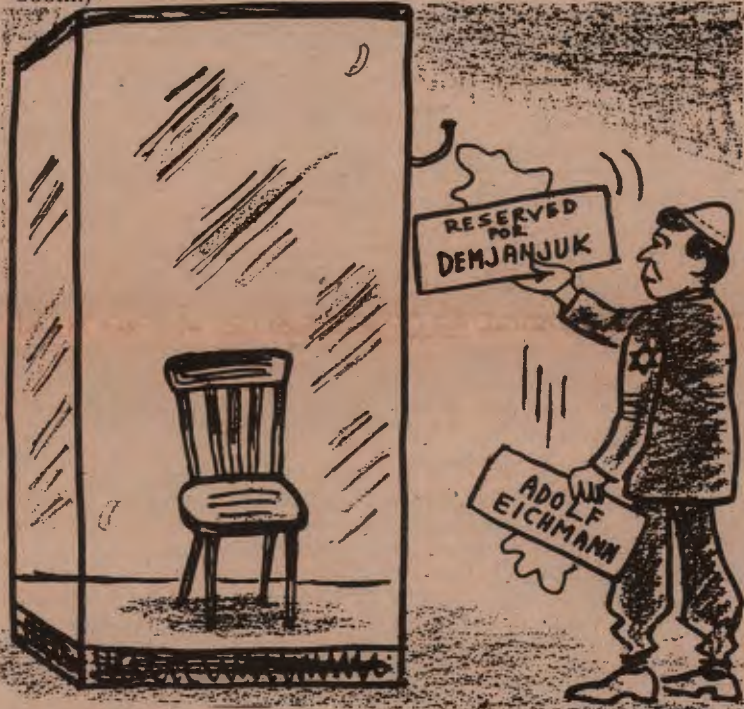

### His Grieving Family Cries Out: "We Want Him Home Now!"

The only document the Israeli prosecution has against John Demjanjuk is a so-called, "Nazi I.D. card," supposedly issued by the Germans at a training camp for guards. Demjanjuk's lawyer, Mark O'Connor, says he can prove the card is a KGB forgery.

In the past the Soviet Embassy would only allow a photo copy of the card to be examined. Allan A. Ryan, Jr., headed the OSI during the trials which stripped Demjanjuk of his U.S. citizenship. Ryan was caught in a deliberate lie in his debate with John Buchanan when he stated Demjanjuk's lawyers, at the Cleveland deportation hearing were allowed to examine the card. THEY WERE NEVER GIVEN THE ORIGINAL CARD FOR EXPERT ANALYSIS.

Today we hear that the Jews have obtained the original I.D. card and all experts say that it is a blatant KGB forgery. First the U.S. press came out with a short article stating the I.D. card had been given to Israel by the Soviets and now the Jews had the proof needed to convict

him. The next thing we know the Jewish Telegraph Agency of Jan. 1, issues a bulletin which only appeared in the Jewish press stating they are now in real trouble. Note article on this page which states the card lists the wrong camp!

The card says Demjanjuk was a guard at the Sobibor camp -

but he is charged with being a mass executioner at the Treblinka camp at age 23! Not only that, but they admit the card errors, when it says Demjanjuk is much shorter than he really is. The JTA says such discrepancies have "raised difficulties."

There are many other "problems" with the Soviet issued card. One is that the card spells words with a latin "ss" which was a German style used only after 1960. In 1942 the letter would be a "B" - according to German language expert Prof. Z. Michael Szaz. Other problems with the card are that in the picture the young Demjanjuk is wearing a Russian conscript uniform. The Germans always put such converts into German style uniforms for I.D. photographs - NOT RUSSIAN UNIFORMS.

The German stamp over the photo (like a passport stamp) has the center circle OFF CENTER. The Germans never had such mis-matched stamps. This card is a crude KGB forgery. Just read the statement by Patrick Buchanan about the other so-called evidence offered by Allan Ryan. There can be no doubt left in anyone's mind that John Demjanjuk is a totally innocent man - the victim of a vicious Soviet KGB frame-up.

## Demjanjuk - victim of KGB Frame-Up

Every camp history, including Jean Francis Steiner's definitive book "Treblinka," insists that the real Ivan was killed in August, 1943. So do many survivors, including 85 year-old Spanish civil war veteran Joaquin Garcia Ribes; Avraham Goldfarb, a Jew; and several Poles who were not allowed to leave Poland to testify on behalf of the defense. Of the 17 Treblinka survivors questioned by the U.S. Justice Department's Office of Special Investigations [OSI] in their preparation of Demjanjuk's deportation hearings, 12 could not identify Demjanjuk from his photographs.

Halevi argues that the "ink, paper, signatures" on the Soviet-supplied SS identity card bearing Demjanjuk's name "were tested to verify authenticity." Not true. The original was only examined, never tested, because the Soviets would never allow it to leave the premises of the Soviet embassy in Washington, D.C. Only photostats were available for careful scrutiny and experts who examined them found errors that suggested forgery by the KGB, the Soviet secret police.

Halevi's assertion that Demjanjuk's lawyers have never questioned the authenticity of the identity card also is untrue. Defense attorney Marc

O'Connor has consistently maintained that the card is a fraud.

What is most distressing about Halevi's article is his cavalier dismissal of Ukrainian-American claims that their community is being defamed by the Soviets for their anti-Soviet posture. This "convenient conspiracy theory," writes Halevi, "ignores a paramount fact: Neither Demjanjuk or others who lost U.S. citizenship for concealing a Nazi past... were politically active."

Political activity is irrelevant to the KGB. The less visible a particular person is, the less obvious the KGB conspiracy. What matters to the KGB is that with the help of present and past OSI officials, as well as certain American newspaper pundits and correspondents, serious doubts have been raised among Americans regarding all displaced persons who fled Soviet tyranny.

Ukrainians believe that it is more than a mere coincidence that at a time when Stalin's 1932-33 forced famine in Ukraine is being brought to the world's attention by Ukrainians outside of the USSR, those same Ukrainians are being defamed by initiatives from Moscow.

What Halevi and other OSI supporters need to consider is this: Demjanjuk's name first came to the attention of OSI through a KGB-published periodical entitled News From Ukraine. 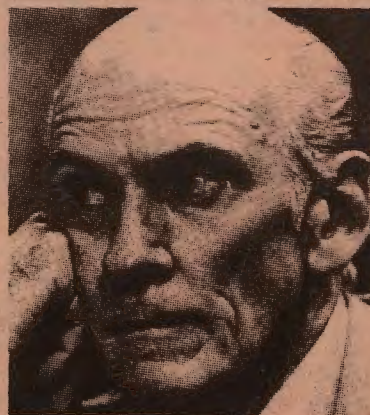

## An even friendlier congress

### ANALYSIS of last week's U.S. elections by WOLF BLITZER

AMERICAN Jewish political activists were clearly delighted by the outcome - not because of the political setback for Reagan, who is widely seen as extremely friendly toward Israel. Rather, the Jews agreed that this new session of Congress will almost certainly be even more pro-Israeli than the last - and the last was very pro-Israeli indeed.

If the Israeli government plays its cards right, the new cast of characters in the Senate and House of Representatives can be expected to maintain very high levels of U.S. economic and military assistance to Israel even during the prevailing budget-cutting atmosphere. And if President Reagan and Secretary of State George Shultz should come forward with new legislative initiatives aimed at further strengthening Israel's defence and its economic recovery, the Congress will almost certainly go along with them.

Moreover, the Democrats in the Senate and House will be in a very strong position to block Republican-backed arms sales to "moderate" Arab states. Many observers, therefore, doubt very much that the administration will even introduce such sales.

The elections demonstrated once again that Israel's popularity in Washington is both non-partisan and non-ideological. Israel has friends among the most liberal Democrats and the most conservative Republicans. This was underscored in what were probably the two most important Senate races in the country - as far as Israel's special interests were concerned.

In California, incumbent Senator Alan Cranston, a liberal Democrat, faced a very stiff and angry challenge from Republican Ed Zschau, a young Congressman who served on the House Foreign Affairs Committee. This was probably the most bitter campaign in the country, with an almost endless number of negative ads appearing daily on California television stations. It drew an enormous amount of interest in the Jewish community around the country.

Zschau, while adopting in recent months a more positive posture toward Israel, had earlier been quite outspokenly critical. He voted against Israel on several key issues as a congressman. During questioning

of State Department officials, he often demonstrated a rather openly hostile attitude. Few Jews trusted him.

Much Jewish money, therefore, went to Cranston, a down-the-line supporter who had often led the fight in the Senate against administration-backed arms sales to "moderate" Arab states. Cranston won in a close contest.

In Wisconsin, Bob Kasten, a conservative Republican, overcame a tough challenge from Democrat Ed Garvey. Kasten, as chairman of the Senate Appropriations Subcommittee on Foreign Operations, was critical in pushing for increased U.S. aid to Israel in recent years. The Jewish community rallied behind him, wanting to reward him for his support.

The Jewish fund-raisers, both individually as well as collectively through their political action committees (PACs), also wanted to make sure that Kasten would remain on that critical panel, which will now be chaired by Democratic Senator Daniel Inouye of Hawaii, another great friend of Israel. An Inouye-Kasten team represents a real blessing for Israel's future aid prospects.

This combination also suggests that the two senators will probably once again cooperate in trying to pass legislation cutting the prevailing

interest rates on outstanding U.S. military loans to Israel by half - an immediate saving of at least \$500 million. Their earlier effort was derailed shortly after the Jonathan Jay Pollard spy scandal erupted.

Morris J. Amitay, a former executive director of the American Israel Public Affairs Committee (AIPAC) who now heads a separate pro-Israeli political action committee in Washington, welcomed the fact that two well-known critics of Israel - Republicans Barry Goldwater of Arizona and Charles Mathias of Maryland - are retiring from the Senate. The new senator from Maryland, Democrat Barbara Mikulski, has had an outstanding record on Israel during her years in the House of Representatives. And in Arizona, the Republican winner of the Senate contest, John McCain, is widely expected to be more friendly toward Israel than was Goldwater. Thus, there has been a net plus for Israel.

In recent years, Republican and Democratic politicians across the country have come to really respect - even fear - the fund-raising and managerial clout of the American Jewish community, which is extremely well-organized and efficient in making its views known. Fear of a potential backlash is occasionally expressed but that has not yet materialized.

Two years ago, Jewish activists worked very hard to unseat Republican Senator Charles Percy of Illinois, and they succeeded. Four years ago, they did the same to Republican Representative Paul Findley of Illinois. Both men were seen as anti-Israel - Findley much more so than Percy. The pro-Israeli community's message was loud and clear - don't tangle with the Jews.

Now more than ever, it's very popular to support Israel and very unpopular to oppose it. This has become a political fact of life in Washington.

None of this means that Israel will now have a free ride in Washington. Prime Minister Yitzhak Shamir and his national unity government will continue to have to be very careful in avoiding statements and actions which could undermine support for Israel in the executive and the legislative branches of the U.S. government - as well as among the American public.

# Tyndall Victory In England

## Victory In England - John Tyndall Wins on Appeal

**British National Party (BNP)** chairman John Tyndall was sentenced to one year in prison for writing words "likely to incite racial hatred." He was freed after an appeals court ruled the sentence too severe. These are the "anti-hate laws" which organized Jewry has forced upon such countries as England, Canada, France, West Germany and other once free nations. Unfortunately, England has no Constitution as we have here in the United States. Thus far this has blocked the Jews from restricting our freedom of speech. Still, they work day and night like termites to have such laws adopted in America OVER the Constitution through subversive traps like the U.N. Genocide Treaty.

John Tyndall is publisher of the magazine **Spearhead** and John Morse is editor of the newspaper "British Nationalist." Both present the views of the BNP. England's two major parties are actually left-wing and are dominated by the Rothschild family which controls many of the nation's industries. Tyndall and Morse were tried in Southwark Crown Court by THREE JEWISH PROSECUTORS who were assisted by a Negress lawyer!!! They were Timothy Cassel along with a Mr. Solly and Mr. Topolski. The defendants were righteously outraged that they did not have prosecutors of their own peers, Anglo-Saxons! England's "race-hate" laws are enforced by the special "Racial Equality Police" called the "Scotland Yard Community Relations Branch." Here in America we have a Justice Dept., bureau called the "Community Relations Service" which is supposed to "protect the rights of minorities," and wants more power all the time.

## Frame-Up Trial Begins

The three Jew prosecutors had to prove Tyndall and Morse published material "Likely to stir up racial hatred." Thus they found one article in **Spearhead** about how 6 million unemployed Germans found work in the 1930s. They somehow said this was an affront to the 6 million dead Jews theory because the figure "six" was used! Next they charged that "British Nationalist," May 1985 issue, stated that Whites were a "superior race" and Negroes an "inferior" race. This, of course is true, but the judge ruled that "truth is not a defense against the charge of stirring up racial hate!"

Another article in the Jan. 1984 edition of **Spearhead** had six cartoons depicting how a well kept White neighborhood can be wrecked once blacks move in. This was also cited as apt to "cause racial hate." Another article stated that Negroes had lower morals than Whites. In America nearly 60% of all black births are illegitimate. Still telling the truth about race in England is a crime!

Tyndall described the jury as "a weak-looking lot, middle class and largely liberal," who elected a socialist type as their foreman. Even though most of the jurors must have had experiences with blacks proving the articles were true they still found John Tyndall and John Morse guilty. The judge gave each one year in Wormwood Scrubs Prison.

## Case Successfully Appealed

Observers agreed the sentence was savage. Part of the appeal objected to the severity of the sentence. Another oddity of British law is that most people are not allowed to go free on bond while their case is being appealed. Thus, after serving nearly half the sentence, the Court of Appeals ruled that indeed it was too severe and reduced it by six months which was close to the time served.

## Packed Victory Meeting

Let no one think for a moment that John Tyndall or John Morse were in anyway intimidated by this vicious Jewish prosecution. On Nov. 14 they were freed and greeted by Patriots as they left prison. Tyndall vowed, "We will not be silenced, the powers that be will soon learn that putting us away was the biggest mistake they ever made!"

The very next evening, Nov. 15th, a meeting was held in London to welcome back Tyndall and Morse. Over 200 Patriots attended on short notice. John Tyndall told the cheering crowd

Epidemics killed Many Prisoners

Thousands of prisoners who died at the Bergen Belsen concentration camp during World War II weren't deliberately starved to death but died from a rash of diseases, according to a psychiatrist who was there in 1945.

Russell William Barton, 61, of Rochester, N.Y., said that when he entered the camp on May 2, 1945, he had heard and believed that prisoners were deliberately starved to death by the Nazis.

But Barton, who was a medical student volunteer with the British Red Cross, said if that was true, he couldn't understand why the camp kitchens were so well equipped.

He told a District Court jury yesterday he decided the stories of vicious German inhumanity weren't true after he found books, dating back to 1942, itemizing the amount of food cooked and distributed each day.

The psychiatrist was the second defence witness at the trial of Ernst Zundel, who has pleaded not guilty to two counts of publishing statements he knew were false and likely to incite mischief.

The publications in question are *Did Six Million Really Die?* which claims the Nazis had no gas chambers and Adolf Hitler never plotted to exterminate the Jews, and *The West, War And Islam*, which contends Zionists, Freemasons, commu-

nists and bankers are conspiring to form a world power.

In his pamphlet *Did Six Million Really Die?* Zundel, a 46-year-old Carlton St. publisher, has reprinted part of an article written by Barton. He states that Barton's recollection of camp conditions is "a surprisingly honest appraisal of the situation at Belsen in 1945."

Barton, senior associate psychiatrist and attending physician at Strong Memorial Hospital, said the appalling conditions of the camp were likely due to massive overcrowding and the camp administrator's resentment because 50,000 prisoners were kept in a camp for 3,000.

The camp administrator felt it was his responsibility to look after the 3,000 prisoners, not the 50,000 who had arrived after the Russian front began to push west, the doctor said.

"I was stunned," the doctor said. The prisoners were suffering from malnutrition, gastro-intestinal, typhus, scurvy and a multitude of other diseases, he recalled.

He said that, when he tried to give prisoners protein intravenously, some of them screamed, saying others had died from injections administered by the Germans.

Intravenous injections were new to medicine at the time, Barton said, and the deaths were likely caused by bad reactions to them.

Another defence witness, French professor Robert Faurisson, said the "gas chambers and the genocide together was a fraud which led to a gigantic political

Gassings Impossible

There were no gassings of Jews at Auschwitz concentration camp during World War II, the air did not smell of burning flesh and there was a special room set aside for religious ceremonies in a satellite camp, a former German army officer has said.

Thies Christopherson, a 67-year-old West German citizen, told a District Court Jury yesterday that he heard rumours of the massacre of millions of Jews at the camp where he spent a year as a researcher and they were "absolutely impossible".

Christopherson was a special officer in the German army but when he was wounded in 1940, he was no longer fit for the front lines and joined the Kaiser Wilhelm Institute as an agriculturalist, he told the jury through a German interpreter.

He was sent to the institute's synthetic rubber research plant at Auschwitz in a small satellite camp known as Raisko, the jury heard. He said that every morning about 200 female inmates of Birkenau went to Raisko to work in the fields that he supervised.

He said he had read and heard reports after the war about dreadful war crimes but he didn't believe them then and doesn't now.

He said there was never any evidence of mass gassings and "the air in Auschwitz was very clean".

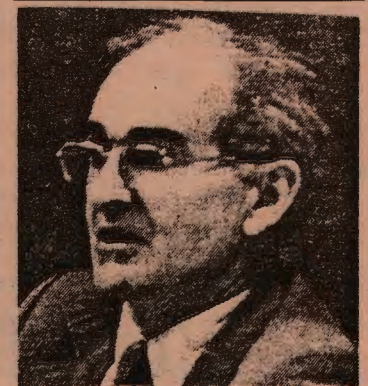
The witness said he knew there was a crematorium because his supervising officer's wife died of typhus and she was burned there.

He said the 200 women from Birkenau, whom he detailed to work each morning, seemed happy and there were no complaints or stories of mass gassings from them.

## Special room

Christopherson told Christie there was one special room reserved in Raisko where religious groups could meet when they wished and no one was obligated to work at that camp.

When some of the survivors of Auschwitz-Birkenau testified for assistant crown attorney Peter Griffiths, they spoke of a large pit near the crematorium where corpses were sometimes tossed to be burned. Christopherson said the land in the area was so swampy that even a small hole would be filled with water.



French Prof. Robert Faurisson found no gas chambers, and financial fraud."

Israel's former prime minister, David Ben Gurion, had twisted the arm of former West German chancellor Konrad Adenauer in order to obtain reparations payments for the relatives of dead and missing Jews, Faurisson said.

To get those payments, "Ben Gurion committed an enormous fraud" in saying 6 million Jews were murdered, Faurisson said.

# Zundel Win Freedom of Press for Canada

## Zundel Found Innocent In "Hate Literature" Case

Canada's most famous Patriot is Ernst Zundel! He was convicted in a Toronto court on a charge of publishing "false news," by daring to question whether or not 6 million Jews really died in a "holocaust." No such tyrannical Laws exist in America because they would be declared un-Constitutional. The case next went before a five member Court of Appeals. They unanimously reversed the conviction and made Zundel an overnight **National Hero!**

The Canadian Jewish Congress made an extraordinary effort to have the so-called "anti-hate" laws enacted. Of course, they only apply to Christians, who might dare to criticize Jews. Such laws would never be used to prosecute Jews who unceasingly slander Christians and Christianity. The charges were brought against Zundel by the Jewish "Holocaust Remembrance Association," which tries to instill a guilt complex within all Christians about so-called "poor-persecuted Jews!"

Ernst Zundel, 46, was charged with the "crime" of publishing two books. One was entitled, "Did Six Million Really Die," and the other, "The West, War and Islam." The first book gives proof that less than 300,000 Jews died in the concentration camps and not one single gas chamber ever existed. (This figure is close to the number of German civilians who died in the fire bombing of the city of Dresden when the war was all but over!) The second book charges a conspiracy exists among "*Zionists, bankers and Communists to dominate the world.*"

After a seven week trial the jury came in with what appears to be a "compromise verdict." Zundel was convicted of publishing "false news" in the first book but found innocent on the same charge in the second book! In effect they voted that the material in the first book was not true but the second book was "true news." Of course, such decisions should never be left up to any jury as Zundel's lawyer, Doug Christie, pointed out; "*This is a matter of freedom of speech and allowing people to discuss the pros and cons of all subjects.*"

## No Conviction Possible In Retrial

The Court of Appeals ruled in such a way that any retrial of the case would insure "not guilty" verdict. Because of this Ontario's Attorney General has appealed the case - this time to the Supreme Court of Canada. It will take over a year for a ruling but since the Appeals Court was unanimous there is little doubt the final decision will be in Zundel's favor.

The Appeals Court ruling was so strong in upholding Zundel that the case is now considered a total victory. Here are the key points in their 125 page decision:

1) The Appeals Court ruled that trial Judge Hugh Locke erred by not allowing Christie to question prospective jurors, to determine if they should be struck "for cause" (if they were in any way biased against Zundel.)

2) Zundel had a right to introduce slides, models and books to prove to the jury that he believed the truth in his own book about the holocaust being a hoax. The "false news" law only applies to someone who spreads news they KNOW to be false.

3) The prosecution should not have been allowed to show a film "*of bulldozers pushing corpses into a mass grave*" because it was shot after the war when typhus epidemics spread through the camps killing prisoners and Germans alike. Also, the film was taken at the Dachau Camp which all now agree was never an "extermination camp." It was conceded that the film was made by "*Hollywood producer George Stevens.*"

## Defense Attorney Doug Christie Hails Victory

Zundel's lawyer Doug Christie said: "*this is a great win for freedom of speech and press. I think we will do far better in any future trial especially now that some of our crucial evidence will be allowed in. We were prevented from showing the jury why Zundel believed his views to be the truth.*"

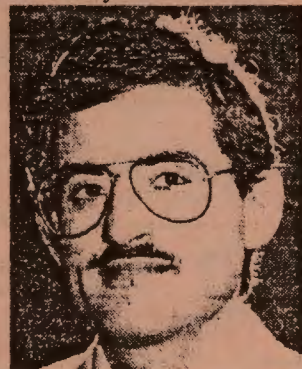
Ernst Zundel was greeted with cheers by his supporters and noted that Judge Locke's order prohibiting him from discussing the holocaust in the future had been struck down. He said his new presses will be turning out the truth on the subject full speed from now on. Zundel added: "If any time is ripe, it's now. There is not a newspaper in the country that can stop the march to victory of an idea whose time has come." ## No Gas Chambers Ever Found

By KIRK MAKIN

A Holocaust revisionist from Sweden told yesterday of risking his freedom to get a look at what he called fake Auschwitz concentration camp ovens, fake doors and fake crematorium chimneys.

Ditlieb Felderer testified at the Ernst Zundel trial that he has made between 27 and 30 trips to Auschwitz in the past few years to wriggle into buildings, basements and chimneys where members of the public are strictly forbidden to go.

The off-limits areas feature chimneys which have been tampered with and crudely drilled roof holes masquerading as poison-gas vents, Mr. Felderer said. Moreover, the walls of a purported gas chamber had none of the bluish tinge identified with any room where Zyklon-B gas had been used, he said.

At another concentration camp, Maidanek, friendly guards invited Mr. Felderer and his revisionist friends to their homes and helped them to get into forbidden buildings, Mr. Felderer said. "Sometimes we gave them vodka and made them very happy."

"One is not allowed into any of these buildings," the 42-year-old man said excitedly. "One is risking, if not one's life, a stiff jail sentence."

The 30,000 photographs he has taken bear witness to the truth of the claim that the Holocaust is a hoax, Mr. Felderer said.

He said he was originally an "exterminationist" — a believer in the Holocaust — but gradually discovered it to be a lie through research he was conducting for the Jehovah's Witnesses.

This research determined that only about 200 Jehovah's Witnesses were killed in Nazi concentration camps rather than the generally accepted figure of 60,000, Mr. Felderer said.

The sect ultimately accepted and published the figure of 203, he said. Nevertheless, Mr. Felderer was excommunicated

in 1974. "I think it is vital for people to be informed of hoaxes of any kind," he said.

The witness was cut off by District Court Judge Hugh Locke as he began to describe the "persecution" he and his wife have undergone, including having stones thrown through their windows.

Defence counsel Douglas Christie said the testimony was relevant because it indicated

why many people do not question the Holocaust. "Can I not make that argument and get a ruling on it?" he asked the judge.

"I've just ruled on it," Judge Locke said flatly. "You're too late."

"I'm used to making arguments before rulings," Mr. Christie shot back.

Mr. Zundel, 46, has pleaded not guilty to two counts of knowingly publishing false news which was likely to cause harm to social or racial tolerance.

Earlier yesterday, a chemist who identified his employer only as a "major U.S. chemical company" gave a long list of reasons why Zyklon-B could not have been used to gas prisoners in the camps.

"I have come to the conclusion that no one was wilfully or purposely killed with Zyklon-B in this manner," said William Lindsey. "I consider it absolutely impossible."

Dr. Lindsey said he has spent considerable time in the past 12 years researching Holocaust literature and the remains of the death camps from a chemist's perspective.

His testimony challenged accounts Holocaust survivors have given of belching crematorium chimneys and of hauling bodies stacked up in piles from the gas chambers.

The time and danger factors render ridiculous the idea of up to 2,000 victims being gassed in the chambers and then taken out by hand to be cremated, he said.

He said the gas is so toxic that any building containing large amounts would have to be thoroughly aired and neutralized with ammonia before workers, who would have to be wearing protective clothing, could enter.

Since hydrogen cyanide is lighter than air, it is nonsense to think people would climb on one another to survive or that unprotected workers could have survived, he said.

"Unless you washed your hands in very short order you would be on the pile of corpses you were carrying out," Dr. Lindsey said. He said the door of one chamber was so flimsy he could have broken it down himself.

# Civil Rights Convert Is Convicted Burglar

**Criminal - Now a Civil Rights Hero**

Gainesville, Ga., is the home of Dean Carter, 27, who now has a new racket going. He has become a "civil rights" leader! Carter gained world-wide publicity as the man who sponsored Rev. 3) Next in 1983 Carter was arrested and charged with a felony - first degree burglary. Carter was found guilty of breaking into a game room and robbing vending machines. He was sentenced to five years in prison. He served little over one year in Georgia's maximum security prison in Jackson, Ga.

Criminality must run in Dean Carter's family. His brother was arrested in Ohio by the F.B.I. Del Carter was convicted of extortion by threatening to put deadly poison in a company's product unless he was paid off. He got the idea from the Chicago Tylenol poisoning murder case. Del also would make a good convert to Hosea Williams' civil rights cause!

This is the background of the man now held up by the media as a "civil rights hero." Believe it or not he now says he wants to sue those who stopped his first march because his "civil rights" were violated!

# Forsyth Citizens Demand Their Rights

Beverly Watts, wife of Defense League president Mark Watts, filed for a permit to march in Forsyth County on Tuesday, Feb. 17. According to a new ordinance issued by city and county officials, local administrators have 15 days to respond to the application.

Calling himself the Aaron to the Forsyth County working people's Moses, Mississippi Lawyer Richard Barrett said that the group will march for majority rights and freedom either by permit or court order. "We believe that the elected officials of Forsyth County will respect the Constitution," he said. "But if they refuse to allow a permit then I will secure a court order."

Barrett said that the Forsyth County ordinance cannot be enforced because of a ruling in College Park.

City manager Gerald Blackburn refuted Barrett's claim.

"It would be a mistake to compare our ordinance with the one in College Park," he said.

The Defense League issued a list of eight requests addressed to Gov. Joe Frank Harris and to state and Forsyth County officials during a press conference on Thursday. Among these was a demand that the governor apologize for a statement issued from his office which called local residents "subhuman".

Among the other requests were a ban on the use of the county courthouse by Forsyth County citizens and that all public meetings by public officials be open. Barrett had been

denied use of the courthouse for his press conference on Thursday and access to a biracial committee meeting on Monday, Feb. 16.

Other requests include that the biracial committee be abolished, that all charges be dropped on those arrested for protesting during brotherhood march, that police brutality and intimidation against Forsyth County residents end, and that leaders stop capitulating to demands by "Black power minority radicals such as Hosea Williams and Coretta Scott King."

Approximately 30 Forsyth County residents were seated with Barrett and Forsyth County Defense League members. Included in the group were Frank Shirley, the leader of the committee to keep Forsyth and Dawson Counties White and Dennis Brock, who made a name for himself by speaking out against blacks on the Oprah Winfrey show.

Those arrested at the brotherhood marches of Jan. 17 and 25 spoke out against the brutality of police.

"The GBI drug me to the ground and beat me," said resident Jerry Baird. "Then they busted my girlfriend's 9-year-old daughter's nose."

On Friday Barrett, Brock, Watts and Junior Staton went to Atlanta to present their list of requests to Gov. Harris and to meet with him. They met instead with the governor's legal counselor, Rick Stancil, and administrative assistants Rusty Seward and Andrew Lewis.

Watt's indicated that he was not satisfied with the reception that the group was given. Barrett said that the group should have been given the same reception that Hosea Williams received.

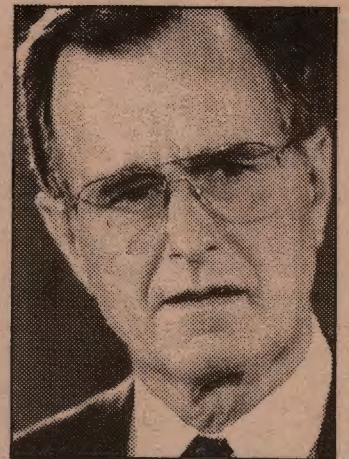

### Lone white member resigns after threats

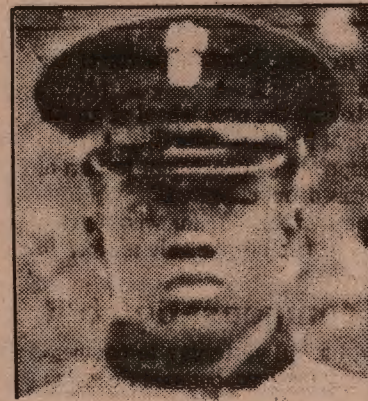
