Linnas Last Words: “God Bless America”

All loyal Americans were sickened when they helplessly viewed the TV news of FBI agents dragging Karl Linnas into LaGuardia Airport, for his forced return to Soviet occupied Estonia.

Linnas was pushed and pulled toward his doom. His last words to shocked Americans were: “What they’re doing right now is just a murder and kidnapping - GOD BLESS AMERICA!” Then he was gone! FBI agents held him by both arms. Others walked in front of him and behind him. Linnas was placed on a Czechoslovakian airliner where Communist KGB agents took over. They chained his hands and feet for the long flight.

Even a reporter for Hungarian state television revealed a dislike for his Red masters saying: “What a tragic blunder. I never expected to see American government join forces with the Soviets against a defenseless old refugee”

Linnas is one of the original victims of ex-Congresswoman Elizabeth Holtzman’s 1978 bill which provides for the deportation of alleged “war criminals” to Russia or Israel for “trials.” This Jewess also is responsible for the Bill which established the Jewish section within the Justice Dept. called the “Office of Special Investigations” or OSI.

Linnas native Estonia was invaded by the Soviets in 1940. Stalin placed many Jews in charge of the Baltic countries and they murdered and deported to Siberia thousands of Christians. Then in 1941 the German army drove the Reds out and the Estonian people treated them as Liberators. Many joined the Waffen SS and fought against the Bolsheviks until the end of the war. It is alleged that Karl Linnas, age 67, killed “Jews and Communists” in a concentration camp in Estonia. There is no reliable evidence to support this charge. The only reason he was stripped of his U.S. citizenship and ordered deported is because under Holtzman’s devilish and cunning retroactive law you can be deported for failure to fully reveal your service in German allied forces during W.W.II. While Linnas admitted to being a policeman they claim he did not say he was a camp guard.

Pat Buchanan led public defense of Karl Linnas

Reagan wanted Linnas deportation blocked.

WASHINGTON [AP]—President Reagan opposes deporting accused Nazi Karl Linnas to the Soviet Union and instead wants Linnas to stand trial in the United States for war crimes, according to a White House memorandum.

The Feb. 9 memorandum by Patrick Buchanan, then White House communications director, was written to Atty. Gen. Edwin Meese.

It recounts a conversation between Buchanan and Reagan earlier that day in which the President was quoted as suggesting Linnas not be sent to the Soviet Union.

According to portions of Buchanan’s memo, obtained Tuesday, Reagan during a Feb. 9 luncheon with a number of advisers expressed the view to Buchanan “that Linnas should not be deported.”

“When I told him it was probably within his authority to block deportation, he said we should go ahead and block it,” Buchanan’s memo said.

Buchanan was one of the President’s most staunch conservative advisers, and he has strongly supported East European ethnic groups critical of U.S.-Soviet cooperation in the area of Nazi war criminals.

Quotes From Vicious Jew Attacks Against Waldheim

The average American would be shocked if he could read the venomous statements made by Jewish leaders seeking to undermine and destroy Austria’s duly elected President. The following presents a clear example:

Patriot Elected In Austria

The world Jewish collective originally thought their slander would defeat Kurt Waldheim in his race for President. They wanted to humble the Austrian people under a new “holocaust guilt campaign.” Proof of this is the latest smear issued by Simon Wiesenthal of the Jewish Documentation Center in Vienna. He charged that a larger percentage of Austrians joined the Nazi Party in the

1930s than did the Germans. Then he said: “The Austrian people were responsible for about half the deaths of the 6 million Jews and communists exterminated during the holocaust.”

Proof that this is yet another brazen holocaust lie is the fact that some 175,000 Jews resided in Austria before World War II. According to Jewish historian Herbert Steiner, quoted in “Jewish Week” of Nov. 21, “The historian (Steiner) noted that, despite difficulties, 120,000 Austrian Jews escaped the Holocaust and many were helped by non-Jewish Austrians.”

The full truth is that thousands of others left Austria before the war and since 120,000 out of 175,000 “survived” we have clear proof that there never could have been any so-called “holocaust” in the first place!

Last summer Kurt Waldheim was elected President by a landslide vote. His Conservative Peoples Party beat the “Socialist Party” which had been in office for 16 years. Also, the Right-Wing “Freedom Party” won 10% of the vote and elected 18 members to Parliament.

The conservative newspaper, “Kronen Zeitung” declared: “If Israel and the World Jewish Congress continue to interfere so massively in Austria’s domestic affairs, they will achieve only the opposite result from what they want as they should realize from their attempt to destroy Kurt Waldheim!”

World Jewish Congress Condemned Linnas To Death

Jews Celebrate Linnas Cruel Fate

Standing at the airport watching Linnas fly off to his death were Miss Holtzman and representatives of the World Jewish Congress. Rubbing their hands with glee and slapping each other on the back in congratulations, Miss Holtzman told the press, "Obviously, the Russians don't have the same system of justice, but they can give him a reasonable facsimile of a trial and allow him to present evidence. They could retry him and change the verdict," she added with a laugh!

Karl Linnas is a well know Anti-communist in the U.S. Estonian community. Thus, in Jan., 1962 the Soviets put him on "trial" in absentia. It is an uncontested fact that a Soviet journal a month earlier reported he would be sentenced to death. Then the Reds officially requested his extradition in 1963. Our government refused because we had no extradition treaty with these bloodthirsty killers. Miss Holtzman and the World Jewish Congress decided to change that immediately.

Perjured Evidence Against Linnas

The court's stripping Linnas of his citizenship was a civil action for which the Holtzman Law provides THERE WILL BE NO JURY TRIAL. Thus minor questions, as to whether persons told the "whole truth" when they entered America as refugees from communism, now can actually result in a DEATH SENTENCE.

In fighting Linnas the OSI had the unlimited funds of the federal government and highly skilled lawyers. Linnas, a poor individual, never had a chance at justice in U.S. courts. They sent him to Russia for execution over a little possible "white lie" he may have told to gain freedom in America!

Even during the OSI deportation hearings against Linnas the U.S. Board of Appeals acknowledged that, (in the Soviet absentia trial of 1962), "Linnas has already been sentenced to death in what appears to have been a sham trial."

The following is the flimsy testimony given in Russia before a communist prosecutor who always referred to Linnas as "the war criminal."

1) Oskar Art said that Linnas shot "a few Jews, men and women, in a ditch."

2) Hansu Laats testified that Linnas shot, "only male prisoners in the ditch." Laats admitted to being an outpatient at a psychiatric hospital and that he suffered from "brain damage" which affected his memory and reaction.

3) The next witness was a Mr. Laats who said that only Communists were executed in the ditch.

4) Another witness at the hearing in Russia was a Mr. Art. He said he was not sure Linnas was present at the "execution ditch." He later said, "Well, I cannot be 100% sure, I think he was there."

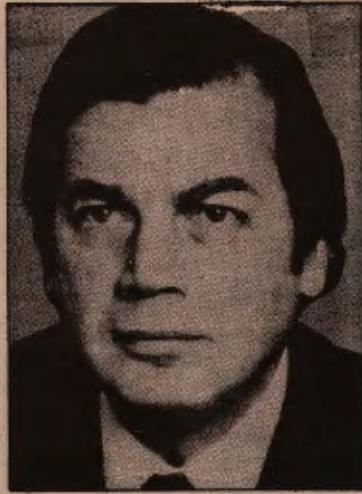
5) The last witness was Elmer Puusepp. He was appointed a Commissar Political Chief at a factory in Estonia by the Soviets after they invaded in 1940. He said that Linnas was guilty on all charges.

6) The other witness, and the only one who lives outside the Soviet Union is a Dr. Deiland from Finland. He said he was an inmate at the Tartu Camp and never saw Linnas working there.

The U.S. Appeals Court Judge, Jacob Mishler, (Jew), after listening to the video-taped interview of the Soviet witnesses noted the Red prosecutor Siim Kirsipuu, who questioned the witnesses kept referring to Linnas as "the fascist prisoner murderer" and "a former war criminal." Mishler called this "prejudicial language" and said the witnesses may have been forced to corroborate the prescribed "Soviet evidence." While noting he was "disturbed" by the way in which the Communists cross examine witnesses he still voted to strip Linnas of his U.S. citizenship for not telling immigration authorities he was a camp guard. Bear in mind that was not a crime until AFTER Miss Holtzman's bill passed in 1978.

Famous People Defended Linnas

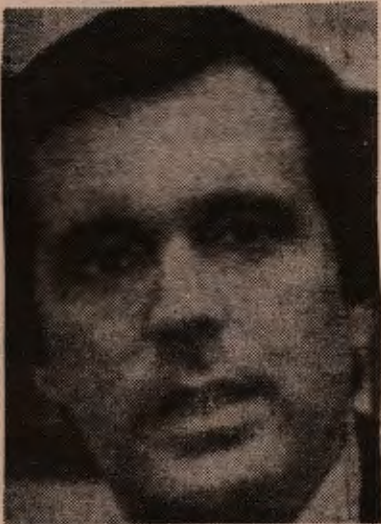
While it is heartening to read the names of the many prominent people who came to Karl Linnas defense the fact remains that they were ALL OVERRULED by the seemingly all-powerful World Jewish Congress. 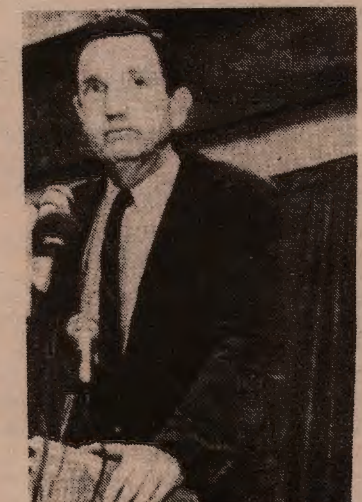
Edgar Bronfman, head of World Jewish Congress, billionaire owner of Seagrams Whiskey, is a behind the scenes international power.

did "Amnesty International" which urged that no free man should be sent to any Communist controlled country for "trial." Then, of course, in a massive effort the Baltic community flooded Atty. Gen. Edwin Meese with thousands of protest letters and telegrams.

Even major liberal newspapers condemned this monumental injustice. The Los Angeles Times editorialized that "sending Linnas to the Soviet Union is tantamount to delivering him to a firing squad on the basis of Soviet-style justice which is not justice by U.S. standards."

The Washington Post said: "Leave aside for the moment the fact that the charges against Karl Linnas have not been proven or even tested in an American courtroom. For the purpose of argument, it is possible to assume that Mr. Linnas was guilty of every wartime atrocity for which a Soviet court convicted him...and still be troubled by his deportation this week to his native Estonia - now a part of the Soviet Union - where the sentence is to be carried out...In a Soviet court, regardless of the facts, American standards of due process - to put it mildly - do not begin to apply."

Three U.S. Supreme Court Justices ruled against Linnas deportation in a losing 6 to 3 vote. The dissenters were Justices William Brennan, Harry Blackmon and Sandra Day O'Connor.

World Jewish Congress Blocks Linnas From Panama

U.S. Estonian, leaders along with Atty. Ramsey Clark sought to find another country which would accept Linnas. The World Jewish Congress let it be known that the wrath of international Jewish finance would come down upon any nation which accepted Linnas other than Russia. They said he could only be sent to Russia because they wanted his execution GUARANTEED!

The daughters of Karl Linnas pleaded with the government of Panama to accept their father. They wanted him to spend his remaining days on earth in peace in a pleasant country close enough for his children and grandchildren to visit. Atty. Gen. Meese also urged Panama to take Linnas. He told friends he did not want the execution of Linnas to be on his conscience for the rest of his life. Thus Panama agreed to accept Linnas on "humanitarian grounds." This agreement went into effect on April 13th, the eve before the Jewish Passover when they supposedly would be huddled in their Synagogues. Linnas was to leave the country for Panama as quickly as possible - THE VERY NEXT DAY IN FACT.

But as the Jonathan Pollard case has proven, Jewish spies lurk throughout our government. The New York Times reports that the Jew, Neal Sher head of the all-Jewish OSI, learned of Meese's plan to deport Linnas to Panama. Sher warned this would incur the wrath of the World Jewish Congress THERE CAN BE NO DOUBT THAT SHER "LEAKED" THESE TOP SECRET PLANS TO THAT SUBVERSIVE OUTFIT.

Miss Elizabeth Holtzman, (today, Brooklyn's District Attorney), and Menachem Rosensaft, chairman of the World Jewish Congress and other Jew leaders rushed to the Panamanian Embassy in Washington. A world economic boycott of Panama was threatened if they dared accept Linnas. World Jewish Leaders insist that Linnas must undergo torture and brutal murder at the hands of vociferous Soviets. Here are a few comments by Jewish leaders:

Truth About Yugoslavia

Organized Jewry Demanded Waldheim Ban

Attorney General Edwin Meese, after an 18 month delay, finally succumbed to the blatant demands of organized Jewry. He made Austrian President Kurt Waldheim the first head of state ever banned from entering America. Waldheim has been placed on the "Justice Dept. Watch List" which includes over 40,000 people who were either in the German army or one of her allied forces in the war against Russia. It was none other than Miss Elizabeth Holtzman, Jew, who as a Congresswoman in 1978, with the total backing of the Jewish Community rammed this "watch" law through Congress. She and her vengeful cohorts also wrote the 1978 law which makes it possible for the un-Justice Dept. to strip East Europeans of their American citizenship as "war criminals" to be deported to Israel and Soviet Russia for execution - WITHOUT JURY TRIALS FIRST HERE IN THE U.S.!

The Bloodiest Warfare Was Inside Yugoslavia

The daily press has totally suppressed the fact that during World War II the fiercest fighting, (away from the front lines), took place inside Yugoslavia against Tito's communist guerrillas. This brutal mountain warfare continued from 1941 until the final end of the war in 1945. The press and TV deliberately omit the fact that the largest ethnic group inside Yugoslavia fought on the German side. They were the Croats. Also, Moslems, monarchists and other anti-communists backed the Germans.

Miss Holtzman makes much of the fact that Waldheim's commanding officer, Gen. Lohr was hanged as a "war criminal" by Tito at the end of the war after his forces surrendered and became POWs. DOES THIS MAKE WALDHEIM A WAR CRIMINAL?

The Germans and their anti-communist allies wanted to retreat into Northern Italy so as to surrender to the Americans and British. The Allies told the German High Command their forces in Yugoslavia must lay down their arms to Tito's Red guerrillas. They obeyed orders after being assured they would be treated fairly under the rules of the Geneva Convention for the humane treatment of prisoners of war.

There followed one of the most brutal butchering of POWs in the history of modern warfare. Tito starved, tortured and executed over one million prisoners. Of the 90,000 German troops who surrendered in Yugoslavia 80,000 suffered barbaric deaths. Of the Croatian anti-communists who fought along side the Germans seeking to free their nation of Tito's Red forces over 600,000 were savagely murdered by the Communists.

Allies Betray Anti-Communist "Chetniks"

There was another pro-Western anti-communist force which fought against the Germans and also against Tito because they didn't want their country turned over to communists. These were the Chetnik troops fighting under the command of Gen. Draja Mihailovitch. He was named "Minister of War" by the Yugoslav Cabinet in exile in London. Once Tito seized power with Soviet backing all of the 25,000 Chetnik troops were rounded up and shot by Tito's henchmen. This bloodbath went on until 1949. When it finally ended over one million people had been slaughtered including Gen. Mihailovitch and Gen. Lohr!

If Kurt Waldheim had not been able to make his way back to Austria at the end of the war he would also have been executed like his commanding officer Gen. Lohr. There is no doubt this would have made the blood-thirsty "World Jewish Congress", (WJC) happy.

Kurt Waldheim was wounded in action in Russia and transferred to Yugoslavia to serve as a supply officer and translator between German and Italian troops. He never rose above the rank of Lieutenant. Even the Jew, Dr. Robert Herzstein, of the University of South Carolina in Columbia, who dug up the data for the "WJC" wrote of the deportations in which Waldheim's military unit was involved:

"Waldheim was not a sadist but he made the deportation system work. The people rounded up were shipped off to labor camps. To be fair, these were not death camps. But this man made possible a program that was judged criminal after the war. The man who headed it, Fritz Alpo, was hanged as a major war criminal."

What Dr. Herzstein conveniently leaves out is that Col. Alpo was hanged by Tito as were ALL THE GERMAN OFFICERS WHO SURRENDERED INTO HIS HANDS!

Communists Gave Jews Data Slandering Waldheim

We are here today to call on the Justice Department to bar Kurt Waldheim from our country.

Under the law that I wrote while in Congress, any person who assisted in acts of Nazi persecution between 1933 and 1945 may be stopped from entering our country. There is no doubt that Waldheim belongs in that category.

Waldheim served as a top intelligence officer on the staff of General Lohr, a convicted and executed war criminal in the Balkans.

Those of us who believe he should be barred from the country have in fact, won a practical victory. It is very unlikely that Waldheim could come to this country today. However, it is still necessary for the Justice Department to rule explicitly that he should be barred from the country.

This act would be more than symbolic — it would tell the world that the U.S. stands firmly against Nazi acts of persecution. It would make the record perfectly clear — that there will be no more reconciliation with evil. There should be no more Bitburgs.

Earlier, Hier told a large audience attending the annual Simon Wiesenthal Center dinner here that the Center and its constituency will not sit idly by if the United States extends an invitation to Waldheim to visit the United States. The rabbi made it perfectly clear to any U.S. administration that "should Waldheim ever be invited to visit this country, the Simon Wiesenthal Center would organize massive demonstrations against him anywhere he visited in the United States." The rabbi Hier also sharply attacked President Reagan for sending Waldheim congratulations on his election victory.

intelligence officer according to a secret Yugoslav criminal file released here, (New York City), by the World Jewish Congress. The dossier, compiled in 1947 by the Yugoslav War Crimes Commission says Waldheim planned German army reprisal measures in the Balkans . . . the file notes that Waldheim is presently a fugitive and the apprehension of this criminal and his extradition for trial by Yugoslav authorities is compulsory."

Decent Nations Show Respect For Waldheim

This is the so-called "evidence" World Jewish Congress leader Edgar Bronfman and Jewess Elizabeth Holtzman gave Atty. Gen. Edwin Meese in demanding that Kurt Waldheim be barred from visiting America. They fail to mention that Tito's fiendish Communist Tribunals branded all German soldiers as war criminals.

Meese or Reagan are quick to respond to demands from the Jewish World Congress, Jewish ADL and Jewish Lobby, once they crack the whip. These spineless politicians dance to their tune. Happily, other nations have more self-respect and refuse to knuckle under to the orders of the Jews.

America's ambassadors to both West Germany and Austria are Jews. Richard Burt, described as abrasive and pushy, represents the U.S. in Germany. The Jew Ronald Lauder is our "official" ambassador to Austria. Last July Lauder left that country rather than attend Waldheim's inauguration. Still others have not been so insulting as the Jews.

When the Helsinki Security Conference was held in Vienna representatives from the following countries paid Waldheim courtesy calls. They included West Germany, Italy, Czechoslovakia, Switzerland and Cyprus. To his lasting disgrace, our Secy. of State, George Shultz snubbed Waldheim. (Shultz has been threatening to resign his post for over a year. We urge him to go ahead and resign so that the tremendous damage he has already done to our foreign policy hopefully may end!)

Waldheim has been invited to visit many countries not as tightly controlled by Jews as is the U.S. Emperor Hirohito has invited Waldheim to pay an official visit to Japan. Jordan's King Hussien has invited him to visit and Saudi Arabia's ambassador stated:

"The Arab world has observed the evil campaign against the President of Austria with disgust. It is designed to discredit the credibility of the U.N. which he once headed."

A dinner in Waldheim's honor was organized by the Ambassador from Spain with most of the ambassadors from South America attending. Mexico's envoy, Cuevas Cancino stated: "I reject the slanderous campaign against Austria and her head of state with horror!"

The Saudi Arabian newspaper, "Al Jazira" of June 10, editorialized: "We congratulate the Austrian people for refusing to bend to foreign pressures. Kurt Waldheim's U.N. stand against Israeli aggression is what is behind the threats and intimidation of the Zionists and their lacky allies."

The Thunderbolt supports Kurt Waldheim and the people of Austria 100%. We will do all within our power to reach the American people with the underlying truth of the Zionist power-play to destroy Waldheim. "John Doe" Wins A Victory For You!

West Palm Beach, Fla., the Greyhound Bus Station was the scene where a young man was stopped by police who demanded identification. He refused to give his name. He was arrested and given the name "John Doe" when placed in jail. The next day he was taken before Judge Richard Wennet who ordered that he either give his name or submit to a psychiatric examination. John Doe said he would do neither and said withholding his name was to preserve his "right to privacy."

Judge Wennet sentenced Doe to jail for "contempt." Some 11 days later Attorney James K. Green came to his defense. He argued that the court did not have the benefit "of legal research on the case because the defendant had the constitutional right to remain silent." Another hearing was held and John Doe told the court he had no prior arrest record and would insist on his right to refuse to answer any questions. Judge Wennet then ruled that "the court had incorrectly ordered the defendant to give his name - he is now free to go!"

Thus another, lone, brave individual stood up for your right not to give statements to the police if you so choose.

History of The Fifth Amendment

The Fifth Amendment to the U.S. Constitution reads: "No person shall be compelled in any criminal case to be a witness against himself."

In every type of investigation you are presumed to be innocent and the Fifth Amendment insures that you cannot be forced to bear witness against yourself." You should always request a court appointed attorney as provided by law and remain silent. This applies even if it is just a knock on the door by some investigator who might possibly seek to entrap or entangle you or even an unsuspecting friend. Your best protection is to always remain silent - SIMPLY SAY NOTHING AT ALL!

"The Father of the Fifth Amendment" was a Puritan dissenter in England, John Lilburne, age 23. He described himself as "an honest true-bred, freeborn Englishman that never in his life loved a tyrant nor feared an oppressor." Lilburne was dragged before a Star Chamber and ordered to answer questions about the distribution of Puritan books. He spoke up before the court: "I see you go about by this examination to ensnare me for seeing the things for which I am imprisoned cannot be proven against me, you will get other matter out of my examination. I shall remain silent for fear that with my answer I may do myself hurt."

The court ordered him to remain in prison indefinitely and pay a fine of five hundred pounds (\$100,000 today.) He later explained, "I was condemned because I would not accuse myself."

John Lilburne was also publicly whipped and had his head locked in a pillory in order to humiliate him. Still he was defiant and spoke to the crowd for half an hour reminding them, "The law of God requires no man to accuse himself." Overnight Lilburne became a national hero in England. In 1641 the Parliament abolished the Star Chamber and prohibited authorities from ordering anyone to testify against himself. They freed John Lilburne.

When the American Continental Congress met in 1783 James Madison reminded the delegates about the case of John Lilburne. 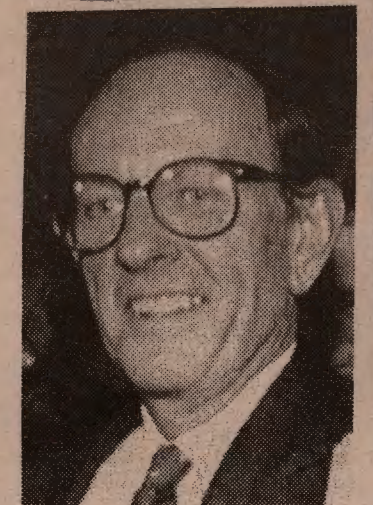

Examples of Jewish Pressure to Deport Linnas

Sen. Chiles Signed Jewish Death Letter
(From "Jewish Telegraph Agency")

WASHINGTON (JTA) — Moves for the deportation of convicted Nazi war criminal Karl Linnas picked up fresh support on Capitol Hill as several congressmen signed a letter to Attorney General Edwin Meese III urging he act immediately.

Meese told the House Judiciary Committee that Linnas' deportation was being delayed 30 days on a plea from Linnas' lawyer, Ramsey Clark, who is seeking to find a country that will accept him. Linnas, a New York resident, faces deportation to the Soviet Union where he faces the death penalty.

Meese was questioned sharply by New York Democrat Charles Schumer, who demanded that he decide the case at once.

Reactions after the hearing were even sharper, with congressmen from both parties denouncing the 30-day reprieve.

"I don't think that's our responsibility," said Rep. William Lehman (D-Fla.), who, along with Sen. Lawton Chiles (D-Fla.), initiated

the letter. "I understand Clark's (point), but we have laws and legislation in this country and we can't predicate our justice system on someone else's."

"Justice has been delayed and thus denied far too longer," said Rep. Bill Green (R-N.Y.). "Further delay is inexcusable; this man must be deported for trial."

Schumer also asked Meese when Austrian President Kurt Waldheim, a suspected Nazi war criminal, would be placed on a watch list of individuals barred from entering the country. Schumer said he had written Meese six times in the past year and has been told only that the matter is being "pursued expeditiously."

Intense Jew Pressure On Meese Insured Linnas Doom

President Reagan asked that Karl Linnas NOT be shipped to Russia. He said this must be "blocked." U.S. Atty. Gen. Edwin Meese said Linnas should be deported to a neutral country and not Russia.

The World Jewish Congress gave the opposite orders and they were obeyed. On this page we reproduce just a few quotes which appeared ONLY in Jewish publications. They are brazen and arrogant in lording their power over their Christian hosts. It is difficult for the average man in the street to fathom how a tiny minority, less than 3% of our population, could have ever gained such control.

World Jewish Congress executive director Elan Steinberg denounced Meese's "slowness" in shipping Linnas off to Russia to death calling it "AN ABOMINATION!" He added that this case posed a "challenge" to all Jews!

World Jewish Congress lawyer, Eli Rosenbaum, said the U.S. Government's plan to send Linnas to Panama was "a subversion of justice!" OF COURSE HE REFERS TO THE JEWISH STYLE OF JUSTICE WHICH IS VENGEANCE!

The Jewish Community Relations Council of New York City sent a letter to its 59 local Jewish organizations urging each to demand that Meese deport Linnas to Russia.

NOTE: the federal courts ordered that Linnas be deported - NOT TO RUSSIA OR ISRAEL - but to any country which would accept him.) Thus Jewish Week, the largest Jewish paper in America on April 3rd editorialized:

"Karl Linnas was ordered deported to the Soviet Union by a federal judge. (This was the Jewish Judge Jacob Mishler.) Linnas faces the death penalty. Meese, however, is allowing Linnas to seek a safe haven in direct contravention of an order of the court. You can express your displeasure by writing Atty. Gen. Edwin Meese, 10th Street and Constitution Ave. N.W., Washington, D.C. 20530, or you can phone him at 202-633-5111.

When the Jews put pressure on the Panama government to rescind their agreement with Meese to accept Linnas THEY VIOLATED THE LOGAN ACT. This makes it a crime to interfere with U.S. diplomatic agreements. Miss Holtzman and Elan Steinberg are obviously guilty but their power and influence is so great that they will never be prosecuted and sent to prison where they rightfully belong. Linnas - Loved By Family And Friends

Karl Linnas - The Family Man

Estonia was a free nation from 1918 until 1940, (along with Lithuania and Latvia.) It was in 1940 when Stalin invaded the three countries. The local Jewish communities made up the backbone of the Baltic Communist Parties. For this reason Stalin placed local Jews in charge of the conquered governments and local industry. There has been a vicious rancorous attitude on the part of Jews against the Baltic people. They made sure that the leadership and intelligentsia of the Christian community were deported to Siberia from which thousands never returned. When Germany invaded in 1941 the vast majority of the Estonian and other Baltic people greeted them as liberators. Many joined the Waffen SS to fight to keep the murderous Red hordes from ever returning to their native homeland.

Karl Linnas was born Aug. 6, 1919 in Tartu, Estonia. He studied at the University of Tartu and later joined the Estonian army. He married in 1944 while serving in the Home Guard. Mr. Linnas fought with the German army against the Soviet Juggernaut along with thousands of his fellow countrymen.

Linnas, his wife and two daughters, came to the U.S. as refugees from communism on Aug. 17, 1951. He became a land surveyor in Greenlawn, Long Island, N.Y. Friends

describe him as a jovial man who liked to play Santa Claus for the local children. Linnas organized the local chapter of the girl scouts for the benefit of his daughters and neighbors children. He was a family man who loved music and community singing. Still, he was not in good health and suffered from arthritis and poor circulation.

Their Lives Destroyed

His quiet life came to an end in 1962 when the Soviet KGB put him on trial as a war criminal in Russia. They began to demand his extradition so that he could be executed. No one believed that this would ever come to pass. Then Miss Holtzman and the World Jewish Congress blackjacked Congress under Pres. Jimmy Carter into adopting her two "war criminal" bills. On April 22, 1986, FBI agents took Linnas into custody because they feared he might try and flee the fate Jews had planned for him as his appeals against the OSI deportation orders ran out.

As the jet left Kennedy airport for Russia his devoted and loving daughter, Anu, cried, "He's been wrongly deported to die. I will spend the rest of my life fighting to vindicate his name!"

59 Jewish Organizations In New York City Alone Campaigned To DEPORT LINNAS AND BAN WALDHEIM!

(Below from "Jewish Telegraph Agency")

On Dec. 1, 1986, the U.S. Supreme Court refused to hear Linnas' appeal against deportation to the U.S.S.R., a decision hailed by at least nine Jewish organizations. Today, these organizations, and many others, are decidedly upset over the failure of the U.S. justice system to provide for Linnas' speedy deportation.

The Jewish Community Relations Council of New York has sent a "Dear Colleague" letter to its 59 constituent organizations asking that they protest the continued presence in the U.S. of Linnas. The letter, urging Attorney General Edwin Meese to sign off on Linnas' deportation order, will be submitted to two senators and two congressmen.

Elan Steinberg, executive director of the World Jewish Congress, said of the failure to, until now, deport Linnas that "the whole thing is an abomination. We're waiting for the attorney general to enforce the law, as we are in the case of (Austrian President Kurt) Waldheim, placing him on the watch list (of war

criminals not welcome in the U.S.) We don't need to protect Nazis in this country. The attorney general should send a clear message, 'Nazis are not welcome here.' The entire Jewish community is being challenged by these cases. Will they stand up in this moral struggle or will they allow those individuals who protect these heinous persons to prevail? We're not asking for a favor—we're asking that the law be carried out."

Eli Rosenbaum, general counsel of the World Jewish Congress in New York, promptly called the decision "a subversion of justice of monumental proportions." He noted that a South American country, Paraguay, came under international criticism for harboring Joseph Mengele in the 1960s.

Attorneys for Linnas, as well as some leading conservatives in the administration and East European groups, have argued that the case against him was based on questionable evidence provided by the Soviet Union and had urged Meese to block the deportation.

History of the Jewish-Communist Persecu

Demjanjuk Case - Continuation Of Ageless Jew Persecution of the Ukrainians

The World Jewish Congress, headed by billionaire Canadian whiskey magnet Edgar Bronfman claims there are 500 "war criminals" of East European descent "hiding" in the U.S. It should be noted that before their prosecution by the Justice Dept.'s OSI, (headed by the Jew Neal Sher), both Karl Linnas and John Demjanjuk could be found listed in the phone book.

Organized Jewry claims their people were victims of a "holocaust" carried out by Germans and East Europeans. They claim 6 million Jews were killed. The American Red Cross in 1945 said 300,000 died, Japanese expert Dr. Uno says 200,000 died. The lower numbers may be close to the truth but the Jews died of starvation and typhus just as did many German civilians in the closing days of the war.

One of the camps the Jews point to is that of Bergen-Belsen. It operated from 1934 to 1945 and held communists, petty criminals and Jews. Some 50,000 people did die there - BUT OF THIS FIGURE 20,000 DIED IN THE SINGLE MONTH OF MARCH, 1945, JUST BEFORE THE END OF THE WAR. The Red Cross said all died of either starvation or typhus. NOT ONE WAS GASSED - THERE WAS NOT A SINGLE GAS CHAMBER IN THE CAMP. IN FACT NO GAS CHAMBER WAS EVER FOUND IN ANY CAMP!

The Jews maintain that since time immemorial the East Europeans have persecuted them. We have read on different occasions in Jewish publications such statements as, "The Poles are more Anti-Jewish than the Germans," or "The Ukrainians are more Anti-Jewish than Germans", or, "The Hungarians are worse than the Germans," etc., etc. It appears the Jews are on the "outs" with ALL the peoples of East Europe.

In this study we will try and explain why they make enemies so easily.

When the Bolsheviks overthrew the Christian Czar of Russia in 1917 the leadership of the Reds was 90% Jewish. Trotsky and Bulgarin were full blooded Jews and Lenin was a half-Jew. The revolution was fully supported by the Jews of Russia who saw this as a means to bring down, once and for all, the Christian leadership under the Czars which they believed held them back economically. Jews Formally Called Holocausts - "Pogroms"

For centuries the Jews have claimed they have been the victims of endless "Pogroms." This term was invented by Jews and the dictionary says it means, "an organized massacre of Jews." It does not apply to any "massacre" of any other racial or national group. Today the Jews have coined a new word - "Holocaust." They say it has replaced the word "pogrom" and should be used only in referring to the alleged deaths of 6 million Jews at the hands of Germans and East Europeans. The word "pogrom" did not sound dramatic enough and they needed a new word which could be incorporated into their religion as a remembrance day.

On this page we reproduce an interesting letter from a Jewish expert on "pogroms", David Ulianitsky. This is extremely interesting because the Jews have for 67 years claimed that

200,000 Jews were "butchered" by the Ukrainians in 1919-1920. By repeating it often enough this figure has been accepted and appears in many history books today. Note that Ulianitsky says that within Jewish ranks, even in this day, Jews still cannot decide among themselves just how many the Ukrainians killed. He writes that David Gross claims 200,000 Jews were killed, but that N. Gregel says it was as low as 50,000, but Howard Sachar alleges more than 250,000 died, and Saul Friedman says it was around 150,000. Ukrainians say it was less than 10,000!

Thus it is exactly the same situation after World War II where the Jews boost the figure of 300,000 dead Jews to 6 million in order to instill a guilt complex within all Christians. Thus they can literally get away with murder in Palestine, spying on the U.S. and thievery in the financial markets of Wall Street where nearly all criminal indictments for stealing multi-millions from the public have been Jews. The media says they should be forgiven - after all - are they not the victims of a HOLOCAUST! Jews Perished in 1919 Fighting To Set Up Soviet State

The Jews rage and wail over how many thousands of their race died in 1919 - 1920. Yet they never explain that their people died while fighting against Christian Ukrainians while helping Lenin and Trotsky take over the Ukraine as part of the Soviet Union.

Simon Petlura is a national hero to the Ukrainian people because he helped establish a short lived independent and free Ukrainian nation. The Tragedy Of The Cossacks

Day By Day Chronicle Of The Betrayal Of The Courageous Cossacks

May 4, 1945, Cossack officers met with British officers who, "guaranteed their rights." Thus some 90,000 Cossacks, including 4,000 women and 2,500 children surrendered. To assure them of safety their officers and security police, (M.P.s), were allowed to keep their sidearms.

May 23, 1945, Churchill released to those officers holding Russian nationals his orders to initiate "Operation Keelhaul". Many British officers were shocked - but they were soldiers - and orders are orders which must be followed to the letter. that money for when they will soon all be corpses? They seized a total of 6 million Italian Lire and 6 million German marks. What became of this money has never been revealed. To this day it is still classified, "Top Secret."

May 28, the British called all of the Cossack leaders and officers to the city of Lienz for a "high level conference." Those who arrived included 2,756 Cossack officers, 35 generals, 167 colonels and 280 elderly men who had served as staff officers under the Czar. THE DIRTY TRICK WAS TO SEPARATE THE COSSACK LEADERS FROM THEIR FOLLOWERS!

These men were taken to a high security camp at Spittal and the next day, **May 29** informed they were about to be handed over to their Soviet enemies. A melee broke out and many Cossacks fought with their hands to the death. British troops using rifle butts beat them over the head. Some were knocked out, others killed or seriously injured. The unconscious officers were tossed like sacks of flour into the backs of Soviet trucks. Others who resisted were simply gunned down. Those still living were driven to a factory building in Judenburg where the Soviet secret police were waiting. They didn't wait to get these Cossack officers back to Russia - THEY HANGED THEM OR SHOT THEM TO DEATH RIGHT IN THE FACTORY!

Americans Were Also Involved

Roosevelt was now dead but Pres. Truman ordered that Operation Keelhaul be carried out in all U.S. occupation sectors in Europe AND RIGHT HERE IN AMERICA.

June, 1945, some 154 Cossack POWs held at Fort Dix, N.J. were ordered deported to Russia. Three of these soldiers committed suicide rather than return. Others were seriously injured in resisting. Second, anti-Semitism has greater intellectual currency and respectability in Japan than in perhaps any other industrialized society. In January 1986, an anti-Semitic novel titled "Passover" by a Japanese woman residing in Los Angeles won the 94th Akutagawa Prize, Japan's most prestigious literary award. It was awarded by a jury of Japan's most respected novelists and critics, headed by the Roman Catholic novelist Shusaku Endo.

In this context, Japanese anti-Semitism reveals itself as but one manifestation of widespread racist thinking that has permeated the highest levels of Japanese Government and business bureaucracy. What emerges is a self-image of the Japanese as a pure race, superior to other mongrelized peoples, but unjustly persecuted by them.

Popular Japanese Books On The Jewish Problem

Popular Japanese Writers Claim Jews Control U.S.

Dr. Masami Uno heads the "Middle East Problems Research Center" in Osaka, Japan. He has a staff of 150 people. Dr. Uno's books on the Jewish problem have become best sellers involving millions of copies sold. His book, "If You Understand The Jews You Can Understand The World" sold 400,000 copies. It says Jews control many U.S. businesses and, "Jews form a behind-the-scenes nation which controls the U.S. government." It also charges Jews caused the Great Depression of the 1930s and are plotting another for the 1990s.

Another Uno book is, "If You Understand Judea, You Can Understand Japan." This states that no six million Jews died during World War II. He says the true figure is around 200,000. In a recent interview Dr. Uno said many of Japan's current economic problems result from Japan's support of the Arab boycott against the purchase of Israeli made products.

Important People Read These Books

A recent study found that the 82 books on the Jewish problem now in circulation in Japan are read by "young, educated, white-collar workers along with the nation's ruling elite," Eisaburo Saito, a member of Japan's Upper House of Parliament wrote the book, "The Secret of Jewish Power to Control The World."

Den Fujita, who heads the McDonald's hamburger chain in Japan wrote the book, "The Jewish Way of Business" and has thus far sold over 80,000 copies. Other popular books by Uno include, "How To Read The Hidden Meaning of The Jewish Protocols." It is interesting to note that "The Protocols" were first translated into Japanese in 1924 and continues to be distributed today by the Shin-Jinbutsu Oraisha publishing company. (You can order the popular English "Protocols" from The Thunderbolt.) Uno explained that there was a need for his books so that, "Japanese may understand how powerful the Jews are in the U.S. because Japanese money is going there and the American economy is led by Jews."

Japan, an Island nation smaller than California, is the world's leading industrial producer. Tiny West Germany is second with the U.S. a rapidly declining third. When it comes to understanding the Jews the Japanese are once again far ahead of this country. It goes

WASHINGTON (JTA)—Officials of the Anti-Defamation League of B'nai B'rith have expressed concern to Japanese Ambassador Nobuo Matsunago about the rise of anti-Semitic literature in Japan.

They told Matsunago at a meeting here last week that the ADL wanted "to work with the Japanese by making available materials to reduce prejudice and stereotyping," according to Jess Hordes, ADL's associate Washington director. Hordes was accompanied to the meeting at the Japanese embassy by Burton Levinson, ADL national chairman, and Abraham Foxman, ADL associate national director. Matsunago was "open and appreciative at the proposal and said he would convey it to the government," Hordes said.

The meeting was prompted by press reports in this country of a popular Japanese author, Masami Uno, who claims that his country's recent economic woes are due to a conspiracy by "international Jewish capital" and that Jewish-dominated interests have begun a "targeted bashing of Japan."

Matsunago told the ADL that Japan guarantees freedom of speech and that anti-Semitic views are not representative of the people or the government. The Japanese embassy refused to comment about the meeting.

But reports of current anti-Semitism in Japan prompted a letter by Rep. Charles Schumer (D-N.Y.) and Sen. Arlen Specter (R-Pa.) in which they told Prime Minister Yasuhiro Nakasone that "the raw anti-Semitism in your country cannot go unchallenged."

Japanese Ambassador Nobuo Matsunago informed the ADL that "Japan guarantees freedom of speech" and therefore material critical of the Jews cannot be banned. World Jewry Defended The Jewish Communist Assassin Of Ukrainian Independence Leader - Simon Petlura

The Assassination of Simon Petlura

On the Jewish feast of Purim Jews make pictures of past leaders they hate the most such as Haman, Hitler and yes, even Petlura. They meet in the synagogue, denounce these people, rip up the pictures, stamp on them, hit them with hammers, etc., while the Congregation hisses. He did not know that he was being stalked by a Jewish-communist named Sholom Schwartzbard who had formerly fought in the Red Army's, "Group Rochelle." This was an all-Jewish force fighting to establish Bolshevik rule over the embattled Ukraine.

Shocking Brutal Murder

Petlura stepped out of the fashionable Chartier Restaurant at 2:15 p.m. Schwartzbard walked through the crowd of mostly students on the Rue Racine and said: "Are you Petlura?" As his victim turned the killer pulled out a Browning automatic pistol and fired one shot. Petlura fell to the sidewalk and said, "my God!"

Schwartzbard stood over him and said, "Defend yourself - dog!" He then pumped four more shots into the prostrate body of Petlura. The date was May 25, 1926. Simon Petlura, great hero of the Ukrainian people was dead - He was only 47 years old.

Schwartzbard became an instant hero to organized Jewry. They said he had slain the "new Haman." Instantly Jewish communities throughout the world organized "Schwartzbard

Defense Committees." They were formed in London, Berlin, Moscow, New York, Chicago and even Shanghai and many other cities. Delegations of Jewish leaders arrived from around the world to demand "freedom for Schwartzbard." Believe it or not the Jews were able to plant favorable news items in the Paris press that Schwartzbard was "justified" because Petlura had persecuted the Jews of the Ukraine.

During past famous trials of accused Jews such as the Dreyfus case, Leo Frank murder case,

Ethel and Julius Rosenberg, Atomic Bombspy case, world Jewry united behind their racial brothers. They stressed the theme that the Jews had been victims of "pogroms" under the two year rule of Petlura in the independent Ukraine. The French Prosecutor, Albert Willm told the jury:

"The Bolsheviks invading the Ukraine had the greatest talent for sending Jewish functionaries as agents provocateurs, people's commissars, and chiefs of the Chekas. Among these secret police chiefs there were some

women, very often more cruel than the men. Inevitably, when the Bolsheviks had to fight in retreat, the populations which had been exposed to all the violence, to all the cruelty, to all the infamies that occurred, held the Jewish people responsible."

Still, when the jury returned, they had been swayed by the massive pro-Jewish press and street demonstrations and found Schwartzbard "not guilty". Immediately Jews poured into the streets of Paris singing and dancing. Jews in the courtroom erupted with cheers and laughter. They attacked Ukrainian friends of the Petlura family right in the courtroom with fists and canes. The police had to escort the Ukrainians out into the street but the Jews were there also. Again they were set upon by screaming Jews and the police had to fight to save the Ukrainians from the vengeful Jews.

It should be remembered that Simon Petlura's slogan to the Ukrainian people in Paris was, "The Ukraine will be restored

tomorrow - the Bolshevik tyranny shall be destroyed!"

The following is found on page 336 of Vol. 10 of the 1934 edition of the Jewish Encyclopedia

"With the complete repulse of the Petlurists by the Red Army anti-Jewish attacks in the Ukraine ceased. Pinchus Krasny (Jew) was appointed minister for Jewish Affairs in June 1920. By the end of 1921 all anti-Jewish organizations in the Ukraine has been suppressed. The Jewish self-defense units in the Ukraine were disbanded by the Soviet government in that year on the ground that there was no longer any need for them.

"In the Ukraine, as elsewhere in Russia, there was organized a 'Jewish National Center', under permission granted by

the Soviet Central Committee that where local Jews formed a majority they could organize Soviets, (communities), with Yiddish as their official language. In 1925 there were in the Ukraine 342 schools with Yiddish as their official language, attended by 56,394 Jewish children."

In May of that year the Communist Central Committee approved the establishment of separate Jewish regions. Even entire Ukrainian cities were turned over to the Jews as new "Jewish autonomous areas" as a reward for helping the communist conquer the Ukraine. On page 335 there is a picture of the Ukrainian city of Kalinindorf which was handed over to the Communist Jews who renamed it "Stalindorf!"

Criminal charges urged against Butler

A Jewish civil rights attorney said Wednesday that she hopes criminal charges will be brought soon against Aryan Nations leader Richard Butler.

If charges aren't filed, people opposing racism and violence in North Idaho should consider filing a civil lawsuit, Betsy Rosenthal of Los Angeles said in Spokane.

On another front, those opposing right-wing violence should consider passing paramilitary training laws to outlaw weapons training conducted to cause public disorder, said Rosenthal, Western states counsel for the Anti-Defamation League of B'nai B'rith.

The ADL attorney said she didn't know what type of civil action could be brought against Butler and his Aryan Nations church, "but there's no reason not to take a look at this."

She said the ADL might consider providing legal assistance if such a court fight were launched.

"If it would result in seeing Richard Butler behind bars, I'd support it fully," she said.

Rosenthal said she's "hopeful there won't be a need to pursue civil action" if federal authorities file criminal charges.

"It seems all along that Butler has been the mastermind of these plans," she said, "but no one has been able to catch him with his

hand in the cookie jar.

Laws outlawing paramilitary training hamper activities such as those that have been conducted at the Aryan Nations compound in North Idaho, Rosenthal said.

Fourteen states, including Oregon, have passed laws banning paramilitary training. In Florida, five Ku Klux Klansmen were indicted and convicted this year under that state's law.

Rosenthal met Tuesday in Boise with the Idaho attorney general and his staff. The agency is considering introducing such a bill in the 1987 Idaho Legislature.

A similar law was introduced in the Washington Legislature in 1985 but was defeated.

CIA's Casey OKd sharing profits with Mossad

MILLIONS of dollars in profits on the Iran-contra arms deal are unaccounted for — and some of the money was diverted to Mossad, the Israeli intelligence service, according to our sources.

What the Congressional investigators into the Iran-contra arms deal don't know is that, during secret discussions with the Israelis on the arms sales, it was understood by all concerned that some of the profits would go to Mossad for its undercover operations in Europe and the Middle East.

In return, the CIA would share in part of the intelligence "take" from the secretly funded operations.

"The Israelis always need cash, and especially Mossad," explained one source familiar with the arms sales. "They need fat Swiss accounts to pay off informants and run their intelligence network."

The arrangement would help to explain how Israeli enthusiasm reportedly kept the dubious scheme alive when some U.S. officials began to get cold feet.

Bonds slowed by Pollard case

TEL AVIV (JTA)—The Israel Bonds Organization has taken a low profile in the U.S. since exposure of the Jonathan Pollard spy case, its world president Yehuda Helevy said.

Helevy told Israel Radio that the Pollard affair would cause a temporary suspension of Bonds activity among non-Jewish organizations, including commercial firms, banks and pension funds. Those bodies are said to account for 30-35 percent of annual Bonds sales in the U.S.

Helevy said at the opening of the Bonds conference in Haifa that a record \$603 million worth of Israel Bonds were sold last year.
