Israel's Brutal 20 Year Occupation

Israel Is Not A Democracy

Israel has no Constitution or Bill of Rights. Israel has military censors which can silence free speech in newspapers, TV., books, plays, movies, etc. They have banned 648 books including Shakespeare's "Merchant of Venice." The Shin Bet secret police can arrest without charge, extract confessions through torture and brutalize anyone who dares defy them. Palestinians can be expelled out of their own country. Their home can be dynamited if they are "suspected of terrorism."

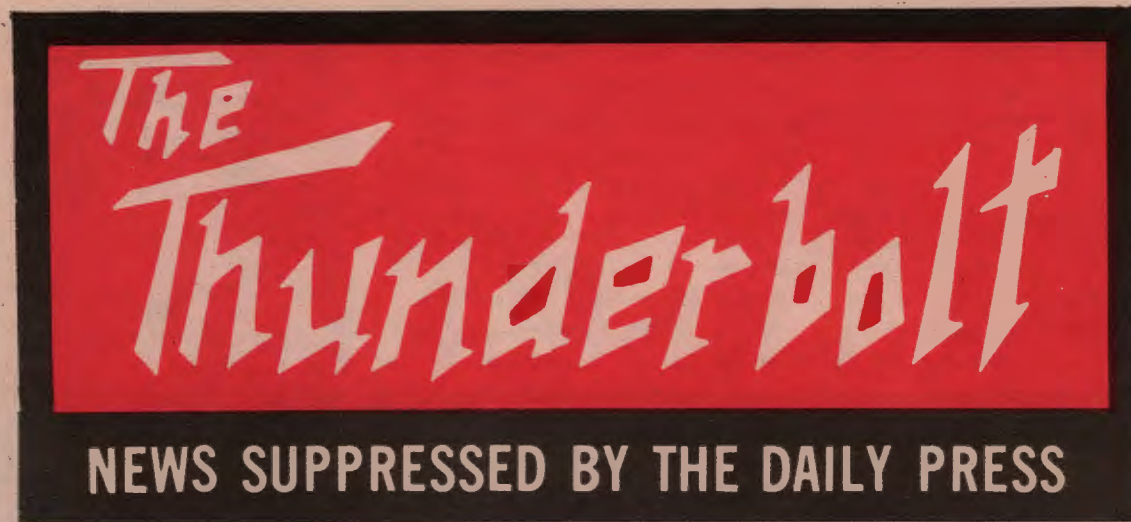
Jews residing in Israel proper, (the East Bank), number around 3 million and rule with dictatorial power over 700,000 Arabs who make up 17% of the population. (On the West bank some 50,000 Jews - ALL BORN OUTSIDE PALESTINE - rule over 850,000 Arabs).

Every Arab is considered a "security risk" even though they are Israeli citizens. Anyone can be summarily exiled from his home and restricted to live in special zones. Entire villages have been forcibly emptied to make way for Jewish settlements or for Kibbutz collective communist farms.

Arabs inside Israel are supposed to have "equal rights" as citizens. There are no Israeli Arabs in any senior position in the government or civil service. There are no Arabs on the staff of any Israeli embassy. They have never had any representation in the cabinet.

Israel Admits Torturing Arabs

June 1, 1987, The Israeli Supreme Court ruled that Lt. Izat Nafso, 32, a member of the Circassian Moslem minority, who served in Israel's army had been tortured by Israel's secret police, called "Shin Bet". He confessed to totally false charges of treason and espionage. Then the Shin Bet agents lied against him in court. Nafso had already served 7½ years of his 18 year sentence when the court released him. This resulted in an Israeli commission being formed to investigate the charges of torture. Still, Israel's Attorney General Yosef Harish said, the government would not be required to accept the results of the commission's inquiry.

U.S. investigators charged that Israel was not living up to a commitment last February from Prime Minister Shamir that Israel would cooperate by responding in writing to American questions.

The investigators have rejected the latest Israeli demand that the U.S. grant immunity from criminal prosecution to all Israeli citizens implicated in the Iranian financial transactions as a precondition for the sharing of Israeli-collected data.

Large sums of money remained unaccounted for.

U.S. officials said Israel was especially interested in trying to protect Amiram Nir, adviser to the Prime Minister on counterterrorism; Ya'acov Nimrodi, an arms dealer;

The four were the key Israeli contacts in the ill-fated U.S. arms deal with Iran. Their actions are said to have been authorized by then-prime minister Shimon Peres and his cabinet.

WASHINGTON. - Israel was last week reported to have played a key role in transferring Soviet-made weapons from Poland to Honduras and then on to the Contra rebels in Nicaragua.

According to the U.S. sources, private Israeli arms dealers purchased thousands of AK-47 assault rifles, which the Soviet Union has licensed Poland to manufacture. Those rifles were then shipped from the Polish port of Gdansk to Portugal and from there to Honduras.

The bills of lading in Honduras, the sources said, listed the weapons as Israeli-made.

U.S. investigators looking into the Iran-Contra arms affair are said to have copies of those Israeli documents, which indicate that the Israeli Defence Ministry had officially authorized the transactions, knowing that they were destined for the Contras. The Honduras army does not use Soviet-made weapons.

In recent months, there have been numerous stories in the U.S. press that Israel sold Soviet-made weapons captured from the PLO in Lebanon to Honduras and that those weapons were then made available to the Contras.

But U.S. sources last week suggested that most of those Soviet weapons did not come from Lebanon but from Poland. Israeli officials have firmly denied that they were involved in directly helping the Contras in any way. But both the Tower Commission and the Senate Intelligence Committee reported evidence of Israeli involvement.

Thousands of Arabs Tortured By The Jews

There are 4,000 Palestinians in Israeli jails - THEY ALL CONFESSED after days of interrogation by Shin Bet agents. In the Nafso case it was found that he had been beaten, tortured with extremely hot and cold showers for 21 days before he signed a confession. This case proves the charges by Amnesty International that Israel has been torturing prisoners since the mini-state was founded in 1948.

Hodding Carter First Exposed Israel's Torture

Feb. 8, 1979, It was the Carter Administration's State Dept. spokesman, Hodding Carter, III who released the secret cables from our embassy in Tel Aviv. He said, "these credible sources, make it appear that instances of mistreatment of prisoners has occurred." The Washington Post carried more details but most of the nation's press suppressed the story.

Israel's Justice Minister Shmuel Tamir issued a "total denial" of the report. He lashed into the Post saying the charges of torture are "utterly false, baseless and libelous."

The cables stated: "the use of brutality in the interrogation of Arab prisoners is a systemic practice. Severe treatment include refrigeration, (in an ice room), the use of electricity, hanging by the hands or feet, extreme forms of sexual sadism, interrogation accompanied by starvation and enforced sleeplessness."

U.S. Jews Defend Israel Against Charges

"The Conference of Presidents of Major American Jewish Organizations," headed in 1979 by Theodore R. Mann declared: "Israel respects human rights and does not engage in torture. Such allegations to the media stem from anti-Israel motives. The Washington Post has joined with extremist groups in the United States in a blatant anti-Israel propaganda effort."

(Note:) The Post wrote: "U.S. consular officials in Israel had concluded that the Israeli torture of Arab prisoners in the occupied territories may be a widespread and even common practice."

The Jewish Community Council of Washington, D.C. issued a statement which in part stated: "These cables are self-serving statements of convicted terrorists dedicated to the destruction of the state of Israel . . . and eager to explain away their criminal behavior in order to be admitted to the United States."

Amnesty International, later in 1984 charged Israel with torturing prisoners. Then, in June of 1986 it was revealed that Shin Bet agents had seized two Palestinians who had hijacked a bus. Shin Bet said they were both killed in the fighting. But, a photographer had pictures of them alive, being taken away from the incident. Later their bodies were dug from their graves. Both had been viciously beaten to death.

This case revealed the identity of Shin Bet's leader, Avraham Shalom. The super-secret Shin Bet had never before had the name of its head exposed. Their methods are so violent that Shin Bet believes its leaders are in danger of assassination from relatives of the thousands of prisoners they have tortured. Thus Shalom resigned.

Prime Minister Shamir granted pardons to Shalom and the 11 Shin Bet agents involved in the murders: "because to make public how the counter-intelligence agency operates would damage Israel's national security." Shamir, an old terrorist himself, added that with the granting of these pardons there was no point to an investigation. Thus the "investigation" ended!

It is of interest that Israel's chief supporters in America are those who proclaim human rights as their highest goal. Still, is there any other country in the "free world" which practices the mistreatment of a persecuted people as exemplified by the suffering of the Palestinians? These truths have been made known. Still members of Congress continue to take orders from the Jewish lobby! The answer is to reach the general public with the facts. Then and only then can we cut off this obscene orgy of massive foreign aid to Israel which has made all these horrors possible. Israel criticized on 'human rights'

LONDON. - Israel's human rights record, especially its treatment of detainees in the administered territories, is criticized by the London-based Amnesty International in its annual report, published last week. The organization records that during 1984 "dozens of regular, border and

military police" were charged with offences against suspects, and 17 were subsequently sentenced.

In the "occupied territories" it reports allegations which include the routine use of prolonged periods of hooding and enforced standing, beatings, sleep deprivation and subjection to hot and cold showers, "as well as insults, and threats to and humiliation of detainees and their families."

Their heads had been bashed in. Minister Ahrens, who was at the scene, reported they were killed while trying to hijack a bus. Alex Levac, a photographer for "Hadashot" newspaper, had this photo held up by Israel's censors for six weeks. Then he released it overseas and the atrocity was revealed. Thus the censor ordered "Hadashot" closed. A poll revealed that 84% of all Jews found the murders "acceptable."

Torture Policy Admitted

JERUSALEM - Israel's Supreme Court, in a landmark decision that could have a profound effect on the nation's internal security apparatus, ruled Sunday that a Moslem army officer convicted of treason seven years ago was innocent and that the evidence against him had been fabricated.

In exonerating Izat Nafsu, a former army lieutenant and member of Israel's Circassian Moslem minority, the court issued what legal observers said was a de facto indictment of the Shin Bet, the highly secretive Israeli internal security organization. Shin Bet's questionable methods of interrogation have been a subject of controversy since a scandal last year.

— could spur appeals by many of the 4,000 Palestinian prisoners in Israeli jails.

Most of these prisoners have been convicted largely on the basis of confessions extracted by the Shin Bet.

The court ruling, handed down after 12 hours of deliberations, found that Shin Bet officers perjured themselves before the military tribunal that originally convicted Nafsu in 1981 and used "unethical interrogation methods" to force him to confess to crimes he did not commit.

Torture denied

Jerusalem Post Reporter

Aluf Shmuel Goren, coordinator of activities in the territories, last week denounced allegations that Palestinian security detainees are tortured and beaten in Israeli prisons as "lies from beginning to end."

Goren said he had not yet read Amnesty International's annual report which appeared in London Tuesday and contains allegations of Israeli abuses.

Goren, who spoke during a press tour of Far'a detention centre near Nablus, admitted that there may be "deviations" in which abuses of Palestinian prisoners do occur.

He said that the general policy regarding security detainees forbids beatings or other forms of physical abuse.

"We are used to these annual exaggerations," one official said, claiming that Israel "continues to be a country of law and order and a beacon of democracy in very difficult circumstances."

David Horowitz writes from London:

Amnesty International criticized Israel for what it calls its increased use of administrative measures to restrict individuals without charge or trial, and for denying internationally accepted rights to prisoners captured by the IDF in South Lebanon.

In its annual report for 1985 published last week, the London-based human-rights organization also expresses concern about "allegations of ill-treatment and torture of detainees in Israel, the occupied territories and South Lebanon."

It also reports beatings and electric-shock torture, directed by Israeli intelligence personnel, in an SLA-run prison in South Lebanon.

The report says Amnesty received the names of 126 people administratively detained between July and December 1985, including students, journalists and trade unionists. It adds that "two field workers for a West Bank human-rights organization who had been interviewing ex-detainees about prison conditions" were among those detained.

Reports reaching Amnesty suggested that "hooding, enforced standings, beatings, sleep deprivation, threats and insults" were routine.

Thank you for your recent account in connection with the work of the Conservative and Unionist Party.

I found your proposal in connection with President Waldheim reasonable. It is to be regretted that on nominating him, the ÖVP could not take into account the political campaign that was launched against him later. Analyzing the situation now, I share your opinion, that in the field of foreign policy the person of Mr Waldheim exerts a detrimental effect on the international Conservative movement and isolates Austria from our Western friends. This isolation may result in a more vigorous orientation of the country towards the Soviet Block. Therefore I regard the resolving of the issue opportune. In this way, it seems to be advisable to persuade President Waldheim to resign in the course of 1987 citing health reasons.

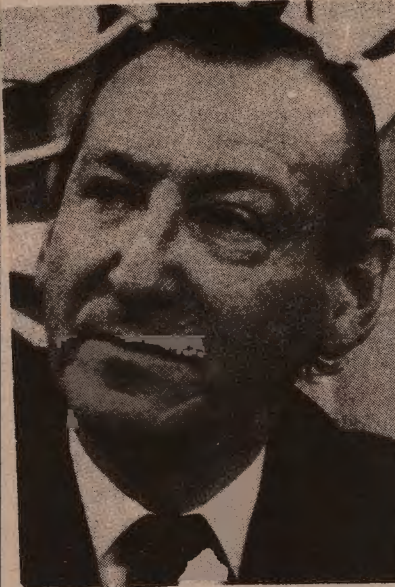
From the point of view of domestic policy - contrary to foreign policy considerations - the fact that Dr Waldheim was elected Federal President has considerably strengthened the position of the ÖVP, since it has meant an advance for the Conservative forces. On the basis of this, the position of the ÖVP is that we should wait until the Austrian domestic political life returns to normal after the elections and leave this issue open until that time. In the present situation the resignation of President Waldheim could do more harm to the ÖVP as a party than staying in power and exercising restraint in foreign policy.

Fake Waldheim Letter Exposed

Israel Secret Police Plant Forged Letter In Vindictive Attempt To Drive Waldheim From Office

The World Jewish Congress headed by Canadian whiskey baron head of Seagrams Distilleries, admitted their move against Kurt Waldheim is designed to drive him out of office as President. They seek to make Waldheim an example of Jewish power so as to frighten into silence anyone who would dare criticize the political goals of Zionism.

The Thunderbolt now presents readers with yet another vital news story which has been **SUPPRESSED BY THE DAILY PRESS!** The World Jewish Congress is using criminal forgery with a faked letter from President Waldheim. The experts in this type of skulduggery are Israel's secret police, "MOSSAD."

Austria's Foreign Minister, Alois Mock, wrote a friendly letter to British Prime Minister Margaret Thatcher on Dec. 18th. It did not even mention the name of Kurt Waldheim. Then, mysteriously, a copy of another letter, purported to be the one from Mock to Mrs. Thatcher, now dated Dec. 15, is circulated among foreign diplomats and the media. This letter is next published in The Jerusalem Post which is often referred to as the "voice of Israel."

Experts quickly declared the signature of Alois Mock **TO BE A CLEVER FORGERY!** The fake letter to Mrs. Thatcher contains these words:

"This isolation, (of Waldheim), may result in a more vigorous orientation of the country towards the Soviet block.

"Therefore, I regard the resolving of the issue opportune. In this way it seems advisable to persuade President Waldheim to resign in the course of 1987 citing health reasons."

The diabolical letter is designed to spread unsettling rumors to the effect that Waldheim will resign as President of Austria. Organized Jewry has left no stone unturned in their efforts to force Waldheim out of office. Alois Mock charged: "The international public will not be influenced by such a falsification. This is part of the atrocious campaign against our head of state, Dr. Kurt Waldheim, and the Austrian people."

Edgar Bronfman Blasts Austria

World Jewish Congress head, Edgar Bronfman, spoke before his group's annual convention held in Budapest, Hungary, (A Soviet puppet state). He "applauded" U.S. Atty. Gen. Edwin Meese's decision to bow to their demands and ban Waldheim from America.

Pres. Waldheim announced on May 7 that he is going to file a slander suit against Bronfman. When asked about the suit, Bronfman, one of the world's richest men arrogantly remarked, "I don't take him seriously as a human being. He was part of the Nazi killing machine. Austria is a third-rate country.

Why Jews Hate Waldheim

The Jerusalem Post of May 9, charged "Kurt Waldheim's actions as U.N. Secretary-General were designed to aid the Arabs during the Yom Kippur War. Once the military advantage changed to Israel's side he called for a cease fire."

The truth is Waldheim sought to maintain peace at all times but if one does not always favor Israel they will viciously turn on you. The Jewish Students Network has demanded Waldheim be stripped of his U.N. pension of \$81,650. Alan Oirich, head of the group, would have Waldheim's pension given to a holocaust survivors group. This has no chance as the U.N. just decided to issue a new postage stamp honoring Waldheim.

Israel Wants To Try Waldheim For "War Crimes"

Israel's Justice Minister, Yitzhak Modai, proclaimed that if Waldheim could be brought to Israel, (does he mean kidnapped?) they could try him as a war criminal. Still Modai admitted, "We don't have any documents or proof... his reprisal actions, (against communist guerillas) would be sufficient to implicate Waldheim."

Thus Jewish vengeance knew no bounds. Their attempt to make an example out of Waldheim has already boomeranged. Reuters poll of Austrians found those who believe Jews have an aversion to hard work rose from 32% in 1980 to 39% after Waldheim's being banned from America. Another question was, "do the Jews possess too much economic and political vengeance." Those who agree rose from 33% in 1980 to 48% today. The poll also found that 16% thought Austria would be better off if no Jews lived there at all, and 38% believe "Jews are responsible for their own persecution in the past!"

Israeli Officials Ask Torture By Legalized!

JERUSALEM (JPFS) — Israel's internal security service, the Shin Bet, has stirred a political storm with a proposal to legalize now-impermissible interrogation techniques.

The bill would legalize interrogation methods which the Shin Bet claims have been in use for the past 20 years. Evidence obtained by these methods — which reportedly include torture and perjury — would become admissible in court for the first time. The proposal was presented to the cabinet by the head of the Shin Bet, with the approval of Attorney General Yosef Harish.

The Shin Bet's legislative initiative came in response to the Supreme Court appeal of Izzat Nafsu, the former Israel Army officer who was recently cleared of treason and espionage charges after serving seven and a half years of an 18-year prison term. The court upheld Nafsu's claim that he was framed and that his conviction was obtained by Shin Bet torture and false evidence.

Israeli courts by tradition do not question the Shin Bet's sources of information, and Nafsu's successful appeal has shaken the agency's image of efficient reliability.

In negotiations with justice authorities leading to the Supreme Court's hearing of the Nafsu appeal, the Shin Bet asserted that any improper techniques used to interrogate Nafsu merely reflected standard Shin Bet practice in investigating security offenders.

The Shin Bet claimed it has never adhered to the so-called "Judges' Rules" regulating interrogation methods and that its operatives have consistently committed perjury to establish the admissibility of evidence.

Mock told reporters in Vienna last week: "The letter does not exist. It is a macabre, repeat macabre, piece of shame. I just hope that the international public will not be influenced by such a falsification, which is part of the atrocious campaign against our head of state, Dr. Kurt Waldheim, and Austria itself."

Austrian Chancellor Franz Vranitzky, in his weekly press conference, referred to publication of The Post story as "an abominable political act of inciting a bad atmosphere," and as an unheard-of method which had to be rejected wholeheartedly.

Michael Graff, the general secretary of the People's Party, said he had no doubts about who was behind the letter — the World Jewish Congress and the "Anti-Waldheim mafia."

The WJC has repeatedly raised charges concerning Waldheim's Nazi past.

"This is exactly how you incite anti-Semitism," Graff said.

Mock, who is Graff's boss, added: "We know who has been behind campaigns like this in the past."

Waldheim's spokesman, Gerold Christian, labelled the Post story a lie. "The Jerusalem Post's informers are either liars or forgers," he said.

Germans Never Allowed Torture

Do Jews Accuse Germans Of Torture Which They Commonly Use Themselves?

It is natural for people to place their own inherent traits and faults on their enemies. We now know the Jewish secret police in Israel, with the full approval of their leaders, regularly and commonly practice torture on both the Palestinian and Lebanese people.

Knowing the sadistic nature of this race Joseph Stalin choose Jews as the heads of the NKVD, (now the KGB) in occupied areas of the Ukraine, Latvia, Estonia and Lithuania. Solzhenitsyn, in his book "Gulag" said that all of the Commandants of the Soviet concentration camp system, whom he knew, were Jews. He

published photos of four Jewish camp heads in "Gulag". (This book can be found in every library!)

Of course, one can read any of the holocaust studies books we have on our list and learn that not one single Jew was ever gassed in any camp. Few realize that Heinrich Himmler, in 1943, gave the order to all concentration camp heads that, "no brutality is to be allowed!" Himmler established an Office of Public Prosecutor to watch over conditions in the camps. It was headed by Judge Konrad Morgen. His office investigated some 800 cases of "brutality" in the camps. Some were found guilty and sent to prison and several were even given a death sentence.

Commandant Koch, head of

the Buchenwald camp, was arrested in 1943 and charged with murdering several prisoners. He was found guilty in Judge Morgen's court and sentenced to death. His execution was carried out by Prince Waldeck who was head of that district.

In Israel there is no such special prosecutors office as the Germans had to prevent the mistreatment of prisoners. Practically all of the 300,000 Jews who died in these camps perished in the very last few months of the war when starvation and typhus swept through the camps. No one was ever tortured in a German camp. The Jews are today accusing the Germans of the type of torture which they have now confessed to in Israel!

Civil Rights In Israel Compared With South Africa

Oppressive Life Of Palestinians In The West Bank

Jews in both America and Israel have been in the forefront lobbying for economic sanctions against South Africa. The truth is that Negroes in South Africa have far more rights than do the Arabs in their own homeland of Palestine! Here are just a few comparisons.

Jews Outnumbered 10 - 1.

South Africa's Whites are outnumbered by non-whites 4 to 1. Jews and liberals say this means they should allow the blacks to rule over their nation. In the West Bank of Palestine Arabs outnumber Jews more than 10 to 1. Still, Jews and liberals say that Palestinians have no civil rights and no human rights and should submit to never-ending brutal rule by the Jewish military and secret police.

Arabs Have No Civil Rights

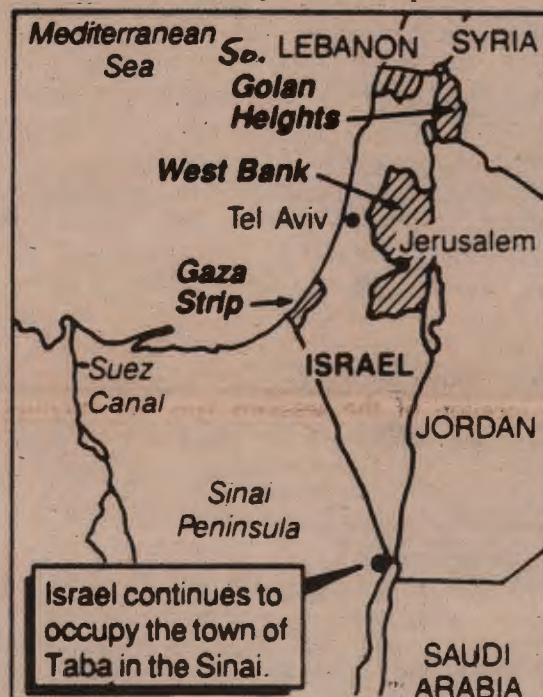
Negroes have the right to organize labor unions in South Africa but this is forbidden Arabs living in the West Bank and Gaza. Negroes can leave South Africa and return. Any Palestinian who leaves the West Bank or Gaza cannot return because Jews feel, "this is one less Arab." No Arab can produce any product for sale in Israel or overseas if it competes with a Jewish made item. (Not so in South Africa.) Jews have closed Arab newspapers and removed Arabs from elective office. No Negro elected to office in any Black township in South Africa has ever been removed from office. Jews can lease land for 49 to 90 years but Arabs are limited to 11 months. (Not so in South Africa black districts.)

Ousted From Own Land

Here are more Israeli acts of oppression not existing in South Africa. West Bank Arabs can be deported out of their native land. Jews cannot. West Bank Arabs can be arrested without being charged, Jews cannot. West Bank Arabs cannot live in Tel Aviv, organize political groups, or vote. (Blacks in South Africa can vote in their townships.) Arabs are not allowed to own guns but Jew civilians in the West Bank are heavily armed. Some Jewish local councils such as Kiryat and Arba have voted to ban Arabs from any municipal jobs. They passed a resolution discouraging any local plant from hiring an Arab.

What hypocrisy it is for American liberals to support such an un-democratic state as Israel! **There should be economic sanctions against Israel - NOT SOUTH AFRICA!**

Any Jew can buy a home and open a business in the West Bank. No West Bank Arab is allowed to buy a home or start a business in Israel proper.

The 70,000 West Bank Arabs who work in Israel must be out of town by sunset. Those who work night shifts must be locked in their place of employment from the outside. There have been many recorded incidents of Palestinians being burned alive in fires because they were unable to escape through the locked gates. Arab farmers are not allowed to grow oranges because this is a chief Jewish export. (No Arab business competition with Jewish

businessmen is allowed.) Arabs are encouraged to grow products such as strawberries because they are backbreaking to pick and cannot be exported as they are much more perishable.

Palestinians suffer the torture of those arrested and the dynamiting of their homes BEFORE CONVICTION.

The typical Jewish attitude toward the Palestinian people can quickly be summed up from these statements by Israel's leaders.

Golda Meir said: "There is no Palestinian people."

Job Discrimination Against Arabs

The production of military weapons is Israel's chief industry. They sell munitions world-wide. Israel's Arab "citizens" are not allowed to work in these "defense factories." Thus there are no jobs for those who study modern technology. The Jewish magazine "Present Tense" quotes one Arab youth, "I thought I was smart to study metalworking but they still would not hire me. They only want us Arabs to do the dirty jobs that Jews don't want to do."

Family Allowances Not For Arabs

Israel wants to increase the Jewish birthrate but not that of the Arabs. Child allowances are paid to families with three or more children. This law requires that recipients must either be veterans or yeshiva (Jewish religious) students. Since all Jews are required to serve in the military and Arabs are banned from service only one racial group can collect these funds. While Arab families are twice as large as the Jews their average income is 66% of an average Jewish household.

Discrimination In Education

Israeli Arabs make up only 1% of college students yet are 17% of the population. Rabbi Emanuel Rackman says: "They are admitted if they qualify. There is a high Zionist sentiment here so we don't socialize with them." There are few jobs waiting for the Arab graduate.

Gil Sedan, of the "Chicago Jewish Sentinel" wrote: "The Israeli economy relies heavily on low-wage Arab labor."

Arabs Not Allowed to Buy Land

Nearly 89% of all the land in Israel proper is owned by the government and the National Jewish Fund. It is against the law for a Jew to sell property to an Arab. At the same time most of the land inside Israel was confiscated from the Palestinian people in 1948. In 1961 the U.N. ordered that Arabs receive restitution on the basis of the property tax value at the time of seizure plus 25%. The Jews agreed.

Discussion began on the compensation and have continued ever since. When one bargains with Jews to receive your money back the discussions can continue forever.

Associated Press of May 8, 1986, reported the story of a Jewish reporter, Yoram Binur, 31, who dressed as an Arab for six weeks to see what their lives are like. He was often stopped and questioned by police. Jewish landlords refused to rent to him. He was given poor service in restaurants, and the one bar where he was admitted, the Jewish women complained. The owner told Binur he would not be allowed in again.

Rep. Kemp Favored At Secret Jew Meeting

GOP Presidential Candidates Appear Before Secret Jewish Tribunal

"Jewish Post and Opinion" of May 13th reveals that all the leading Republican candidates for President appeared before the National Jewish Coalition. Its head Max Fisher is the richest Jew in Detroit. NOTE that the meeting was closed to the press and held at a secret location.

After the meeting, Mark Neuman, spokesman for the coalition gave Bernard Weinraub of the New York Times a briefing. Neuman said each of the candidates waited in an anti-room and were brought in to face the wealthy Jewish businessmen one at a time. Neuman added, "this was not a cattle show." (Note: Many Jews refer to Gentiles as the "goyim" - which happens to also mean "cattle!")

Sen. Bob Dole appeared first declaring he would support creating a "role in the North Atlantic Treaty Organization (NATO) for Israel." This could mean more free military aid. Dole also advocated, "a new level of strategic partnership between the U.S. and Israel."

Vice-Pres. George Bush entered the room and said the Pollard spy affair "would not alter America's commitment to Israel!" Bush was asked about his criticism of Israel's bloody invasion of Lebanon and their bombing of Iraq's nuclear reactor. Instead of standing up like a man defending his past statements condemning Jewish aggression, Bush meekly whined: "My views have been misrepresented in the press."

The purpose of NATO is to fight off any attack by the Soviet Union. Israel's leaders have time and again declared they would be neutral in the event of any war between the West and Russia.

Rep. Jack Kemp Brings Down The House

Rep. Jack Kemp came into the room and told the Jews he was the only candidate who has voted AGAINST every single bill which would allow the U.S. government to sell arms to the Arab nations. The Jews jumped to their feet and gave Kemp a standing ovation. He also said that if elected President he would appoint the darling of the Jews, former U.N. Ambassador Jean Kirkpatrick as Secretary of State in order, "to clean out the Arabists in the State Department."

(Note: The word "Arabists" is one used by Jews to slur those few left in government who still believe in an even-handed U.S. policy in the Middle East.)

Pat Robertson received a "cool and restrained reception" from the Jews. Neuman said Jews fear he may try and "tear down the walls separating church and state." In the end Robertson, "handled himself very well and relieved a great deal of anxiety", according to Neuman.

Presidential Hopefuls Go For The Money

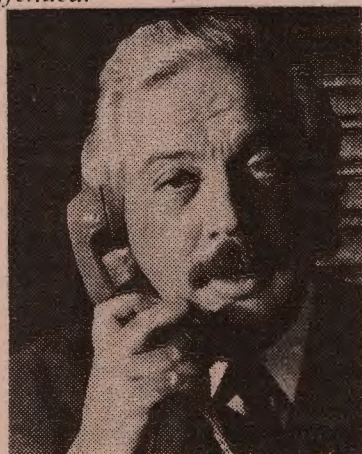
Vice-Pres. Bush's campaign fund raiser is the Jew Gordon B. Zacks, a wealthy Ohio businessman.

At least five Republican presidential candidates were queried on their policies, presumably about Israel and other issues of concern to Jews, when they appeared before the National Jewish Coalition, headed by Max Fisher and Gordy Zachs. The candidates included Vice President Bush, Senator Bob Dole, Representative Jack F. Kemp, Alexander M. Haig, Jr., and the Rev. Pat Robertson. Others may have attended the session closed to the press. Even the location of the sessions was not announced. Fisher and Zachs co-chair fundraising for Bush, while Leo Bell does the same for Dole and Richard Fox for Kemp.

Would Close PLO But Not Jewish Lobby

Sen Dole - Rep. Kemp Seek To Close PLO Offices

The U.S. Elections are over a year away but two of our leading political prostitutes are posturing themselves before Jewish voters. Sen. Bob Dole and Rep. Jack Kemp have both introduced bills in the Senate and House which would close the two Palestinian Liberation Organization, (PLO), offices in the U.S.

On Oct. 31, the powerful "Conference of Presidents of Major Jewish Organizations" (representing 40 Jewish groups), called upon Atty. Gen. Edwin Meese to close the PLO office in the U.N. building and its Information Office in Washington. Just last year, under Jewish pressure, the FBI raided the PLO office in Washington and could find no violation of U.S. law. Thus the Jews approached two Republicans who have catered to their every whim.

May 13, Sen. Dole said the PLO office must be closed, "to strengthen the defenses of this country against the threat that the PLO represents."

The PLO has never attacked any American ship, sent spies here, nor terrorized our people. Why not ban the Jewish Defense League which has bombed, burned and murdered innocent Americans? Why not ban the Israeli Bonds Organization whose offices were used to recruit Jonathan Pollard to spy against this country? Why not outlaw the American-Israel Public Affairs Committee, (AIPAC), which is the Jewish Lobby which seeks to subvert our Congress?

Rep. Jack Kemp's bill would make it a felony to give aid to the PLO under the RICO Act. The Justice Dept. said Kemp's bill in nonsense because the PLO is not a money making organization! It should be noted that the U.S. State Dept., has stated that the PLO has a legal right to fight for the independence of the West Bank and Gaza, "inside Palestine."

Also, joining Dole in his anti-PLO bill are Senators Ted Kennedy and Charles Grassley and Jew Senators, Rudy Boschwitz, Frank Lautenberg and Howard Metzenbaum.

Frame-Up by Jewish talk show Host. Connecticut

adopted the Jewish ADL's "model law" whereby anyone using "racial slurs" over the phone could be charged with a misdemeanor punishable by a fine of \$500 and 90 days in jail. WATR-Radio talk show host, Jay Clark, (Jew), often speaks out against the Arabs and U.S. foreign policy.

Thomas Speers phoned in protesting the killing of innocent people by the Jews in Lebanon and the incarceration of hundreds of Palestinians in concentration camps. Clark got together with Waterbury, Conn. Detective Lt. Robert Segal (Jew), and had Speers arrested. When Speers lawyer went before Jewish Judge Samuel Freed to get the charge dismissed his motion was denied. After five days of trial Judge Anthony V. DeMayo ruled that the constitutional free speech issue was so clear-cut that he ordered Speers acquitted. While this is yet another triumph for our First Amendment rights it still shows that organized Jewry is working to undermine our freedoms.

City Won't Ban White Clubs

Coral Gables, Fla., Commission voted 3 to 2 against a resolution which would ban "discriminating clubs", from holding meetings at the city owned Biltmore Hotel. Mayor George Corrigan, who is a member of the all-White Coral Gables Country Club, said such a rule would cost the hotel over \$100,000 a year. Corrigan along with three Commission members, Hildreth, Kerdyk, and Valdes-Fauli, are members of the all-White "10th Holes Golf Assn." (It should be noted that Jewish groups also use the hotel and they ban Gentiles from membership.) At least in this case common sense prevailed.

The Suppressed Truths On the Attempt To Sink The USS Liberty and Kill All Sailors Aboard

Early in the morning of June 8, 1967 low-level Israeli jets buzzed the Liberty as low as 200 feet overhead. They flew so low that some of our sailors sunning themselves on the deck waved back to the pilots. They made at least 13 orbits over the ship which was flying a large American flag over a six hour period.

U.S. Naval Intelligence received word that the Liberty was in danger. They sent five coded warnings to the Liberty to leave the area. **The messages never got through.** Were they misrouted or jammed by Israel? At 1:50 PM in the afternoon Israeli jets attacked the Liberty at close range. Again and again they swept in blasting the ship which was inflicted with 821 rocket, cannon and bullet holes. They even dropped napalm setting the Liberty on fire. Still the ship would not sink.

MAYDAY - MAYDAY messages from the Liberty to the Sixth Fleet were also jammed by Israel. But, at 2:12 PM a message got through. Suddenly, the Jews sent in torpedo boats to finish off the Liberty. They fired six torpedoes and one hit. This single blast was responsible for 25 deaths alone. **STILL THE LIBERTY WOULD NOT SINK!** The torpedo boats machine gunned the Liberty's life boats after they had been lowered into the water in preparation for abandon ship orders. **THE JEWS WANTED NO SURVIVORS.**

3:15 PM two Israeli Hornet assault helicopters arrived carrying armed men in battle dress They were going to land and kill all who were left alive on the Liberty. Capt. McGonagle gave the orders: *"Stand by to repel boarders. They've come to finish us off!"* Suddenly they turned and flew off. The attack left 34 men dead and 171 wounded out of a crew of 317 men.

Why Was The USS Liberty Attacked?

Even 20 years after the horrific attack upon the Liberty many vital questions remained unanswered. The Liberty only had four small .50 caliber machine guns and could not defend itself. This was a sophisticated electronic surveillance ship. **WHY WAS IT ATTACKED?**

Today it is believed that the CIA knew all about Israel's planned invasion of Egypt and the attack against Jordan. But, there was an agreement that Israel was not to invade Syria. The Liberty was able to pick up any and all radio communications between all fighting forces on either side in the war. The Jews planned to seize Syria's Golan Heights!

The Liberty had to be silenced before this operation could be undertaken otherwise Washington would order it halted. Also, there was the chance of quickly sinking the Liberty, killing all the U.S. sailors aboard, **AND THEN BLAMING IT ON THE EGYPTIANS!**

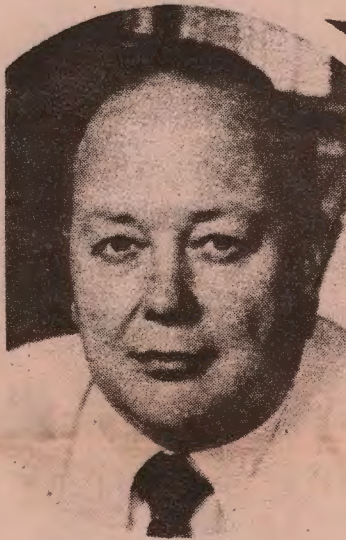

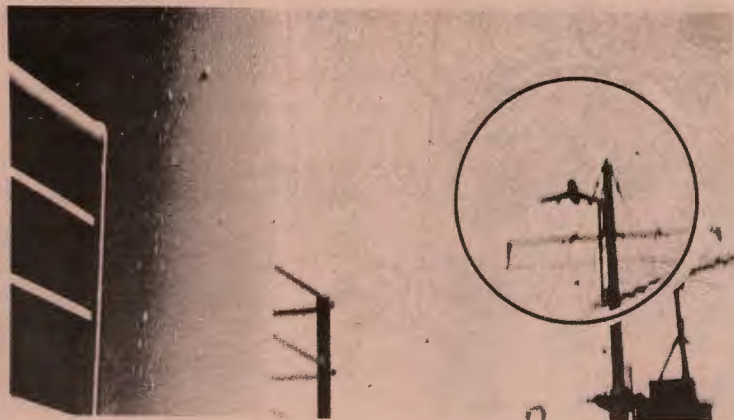

Holocaust study book is issued by Navy

The U.S. Navy has issued a chaplain's workbook and resource packet on observance of the Holocaust, the first such effort by a branch of the American military.

"Horror and Hope: Americans Remember the Holocaust" was distributed to the Navy's 1,150 chaplains—rabbis, priests and ministers—in time for the recent observances of Yom HaShoah and the national Days of Remembrance.

The packet, for use in commemoration services, sermons and classes, includes prayers, articles by theologians and readings on ethics and morality. They range from notes about Jewish resistance and excerpts from Elie Wiesel's "Night" to Simon and Garfunkel's "Sounds of Silence."

The package conveys "an American perspective," says Rabbi Arnold Resnicoff, the naval chaplain who served as project editor. Resnicoff, instructor at the Naval Chaplains School and Naval War College in Newport, R.I., calls the Holocaust "a Jewish event with a universal lesson."

Resnicoff, who spent a year reading "every article, book I could find on the subject," says the project was supported by Defense Secretary Caspar Weinberger and Rear Adm. John McNamara, Navy chief of chaplains.

Pres. Lyndon Johnson Ordered Coverup

5) The U.S. Government suppressed the facts about the attack claiming it continued for only 6 minutes when it went on for over 2 hours! They said it ended with the torpedo attack. Yet, 40 minutes later the same torpedo boats riddled the ship's life boats with bullets rending them unusable. It is a study of World War II which concludes that 200,000 Jews died and not the ballyhooed 6 million figure. For this reason the Jews have launched a national campaign in the U.S. demanding an economic boycott of Japan.

Now comes a report from Jewish Week, May 22nd, that at a dinner for the foreign press Japan's U.N. Press Officer, Masaki Sato, asked the Times "foreign editor," Joseph Lelyveld, (Jew) "How many Jewish editors are employed at the New York Times?"

Lelyveld feigned ignorance by saying he didn't know the "religion" of his editors. The truth is that the Jews are a RACE and only 40% belong to any synagogue. Still the Times sought an apology - DESPITE THIS BEING AN HONEST AND IMPORTANT QUESTION!

Jews boycott Japan

Do two wrongs by Japan, make it right for Jews to boycott that nation's economy?

Reports that anti-Semitic literature has become widespread in Japan, coupled with long adherence by many major Japanese companies to the Arab boycott of Israel, have caused some American Jews to feel the time is right for a counter-boycott of Japanese products and services.

The last time such a boycott was employed by an outraged American Jewish community was after Mexico voted for the infamous United Nations Zionism-is-racism resolution in 1975, when large numbers of American Jews responded by canceling vacations in Mexico. The boycott was so successful that Mexico not only backed off, it granted new landing rights to Israel's national airline, El Al.

Japan, unlike Mexico, is not a one-time violator of Jewish sensitivities. Many Japanese corporations not only give in to Arab demands, they even preempt pressure by voluntary boycotts on both imports from and exports to Israel.

As if this situation in itself were not damaging enough, reports about anti-Semitic literature flooding the Japanese market have shocked many peo-

ple. Based upon "The Protocols of the Elders of Zion," a notorious forgery described by historian Norman Cohn as "a warrant for genocide," books currently popular in Japan include "If You Understand Judea You Can Comprehend the World: 1990 Scenario for the 'Final Economic War.'" Newsweek noted that "If You Understand," written by Masami Uno, recycles the old, vicious falsehoods about Jews controll-

ing the wealth of the world and adds dangerous localized lies, claiming that Jews are behind the damaging rise of the yen; According to Newsweek, the "Jewish corners" of bookstores in Japan now feature more than 50 sensationalized works, with such titles as "The Jewish Plan for Conquest of the World," "How to Read the Hidden Meaning of the Jewish Protocol" and the execrable "Protocols of the Elders of Zion."

Another book, "The Secret of Jewish Power to Control the World," written in 1984 by Eisaburo Saito, a member of the upper house of the Diet (Japan's parliament), is still in circulation. Many of these books claim that Jews hate Japan because Japan sided with Nazi Germany during World War II.

KKK Blamed in Bizarre Case Dallas, Texas, Rev. Dr. Walker L. Railey, is pastor of what the press calls, "the most prestigious church in the area" - The First United Methodist Church Railey, 39, has been an outspoken advocate of racial integration and intermarriage. The Rev. Dr. Railey claims he has received a series of letters from the Ku Klux Klan threatening him, his wife Margaret, and two children over his work for "civil rights."

Then on April 22nd Mrs. Railey was attacked in their garage. She was savagely beaten, strangled and left for dead. Rushed to Presbyterian Hospital doctors say she may never regain consciousness. The FBI and state police entered the case. An officer found a typewriter in the church from which all the threatening KKK letters had been typed.

On May 1st., the police were scheduled to question Rev. Dr. Railey about his whereabouts the night his wife was attacked. Just 4 hours earlier Railey attempted suicide with an overdose of tranquilizers. He recovered and immediately admitted himself to the Timberlawn Psychiatric

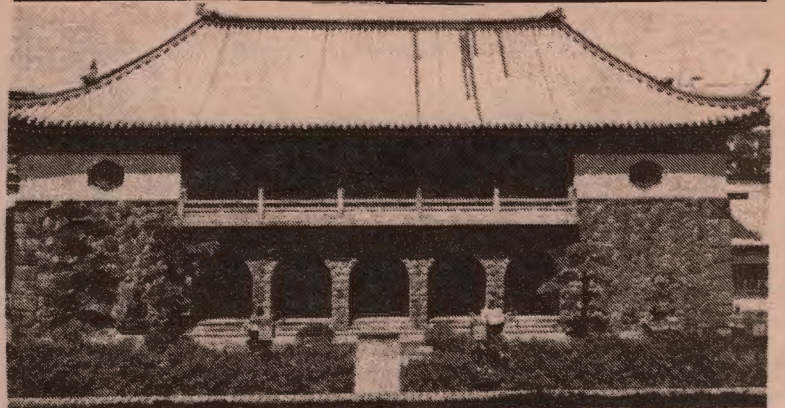
Hospital. There Dr. Casad said Railey was in "no mental condition to be questioned!"

It should be noted that during the period Railey claimed he was threatened by the Klan he was grandstanding by having Dallas police acting as his bodyguards. He even wore a bulletproof vest under his religious vestment while preaching. Observers say this was to gain an appointment as a Bishop!

Rev. Jesse Jackson Defends Rev. Railey

Presidential candidate Rev. Jesse Jackson flew into Houston and attacked the KKK for "wounding Margaret Railey." The Communist Party gave the case major prominence in the May 9th edition of the "Daily World" newspaper. The similarity between current Japanese anti-Semitism and that of pre-World War II Germany (which was rife with anti-Semitic literature and engaged in anti-Jewish boycotts) worries many American Jews. Larry Hochberg, a Midwest and West Coast businessman who led the successful Jewish boycott of Mexico in 1975, thinks the time is right for economic counter-pressure on Japan.

"Japan has to export or die," Hochberg says, "and Jews are tremendous buyers of Japanese products, both as consumers and retailers." A little "educational pressure" now, Hochberg says, may save a lot of grief later.

This does not mean the counter-boycott will happen almost overnight, as the Mexican boycott did. The Zionism-is-racism resolution received much more international attention than the Japanese situation has, and attention translates into action.

Proponents of the counter-boycott concede that there are great obstacles, but say they're not insurmountable. In fact, one advocate notes, in some respects the Japanese are an easier target because, unlike Mexico, Japan does not have a large indigenous Jewish community that could be harmed by a backlash. Furthermore, America already harbors a considerable hostility to Japan

Some American Jewish businessmen have already examined their options on a counter-boycott of Japan and found it feasible. As one Chicago Jewish entrepreneur says, "I may not run to return merchandise already on my shelves and in my warehouses, but I certainly won't run to restock Japanese goods if they continue their anti-Semitism. There is life after Japan: It's called Korea and Taiwan."

And Japan Inc. may be awash in red ink.

Burial of USS Liberty 1967

Crewmen
Six men of the USS Liberty's 34 dead were never identified. Only parts of their bodies were found after the Israeli torpedo boat made a direct hit. All the other 28 dead were sent home for burial by their relatives. Thus the families decided to allow the government to have a "group burial" in Arlington National Cemetery on Aug. 21,

Navy people were shocked to learn that the Liberty coverup was extended even to the burial of the dead! The marker on their grave was made to read: "Died in the Mediterranean." It neither stated the date of their tragic deaths nor the attack in which it occurred!
Thus retired Navy Commander, Xavier B. Tansill, united the families together and

demanding a new marker. In December they gathered once again at the grave site to honor the dead with a new marker declaring "Killed - USS Liberty, June 8, 1967." The names of the dead were listed: James M. Lupton, Jerry L. Goss, Lawrence P. Hayden, David M. Marlborough, Carl C. Nygen, and Marine Sgt. Jack L. Raper.

WASHINGTON — Retired Admiral Thomas Moorer accused the U.S. and Israeli governments Saturday of covering up evidence surrounding the 1967 Israeli attack on the American intelligence ship *USS Liberty*.

Thirty-four American crewmen were killed and 171 wounded in the combined air and sea attack June 8, 1967 against the reconnaissance ship, cruising in international waters 15 miles off the Sinai Peninsula during the Six-Day War.

Israel maintains its fighter pilots, who buzzed the ship for eight hours prior to the attack, and torpedo boat crews, mistook the *Liberty* for an Egyptian ship.

"The Israelis maintain this was simply a case of mistaken identity, but this clearly does not hold water," said Moorer, who was chief of naval operations at the time of the attack "In clear visibility, this unique ship was very easy to identify."

"The Israeli forces circled the ship and then proceeded to attack over an extended period of time. There is simply no way the fighter pilots and torpedo boat crews could have come to such a conclusion," he said.

Moorer, a former chairman of the Joint Chiefs of Staff, joined a dozen

surviving crew members of the *USS Liberty* at a seminar during the annual convention of the American-Arab Anti-Discrimination Committee in Washington.

Moorer said the electronics-laden ship could not have been misidentified by highly-trained Israeli pilots.

He suggested the incident was a deliberate attack to prevent the *Liberty* from picking up signals that would have forewarned the United States of an Israeli military push into Syria the next day.

Israel occupied the Sinai Peninsula, the Gaza Strip and East Jerusalem during the Six-Day War, and drove 12 miles into Syrian territory.

THE RETIRED admiral charged that President Johnson "significantly understated the extent of the casualties," and said no formal congressional hearings were held on the incident, as was the case following the capture of the *USS Pueblo* by North Korea in 1968.

"Based on the way this tragedy was handled, both in the United States and Israel, one must conclude there is much information that has not been made available to the public," said Moorer, who was a member of President Reagan's Foreign Intelligence Advisory Board from 1982 to 1984.

The U.S. Sixth Fleet, positioned nearby, received a distress call from the *Liberty*, and one carrier dispatched a squadron to search for the disabled ship. Before the ship was found, the fleet received orders from Washington ordering the planes back.

"In the United States, all the information available to the U.S. government indicating those who participated in controlling this operation from Washington, together with the exact text of orders transmitted to the Mediterranean fleet and the *Liberty* have never been made public," said Moorer.

Moorer called on the Congress to "once and for all clear up the uncertainties, speculation and unanswered questions surrounding this tragedy, which is still thought by many to be a deliberate cover-up on the part of the government of Israel as well as the government of the United States."

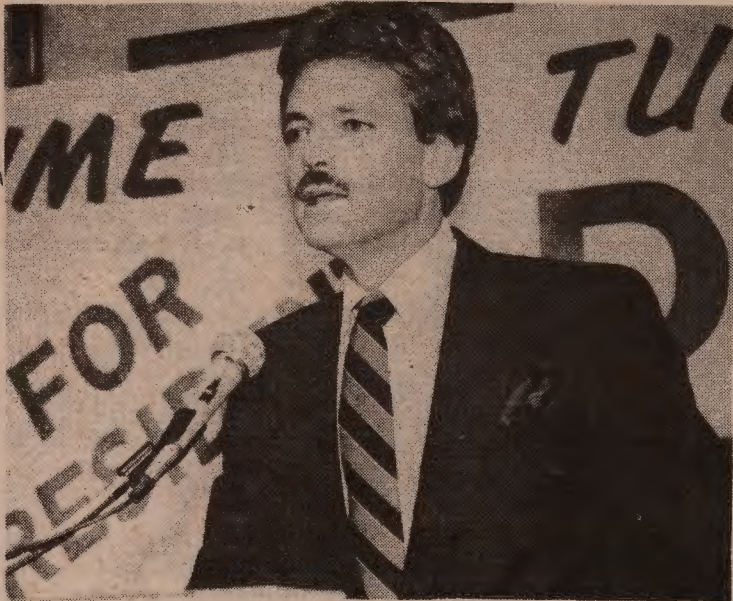

David Duke Runs For President

Duke Opposes, Busing, Reverse Discrimination, Welfare

White rights activist David Duke, who said he will seek the kind of voter who backed George Wallace, told Cobb County supporters he will announce today his candidacy for the Democratic presidential nomination.

Duke, head of the National Association for the Advancement of White People, was to make his official announcement today at the state capitol.

The rally was to have been held at the Ritz-Carlton Atlanta but was cancelled by the hotel late Monday, said the Louisiana native.

"I expect a tremendous fight over the next few months," he told a crowd of about 150 Monday night at the Marietta Marriott. "I can't dismiss the danger. We all know what happened to George Wallace. A lot of people are afraid of a David Duke candidacy."

Duke said he would be campaigning nationwide and plans to visit New Hampshire, site of the nation's first presidential primary, next week.

"If Jesse Jackson can speak for the Rainbow Coalition, why can't we of European descent have a Sunshine Coalition?" he asked.

"I don't know if I can win," he said, "but I know in this state I can beat Jesse Jackson. With the same type of constituency George Wallace had in 1972, I think I can do well."

"Those of us who love our country don't have any choice about whether we want to fight or not," he said.

Duke, 36, an author from New Orleans, assailed affirmative action, welfare, integration, the Internal Revenue Service and the Supreme Court during his speech.

The white majority in this country is paying most of the taxes, he said, but is losing many of its basic rights to affirmative action.

"In Great Britain they make no bones about it and call it affirmative discrimination," he said.

Affirmative action is not needed here, he said, because the rights of minorities are already protected under the 1964 Civil Rights Act.

"How many times have we read about the terrible cost to this country of racial discrimination?" he asked. "Is it not so terrible if a white person is the victim of racial discrimination? We have civil rights too, and we are going to begin standing up for them, no matter what."

Duke cited figures claiming 1 million white people were victims of crimes perpetrated by blacks last year, and said blacks commit 10 to 15 times more crime than whites.

"Welfare is supporting illegitimacy," he said, adding he prefers a "work-fare" system in which those receiving help would have to perform work for the community.

Welfare clients would also have to practice family planning, he said.

"They must not be rewarded for having illegitimate children," he said.

David Duke - Off and Running In a Blaze of Publicity

David Duke, a life long Segregationist leader from New Orleans, announced his candidacy for President in Atlanta's plush Marriott Hotel. What shocked many people was that the Jewish Anti-Defamation League, (ADL) did all within their power to prevent him from holding his meeting in a first class hotel. Note in the articles on this page stating both the Waverly Hotel and Ritz-Carlton cancelled his meetings.

The Waverly admitted they were illegally breaking a signed contract with Duke. The Waverly had been paid, they signed a contract, and knew it was for a meeting whereby Duke could make his formal announcement. The very next day after the invitations were mailed - the hall was cancelled!

The arrogant Jews Stephen Selig and Sherry Frank, both with the American Jewish Committee praised hotel manager Joe Builbault for cancelling the hall stating, "we applaud him for his bold action."

meeting room refused

The manager of a Cobb County hotel has refused to rent a meeting room to white supremacist David Duke, who planned to announce his candidacy for president there Monday.

Joe Guilbault, vice president and general manager of the Stouffer chain's Waverly Hotel, said he canceled Duke's reservation because of fear for the safety of his guests and employees.

"Mr. Duke arranged for a meeting room for a press conference to announce his candidacy for president," Guilbault said. The reservations were booked by the Duke for President campaign committee, he said.

But, Guilbault said, after investigating Duke's background, he decided not to allow him to use space at the hotel.

"I'd never heard of Mr. Duke," he said. "Neither had the catering people. I wanted to know who he was."

Duke, 36, a suburban New Orleans businessman and former leader of the Knights of the Ku Klux Klan, is now president of the National Association for the Advancement of White People.

Guilbault's decision has earned him praise from the Atlanta Black/Jewish Coalition and the local chapter of the American Jewish Committee.

"I applaud what the Waverly Hotel has done," said Stephen Selig, president of the Atlanta chapter of the American Jewish Committee.

In a letter to Guilbault, Selig praised the manager for his "bold action" and called Duke "an affront to the fair and decent people of this country."

Selig said his organization "had no influence" on the Waverly manager's decision.

"We've never pushed the hotel to cancel meeting space, but we're glad they did," said Sherry Frank, who works with both the committee and the coalition.

Duke has described himself as "a populist Democrat in the tradition of Thomas Jefferson and Andrew Jackson."

ADL Stops Tokyo Meeting

NEW YORK — The seeming indifference of the Japanese to the charges of spreading anti-Semitism in many recently published books was somewhat ameliorated as a leading department store chain cancelled sponsorship of a forum at which the author of two anti-Jewish books was the scheduled speaker. The Seibu Department Stores advised Abraham H. Foxman of the Anti-Defamation League of its withdrawal after the ADL protested.

Lone U.S. Marine Backed Down Israeli Tanks

Israel's Military Has Threatened U.S. Forces on Numerous Other Occasions

The attack on the USS Liberty was not Israel's only cold-blooded attempt threatening the lives of American servicemen.

May, 1976, a U.S. reconnaissance jet was on a photo mission over the Middle East. Israel scrambled to intercept. A tape recording was made by the U.S. jet which transcribes as follows: Pilot radios, "I have it on my radar. It is an SR-71." Back came a direct order from a high-ranking Israeli Air Force Commander: "Down it."

The American SR-71, flying at 85,000 ft., cut on his afterburners and easily outclimbed and outdistanced the Israeli Phantom jets. (which just happen to be U.S. jets we gave them as FREE foreign aid!)

U.S. Oil Ship Threatened

March 7, 1978, an American oil-drilling ship owned by Gulf Oil was approaching one of its sites off the coast of Egypt. The Israeli gunboat chased the American ship off with a threat to sink her. The U.S. state Dept. sent a "message of displeasure." (This is lesser than a formal protest!)

For two more days the Israeli boat guarded the oil drilling site which Israel wanted for their own use. Still, it refused to allow the American ship to begin drilling. Then, suddenly, the Israeli gunboat gave up and sailed away. No doubt Jew leaders in Tel Aviv decided they had better not turn this into another USS Liberty atrocity.

Israeli Tanks Blocked By Lone U.S. Marine

April, 1983, U.S. Marines were sent to Lebanon on a peace keeping mission to separate Jewish forces from the Arab armies. Three Israeli tanks were moving up the Sidon Highway which is in the American zone. Marine Capt. Charles B. Johnson of Neenah, Wisc. drove his jeep right in front of the lead tank blocking its path.

The Jew tank commander, Lt. Col. Rafi said: "I am going through." Capt. Johnson drew his .45 and climbed atop the tank and grabbed Rafi by the collar and told him, "You will pass only over my dead body!" The tanks then turned and left. Back in the states the U.S. Defense Dept., said Capt. Johnson would receive a "commendation."
