

Bisexuals Infect White Women With AIDS

Most bi-sexuals are Negroes who often seek affairs with White females. Interracial couples open door to infecting White population. AIDS - Rapidly increasing in females

The Center For Disease Control, (CDC), in Atlanta reports that 7% of all AIDS victims are women and 30,000 females are believed to carry the AIDS virus. Since lesbians cannot transmit the disease the vast majority of these women caught AIDS from either bi-sexual men or men who are intravenous drug addicts. The vast majority of men in America who are classified as "bi-sexual" are Negroes. Most intravenous drug addicts who swap dirty needles are also Negroes.

While blacks make up 13% of the population they constitute 25% of all AIDS victims. People the CDC designates as "Hispanics", (who are mainly Puerto Ricans of Negro descent), make up 16% of AIDS cases - for a total of 41%. It is also reported that at least 12% of those with AIDS do not bother to report the disease. Most in this category are believed to be men of Negro blood. Thus it is highly possible that a majority of all AIDS cases in the U.S. are confined to members of the Negro race.

No one knows how many men are "bi-sexual" because they are extremely secretive. But, it is known from studies made in Haiti and Africa where a great many women have contracted AIDS - and a very large percentage of Black men can engage in sex with either men or women without any emotional conflict. Likewise here in America Negroes make up a majority of all "bi-sexuals" who can easily engage in sex with either gender.

Combine the following reports and the threat is clear:

U.S. News, April 20, "Some AIDS carriers are bi-sexual men who have contracted the disease through homosexual relationships and spread it into the heterosexual community when they have sex with women."

New York Times, March 16, "Another 2 percent of all cases involve women who became infected through heterosexual intercourse with a partner from a known risk group - a bisexual man or drug addict."

U. S. Office of Minority Health scientific adviser, Dr. Jacqueline Bowles of May 13, "Among heterosexual AIDS victims, 50% are Black women, 25% are Hispanic and 25% are White."

The Tropical Disease Institute in Belgium, their AIDS expert, Dr. Peter Piot states, "Our study in Haiti shows how rapidly the AIDS virus can spread in a promiscuous heterosexual population. We found that in 1982 women made up 14% of all victims. This figure grew to 40% in 1985."

The Washington Post, Nov. 3, 1986, quotes Dr. Wayne Geaves of Howard University Hospital, "Other sociological factors affect the picture here as well because the black community looks down on homosexuality. I think it happens that more black men who are gay are also bisexual to avoid disclosing their sexual preference."

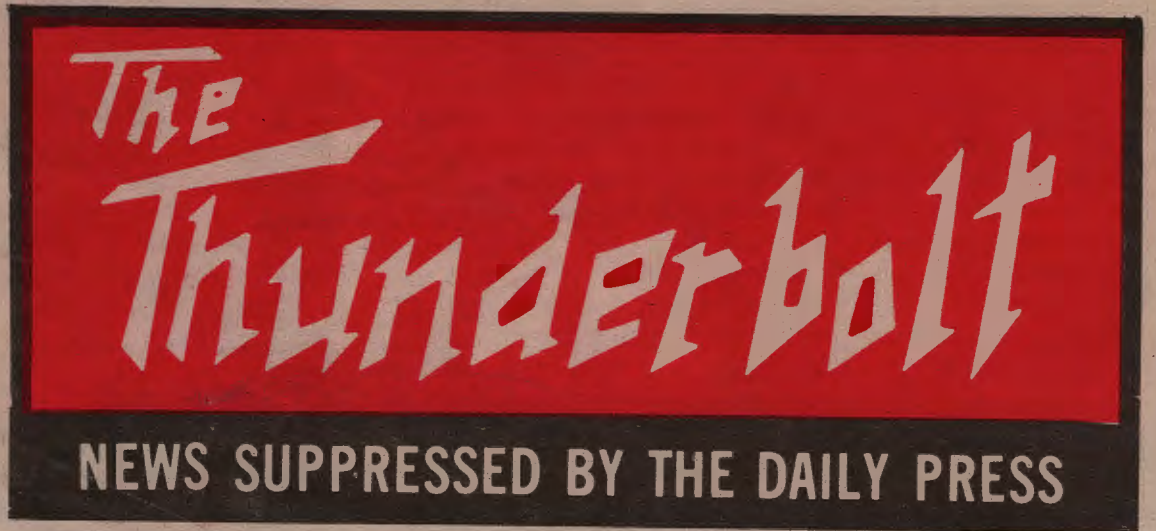
Negro Bi-Sexuals Seek White Women

It has been established that White men who are homosexuals do not feel the pressure to become bi-sexuals like blacks. Many black bi-sexuals are better educated and have higher incomes than average black homosexuals. In order to bolster their "status and image", they go out of their way to try and find White women who will mate with them. This element is the chief cause of the rising infection rate among White women. Already in New York City AIDS has become the third leading killer of women age 35 to 44, (after cancer and heart disease.) In San Francisco one out of every two women applying for a marriage license is found to be a carrier of the AIDS virus.

Today 7% of all AIDS victims are women and this will grow to 10% by the end of 1991. There will then be 350,000 full blown cases of AIDS. What this means is that 35,000 women will then also have the full-disease.

New York Times of Oct. 28, 1986, "Leading New York health officials argue - against the grain of much expert opinion elsewhere - that passage of the virus from female to male in intercourse is extremely rare."

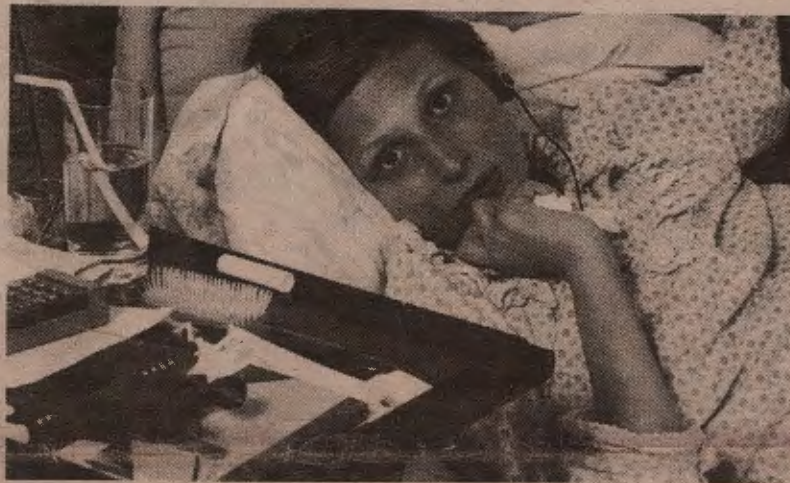
Thus when you read of "heterosexual AIDS victims," they are speaking mainly of women who have contracted the deadly disease from men - both bi-sexuals and drug addicts.

Cases Where Women Contract AIDS

Walter Reed Army Institute of Research found that 36% of all wives of military men with AIDS have themselves succumbed to the disease. Military bases are havens for large numbers of interracial couples and here lie many cases of black men with white wives where both have AIDS!

A New York City study of AIDS victims found that 37% of the women living with them had also contracted the disease.

A University of Miami study of male AIDS victims living with women found a 50% infection rate among the females. They also studied 16 black men with AIDS, who despite doctors warnings, continued to have unprotected sex with their female partners. Here 13 of the women came down with AIDS for a transmission rate of over 80 percent!

Prostitutes also have a high rate of AIDS which many have contracted from their male customers. The rate is 57% among prostitutes in Newark, Jersey City and Patterson, N.J. and 47% in Miami.

Thus White women who engage in sexual relations with Negro men are at high-risk of being infected with the deadly AIDS disease. It behooves all White people to spread this "suppressed truth" so that "Liberal" women can be alerted in time to change their behavior and thus save their own lives.

Who Is To Blame For The Spread of AIDS To White Girls?

It has now been firmly established that the spread of the AIDS virus to White females can clearly be laid at the feet of Negro bi-sexuals and Negro drug addicts. WHO IS RESPONSIBLE! When we think back just a few years to 1960 there was almost no interracial dating, sexual liaisons or mixed marriages.

The growing AIDS tragedy can be blamed squarely on all who have promoted the ideas of "liberal race-mixing!" All who have taught in the schools and churches that it is good to intermingle little White children with blacks — THEY ARE GUILTY OF THE AIDS INFECTION OF WHITE GIRLS!

We must include all politicians who voted for anti-White civil rights laws, judges who ruled for school integration and busing and all who have aided, abetted and encouraged socializing contacts between Whites and blacks.

Cases Show How Negroes Infect White Women

The full depth of the tragedy which race-mixing has inflicted upon the rapidly growing number of White females infected with AIDS is typified by the sad fate of poor Sonya Sherman of New York City. At age 29 in 1980 she was engaged to marry a Negro who had a high paying job. Then she discovered he was a bi-sexual and carried on sexual liaisons with both White and black homosexuals.

She broke off the engagement but soon discovered he had made her a carrier of the AIDS virus. In 1983, Sonya, the legal secretary with a promising career, was diagnosed as having the AIDS disease. She died a torturous death on Aug. 18, 1986 at the young age of 34. Her poor body was emaciated, she was deaf and weak from repeated bouts of pneumonia. IN TRUTH — SHE WAS A VICTIM OF RACE-MIXING!

Yet other sociological factors affect the picture here as well. "Because the black community looks down on homosexuality, I think it happens that more black men who are gay are also bisexual to avoid disclosing their sexual preference," said Greaves, who is one of two Howard University Hospital staff members working on AIDS research and treatment.

AIDS initially was considered a disease that struck only homosexuals and intravenous drug users. But 3,000 women in the United States have developed it, many because they had sexual intercourse with bisexual men or men who were intravenous drug abusers.

She said that among heterosexual AIDS victims, 50 percent are Black, 25 percent are Hispanic and 25 percent are white.

AIDS Is Depopulating Africa — Millions To Die

AIDS Decimating Black Africa

Millions will soon die. Big business had already written off Black Africa. The Negro Population will rapidly decline. Only isolated small villages will remain.

The world's greatest population explosion has occurred in Africa. With so many blacks unable to feed themselves, cutting down the forests, failing to farm the land, starvation and disease has become rampant. Millions suffer from malaria and diseases like sleeping sickness, (which was eliminated under White colonial rule but has returned with a vengeance). AIDS first developed in Uganda in the late 1950s. There proper sanitation is unknown and filth and tropical diseases have become worse with each passing year since the Whites were driven out of Central Africa. TODAY UGANDA IS A DOOMED COUNTRY!

Uganda has 30% of its population infected with the AIDS virus. Dr. Samuel Okware says that by the year 2,000, only 13 years away, at least 50% of Uganda's population will have AIDS.

The U.N. World Health organization reports that the hardest hit countries with a 10% to 30% AIDS infection rate are Uganda, Rwanda, Burundi, Tanzania, Zaire and Zambia. With no cure in sight how can any of these backward, fourth world countries, survive the AIDS onslaught?

University of California's AIDS expert, Dr. Jay Levy told UPI on Oct. 30, 1987 that Zaire, (formerly the Belgium Congo), had 20% of its population infected with the AIDS virus.

Hopkins University, Epidemiologist Dr. Frank Polk stated: "Some African countries will lose 25% or more of their population. The loss in terms of their economy and social structure could well equal the Black Death Plague's ruination of medieval Europe!"

Zambia, (formerly Northern Rhodesia), has 300,000 of its people infected with AIDS out of a total population of 6 million. Within 10 years, this number will increase to over 1 million! Rwanda has a 22% AIDS rate and Burundi 10%.

Listed as "Second Line Countries" with an AIDS infection rate of around 5% are Kenya, Angola, Congo, Malawi and Zimbabwe, (formerly Rhodesia).

Nothing Can Stop The African Plague

Belgium AIDS expert Dr. Nathan Clumeck said that his team of doctors estimate that up to 30% of Central Africa's population of 150 million carry the AIDS virus. Already, over 200,000 blacks have died from AIDS. The situation is so desperate Zaire's government has given a French medical group permission to experiment with possible AIDS vaccines on human guinea pigs. This testing is supposed to be a "top secret project" but in truth it is well known and has been mentioned on U.S. TV. Zaire officials are desperate because up to 300,000 in their capitol city of Kinshasa are believed infected.

How can a country with even just a 5% infection rate survive when there is no cure in sight? Remember the AIDS infection rate is doubling each year? Because the Negroes' genetic weakness toward the disease a number of other factors have contributed to its speedy spread in Africa.

Along the trade routes between Tanzania and Uganda lies the village of Kasensero. The town consists of a dusty main street of mud brick and clapboard huts lined with two dozen discos full of prostitutes offering gin and sex at cheap rates. Then in 1982 AIDS swept the village of 600 people killing 200 and leaving only 150 the others ran away! Today there are still seven discos open with music blasting and plenty of customers for the remaining prostitutes. They are doing a "booming business!"

Kampala, capitol of Uganda, 100% of the local prostitutes test positive for the AIDS virus. In Nairobi, capitol of Kenya, 88% of the prostitutes have the AIDS virus. In Africa black men deem prostitutes important and believe they have a "right" to be so "entertained" in the discos. The average African prostitute sees over 1,000 customers a year. The males feel their "prestige" requires them to have several wives, mistresses, and concubines - which they also share with other men.

A recent study showed that the average African Negro male consorts with an average of 32 DIFFERENT sex partners per year. Multiple sex partners is a chief cause behind the AIDS

epidemic among Negroes and homosexuals in America. Venereal disease is extremely high in Africa with 50% of the prostitutes being infected with gonorrhea. As for the men, 10,000 per 100,000 have venereal disease compared with a rate of 975 per 100,000 in New York and 310 in London. Open sores and chankers speed the spread of AIDS.

The Sex Parties Cannot Be Stopped

One doctor said that he has been jeered and laughed at when urging fellow blacks to cut back on sexual contacts. They told him, "this has always been our way of life, we will not change now!"

Tanzania's chief medical officer, Dr. Jairo Kidenya said: "Our society is like Sodom and Gomorrah. There are wild parties where men and women engage in drunken sex orgies going on all the time." French AIDS expert Dr. Francis Barin said: "Africa is on the brink of apocalypse now!"

African Military Rule Will Collapse

U.S. big business has already dismissed black Africa as a "basket case". White managers and technicians do not want to work in Africa because of AIDS. The big banks such as Chase and Citicorp have written off loans to Africa as losses. They notified stockholders that any hope of ever being repaid is gone.

World Health Organization official Jonathan Mann in Geneva stated: "With 10% to 30% of the people of Central Africa having AIDS means one million active cases will soon appear. This has very grave implications because it will destabilize the political system when 20% to 40% of all young adults have AIDS. There will simply be no work force left to keep the economy going."



Here is the deadly "AIDS Belt" where from 10% to 30% of the entire black population already has the AIDS virus. Without a cure these nations will be decimated and only a few isolated tribes will remain alive!

New York Being Destroyed By AIDS

Will New York's Fate Spread To Other Cities?

The facts about the AIDS epidemic in New York City is the most shocking news headliner of this century - YET IT IS SUPPRESSED BY THE DAILY PRESS!

The following figures tell the shocking truth about the infection of an entire city - OUR LARGEST AND MOST IMPORTANT CITY!

New York City has one-third of all AIDS cases in America.

N. Y. City Council AIDS chairman Joseph Lisa states that 750,000 New York males are now carriers of the AIDS virus. (Quoted from New York Post of Nov. 7.) This means that one out of every four men walking the streets of New York are infected with the AIDS virus!

Even though it may be from 2 to 20 years before they all come down with the disease each can pass it on to others through sexual contact right now. Over 5,000 New Yorkers have already died of AIDS and this figure will grow to 25,000 in only five years. The city has 250,000 intravenous drug addicts and over half now carry the AIDS virus. Most are either Negroes or Puerto Ricans. In New York City 54% of homosexuals and bi-sexuals are Negroes or Puerto Ricans.

San Francisco has around 90,000 homosexuals. According to Time Magazine of Feb. 16 up to 70% of them are already carriers of the AIDS virus. Remember, even if an anti-AIDS vaccine was developed tomorrow, (and there is no cure in sight), it is already too late to save anyone already infected! This means that most of the homosexuals in America will die. In New York at least one-fourth of all males, now in their most productive working years of ages 20 to 45, will become very ill and soon die. There will be a severe shortage of workers in New York for years to come!

The CDC states that AIDS is going to stop black population growth in America and many believe their population will suddenly decrease. The spreading AIDS plague means that any White women who engages in sex with a Negro has an extremely high risk of contracting the deadly disease. Of course, this is also true of White bisexuals and White drug addicts. But the statistics prove that MOST BI-SEXUALS AND DRUG ADDICTS - WHO SHARE NEEDLES - ARE NEGROES!

Tragic Women With Aids Genetic AIDS Tendency

There is reason for women to be alarmed. Kris, 37, is an attractive divorcée from Pasadena, Calif., and the mother of a teenage daughter. In 1983 she embarked on a "sexually indiscriminate" period of her life during which she had about 15 sexual partners. "I never gave a thought to AIDS," recalls Kris. "I didn't even know there was a threat." After two frustrating years of incorrect diagnosis, the disease was finally identified, first as AIDS-related complex, then as AIDS. She does not know who gave her AIDS or whom she might have infected.

Active bisexuals are one route of viral transmission to the female population. In 1984 Free-Lance Writer Alexandra Wolf, 41, met a charming man in Hollywood. "We hit it off really well," she recalls, deciding at the time not to use any sexual precautions because "it's not a risk-free world, and I'm going to take the chance." After four encounters, he confessed he was a bisexual whose previous lover had died from an AIDS-related cancer. Ten months later, tests confirmed that Wolf had the live virus in her bloodstream.

So far, nine of ten AIDS patients in the United States have been homosexual or bisexual men or intravenous drug users. Federal experts estimate that from 4 percent to 7 percent of all adult patients were infected through heterosexual intercourse.

Of these suspected heterosexual cases nearly half, 2 percent of the nation's total cases, involve immigrants from Africa or Haiti, where vaginal intercourse is believed to be a common means of transmission. Another 2 percent of all cases involve men and women who became infected through heterosexual intercourse with a partner from a known risk group — a bisexual man, a drug addict or a person infected by blood products. In addition, officials believe, a portion of the 3 percent of the nation's cases in which the source of infection is undetermined may reflect heterosexual transmission.

AIDS Already An Epidemic Facts About AIDS In The U.S.

The CDC states that 40,000 people now have the full-blown AIDS disease and this figure may be underestimated by 20%.

From 2 to 4 million Americans are carriers of the AIDS virus.

It was first said that 30% to 60% of the carriers would eventually come down with the full effects of the disease. Now the U.S. Surgeon General Dr. C. Everett Koop says that all may eventually have the full disease.

Dr. Anthony Fauci head of the National Institute of Infectious Diseases says that 50% of all those carrying the virus will get the full disease within just six years and all the rest within 20 years.

Of those having AIDS 80% will die within 2 years.

The millions who are unknowing carriers of the AIDS virus can infect anyone they have sex with.

The CDC has long stated that 270,000 Americans will have AIDS by 1991. On July 1st this figure was raised to 324,000!

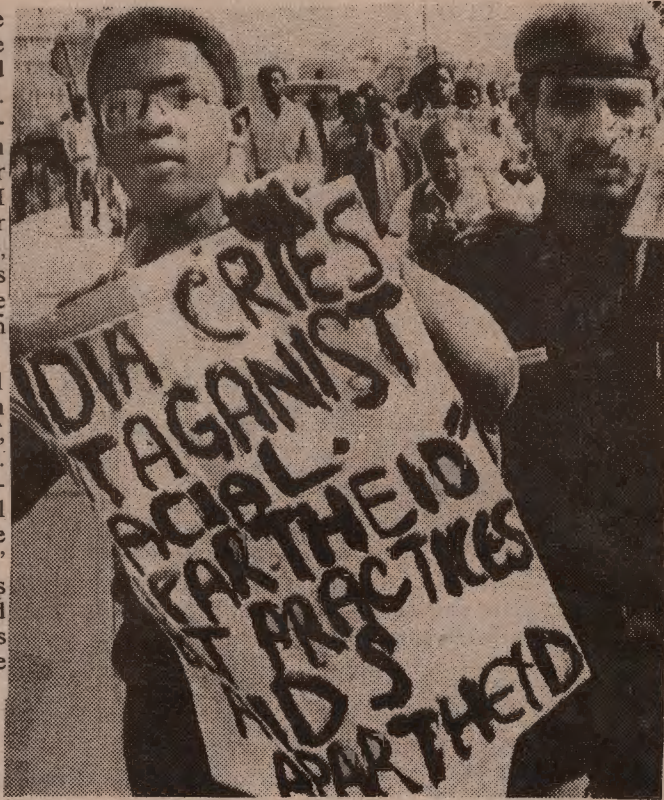

Most of these countries are ruled by military dictators. Recent studies show that a higher percentage of their soldiers and officers have AIDS than does the general population. The reason is that they have money and more time on their hands to spend carousing with the diseased prostitutes. A rapid turnover in the military could lead to revolts and civil war.

How Can America Defend Itself From The African Plague?

AIDS originated in the steaming jungles of Africa. It was brought to this hemisphere by Haitians who traveled back and forth to work in the French speaking Congo. While we now give AIDS tests to all new immigrants we do not test African students - who most often never return home!

The Soviet Union and India now give AIDS tests to all foreign students from Africa. It is time we act to stop the influx of AIDS infected people. AIDS carriers may eventually have to be quarantined in America but at least we can act now to keep those in Africa from coming to our shores and contaminating our people!

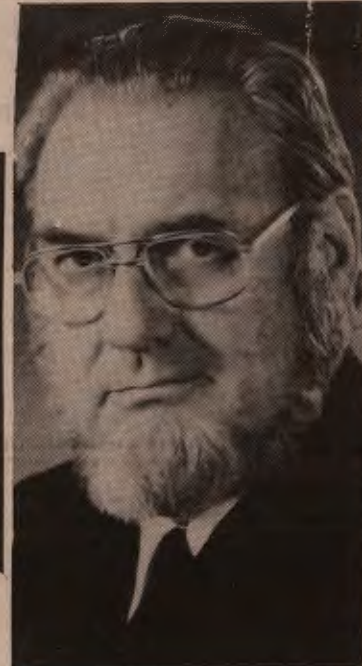
"Interracial Sex Is The Main Cause Of Heterosexual AIDS Infection".

Thus interracial dating, interracial marriage and any interracial sexual liaison between White females and Negro men immediately places such women in dire danger of being infected with the disease which is now called - "THE AFRICAN PLAGUE!"

AIDS

An estimated 1.5 million to 4 million Americans have come into contact with the AIDS virus but remain free of symptoms. British researchers have just learned that the vulnerability of an individual, or of an entire ethnic group, to the lethal virus depends at least in part on genes. A team led by Lesley-Jane Eales of St. Mary's Hospital Medical School in London looked at six varieties of an inherited protein found on all human cell surfaces. The researchers concluded that one of the protein variations makes the people who carry it highly resistant to AIDS, while another makes them highly vulnerable. The other four variations fall in between.

The work may shed light on why the disease is spreading so rapidly among heterosexuals in Central Africa. Blacks from that region are nearly 19 times more likely to contract AIDS than White people!

Blacks Are Genetically Prone To AIDS

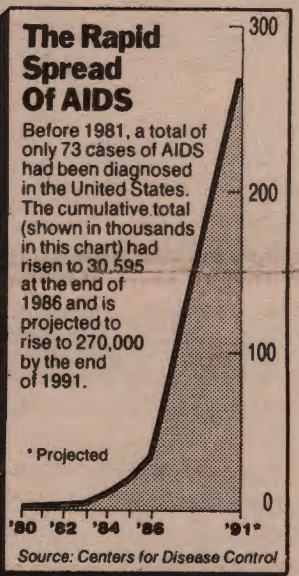
University of Texas geneticist, Dr. Stephen Daiger, states that Negroes are 19 times "more susceptible" to catch AIDS than White people. He says this is because they carry a "genetic coding" which lowers their natural resistance to the disease.

The strengths and weaknesses in every individual have been determined within each person before birth. Your future has been pre-established through generations of ancestors in your family tree which make you the total person you are.

The Negro race has a higher susceptibility to AIDS than do members of the White race. Therefore, when a woman ventures outside her own race to sexually "experiment" with a black male she is instantly placing her life in danger!

The Rapid Spread Of AIDS

Before 1981, a total of only 73 cases of AIDS had been diagnosed in the United States. The cumulative total (shown in thousands in this chart) had risen to 30,595 at the end of 1986 and is projected to rise to 270,000 by the end of 1991.



This is the CDC chart of Sept. 1986. Now they predict 40,000 AIDS cases this Oct. 1987 and 324,000 by 1991 - THE PANDEMIC EXPLODES!

One Bisexual Can Infect Many Women

One Black Male Infects Nine Women

Belgium's St. Pierre Hospital AIDS researcher, Dr. Nathan Clumeck, presented the study quoted below before an international medical seminar. Dr. Clumeck traced 12 women who had sexual relations with one black businessman who traveled back and forth to Africa. Dr. Clumeck discovered that the Negro had infected 8 White

women and one black. He may have gotten the disease from contacts with black prostitutes in Africa.

Still the odds are that he was one of the very large number of black bi-sexuals. We will never know for certain as he was diagnosed as having AIDS in Nov. 1985 and died from the disease at age 40 in February,

1987. Dr. Clumeck states that this is only the tip of the iceberg as there is evidence the Negro had sexual relations with additional White women. All were under the impression that since he was a "high class black businessman" there was no chance that he might be a carrier of a deadly communicable disease.

Official Report on Dr. Clamek's Investigation

A still unraveling case shows starkly how one person, though heterosexual, can scatter the AIDS virus. A black Belgian businessman is being investigated by Dr. Nathan Clumeck, a specialist in infectious diseases. The man, by all accounts exclusively heterosexual, made regular business trips to Africa. He had at least 12 sexual partners there and in Belgium, all but one of them white, middle-class women who had met him at parties. None was promiscuous, none used drugs, and all had only vaginal intercourse with the man. The source of his AIDS is unknown. Nine of the 12 women have developed AIDS or AIDS-related complex (ARC), a precursor to the disease. One of the known sex partners of these women has ARC, and three more of their partners have tested negative. Three of the 12 women have tested negative. The man, diagnosed as having AIDS in November of 1985, died at 40 last February.

White Students Stand Up For Their Rights

College Students Oppose Integration

National attention has been focused on the campuses of our largest universities from coast-to-coast. Nowhere has there been a drive more intense to brainwash White youths into accepting racial integration than on the college campus. In fact many conservatives had all but written off the college student as "lost to the cause" due to the influence of extreme left-wing professors.

What is responsible for this turn around and new "underground resistance" on the part of thousands of White college students? First, many have been the victims of Negro street crime in and around campus. Vicious murders of White students have taken place and rapes of White coeds are frequent. Interracial dating is also a point of concern to race-conscious students.

Many Whites in college have learned that communist groups have great influence over the minorities on campus. Thus the following is a brief listing on what forms of protest activities the "White resistance" is taking.

George Washington University's Delta Tau Delta fraternity decided to hold "White History Week." They posted signs on campus declaring, "Come help the Delts celebrate White History Week! Did you know George Washington was a White man?" Black students called this "racist" and picketed the Delt's party. This means that "Black History Month" must also be racist!

Cleveland State University has been the focus of black demonstrations. They complain White students tell "racial jokes" and laugh at them. They charge discrimination because no black basketball player has ever actually graduated and few black professors ever gain tenure. Others claim SAT tests and college entrance examinations are biased because they cannot pass them!

Purdue University found black students demonstrating over a cross burning in front of the Black Cultural Center. (Perhaps some Whites do not think Negroes are a cultured people!) They were joined in their demonstration by the Jewish Student Assn. They made these demands: 1) Affirmative action hiring of black teachers and recruitment of black students. A mandatory course on black culture for White students and the divestment of university funds from South Africa. (NOTE: What has all this got to do with the cross burning?)

Minnesota's Pillsbury Baptist Bible College had 22 Negroes on their football team. One was fullback Calvin Addison. He insisted on dating a white girl, Jennifer Schwab. Dean of students, James Threlfall, told Addison he had to have the girl's parents written permission to date her. He began to sneak around to see the child and was expelled.

At that point, the Minn. State Dept. on Human Rights, headed by the Negress Jayne Khalifa, investigated the school and ordered them to drop this rule. Still the college would not readmit Addison stating he had "too many demerits, sang and told jokes in chapel, and cursed a White female student."

The school also got rid of all but two black football players and made a new rule. Henceforth members of fundamentalist Baptist churches cannot date students whose families are non-members! (NOTE: Where there is a will there is a way.)

Nashville's Vanderbilt University is truly a prestige school with only a 2.8% black enrollment, the smallest of any major Southern college. Blacks have been turned away from fraternity and sorority parties so the protests began. Chancellor Joe B. Wyatt threatened to shut down the 26 fraternities and sororities unless they pledged some blacks. Only one sorority accepted one black - NONE OF THE OTHERS HAVE BEEN CLOSED!

New York, Columbia University saw black and Marxist groups demonstrating against the Sigma Chi and Phi Gamma Delta fraternities. It seems black students came out on the losing end when they got into a fight with the fraternity brothers.

University of Michigan black students have complained of White students using racial slurs, jokes, writing racist graffiti on walls and distributing pro-White literature. Even presidential candidate Rev. Jesse Jackson came to Ann Arbor, Mich., to demonstrate. The university president is the Jew Harold T. Shapiro. He apologized and promised to give an honorary degree to the violent, imprisoned, Nelson Mandela, head of the outlawed terrorist, African National Congress.

Campanis Crucified For Telling Truth

Do Negroes Have The "Necessities"

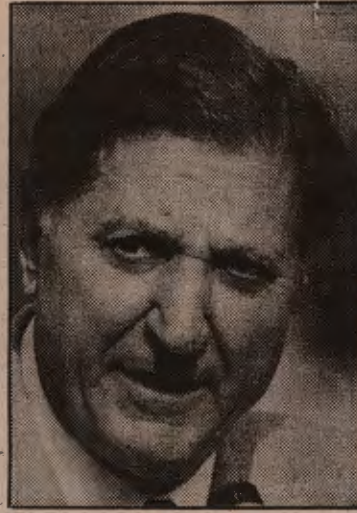
To Manage Baseball?

Los Angeles Dodger, Vice-President Al Campanis, was fired from the famed baseball organization for saying what most people believe is the truth. At age 70 he had been with the Dodger organization since 1940 when he started as a player and worked his way up through the ranks. Then came the 40th anniversary of Jackie Robinson's being the first black integrated into professional baseball in 1947.

ABC-TV's "Nightline", moderated by the Jew Ted Koppel featured Campanis as a guest since he was with the Dodgers when Jackie Robinson was on the team. Koppel asked Campanis why there are no blacks in the "front office" of any team. Campanis gave an answer which is the simple truth.

Campanis said, "Blacks may not have the necessities to be, let's say, a field manager, or perhaps a general manager."

With that Koppel zeroed in on Al Campanis and tried to ridicule him. But Al fought back - he in turn asked Koppel how come there are no blacks in the upper management ranks of any

TV network? Koppel admitted this was true. The next morning the liberal press nation-wide was screaming for Campanis' scalp. Rev. Jesse Jackson threatened a black boycott of Dodgers games if Campanis was not fired and a black hired as his replacement.

At first Dodger President Peter O'Malley said he would stand by Campanis. The next day he bowed to pressure from the media and fired a man who had become a legend in baseball at age 70. Campanis was a civic minded person who promoted baseball among youths as a way

to give them a sport to keep them out of trouble.

Communist Party Hails Campanis Firing

The Communist Daily World newspaper carried a very interesting article by their Jewish sportswriter, Si Gerson. Back in 1947 the Communist Party was very strong. World War II had just ended and many still considered the Communists our "ally". Communist Party members were actually elected to public office.

Two were elected to the New York City Council. They were Pete Cacchione and Negro Benjamin Davis. On this page we reproduce an article by Si Gerson in which he brags about

the role Pete Cacchione and the Communist Jew writer Nat Low played in integrating baseball. They promoted street agitation by the Young Communist League which built enough pressure to force the Dodgers into hiring Jackie Robinson.

It should be noted that the Communist platform printed in The Daily Worker of May 26, 1928 called for: "full racial equality; laws forbidding all discrimination against Negroes in the sale or rental of housing, the integration of public schools and colleges and the entrance of Negroes into baseball and all professional sports."

Blacks Failed In Certain Baseball Positions

Baseball owners do not have to worry about a black boycott because very few Negroes attend baseball games in the first place. Bowie Kuhn, baseball commissioner from 1969 to 1984 states, "with rare exceptions black attendance is low, very

Over 400 students attended a dance against racism at the University of Massachusetts Amherst campus Friday. The campus was the scene of a racist attack by several hundred white students against 15 Black students after a World Series football game last fall.

The dance was sponsored as a response to the violence by several student organizations, including the Black Mass Communications Network, the Office for Marxist Studies, and the Young Communist League. "There is a broad base of opposition to racism on campus," said Jason Rabinowitz, one of the organizers.

Kevin Whitfield, a part-time instructor in the college's Law and Justice program, said he received two letters filled with racist, sexist and anti-Semitic statements.

Whitfield said he believes he is a target because he is a communist and the adviser to the campus chapter of the International Committee Against Racism, a militant, leftist group that advocates strong tactics to combat bigotry.

Scientists Prove The Races Are Not Equal

Scientists Prove Negro IQ 15 Points Lower than Whites

The U.S. Press gave much publicity to former Commissioner of Education Francis Keppel's proclamation that, "all children have similar potential at birth - the differences occur thereafter."

The liberals believe that a poverty environment is the reason blacks do poorly in school, commit much crime and have such a high welfare rate! Due to the persistent research work of men like Nobel Prize winner, Dr. William Shockley, Prof. Arthur Jensen and Harvard Prof. Richard Herrnstein Liberal theory on this issue has been reversed.

The Public Interest, a scholastic journal recently explained that during the 1970s there was much controversy on whether or not an individual's inherited genes affected intelligence. Brilliant scientists such as Shockley, Jensen and Herrnstein were often shouted down by Marxist students seeking to silence them. Now a new study shows that most specialists in this field believe that heredity is very important to intelligence. They were afraid to speak out in support of the above men at the time and thus practiced self-censorship.

Prof. Shockley nailed down the basis of our beliefs in these words: "The major deficit in Negro intellectual performance must be primarily of hereditary origin and thus relatively irremediable by any practical improvements in the environment."

Facts And Figures on Negro I.Q.

University of Calif., Prof. Arthur Jensen, is highly regarded in his field of educational psychology. His findings are:

1) Our genes determine our IQ much more readily than education and environment factors. Heredity accounts for about 80% of the difference in IQ.

2) Blacks consistently score about 15 points lower than Whites in IQ testing.

3) Compensatory educational projects such as "Head Start" have failed to raise black's IQ.

The average I.Q. for White people is 101.8. Yet, 95.5% of Negroes test below this average for Whites. Any I.Q. test score below 70 means the individual is mentally retarded. Some 18.4%

low, under 5%."

The New York Mets play in a city which is 25% black. Still black attendance only averages 6%. The Los Angeles Dodgers report that of their 27,000 season ticketholders only about 25 are black.

When it comes to other sports only 7.5% of ticket buyers for football games are black while 17% of paid basketball fans are black. While Negroes make up 13% of the population nationwide, the cities where these teams play, their percentage is much higher - such as Atlanta - which has a 70% black population.

Why is it that there are no black quarterbacks in professional football? Several have tried, especially with the Tampa team, but none were successful. How many black football kickers are there? Some say one might try to play that position this year. How come baseball does not have one single black catcher on any team? Could it be they don't have the "necessities" to play this position, (Al Campanis would say!) Blacks make up 25% of baseball players. But what positions do they play?

They say blacks can run fast. Perhaps that is why 70% of the outfield is black, 12% play First Base, 10% play Shortstop, 7%

Second Base, 5.7% are Pitchers, 4% play Third Base. Again, none, ZERO, play the very difficult, fast thinking position of Catcher. PERHAPS OLD AL CAMPANIS WAS RIGHT AFTER ALL!

How Communist Party Helped Integrate Baseball

Pete may not have been in the stands that day in 1947 when Robinson made his first appearance at Ebbets Field, but the Communist councilman had a lot to do with the historic occasion. The movement to break down the color line in organized baseball was, of course, not new when Pete got on the political scene. But the record shows that it was Pete and the Communists, particularly the Communist youth, who took an aggressive initiative, and virtually forced the issue.

Thus it came to pass, as the old book says, that 1942 and the spring of 1943 saw thousands of leaflets passed out at Ebbets Field calling for an end to discrimination in baseball. Members of the Young Communist League circulated petitions among the fans calling on the Dodger management to recruit Black players. Meanwhile, Pete saw to it that resolutions calling for the big league teams to join in breaking down Jim Crow were advanced in unions and civic organizations and forwarded to the high moguls of organized baseball.

The Daily Worker sports page, led by Lester Rodney and Nat Low, kept up a drumfire on the issue, with an able assist from Pete's column and the paper's editorial page. Nat Low of the Daily Worker sports page, as well as two leaders of the Young Communist League. And to make sure that the public — and more particularly baseball-mad Brooklynites would know the underlying issue, Pete was careful to issue an advance statement on the purpose of the visit. In a few neat sentences it deftly linked the fight against Jim Crow with the war on Hitlerism:

of all blacks test below this figure while only 2% of the Whites test lower. Going to the range of "slow learners", between the I.Q. figures of 70 and 80 some 44% of the blacks fall into this group but only 16% of the Whites are in this level.

Environment Not Reason For Black's Low I.Q.

University of Chicago Prof. Robert E. Kuttner states: "Examination of census and other pertinent statistical data indicate that American Indians currently lag behind Negroes in environment approximately as far as Negroes lag behind Whites. Despite visibly greater handicaps in terms of family income, life expectancy, years of education and employment opportunities, Indian school children generally outperform Negroes on scholastic tests, as reviewed in the Coleman Report."

"There is considerable evidence that the gap between Negro and White scores is increasing despite marked socio-economic advances by Negro citizens."

High I.Q. People Are The Leaders

— Low I.Q. People Cannot Adapt In Today's Society

Dr. Herrnstein explains: "While a high I.Q. is necessary for success, it is not sufficient. That is, a person with a low I.Q. is almost always going to be relegated to a menial, low paying job - or no job at all. But a person with a high I.Q. must also possess other qualities such as energy and motivation to succeed."

Atlantic Magazine quotes Herrnstein declaring that after reviewing a century of research he has come to the conclusion that intelligence is largely hereditary. I.Q. influences social status, and the nation already has a high I.Q. ruling class and a lower class with I.Q.s below average. He believes, moreover, that the differences will become sharper. The better the U.S. succeeds in letting each man reach the level of his ability the more wealth and prestige will be concentrated at the top.

Herrnstein states: "There will remain a human residue that may be unable to master the common occupations and were probably born to parents who have similarly failed. As machines take over the easy jobs the task of running the machine may be too difficult for those with low I.Q.s. Even the tendency to be unemployed may run in the genes of a family about as certainly as bad teeth do. This vision of a virtual caste system reminds us of aristocracies, privileged classes and the advantages of birth."

Low I.Q. As A Cause Of Crime

There are over half-a-million retarded Negro youths in America with I.Q.s under 70. Most of the robberies, rapes and murders in America are committed by low I.Q. blacks. Over 60% of all black births are to un-wed Negro girls of low I.Q. on welfare.

Prof. Shockley says: "Our generation may already be on the downgrade in a decline of civilization. One incident that led me to express my worries publicly was a news story of an acid throwing teen-ager who blinded an innocent person. He was one of 17 children of a mother with an I.Q. of 55. Later I learned of Denmark's sterilization programs with their eugenic implications. The rising murder rate in Washington, D.C. is 50 times higher than Denmark's."

Anyone involved in law enforcement quickly realizes that the vast majority of those crowding our prison system are people of low I.Q. The great problem is our welfare system encourages the breeding of more and more low I.Q. retarded people. What we are actually doing is paying black unwed mothers to produce more low I.Q., crime prone offspring.

It must be remembered that Negroes have brains which are substantially smaller, and weigh less than Caucasians. Negro skulls are thicker, their cranial structure is more primitive, and their cranial sutures fuse at an earlier age thus restricting the development of the brain. This is not the case with Whites.

This is not racist theory but scientific fact which has been carefully observed in thousands of autopsies and comparative anatomical studies. This information has, until just a few years ago, been readily accessible to the inquiring reader in any encyclopedia worthy of the name. Today all of this information has been deleted by censors.

The true scientist has always been rare. Those who were able to recognize TRUTH amid the prejudices and dogmas of their day and then were willing to sacrifice for the sake of that TRUTH were few. In the past, Bruno and Galileo made the sacrifice. Today, Shockley, Jensen and Herrenstein battle to bring these suppressed TRUTHS to the attention of the people.

Negro Murders More Brutal As

America Wracked By Negro Murder Wave

Detroit led the nation last year with a homicide rate of 59.5 per 100,000 people. Not considering population the cities with the most murders were New York City with a shocking 1,582 killings and Chicago with 744. Nationwide there was a 13% increase in murders over 1985. It is believed that 1987 will break another murder record with Chicago right now averaging 2 murders per day.

Nationally Negroes commit over 52% of all murders while they are only 13% of the population. If you count Puerto Ricans as Negroes, (instead of Hispanics), then the black murder rate is much higher than 52%. In New York, Chicago, Detroit, Washington, Atlanta, New Orleans, Houston, etc., where large numbers of blacks live the percentage of murders committed by Negroes is as high as 90% or HIGHER!

Murder And Crime Are Hereditary

The American Assn. for the Advancement of Science issued a report stating criminal behavior cannot be blamed on environment. It found "Criminal tendency has a genetic basis and is associated with bad judgment and poor impulse control."

More significant was the revelation: "Many criminals have a low IQ which is also an inherited trait. Many criminals are psychotic and there is clear evidence that psychoses is controlled by an inherited genetic factor. Also, many crimes suggest sexual disturbances, especially homosexuality, which has an inherited basis."

There is much evidence that a genetic tendency toward violent crime exists.

Detroit Minister Murdered By Maid

Maid Murders Elderly Minister

Lutheran minister, Rev. Frank P. Madsen, 81, had from 1952 until 1972, been president of two different synods of the United Lutheran Church in America. He is well known for his lifelong efforts to help blacks. Now they have repaid him with murder.

Rev. Madsen's part-time maid, Stacy Yvette Barker, 21, has been charged with stabbing him seven times with a steak knife and ransacking his home

White Women Targets Of Black Killers

Chicago police called it one of the most barbaric murders they have ever witnessed in the Windy City.

Beautiful Lori Roscetti, age 23, had everything in the world to live for. She was one of six children, born to a working-class family in Springfield, Ill. In high school she was a straight-A student. She got an award as the top English student, named to the four member "Braintrust Academic Team", was vice-president of the National Honor Society, a member of "The German Club," and voted "Most Likely To Succeed".

Lori wanted to become a Doctor so that she could help sick people. She worked as a checker in a grocery store and cleaned homes to make money to attend medical school in Chicago. Her friend, Karen Boyer said: "She wanted to see the big city and expand her horizons. She won a prestigious scholarship at the University of Illinois and was Phi Beta Kappa."

45 Minutes Of Terror - Rape - DEATH!

Lori Roscetti called it a day after 14 hours of research work at Chicago's Rush Medical College Library. She drove three blocks to Flournoy and Loomis Streets - just one block from her apartment. Suddenly a black youth stepped out in front of her car. She jammed on the brakes. As she stopped a second black youth yanked open the passenger side door, jumped in and opened the back door to let three more blacks jump in. They quickly pulled Miss Roscetti over the seat on to the floor in the back.

From confessions signed by the youths it is known that Larry Ollins, 16, raped Lori first. The others got into a fight over who was going to rape her next. Lori got up and tried to run. They were in a desolate area near the railroad tracks. Ollins and Marcellius Bradford, 17, began to beat her, she was brutally kicked all over her body and stabbed 40 times, all her ribs were broken, she was struck with sticks and bricks for 45 minutes.

Now she lay dead - then Bradford, Omar Saunders, 18, and a 14 year old juvenile whose name was not released because he is a minor, all four proceeded to rape the already dead girl! After that they went back to stomping her again and poking her eyes out with sticks just to make sure, if she wasn't dead, she could never identify them.

The fiends then took the few dollars she had and put clothes back on to try and make it look as if she hadn't been raped. Three of the black killers lived in the high-crime Abla Housing Project. They all said they returned home that night and got a good night's sleep!

Blacks Demonstrate - Say Youths Framed!

Negro, Rev. Johnny Jackson, led a protest demonstration of about 100 screaming blacks in the Abla project. He shouted that the charges against Bradford were a frame-up. Rev. Jackson said: "Bradford is not a violent person. He's being shafted. This is a case of police brutality."

Finally, Omar Saunders, 18, was arrested one month later. He was the fourth killer. He has an extensive juvenile record and is known as "Shim Sham." All four are the offspring of unwed mothers who are all on welfare. All the youths have long criminal records. Bradford was only 14 when charged with armed robbery and has a total of 23 arrests including burglary, assault, retail theft, etc. Ollins has 8 arrests including burglary, gang activity, robbery, etc. His mother is 34, never married, unemployed with one other child. Bradford's mother has never been married, is unemployed and has three children.

Ollins was arrested in Feb., 1984 for an exceptionally brutal attack on an 11-year old boy. Police say Ollins and two other black youths took the boy to a vacant Abla apartment and forced him to sodomize them. Next they beat him, burned his hair off with matches, and urinated into his mouth. They stole the groceries he was bringing home to his mother. Still they were not finished. They held the youth down while Ollins forced a broomstick into him damaging his rectum. For all this mayhem they spent only a few months in jail!

Ollins attended special classes for students with "behavior disorders." Bradford has a very low IQ and only attended school 2 days last year.

Detective James Maurer said: "Lori's was the worst case I have ever saw. They tortured and raped her after she was dead. This young girl gave up so much to become a doctor - what a senseless waste." Lori's father, John Roscetti said, "I hope they receive the maximum penalty."

African Savagery Sweeps America

New York Blacks Out of Control

Cops say slain priests fell victim to teens they tried to help out

A TEENAGER betrayed the trust of two Catholic priests who had counseled him — savagely beating, robbing and stabbing them to death with the help of a teen partner, police in Buffalo charged yesterday.

The companion, a 200-pound high school football player, allegedly confessed they killed the first priest in a \$1000 robbery.

That priest was stabbed repeatedly and bludgeoned with a can of Chinese food he was preparing for the teens after they claimed to be homeless.

The motive in both slayings — 12 days and one-half mile apart — was robbery, confirmed Buffalo Chief of Detectives Angelo Alessandra. He would not say how much was taken in the second killing.

Milton Jones, 17, a 6-foot-2 McKinley HS football player, confessed after his arrest in Buffalo, Mayor James Griffin told The Post.

Jones' alleged accomplice, Theodore Simmons — who had been counseled by both priests, police said — was arrested yesterday in San Diego.

Simmons, 18, a high school dropout who lived two blocks from the first slaying, was being held for extradition.

Both were charged with second-degree

murder, robbery and weapons possession.

"These were cold-blooded killings ... [for] robbery," said Alessandra.

The Rev. Joseph Bissonette, 55, reportedly had befriended Simmons over the last year and had a reputation as a dedicated street priest whose doors were always open, according to police.

Conned into believing the pair needed food and shelter, Bissonette opened the rectory of St. Bartholomew's Roman Catholic Church Feb. 24. He was forced to open a safe, then was stabbed repeatedly with a hunting knife and beaten with the food can, police said.

Msgr. David Herlihy, 74, whose body

was found early Sunday in the rectory at St. Matthew's Church, also had befriended Simmons, police said.

The Chicago Locksmith Murder Case

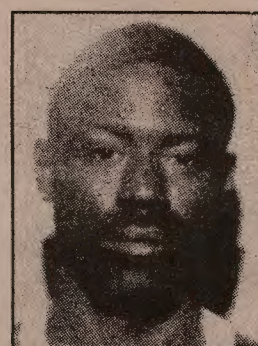
It was Nov. 18, 1983 when beautiful Lisa Tyson returned to her fashionable apartment in Chicago's North Clark St. area. Upon entering she was attacked by a young black with a butcher knife. Lisa screamed as the brute stabbed her 7 times and then fled. A neighbor, James Ardrey, rushed to help. He found her

him in the act so he killed her.

Later he changed his story and said he was brutalized by police who forced him to sign a confession. During his first jury trial several blacks "hung" the jury by refusing to convict. During the second trial it was hung 8 to 4 for conviction. Again 4 blacks were holding out for acquittal. That night the jury was sequestered in the

bleeding profusely. Her last words were: "Help me, Jamie, I'm dying."

Two years later a police officer noted there was no forceful entry in many of the burglaries in the neighborhood. This reminded him of Miss Tyson: There was no forceful entry into her apartment! This led them to Cook's Hardware as they had changed many of the locks in the area to provide extra security for fearful residents.

Still, many of Cook's clients were being broken into without forceful entry? Then it was noted that Negro Maurice Hunley changed the locks on all those stores and apartments which were entered.

Hunley and his wife lived in the high crime Cabrini-Green Housing project. He was arrested and confessed to Lisa's murder. His explanation was that he had a \$400 per week cocaine habit which could only be fed by burglaries. Lisa surprised

Quality Inn at Halsted and Madison Streets. Four jurors had their money and jewelry stolen that night by someone with a pass key. This occurred even though black sheriff's deputies claimed they stood guard on their floor all night long??? **That afternoon they voted Hunley GUILTY!**

Hunley, now age 24, was sentenced to 40 years in prison. He will be eligible for parole in only 20 years! The defense is appealing because they claim the motel room burglary biased the conviction. Hunley may yet get a third trial! Lisa's distraught father, Bill Tyson, a prominent financial advisor for a LaSalle Street investment firm said: "What else could go wrong? The guilty verdict will not bring my daughter back but we hope it's over. Maybe our family can start our lives over again." (NOTE: They will never be able to forget this horrific tragedy - no one ever does. **It will haunt this family forever.**)

Filthy Sexual Practices Spreads AIDS Epidemic

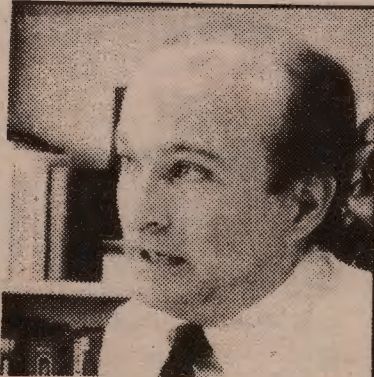
Black Male Prostitutes Spread AIDS

Jackson, Miss., Police Chief L. C. Smith describes a problem which is occurring all across the country. A majority of male prostitutes are Negroes and most of them are AIDS carriers. Chief Smith said: "When you buy sex from them you are taking your life in your hands - YOU ARE BUYING DEATH!"

Chief Smith's main concern is Negro James Henry McIntyre age 28. He has been arrested 60 times for selling his services to White and black men, married and single, young and old. McIntyre is so "feminine acting" that many do not even realize he is a male! At one point the Jackson police dept., bought McIntyre a one way bus ticket to San Diego, (his native hometown), but to their chagrin he later returned.

Police arrested McIntyre in the act of practicing sodomy on a prominent local White businessman. He is now being held in an isolation ward to prevent him from infecting other prisoners. Chief Smith said: "We can only hold him so long and then he will be back on the street. The guy is obviously not going to quit what he does. We have the strongest quarantine law in the nation but civil rights advocates would go to court to free him."

As for McIntyre he says: "I've been told that I have the AIDS virus but not a full case of AIDS. But, I don't feel like I have anything. I don't feel bad. I never think about it. I just always do these things because they come natural to me."

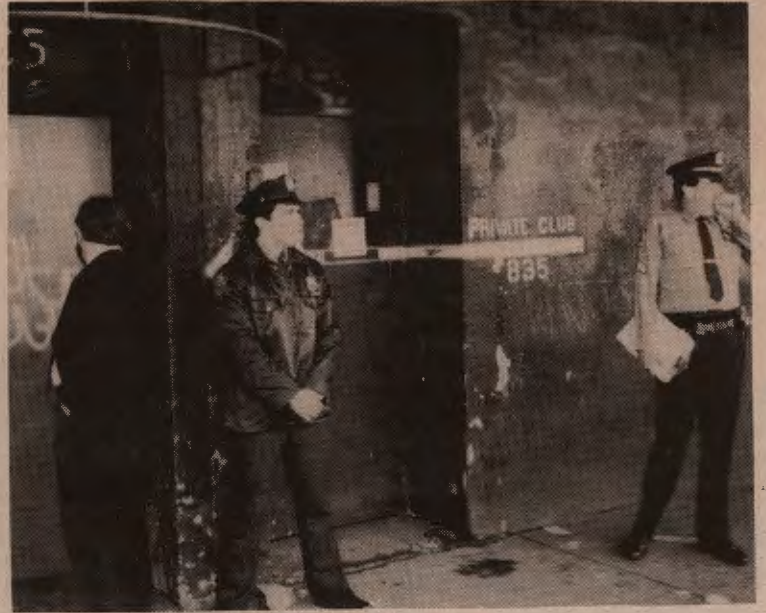

The Homosexual Connection

Experts agree unanimously that AIDS is transmitted largely by homosexual behavior and intravenous drug use. "Men who have sexual relations with other men are especially at risk," says Dr. Koop. "About 70 percent of AIDS victims throughout the country are male homosexuals and bisexuals"

The Perversity of Homosexuality

As Reverend Rueda indicates in his book, these diseases can be directly linked to homosexual practices. Drs. Rompalo and Handsfield note as well that "certain sexual behaviors that are especially common among homosexual men, especially those involving direct or indirect contact with feces, specifically increase the risk of sexual transmission of enteric infections. . . . Numerous factors such as sexual practice, multiple partners, and anonymity interact to make the presentation and problems of STDs [sexually transmitted diseases] in homosexual men unique." A brief examination of these factors reveals both the depravity of the homosexual lifestyle and the cause of the high prevalence of these diseases:

Sexual Practices: A 1983 national random sexuality survey performed by the Institute for the Scientific Investigation of Sexuality found that 100 percent of all homosexual men had practiced oral/penile sex at some point in their sexual history, 93 percent had practiced anal intercourse, 92 percent had participated in oral/anal sex, 41 percent had at some point practiced "fisting" (the insertion of the hand and/or forearm into the anus and rectum), 29 percent had participated in "water sports" (urinating on or in their partner), and 37 percent had taken part in sadomasochism. Furthermore, the study found that 17 percent admitted to eating and/or rubbing themselves with the feces of their partner, and another 12 percent reported giving and receiving enemas as part of sexual pleasure.

In another 1983 study, the federal Centers for Disease Control (CDC) surveyed 50 male homosexual AIDS patients and 120 male homosexual "con-

trols." The study found that during the previous year 99 percent practiced receptive oral/penile sex, 92 percent practiced receptive anal intercourse and 96 percent practiced insertive anal intercourse. In addition, 68 percent acknowledged insertive oral/anal sex, 40 percent admitted insertive fisting and 16 percent receptive fisting.

Multiple Partners/Anonymity: More than one AIDS researcher has been shocked by the widespread promiscuity of homosexual men. The same CDC study found that the median number of lifetime sexual partners (i.e., the number of persons with whom the subject had sex from the time he became sexually active to the present) of these men was 1,100; a few of the patients reported as many as 20,000. Another study by the Kinsey Institute for Sex Research found that 15 percent of the homosexual men surveyed reported having between 500 and 1,000 partners; an additional 25 percent reported having more than 1,000.

As shocking as these numbers may be to traditionally-minded Americans, they are even more disturbing when looked at on a weekly or yearly basis. In a 1977 study of male homosexuals with sexually transmitted diseases, investigators reported that these men visited bathhouses an average of several times a week and had an average of two or three sexual contacts per visit, largely with anonymous partners.

Strangers in the Night

Fast-lane homosexuals patronize the sex emporiums of "gay" bathhouses, bars, sex clubs, theaters, and global sex cruises. Individuals often have relations with several hundred anonymous partners. "Taylor Branch in *Harper's* magazine (October 1982) explains what Dan Bradley (former head of the U.S. Legal Services Corporation and one of America's most celebrated homosexuals) found when he discovered the "gay" bathhouse: "Having read about the gay baths, he finally worked up the courage to visit one in Miami. He walked behind the forbidding walls and saw hundreds of gay men wearing towels. It took Bradley about five minutes to discern that the whole place was expressly designed for promiscuous anonymous sex, which was ex-

actly what he had in mind. He felt secure behind the great walls. 'I must have had sex with ten different guys that first night. I was like a kid in a candy store.'"

The Advocate for November 25, 1986 reported that Dan Bradley is dying of AIDS.

Typical homosexual activity conducted in these bathhouses includes: ejaculating semen into the anus; ejaculating semen into the mouth; urinating in eyes, mouth, anus and on open sores; placing hands in the anus ("fisting"); placing the tongue in the anus ("rimming"); eating feces; inserting "sex toys" into the anus and mouth; and popping amyl nitrate inhalers ("poppers") to relax the anal sphincter muscle.

The terrible consequences of homosexual behavior have been reported in the medical literature. Based on dozens of clinical case studies the following is a medical profile of sexually active homosexuals as found in AIDS: *The Medical Mystery:*

The mucous membranes of the rectum in gay men are frequently traumatized and inflamed. . . . Many have a history of multiple, recurrent bacterial, protozoal and viral infections of the gastrointestinal tract, including shigellosis, amebiasis, giardiasis, and salmonellosis. The genital and anal surfaces in homosexual males often show effects of many sexually transmitted diseases, including herpes, syphilis, gonorrhea, non-specific urethritis and venereal warts. The prior damage to these surfaces may actually facilitate entry of an agent like AIDS.

The National Institute of Allergy and Infectious Diseases reported in the January 1987 *Journal of Virology* that the AIDS virus can both infect and linger in cells from the large intestine and its lower region. "This finding," said Sandy Hecker of the National Institute, "may provide one explanation for the high incidence of AIDS among persons practicing anal intercourse."

Mixed Marriage Goes Against Nature-Disrupts Society

Integration Leads To Interracial Marriage

The American Nationalist was an excellent newsletter published by Frank L. Britton in the 1950s. (He is author of the book, "Behind Communism" our best seller.) Immediately after the Supreme Court outlawed Segregation in the schools Mr. Britton wrote the following article. He predicted this would lead to interracial dating and marriage.

"If White children are educated with Negroes in the same school, go to church with them, and thrown into constant and intimate social contact with them they will become blind to the differences between the races which are obvious to you and me. They will be unable to discriminate between what is right and wrong.

"Our children are being mentally conditioned to accept the presence of black students in their midst. Later they will be taught that all races are equal in ability and intellectual capacity and that there is no essential difference between the races. White youths will be brain-washed into believing any manifestation of racial pride, race consciousness or racial separation is "anti-social, racist and even criminal."

When this process of brain-washing is far enough along White students will be introduced to the 'joys of interracial social activities.' Needless to say, it is only a step from there to interracial sex and mixed marriage. My point is that our children must be taught the difference between good and bad, right and wrong, black and White."

Interracial Marriages Increase

Frank L. Britton's prophecy has unfortunately come to pass - EVERY WORD OF IT! In 1968 the Supreme Court held invalid all the laws banning interracial marriage in the Southern states and most Western states. That year mixed marriages were 0.7%, and in 1980 increased to 1.5%, and today 2%. There are nearly one million interracial couples in America. The largest number, by far, consist of a White bride and a black groom.

Why Some Women Marry Negroes.

Sexual Racism is an establishment book by Charles Stember. He states that some women favor dominant characteristics in men over their physical appearance. Stember admits that black men "madly lust after White women". This is explained as follows:

Lust in fact, may be too gentle a word for the maelstrom in the Black male's brain. Because the White woman stands at the apex of beauty and social status throughout the world, intercourse with her vastly magnifies a Black male's perception of dominance and defilement of that which is opposite his own race. It is his crowning sexual experience, which is why he seeks out a 'mulatto' or 'high-yellow', half caste, when he cannot get a White woman.

Stember says that if a Negro can demonstrate he has athletic ability, money, success in music or show business, or even street-corner sassiness it is possible for him to find a White woman who wants to be DOMINATED! Stember predicts that interracial marriage will rise phenomenally. His book was published in 1978 - well before the advent of AIDS. As people become aware that interracial sex is the fastest way of getting AIDS this self-destructive practice will come to a screeching halt!

Stember proves his point by reprinting Eldridge Cleaver's infamous quote from his book, "Soul on Ice" - which we reproduce here:

"I love white women and hate black women. It's just in me, so deep that I don't even try to get it out of me anymore. I'd jump over ten nigger bitches just to get to one white woman. Ain't no such thing as an ugly white woman. A white woman is beautiful even if she's balding and only has one tooth. . . . It's not just the fact that she's a woman that I love; I love her skin, her soft, smooth, white skin. I like to just lick her white skin as if sweet, fresh honey flows from her pores, and just to touch her long, soft, silky hair. There's a softness about a white woman, something delicate and soft inside her. But a nigger bitch seems to be full of steel, granite-hard and resisting, not soft and submissive like a White woman. . . . I love a White woman's dirty drawers."

Murder-Prostitution-Result From Mixed Marriages

Every reader has viewed on TV or in your local newspaper stories in which a black male and a White female companion have committed some terrible crime and were arrested. For some strange reason White women who are prone toward crime will often join with a black criminal. Also, those who get involved in interracial marriage are unstable people who are in revolt against the customs of White society. Children of such unions often find themselves going contrary to social mores.

When former heavyweight champ Floyd Patterson married

Problems Of The Mixed Marriage

Interracial Family Alliance is a New York based organization which tries to find answers to the difficulties facing mixed couples and their children. I found out very quickly that you don't live in one and the other. We lived in the black world. We were never really accepted by the Whites."

Liberals Work To Place South Africa Under Heel Of Soviets

Destruction of White Civilization Sought

Amnesty International (A.I.) has never requested that Nelson Mandela be released from prison. They explained, "A.I. works for the release of prisoners of conscience. A.I. does not believe that this definition applies to Nelson Mandela. He was sentenced to life imprisonment in 1964 after acknowledging in court his participation in

the planning of acts of sabotage as a leader of the ANC."

Mandela has been offered his freedom if he would renounce the use of violence. He has steadfastly refused. He was arrested in 1964 for planning with the Communist Party, a major guerrilla uprising called, "Operation Mayibuye." He envisioned the deployment of thousands of terrorists throughout the country. Mrs. Mandela Pays Her Rent

Nelson Mandela's wife Winnie has been leading a "rent strike" among blacks who live in low rent subsidized government housing. She has been urging her followers not to pay any

rent so as to further her long-range plans to bring down the government. Many have thusly refused to pay.

South Africa's "Star" newspaper investigated and found that Winnie has never missed a rental payment on her home in

Phefeni.

Also, she is now building a million dollar palatial mansion in Soweto. Mrs. Mandela has not missed a single payment on this new home either! What we have here is a perfect example of hypocrisy of the lowest order.

Mrs. Mandela is saying, "Do as I say, not as I do!" This revelation has received much publicity in South Africa and many blacks are now having second thoughts about their self-appointed leaders!

●The terrified Black victim is captured by his (her) Black executioners. Frequently, his hands are hacked off as a first deterrent to resistance. Barbed wire is otherwise used to tie the helpless victim's wrists together.

●The tire is placed over the shoulders and filled with petrol or diesel. (The latter has been found to stick to the skin when it burns. It is, therefore, in greater demand.)

●The fuel is ignited with a match. (Exhibiting boxes of matches is one way the Comrades instill fear in the Black townships.) The victim is sometimes forced to light his own necklace.

●The fuel ignites the tire which rapidly attains a temperature of 400°C to 500°C.

●As the tire burns, great clouds of black smoke spiral upwards. Various short-chain hydrocarbon-type fumes are released which reach a temperature of 300°C. They are inhaled and destroy the lining of the throat and lungs.

●The rubber melts and the molten

rubber runs down the neck and torso, burning, as it goes deeper and deeper into flesh and tissue. (The tire cannot be removed by others, e.g., family, at this stage; neither can the fire be doused with water.) The victim is now a living corpse.

●The victim may take up to 20 minutes to die. While he endures this agony, the Comrades stand about laughing and ridiculing him. The molten rubber is similar to boiling tar and cannot be separated from the scorched flesh.

●In the first four months of 1986, the year in which the Comrades have promised to free the people of South Africa, 250 people died by necklace murder. Between September and December last year, an equal number died in this way.

●"Necklacing" is only part of the horror. In addition 1,714 Black businesses, 4,435 houses (excluding Crossroads), 28 churches, and 54 halls have been destroyed by fire.

South Africa Will Destroy Any Invasion Force

South Africa Is Heavily Armed And Ready To Fight
The White People of South Africa number 5 million in a nation of 23 million blacks. Central Africa has a population of over 150 million blacks. According to the Organization of African Unity based in Nigeria they wish to equip an "All African People's Force" to mount a conventional war against South Africa!

The regular army has about 75,000 men which includes conscripts of all White males who must serve two years. They built 1,500 Ratel MICVs which can carry up to 12 men for rapid deployment and can still fight with a 60mm or 20mm guns and a machine gun.
