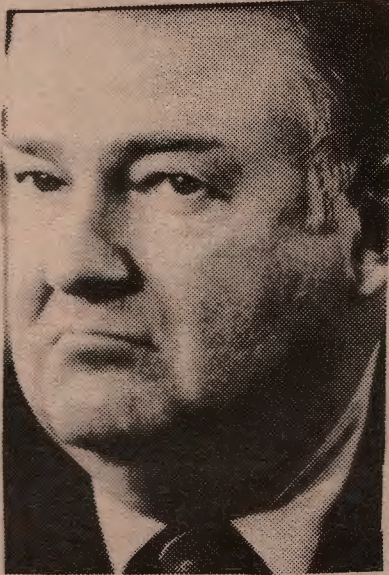


Atty. Gen. Edwin Meese Behind Wedtech Scandal

How U.S. Attorney General Edwin Meese Made Wedtech Scandal Possible

Edwin Meese is the first Attorney General in history to be investigated by three different "independent prosecutors." This time his luck may well be running out as he may be indicted by a Grand Jury now meeting in Washington. Meese has long claimed to be a "conservative" but his close personal ties to Zionist socialists render this very questionable. The main point to bear in mind in studying the information below is that Edwin Meese personally aided Wedtech to obtain much of its \$250 million government contracts.

New York City District Attorney Mario Merola declares: "Wedtech is a criminal conspiracy from start to finish. It involves payoff schemes, bribes and corruption which reach into the highest echelons of government."

A White man from Puerto Rico, John Mariotta, had a small tool and die shop in the Bronx, N.Y. He met a Jew from Romania named Fred Nueberger who represented a consortium of other Jewish immigrants with ties to the Israeli Mafia and the Jewish Lobby. Neuberger told Mariotta that he had friends in government who could help them obtain military contracts. There would be no competitive bids because of a special program to help "members of disadvantaged minority groups."

Mariotta is a member of the Puerto Rican minority and could be eligible for the program. Mariotta agreed and took Neuberger and some of his Jewish friends into the company. Neuberger changed the name to Wedtech because it sounded more scientific than "*Mariotta Tool and Die Co.*"

Meese and Wallach Move To Washington

In 1981 Pres. Reagan took office and Edwin Meese moved from California to become "Presidential Counselor." Also, Meese's life long friend, E. Robert Wallach, Jew, moved to Washington from San Francisco, where he had long been active in left-wing causes. He went to work in the Jewish law firm of "Arnold and Porter" which is an arm of the Jewish Lobby. Wallach also became an advisor to Meese. Wallach sent Meese numerous memos appealing to him to help Wedtech obtain military contracts.

In 1982 Meese directed members of his staff to aid Wedtech in obtaining no-bid U.S. Army contracts. This led to Wedtech's first big \$32 million contract.

In 1983 Wallach goes on Wedtech's payroll as a "consultant" and is paid hundreds of thousands of dollars worth of Wedtech stock.

In 1984 Wallach is paid \$76,000 in government money to be an advisor to Meese during his confirmation hearings which led to his becoming U.S. Attorney General. Meese faced 11 allegations that he arranged for government jobs for people who have helped him financially. The charges against Meese are dropped for insufficient evidence.

It is then revealed that in 1982 Meese told Wallach to invest in Wedtech stock as this company was "going places."

In 1985 Meese requests that U.S. funds be provided to build an Iraqi pipeline project which is headed by Wallach.

Meese Aids Go To Work For Wedtech

In 1984 Meese chief deputy, James E. Jenkins, presided over meetings between the U.S. Army and Wedtech to insure they got

Ginsburg's Shocking Record

Atty. Gen. Edwin Meese Picked Ginsburg Hoping To Save Himself From Prison

Judge Douglas Ginsburg's nomination to the Supreme Court shocked many in Washington. Howard Baker, Chief of Staff to the President, warned that Ginsburg had less experience than any other nominee in history! President Reagan didn't even know who he was and only met him for 30 minutes on the morning he made the nomination?

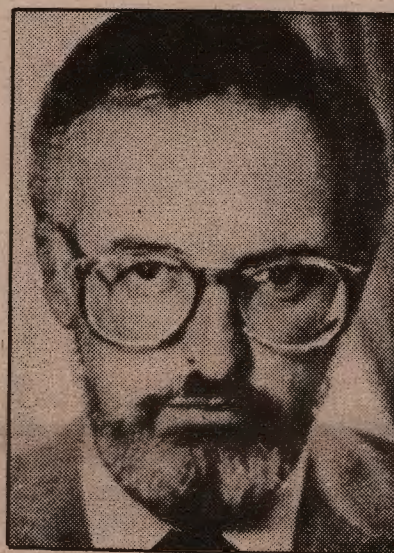
U.S. Attorney General Edwin Meese marshalled all his friends behind the scene to pressure the President into choosing Ginsburg. What motivated Meese to pick a nearly unknown who tried one case in court, and had served only 11 months as an appeals court judge?

Edwin Meese is deeply involved in the Wedtech Corp. scandal and may well soon find himself indicted. He is the first U.S. Attorney General to have been investigated three times by independent prosecutors. Here is what we have been able to discover about the Ginsburg - Meese connections.

Ginsburg No Conservative

1) **Human Events**, a Republican newspaper, investigated Ginsburg and they could find nothing "conservative" in his background! Reagan said Ginsburg would be "tough on crime." Human Events reported: "*Ginsburg has no tract record in the areas of crime, quotas, pornography, abortion and the like - his friends say they are unsure where he stands on these issues.*"

2) Ginsburg was given a "qualified" rating on his

nomination to the Court of Appeals by the American Bar Association their lowest rating! Reagan had said "Ginsburg is eminently qualified."

3) Ginsburg was a law clerk to the most left wing Supreme Court Justice Thurgood Marshall from 1974-75. Meese had said "Ginsburg is a hard-rock conservative?"

4) The so-called, "conservative Jew," Ginsburg actively supported Robert Kennedy for President in 1968.

5) Ginsburg strongly believed in feminism. He was married twice and had a daughter by both marriages. He told both wives to keep their own last names and their daughters were to take their mothers last names.

6) Ginsburg's last wife, Dr. Hallee Morgan, performed abortions while a resident at the Jewish Beth Israel Hospital. Dr. Morgan was also active in both civil rights and anti-nuclear groups.

Ginsburg was only age 41 and could easily have sat on the Supreme Court for another 40 years inflicting possibly great

damage on our nation. How could Reagan have chosen such a left-wing Jew for the highest post in the land next to his own? The following are criminal allegations which have been placed against Ginsburg - the great "law and order" nominee of Reagan and Meese.

As a Justice Dept. attorney Ginsburg successfully argued a case favoring the Cable TV industry. Unknown to others he had a \$140,000 investment in a cable TV Co. which represents a conflict of interest.

B) **The Cleveland Press** closed in June 1982 after Jew, S.I. Newhouse, (owner of the competing "Plain Dealer"), paid Joseph Cole \$22.5 million for The Cleveland Press subscription list. The shut down cost hundreds of workers their jobs. Ginsburg closed an anti-trust investigation in favor of Newhouse.

C) In the mid-1960s Ginsburg started a sex club called "**Operation Match.**" It asked questions such as "*is extensive sexual activity part of growing up?*" and "*Do you believe in a God who answers prayer?*" The club went bankrupt and many who joined filed complaints with the U.S. Postal Inspectors. Ginsburg sold out at a profit when he saw the club was going to fold-up.

E) Ginsburg was forced to withdraw his nomination for the Supreme Court when National Public Radio, (not the FBI), revealed he has long been a user of the drug marijuana, even while a law professor at Harvard in 1979.

Why Did Meese Choose Ginsburg?

Meese is in grave trouble over the Wedtech scandal and

contracts. Meese admits that Jenkins was in charge of the project to help Wedtech obtain government work.

Army officials now say, as a result, they ended up paying much more than they originally intended. It is discovered that Wedtech did no actual work on many government contracts but sub-let them out to sub-contractors. Thus Wedtech pocketed huge profits with little or no work.

In 1986 James E. Jenkins resigns from Meese's office and accepts a high paying job at Wedtech, (you guessed it), as a "consultant."

In 1982 Wallach introduces Meese to a Chinaman from Shanghai named W. Franklin Chinn. He is a financial "consultant" - of course. Wallach obtains a job for Chinn with Wedtech as a "consultant" and later he becomes a director.

In 1985 Meese gives Chinn \$60,000 to invest for him in a "blind trust." Only 19 months later Chinn tells Meese of his good fortune. Meese's investment has earned him a handsome \$40,000 profit. How such a quick profit was possible has not been explained.

Chinn obtains a job for Jewish Dr. R. Kent London of England, as, yes, another "consultant" for Wedtech. The two meet in Geneva, Switzerland and three times in London for which no work for Wedtech has ever been discovered. Still Wedtech pays London \$1 million for "promotional compensation."

In May, 1987, the court appointed trustee of Wedtech sues Chinn for \$11 million for *illegally obtaining consulting fees for which he performed no work.*

Sept. 30, 1987, a former Wedtech vice-president, Mario Moreno filed an affidavit in federal court charging that, "Meese interceded with Defense Secretary Casper Weinberger to help Meese obtain a \$135 million contract from the U.S. Navy for Wedtech."

A few weeks later Weinberger resigns and many believe he left office in order to try and avoid being drawn into the spreading Wedtech scandal.

Meese Under Criminal Investigation

Oct. 31, 1987 Edwin Meese is questioned for five hours by a federal grand jury. Special prosecutor James C. McKay says the possible indictment against Meese would be, "bribery, receipt of unlawful gratuities and conflict of interest." Other laws which apply include: "government employees must not give preferential treatment to any person."

Last fall Wedtech filed for bankruptcy and four of its officials pled guilty to bribery charges. New indictments are forthcoming and Meese, Wallach, Chinn and others are at the top of the list. Meese has retained Jew lawyer Nathan Lewin to defend him in the event he is indicted.

There can be no doubt that Edwin Meese is the chief person responsible for many of the government contracts which went to the Israeli Mafia operated Wedtech Corp. If there is any justice left at all in Washington Meese will be indicted, removed unceremoniously from office and given the stiffest sentence provided by law.

In 1984, Meese had Pres. Reagan salute Wedtech for setting an example as to what minorities can achieve in America. Reagan called its executive officers, "heroes for the 1980's for achieving the goals of the Great Society for minorities." Edwin Meese wrote the speech for Reagan.

may well soon be indicted. He has long surrounded himself with wealthy Jews and believes that the Jewish Lobby in Washington is so powerful that it can prevent his indictment or save him from conviction or help him win on appeal! The Wedtech story is one with Jewish involvement from beginning to end.

Ginsburg's nomination for the Supreme Court was sponsored by the Jewish operated "Heritage Foundation." This is a front group financed by wealthy Jews for the sole purpose of winning conservatives over to support Zionism. This Heritage Foundation is a serious threat by Jews to control the Right-Wing.

Washington lawyer, Mike Horowitz, who is closely connected with The Heritage Foundation told Meese that Ginsburg would be his wisest move. That did it - before long Meese had engaged his entire White House staff working to obtain Reagan's nomination for Ginsburg. No one knew anything about Ginsburg's liberal activities and his illegal activities! And to think that Pres. Reagan asked the Senate to speed through Ginsburg's confirmation without any witnesses being heard - Pro/or Con! Thank God for National Public Radio for blowing the whistle on this drug user in time to prevent the Senate from approving his nomination!

"Quiet" Jewish Support For Ginsburg — says Evans and Novak

An unmistakable tilt away from all-out opposition to Judge Douglas H. Ginsburg by liberal Jewish leaders is weakening the wall of opposition that blocked Robert Bork's Senate confirmation to the Supreme Court on, above all else, the civil rights issue.

If confirmed, the court of appeals jurist would be the only Jew on the high court. An aide to one Jewish senator told us this factor "is softening" Jewish critics of his conservative ideology, despite the American Jewish Congress' denial that Judge Ginsburg might receive favorable consideration. Senators backing Judge Ginsburg see signs that His-

panics, also participants in the umbrella Leadership Conference on Civil Rights, may also lay off.

Dave Brody, the longtime head of the Washington office of the Anti-Defamation League (part of the Leadership Conference on Civil Rights), told us Jewish groups "will be looking at Judge Ginsburg's record but particularly at his positions as they are developed on issues of concern." The ADL took no public position on Judge Bork and will not on Judge Ginsburg on grounds that the issue is strictly a "political" one. The same is true of other tax-exempt organizations, such as the American Jewish Committee.

But leaders of these pressure groups are well- and widely received on Capitol Hill. Their opinions carry weight. The lack of a Jewish justice ever since Abe Fortas resigned as an associate justice in May, 1969, has been a source of frustration within the Jewish community. Judge Ginsburg's confirmation would change that.

Meese Backs Israel

Israel and the United States share the same interests and long-term objectives that led to their collaboration in the sale of arms to Iran, Attorney General Edwin Meese III told 700 attorneys here at the Proskauer award dinner of the UJA-Federation lawyers' division.

"Israel has taken a long view in looking at this and has taken with us a strategic approach, of which Iran is a very important piece," Meese said.

"We share with Israel the same objective and interests as far as that region of the world is concerned," Meese said.

Meese added: "Because we share the same interests, this administration is committed irrevocably to the safety and security of Israel. Whatever steps we take in that region will always have in mind the impact of those steps upon that nation."

(Editor's Note: Meese is wrong. Israel's interest is to keep Arab nations divided and fighting each other, thus they sell arms to Iran! U.S. interest are to build peace and stability in Middle East.)

Voters Reject King

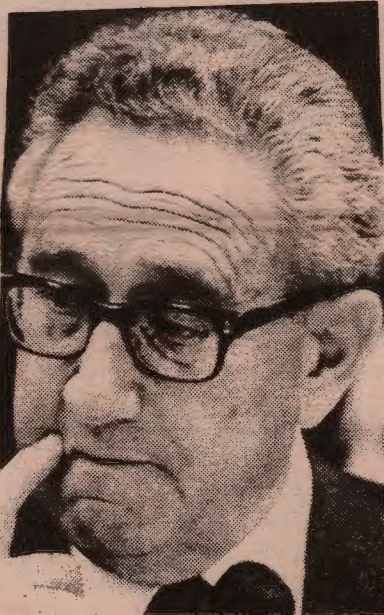
This controversy received wide publicity in North Carolina. It has served the purpose of awakening many sleeping people to the subversive threat to our children which exists in many universities.

A Jew In The White House?

Is the United States ready for a Jew in the White House?

Yes, according to Kitty Dukakis, the wife of Massachusetts Gov. Mike Dukakis, who is a candidate for the Democratic presidential nomination.

Kitty, who is Jewish, was in Minnesota recently campaigning for her husband. She noted her Minnesota connection by hugging Rabbi Barry Woolf during her appearance at the Minneapolis Ritz Hotel. Woolf was her rabbi while she was at Hazelden Center in Center City, Minn., five years ago, recovering from her addiction to amphetamines.

That 1975 trip to Israel, Dukakis' first, proved to be life-changing. "I had a kind of 'conversion' there," she said. "When I returned, for the first time in my life I joined a temple and became more involved in Jewish activities in Boston and Massachusetts." She has since visited Israel five times, and has developed friendships there.

She also helped develop a curriculum for Massachusetts schools

on the Holocaust, along with one on the Armenian genocide by the Turks. In 1979, she was appointed to the president's Commission on the Holocaust and its successor, the U.S. Holocaust Memorial Council.

In Boston, she works with Hadassah and the United Jewish Appeal. And, she has taken activist positions on behalf of Soviet Jewry.

She is also involved—as an "activist-spouse," as she calls herself—in refugee resettlement work.

Her maiden name, Dickson, was changed from "Deuchin" by her great-grandfather as he and his family traveled from Russia to Ellis Island.

The family celebrates both Jewish and Christian holidays. "We both felt strongly enough about our religion and our ethnic ties," she explained. "Our children are Jewish, because I am Jewish, but they consider themselves half-Jewish."

She is also a member of the executive committee of the New England Anti-Defamation League.

The Jewish Campaign of Gov. Dukakis

Gov. Mike Dukakis has raised over \$10 million, twice as much money for his Presidential campaign, than any other Democratic candidate. It has been speculated that Greek Americans are contributing heavily to him. Still, on the other hand, the Greeks we know reject him because he is married to a Jewess and allowed his children to be raised as Jews! Then, where is the money coming from?

On closer examination we find money flowing in from wealthy Jews. From scanning Jewish publications we read that they believe it is time to have a Jewish First Lady in the White House! Kitty Dukakis is a member of the Jewish Anti-Defamation League, (a sort of Jewish secret police), and the Holocaust Council.

Jews Run Dukakis Campaign

The Wall Street Journal says Rosen is a specialist at raising money from, "a small group of wealthy and well-connected people."

It is interesting to note that some candidates' campaigns are deep in debt including Babbitt, Gephardt and Haig. Deepest in debt is Rep. Jack Kemp who already owes over \$1 million.

No Free Speech For Holocaust Dissidents

The University of Nebraska held a conference on the holocaust last November. Businessman William Curry sought to place a full page ad in the student newspaper at a cost of \$1,000 offering the school \$5,000 if they would allow Prof. Arthur Butz to participate. Prof. Butz teaches at Northwestern University in Evanston, Ill., and has written a book proving that the holocaust never happened. Needless to say, Mr. Curry's offer was rejected after pressure from local Jewish leaders.

French Right-Wing Strongest In Europe

Slander Campaign Fails To Stop French Leader

The National Front Party in France made spectacular gains in the last election and jumped from 1% of the vote to 10%, and from no members in Parliament to 34. Recent polls show they will win 17% in 1988. The National Front advocates deportation of the 4 to 7 million immigrants back to Africa in order to solve France's serious 11% unemployment problem.

The left-wing news media has long sought some excuse to smear National Front founder Jean-Marie Le Pen to hurt his chances in next year's race for President. Believe it or not, in France, (as well as in both Canada and Germany), it is against the law to state you doubt the holocaust!

Gas Chambers Questioned

In a radio interview on Sept. 13, Le Pen was asked this trick question: "Do you believe that Jews were the victims of genocide through gas chambers?"

Le Pen replied: "Do you want me to say it is a revealed truth that everyone has to believe? That it's a moral obligation? I say there are historians who are debating these questions."

"I am not saying that gas chambers did not exist. I couldn't see them myself. I haven't studied the question specifically. I believe that it is a minor point in the history of World War II."

Jews and Communists Attack Le Pen

Of course, the truth is that many Jews and other prisoners did die in the concentration camps. Still most perished from typhus and other diseases which not only swept the camps but the local communities as well killing many German civilians. The real truth is that not a single Jew was ever gassed in any German camp. (See our "Truth Tract No. 1, "Was There Really a Holocaust," and our holocaust studies book list.

The media in France still twisted what Le Pen actually said out of context and ran sensational headlines such as "Le Pen Denies Holocaust." They reported 5,000 Jews and communists demonstrated in front of the French Parliament demanding Le Pen's immunity be lifted so he could be prosecuted on the charge of "spreading hate!" The truth is that only 1,300 demonstrated and the press said nothing about the 50,000 who attended

a National Front rally three days later who gave Le Pen a 15 minute standing ovation.

Court Intimidated

The radical "International League Against Racism and Anti-Semitism" did file a suit against Le Pen in court "for daring to question the holocaust!" The case against Le Pen went to trial on Sept. 23. The judge found him guilty for "criminal defamation against humanity" - meaning Jews! (No such charge would be possible in America.) The judge was seen trembling before a courtroom crowded with screaming Jews and newsmen. He fined Le Pen - ONE FRANC! Still, came new headlines proclaiming, "Le Pen Condemned" and "France Outraged by Le Pen." All of this is supposed to cut his percentage of the vote in next year's election. Many feel this persecution will backfire and actually increase his total vote.

Oppressive Laws Planned

Still the Marxist Liberals continued their hate campaign against Le Pen. French Interior Minister, Charles Pasqua, demanded new laws to silence any one who would dare to question the claims of the holocaust survivors - (all 6 million of them!) He asked Parliament to enact laws making it a crime to speak or write any expressions doubting the holocaust story. Any printing, selling or owning of books or literature daring to question the holocaust would also be a crime.

The police would be given powers to search private homes and seize any "defamatory books, newspapers, leaflets or tracts which cast doubt on the holocaust." Heavy jail sentences and fines would be imposed on those found guilty. It should be noted that at one time in Europe it was also a crime to say that the world was not flat. This was considered a heresy.

Thousands take to streets of Paris demanding that Le Pen face justice

PARIS (JTA) — Thousands of people demonstrated here demanding that Parliament lift the immunity of rightwing leader Jean Marie Le Pen so that he can be tried for inciting racial hatred and defending Nazi war crimes.

The demonstrators were protesting Le Pen's public statement doubting the existence of Nazi gas chambers and the reality of the Holocaust. Le Pen also downgraded the massacre of millions of Jews during the second World War as "a minor historical detail."

Among the approximately 5,000 people who marched in front of the National Assembly were two former Socialist premiers, Pierre Mauroy and Laurent Fabius, and dozens of

prominent writers and philosophers, mainly Jews. Some of the organizers privately expressed disappointment over the turnout, which they expected to be larger.

Le Pen's National Front won 34 seats in last year's Parliamentary elections. According to public opinion polls it still enjoys the support of some 10 percent of the electorate.

Chirac and Barre have not yet reacted to Le Pen's statements about the Holocaust.

Six organizations representing former deportees and resistance fighters announced they will sue Le Pen for civil damages. Parliamentary immunity does not protect him from civil suits.

Assassination Plots

The Vicious Persecution of Le Pen

There have been several assassination attempts upon Le Pen. His apartment in Paris was bombed while he was away. His children barely escaped with their lives. His second in command, Francois Deprat, was murdered when his booby-trapped car exploded. His office was dynamited. Some twenty of his meeting halls have been either bombed or so vandalized they could not be used.

Leftist thugs attacked Le Pen and so damaged one eye that he is nearly blind in it. Still not a single attacker has been arrested by the police. Thus Le Pen has formed his own private security force of young French Patriots who guard his every move.

Despite these many grave provocations Le Pen has continued his aggressive campaign style. On Oct. 2, the French Parliament heads decided to create an affront to Le Pen for his radio broadcast about the holocaust. They held a ceremonial moment of silence for the alleged 6 million holocausted Jews. Outraged the National Front's 34 Deputies walked out in protest.

Le Pen Charges Enemy

Just a few days later Le Pen led a National Front march to lay a wreath at the monument to French war dead in Chambery. During their traditional minute of silent prayer some 30 colored immigrants from Africa screamed insults at the National Front members. Le Pen instantly led his men in a direct assault against these rabble running them out of the town square area. Later the former paratrooper fighter said: "We will not tolerate foreigners who have the audacity to stop Frenchmen from paying homage to our war dead right here in our own country."

Police looked the other way as National Front men thrashed the screaming immigrants.

To keep up with the progress and election campaigning of the National Front in 1988 continue to read THE THUNDERBOLT.

The **Thunderbolt** carried a story last month in Issue No. 321 on the common practice by Jewish businessmen of requiring "kickbacks" from sales people and others forced to do business with them. The women on the show included Morgan Fairchild of Falcon Crest, Delta Burke of Designing Women, Ana Alicia of Falcon Crest and Grace Garland of All My Children.

Starlets Reveal Sexual Attacks

They all agree that the old "casting couch" stories of the 1930s and 40s are still true life horrors today. It should be stressed that the vast majority of all directors and producers in Hollywood are Jews. The line they give these young aspiring starlets goes like this: "If I give you this role, which could lead to stardom, what are you going to do for me?" It is soon made crystal clear that they must give in to his more lustful desires and without much delay! Failure to obey can lead to a young girl being ostracized by all studios where the director has influence. To fellow Jews they explain, "she failed to show the proper appreciation for what I could have done for her."

Delta Burke said on 60 Minutes "I have been 'jumped' by both movie executives and producers. They grab hold of you, throw you on the floor and stick their tongue down your throat. It happens. I've been told that a job hinged on playing ball or getting out of the game."

Morgan Fairchild followed on 60 Minutes and stated: "When I was starting out, there was a particular casting person that I was always sent to see. He'd lock the door and chase me around the desk. I knew that I would never get a part from him because I wouldn't go to bed with him."

Ana Alicia said: "I was brought back three times for tryouts for a TV series. The last time he closed the door and we were alone. He told me his wife didn't understand him. I told him I didn't like him that way. He said I'd never work in this town again."

Grace Garland declared: "I was in my early 20's, and had just started acting. This producer said it looked like I'd do anything to succeed. I said sure, but I wasn't thinking along the same lines as him. He kept taking photos of me and kept telling me to be free. He then wanted me to meet him at his beach cottage for another tryout. The next day I phoned and called it off. He said, I'm very disappointed in you. I really thought we understood each other. I got off the phone and was shaking. I didn't get the job, but one good thing came out of it. I gained a new awareness of the down side of this industry. The casting couch still exists."

Actors Guild No Help

Sexual harassment is against the law but it's alive and well on the "casting couches" of the vicious Hollywood moguls - the vast majority of whom are Jews. The head of the Screen Actors Guild Union is the Marxist Jew actor Ed Asner. Some girls have filed complaints with the union but nothing is done. These women are then ostracized from all the studios. When asked to comment Ed Asner admitted this is a major problem stating:

"Sexual harassment goes on right and left. I know a girl who went to see an agent and he closed the door by pressing a button. He pushed another button and a bed shot out from the wall. That's about as glaring as it gets!"

The old, time worn, Jewish line of, "What's in it for me", and "what are you going to do for me," should be remembered the next time you watch the Jew directors and producers on the Academy Awards. Pres. Roosevelt On The Jew
Pres. Franklin D. Roosevelt made an interesting statement during the 1943 Casablanca Conference in regards to the British-American occupation of North Africa, this was discovered in recently released documents from the U.S. Foreign Relations Archives. Roosevelt stated after the liberation of North Africa from the Vichy French:

To this the Jewish Anti-Defamation League (ADL) protested as yet another act of "anti-Semitism."

Nobel Peace Prize For Vanunu

Mordechai Vanunu, the technician at Israel's secret Atomic bomb plant revealed they have 100 atomic bombs ready for use. After giving this shocking information to the London Sunday Times he was kidnapped back to Israel by the brutal secret police - Shin Bet. He is now undergoing a secret trial for treason after having been beaten and tortured. Vanunu has been nominated for this year's Nobel Peace Prize.

Pope Benedict XIV Warning To Christians About Jews

This encyclical letter was issued on June 14, 1751 at Castel Gandolypho and represents the Church Defense of Christians who were victims of Jewish exploitation.

Moreover, all the trade in articles in general use, such as liquors, and even wine, is also in the hands of Jews; they are allowed to have charge of the administration of public funds; they have become the leaseholders of inns and farms and have acquired landed estates. In all these ways, they have acquired landlord rights over unfortunate Christian tillers of the soil, and not only do they use their power in a heartless and inhuman manner, imposing severe and painful labors upon Christians, compelling them to carry excessive burdens, but in addition, they inflict corporal punishment, such as blows and wounds. Hence, these unhappy people are in the same state of subjection to a Jew, as slaves to the capricious authority of their master. It is true that, in inflicting punishment, the Jews were obliged to have recourse to a Christian official to whom this function is entrusted. But, since that official is forced to obey the commands of the Jewish master, lest he himself be deprived of his office, the tyrannical orders of the Jew must be carried out.

Jews Show Contempt For Christians

We have said that the administration of public funds and the leasing of inns, estates and farms, have fallen into hands of Jews, to the great and manifold disadvantage of Christians. But We must also allude to other monstrous anomalies and We shall see, if We examine them carefully, that they are capable of being the source of still greater evils and of more widespread ruin than those We have already mentioned. It is a matter fraught with great and grave consequences that Jews are admitted into the houses of the nobility in a domestic and economic capacity to fill the office of major-domo or steward. Thus they live on terms of familiar intimacy under the same roof with Christians and continually treat them in a high-handed manner, showing their contempt openly. In cities and other places, Jews may be seen everywhere in the midst of Christians; and what is still more regrettable, Jews are not in the least afraid to have Christians of both sexes in their houses attached to their service. Again, since the Jews are much engaged in commercial pursuits, they amass huge sums of money from these activities, and they proceed systematically to despoil the Christians of their goods and possessions, by their excessive usurious exactions. Though at the same time they borrow sums of money from Christians at an immoderately high rate of interest, for the payment of which their synagogues serve as surety, yet their reasons for doing so are easily seen. First of all, they obtain money from Christians which they use in trade, thus making enough profit to pay the interest agreed upon, and at the same time increase their own wealth. Secondly, they gain besides as many protectors of their synagogues and their persons as they have creditors.

Cardinal Baronius under the year of Christ, 1146, he at the same time urged the king to take severe measures against them, on account of their excesses, in particular, to despoil them of the goods which they had taken from the Christians or amassed by usury, and to use the proceeds for the benefit and advantage of religion.

Christians Are Not To Be Servants To Jews

As for Us, in this matter, as in all others, We follow the line of conduct adopted by Our Venerable Predecessors, the Roman Pontiffs. Alexander III forbade Christians, under severe penalties, to enter the service of Jews for any length period or to become domestic servants in their households. "They ought not," he wrote, to serve Jews for pay in any permanent fashion." The same Pontiff explains the reason for this prohibition as follows.— "Our ways of life and those of Jews are utterly different, and Jews will easily pervert the souls of simple folk to their superstition and unbelief, if such folks are living in continual and intimate converse with them." This quotation concerning the Jews will be found in the Decretal "Ad haec." Innocent III after having mentioned that Jews were being admitted by Christians into their cities, warned Christians that the mode and the conditions of admission should be such as to prevent the Jews from returning evil for good: "When they are thus admitted out of pity into familiar intercourse with Christians, they repay their hosts, as the proverb says, after the fashion of the rat hidden in the sack, or the snake in the bosom, or the burning brand in one's lap." The same Pontiff says it is fitting for Jews to serve Christians, but not for Chris-

This brazen affront appeared in "Jewish Week", September 18, 1987. It was written by a Jew using the name Peter R. Allen-Frost who is a correspondent for ABC-Radio TEL AVIV — Old-fashioned anti-Semitism lingers

in the Catholic church, say prominent officials here, despite hopes for a serious improvement in relations with the Vatican. That is why, they say, the Vatican has not established formal diplomatic relations with the State of Israel.

For centuries, Catholic prayers included openly anti-Jewish references, while the church fervently carried out its "mission" to the Jews. In modern times, that meant converting them. In other eras, it meant converting them or killing them.

The Spanish Inquisition may have happened centuries ago, but in the Jewish psyche, it is as though it happened only yesterday.

The silence of Pope Pius XII in World War II echoes as well through the decades to modern Israel. Because of this Vatican inaction, Jewish men, women and children died in the Holocaust.

Yitzhak Minerbi was a young boy in Rome in those days, one of the few Jewish children saved by the Catholic Church in Italy. Elsewhere, he said in an interview in Jerusalem, "the church did nothing. Even Italian fascists helped Jewish children escape the Nazi onslaught in Italy, France and Greece. The pope was silent."

The Vatican, however, still snubs the Jewish state. While anti-Semitism among world Catholics may have died down, certainly among Western nations, the general opinion here remains that in the "secret, cobwebbed crypts of the Vatican," as one Israeli official put it, anti-Semitism still exists. The Vatican has never forgiven the Jews completely for what happened 2,000 years ago, officials believe, and still holds Jews, and thus modern Israel, responsible for the death of Jesus.

Jews Corrupt Public Office

tians to serve Jews, and adds: "The sons of the free-woman should not serve the sons of the bond-woman. On the contrary, the Jews, as servants rejected by that Saviour whose death they wickedly contrived, should recognize themselves, in fact and in deed, the servants of those whom the death of Christ has set free, even as it has rendered them bondmen." These words may be read in the Decretal, "Etsi Judaeos." In like manner, in another Decretal, "Cum sit numis," under the same heading, "De Judaeis et Saracenis" (On Jews and Saracens) he forbids public positions to be bestowed on Jews: "We forbid the giving of public appointments to Jews because they profit by the opportunities thus afforded them to show themselves bitterly hostile to Christians." In his turn, Innocent IV wrote Saint Louis, King of the French, who was thinking of expelling the Jews from his domains, approving of the king's design, since the Jews did not observe the conditions laid down for them by the Apostolic See: "We, who long with all Our heart for the salvation of souls, grant you full authority by these present letters to banish the above-mentioned Jews, either in your own person or through the agency of others, especially since, as We have been informed, they do not observe the regulations drawn up for them by this Holy See." This text can be found in Raynaldus, under the year of Christ 1253, No. 34.

Now, if any one should ask what is forbidden by the Apostolic See to Jews dwelling in the same towns as Christians, We answer that they are forbidden to do the very things they are allowed to do in the Kingdom of Poland, namely, all the things We have enumerated above.

Popes Edicts On Jews

The Popes Have Long Sought To Protect The Rights of Christians From Jewish Exploitation

Organized Jewry has demanded that Pope John Paul denounce the acts of previous Popes. This is because past Popes have acted to protect the rights of Christians from being exploited by the Jews. Jewish Launch Vicious Attack Upon Pope

Pope John Fails To Appease Jews

"Anti-Semitism" and "Holocaust" are two words which are often used to silence anyone who is critical of Zionism or organized Jewry. There is an old saying that if a Christian criticizes the Jews he is guilty of anti-Semitism. If a Jew criticizes a Christian, then the Christian must be guilty of having wronged a Jew and thus be anti-Semitic. Thus Pope John discovered that in trying to appease the Jews it is really a case of "Heads they win - tails you lose!"

Here are the complaints of the Jews against the Pope. He visited with Yasir Arafat in Sept. 1982 and with Austria's President Kurt Waldheim on June 25, 1987. (Note: Why do the Jews feel they should determine who the Pope may visit???) Also, they objected when the Pope wanted to open a new convent in the city of Auschwitz in Poland. The Jews insist this must be a place where tourists come to weep for the Jews and not, as they put it, "for religious pilgrimages". The Jews have long demanded that Pope John condemn Pope Pius XII because he allegedly did not do enough for the Jews during World War II.

In an attempt to placate organized Jewry the Pope agreed to meet with a delegation of Jews in both Rome and in Miami at the start of his U.S. tour. During these meetings, Pope John said he believed in the holocaust, said the Jews should not bear collective guilt for the crucifixion of Christ and that Jews should not be persecuted.

Pope Defends Palestinian Rights

Were the Jews satisfied with these statements? The answer turned out to be a very loud NO and the Jewish attack upon the Pope became more vicious than ever before! The Pope failed to recognize the state of Israel, saying: "While the Jewish people have a right to a homeland, so do the Palestinian people, so many of whom remain homeless and refugees." Instead of condemning Pope Pius XII, the Pope praised him for helping all people during World War II.

Rabbi Mordecai Waxman took the microphone at the Miami meeting and insulted the Pope saying: "your meeting with Waldheim raised deeply felt concerns among Jews. (Note - who cares?) Greater attention needs to be paid the Christian roots of anti-Semitism. The teaching of contempt for Jews and Judaism must be ended once and for all."

(Note - what about ending Jewish anti-Christian attitudes?)

Pope Condemned For Meeting Waldheim

Rabbi Alexander Schindler, head of the Union of American Hebrew Congregations said: "We did not accept the Pope's explanation of why he had received Kurt Waldheim, the accused war criminal. Nor did we find persuasive the Pope's statement on why the Vatican has not yet recognized Israel."

(Note: - Waldheim served as a German intelligence officer in Yugoslavia where the most brutal fighting of the entire war took place against the communist guerrillas.

Some people were deported from war torn areas just as U.S. forces did in Vietnam. They were not slaughtered as was the entire GERMAN ARMY - in Yugoslavia when the Allies forced them to surrender to Tito. Over 90,000 German soldiers were murdered by Tito and over one million civilians who were either anti-communist or allies of Germany.)

When the Pope greeted Kurt Waldheim he praised him for his many years of working for peace as Secretary General of the U.N. He said: "All of your activity in the course of an international life a diplomat and foreign minister of your country, and also in your difficult work, full of responsibility at the United Nations was always devoted to securing peace among people."

Israel's Prime Minister Shamir shot back: "This could be interpreted as a justification for crimes of which Waldheim is accused."

Rabbi Avi Weiss of the Bronx said: "The Vatican desecrates the souls of the six million Jews killed by the Nazis."

World Jewish Congress Head Lashes Out At Pope

Canadian Liquor barron and billionaire, Edgar Bronfman, head of the World Jewish Congress said: "By saying other groups died at Auschwitz too, the Pope is trying to universalize the holocaust and cloud the issue of Church responsibility for it. There was nothing in the Pope's speech about the rise in anti-Semitism in Austria or elsewhere in the last year."

The Vatican's reconciliation with the Jews' should be accompanied by Jewish dignity and Vatican substance."

Rabbi Arthur Schneier said: "When the Pope met with Yasir Arafat some Italian Jews said that he bore indirect responsibility for PLO attacks upon Israel."

After reading the above quotes and the news clippings reproduced here is there anyone who believes that it is possible to appease the Jews and satisfy their demands? Of course not and such should not even be attempted. Why not stick to the truth in the simple fact that there was never any holocaust of Jews in the way they describe it. Many people of all civilian groups died during that horrible war-Poles, Russians, Jews and, yes, German civilians. No single group was ever singled out for systematic genocide.

"The Talmud" Opposes Jews Meeting Pope

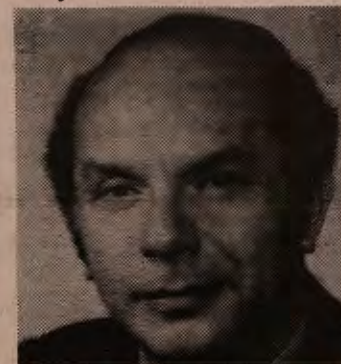
How is it possible to negotiate any differences with Jews who are so vicious in negotiations? Why even try to placate the insatiable demands of such obstinate people?

Some harsh words were uttered by rabbis who seem almost up in arms over the two meetings between Pope John Paul II and Jewish leaders.

Christ and were responsible for the death of their Messiah," Dinitz said recently. "It would be naive to believe this does not leave residues of anti-Semitism in the cultural heritage of people following this tradition."

Eliahu Ben-Elissar, Knesset member of the hard-line Herut party (the main bloc in the Likud group), does not mince words. He acknowledges that political pressures exist but said in an interview that the real reason is old-fashioned hatred of Jews — not specifically Semites. "That's why the Vatican can have relations with Moslem nations, such as Egypt, Iran and Iraq, but not with Israel."

"It's simply unacceptable that we give all the facilities to the Vatican in Jerusalem, Bethlehem, Nazareth and other places, yet for some reason the Vatican refuses to establish relations with Israel. I don't accept the talk of ideological or political reasons — it is simply anti-Semitism."

Another question which comes to mind is why the pope met with Austrian President Kurt Waldheim and Palestine Liberation Organization Yasir Arafat.

Dinitz believes it was because the pope and the Vatican simply do not understand the depth of Jewish feeling, the anguish such meetings produce. Ben-Elissar smiled, saying: "I really do give credit to the head of the Catholic Church — he understands it." He stopped short of accusing the pope of callous, deliberate political maneuvering.

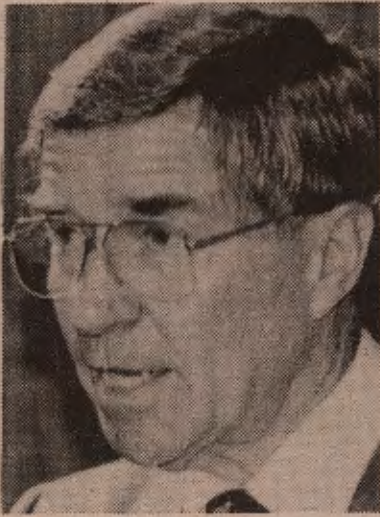

Supreme Court Judge Thurgood Marshall Attacks U.S. Constitution

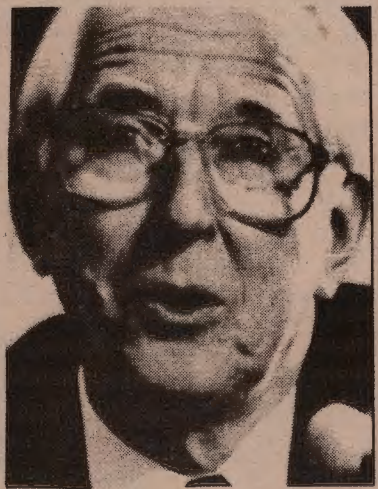

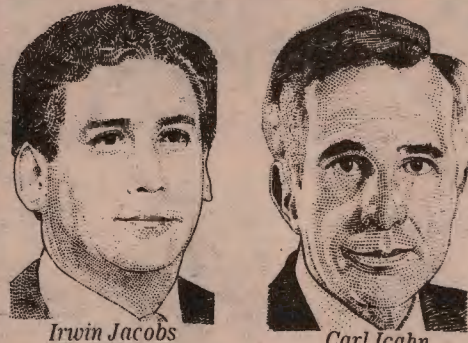

Arbitrators Selling

One disturbing sign, traders said, was the apparent unloading of speculative takeover stocks by arbitrators in recent days. The savvy "arbs," traders say, are getting out because they fear high interest rates and other economic factors will severely curb values and merger financing costs.

THURSDAY, Oct. 22, three days after the crash, cash rich Jews are ready to buy up crippled Christian companies.

The stock market wolves have already begun sniffing around wounded corporate America.

Corporate raiders, with some notable exceptions, are emerging from the stock market's crash with manageable or small losses and newly undervalued companies in their sights.

For Minneapolis investor Irwin Jacobs, for example, the past three days presented a plethora of opportunities.

Mr. Jacobs confirmed yesterday what had long been rumored on Wall Street. He holds a large stake in Greyhound Corp. that is "larger today than it was before Monday," he said.

His resources to hunt for bargains among the depressed shares were bol-

3) The Wall Street Journal, Thursday, Oct. 22, carried this headline—"Raiders Smell Blood In Crash Aftermath." Warburg, Paul Bilzerian, Sir James Goldsmith and Ronald Haft are seeking to take advantage of the misery inflicted upon the business community to further enrich themselves.

4) This article states that Irwin Jacobs sold his stake in McGraw-Hill at \$80 a share, just before it crashed to \$52. Then Jacobs used this profit to buy a huge stake in Greyhound Bus Corp for a new takeover.

5) Carl Icahn stated he has a

new "warchest of \$1 billion" which is aimed at a "new target". Vulnerable Christian businesses are now com emptiously referred to as "targets" by the money-crazed Jews.

The German Experience

The S.G. Warburg Investment Corp. in England reported "There are quite clearly going to be a significant number of buying opportunities for foreign investor takeovers in the U.S." Therefore it is evident that organized Jewish businessmen knew the scene was set for a stock market crash. When they sold huge blocks of stock they knew this would instantly trigger the collapse of the stock market. This is exactly what they did in Germany after World War One. They then rushed back in and literally bought up the country, including hotels, apartment buildings, factories, newspapers, etc. The resentment against the Jews for their brazen takeover of German businesses later paved the road for the rise of Adolf Hitler to power. Many feel that similar hostile feelings now being

stered by his decision to bail out of earlier investments before the crash. Mr. Jacobs said he was savoring this week's bargains. "I don't think in a lifetime I'll see this opportunity again," he said.

Like Mr. Jacobs, others are eager to snap up stocks that have declined in value by as much as half. Several cash-rich investors, including Asher B. Edelman, Carl Icahn and Paul Bilzerian, say they are looking at new targets and may announce stock accumulations in coming days.

But while acquisition funding is difficult to obtain, several raiders expect conditions to rebound in coming weeks. Others already have cash in hand to do transactions. Mr. Icahn, for instance, has a war chest estimated at more than \$1 billion for potential takeovers.

Ronald O. Perelman is looking at about 30 investment candidates "to see if they make sense for us," says Donald Drapkin, vice chairman of Mr. Perelman's New York-based Revlon Group Inc. Mr. Drapkin adds that the current market situation represents "a dramatic buying opportunity from our point of view."

Robert Haft, president of Dart Group Corp., the Landover, Md.-based discount retailer controlled by the family, said:

"We wish that we would have been able to buy Dayton Hudson, but we're now prepared to go on to the next opportunity."

Mr. Haft said that even after the loss on its Dayton Hudson stake, Dart would have more than \$400 million in cash and equivalents. In addition, the family has a net worth—separate from Dart's cash—that was estimated to be about \$500 million before the stock market crashed. "They think there are many, many opportunities that have been created by this market," the individual said, "and the Hafts have a lot of money."

Selloff of Takeover Stocks

A frenzied selloff of takeover stocks by arbitrators the previous week, which had reduced the Dow Jones average more than 250 points in just three days, was a blast that cracked the market's foundations.

This initial retreat was caused partly by a little-noticed development, a new tax bill that included provisions removing tax benefits for takeovers that involved large amounts of borrowed money, the hottest part of the takeover business. The reaction to this threat was sharp.

"That was the match that ignited the dynamite," said Carl C. Icahn, one of Wall Street's best known speculators in takeover stocks and now the chairman of Trans World Airlines. "That selling started the whole thing. That's when the whole thing started to tumble."

Wall Street's aggressive pursuit of takeovers had fundamentally altered the face of corporate America — and made criminals of once-respected, millionaire investment bankers through the insider trading scandal.



More Evidence Holocaust Is A Fabrication

Contradictions Plague Holocaust Story

When did the holocaust begin? This is a question that has long been argued by Jews. In 1939 American Jewish leader Rabbi Stephen Wise said that the Germans secretly planned a holocaust against Jews. That same year the future founder of Israel, Ben Gurion, predicted that there would be a holocaust against Jews. How could they know? How did they arrive at such a conclusion?

"Jewish Post and Opinion" of Oct 7, 1987, featured an article about Yehuda Bauer who says the holocaust began in 1941. He also admits that there was no order or plan for such a massive extermination policy and says until 1941 there was no "pre-meditated plan to kill Jews."

Other Jewish leaders, such as Raoul Hilberg, who wrote "The Destruction Of The European Jews" state that the holocaust was planned at what they refer to as "The Wannsee Conference" on Jan. 20, 1942. All existing records of that meeting say only that Jews would be removed from certain areas of Europe and resettled in Poland until the end of the war!

Already we have discussed three different time periods in which this holocaust was supposed to have taken place. It is our belief that many people died in the concentration camps during World War II including Jews and the living conditions were no doubt very bad.

Still, even Bauer and other Jews now admit they can find no order or plan for any mass extermination. It is also of interest that Jews now say that the only camps where the holocaust was carried out existed in Soviet controlled Poland. Not a single German made gas chamber, (nor a trace of one or plan for one), has ever been discovered anywhere!

David Low was a Jewish war propagandist who drew the cartoon printed on this page. No Holocaust Until 1941 - Bauer

QUEBEC — Even for Yehuda Bauer, one of the world's foremost authorities on the history of the Holocaust, there is a paradox built into trying to understand the crimes perpetrated by the Nazis.

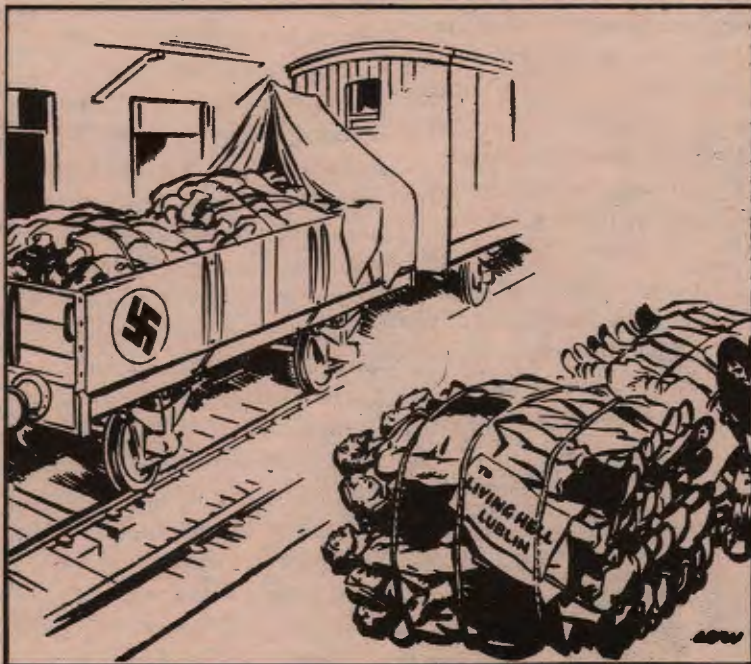
Bauer maintains that, contrary to popular belief, there was no pre-meditated plan to kill Jews until 1941. "The policy was to force them out of Germany... By expelling them to countries hostile to Germany, the Nazis believed that the Jews would corrupt those countries and in the process make their enemies more pro-German."

There is also, Bauer said, no actual proof that Hitler intended to exterminate the Jews until 1941. "He never said it, he never wrote it down.

If someone can find proof in *Mein Kampf* I'd like them to show it to me... It wasn't until eight years after Hitler came to power that the light shone at last — that the Nazis realized that killing the Jews was what they had wanted to do all along."

had been used for. Maybe what oppressed me was the smallness of it all. It was hard to imagine, looking at the neatness of everything, that tens of thousands of people had over many years suffered incredible degradation and pain here. True, in a way the orderliness and dispatch with which bureaucratic transactions in human lives were once effected here had been one of the supreme horrors of the place. But this, too, no longer came through from the present neatness and orderliness. The little box that had been the death chamber could not have held very many prisoners at once. There were only two openings, each admitting but a single corpse at a time to the oven of the crematorium. The two burial places, one marked with a wooden cross, the other with a Jewish star—pits into which the ashes of thousands of human beings had been dumped—were each not much larger than an individual grave.

The above clipping, describing Dachau as a "place of horror", was taken from the Feb. (1956) issue of COMMENTARY, official organ of the American Jewish Committee. But note that although the author claims "thousands" of Jews were cremated here, the crematorium is only of normal size—much too small for the mass cremations he claims took place there.

"Death Camp" On Staten Island?

Hollywood Also Predicted The Holocaust

Nearly all of the Hollywood film industry was either controlled or run by Jews before World War II as it is today. Then, like now, at least 80% of all film producers and directors are Jews. An interesting article appeared in the Bergen, N.J., "Sunday Record" of Feb. 15, 1981 which in part stated:

"Jack Glenn, 'March of Time' Film Director Dies"

"Jack Glenn, director of the popular 1940s newsreel series, 'March of Time' is dead at 76. . . Glenn met Louis De Rochemont, (Jew), the producer of the 'March of Time' newsreels and began an association that lasted until 1953.

"As senior director for the popular moviehouse newsreel, he often recreated world events with actors and movie sets. One such news feature film 'Inside Nazi Germany,' made in 1938 included footage of a 'concentration camp' that was filmed on Staten Island with scores of New York City actors.

"Rochemont had ordered Glenn to re-enact the widely reported Nazi camp atrocities."

Here we have yet another date of 1938 when holocaust exterminations were supposed to have already started. As for the "widely reported Nazi camp atrocities" - only organized Jewry were making such claims! This is hard proof that the horrors of the concentration camps were a Hollywood production emanating from the wild imagination of Jews.

When the war was over the Communists in Russia were only too happy to go along with the holocaust story to promote hatred of their worst enemy - the Germans! The public was told that the "March of Time" story, was an actual on the scene authentic newsreel.
