Sealed King Files A "Time Bomb"

Negro "Jet Magazine" editor Simeon Booker wrote the following on Feb. 10, 1986:

"The millions who celebrated the first federal holiday honoring Dr. Martin Luther King, Jr., ignored 'a time bomb' that threatens to ruin the reputation of the non-violence apostle. Lawmakers voted to place King's bust on Capitol Hill but have failed to pass a law ordering that FBI records collected on King via wiretaps be destroyed. The files are sealed for 50 years. What will be the reaction when Americans a half century from now are exposed to the FBI collected information?"

King Associated With 60 Communist Fronts

J. Edgar Hoover had the FBI plant Karl Prussion inside the U.S. Communist Party as a spy. On Sept. 28, 1963 Prussion signed a sworn affidavit detailing five party cell meetings he attended in California. He declared that:

"At all of these meetings one Rev. Martin Luther King was always set forth as the individual to whom Communists should rally around in the Communist struggle on many racial issues . . . King has either been a member of, or wittingly has accepted support from, over 60 Communist fronts, individuals and/or organizations, which give aid to or espouse Communist causes."

This statement by Karl Prussion was entered into the Congressional Record of the 89th Congress on March 30, 1965.

FBI "Operation SOLO" Wire Tapped King

FBI Director J. Edgar Hoover went to then Attorney General Bobby Kennedy with evidence to the effect that King was under the control of Communist agents, and "posed a danger to the

Bisexuals Spread AIDS

Interracial Couples Spread AIDS

AIDS began in Africa and then spread to Haiti and America. The infectious disease is pandemic in Africa and rapidly growing among the black community in America. Temporarily a majority of AIDS victims are homosexuals. American Negroes and Negroes from "Hispanic" countries are expected to soon surpass homosexuals and constitute a clear majority of AIDS victims. There are already more black AIDS victims in New York City than Whites.

The only way AIDS is entering the White heterosexual community is by sexual contact between Negro men and White women. The reason is that the vast majority of bisexuals and drug addicts are Negroes.

Studies have found that blacks can engage in homosexual activity in prison and upon release immediately return to heterosexual acts with females. This has been referred to as "switch-hitting" with blacks able to engage in sexual acts with males just as easily as they can with females.

Thus there are many more bisexual blacks than White bisexuals. Another important point is that bisexuals often insist that women submit to anal sex which is a chief way in which AIDS is spread. Also, black bisexuals usually are better educated with a higher income than other blacks. Thus they are in a better situation to seek White females to raise their social status.

Many black males feel having a White woman on their arm is a sign of "success." This has special appeal to black bisexuals. Thus White women who are so misguided as to succumb to the "dark forbidden fruit" of "kinky" interracial sex may well discover they are facing infection with the AIDS virus from a bisexual black!

Over 3,000 Women Have AIDS

The Washington Post, Nov. 3, 1986 reported that most bisexual men are Negroes.

The New York Times, of March 16 reported that 2% of all AIDS cases are women who contracted AIDS from bisexual men. (Most of whom are Negroes.)

U.S. News of April 20, states that the main way in which White heterosexuals are being infected with AIDS is from sexual contact with Negroes.

University of Maryland, Chancellor Dr. Edward N. Brandt states that bi-sexuals are the main way by which White heterosexuals are being infected with AIDS.

In Haiti 14% of all AIDS victims were women in 1982. But, by 1985 this figure increased to 36% and may equal that of the males today. Since intravenous drug use is rare in Haiti this means that bisexuality must be common.

National Review of July 3, 1987, page 19, states: "Despite the millions of words that have been written on AIDS the simple fact is that heterosexuals with AIDS have been infected by bisexuals!"

Bisexuals Infect White Women

Belgium's St. Pierre Hospital AIDS researcher, Dr. Nathan Clumeck startled the world with the story of a prominent black businessman who was a bisexual. In the corporation for which he was employed he frequently traveled back and forth to Africa. HE WAS A BISEXUAL!

In Africa he contracted AIDS. Back in Belgium he engaged in sexual encounters with 12 women - all but one were White. All the women were from the middle-class and met him at cocktail parties. None were promiscuous and none had anal sex with him it was all vaginal.

Unsuspecting White Women

The Negro was diagnosed as having AIDS in November of 1985 and died at age 40 in February, 1987. Of the women, 9 of the 12 have tested positive with the AIDS virus. Thus far one White male partner of one of these women has tested positive with the AIDS virus.

Thus it is easy to see how just one single black who seemed to be "a high class businessman" can spread AIDS to unsuspecting women. Just think, he infected eleven White women who believed in racial equality and thought there was nothing wrong with interracial sex! A vast educational drive must be undertaken in America to awaken White women

□ Miami prostitute Wendy Ann Blankenship, 19, learned two years ago that she has the AIDS virus. Nevertheless she continues to ply her trade. In an interview by phone, from prison, she told the *New York Post*: "You just can't tell everybody you go into a car with that you have it . . . I usually carry condoms, but most of my clients don't want to use them. . . . I don't feel bad—all the girls out there are doing the same thing." The sentence for prostitution in Miami is sixty days. There's no law on the books that defines attempted murder in such a way as to apply to Miss Blankenship's attempted murders.

Martin Luther King - Whoremonger

Morehouse College in Atlanta elders say King considered himself to be a "Don Juan." He and two friends would scout other schools for young girls they would ply with alcohol in order to sexually seduce them. King's little group was called "the wreckers." When asked what this meant he explained "we wreck girls. We wreck up all the women." He bragged that no girl who dated him would leave a virgin.

King always tried to date "very fair skinned" Negro girls. Later he would spend SCLC funds exclusively on White women. Thus F.B.I. Director, J. Edgar Hoover, would say, "King has the morals of an alley cat."

King Tapes Labeled "Obscene"

King's FBI files, which a federal court ordered sealed until the year 2027 are in many sections labeled, "obscene." These are the wire tapes of King's wild orgies with White prostitutes who were paid with SCLC money. The FBI initiated an investigation of King for violating The Mann Act. This is the taking of women or under aged girls across state lines for immoral purposes. This mainly refers to interstate prostitution.

There is one memo from President Lyndon Johnson halting this part of the investigation. Johnson said an indictment of King under The Mann Act, "would harm the civil rights movement."

Sex Acts Include Violence

Some of the taped incidents include, "a two day drunken sex orgy at the Willard Hotel in Washington." In this case King had taken on two women from the Philadelphia Navy Yard. Then there was the Los Angeles dentist's wife who was referred to as "King's Mistress." The dentist took a gun and went looking for King when the "civil rights crusader" fled town.

In another case an expensive Las Vegas prostitute complained that the "Rev." King's sexual appetite was so violent that she had to be rushed to a local hospital for medical repairs. One FBI report tells of a drunken King threatening to leap from a 13th floor hotel window if a White girl civil rights worker did not go to bed with him. King would force girls to drink strong "White Russians," (mixed drinks), in order to seduce them. He would give his men SCLC funds to go out and hire "White only" prostitutes if no White "civil rights" workers were available.

King Almost Indicted

King's sexual appetite included acts of perversion and he told friends that this was a "form of anxiety reduction." Prof. David J. Garrow, wrote the biography of King's life, "Bearing The Cross". He says FBI assistant director in charge of domestic intelligence, William C. Sullivan, reported that there were four solid grounds for the indictment of King. Garrow quotes Sullivan as saying, "they are embezzlement, (of SCLC funds), employing prostitutes, alienating wives affections from their husbands and violation of the Mann Act."

Thus King was a clerical fraud and a Marxist who sought to bring revolution to the streets of America. We demand that the King Holiday be repealed. Let us all work together, hand in hand, to protest against the King holiday. We must bring the truth about this fraudulent civil rights leader's background before the public.

AIDS strikes Black Neighborhood

The demographic patterns of AIDS in New York City are changing, public health officials and doctors say, putting the minority poor at a disproportionate risk and causing entire families to fall like dominoes.

Even more dramatic is the increasing incidence of AIDS among black and Hispanic people. Of the 9,188 AIDS cases so far reported in New York City, 54 percent involve black and Hispanic victims. Among the 932 women with AIDS, four of five are black or Hispanic and among the 178 children, 9 out of 10 are.

"AIDS is not evenly distributed and certain communities are more at risk than others," said Dr. Gerald Friedland, a specialist in infectious diseases at Montefiore Medical Center in the Bronx.

These shifting numbers have faces and tangled, tragic histories. In places like Harlem Hospital, among the 50 adult and 10 pediatric AIDS patients on any given day, there are women, unaware they were at risk but infected by drug-abusing husbands. There are babies, born to addicted mothers, diagnosed, then abandoned to die. There are ruined young men, unemployed, homeless and scarred with the tracks of hundreds of dirty needles.

Sometimes a whole family will die, one member after another, in a chilling reminder that AIDS can be spread through heterosexual sex and can be transmitted to the unborn.

In neighborhoods torn by poverty and drug abuse, the victims of AIDS seem mute, disorganized, friendless. Here, there are few grass-roots social service organizations, like the ones formed early in the epidemic by homosexual men, who are predominantly white, middle-class and educated.

"Who speaks for the drug abuser in our society?" asked David J. Sencer, the former City Health Commissioner who is now a member of a Boston-based consulting firm. "Who's in favor of them?"

Officials describe a fragile social and economic ecology in these neighborhoods that makes AIDS particularly dangerous. They cite poor nutrition and health care, homelessness, low literacy and widespread sexual activity in a culture that shuns the condom.

"The structure is so rotted out already," said Ernest Drucker, the director of community health at Montefiore. "To superimpose this is almost unimaginable."

These experts also say that ignorance and denial are widespread in the inner city.

King Investigated

WASHINGTON (AP) — A New York attorney has been named as the man whose association with the late Martin Luther King Jr. led the FBI to place the civil rights leader under surveillance in 1963. The Washington Post said in its Monday editions that the attorney was Stanley Levison, a long-time friend of King.

Then-FBI director J. Edgar Hoover made wiretap requests of former Atty. Gen. Robert F. Kennedy on Oct. 7 and 18, 1963, saying that surveillance of King was necessary because of possible Communist influence.

The Post reported that "a former high-ranking Justice Department official" had confirmed that Levison, who had known and aided King since the days of the Birmingham bus boycott, was the person whom Hoover suspected.

AIDS from Interracial Sex

Official Report on Dr. Clumeck's Investigation

A still unraveling case shows starkly how one person, though heterosexual, can scatter the AIDS virus. A black Belgian businessman is being investigated by Dr. Nathan Clumeck, a specialist in infectious diseases. The man, by all accounts exclusively heterosexual, made regular business trips to Africa. He had at least 12 sexual partners there and in Belgium, all but one of them white, middle-class women who had met him at parties. None was promiscuous, none used drugs, and all had only vaginal intercourse with the man. The source of his AIDS is unknown. Nine of the 12 women have developed AIDS or AIDS-related complex (ARC), a precursor to the disease. One of the known sex partners of these women has ARC, and three more of their partners have tested negative. Three of the 12 women have tested negative. The man, diagnosed as having AIDS in November of 1985, died at 40 last February.

nation."

Therefore, on Oct. 10, 1963 Bobby Kennedy signed a secret order authorizing the FBI to wiretap King's SCLC office and later 10 motels and hotels.

The FBI had "Operation SOLO" in effect at this time covering the every move of a Jew named Stanley D. Levison. He was a New York lawyer and was the middle-man for the \$1 million annual cash subsidy by which Soviet intelligence finances the U.S. Communist Party. The FBI discovered that a Jew named Isidore G. Needleman, working for the Soviet AMTORG trade mission, was also a secret KGB agent. He passed the money on to Levison who in turn gave it to the Jew William Weiner, treasurer of the U.S. Communist Party at the time.

Soviet Agent Guided King

Levison's job was to direct King in stirring up racial discord and agitation against the Vietnam War. Levison sought to demoralize the "Home Front" so that we would lose the war. The sealed tapes quote King as telling Levison, "Comrad Levison I am a Marxist." Levison instructed King to appoint Negro Hunter Pitts "Jack" O'Dell as his executive assistant who used the alias "Cornelius James." O'Dell was formerly a member of the National Committee of the Communist Party.

Atlanta Mayor Andrew Young has said, "Sam Levison was one of the closest friends Martin Luther King ever had." He credited Levison with making the major decisions for King's SCLC organization. It was Levison who wrote King's major speech against the Vietnam War given on April 4, 1967 at the Riverside Church in New York City. King called the U.S. Army, "the greatest purveyor of violence in the world today." King said that South Vietnam's anti-communist leader Diem is, "one of the most vicious modern dictators." Of our soldiers, King said: "they may have killed a million Vietnamese - mostly children."

Not only did Levison keep the money from Communist sources pouring into King but he continued to direct King's activities. In fact, it was none other than Levison who wrote King's so-called, "I Have A Dream" speech, which our children are now forced to study in school. This was given on Aug. 28, 1963 at King's last mass civil rights demonstration in Washington, D.C. on the steps of the Lincoln Memorial.

It should be noted that not only was Levison once a member of the U.S. Communist Party's Executive Committee but he was also a former vice-president of the N.Y. Council of the American Jewish Congress. (This is the U.S. affiliate of The World Jewish Congress.) It is of interest to note that Levison remained under FBI surveillance long after King's death.

What Famous People Said About King

J. Edgar Hoover called King, "the most notorious liar in America." He also said: "King is a 'tom cat' with obsessive degenerate sexual urges."

Sen. Robert Byrd of West Virginia issued a statement immediately after King had provoked riots in Memphis, Tenn. during the garbage collectors strike. Byrd stated: "The predictable rioting which erupted in Tennessee saw King flee the scene. He took to his heels and disappeared, leaving it to others to cope with the destructive forces he had helped to unleash."

President John F. Kennedy once told King to his face in referring to Stanley Levison and his associates: "They're Communists. You've got to get rid of them." (King refused to take Kennedy's advice.)

President Lyndon Johnson, after listening to some of the FBI's tape recordings of King's activities in motels with prostitutes, said: "G_d damn it, if only you could hear what that hypocritical preacher does sexually!"

Honoring King Is Honoring A Fraud

Everything about King is untrue. "Martin Luther" is not even his real name! He was born Michael King, Jr. on Jan. 15, 1929. Six years later his father, Michael, "Daddy", King announced to his congregation that hence forth they would both be known as Martin Luther after the great Protestant Reformer. "Daddy" King never bothered to go into court to legally have his name changed. Thus, this should be called the "Michael King Holiday!"

King is not a "Christian Minister" as one might normally expect. King never, ever, told his congregation that he accepted Jesus Christ as his personal Savior. In fact he tried never to mention the name of Christ in his sermons.

These agencies believe the Communists hope to turn the "New Politics" movement into a political front as a successor to the defunct Progressive Labor Party.

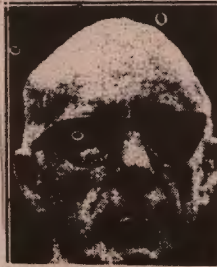

Security agencies here say that the Communist Party has launched a nationwide campaign to send undercover delegates to the conference to grab control.

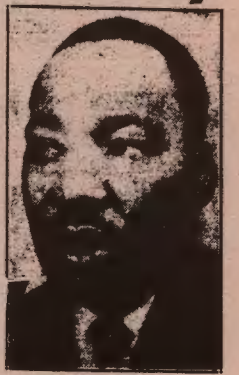

The Bisexual Threat To Heterosexual Community

How Many People Have Aids?

The Center for Disease Control in Atlanta reports there are 45,000 active AIDS cases in America. Dr. Jonathan Mann, a director of the U.N. World Health Organization, states that for every active case of AIDS there are up to 100 people who are carriers of the AIDS virus. This would translate into 4.5 million infected AIDS victims in America right now! U.S. Surgeon General, Everett Koop, says that up to 100 million people world wide could die of AIDS by the year 2,000 - (just 12 years from now!) Koop has just recently declared there could be from 1.5 million to 4 million people infected with AIDS in the U.S. right now. He added that only wide scale testing for AIDS could give a more exact figure. (National testing for AIDS is advocated by the Thunderbolt)

Who Will Get AIDS?

AIDS is primarily a disease of the Negro race, followed by homosexuals and drug addicts - in that order. There has been a coverup on the racial aspects of the AIDS epidemic because our "liberal" officials do not want a backlash against blacks. This could neutralize the civil rights movement and pave the way for re-segregation in America.

Current statistics show that about 28% of all AIDS victims are Negroes and 12% are Hispanics. **HERE IS WHERE THE DECEPTION LIES!**

About 50% of all Cubans are White and 20% of Puerto Ricans are White. **THEY ARE NOT COMING DOWN WITH AIDS!** Negroes from Cuba and Negroes from Puerto Rico, are the so-called "Hispanics" who are infected with AIDS!

The truth is that a majority of all AIDS victims in New York City are Negroes, 55%. The same is true in Detroit and Chicago. Most of the unreported AIDS cases in America are also blacks. Thus their true percentage may be around half of all AIDS victims. Remember that AIDS came to America by way of Haiti, and Africa. It is an **AFRICAN PLAGUE** which homosexuals can contract!

Time Magazine of Feb. 16, 1987, reported that of the 90,000 homosexuals living in San Francisco up to 70% already are carriers of the AIDS virus.

New York City is the center of the AIDS disease in America with 25% or one-fourth of all cases. There are 12,000 active AIDS cases in New York. This is just the tip of the iceberg! The **New York Post** of Nov. 7 quotes N.Y. City Council AIDS chairman, Joseph Lisa, as revealing that there are some 750,000 carriers of the AIDS virus in the metro-New York City area. What this means is that one out of every four men now walking the streets of the city are already infected with AIDS.

Some 30% will come down with the disease within 5 years, another 30 percent within 10 years and the balance within 15 years. Negro Rev. Earl Jackson of Boston's Cornerstone Baptist Church said: "She is sending the wrong signal about morality and unwed motherhood to young blacks, who already are responsible for a

Chief Fitzpatrick admitted her statement, "was not overtly racist" but did have "racial overtones!" (Or, so the Chief thinks!) Fitzpatrick even had his "internal security police" study the tape to determine if her tone of voice might show any contempt for blacks.

Rockford, Ill., should immediately rehire Ms. Suhr and apologize. The next step should be the firing of Chief Fitzpatrick for his callous misuse of his authority in seeking to ingratiate himself with local blacks.

Atty. Peter Nolte filed a suit in an effort to have Ms. Suhr reinstated to her job. He said he cannot find even "subtle racism" in her tone of voice which the chief claims is "obvious." The American Federation of Municipal Employees, Local No. 1058 is also appealing Ms. Suhr's firing. Local President, Gary M. Cook said: "We are ready to appeal this case to have Ms. Suhr reinstated with all back pay!"

It is very clear that Rockford, Ill., urgently needs a new Chief of Police who is not so prejudiced against members of his own race!

Meese Surrendered To Rioters Stop Immigration

U.S. Prisons suffered millions of dollars in damage caused by hardened criminals from Cuba. Atty. Gen. Ed Meese announced that the U.S. would accept 27,000 immigrants per year from Cuba if Castro would take back 2,500 criminals. Meese took no steps to "lock down" these violent people in their cells! 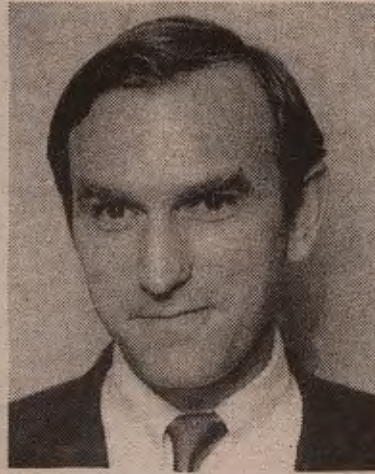
Who Are These Castro Criminals?

All Blacks In Africa Threatened With Aids

Negroes In Africa and America Face Depopulation from AIDS

CBS "60 Minutes" TV show of Nov. 7 in a report direct from Uganda, Africa stated that this was the country in which it is believed the AIDS plague first began. Then CBS reported that some 28% of the entire black population of Uganda are carriers of the AIDS virus. With no cure in sight how can any segment of that population survive?

Lusaka, the capital of Zambia, has 33% of its young men between the ages 15 and 40 infected with the AIDS virus and nearly 50% of the military!

What this means is that the AIDS epidemic is going to DEPOPULATE both Africa, and yes, America of black people!

The Washington Times of May 28th declared: "The AIDS epidemic threatens to depopulate much of Africa. . . It is feared that within 10 years the plague could depopulate East and Central Africa."

Hopkins University, Epidemiologist Dr. Frank Polk states: "Some African countries will lose 25% or more of their population. The loss in terms of their economy and social structure could well equal the Black Death Plague's ruination of medieval Europe!"

World Health Organization director Dr. Jonathan Mann in Geneva stated: "With 10% to 30% of the people of Central Africa having AIDS means one million active cases will soon appear. This has very grave implications because it will destabilize the political system when 20% to 40% of all young adults have AIDS. There will simply be no work force left to keep the economy going."

The London Daily Telegraph of Oct. 6, "AIDS will have crippling effects on the already unsteady economics of African States. Modernization programs will be jeopardized, with a return to subsistence farming in rural areas and hunger in the towns."

What this means is that the population of Africa will drastically decline and there will not be enough able bodied people left to sustain the economy.

Blacks In U.S. Also Face Depopulation

Important reports on AIDS have been released and then suppressed because they show a decline in the black population in America due to the AIDS plague.

Howard University, Dr. Wayne Greaves says: "Because of the high prevalence of infection among women and young children, I see AIDS limiting the black population. Unless we can interrupt transmission somehow, we may be looking at zero population growth for blacks." (quoted from "Village Voice," March 10th.)

ABC-TV, April 16, 1987, on the evening news, amazingly broadcast a prediction that, due to AIDS, there would be zero population growth for blacks by 1991.

The New York Times of March 16 by Jane Gross, reported that: "If we don't recognize that certain populations are more at risk than others, we will not provide resources to the right communities and will use the wrong cultural idiom...whole communities are dying...A mortician in East Harlem, for example said that he rarely buries anyone older than 40. His cases used to be divided between overdoses and gunshot wounds. Now they are mostly AIDS victims!"

What this means is that the black race faces self-destruction because they can't stop promiscuity, drug use, and both homosexual and bisexual activity. This has become a way of life in the ghetto.

AN ESTIMATED 1.5 million Americans have come into contact with the AIDS virus but remain free of symptoms. British researchers have just learned that vulnerability to the lethal virus depends at least in part on genes. A team led by Anthony Pinching of St. Mary's Hospital Medical School in London looked at six combinations of an inherited protein found on some

human and animal cell surfaces. The researchers concluded that one of the protein combinations makes the people who carry it highly resistant to AIDS, while another makes them highly vulnerable.

The work may shed light on why the disease is spreading so rapidly among heterosexuals in Central Africa. Blacks from that region are nearly ten times likelier than Caucasians to carry the "most susceptible" protein.

Will All AIDS Carriers Get The Full Disease?

New York Times medical writer, Dr. L.K. Altman on Sept. 9 wrote, "many experts have begun to voice fear that in time, perhaps two decades or more, virtually every AIDS carrier will develop the full disease. The available data is frightening. Among those who are infected with the AIDS virus more each year show signs to the immune system with the characteristic AIDS symptoms of fevers, weight loss, thrush, diarrhea and swollen lymph nodes throughout their bodies."

"More each year progress to full scale AIDS. No one, once diagnosed with AIDS, has ever been cured. Once infected 20% to 30% will develop AIDS within six years and 35% after 7 years. If these numbers continue their relentless climb, virtually all the men in the study will eventually develop AIDS."

Aids wiping out Af

SUNDAY'S public statement by President Kaunda of Zambia, that his son, Masuzyo, who died aged 32 last December, had contracted Aids, was a brave move.

Unlike in America, where film stars, politicians and famous designers have all been seen to die of Aids, not one newsworthy death had previously been attributed to the disease in Africa.

But while Dr Kaunda's honesty may be unusual among the élite in this continent, his reason for weeping is not.

Aids in Africa is hitting the urban middle class—the teachers, administrators, doctors, engineers, traders, mechanics and military officers whose skills are so vital for the future of African countries.

In the cities of Central and East Africa, studies suggest that between 10 and 20 per cent of people aged 15 to 40 have been exposed to the Aids virus. Many doctors believe that in Africa, half of those who test positive for the virus will be dead in five years and most within a decade.

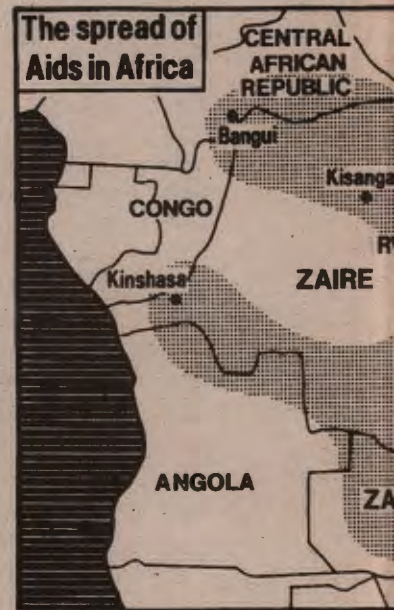
Business elite and officers infected

"A disease selectively causing ill-health and death in the most productive age group and in the best educated will have...horrifying demographic, social and economic consequences," says a report, "Aids in Africa," published earlier this year in Aids-Forschung, an international medical bulletin.

In Zambia, Aids-watchers privately admit that more than a few of the business and political élite have already died of the disease. It is believed that more than half of the Zambian army is already infected with the virus—and there is evidence that the percentage of those infected increases with rank.

At the main hospital in Lusaka, Zambia's capital, more than a third of the young men who were tested last year were infected with the virus—and only the better off and better educated ever go to an urban hospital.

In Kitwe, in the industrial



copper belt, 44.4 per cent of female patients at the hospital tested positive for the Aids virus, while well over 10 per cent of "healthy" people, such as blood donors and pregnant mothers, were also infected. Official figures show that more than two-thirds of these people are skilled professionals.

Similar statistics are repeated in cities in an arc sweeping north from Zambia through Tanzania, Burundi, Rwanda, Uganda, Zaire and the Central African Republic.

At a maternity clinic in Kampala, 13 per cent of pregnant mothers tested were found to

have the virus in 1986. By the beginning of this year, the percentage was almost a quarter.

Studies show that in the rural areas and in the poorer shanty towns of the cities, Aids has not taken such a strong hold. Even in Rakai district, in south-west Uganda, the only rural area to produce figures similar to the cities, it is the community leaders and traders who have fallen ill and died.

Many of the traders in Kyotera, once a thriving market town, in the middle of Rakai, have died or left. The mayor lost three brothers to Aids.

AIDS News Flashes

Explosion In AIDS Cases Coming

The Center For Disease Control reports that the fewest number of AIDS cases expected by 1991 is 270,000. The highest estimated figure is 324,000. Thus if carriers of the AIDS virus are 100 times the number of active cases we will have 27 million carriers on the low estimate and 32 million on the high side by 1991!

Four Times More Black Soldi

WASHINGTON — Mandatory blood tests of U.S. military recruits show blacks test positive for exposure to the AIDS virus at a rate four times as high as whites, public health experts say.

The experts, speaking Friday at a national conference on acquired immune deficiency syndrome, said Pentagon figures showed AIDS had joined a list of other diseases, including cancer, tuberculosis and

hypertension. The military blood tests began in October.

Among the rate of exposure, 1,000 recruits tested, the rate was 3.9

Experts in Uganda are urging that major efforts must be made to educate children about the disease, but prevention is an almost impossible task. Where a quarter of sexually-active adults are infectious the chances of a marriage without Aids are small.

Experts in Uganda, the first country in East and Central Africa to face up to the problem, urge that major efforts must be made to teach children about the disease. But even well-educated Ugandans seldom use condoms, and promiscuity is rife.

When Aids first appeared in Africa, some aid workers guiltily whispered about it counterbalancing billowing over-population. But it is not the myriad children in the rural areas who have caught the disease, nor the unemployed youths in the shanty towns.

It is the young men and women who should be bearing the hope of Africa. That they are the targets, says Aids-Forschung, "will have crippling effects on the already unsteady economies of African States. Modernisation programmes will be jeopardised, with a return to subsistence farming in rural areas and hunger in the towns."

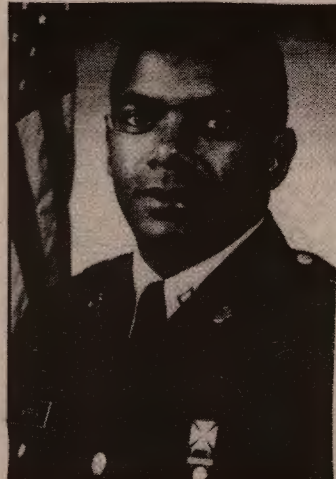

Bisexual Blacks Infect White Girls with AIDS

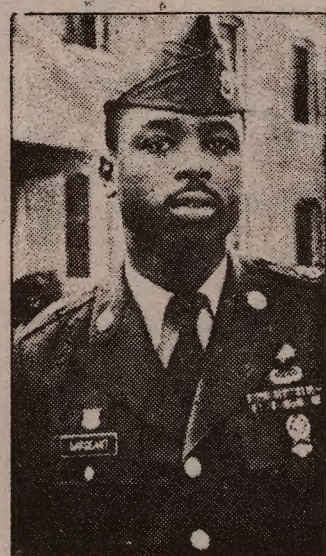
Fort Huachuca, Arizona is where U.S. Army Pfc. Adrian Morris, Jr., was stationed. He is a bisexual who had been informed by doctors that he was a carrier of the AIDS virus. Despite this knowledge Morris recklessly continued to carry on bisexual activities. For this reason Morris was brought before a court-martial on Army charges of aggravated assault and for conduct bringing discredit on the service.

While in the U.S. Army in April, 1986 Morris took an AIDS test. In July, 1986 he was notified that he tested positive as a carrier of the AIDS virus. After that date Morris continued to have sex with his White girlfriend, Specialist 4 Patricia C. Pruitt. She became pregnant. He also engaged in sex with another female soldier on the base. On top of that he committed sodomy with a male soldier and had anal sex with him.

His case is now on appeal as Judge Raymond Dean Cole ruled that his AIDS test results cannot be used in court as they would violate Morris "right to privacy." (The Thunderbolt position is that AIDS test results should be made public in such cases. New laws should be adopted NOW to make this legally permissible).

South Koreans Fear AIDS From Black G.I.'s

South Korea's government has revealed that a growing number of that country's 400,000 prostitutes have contracted AIDS from U.S. Negro soldiers. They are waging an educational campaign encouraging these women not to consort with blacks.

G.I. with AIDS convicted for not warning partners

Army Sgt. Richard Sargeant, 28, leaves court in Fort Sam Houston, Texas, after being sentenced for not warning seven female soldiers, including two officers, he had AIDS before having sex with them. On Wednesday, Sargeant was given five months in prison, stripped of his rank and dishonorably discharged. In Fort Sill, Okla., Sgt. Vincent Stewart, 29, faces court-martial on similar charges involving a female sergeant. A third such case is pending in Arizona.

More Black Soldiers In AIDS Cases

Fort Sam Houston, Texas, U.S. Army Sgt. Richard Sargeant, a black bisexual, has been convicted of having sex with seven female soldiers. Some are black but most are White. Sargeant carried on this activity after being informed by doctors that he was a carrier of the deadly AIDS virus. On Dec. 3, 1987 he was convicted in a military court, given 5 months in prison, stripped of his rank, and dishonorably discharged.

Fort Sill, Okla. another black bisexual has also been charged with having sex with a female sergeant with the full knowledge that he is infected with the AIDS virus. He is now awaiting court-martial. At this time there are similar AIDS investigations being conducted at other U.S. army bases. This is evidence of the wretched depths of sexual perversion which exist on U.S. Military bases. How would such "troops" stand up in a war with Russia?

Negroes Have A Genetic Weakness For AIDS

In Africa perhaps 20 million people already are carriers of the AIDS virus. There Negro women have contracted AIDS in equal numbers with males. Most have caught the disease through heterosexual activity. In America, only women who have engaged in sex with bi-sexual men, drug addicts, or who are drug addicts themselves have AIDS.

Scientists are just now beginning to understand this phenomena. U.S. News of Aug. 17, 1987 states: "British researchers have found what they say is a genetic vulnerability to the AIDS virus among black Africans."

"The Los Angeles Times" of July 16, 1987 reports of youths examined for military service 0.9% of the Whites were carriers of the AIDS virus as compared with 3.9% of the blacks. Thus among young people four times more Negroes are infected with AIDS than Whites! Of adults, on a percentage of the entire population, Negroes are three times more likely to be carriers of the AIDS virus than are Whites.

"Village Voice" of March 10, 1987, which is a pro-homosexual publication out of Greenwich Village, N.Y., quotes the CDC of finding: "A black woman is 13 times more likely than a White woman to contract AIDS and a Hispanic woman is 11 times more at risk." The more important point is that these people make up less than 20% of the U.S. population and this alone make such figures even more shocking.

"Readers Digest" of Sept. 1987 reports that Negroes carry an inherited genetic weakness which makes them more vulnerable to AIDS than members of the White Race. The report stated: "British researchers have just learned that vulnerability to the lethal (AIDS) virus depends at least in part on genes. . . The researchers concluded that one of the (inherited) protein combinations makes the people who carry it highly resistant to AIDS, while another makes them highly vulnerable."

Thus it is clear that Negro heterosexuals are much more susceptible to AIDS than are White people. The only Whites who may contract AIDS are homosexuals, bi-sexuals, drug addicts or White women who engage in sexual activity with any of the above - OR THOSE WHO ENGAGE IN INTERRACIAL SEX!

It is very difficult for a White male to contract AIDS from a female. Also, it is very easy for a White female to contract AIDS from either a White or black bi-sexual. Therefore refraining from interracial sex should be at the top of the government's "Safe Sex" educational program.

It is vital that we take every step within our means to spread the truth about real "safe sex" practices. Our youth must avoid at all costs interracial socializing. Those who are lulled into believing that friendly social contacts with Negroes is harmless should study the cases reported on this page. None of these innocent women ever thought for a single moment that they were engaging in sex with a bisexual - BUT THEY WERE!

Interracial couples today are the chief source of AIDS infection which has penetrated the White heterosexual community. By closing this window of vulnerability we can make the White heterosexual community one which is almost an impenetrable AIDS-Free Zone! If this can be accomplished we could announce that White hetero-

sexuals are immune to the AIDS disease! Sound the alarm to America's youth today - AVOID SOCIALIZING WITH BLACKS AT ALL COSTS!

Millions May Die From AIDS

Oct. 24 (EIRNS)—Twenty-five million Americans, or 10% of our population, will be dead of the AIDS virus by the year 2007—less than 17 years from now—and another 43 million will be carriers doomed to die, if the U.S. fails to adopt a sound public health program, including mass AIDS testing.

Those are the terrible conclusions of a new computer study conducted by Dr. Allan Salzberg, chief of medical services at the Veterans Administration in Miles City, Mont. The study was presented on the floor of the House of Representatives Oct. 15 by Rep. Dan Burton (R-Ind.), and bears out the warnings

Huge Gains For South African Patriots

Great "Conservative Party" Victory In South Africa

The National Party of President P. W. Botha has been moving away from its previous Apartheid, (Segregation), stand. Botha's plans for "power sharing" with the blacks led White Patriots to organize a new political party. For this reason Dr. Andries Treurnicht, age 66, resigned his National Party seat in Parliament five years ago and helped found the Conservative Party.

In a surprising upset the Conservative Party won 22 seats in Parliament. They replaced the left-wing Progressive Party as the second largest party. Thus for the first time a political party on the right - instead of one on the left - is the official party of the opposition which gives them much more influence in government.

29% For Right-Wing

The Conservative Party, along with the HNP party, won 607,220 votes, or 29% of all votes cast. They gained 40% of the Dutch "Afrikaner" vote. The National Party's

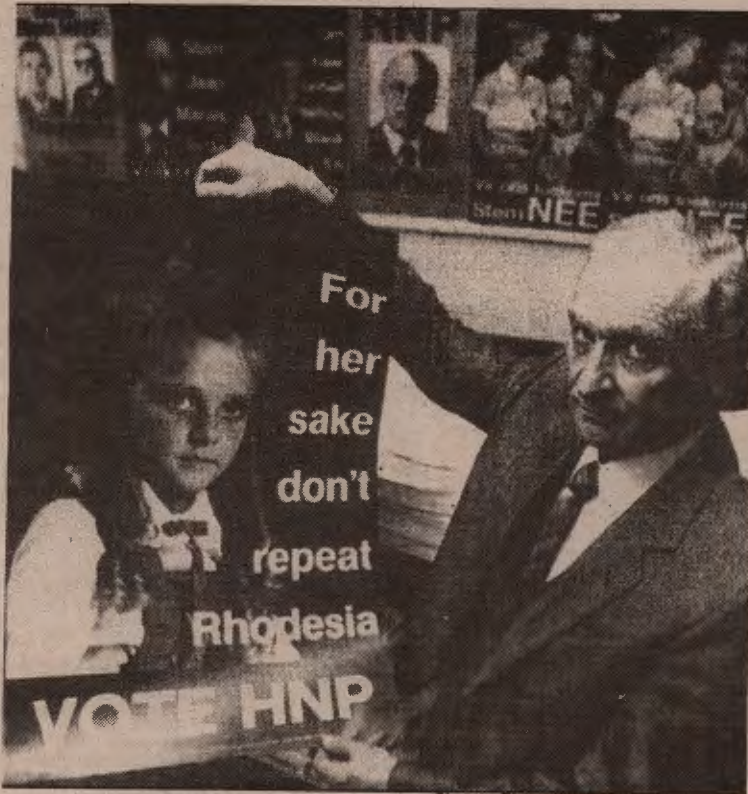
"Afrikaner" vote fell from 80% to an all-time low of 50%.

Black leader Desmond Tutu called the Right-Wing gains as "plunging South Africa into the darkest age in its history. Now we have a right-wing government that has been confirmed in its right-wing views, with a party of extreme right-wing opposition!"

Just Begun To Fight

Dr. Treurnicht said the struggle in South Africa was between conservative and leftist liberals, "who want to negotiate the rights of White people until their future is surely doomed to national suicide. We will not allow ourselves to be treated as a minority group right here in our own homeland. We want a return to old-style Apartheid and stricter security. The current government is contemplating the surrender of White political power with its 'reform' recipe of power-sharing."

The Right-Wing in South Africa may gain full power within just a few short years at the present rapid growth rate.

World-Wide Right-Wing Resurgence

The Daily Press has suppressed the news of the great gains made by anti-Communist political parties throughout the free world. Adami is described as a "tough minded lawyer", an organizer and planner. He built a well-oiled vote producing machine. They won by hauling sick people out of the hospital to vote, calling back overseas immigrants, and busing cloister nuns to the polling stations.

Resurgence In West Germany

Germany's Right-Wing Patriotic, "German Peoples Union Party" elected its first member to Parliament in the state of Bremen. He is Hans Alterman who gained 8.5% of

the popular vote. The new party is headed by the well-known anti-Communist publisher Gerhard Frey. He is editor of the weekly National Zeitung newspaper based in Munich. This great victory has been attacked by U.S. Jews.

Right-Wing Party Gains Parliament Seat In Germany, In Surprise Vote

BONN (JTA) — A candidate of a neo-Nazi party won a seat in the Parliament of the federal state of Bremen in northern Germany, to the surprise and consternation of liberals and conservatives alike. Hans Alterman, a right-wing extremist, represented the Deutsche Volksunion (DVU), a party headed by neo-Nazi Gerhard Frey. Frey publishes the Munich-based weekly *National Zeitung* which claims to have "scientific" proof that the Holocaust was a fiction and the gas chambers "Zionist propaganda."

The neo-Nazis drew a striking 8.5 percent of the popular vote in Bremerhaven, Bremen's deep-water seaport at the mouth of the Weser.

Franz-Josef Strauss, the conservative Bavarian leader, said in Munich that the liberal policies of Chancellor Helmut Kohl's Christian Democratic Union (CDU) allowed rightwing extremists to score gains with conservative voters.

South Africa's Right-Wing Parties Chief Platform Points

Conservative Party: The CP is not prepared under any circumstances to negotiate the future of the Whites with any other nation, of whatever colour. The CP's policy of partition eliminates parts of the question as the policy leads to a system where each nation governs itself and eradicates any problems of how to negotiate with Blacks, how much to give, so-called "minority guarantees" and cultural retention. It is the only policy which eliminates the possibility of political domination by one nation over another.



Herstigte Nasionale Party: The political aspirations of Blacks should be confined to their own peoples, which should develop their own political institutions in the territories they historically settled. Parliamentary democracy has a limited tolerance for racial and religious dissension. Nowhere and never has there been a successful system of power-sharing between different races and religions. India started off as a single country. Yet within two generations it has disintegrated and in its former territory there are now three independent states. In Zimbabwe the limited representation of Whites is threatened with abolition by the Black majority and even the Black Matabele minority enjoys a precarious state of physical security. The lesson of Africa is clear. Blacks do not want to share power with Whites; they want all the power. Once the HNP takes over the reins of power we shall negotiate with representative Blacks on the basis of separate development.



Conservative Party: Reform is South Africa's Lorelei — it sounds so sweet and is yet so dangerous. The word "reform" is a misnomer — it is a public relations gimmick to cloak the real intentions of a weak government and that is to surrender South Africa piece by piece. Rhodesia reformed and was forced to surrender by her so-called friends. The surrender must be stopped in its tracks. The Conservative Party has no objection to change as long as it is not merely for the sake of change and as long as that change improves the position of all the people in South Africa. So far, reform has been a complete disaster. Confirmation of this can be found by asking anyone in South Africa, Black or White, whether under today's reform South Africa has given them more security, a better life style and freedom from fear. Let the answers measure the efficacy of reform.

Liberals Want Whites To Live Under Tribal Savagery

Horrific Slaughter of Innocents In Rhodesia

Darkest Africa burst onto the headlines showing the world the true depth of the savagery which awaits White people unfortunate enough to fall under "Black Power" rule. The details of the viciousness of the killings is almost too much for a civilized person to comprehend. The victims included 10 adults and 6 children. They were all beheaded! It was no swift death either because the Negroes used crude machetes and hacked away at their necks until the head was finally severed in a sea of blood. The killers did their evil deed upon the victims one at a time. They began chopping off the heads of the youngest children first forcing their parents to watch in horror until their turn came.

The Christian Missionaries Listed

The Christian missionaries were rounded up by the terrorists on two adjoining farms. At the Olive Tree Farm those herded into a house included Rev. Jerry Keightley, 40, his wife Marian Keightley, 39 and their daughters, Gay Deborah, 16, and Glynis, 14, and their 18-month-old son, Barnabas. Murdered with them were Rev. David Emerson, 35, and Miss Penelope Lovett, 28 - they were engaged to be married this Christmas!

At the New Adam Farm those similarly slaughtered were Rev. David Marais, 35, his wife Katherine Marais, 34, and their son Ethan, 4. Also killed were Rev. Robert Hill, 38, his wife, Gaynor, 27 and their 6-week-old son, Benjamin, also, murdered were Hazel Russell, 46, and Jean Campbell from England as well as Karen Iversdahl, 32, from Choteau, Montana, a veterinarian.

The terrified innocents had their arms and legs tied with barbed wire before they were hacked to death. Then the two houses were set afire. One girl, 13, was allowed to run off with a note from the beastial murderers. It declared the slaying to be a warning to all White people to get out of Zimbabwe, (Rhodesia), or die because the killers want a "Marxist nation devoid of all Western, capitalist-oriented people."

Black Marxists Blame South Africa

The Communist African National Congress, (ANC), which is supported by many American liberals, charged that South Africa is responsible for the killings. They said Apartheid, (Segregation), "Infuriates poor blacks" and makes them do such things! 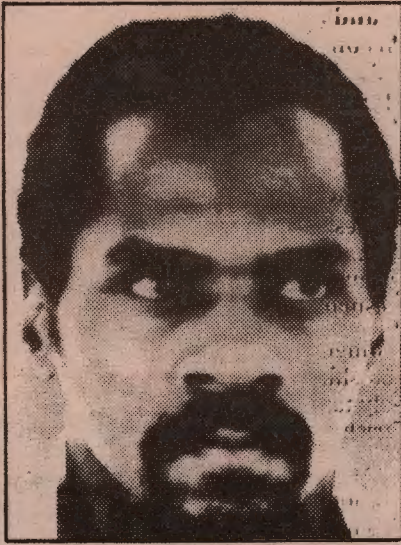
Negro Crime Rampage Is "Terrorism In U.S.A."

Killer of Elderly Women Caught

San Francisco was relieved when police finally arrested the elusive killer Franklin Lynch, age 32. He brutally murdered at least a dozen elderly White women and beat and robbed 26 others. Lynch would watch the homes of elderly White women. He usually chose small houses on corner lots. When they would leave for the store he would break in and wait for their return. Lynch would then seize and tie them up, throw a blanket over their head and beat them to death.

Next he would ransack the house for cash and anything of value he could sell.

The body of Marie Lovardi, 82, was discovered tied up in a

closet by her great-grandson. A week before that Agnes George, 74, was found in her Richmond home beaten to death. In San Leandro the body of Marie Figuerido, 88,

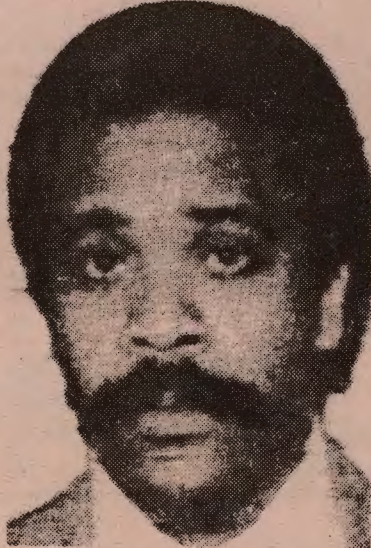
was found with her hands tied behind her back and a sheet over her head. She had also been beaten to death. Her grandson, Garry Figuerido, said: "Imagine the torment on these poor women's faces as Lynch fiendishly beat them during their last moments of life! I feel the death penalty is too lenient for this guy!"

Vickie Constantin's 73 year old mother, Anna, was beaten in her home by Lynch. He hit her with his fists, a clothes iron and a gallon bucket of paint. She died six weeks later in the Castro Valley Hospital.

Vickie Constantin, 35, said: "I wish I could kill him myself. He's a devil. He's not an animal - animals don't do this to one another. People like him should not be allowed to live. I hope they go for the death penalty."

Kills 43 People In Suicide Air Crash

US Air had transferred David A. Burke, 35, from Rochester, N.Y. to Long Beach, Calif., to get him away from "bad influences". In New York his name came up in three drug investigations with Jamaican criminals. As far back as 1984 he had been charged with stealing \$45 in goods from a local store.



David Burk's hatred for one White man led to murder of 41 innocents.

At the US Air office in Los Angeles, a hidden camera caught Burke in the act of stealing \$69 in cash from flight cocktail sales. He was dismissed from his job by Ray F. Thomson, 48. Somehow Burke discovered what flight Thomson was going to be on. He bought a one-way ticket, left a suicide note and smuggled a gun aboard the flight. He apparently shot the pilot to cause the crash killing of 41 innocent people who knew nothing about his problems!

Back in Rochester, N.Y. members of Burke's family charged that "White racism" was behind all this. His brother, Allan, said David was fired due to "racial discrimination against blacks. This was racial genocide."

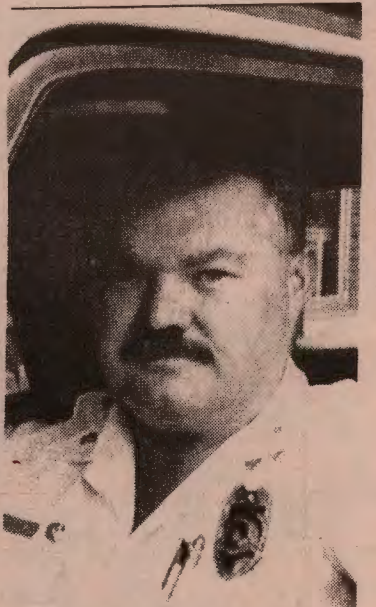
Got Away With Murder

Murders Four and Walks Away Free

Chicago Judge Thomas J. Maloney blasted the Illinois Appellate Court for throwing out "an avalanche of evidence" when they reversed his conviction of James Early, 23. Early was free on \$1,500 bond from a rape charge when he murdered Kristian Parker, 33 and her three children by strangulation. He was sentenced to life in prison but soon will walk out a free man. His lawyer, Randy Mehrberg, (Jew), said: "I am really delighted. This will teach the police they have no right to beat confessions out of innocent people just because they are black."

Fingerprints Catch Rapist

Homestead, Pa., police chief, Chris Kelly, was seeking the black rapist of six elderly White women, ages 64 to 85. All lived alone and were attacked

between Aug. 10, 1983 and Aug. 25, 1987. Chief Kelly started a program which enraged civil rights groups and the ACLU. He asked that every black male in town submit to fingerprinting to see if they matched those of the rapist found at the scene of the crimes.



Dennis Foy was the least suspected - but turned out to be the rapist.

Some 125 black men voluntarily were fingerprinted in a door-to-door canvas by police. Then Dennis Foy was arrested on a stolen property charge. His fingerprints matched the rapist and he confessed to all of the crimes. Kelly said that 31% of the people in his town are elderly and easy prey for such criminals. Kelly said if he had it all to do over again he would do the same.

Atlanta Wracked With Black Crime Wave

Black Crime Out Of Control

Negroes commit far more crimes of violence than do Whites. The leading cause of death for black males aged 15 to 24 is homicide. (For Whites it is auto accidents.) One out of every 47 blacks in America will be murdered. The figure is one out of every 240 for Whites.

Atlanta's murder rate by blacks is skyrocketing and jumped by 36% over the last two years. Alcohol and drug

addiction is blamed.

Many Whites feel it is too dangerous to go into downtown areas where Negroes predominate. Atlanta has grandiose plans to build a huge domed stadium for the Falcons football team and also rebuild the old "Underground Atlanta" nightclub district. Long time residents believe that both projects will have a very tough time succeeding because fewer and fewer people

will go downtown anymore.

On this page we reproduce the terrifying experience of Mrs. Martha Mathis and her family the last time they visited Atlanta's Omni entertainment complex. We should note that Mrs. Mathis' family is from Cumming, Georgia which is in the much maligned Forsyth County. Here people are very happy to live in a crime free all-White County.

Forsyth County, Ga. Family Attacked

Editor:

On Sept. 19 my husband, myself, my brother and his girlfriend took our two 15-year-olds to a concert at the Omni. My husband, myself, my brother and his girlfriend waited outside until the concert was over at about 11:15.

We watched for the boys coming out and soon saw them coming up the sidewalk. I started walking toward them. A group of black boys were directly behind them when suddenly one of the black boys pushed my nephew aside and hit my son on the head with something. As he fell, another one of the blacks reached and jerked a gold chain and nugget from around his neck. I ran between them and screamed for my husband. He, in turn, along with my brother, chased them down the sidewalk - cars were stopping in the streets and more blacks were getting out to help "their brothers."

The ones my husband and brother were chasing stopped, only to find they were standing in a parking lot full of blacks. Two of them took out guns and were pointing them at us, and several were holding knives. All of them were cussing us. We realized it was a hopeless case so we turned around and started to leave, but that wasn't enough. One of them hit my son on the head with a brick and another one hit my brother on the head with a piece of concrete block. We began to wonder if we were ever going to be able to leave at all.

As we walked toward the parking lot, several of them kept following us cussing, pushing and tripping us, trying to pull our necklaces off of our necks too. As we crossed

the parking lot we saw two black police directing traffic. We approached them trying to explain what had happened. The policewoman simply walked off and wouldn't even listen. The policeman was a little more considerate. He listened and then told us there was nothing he could do. "Describe them," he said.

They were black holding knives and guns, and we sure didn't stay around taking names and getting their social security numbers. We soon realized they weren't going to help us, so my husband asked the policeman to just walk us to our car and we would leave. We knew if they followed us to our car and saw we were from Forsyth County we would really be in trouble. The policeman wouldn't do that. He said, "go on, they're not going to bother you."

He continued to direct traffic as if it was more important than someone getting shot or stabbed. All the way home I thought about the march they had up here and all their "rights". Where were our rights last night?

Then to wake up this morning and right on the front page was Hosea Williams wanting to build apartments for the "poor blacks." Well, I know one "poor black" who's \$800 better off this morning, the cost of the necklace he stole. Then we're asked to teach our children to accept them as equals. What could I possibly teach my son after last night? I would like to be treated as an equal too. But I doubt if they will call out the National Guard every time I need or want to go to Atlanta, or if the police will ask them all to stay at home while I'm there so I can feel safe.

Mandatory AIDS Testing**

Civil rights groups and the homosexual lobby are strongly opposed to mandatory testing for AIDS. This deadly infectious disease has entered the heterosexual community mainly through bisexuals and drug addicts infecting White women. **THIS MUST BE STOPPED!**

Dr. E.R. Fields, editor of The Thunderbolt and our staff believe that every American should be tested for AIDS. Everyone should be required to carry an AIDS card just like a driver's license or Social Security card. This ID should be presented upon demand to employers such as hospitals, food handling establishments, child care centers, etc. The card should be shown to anyone whom a person might be intimate with sexually.

It is true that a tiny few infected carriers might slip through this protective barrier into the disease-free community due to the time period in which it takes for AIDS to show up. **BUT THERE WOULD BE SO FEW THAT 99.9% of the population would**

be protected. Actually even AIDS carriers should want to know whether or not they are infected. Then they could take measures to insure they will not pass the deadly disease on to others.

Once all of the 1.5 million to 4 million AIDS carriers are identified the spread of the disease can be stopped in its tracks.
