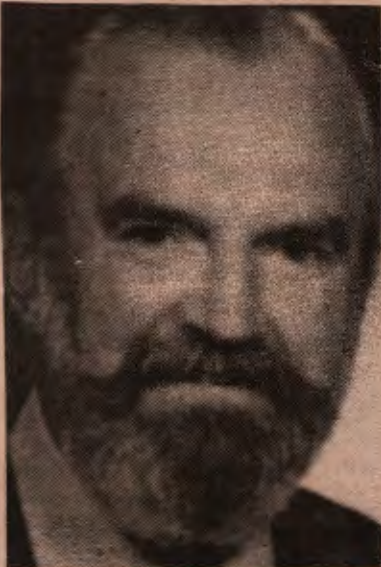


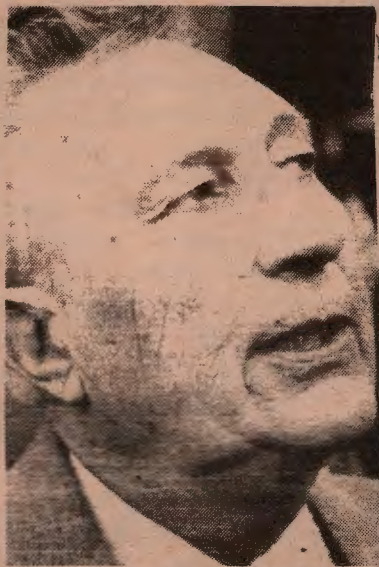
Sedition Law Threatens Free Speech

Freedom Of Speech At Stake In Ft. Smith, Arkansas

"Operation Clean Sweep" was the name of the crackdown organized by U.S. Attorney General Edwin Meese to put Right-Wing Christian groups out of business, because they have been critical of zionist influence over our government. Meese faces indictment on numerous illegal activities. He has been investigated by more Grand Juries than any other Attorney General in U.S. history. In fact, Meese may well be indicted any day! It was Meese who personally ordered "Operation Clean Sweep" in order to further ingratiate himself with the Jewish lobby in Washington. Meese knows they have great influence over the nation's major newspapers and TV networks. Their favorable publicity can make him appear too "nice a guy to indict." Thus if Meese can position himself as the "darling" of the Jews he hopes to avoid going to prison.

Edwin Meese's chief aid and Deputy Attorney General is the Jew Allan Gerson. He is personally in charge of the Sedition Trial. There was a group out in Seattle, Washington called "The Order". It had no official connection with any legitimate Right-Wing organization. They did commit bank robberies, etc. They were all given very stiff sentences in Seattle ranging from 60 years in prison to 120 years. Four of them were also tried in Denver for shooting a Left-Wing radio talk show host named Alan Berg. Two were convicted and given stiff sentences of over 100 years and the other two were acquitted.

Real Targets Are Three Innocent Men

These people will never live long enough to get out of prison — YET THEY HAVE BEEN INDICTED ALL OVER AGAIN FOR SEDITION ALONG WITH THREE TOTALLY INNOCENT MEN! No legitimate Patriotic Christian group condones any of the actions taken by "The Order." The conspiracy here is on the part of the Justice Dept. to overtly FRAME three innocent men by putting them on trial with the "bad apples."

They are all charged with "sedition" - or plotting the overthrow of the U.S. Government. Actually, the only three men really on trial are those who were not in The Order. They are Pastor Bob Miles, Rev. Richard Butler, and Louis Beam. The Order Members, eleven of them, don't care whether or not they are convicted as the sentence for sedition is "only" 20 years. They are all serving life over the Seattle case. The only reason for indicting them with Miles, Butler and Beam is to prejudice any fair trial for the real defendants. If the government was honest about this they would grant the three real defendants SEPARATE TRIALS. They refuse to do this because without the other "wild men" element they would have absolutely no chance whatsoever of winning a conviction before an impartial jury.

What Are The Charges Against The Three?

Pastor Richard Butler is charged with five counts of "seditious conspiracy." They are as follows:

- 1) Inviting Jim Ellison to attend an Aryan Nations conference.
- 2) Attending a meeting in his own church.
- 3) Receiving a letter from Randall Duey.
- 4) Receiving two phone calls from Jim Ellison.
- 5) Cleaning out his files.

Israel Violates Camp David Accord and Geneva Convention

President Carter Egypt's Anwar Sadat and Israel's Begin signed the Camp David agreement which included direct elections in the Gaza Strip with the area being policed with a Palestinian police force. Israel has never shown any interest in implementing this agreement. After the death of Sadat and Carter leaving office the Reagan Administration has simply been afraid to remind the Jews of their pledge! Don't forget that as part of this agreement Carter promised the Jews that all of Israel's foreign aid in the future would be free grants which they do not have to repay! Before that, at least half of their economic aid was a loan which had to be paid back with interest.

Israel Has No Concern For "Human Rights"

The United Nations Security Council adopted a strong resolution deploring Israel's "policies and practices which violate the human rights of the Palestinian people, and in particular the opening of fire by

America's Cowardly Response To Israel's Brutality

Israel's guns, tear gas and even their billy clubs are paid for by the massive amount of foreign aid our cowardly Congress votes Israel every year. When Israel seized the West Bank and Gaza Strip during the 1967 Six Day War their leaders said they would hold onto the land for only a few months. The rest of the world accepted their word. No one ever dreamed that 20 YEARS AND 8 MONTHS LATER THIS ILLEGAL OCCUPATION WOULD CONTINUE WITH THE INHABITANTS TREATED WORSE THAN SLAVES!

The U.S. government has acted like a weak wimp in failing to ORDER the Jews to cease their acts of violence against Palestinian men and women. Both Israel's Defense Minister, Yitzhak Rabin and Foreign Minister Shimon Peres, have declared their "right" to use deadly force against the demonstrators.

U.S. State Department spokeswoman Phyllis Oakley issued the following statement: "Order should be maintained without the use of lethal force. Techniques are available to accomplish this, and we urge they be employed."

Israel's Ambassador to the U.S., Moshe Arad dismissed this out of hand and arrogantly replied: "Ms. Oakley's statement is unfortunate and will not harm U.S.-Israeli friendship which is strong enough to withstand these differences. Her statement is merely a slap on the wrist."

America's U.N. Ambassador Herbert Okum described Israel's measures in the occupied territories as "unacceptably harsh. They have international responsibilities as an occupying power!"

Israel's Rabin responded on NBC's Meet The Press, whenever our soldiers are in danger they are allowed to use live ammunition." When asked about all the deaths and wounded Palestinian children he sarcastically replied, "these are accidents and not our policy."

Jewish Leaders Descend On State Department

"The Conference of Presidents of Major American Jewish Organizations" is the grandstanding name for the umbrella group which is the voice of all large Jew groups. Its Chairman, Morris B. Abram of Atlanta, Along with 24 other powerful Jews met for over an hour with Deputy Secy. of State John Whitehead. Abram said they spoke with, "total unity to express our deep concern about criticisms that cast Israel as an equal to the Palestinian rioters in responsibility for the violence."

Abram told Whitehead that the Palestinians were, "guerrillas seeking the overthrow of the government of Israel not only in the territories but also the government of Israel in Israel. (They called this "sedition.") Israel is seeking to maintain law and order and they are trying to uproot law and order. They have been incited by outside terrorists!"

The very next day Ms. Oakley muted U.S. policy and issued this watered-down statement, "there is a need for restraint by all parties and a common commitment to deal with the underlying

The charges against Miles and Beam are just as nonsensical. In Beam's case it says he received money. The insinuation is that it may have been stolen money — BUT HE HAS NEVER BEEN CHARGED WITH THAT! Who can tell if a cash donation is stolen money or not?

Justice Department Attorney Allan Gerson has over and over again "leaked" reports to the press calling the three REAL DEFENDANTS in this case - "neo-Nazies" and "anti-Semites". The smear campaign has been unrelenting and endless. They hope to thereby prejudice the people of Arkansas and potential jurors in this case to insure a conviction. In fact the Justice Department says this trial will last three months with 250 witnesses! No defendant can receive a fair trial under such circumstances because they do not have all the resources, (money), of the government to respond to hundreds of accusations mainly rehashing the Seattle case all over again. Actually this case clearly represents "double jeopardy" for the Seattle defendants and "TRIPLE JEOPARDY" for those who have been tried in both Seattle and Denver and now in Ft. Smith, Arkansas!

Just as the Sedition Law of 1798 was a threat to freedom of speech and press, and just as it was during World War One and World War II — SO IT IS TODAY! There is no room in a truly FREE NATION for any "sedition law". It is too fraught for abuse as is clearly seen in this case. To toss three innocent men into a trial with members of "The Order" is the greatest outrage of this decade. It is an affront to all freedom loving Americans.

Both Men Have Heart Problems

The very thought of Pastor Miles and Rev. Butler trying to overthrow the U.S. Government is so ridiculous that it should be laughed out of court. Both Butler and Miles have serious heart problems. Butler just recently had triple by-pass surgery after a near fatal heart attack. Miles had had FOUR HEART ATTACKS and is a constant heart patient. Louis Beam is nicknamed, "Lone Star," not just because he is from Texas, but because he is a "loner" and has no following. How could any serious man dream for even a moment that these men could ever pose any kind of threat to the U.S. Government. That they dare make such a charge against these three men is an insult to the intelligence of every American and a grave threat to our FREEDOMS under the Constitution.

If these men can be convicted for speaking out against the admitted powerful influence organized Jewry holds over our government — well, then just about any free man can be charged with sedition! This danger was fought by Thomas Jefferson and other famous Americans. We are praying for these men's acquittal and ask that all Christian Americans join us in distributing extra copies of this newspaper. Here is the whole story of the sedition laws dating back to their very beginning. Your editor will attend the trial and keep in constant contact with both Pastor Miles and Rev. Butler. We will keep you fully informed as this despicable road show draws on and on just like the 1944 Sedition trial which outlasted even the life of the trial judge.

Sedition Law Violates First Amendment Rights

Fortunately the Sedition Law has always been rejected by thoughtful men in the past including Thomas Jefferson, Oliver Wendell Holmes, and Sen. Robert A. Taft. We shall likewise oppose this law and ask that all like-minded Americans join us in raising our voices before the media and the public. WE DEMAND THAT THE SEDITION LAW BE REPEALED!

The Sedition Law of today is just as bad as the one rejected by Thomas Jefferson in 1798 and by Oliver Wendell Holmes in 1919. It reads in part as follows from title 18 USC 2385 headed: "ADVOCATING OVERTHROW OF THE GOVERNMENT."

"Whoever, with intent to cause the overthrow or destruction of the government, prints, publishes, edits, issues, circulates, sells, distributes or publicly displays any written or printed matter advocating, advising, or teaching the duty, necessity, desirability, propriety of overthrowing any government in the United States...or attempts to do so, etc., shall be guilty of SEDITION!"

This law has always been selectively applied because when Communists and Liberals fought to undermine our war effort in Vietnam no one even dared to suggest that the "war disruptors" be indicted for sedition! Today this very same element which has

More Corruption By Meese

Meese May Still be Indicted

Ed Meese Squirms Like A Cornered Rat

Edwin Meese is the most criminally investigated Attorney General in history. Two of his closest friends and advisors have been indicted for receiving millions in kick-backs to win government contracts for the Wedtech Corp. Meese has admitted using his influence to obtain contracts worth millions to help his pals Wallach and Chinn.

San Francisco lawyer, E. Robert Wallach, (Jew) went to law school with Meese at U. of Calif. He moved to Washington, D.C. when Meese was first appointed an Advisor To The President. Meese got Wallach appointed to a high paying post as U.S. Representative to the U.N. Human Rights Commission and to another job, as deputy chairman of the Advisory Commission on Public Diplomacy.

While Meese has long claimed to be a "conservative" his close friend Wallach was a leader in the NAACP, the Ban The Bomb movement, as well as a leading spokesman for the legalization of the drug marijuana. Wallach is now under indictment for taking \$300,000 in kickbacks from Wedtech. Wallach was released under a \$500,000 bond.

Meese Financial Advisor Indicted

W. Franklyn Chinn came to the U.S. in 1945 as a refugee from Shanghai, China. Chinn is described as a "loner" who invests other people's money in stocks. He operated out of his apartment in an expensive high-rise atop Nob Hill in San Francisco. Shortly after Meese became Attorney General, by a strange coincidence, W. Franklyn Chinn just happened to be named a Director of Wedtech!

Next Meese gives Chinn \$60,000 to invest for him in a "blind trust." Just 19 months later Chinn tells Meese how lucky he is because his "investment" has earned a \$40,000 profit. Not bad, but investigators now say the stocks Chinn bought for Meese never earned anything close to that figure. WHERE DID THE MONEY COME FROM??? Chinn is now under indictment for taking \$1 million in kickbacks from Wedtech. He was released under a \$1 million bond.

Dr. Rusty Kent London, whose real Jewish name is Irving Lobsenz is from Jersey City, New Jersey. He was Chinn's partner in the scam to obtain \$1 million from Wedtech for their "advice" - of which they gave none! London is the former head of a waterbed firm and author of three books on how to win at blackjack. One of his novels, "The Big Night," is about a gambler who swindles at Las Vegas casino out of \$1 million - THE VERY SAME AMOUNT HE GOT FROM WEDTECH!

New Investigation Of Meese

Special Prosecutor James McKay has launched yet another investigation into possible "conflict of interest" charges against Meese. It now has been revealed that Meese owned \$9,600 in Bell telephone stock at a time when he was involved in supervising the division of the phone company. Meese claims his stock had been signed over to Mr. Chinn. Today it has come to light that Meese never actually acted to sign the stock over to Chinn. Meese now claims that he "lost" the transfer papers!

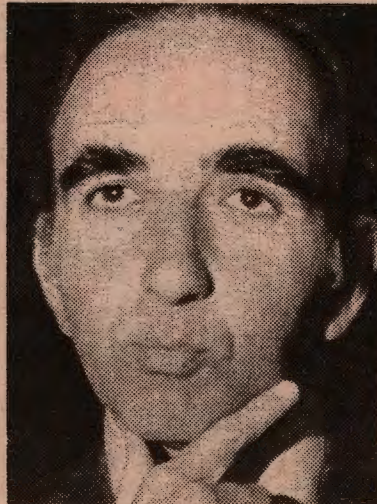
Prosecutor James McKay has enough evidence to indict Meese. But Meese is supported by the powerful Jewish community and this presents Meese with his best hope of saving himself from prison!

Meese personally announced the indictments of Right-Wing Patriots, Pastor Bob Miles, Rev. Richard Butler and Louis Beam for "sedition." The Jewish Anti-Defamation League admits they worked with Meese to obtain these indictments. Meese and Shultz are the two strongest supporters of Israel in the White House. Meese says "Because we share the same interests, this administration is committed irrevocably to the safety and security of Israel."

What James McKay faces is the wrath of the politically powerful Jewish community in Washington should he indict Meese. Hopefully, he may well decide to become a national hero to the Christian conservative majority of this nation. Yet, Meese lawyer, Natan Lewin, (Jew), said, "I am confident that these and other matters will be concluded favorably to the Attorney General."



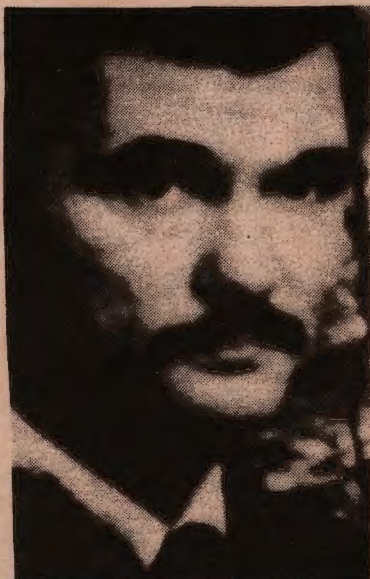
Atty. Gen. Ed Meese, fighting to stay out of prison.

problems and frustrations."

The problem is that 1.5 million Palestinians have been held in abject slavery under continuing persecution for 20 years and 8 months. They are not willing to take it any longer. They know that without resistance and protests they and their children and grandchildren will remain slaves forever and ever!

Jews Resort To Murder, Starvation and Beatings!

As we go to press 54 Palestinians have been killed, untold thousands injured from beatings and 2,500 arrested. Few people realize that most of those arrested are not caught during the rioting. Israel's secret police wire tapped hundreds of Palestinian telephones. They also take pictures of demonstrators. Those they hear talking in favor of the uprising or identified from pictures are arrested in the middle of the night. This technique is used for two reasons. First, so that there is no resistance from either the family or neighbors. The second is to strike terror into others with midnight arrests.

Jewish Defense Minister Rabin says this is all part of their "IRON FIST" policy to put down the unrest. Rabin was asked why he continues to use live ammunition and not rubber bullets as the British do in North Ireland and like the Whites of South Africa? He replied: "We'll try to reduce it, (the deaths), to a minimum but our soldiers often run out of rubber bullets and tear gas and then must use live ammunition. Also, the policy is that whenever our soldiers are in danger, they are allowed to open fire with live ammunition."

(NOTE: Israel has unlimited quantities of American made rubber bullets and tear gas!)

Starvation Fails To Suppress Palestinians

The 244,416 Palestinians living in the eight poverty struck United Nations operated refugee camps in Gaza. Here these poor people have languished for 40 years since the Jews drove them out of their villages, homes and farms in the East Bank of Palestine. For two weeks the Jewish military cut off their food supplies from the outside world.

A Washington Post reporter interviewed one woman known as Annouri, age 34, who said: "There is no meat or eggs for the adults, no milk for the children, all we have is rice and water. We are eating like animals. I have lived here all my life and have never seen the home of my ancestors in which Jews now live. There is nothing in the shops. We face starvation!"

The Jewish soldiers even prevented U.N. emergency food supplies from entering the refugee camps. The women are only given one hour a day outside their cramped shacks to try and find food. When U.N. officials lodged an official complaint the Jewish officers said, "They are only making propaganda!"

Rabin said: "We shall show them who is running the territories. There is hunger but not starvation. When they can't work or eat they will apply pressure on the instigators to stop the rioting. This will teach them humility and a gradual return to tranquility will begin."

Beat Them and Break Their Bones

When the midnight arrests and starvation failed to work new orders came down from the Jewish military high command. They were told to begin terror beatings and instructed the soldiers: "those with broken hands can't throw rocks for weeks, those with broken arms can't throw rocks for months!"

Thus began the horrifying reports which slipped through to reporters about teenagers and young men being dragged by Jewish soldiers behind buildings. Their arms were broken in two after being smashed with rifle butts. Photographers caught Jew troops holding children's hands against a wall while one of them cracked his knuckles open with a rifle butt. Screaming in agony they were seen being dragged away with broken limbs in jeeps and trucks - still being beaten as they ride off to the concentration camp. And still there are no voices arising from the U.S. Congress in protest - they all live in fear of the powerful Washington Jewish Lobby.

the Israeli Army, resulting in the killing and wounding of defenseless Palestinian civilians. We call for maximum restraint by Israel."

The weak and cowardly U.S. government abstained from voting on this resolution. Our U.N. representative, Herbert Okum explained, "we abstained because the resolution generally criticized Israel and ignored the dangers and provocations faced by the Israeli security forces."

This is the latest surrender by our government to their fear of the Jewish Lobby which

acts against them. But the truth is that the Jews were never starved, never beaten or ever had their bones broken. They were never shot down in the street or even tear gassed.

Contrary to a massive campaign of lies, not one single Jew, let us repeat, NOT ONE SINGLE JEW, was ever gassed by the Germans. Also, no 6 million ever died either, the true figure as given by the Red Cross was around 300,000. Most of these perished from a typhus plague which swept the camps at the end of the war and killed many Germans also. (See our Holocaust Studies book list on Page 11 for available documentation.)

What the Jews are doing is to use terror and torture of the type they have always accused their enemies of using. The truth is that this is the nature of the Jew and foreign to other races!

American Leaders On The Middle East

Statenman, George Ball, former Deputy Secretary of State under Presidents Kennedy and Johnson responded to this question from USA Today: "Shouldn't the USA have a special relationship with Israel because it is the only democracy in the region?"

George Ball replied: "In the first place part of the mythology is that their strategic interests and ours coincide. Our interests diverge to a very considerable degree. Secondly, all you have to do is look at their behavior toward minorities, and you get a very clear idea that if it's a democracy, then South Africa's a democracy. Now, for having a special relationship, well, that's simply just a figure of speech."

Shocking Conditions In Gaza

The World's Largest Concentration Camp

The Gaza Strip is only thirty miles long and 6 miles wide. It is the most crowded area in the world equaling that of Hong Kong. Some 650,000 Palestinians are jam-packed into this area. Three-fourths are refugees who were driven there from other parts of Palestine when the Jews seized the country in 1948. Today, 59% of this population are under the age 19 and they have no intention of spending the rest of their lives as slaves to the Jews.

These poor wretched people are crammed into eight U.N. refugee camps. Many families live in single-room shacks built from scraps of wood and corrugated iron. At one time they lived on prosperous farms with comfortable homes - these have all been confiscated by the Jews. The Arabs were paid no "reparations" as the Jews demanded from the Germans.

They Must Work For The Jews

These are a stateless people, embittered by being forced to carry Israeli issued ID cards which list their nationality as "undefined." There are shortages of food, water and medicine. It is against the law to display a Palestinian flag or to possess books on a list of banned reading material issued to them by the Jews. People suspected of inciting unrest are often arrested in the middle of the night and taken away to concentration camps. They can be detained without trial and deported out of their own country.

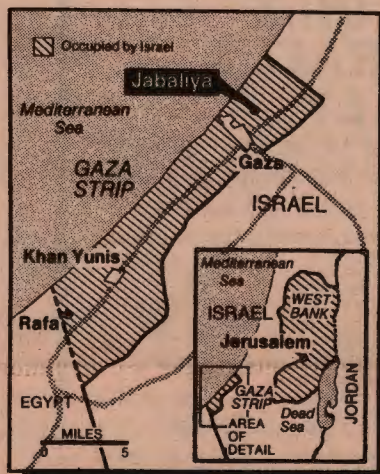
There has been no election in Gaza since 1945. Up to 65,000 Gaza people work in Israel each day mainly doing menial jobs which Jews refuse. They are hauled in trucks to work in construction, street cleaning, garbage collecting, picking fruit and vegetables, and at very low paying factory jobs. Many are college graduates with degrees in education, business, etc., but they cannot obtain jobs. At night, they must be out of Israel and trucked back to their barbed wire surrounded U.N. camps. They must have their I.D. papers renewed every three months, otherwise they will not be allowed back into the land of their forefathers to work.

No Free Enterprise

In the Gaza the Palestinians are not allowed to produce farm products unless they are sold through the Jewish marketing trade system. If a

specific factory product represents "competition" with a similar product in Israel the Jews refuse to license it. On the reverse side the Jews make money on these poor oppressed Palestinians who are taxed at the same rate as Israelis - BUT THE JEWISH GOVERNMENT SPENDS FAR LESS THAN THEY TAKE IN ON ROADS, HOSPITALS AND SERVICES IN GAZA! Since there are very few items made in the Gaza the people must buy most of their consumer goods from the Jews. In other words the Jews are making a big profit off the people they treat as slaves!

Jews Are Stealing The Land of Gaza

Only 2,500 Jewish "settlers" live in Gaza. They reside in comfortable homes built with U.S. taxpayers money in 13 settlements. They are guarded 24 hours a day by heavily armed Jew troops. These Jews make up only 0.4% of the Gaza population but already own 8% of the land. Even worse is the fact that the Jewish government has seized control of nearly 40% of the rest of Gaza land for future Jewish "settlers" and Jewish "development." The Jews

arrogantly refer to this as "establishing facts on the ground."

These are the reasons why the Jews have no plans to grant the Palestinians their freedom despite the Camp David Accord. It was signed by Israel's Begin, Egypt's Sadat and America's Jimmy Carter and promised "full autonomy" with free elections for all Palestinians living in Gaza. The Jews never had any intention of implementing this plan which Pres. Carter promised would result in "peace in the Middle East."

Victory In Numbers

Despite all this persecution the future looks bright for the Palestinians. Their numbers are growing daily because of their high birth rate. By the year 2000, just 12 years off, there will be ONE MILLION people in Gaza which Jews refer to as "that demographic monster." The Jews cannot expect to hold these people in bondage forever.

The longer they postpone a settlement the bigger the eventual explosion will be. We may already be witnessing the beginning of that day! The following are comments quoted by wire services from the people in the streets of Gaza:

An old man: "This is our struggle. We must fight the Jews to get our green homeland back."

A young boy: "I will be killed fighting them, and my brother and my sister will also die. We will struggle as you see. We will struggle with stones until we are either all dead or free men!"

A young mother: "As long as I am alive I am going to teach the young people to fight until we have a solution. We want to live in peace and we want the Jews out of our land. I don't care what happens to us as long as we get our land back!"

Israel shames U.S. by shooting children

The United States should immediately issue a clear demand to Israel that it cease the brutalization of hundreds of thousands of Palestinians who now are being shot at daily by Israeli soldiers. We don't for a moment believe Israel could continue its Nazi-like conduct except for the billions of dollars it receives each year from the United States government.

It has become all too clear to anyone who cares to look at the situation that Israel has absolutely no intention to ever work out anything like peace but will continue its war against the Palestinian people. Some days we wonder just how long it will be before the Israelis herd the surviving Palestinians into gas chambers for the ultimate final solution.

It is time for the United States to stop its indirect participation in this continued affront to the basic standards of human decency. The daily shootings of Palestinian children by Israeli soldiers must not be excused.

Certainly it is time for the government of the United States to stop being the defender and apologist for Israel no matter how serious the offense. By so doing we compromise our principles and deliver the message to all of the Arabic world that the United States can never be trusted to champion basic ideas of peace and human rights when it is an issue of an Israeli stepping on an Arab.

It is really absurd for the U.S. State Department to wring its hands and proclaim to the world, as it has been doing the past few days, that the United States regrets the slaughter of Palestinian children but can't do anything about it. Such total nonsense is insulting to concerned citizens everywhere. So long as American money pays the Israeli bills, America cannot dodge responsibility.

The U.S. could make a start by joining in a strong United Nations condemnation of Israel. But we won't. The standard American response to any U.N. criticism is an automatic veto. But we should welcome a strong United Nations stance.

As more soldiers poured through the hospital gate, the Jeep left the compound and stopped a few feet away. The driver jumped out and hauled the two Palestinians before an officer. Both Arabs were bleeding heavily from their eyes and noses.

"Are you crazy?" the officer shouted at the driver. "There are two journalists over there. Get them back inside the Jeep. And put your helmet on."

The driver pushed the youths back inside the vehicle and drove away.

History Of The "Sedition Law"—F

Sedition Law Threatens Free Speech

America has witnessed very few "sedition trials."

The first was held right after the founding of this nation. In 1797, John Adams is elected President by only three votes over Thomas Jefferson. Adams is a member of the Federalist Party while Jefferson represented the Republican Party. In 1798, the Federalists enacted a Sedition Law by which they hoped to suppress their political opposition. They soon accused the leading supporters of Jefferson with "Sedition" - that is, plotting the overthrow of the government. Those charged with "Sedition" included many of the nation's leading writers, speakers and editors.

The Sedition Law provided stiff prison sentences for anyone engaged in "false, scandalous, and malicious writings against the government, either house of Congress or the President."

Government prosecutors made sure that the juries were packed with Federalist supporters. They even ruled that juries were not allowed to consider the truth of the defendants' writings, writers and printers were convicted of sedition.

Prominent American Leaders Accused of Sedition

One of the first convicted was Republican Congressman Matthew Lyon of Vermont. His offensive words were as follows: "President Adams manifests an unbounded thirst for ridiculous pomp, foolish adulation and selfish avarice."

Rep. Lyon was convicted by a hand-picked jury, sentenced to five years in prison and handed a heavy fine. He also had the misfortune of falling into the hands of a sadistic marshall who subjected him to inhumane treatment while in prison. His friends tried to hold a lottery to raise money to pay off his fine and they were also arrested.

Pennsylvania's celebrated philosopher, Dr. Thomas Cooper was arrested for sedition after writing an article critical of Pres. Adams. The public was becoming sympathetic with the luckless sedition victims. They began to realize that the sedition law was clearly violating the First Amendment to the Constitution which guarantees the right to free speech and press.

Virginia's well know publisher of pamphlets, James Callender, was accused of sedition for writing, "The Prospect Before Us." Federalist Judge Chase so bullied Callender's lawyer that he withdrew from the case. When Col. John Taylor sought to testify for Callender he was stopped by Judge Chase and fined for contempt. Callender was given a severe prison sentence.

Leaders Demand Sedition Law Repeal

Some of America's foremost founding fathers then appealed to the state legislatures of America to help them repeal the Sedition Law. Leading this move were Jefferson, Breckenridge and Madison. They were then joined by Federalist Party leaders, Alexander Hamilton and John Marshall, who defected from their own party to demand the repeal of the sedition law.

The situation had degenerated to the point where the government planted spies at Republican Party meetings taking notes on those who opposed Pres. Adams. Such persons were later arrested, hauled before irate Federalist judges who berated them and convicted them of sedition.

Hamilton warned, "Let us not establish a tyranny."

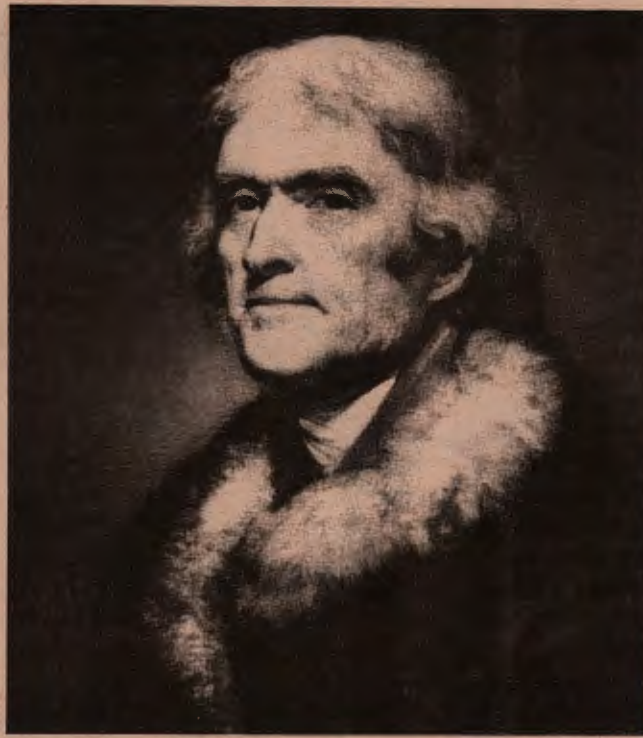
John Spencer Bassett said: "The sedition law grew out of a momentary hysteria, not incomparable to that which produced the Salem persecutions for witchcraft."

People began speaking out denouncing the sedition law as a "judicial disgrace." Others said government leaders should "hang their heads in shame!" The outcry became so strong that in 1801 the sedition law was repealed. Those Americans convicted of sedition were all released from prison and were regarded as martyrs.

In 1840 the Congress passed a bill which remitted all the fines and court cost to the defendants.

Roosevelt's "New Deal" Sedition Law

June 28, 1940, President Franklin D. Roosevelt enacted a new Sedition Law which he planned to use against Patriotic Americans who were trying to keep this nation out of World War II. Sedition indictments were issued on July 24, 1942.



Founding Father, Thomas Jefferson, our 3rd President, (1801-1809) repealed the Sedition Law and called it "a source for tyranny."

They were accused of publishing "pamphlets and newspapers," which tended to undermine the war effort. (Oh, how the powers that be fear freedom of the press!) The sedition trial began in 1944. The indictment included these charges.

These defendants have said:

- 1) The U.S. government is controlled by Communists and Jews!
- 2) The U.S. government is controlled by alien-minded persons who seek ^{been} overthrow of the U.S. Constitution.
- 3) ^{been} s. Roosevelt is reprehensible, a warmonger, liar, unscrupulous, and a pawn of the Jews and Communists.
- 4) The Axis powers are fighting to free the world from domination by Communists and international Jews.
- 5) The present war is a dishonest war waged at the expense of our peoples' blood and dollars for the sole benefit of the International Bankers, Communists and International Jews.
- 6) The Japanese attack upon Pearl Harbor was deliberately invited by Roosevelt in order to involve the U.S. in a foreign war
- 7) An honorable and just peace could be brought about speedily were it not for the opposition of Communists, war profiteers and International Jewry.

Believe it or not, these are the "crimes" charged against Patriotic Americans who sought to keep us out of World War II! Today we know that these charges have been proven to be mostly true! Still voicing such views was considered "sedition" under the Roosevelt regime.

Communists Supported Sedition Trials

The U.S. Communist Party through both its leader, Earl Browder, and newspaper, "The Daily Worker," hailed the sedition indictments and demanded the defendants be given the maximum penalty. The Jew Eugene Meyer, owner of "The Washington Post," carried prominent articles on a daily basis attacking the defendants. Also, the radio gossip monger, Walter Winchell, continually slandered the defendants.

Conservative Patriots Blame

Ohio's Senator Robert A. Taft, William Howard Taft, was warned by his political career by speaking out while the war was still in progress caution to the wind and he said he would remain silent.

Sen. Taft said: "I am deeply alarmed to smear loyal citizens who are loyal to the Administration...Something very clear in certain circles here. I cannot understand but...Freedom of Speech itself is at stake."

Hoffman then attacked those who "leaked" details of the Grand Jury proceedings to the Washington Post. He added: "In order to protect the Congresses and to expose these men, where they get their money, but what they are trying to do...The persecution of the defendants, should be ended, as it is to convict one upon proof obtained in a secret trial."

Hoffman then attacked the charge of "seditious literature" and said: "It is imperative before a committee those who originate such literature."

Palestinians Are Not "Terrorists"

WASHINGTON — The violence in Gaza and the West Bank has abated; Defense Minister Rabin's policy of "force, might, beatings" seems to have worked. But, though the Palestinians lost three dozen dead, and hundreds injured, victory is theirs; it was written all over the grinning countenance of Yassir Arafat at the Arab summit.

When the day comes that a Palestinian state is established, Gaza's riots will be recorded in its history like the "Boston Massacre" of 1770, when British troops fired on a rock-throwing mob of Americans, killing six, but persuading thousands more in the 13 colonies that the break with London had to come, and soon.

This time, the Palestinians did it right, if you will. They got the attention of the world, and, most important, of the Americans, not with some bloody massacre of defenseless women and children, but by the physical defiance of Israeli troops.

But the Palestinian who flew that hang glider over Israel's northern border, and took six soldiers with him when he gave his life, was not a terrorist, as we know the term. And the Palestinian boys throwing rocks at Israeli troops are not terrorists. That these riots were instigated by, or directed by, the PLO, may or may not be true; but that is not the relevant truth.

To compare the riots in Gaza and on the Temple Mount with the orgies of looting and mayhem in America's

cities in the '60s misses the point utterly. These Palestinian riots were expressions of nationalism, a genuine popular uprising, a collective assertion by the Palestinian people that they have had enough, enough of military occupation, enough repression, enough squalor. As one veteran U.S. diplomat told me, there is a "qualitative difference" to these disorders. Their message is simple. Our time has come.

For the United States, the Palestinian riots of '88 should cause serious new thinking. When Israeli troops dragged those Arab youth behind buildings and broke their hands with two-by-fours, those were our tax dollars at work. Because America provides Israel \$3 billion in annual subsidies (\$12,000 for every Israeli soldier), we cannot escape responsibility for what is being done.

But, because the United States has vast interests in an Arab world extending from Morocco to Mesopotamia, in a Moslem world extending from Marrakesh to Manila, Israel cannot be permitted to dictate or determine American policy toward the Palestinians. And, Mr. President, we need new thinking and a new policy.

Congress Fears Jewish Lobby New Ways To Aid Israel

WASHINGTON — The Congress of the United States is where everything under the sun is investigated with appropriate hearings and hours of gasbag oratory whenever there is any faint whiff of publicity and political profit.

Members of the Senate and House can be courageously outspoken on a range of public issues from foreign wars to wheat rust spores, from space flight to snail darter blight, from Soviet wiretaps to coyote traps, from impressive medical feats to million-dollar toilet seats, from moonshine and drug abuse to Imelda Marcos' fancy shoes.

Any hot publicity prospect will excite rival committees to swarm like sharks in a feeding frenzy.

Americans may find comfort knowing that members of Congress are always there, poised to probe and speak out on anything that's happened, anything that should have happened but didn't, any blemish on the democracy — anything, that is, that will pull in the cameras and reporters with the accompanying prospect of an instant's fame on national TV or a paragraph in the hometown gazette.

Well, almost anything. But not everything.

Never, not in all the decades that billions of U.S. tax dollars have been slavishly voted and lavishly bestowed, has the Congress gathered its collective courage to discuss in public how one of the world's tiniest nations — Israel — has used that money to damage and destroy the worldwide good name of the American people.

Now, during another outrageous use of military force financed by Americans, when Israelis use live ammunition, midnight arrests and drumhead trials without appeal against young Palestinians who protest 20 years of Israeli-imposed apartheid, even now the Congress is silent, still dumbstruck.

The collective congressional

strategy is as it's always been: To say nothing, avoid any criticism, anything that could be interpreted as criticism of the Israeli government and its actions.

A sometimes acknowledged cardinal rule of congressional conduct is that members worried about their futures in politics never give the Israeli lobby any cause to oppose their re-election or candidacy for other office.

In Congress, where maintenance of incumbency is seen by Republicans and Democrats alike as the highest priority, members not only shrink from getting crosswise with the Israeli lobby, they invent ways to serve Israel at U.S. taxpayers' expense.

For a few current examples: Not only does the recently passed \$600 billion omnibus appropriations bill contain \$3 billion in no-strings cash for Israel, but cloying members of Congress shoveled in other re-

wards. A "debt restructuring" provision benefiting Israel will, over a period of years, cut off Israel's repayments on outstanding debt to the United States by at least \$1.5 billion and more likely \$2 billion. Another outlay of U.S. money is modest by congressional standards but at the same time startling. It will set aside \$8 million for a school to be built in France to aid Jewish "refugees."

A source of some optimism could be that the goodness, the basic decency and sense of justice of Jewish people, in Israel as well as in the United States, will turn Israel from its doomed course.

When it's seen as safe, then maybe a few members of Congress will risk abandonment of their duties as toady order-takers for the Israeli lobby.

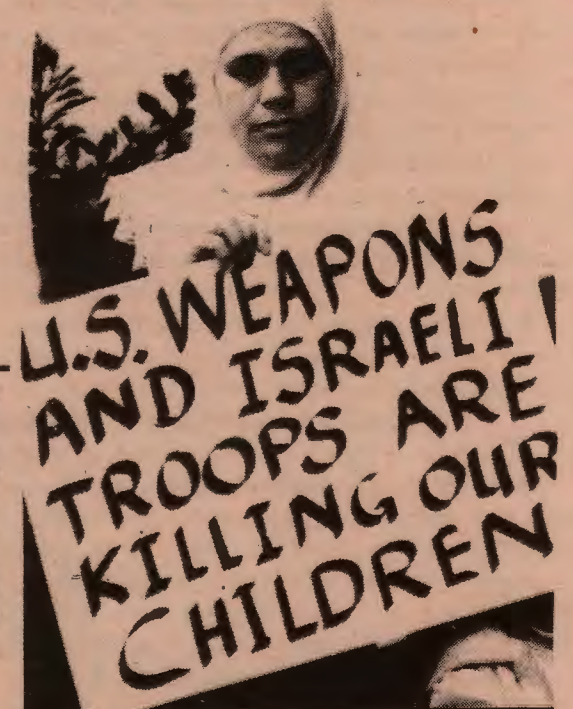
antagonize the Arab. We must learn to live together." This begging and crawling in a Jewish nation. In a Jewish state, the Arab once again has privileges.

Most Barbaric Trials Ever Held In West

Trials In Israel Same As Soviet Russia

The World has been stunned by the heavy handed dictatorial way in which Palestinians have been tried by Israel's army. There are no Arab judges and no juries in the occupied territories. Jews can have civilian judges and can appeal a case in Israel. But, the Arabs must stand before a Jew military officer and his sentence is the final word - the Jews allow no appeals!

As we go to press over 3,000 Palestinians have been arrested. They range between the ages of 14 and 27. The average trial will only last between 2 and 10 minutes. No defense witnesses or even prosecution witnesses testify. A Jewish military officer simply reads the charge and you plead either guilty or not guilty. He then decides the sentences which range from 2 months to 2 1/2 years. A trial can also be held in secret.

An arrested person can be held 18 days without their family being notified that they are under arrest. Also, you can be sent off to prison with no trial at all for up to six years after a secret summary judgment by an unnamed military tribunal. Over the past five months 129 defendants have been given this tyrannical treatment.

The most severe penalty of all is "deportation." This is a misnomer because the dictionary says the word "deport" means to send someone out of a country to which they have no legal right back to their resident country. In this case they are exiled out of their own homeland, never to be allowed to ever return to see their mothers, fathers, wives and children. This is a terrifying sentence which has been handed down to 44 Palestinians. An entire nation has been embittered by such despotic treatment. All of these measures have been copied by the Jews from the Communist legal system in Russia!

How Jewish Military Trials Work

Makeshift courtrooms have been setup in seven locations in Gaza and the West Bank. The older defendants are brought in blindfolded with their hands tied with plastic wire. They arrive in sealed vans. They enter the courtroom 20 to 40 at a time. The judge announces that all who plead guilty should step forward to receive a lighter sentence. Usually they are given three months prison sentences. Those who plead "not guilty" are treated more harshly with 2 to 10 minute "trials." Lawyers who complained about the speedy process are dismissed out of hand by the Jew judges.

Prisoners Are Beaten Unmercifully

The 300 Arab lawyers in Gaza declared: "there is no use appearing on behalf of the defendants - these trials are a farce!" Many of the lawyers are boycotting these summary trials. Attorney Lea Esemel said most of those arrested are severely beaten by the police. Attorney Felicia Langer said: "There is a regular pattern of beatings and humiliations. The prisoners basic human rights are being violated. The overcrowding is terrible. There is only one mattress for three prisoners."

Attorney Mohammed Abu Shaaban said he had affidavits testifying to terrible brutality. He said that in the Ansar II Concentration Camp 175 prisoners are being held in tents despite cold rainy weather. He said there are many with severe wounds and broken limbs from the beatings but there is no medical treatment for them. When told of these complaints Israel's chief army judge, Advocate General Amnon Streshnov said: "We will continue to give them speedy trials and they will not be denied their full rights under Israeli law."

Still reports emerge about "inhuman conditions" inside the jails. Attorney Abu Ghabban said: "I have seen prisoners in bad condition. Some were bleeding because of injuries they suffered inside the prison. These military judges are no different from a soldier on the street. They are not judges. These trials are a farce. Many common criminals have been set free to make room for the political prisoners."

Inside a Jewish Military Courtroom

(Following Is Taken From The French Press Agency:)

Handcuffed, blindfolded and guarded by soldiers carrying machine guns 25 prisoners are marched into an Israeli military courtroom. They are charged with having taken part in demonstrations against Jewish military rule. They range in age from 12 to 18.

The parents of 16-year-old Ibrahim Mohammad were able to hire a lawyer who spoke out: "My client was wounded in the head." Judge, Lt. Col. Levy responds: "If he is wounded in the head that proves he participated in a demonstration - I find him guilty and sentence you to six months in jail. Guards, take him

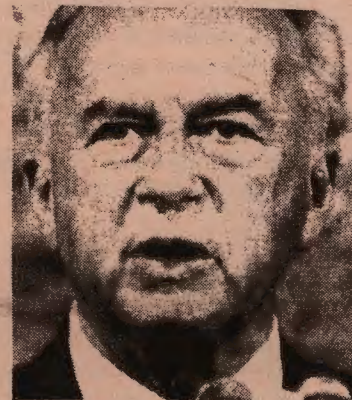
away!" The entire "trial" took only 2 minutes.

"Next defendant," shouts Judge Levy. The guards push before the bench Bamal Hassan al-Baraba who is accused of starting a boycott by having Arab shopkeepers lock up their stores. The young man says, "I am innocent." Judge Levy says: "Since the shops are closed that is proof that you are guilty - four months in jail - guards take him away."

Next is Nasser Abu Rahme, age 11, who is charged with throwing a rock at a soldier. He has a lawyer who whispers in his ear - then the youth says, "It is not true!" Judge Levy is enraged and shouts at the Arab lawyer: "You are advising your client to deny the facts - he is guilty - one month in jail."

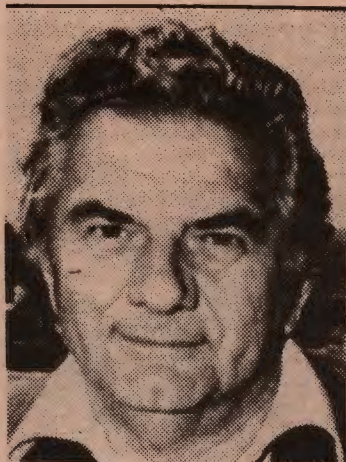
Parents Billed After Killing

JERUSALEM (Reuters)—Israel has billed a Palestinian family for the cost of flying their fatally wounded son to a hospital after Israeli troops shot him during riots in the Gaza Strip this month, a Palestinian lawyer said yesterday.

Gaza lawyer Raji Sourani told Reuters the parents of Hassan Abu Jaroun, 25, brought him a government bill for 5,000 shekels (\$3,300) for flying their son by helicopter to an Israeli hospital after he was shot in Khan Yunis on Dec. 16.

He died later the same day. "The parents are poor people who do not have the money to pay but even if they did, they should certainly not pay any expenses after it was Israeli troops who killed him," Sourani said.
