Mystery Guest Arrives In Connecticut

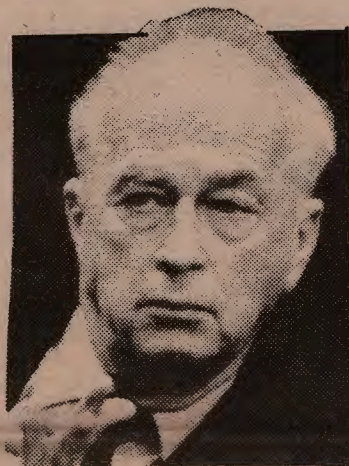

A few days later Pres. Reagan held a dinner in the White House for Gorbachev. The invited guests included

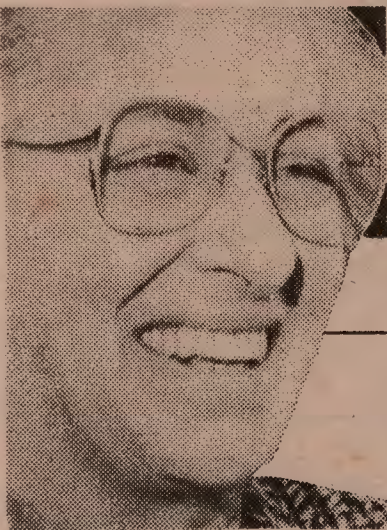

AIPAC won't press Reagan on Saudi weapons sale, despite opposing it

WASHINGTON (JTA) — The American Israel Public Affairs Committee, while opposed to President Reagan's proposed \$354 million sale of missiles to Saudi Arabia, will not actively lobby against the sale in Congress, AIPAC sources said. The AIPAC decision was officially disclosed to Secretary of State George Shultz by Thomas Dine, AIPAC's executive director, according to the sources.

This move follows the announcement by the Israeli government earlier this month that it will not actively campaign against the proposed sale.

Most observers here see the decision by both Israel and AIPAC as aimed at not wanting to damage the present good relations between Israel and the United States over an issue that is considered only marginal to Israel's security.

The AIPAC sources said they believe they could have obtained the votes in both Houses of Congress to block the sale. But they stressed that the threat posed to Israel by the missiles was "not proportional" to the cost of a fight against the sale.

AIPAC Defeats Arms Sale

WASHINGTON—President Reagan has decided to indefinitely postpone his proposed \$1.9 billion arms sale to Jordan in the face of overwhelming opposition in Congress.

The controversial package, which included anti-aircraft missile systems and advanced jet fighters, was supposed to be decided by Congress by March 1. Late last year, the administration had postponed an earlier vote on the matter.

Last week, however, administration officials said that Reagan has decided to effectively scrap the sale "for the time being." The decision represents a major setback for the administration, which earlier had strongly defended the package. It was largely seen as a victory for Israel and its friends in Congress.

Secretary of State George Shultz, Secretary of Defense Caspar Weinberger and other senior administration officials were described as very disappointed over the decision. They privately expressed fear that it would further undermine the peace process and drive Jordan and other more moderate Arab states away from the United States.

THE PRESIDENT had been advised by both Sen. Richard Lugar (R-Ind.), chairman of the Foreign Relations Committee, and Sen. Robert Dole (R-Kas.), the Senate majority leader, that the sale almost certainly would be defeated in a roll call vote.

Israel and its supporters on Capitol Hill, led by the American Israel Public Affairs Committee, the major pro-Israel lobbying organization, had organized a massive amount of resistance to the sale. Some 270 members of the House and 80 senators had already signed opposition resolutions.

White House officials said they were probably going to have to further delay consideration of a new \$1 billion arms package for Saudi Arabia as well, given the strong congressional opposition.

As part of a face-saving formula, the administration has not completely canceled the Jordan sale. Instead, it has simply informed the Senate and House leadership that the matter was being dropped for now. Administration officials insisted the president had the right to revive the package at some point in the future.

State Department officials meanwhile were bracing for a very negative Jordanian reaction. They raised the possibility that King Hussein might now seek similar weapons from Britain, France or perhaps even the Soviet Union. But congressional opponents of the sale insisted Jordan did not have the money for such sales and that Saudi Arabia, given its own financial crunch, was unlikely to finance them. The United States had been expected to finance much of the ill-fated sale.

Saudi arms plan scrapped

WASHINGTON (JTA) — The Reagan administration, forced into suspending the \$1.5 billion Jordan arms deal, has also decided to scrap plans for a \$1 billion arms sale to Saudi Arabia.

Deputy State Department spokesman Charles Redman said this week that "We expect our security relationship with the Saudis to continue, but there is at present no major new arms program in the pipeline."

Members of both houses of Congress had voiced strong opposition to the Jordan sale and it was widely assumed that the fate of the Saudi package would hinge on that of the arms deal for Jordan.

Linked Donations?

Political Contributions From Pro-Israel PACs Suggest Coordination

Groups' Leadership Overlaps With That of AIPAC, A Lobbying Organization

It Denies a Linkup in Giving

WASHINGTON — When Idaho Senate candidate John V. Evans decided he needed to raise big out-of-state money for his race last year, he went to the American Israel Public Affairs Committee, or AIPAC, one of Washington's most powerful lobbying organizations.

Despite the initials in its name, "AIPAC emphasized constantly that they were not a PAC (political action committee)," which gives money to candidates, says Mr. Evans, a Democrat and former governor. "But they noted that there were Jewish organizations all over the country that had their own PACs and that if we would contact them, they would be able to help us."

Indeed, AIPAC did much better than an ordinary PAC could do for Mr. Evans. By federal law, a PAC is limited to a maximum contribution of \$5,000 per race, and groups that coordinate their spending are counted as one PAC under this limit. But AIPAC steered Mr. Evans to a series of supposedly independent organizations—

\$2,000,000 in Federal Funds For Jewish Refugee Program

U.S. Senator Alfonse M. D'Amato (R-NY), member of the Senate Appropriations Committee, today announced the awarding of a Department of Health and Human Services (HHS) grant of \$2,000,000 for the refugee resettlement program of the Council of Jewish Federations.

"These funds represent the ongoing commitment to providing for Jewish refugees seeking a better life in America," said D'Amato in announcing the award. "Most of the recent refugees are settling in New York City, and it is important that they have the resources to start their new lives."

"These funds will contribute substantially to the resettlement program, allowing the Council of Jewish Federations to continue to provide for the refugees in the exemplary tradition they have established," the Senator added.

Most of the recent Jewish refugees coming to the United States have emigrated from the Soviet Union and Iran, with over 40% of them settling in the New York City area.

many of them run by people with ties to AIPAC—that gave him \$204,950 for his losing race against Republican Sen. Steve Symms.

According to a computer-aided analysis of 1986 Federal Election Commission reports, despite AIPAC's claims of non-involvement in political spending, no fewer than 51 pro-Israel PACs—most of which draw money from Jewish donors and operate under obscure-sounding names—are operated by AIPAC officials or people who hold seats on AIPAC's two major policy-making bodies. The study shows that 80 pro-Israel PACs spent more than \$6.9 million during the 1986 campaigns, making them the nation's biggest-giving, narrow-issue interest group.

The analysis shows that three of seven "regional chairpersons" at AIPAC direct PACs and 26 more PAC chairmen or treasurers sit on AIPAC's 131-member executive committee, which meets four times a year and sets overall lobbying strategy. Twenty-two more PAC leaders hold seats on a second, advisory body, the 200-member national council.

Similar Spending Patterns

While the pro-Israel PACs represent diverse and supposedly bipartisan Jewish communities in almost every major city and region in the country, their spending patterns are remarkably similar. For example, of \$3.9 million given directly to candidates, the pro-Israel PACs focused their power on three Senate races, spending \$642,000 on Democrats in South Dakota, Idaho and California. In these races, only one \$5,000 donation went to a Republican.

AIPAC leaders, including its executive director, Thomas A. Dine, refused repeated requests for interviews on the group's relationship with the pro-Israel PACs. Reading from a prepared statement, an AIPAC spokeswoman says the group "denies most forcefully that any such (spending) coordination occurs," and insists that the interlock with pro-Israel PAC leaders "is a function of the nature of political activism and in no way connotes affiliation or connection."

But the overlaps between the organization and the pro-Israel PACs begin at the top. For instance, the Los Angeles-based Citizens Organized Political Action Committee was founded by the wife of AIPAC's chairman, Lawrence J. Weinberg. And Citizens Concerned for the National Interest, located in Chicago, was started by Robert H. Asher, AIPAC's president. Neither could be reached for comment.

Both AIPAC and the pro-Israel PACs were keenly interested in the tight 1986 California Senate race between incumbent Democrat Alan Cranston, a staunch supporter of Israel, and Republican candidate Edwin Zschau. Last September, three AIPAC staff members—regional director Murray Wood, lobbyist Dan Cohen and intern Michael Tuchin—met at AIPAC's Los Angeles office with Breck McKinley, a Libertarian Party candidate.

Anti-Zschau Strategy Alleged

During the meeting, according to Mr. McKinley, Mr. Cohen offered to get him a campaign manager and to finance a direct-mail campaign for him in heavily Republican Orange County. Mr. McKinley, who at that time had earmarked \$350 to spend on his campaign, asserts that Mr. Cohen's "stated purpose was to get Zschau" by siphoning votes away from him. After considering the offer, Mr. McKinley says, he decided to reject any assistance.

Messrs. Cohen, Wood and Tuchin didn't respond to phone calls on the subject. Meanwhile, AIPAC's spokeswoman confirms that a meeting took place, but calls it a "routine" contact that AIPAC staff members make with many candidates and asserts that no offer of campaign aid was ever made.

The race that experienced the biggest

influx of pro-Israel PAC money was the Senate race in South Dakota, where Democratic Rep. Thomas Daschle's successful campaign received \$229,480. The PACs and people associated with them spent another \$91,000 to help the state's Democratic

Party finance an unprecedentedly lavish get-out-the-vote drive, including computerized voter lists, statewide phone banks and paid operatives who scoured remote Indian reservations for Democrats needing a ride to the polls.

The effort on behalf of Mr. Daschle infuriated Stanford M. Adelstein, a Rapid City developer, a former AIPAC executive committee member—and a Republican. "I'm angry. I really, in a sense, gave up on AIPAC," says Mr. Adelstein, who estimates that half of the state's 150 Jewish families are Republican.

Mr. Adelstein says he went to great lengths to get Jewish contributors to listen to incumbent GOP Sen. James Abdnor, and he helped arrange the senator's mid-campaign trip to Israel, where Mr. Abdnor promised to soften his long-held stand against all foreign aid. But Mr. Abdnor was unsuccessful in stemming the flow of funds to his opponent.

Mr. Abdnor wasn't the only target of pro-Israel money to visit Israel last year; Mr. Zschau and Sen. Symms also made trips there and had warm praise for Israeli leaders and their prospects for future U.S.

aid. The pro-Israel PAC money, however, went almost unanimously against them.

Leaders of the pro-Israel PACs who also hold high positions in AIPAC deny that their two roles overlap. What happens with the campaign money, they insist, is the result of local PACs making entirely independent decisions. For instance, Jeffrey L. Berkowitz, the head of the Miami-based National Action Committee PAC and a member of AIPAC's executive committee, says that when the committee meets in Washington, matters involving the pro-Israel PACs never come up.

"We don't discuss that. It happens to be illegal to work cooperatively. We discuss politics in general terms," says Mr. Berkowitz, a lawyer and real estate developer. He says it is a "coincidence" that his and the other 28 PACs represented on the executive committee so often agreed on what candidates to back. "I don't give a damn what the other PACs are doing. When I lobby I do it on behalf of 400 members of NACPAC," he asserts.

"AIPAC is not involved," says Betty Chrustowski, a member of AIPAC's execu-

Who Is The Most Powerful Jew In America

Most people would answer, Henry Kissinger. That is close but there is one shadowy Jew who holds tremendous POWER BEHIND THE SCENES. We are no longer afraid to recognize that we are indeed a powerful political force in America. We are no longer paralyzed by charges of 'dual loyalty.' We seem finally to appreciate that overcaution and reticence validate rather than disprove the canard that there is something wrong in Jewish political power. Indeed, we would rather be criticized for being too strong than ignored for being too weak!"

The Wall Street Journal charges that Dine and AIPAC violate U.S. law by directing the Jewish political PACs. Still, there is no one in the Justice Dept. with the courage to investigate AIPAC. Today, Dine has a staff of 45 Jews working out of a large office located at 500 North Capitol St., N.W., Washington, D.C., 20001, phone No. 202-638-2256. AIPAC has a budget of over \$4 million.

Jewish Lobby Controls The U.S. Congress

American Jewish Committee leader, Hyman Bookbinder, is quoted in the "Atlanta Jewish Times" of Dec. 11, 1987, as saying: "We've gotten 90 to 95 percent of Congressional votes on some pro-Israel issues. In half of those politicians' districts, there aren't enough Jews to talk about."

How can this be: What sinister force has been quietly working away, out of the light of public attention, undermining the independence of the Congress?

Why are so many in the Congress held in mortal fear by the Jewish Lobby and the Jewish Political Action Committees, (PACs)? The chief reason is the vast organizational structure the Jews have established in America and their ability to combine together for a "Narrow-Issue" pro-Israel political goal. Note the chart from the Wall Street Journal. It says there exist 80 Jewish PACs. They are larger and more powerful than the AMA, NRA or Real Estate PACs.

The law prohibits any single PAC from donating more than \$5,000 to a single candidate. So the Jews cleverly evaded this law by forming 80 PACs. EACH ONE CAN NOW GIVE THEIR "CHOSEN" CANDIDATE \$5,000 for a total possible amount of \$400,000. On top of this individual Jews can, on their own, give \$2,000 each.

The Wall Street Journal reports that Jewish PACs donated \$229,480 to help left-wing Rep. Thomas Daschle defeat conservative GOP Sen. James Abdnor in South Dakota. This is a state with very few Jews and nearly all of this PAC money came from Jews residing OUTSIDE South Dakota. The Jewish PACs raised \$6,931,718 in 1986 to strengthen their control over the Congress.

tive committee who also is treasurer of Badger PAC, which operates in the Milwaukee area. "This is a community PAC." Ms. Chrustowski admits, however, that she is aware of the donation patterns of the other pro-Israel PACs. "When you're politically active you kind of get a feel for what's going on."

"I've never been in a meeting where we discuss who we're endorsing and why

we're endorsing," explains Donald G. Linker, a member of AIPAC's executive committee and the chairman of the San Franciscans for Good Government PAC during the 1986 campaign. "Because of my role with AIPAC I'm better informed. It's just like being informed citizens and taking information from one organization and giving it to another."

Special Privileges Increase Foreign Aid To Israel

Aid To Israel Shocks Americans

The vast sums of Foreign Aid we give Israel is so far out of balance that very few realize how enormous it is. The truth is in fact mind boggling.

This article appeared in the "Jerusalem Post" of Dec. 19, 1987. It reports that Israel has more excess cash reserves than ever before in their history. The Jews have \$5.32 billion in reserves and this increased by \$907 million in one month! Note that "the public was engaged in a spending spree."

This is because, a nation which should be one of the world's poorest countries, is actually one of its richest because we American taxpayers have bailed them out! Because of the budget crisis all countries receiving U.S. Foreign Aid were notified that they would be cut 14% from what they got last year. But, a special exemption was made for Israel and Egypt. America "bought off" Egypt at the Camp David Accord whereby they promise to keep Israel's Southern border secure in return for vast sums of U.S. Foreign Aid.)

JERUSALEM — Amid all the talk about cuts in foreign aid from the U.S. for Israel, Defense Minister Yitzhak Rabin said that despite the budget talks in Washington he assumed that funds for Israel would not be slashed.

Israel Will Not Return Aid

TEL AVIV (JTA) — Finance Minister Moshe Nissim said that Israel would not voluntarily give up any part of American military aid.

According to Nissim, Israel is fully entitled to both economic and military assistance from the United States.

He spoke at the annual seminar of the Treasury's budgets department and was referring to speculation by the news media that Israel might willingly forgo about \$80 million of the \$1.8 billion of promised American military aid this year as a gesture toward Washington's efforts to cut the federal deficit.

The defense ministry denied any such intention. The Cabinet reportedly agreed that Israel will insist on receiving its American aid package in entirety.

Israel embassy spokesman noted that economic and military aid was part of a formal American commitment to Israel.

Boost from U.S. aid

Israel's foreign currency reserves reached \$5.32 billion, their highest level ever, at the end of November and an increase of \$907 million from the previous month, the Bank of Israel announced.

While the reserves reached record heights, the public was engaged in a spending spree, tax figures released yesterday by the Treasury also showed.

The large increase in the reserves figures was due to \$1.2b. of American civilian aid transferred to Israel for the year ending in October 1988. Part of that sum, some \$300m., was used by the government to repay debts

Special Exemption For Israel

The plan to exempt Israel from the regulations was backed by Sens. Daniel Inouye (D-Hawaii) and Robert Kasten (R-Wis.), the chairman and top ranking Republican of the State counterpart to Obey's subcommittee.

"Obey went ballistic," said that source, who also predicted the issue "will be revisited."

Obey's office did not return phone calls following the move.

Obey is a key member in Congress on legislation affecting Israel and is regarded as an independent thinker, especially on budget issues.

Israel has so far not agreed to the regulations, arguing that they would cause it an accounting nightmare, an Israeli embassy official said.

Israel Wants Exemption From Record Keeping

In Oct. 1986 the Congress passed a law which simply required all nations receiving Economic Support Foreign Aid to keep records. We want to be sure the money is properly and legally spent. Israel's leaders were outraged and became the only recipient nation to flatly refuse to sign the agreement.

Israel's Finance Minister, Moshe Nissim, asked that his nation be "exempt" from the rule. He said: "This is an important matter for us. Instituting such changes would set Israeli banking practices back some 30 years."

What kind of "banking practices" do they have? Does Nissim mean they keep no record of what happens to the money we give them? Israel's two chief aids in the Congress, Sen. Kasten and Sen. Inouye, came to their rescue and worked out a "compromise." It makes the Jews above U.S. Law by exempting them from keeping records on what happens to U.S. Foreign Aid. Thus we have more special privileges for the "self-chosen" people.

Tax Exempt Funds Not For Jewish Settlements

The U.S. Internal Revenue Service has a special rule making Israel the only foreign nation receiving tax exempt donations from the U.S. This was passed after much lobbying and pressure from Jewish groups. There is just one provision which prohibits such funds from being used to develop Jewish settlements in the Palestinian West Bank.

The United Jewish Appeal, Jewish Agency and United Israel Appeal all spend money in the West Bank. Irving Kessler, on Dec. 19, 1987 announced to the Jewish groups that they should ignore the law and deduct such donations from their taxes anyway. He believes that no one in the IRS would have the guts to challenge them.

Rockefeller Backs "Free Trade" With Israel

By YITZHAK RABI

Israel is becoming an "economic bridge" for American and European trade as a result of its trade agreements with both the United States and the Common Market, Israeli Minister of Economy and Communications Gad Ya'acobi said at the conclusion of a recent 12-day visit to the United States.

Addressing a conference here on the U.S.-Israel Free Trade Area Agreement, Ya'acobi said, "American firms can export to the European market through Israel at lower cost, if a certain percentage of the exported product is produced in Israel, and vice versa. This potential is beginning to be realized, as many companies have begun studying this possibility."

Ya'acobi said that since the signing of the Free Trade Area agreement in 1985, there has been dramatic growth in Israeli exports to the United States.

(Para. 1) "In 1985, for the first time, Israel exported more to the United States than to the European Common Market. This trend is continuing this year," he said. Israel had a civilian balance of trade surplus with the United States of \$558 million in 1986, he pointed out.

(Para. 2) "In 1986," Ya'acobi said, "Israeli exports to the United States were over \$2.3 billion, or approximately one-third of Israel exports. Civilian imports from the United States were about \$1.8 billion, or about one-sixth of the total."

(Para. 3) The Israeli minister said his country's goal is to increase Israeli exports to the United States to \$5 billion in the next five years.

"We can reach this goal if we learn to function in the American marketplace and place greater emphasis on product quality," he said.

(Para. 4) David Rockefeller, chairman of the New York Chamber of Commerce, said that Israel-U.S. economic relations are expanding significantly as a result of the Free Trade Area Agreement. He echoed Ya'acobi's point that one aspect of the agreement is increased possibilities for American exports to Europe through Israel.

(Para. 5) Andrew Stein, the New York City Council president, told the conference, which he helped organize, that "New York City will be the first to reap the rewards of increased trade with Israel, and the rewards are likely to be substantial."

The conference, co-sponsored by the American-Israeli Chamber of Commerce, the New York Chamber of Commerce and Stein, brought together leading manufacturers in New York and Israel as well as government trade officials, about 200 people in all. They shared knowledge and information about the opportunities created for both United States and Israeli businesses by the Free Trade Area Agreement.

Investing in Israel called wise move

WASHINGTON (JTA) — With tariffs and other trade barriers gradually being phased out under the U.S.-Israel Free Trade Area Agreement, businesses here would be wise to invest in Israel now, according to Deputy Commerce Secretary Clarence Brown.

Since most of the trade barriers between the two countries will be eliminated by 1989, "you can beat your competitors by expanding trade with Israel now," Brown told a recent conference here marking the second anniversary of the trade pact.

The two-day conference was hosted by Ariel Sharon, Israel's minister of commerce and industry, and the U.S. trade representative, Clayton Yeutter. The meeting was sponsored by the Israel-Amer-

ica Chamber of Commerce and Industry, the Israel Export Institute and the Israeli embassy.

More than 350 businessmen, about one-third from Israel, attended the conference to discuss ways the trade agreement can help their companies in trade between the two countries.

Most of Brown's speech was spent extolling the benefits of Israel to U.S. investors. He noted that Americans are now more interested in investing in Israel because of improvements in the economy, which is showing growth for the first time in years.

Brown added that the U.S. Department of Commerce has been participating in seminars throughout the country to explain the opportunities the Free Trade Area Agreement offers U.S. businessmen.

"The feedback is very good," he said. "There has been a great increase in inquiries and interest in doing business with Israel."

Bush Writes Off Jewish Vote

WASHINGTON — Vice President George Bush may have decided to sacrifice Jewish support for his presidential election bid in an effort to neutralize the political fallout from the Iran-contra scandal, say Jewish political observers here.

Bush, it was noted, insisted during his recent broadcast tussle with CBS News anchorman Dan Rather that the arms sales "were an operation in the hands of a foreign power." Analysts say this was a continuation of a Bush effort to shift blame for the arms-for-hostages affair from himself onto Israel.

"It's noteworthy that the only major reservation that the vice president has had about this affair — at least publicly — was Israel's role," said Dan Mariashin, communications director for one of Bush's GOP rivals, former Gen. Alexander Haig. "I would ask this question to the vice president: Why did he feel it was only Israel's role he had to bring up?"

Mariashin also suggested that Bush "wants it both ways. On one hand, he wants to position himself as a staunch friend of Israel and on the other, at the first opportunity, he's trying to call into question Israel's role."

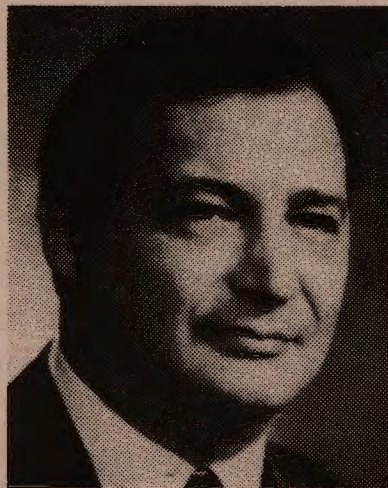
Other analysts go even further. "I think it had to be a conscious decision to write off the Jewish vote," said an official with a major Jewish organization here. "[Bush] claims that he met with Amiram Nir, but didn't realize what he was talking about. I find this very hard to swallow, in light of his considerable experience in government."

Other observers note that Bush never has enjoyed particularly strong support from the Jewish community and that, in any case, Jewish support is not a crucial factor in Republican presidential primaries.

Facts Prove Leo Frank Murdered Mary Phagan

THE NBC-TV docudrama, "The Murder of Mary Phagan", led some people to believe that Leo Frank was the victim of "prejudiced Southerners who lynched an innocent Jew." Here is the evidence in the case upon which the jury found Leo Frank guilty of First Degree Murder!

Leo Frank was born in Brooklyn, N.Y. of Jewish parents who came here from Russia. The Jewish Strauss family owned the National Pencil Company in Atlanta. They hired Frank, age 29, to be the manager of the factory. Most of the employees were young women who earned only \$1.20 per week in what was acknowledged to be a "sweat shop."

Frank was prominent in the Atlanta Jewish community as the president of B'nai B'rith, (the secret Jewish businessmen's fraternity), and a member of the synagogue. Frank was known as a "letcher" at the pencil factory by the Christian girls who worked there. He would often try to fondle the girls and entice them to meet him privately at the office. A local prostitute told police that he was a regular customer who was sexually perverted. Frank would ask the factory janitor, Negro Jim Conley, to watch for him on the first floor. Conley would rap on the wall if someone was coming while Frank was "entertaining" a female in his second floor office.

Evidence From the Trial Proves Leo Frank Guilty

(No. 1) April 26, 1913 was Confederate Memorial Day. Little 13 year old Mary Phagan wanted to see the parade with her boy friend George Epps. But first she had to go by the pencil factory to pick up her wages of \$1.20. A girlfriend had offered to take Mary's money home to her but Frank said, "No!" She had to pick it up in person.

Mary Afraid of Frank

(No. 2) The factory office boy, Alonzo Mann, testified that he left the factory at 11:30. He had not seen Mary Phagan. Mann was a defense witness for Frank. George Epps, 15, Mary Phagan's boyfriend testified that Mary was supposed to meet him to watch the parade. She told him that she was afraid of Frank as he tried to get her into a corner at times and make passes at her.

Frank Not To Be Found

(No. 3) At 12:00 Mary arrived at the factory and went to the second floor. At exactly 12:05 Miss Monteen Stover came to pick up her pay. She went up to the second floor. Mary was not there - Leo Frank was not there!

(No. 4) Jim Conley testifies that Frank called him to come up to the second floor. He told him that Mary was dead. Conley said

Frank was holding a cord of cloth in his hand and was shaking. He asked Conley to help him carry the body to the basement. Frank gave Conley \$200 to cremate the body in the furnace. Conley left to get fuel, but got drunk, and never returned.

(No. 5) At 1:10 PM Frank tires of waiting for Conley to return and goes home. But, Frank comes back to the factory at 3:20 PM and waits for the night watchman to arrive at 4:00. Negro Newt Lee is surprised to find Frank at the factory because he never works on Saturday nights. Lee testifies that Frank appears very nervous. Frank sends Lee away and to come back later.

Frank Is Shaken

(No. 6) Newt Lee returns, ready to work at 6:00 PM along with a discharged White employee, Bill Gantt. Gantt wanted to pick up a pair of work shoes he left as he had been fired the day before. Both Lee and Gantt testify that Frank was shocked to see both of them and jumped back shaking from nervousness.

Frank Phones Nightwatchman

(No. 7) Frank arrives home. The maid later tells police that Frank was so nervous he couldn't eat dinner and retired to his room. At 6:30 PM he phones night watchman Lee, "to see if everything at the factory is OK." He had never called Lee in the past with such concerns. At 7:00 he phones Lee again but there is no answer. At 7:30 he phones Lee once again with the same question. Lee wonders what Frank is worried about!

(No. 8) Mrs. Frank's relatives arrive to play cards. But, Frank is too nervous. He can't play and retires to his room.

The Body Is Found

(No. 9) At 3:00 AM Lee is making his rounds at the factory. His light spots something, it is a head matted with blood and charcoal! Its a grisly sight - Lee lets out a scream and runs to phone the police. The police find little Mary with a hole in her head and strangled with a cord of cloth. Also, they report, she had "suffered violence to her sex organs."

(No. 10) Early in the morning the police arrive to question Frank. He opens the door, looks startled, and asks, "what is wrong at the factory?" THEY HAD NOT MENTIONED THE FACTORY! Frank is very nervous and insists on dressing in his best suit before going with the police.

(No. 11) The coroner, Dr. Harris, places Mary's death at between 12:15 and 12:30 of the day before. This is the period when Miss Monteen Stover could not find either Mary or Frank in the second floor office. The large work room behind Frank's office is the location of the pencil making machines. There, in one corner, the detectives found traces of blood

Gentlemen:

Reference is made to your comments on the morning news at about 8:15 a.m. this morning concerning NBC's The Murder of Mary Phagan. I hasten to write you that it is not only the Phagan family who is protesting the distortions and non-factual presentation hashed up by NBC in this miniseries. The Phagans, like the rest of us who have some knowledge of the case, are not suggesting that NBC was not "exactly" accurate in its rendition but rather that the program turns the case upside down, libels the Phagan family, Hugh Dorsey, Tom Watson (my great-grandfather) and assorted witnesses in the case, and conceals the evidence that convicted Frank and Governor Slaton's scandalous conduct.

Most dramatically, the series refuses to reveal to the audience Governor Slaton's active partnership in Rosser, Brandon, Slaton & Phillips, the law firm leading Frank's defense. Watson and Dorsey did not urge Slaton to review Frank's petition for clemency. Rather, they pressed on him - because of the outrageous conflict of interest - that he not review the petition but rather let it go over to the incoming Governor, "Nat" Harris. Slaton did not conduct the clemency hearings portrayed in the movie, which would have constituted a retrial without sworn testimony, benefit of counsel, cross-examination, etc. No such hearings took place. However, he did confer at length with his partner Luther Z. Rosser the night before issuing the commutation order.

In addition, much of the evidence of Frank's guilt presented to the jury is omitted or muted in this "docu-drama", such as his refusal to send Mary Phagan's pay home by a neighbor, his erratic and wild behavior when he reached home the night of the murder, etc. Frank's wife's refusal to visit him in jail for weeks after his arrest is reversed in the NBC film, as is her physical attractiveness.

Tom Watson was not a political "boss" and had nothing to do with the Frank case until a year after Frank's conviction, when he began to respond editorially in his Weekly Jeffersonian to the attacks on Georgia by the Northern Press.

Hugh Manson Dorsey was not a dishonest district attorney (he was Fulton County Solicitor, not Solicitor General of Georgia as the film depicts) who railroaded an innocent man by suborning perjury of witnesses. Rather, he was a courageous prosecutor who prevailed over Atlanta's best lawyers in a hard-fought five-week trial, the then longest in Georgia history.

Mary Phagan's father was not the "linthead" living off his daughter's wages in 1913 as portrayed by NBC. He died in 1899, some 14 years before his daughter's rape-murder.

Governor Slaton had already lost his race for the U.S. Senate in 1914, a year before he signed the commutation order. Hence, he had no political future to sacrifice.

In short, NBC's production does not even approach historical accuracy. Obviously, little, if any, attempt was made by the producers at research into the Phagan-Frank case, despite the plethora of factual material readily available to them.

It is deplorable that a great television network has so little regard for factual presentation, historical accuracy or indeed, common decency.

When the Jewish ADL made their first move in 1984 to win a

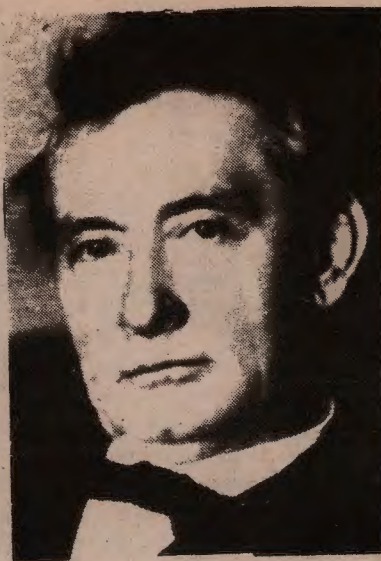

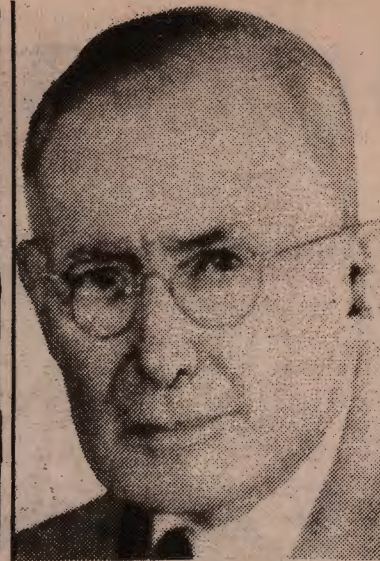
The posthumous pardon for

Frank Case Determined The Future of Georgia Politics

The aftermath of the Frank case was far reaching and is felt even to this day. The NBC-TV show cried that Gov. John Slaton's commutation of Frank's death sentence on June 2, 1915 wrecked his political career. But it was a year earlier, in 1914, when Slaton was defeated in his race for the U.S. Senate. Thus, the truth is that Slaton was a "lame duck" Governor whose political career had ended. The people of Georgia were so outraged over Slaton's saving Frank that he had to flee the state. Slaton lived in Alaska until 1940.

But, the Frank case saw the prosecutor Hugh Dorsey elected Governor by a landslide in 1916. Also, Tom Watson was elected to the U.S. Senate where he found "Rural Free Mail Delivery." His weekly magazine, "The Jeffersonian" zeroed in on the New York Jews who sought to buy

Frank's way out of prison. Watson exposed the fact that Chicago Jew advertising magnet, Albert Lasker, donated over \$100,000 to hire famed lawyer Louis Marshall to fight Frank's appeal to the U.S. Supreme Court.

The Jews have never forgiven Tom Watson. In fact, Stu Lewengrub, head of the Atlanta Jewish ADL, has declared that he will not rest until the huge statue of Tom Watson which graces the entrance to the Georgia State Capitol, is torn down!

Two weeks later a group of Marietta, Ga., residents traveled to the state prison in Milledgeville, Ga. There they cut the phone lines to the prison. They tied up the guards and seized Frank. He was taken to Marietta and hanged near the present intersection of Roswell Rd. and I-75.

Not far from this spot in the Marietta National Cemetery is the grave of little Mary Phagan. Her tombstone bears these words: "May God bring the man guilty of this terrible crime to justice!" The will of the jury - the will of God - had finally been carried out by the people of Georgia.

and Paris. The Leo Frank family hired the law firm of "Rosser, Brandon, Slaton and Phillips." The attorney Slaton just happened to be Georgia Gov. John M. Slaton. The NBC-TV show had Christians in front of the courthouse shouting "HANG THE JEW." Such events never occurred. One incident exposed the true attitude which many Jews hold toward Christians. It was an outburst by Leo Frank's mother against prosecutor Hugh Dorsey.

"You Gentile Dog"

The Jew Harry Golden mentions this in his book, "A Little Girl is Dead." (The NBC story is based on this book.) Golden says Frank's mother jumped up in the courtroom and shouted, "You Dog" at Dorsey. The trial transcript reads that she shouted, "You Gentile Dog!"

In two years of appeals, both the Georgia Supreme Court and the U.S. Supreme Court rejected Frank's appeal. Then Gov. Slaton saved Frank from the hangman's noose by commuting his sentence from death to life in prison.

The public was outraged! Slaton was about to leave office and could easily have left the decision to the next Governor. But, Slaton was a law partner in the firm which was

A Torture Murder

(No. 12) The Coroner found that little Mary had been struck so violently that there was a hole in her head left by a hammer. A piece of her undergarment was around her neck. It was so deeply imbedded in the throat that her eyes bulged and her tongue protruded one-and-a-half inches out of her mouth. It was a sadistic torture murder! One of the most grisly ever committed in Georgia!

(No. 13) Conley testified that Frank dictated a note which Conley wrote seeking to place the blame on the night watchman, Newt Lee. During the trial Frank sought to use this to first claim Lee did it and next that Conley was guilty. But the jury was reminded that never before in history, (or even since that time), has a black murdered someone, then sat down, and writes a letter naming a third party as the killer! A Negro would simply run away from the crime scene.

Trial Is A Slander Against All East Europeans

Trial Evidence Proves Demjanjuk Innocent

The overwhelming preponderance of the evidence in the one-year long trial of John Demjanjuk has proven him totally innocent. When the trial opened on Jan. 16, 1987 the following charges were read over nation-wide TV in Israel against Demjanjuk.

"Demjanjuk stood at the entrance of the gas chambers armed with a sword, bayonet, whip or iron pipe and would force his victims into the gas chambers while tormenting them on the way to their death."

"With the weapons in his possession, the accused stabbed his victims in various parts of their bodies, tore pieces of flesh from their limbs and injured them with great force before he turned on the motor that pumped in the gas. He often used a knife to slice off the noses and ears of the prisoners with the sword or bayonet. He also shot prisoners, beat them to death or strangled them on barbed wire fences."

Treblinka existed only from 1942 through 1943. Demjanjuk was age 22 and 23 at the time and could speak very little German. Does it make any sense at all that the German's would put such a young boy in charge of such a vast operation as gassing 850,000 Jews??? Even the charge itself boggles the imagination.

It should also be noted in the Germans favor that no remains of any gas chambers, (or plans for one), has ever been located at the Treblinka area.

Additional Evidence Proves Demjanjuk Innocent

Famed British scientist, Dr. Julius Grant, told the court that Demjanjuk's signature had been forged to the "SS Identity Card" which Soviet agents so conveniently furnished the Jewish prosecution. Dr. Grant gained fame by exposing the so-called "Hitler Diaries" as a forgery. He is the author of 28 books on forensic science and is a member of the faculty of the University of London.

Documents Expert, Dr. Edna Robertson, of Panama City, Fla., testified that the Soviet supplied, "SS I.D. Card" photo of Demjanjuk had been substituted for an original photo of another person. She also testified that the signature of Demjanjuk had been forged by the Soviet KGB.

Records of the Trawniki camp where Demjanjuk supposedly was trained and given the "SS card" have been found. Of the 4,000 men who went through the camp training Demjanjuk's name cannot be found. Of those who were sent from Trawniki to Treblinka to serve as guards - Demjanjuk's name cannot be found!

Avraham Shifrin is a Jew who was a "law officer" for the KGB when he lived in Russia. He testified that the KGB operates a secret section which manufactures false documents against Ukrainian dissidents. Their object is to discredit Ukrainian Patriots as "Nazies" in order to undermine the Ukrainian liberation movement both in Russia and in the free world.

Attorney Chumak charged that "the entire case may be a KGB provocation." He reminded the court that the KGB has the power to create "perfect forgeries against ordinary people."

The OSI Works With The KGB and MOSSAD

Brooklyn District Attorney Elizabeth Holtzman came up with the idea of having Congress establish the "Office of Special Investigations" inside the U.S. Justice Dept. At the time she was a Congresswoman in 1974. Her bill to set up the OSI was adopted by a unanimous vote by both the House and Senate.

Miss Holtzman argued that there were over 10,000 war criminals running loose in America and they had to be punished. Thus the OSI has a taxpayer paid budget running into the millions of dollars and a staff of 45 lawyers and secretaries. (Note, 34 are Jews!) This is actually a special Jewish secret police agency working inside our government!

Pat Buchanan Leads Fight Against The OSI

Pat Buchanan, is a former White House Communications Adviser to Pres. Reagan, a TV commentator and syndicated columnist. Buchanan said: "I don't think there is a need for the OSI. If you have a case that comes to light of a Nazi war criminal here, the Justice Dept. can handle it. I am utterly against collaboration with the KGB. 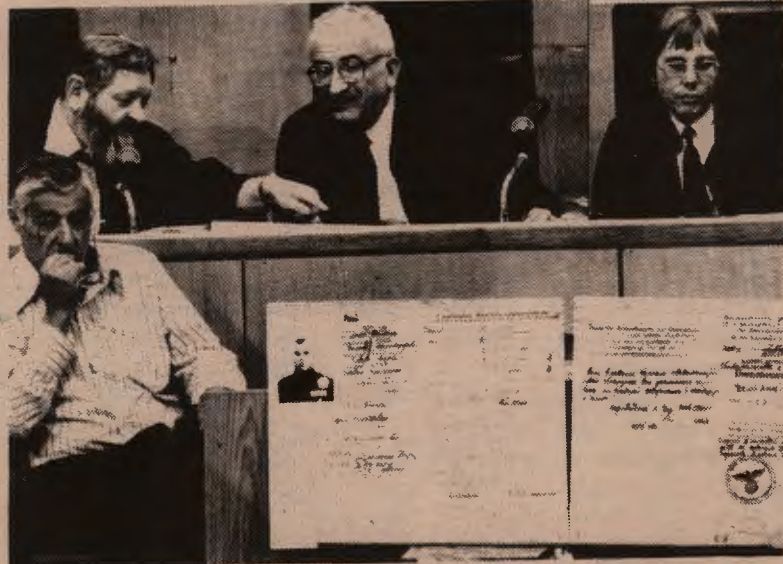

Chief Witness Against Demjanjuk Is A Liar

Eliahu Rosenberg was a chief witness for the prosecution who gave a positive identification of Demjanjuk as "Ivan The Terrible." Rosenberg, a self-proclaimed "survivor" of Treblinka, was discovered to have given Polish Communists a detailed statement in 1945 about the prison revolt in 1943.

Rosenberg was unable to explain to the court how, as an eye-witness to the killing of Ivan the Terrible in 1943, he now finds him alive today! OSI Withheld Evidence Proving Demjanjuk Innocent

With that Mrs. Vera Demjanjuk, age 63, jumped up and shouted in open court at the prosecutor, "You're a liar. Shame on you, Shame on you - you have no heart!"
