Great Right-Wing Victory In France

The French National Front running on an anti-immigration platform shocked all observers by polling 14.4% of the vote in the Presidential election. The press called it "a Thunderclap from the Right" and declared that the face of European politics has been altered for a long time to come. The Front's Presidential candidate, Jean-Marie Le Pen, had been viciously smeared because he stated on a radio show that he doubted any holocaust of Jews ever took place! Organized Jewry charged this was his "fatal mistake" which would hold Le Pen's vote down to perhaps 6.5%. Most newspapers said Le Pen would be lucky to poll 10%.

The *New York Times* admits that Le Pen's surprisingly big vote made him the "Kingmaker" of French politics. Le Pen declared, "We are certain that this is a political earthquake and a radical transformation of the national landscape."

The favored socialist President Mitterand polled 34.1% of the vote, while the conservative Premier Chirac only received 19.6% and the moderate former Premier Barre won just 16.7%. Le Pen, the real underdog, increased his vote from 9% in the last election to 14.4%. Note how close Le Pen's vote is to Chirac and Barre!

The once powerful Communist Party received the lowest vote in its history of only 6.7%. A study found that the growth of Le Pen's party comes from defections from both the conservative party and the Communist Party. The *Wall Street Journal* stated: "The strong showing by Le Pen indicates that the entire French political landscape has shifted considerably to the right, in line with many other countries in Europe."

Huge Throngs Attend National Front Rallies

National Front rallies have been far larger than any other party. In fact, most of the other candidates have held their "campaigning" down to expensive TV ads and interviews with the press. Le Pen received very little such "free" publicity but his gigantic rallies brought out crowds of from 2,000 to 15,000 very enthusiastic supporters! In September the National Front convention attracted over 20,000 people. Time and again Le Pen brought the crowd to its feet with his dynamic speaking style. He called the press, "a machine of subversion and disinformation that uses deliberate lies and illegal, shameful and repugnant tactics."

Israel Made Serious Error In Convicting Demjanjuk

WASHINGTON - "I am not Ivan the Terrible, and to that God is the most just witness. He knows I am innocent."

- John Demjanjuk on receiving the death sentence in Jerusalem.

THE State of Israel will make a grave, irreversible error if it carries out the execution of John Demjanjuk. Not because the crimes with which Demjanjuk was charged do not merit a death sentence; but because the year-long trial of the Cleveland autoworker has not erased, but only deepened, the suspicion that John Demjanjuk is an innocent man.

To believe Demjanjuk is "Ivan the Terrible," the sadistic camp guard of the Treblinka killing field, consider what else we must believe.

We must believe that, within weeks of his capture in the Crimea in 1942, this 22-year-old Ukrainian conscript suddenly transformed himself into the greatest mass murderer that World War II produced.

We must believe that this seemingly docile and decent family man, 45 years ago personally drove into gas chambers the equivalent of the entire population of Pittsburgh and St. Louis; that Demjanjuk then miraculously survived a prisoner uprising in which his death was a primary objective; that, when the SS ordered Treblinka bulldozed into oblivion and all trace of its existence expunged, the Nazis not only permitted the Butcher of Treblinka himself to survive, they let him fall into the hands of the Americans, where his testimony could send them all to the gallows.

But that is not all we must believe. With more blood on his hands than Mengele himself, Demjanjuk then calmly went to work for the Americans, not even bothering to change his distinctive Ukrainian name. And instead of taking the first opportunity to flee to obscurity in South America, he coolly applied for admission to the U.S., to become an autoworker in Cleveland.

Many American veterans of World War II and Vietnam who accidentally killed

women and children have suffered severe pangs of remorse and terrible depression; among them the rates of divorce, alcoholism and suicide are abnormally high.

Can it be that John Demjanjuk personally threw thousands of infants into gas chambers, and shoved thousands of women and children after them, and then exhibited not the least trace of guilt or sorrow to family, friends, co-workers, or fellow parishioners at the Orthodox church where he worshipped? Was his entire life in America a 30-year cover story?

American prosecutors and the audience in Israel were alike astounded at Demjanjuk's lack of remorse, his repeated protests of innocence ("I couldn't kill a chicken!"), his pathetic efforts to befriend the Treblinka survivors testifying against him.

No other Nazi war criminal behaved thus; some were defiant; some cowardly; some defensive, insisting they were only "following orders."

Not Demjanjuk: Either he is among the most sordid sociopaths and greatest actors of our age, or he is an innocent man.

For the way Demjanjuk behaved in Cleveland and behaved in Jerusalem is exactly the way you and I would behave if accused by half a dozen "eyewitnesses" of mass murder. He is a por-

trait in confusion, bewilderment, incredulity. Can this all have been but a brilliant act — for a dozen years?

Why, then, is this man about to die by a hangman's rope in Jerusalem on a gibbet erected for Adolf Eichmann? Because half a dozen "eyewitnesses" testified that Demjanjuk is the same man who, almost half a century ago, stood outside the gas chambers at Treblinka.

Yet, among these eyewitnesses against Demjanjuk, one testified in 1948 that Ivan had been killed in the prisoner uprising; another remembered in Jerusalem the most lurid of atrocities which he somehow forgot to mention at the Cleveland hearing; another testified that he had traveled to Cleveland from Israel "by train."

How can half a dozen "eyewitnesses" be wrong? The same way a dozen "eyewitnesses" were dead wrong when they testified that they personally observed the atrocities of Frank Walus, the Nazi butcher of Kielce, Poland, until hard evidence proved that Walus was a 19-year-old farm worker in Germany at the time, too young, too short and of the wrong nationality even to have belonged to the elite SS unit he was supposed to have headed.

While some of the guards and inmates at Treblinka say Demjanjuk was indeed Ivan, others have turned up to say it is impossible, that Ivan the camp guard was a giant of a man twice Demjanjuk's age in 1942-43, and, besides, Ivan died in the uprising. The court, however, chose for the prosecution.

If John Demjanjuk — whom I believe to be an utterly innocent man — hangs on Eichmann's gallows, it will be Israel that will one day be in the dock, when it is revealed, as one day it surely shall be, that John Demjanjuk was who he had always said he was.

What Does the National Front Stand For?

The cornerstone of the National Front is its opposition to immigration in a nation with 11% unemployment which rises to 15% in Lorraine and Marsallies. Here the National Front polled 30% of the vote - more than Mitterrand or any other party. Le Pen says there are 4 million immigrants in France, (most from Africa), and says that this is 3 million too many. He holds they are the chief cause of unemployment and if 500,000 were sent back home immediately there would be 500,000 more jobs for unemployed Frenchmen. The Front holds that public housing has been turned into slums by the Africans and that the social security fund has been drained by the Africans.

Le Pen also proposes giving French people "priority hiring" over immigrants in all jobs. Another reason he opposes immigrants from Africa is that they are the chief source bringing the deadly disease AIDS into the country. France has a suicidal low birth rate by which they are no longer reproducing their own kind. Le Pen is the only political leader calling for more babies by paying women to stay home and care for their children. Also, French women complain they have often been "pinched and manhandled" by Africans on the street. Le Pen would make this a serious crime. Le Pen would Segregate public schools and hospitals which he now says, "are being overcrowded with people who do not even speak French." The slogan of the National Front is: "FRANCE FOR THE FRENCH!"

Le Pen wants to bring back the death penalty for murder and rape. He says welfare and social security should be for the French people only and not for immigrants. His crowds are made up of working class people, small businessmen and youths - many of whom wear black leather jackets which have become a kind of "uniform" of his party. Le Pen said: "When I am President of the Republic, the foreigners will demand nothing. Our victory will come sooner or later." The crowd leaped to its feet shouting their approval. All his meetings end with a rousing chorus with all in mass singing "La Marseillaise."

No other candidate can even begin to match Le Pen's popular appeal with crowds. This latest victory proves that HE CAN WIN - and this alone assures even more support!

The History of Le Pen And The National Front

Jean-Marie Le Pen, 60, is the son of a fisherman from Brittany. He was a law student in 1956 when he supported anti-tax populist Pierre Poujade. Le Pen was elected to the French Congress on the Poujade party ticket. He was very anti-communist and fought many street battles against the Reds. This cost him his right eye. He served in the Army as a parachute soldier and fought in Algeria. In 1972 Le Pen formed the National Front Party and won only 1% of the vote. In the 1986 election the Front polled 9% and elected 35 deputies to their "Congress." This year Le Pen polled over 4.5 million votes which is an increase of 1.5 million votes.

Le Pen holds that the African immigrants who have flooded France constitute a "Trojan Horse" which will one day destroy their nation unless deported. One key supporter said that people realize that Le Pen is the only candidate "who dares to speak out against Communism!" Le Pen has inspired many others to now stand up above the crowd and organize groups in other countries patterned after the successful development of his "NATIONAL FRONT PARTY."

Win Two Elections In South Africa

Rightists May Take Over South Africa

The Conservative Party has made rapid gains winning 26% of the total vote in South Africa's last national election. They elected 22 members to Parliament thus becoming the second largest party.

Last month two separate by-elections were held. The press reported that the ruling Nationalist Party would win one seat and the Conservative Party might gain the other seat. The Right-Wing campaigned hard arguing that the government is compromising by giving the blacks more and more influence by relaxing the Segregation laws even to the extent of allowing interracial marriage for the first time in 1986.

When the results rolled in the Conservative Party had won overwhelming victories in both election districts. They had tripled their previous vote. This sent shock waves through the left-wing. Even those in Washington who had hoped to bring South Africa to its knees by applying ever stronger economic sanctions now are dismayed. Their plans have backfired and the Right-Wing has now become so powerful they now are poised to take over South Africa!

Le Pen vote alarms Jews

PARIS - The French Jewish community has reacted swiftly and vigorously to the unprecedented showing of extreme rightist Jean-Marie Le Pen in this week's presidential election. Out of 38 million potential voters, Le Pen's National Front garnered 4.5 million or 14.3 per cent of the total.

CRIF "very respectfully and very firmly" asked the candidates not to "try to catch the voices of [Le Pen's] supporters through rhetoric that would copy in one way or another that developed by Le Pen, or through measures that would favour the local, regional or national implantation of the National Front." Paris Chief Rabbi Alain Goldman sees Le Pen as a potential danger to

the Jewish community. "No one can spread theories about immigration without being oneself a racist and an anti-Semite," he told *The Jerusalem Post*.

"On the other hand, no one can say that all those people who voted for Le Pen in the first round are a bunch of bloodthirsty racists and anti-Semites."

Le Pen's showing illustrates a swing to the extreme right. Things started the same way in the '30s in Germa-

Goldman believes that many of The lessons of history have not been learned. But let's not exaggerate, the situation here is not that bad yet."

Feelings in the Jewish quarter are mixed. "When Le Pen reaches 20%, that will be the signal to leave," said one.

Jewish activists in Paris trash two shops that sell anti-Jewish works

PARIS (JTA) - A group calling itself the "Jewish Organization of Combat" took credit for ransacking two Paris bookshops, one specializing in "revisionist" texts that deny the Holocaust occurred and the other in right-wing extremist literature.

The group said it hit the shops to protest the scheduled appearance of Jean-Marie Le Pen,

leader of the far right-wing National Front Party, on a major political program broadcast on French television

Le Pen, in a Radio Luxembourg interview last October, dismissed the Holocaust as a mere "historic detail," but he denies he is anti-Semitic. He recently announced he will be a candidate in April's French presidential elections.

Terre Blanche strode to the speakers platform surrounded by his personal guard called, "The Storm Falcons." He addressed the massed crowd:

"The day is coming when this government will capitulate. The Afrikaner Resistance Movement must build up its strength now because that is the day, the day of capitulation, when we will take over.

We will govern ourselves, just ourselves, without any interference, certainly without the intervention of the international money men.

We don't need the American Coca-Cola culture, we don't need the international bankers, we don't want the Jews. We will govern ourselves with our own White, superior genes. We are hungry for our National White homeland because we promised it to God."

A thunderous roar of approval is shouted by the masses as 600 uniformed supporters drive to the Government building to deliver a petition demanding an end to the appeasement of the communists and blacks.

The Rightists demand that only Whites be allowed to be citizens of the nation with all blacks becoming citizens of tribal nations.

All Segregation laws would be reinstated including the outlawing of interracial marriage. Their strength is growing and this new success is encouraging others in Europe and America to organize similar organizations to ensure the future preservation of the White Race.

Sanctions Hurt U.S. Workers

Sanctions Cost U.S. Coal Miners \$250 Million

The Chamber of U.S. Mines representative, Attorney John Chettle, charged that U.S. imposed sanctions against South Africa have cost American coal miners \$250 million. American and South Africa are two of the world's largest coal exporters. When sanctions were imposed in 1985 South Africa was fearful of losing its world share of 45 million tons of coal which they sell overseas. Thus they began slashing prices to attract new customers and hold on to old ones.

Then other coal mining countries such as Australia, Canada, Denmark and France

Communists Back Israel

U.S. Communist Party Hails Demjanjuk Sentence

The Communist Party official newspaper, "People's Daily World" ran articles in three separate editions hailing Demjanjuk's conviction by the stacked Jewish court. On April 20th, they wrote: "Retired U.S. Autoworker John Demjanjuk was convicted Monday of being the sadistic concentration camp guard who sent thousands of Jews to their deaths. He fired up the engines that fed deadly fumes into the chambers where he murdered over 850,000 Jews."

On April 26, the communist paper wrote: "Demjanjuk has been sentenced to hang for killing 850,000 Jews. He used whips, a sword and a pistol to jam thousands of Jews into the gas chamber before he then turned on the gas."

Demjanjuk was only age 22 at this time and could not even speak German. He would have to kill 12,000 Jews per day, seven days a week, working around the clock straight for two years! Also, there is no evidence of any kind that gas chambers ever existed in this camp! No sensible person could ever believe such a monstrous lie.

Jews Are Crucifying John Demjanjuk

Demjanjuk Sentenced to Hang In Total Frame-Up

American courts require a "change of venue" for an accused if it is felt he cannot obtain an "impartial and fair trial" in the district where charged. In the case of John Demjanjuk, he was stripped of his U.S. citizenship by the Jewish run OSI and shipped into the hostile Jewish state of Israel. There he was tried by a panel of three Jewish judges before a Jewish audience screaming for blood under Jewish law. The audacity of all this is the claim of Jewish leaders and the Jewish press that he received a fair trial and now should be hanged!

On the front page of this issue columnist and TV host Pat Buchanan explains why Demjanjuk should not have been convicted. Here we will study the facts of the trial proving it was one of the most biased and prejudiced trials in history. It is a disgrace to the nation that our courts permitted his deportation and that Atty. Gen. Ed Meese signed the deportation order. An innocent Patriot sacrificed just to appease a small, but wealthy, clique of radical Zionist Jews.

Defense Lawyers Called "Anti-Semites"

The chief prosecutor Michael Shaked, was obviously biased. He accused the defense of employing "anti-Semites as investigators, some of whom not only were not acceptable due to their disgusting reports but also because their hate filled writings were distributed around the world thus creating new hostility towards Jews."

Defense counsel John Gill told the court that eyewitness testimony after a 45 year time lapse was inaccurate evidence. He said that some 20 other witnesses, described someone else who would never fit the description of John Demjanjuk. But, this recorded testimony was concealed by the Jewish run OSI until after the trial.

Gill also cited the case of Chicago Patriot Frank Walus. He was almost deported to the Soviet Union after 11 Jews swore in court that Walus was a member of the German SS and killed Jews. Walus is Polish and new documented evidence was introduced, including witnesses, which proved that he worked on a German farm throughout the war! He was released with no apology from the OSI for their "mistake."

John Gill asked the judges "Don't commit a horrendous crime because taking this innocent man's life is a new holocaust!"

Show Trial's Disgraceful End

The trial of John Demjanjuk was held in a movie theatre seating 500. The trial lasted 14 months and some 250,000 Jews sat in at one session or another for this "holocaust experience." It was broadcast daily over TV and radio to unite the Jews of Israel behind the Zionist state. The reading of the verdict took 10 hours, (which is unheard of). The wife of Demjanjuk, Vera, age 62, and their three children walked out after five hours of listening to this self-serving garbage when it was obvious the verdict would be "guilty."

The three Jewish judges droned on and on taking turns reading the verdict which was referred to, even by the Jewish press, as a "Hollywood production."

Judge Levin read in part:

"What punishment must be given this Ivan the Terrible? A man who killed both tens-of-thousands and individuals, who tortured and treated sadistically those taken to death in their last hour, what is his sentence?"

"A thousand deaths cannot compensate for what happened, but at least we have judged one of the angels to death."

Attorney John Gill said: "The judges have totally ignored all of the evidence, which proved the SS I.D. card was a KGB forgery, and that the witnesses contradicted themselves. The case was never proven!"

Demjanjuk, over and over again said: "This is a very, very, very big mistake. I am not Ivan the Terrible, and to that God is the most just witness. He knows I am innocent." All the while Demjanjuk continued to make the sign of the cross and whispered prayers to God. He is a member of the Ukrainian Orthodox Christian Church.

His son, John Demjanjuk, Jr., who has attended his father's trial each day said: "This amounts to nothing less than the judicial murder of an innocent man. I left because I realized they were completely ignoring all the evidence the defense has presented. I'm sure the world legal community will condemn this travesty."

As far as I'm concerned, this was nothing more than a Soviet show trial."

The judges said the case cost Israel \$690,000. (NOTE: They failed to add it was mostly U.S. taxpayers' money!) They didn't mention that the Ukrainian community in the U.S. and Canada had raised \$650,000 for John Demjanjuk's defense and now must fight a useless appeal before more Jewish judges.

The judges droned on and on reading their so-called "verdict." "He slashed people's noses off, stabbed pregnant women in the abdomen and gorged peoples eyes out before shoving them into the gas chamber and turning on the gas." LIES - LIES - LIES!

There was even worse slander as Judge Levin read: "Demjanjuk wanted to force the prisoner Rosenberg to have intercourse with the body of a women he had just removed from the gas chamber."

SUCH OBSCENE LIES COULD ONLY BE INVENTED BY JEW PORNOGRAPHERS! The "Zyklon-B" gas the Jews claim the Germans used sticks to the body and clothing and would have instantly killed Rosenberg and Demjanjuk if any such event ever actually took place. A very long airing out period would be required and the Jew witnesses said none of their guards ever wore gas masks??? THIS IS NOTHING MORE THAN A GALLERY OF OBSCENE LIES!

The Disgraceful Jew Court "Celebration"

When the sentence of death by hanging was finally announced the Jewish mob began chanting, "death, Death, DEATH!" They did the Purim dance around the courtroom. Jewish youths sang "The Jewish People Live", while others cursed the defense lawyers. Hundreds clapped and shouted "Hang The Hamen."

It was an obscenity if there ever was one and lawyers and judges in America were shocked by such behavior calling it "uncivilized." Is this not the exact same response Pontius Pilate received when he asked the Jews to spare the Life of Jesus Christ? Their response was "Crucify Him, Crucify Him, Crucify Him!"

American Jewry Hails Verdict As A Victory

Jewish Week of April 29, editorialized, "This was not vengeance that was meted out, it was justice!"

"Atlanta Jewish Times" of May 6, wrote: "Given Demjanjuk's age and poor health, some legal experts had earlier believed he would receive a life sentence. But his crimes were too great!"

Hanging Judge In U.S. Sher's Secret Trip To Russia

Demjanjuk-Judge Now on U.S. Fund Raising Tour

United Jewish Appeal doesn't miss a trick. Only seven days after Israel's Supreme Court Justice, Judge Dov Levin, 62, had sentenced Ukrainian John Demjanjuk to hang, the judge was here in the U.S. He is raising money for the UJA speaking before Jewish groups. They include the Jewish Community Center in Hartford, N.J., and Synagogues in South Orange, Newark, Bergen County, South Jersey and Philadelphia. He will then visit other parts of the country.

Judge Levin criticized East European groups which have protested that Demjanjuk did not receive a fair trial. Levin responded:

"What a pity it is that some people will go against our verdict which they have never read. I can say he had a fair trial. The Israeli tradition is known as a fair and good judiciary. I personally am against the death penalty but this case was the exception.

"He was responsible for the deaths of at least 800,000 people by gas, by shooting, by stabbing. One cannot believe that human beings can be so cruel and do such a cruel thing with a feeling of happiness. He was happy to do it as proven by the evidence. We were entirely

convinced that the indictment was proven and the accused is really Ivan the Terrible. That's why this should be the death penalty - now, we want Demjanjuk to have every possible opportunity, if there is the slightest trace of wrong identity. That's why the appeal hearing will take as long as necessary!"

(NOTE: We ask all to re-read the last sentence again. Levin is admitting that in his mind - there is a "slight trace of wrong identity!" Any time there is "reasonable doubt," the accused must be acquitted! At the very least, he should not be sentenced to the death penalty! This was a kangaroo court trial and there should be a united world-wide protest against this dastardly injustice!)

The Department's Office of Special Investigations (OSI) is responsible for proceeding against Nazi war criminals presently residing illegally in the U.S. In this regard, OSI is seeking to locate survivors who have knowledge of the events which

took place in Salaspils and Sauriesi, Latvia during World War II.

OSI is especially interested in the fate of the Jews and other civilians in those areas, as well as the activities of any Latvian paramilitary units or auxiliary police in those areas.

Jews Hang Waldheim And Arafat In "Religious" Ceremony

Judaism is without a doubt the world's strangest "religion." The Jewish Encyclopedia states that while Christianity teaches the "forgiveness of ones enemies" Judaism believes in "justice." Further, they explain that "justice" means "rewards" for their collaborators and "PUNISHMENT" for their opponents.

Very few Christians have any knowledge whatsoever of the Jewish feast of Purim. This is their principal religious holiday. In the Biblical Book of Esther the Jews hang Hamen, the Prime Minister of Persia. With the help of the King they murder 75,000 of Hamen's followers. The Book of Esther says that many Gentiles then converted to Judaism because "the fear of the Jews fell upon them!"

This is the only genuine Jewish book in the Bible. It is the only Book which does not mention the word God one single time! Martin Luther, the founder of the Protestant church, held that the Book of Esther was un-Christian and should never have been made a part of the Bible.

In fact Esther was the last book added to the Bible. There was a bitter struggle among the sages who wanted to keep it out. Read the Book of Esther and you will learn much about the belief in "hatred" which is the chief component making up the religion of Judaism.

Waldheim and Arafat Hanged

Each year the Jews choose, not one, but three Gentiles who are to be hanged in effigy, just like Hamen. Schoenberg said B'nai B'rith's, "international council," had named Arafat the "Hamen of the year." He said "the first runner up is Austrian's President Kurt Waldheim and the second runner up is Vsevolod Sofinsky. He is a Russian who sits on a minor U.N. sub-committee and earned the hatred of the Jews on Aug. 19, 1987. Sofinsky told the U.N. they should expel all Jewish non-governmental organizations from the U.N. because, "they are intrinsically chauvinist and racist!"

Judaism - The World's Strangest "Religion"

It is very easy to understand why rabbinical authorities have long ordered that Gentiles be "forbidden - from prying into our religion!" The reason being that they indeed have a lot to hide! Judaism's vicious and brutal hatred which they hold towards all who stand in their way on any issue knows no bounds!

The feast of Purim can fall in either February or March. The two day holiday builds up to its "grand finale" with the re-enacted slaughter of Hamen, (who represents all their enemies past and present.) Some synagogues actually hang a dummy inscribed with the name Hamen. Others "celebrate" in less dramatic ways but they are still shocking to Christians who believe in "forgiveness."

Most often the Jews make up a doll they name Hamen. They hiss at the doll and use noisemakers and when the fury reaches a climax they suddenly smash the doll on the floor. The Jews take turns stomping the broken doll with the heels of their shoes. They joyously dance around the remains because they have destroyed their enemy Hamen. Sometimes the Jews will inscribe the name Hamen on a rock and then smash it with hammers, other times they make Hamen cookies and eat them saying, "We have devoured Hamen!"

Jews also use the names of this year's "Hamens", Arafat, Waldheim and Sofinsky during these "holy ceremonies." Last year Syria's President Assad was the Hamen and thusly "destroyed" in effigy. Still, as you can see by the picture on this page they hanged him again this year? Not long ago we ran a picture of a neon light just inside the entrance to a synagogue, (so that Christians outside could not view it.) 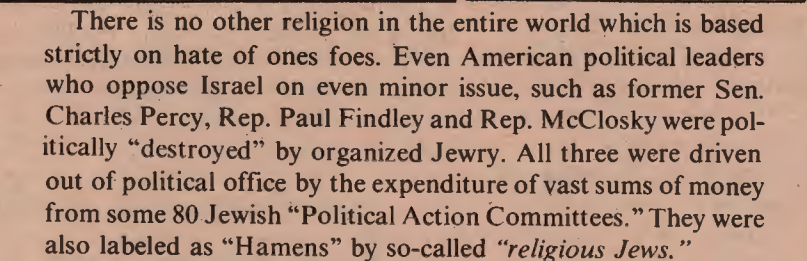

Patriots Found Innocent in Ft. Smith, Arkansas

The Seditious Law Is Dead - Jury Rules For Freedom of Speech!

Thursday, April 7, CBS-TV News came on the air with a startled Dan Rather declaring "AN ASTOUNDING VERDICT OUT OF FT. SMITH, ARK. THIRTEEN WHITE SUPREMACISTS ARE FOUND INNOCENT OF SEDITION CHARGES."

A jury of 12 White men and women had struck a blow for freedom which will long be remembered by generations of Americans yet to be born. It is very doubtful if any Patriot will ever be charged with "sedition" again. This law has long been frowned upon by both the courts and constitutional authorities because it poses a very grave threat to our First Amendment Rights.

U.S. Attorney General Ed Meese personally announced the indictments of 13 Patriots including three Right-Wing leaders, Louis Beam, Pastor Bob Miles, and Pastor Richard Butler. Meese, (the most corrupt Attorney General in U.S. history), said this trial would send a message to those who oppose Jewish influence over the federal government. Now it looks as if the message went in reverse. A jury of 12, average, working class Whites, told the Justice Dept. to stop persecuting Patriots whose viewpoints are opposite those of the Zionist influenced federal government! We want to leave our children a nation that is free of Jewish domination!

What Was Their Act of "Sedition"

The Justice Dept. claimed that a three year investigation at a cost of multi-millions of dollars led to the indictments. They predicted a 3 month long trial with 250 witnesses. It ended up being two months long with 108 witnesses but the entire case was actually based on the testimony of one James Ellison.

Ellison ran a religious cult in Arkansas where his followers had to turn all their "earthly wealth" over to him. He told the court that God had anointed him, "The King of The Ozarks." God even told Ellison he could have two wives! Thus he married two women, had children by both, and they all lived together under the same roof on his "religious" farm. It didn't take the jury long to figure out that the government's "star" witness was a looney!

His main testimony was that the key defendants attended Pastor Butler's "Aryan Nations Congress" in 1983. He alleged that at this meeting they plotted the violent overthrow of the U.S. Government to establish an all-White nation out of the five Northwest states of Washington, Oregon, Idaho, Montana and Wyoming. This story was easily picked apart when defense witness after defense witness all who attended this meeting said absolutely no illegal talk ever took place. Also, the only one who ever advocated violence was Ellison himself! Most simply passed him off as a "harmless nut!"

Ellison swore that the late Bob Mathews attended this meeting. But the defense presented Miss Karen Steffen, the payroll clerk at Lehig Portland Cement Co., in Metaline Falls, Wash. She presented time cards which proved Mathews was working on his job at the very same time Ellison swore he was at the meeting in Hayden Lake, Idaho! Attorney Bennett Nolan charged that FBI agents already had this information and said: "the government has acted improperly by allowing Ellison to testify to something that the FBI already knew was false!"

Local Newspaper Reported, "It's A Weak Case"

"The Southwest Times Record" of Ft. Smith, Ark., reported on March 20, near the end of the trial that, "the jury may have difficulty with the government's case. Jim Ellison has two wives and calls himself, 'King of The Ozarks.' He said he decided to cooperate with the government because he hopes to see his 20 year sentence on a racketeering conviction shortened. He also admitted that both his wives and all their children have received government assistance since he turned informer."

Another problem for the prosecution was Federal Judge Morris Arnold! Time and again he threatened to call a mistrial in the case because the government continued to introduce hearsay evidence with no corroborative testimony to back it up. He ordered a directed verdict of acquittal for Robert Smalley saying there was no evidence whatsoever against him. Judge Arnold also shocked the prosecution when he stated: "I was rather startled that no government witness has implicated defendant Bill Wade."

Dr. Fields Testifies For Louis Beam

During the trial, a prosecution witness testified that Louis Beam, Bob Miles, Richard Butler, Dr. William Pierce and Dr. E.R. Fields had received stolen money from the late Bob Mathews. Your editor did not need a subpoena to bring me to Ft. Smith, Ark. to testify. I rushed out there and picked it up at the courthouse.

My testimony was that I had not only never, never, received any stolen money, but that I had never even met Bob Mathews! Also, I testified that I phoned all of the above and many other Right-Wing leaders warning them not to accept any such funds as it could lead to an entrapment. This testimony placed a cloud of doubt over all such charges. After the trial, jurors told reporters they simply did not find Ellison and other key government witnesses believable!

While in Ft. Smith, Dr. Fields was interviewed by the "Southwest Times Record." He attacked the very application of the sedition law because it violates First Amendment rights to freedom of speech. The interview appeared on the front page. He also was invited to appear on both of Ft. Smith's local TV-News Programs (Channel 40 and 24), just before the trial began. He again attacked the very basis of the sedition law as being unconstitutional!

The government's case was greatly weakened when two chief witnesses admitted they had received large sums of money from the Justice Dept. for their testimony. Mark Jones said he had been paid \$44,000. Another witness from Philadelphia, Tom Martinez, said he had been paid \$75,000 and is now writing a book which is being financed by Jews! All of this thoroughly discredited their testimony in the eyes of the jury.

Was This A Plot To Bankrupt Defendants?

When the government first announced that the trial would last three months Miles and Butler had to hire lawyers for that period of time. Bob Miles hired Deday Rene, the best trial lawyer in Michigan, at a cost of over \$50,000. Patriots contributed some \$30,000 toward his defense fund thus Miles still owes his lawyer a lot of money.

The Jewish Anti-Defamation League was heavily involved in this case. Their Los Angeles mouthpiece, Betsy Rosenthal, stated that even if the defendants won their case they would be personally bankrupt by the time it was over. The ADL even bragged that they had given the FBI "evidence" to be used against the defendants. It is also very interesting to note that the assistant prosecutor in the case said: "Regardless of how this case ends the defendants will be severely damaged financially!"

Has the Justice Dept. been reduced to prosecuting people with a side goal in mind of simply hurting them financially? There was also a threat made by Justice Dept. Attorney Asa Hutchinson who wishfully stated before the trial: "This trial could wipe out the majority of the White separatist movements leaders." (Note: Only three leaders were on trial while the Jew ADL reports there are 71 Rightist groups!) Hutchinson added:

"They're going to be very thin in their ranks if the prosecution is successful. I think it would be a serious, if not fatal, blow to those organizations." (NOTE: Of course, this statement is ridiculous and it makes this an even greater victory for freedom loving Americans.)

Left-Wing Jews Shocked At Verdict

Jewish ADL official, Irvin Suall said: "It was my impression that the government had a strong case."

The Atlanta based "Center For Democratic Renewal," was founded by Communist Party leaders such as Ann Braden. The director of this Red Front, Leonard Zeskind, a Jew from Kansas City, said:

"There were three problems, the government cut its list of witnesses in half, Judge Arnold ordered the direct acquittal of one defendant and let it be known there was a possibility of a mistrial because of the lack of corroborative evidence."

Another Center for Democratic Renewal spokesman, Eya Sears, lamented:

"The Rightists will view this acquittal as a green light. They are going to step up their activity. So it is very, very important that those of us who love democracy become more vigilant." (NOTE: Is this an appeal for violence?)

Jewish Newspapers Attack Jury System

The Atlanta Constitution ran the most radical and vicious attack on men found INNOCENT by a jury that we have ever seen. The gutter sheet is now edited by the fanatic Jew Bill Kovach who worked for the New York Times. In an unbelievable letter to the editor on April 11th, the Kovach column wrote in part:

"An all-White jury failed to put away loops and unfortunate verdict - one that surprised more than a few... these were especially dangerous people... the monster and could still be dangerous... This verdict could give it a Justice Dept., must maintain the pressure and keep the run!"

(NOTE: Bill Kovach's writings are dripping with venom against the concept of the "all-White" jury. Jews don't trust White men because they are liable to free those they consider Jews." No doubt he would prefer the court system in Israel where there is no jury, where three Jew judges hand down the guilty verdict. They prefer the kind of "Jew justice" which they meted out to innocent John Demjanjuk.)

The Defendants Declare Total Victory

The courtroom became jammed during the last days of the trial. Defendants such as Leonard Zeskind, who was paid by the Jew ADL to cover the trial, along with ADL chief Irvin Suall and other leftists packed the courtroom. They laughed, jostled one another on the back during the final hours of the jury deliberations. They anxiously awaited the expected "guilty" verdict.

When the Jury foreman began to read the verdict the courtroom dropped open. "Not Guilty on count one, Not Guilty on count two, etc., etc., on and on the 13 defendants were declared innocent. Dead silence filled the courtroom. The six prosecutors all kept their heads down staring at their table. They never looked up at either the jury or judge. When it was all over the defendants, their friends and families let out a cheer! The liberals beat a hasty retreat out of the courthouse and leaving only the defendants to give interviews to the press.

Louis Beam said: "I think everyone saw through the case that I was simply being punished because I'm a separatist and outspoken opponent of the federal government. I think the Occupation Government has suffered a terrible blow!"

With that Beam's wife, Shelia, fainted and he carried her to the car to drive back to Texas. Before his arrest the FBI put him on their ten-most-wanted men list. He was held without trial, handcuffed and in leg irons to and from court each day. The "dangerous" Patriot is back in Texas freely giving lectures and talks showing discussing the case - and winning more new converts!

Pastor Bob Miles was asked if he was going to take a vacation. He replied, "no, I must rush back to Michigan to get the newsletter out - we're already late. Also, I am hosting a conference of White Separatists at my church next month. It's a tremendous amount of work to do."

Miles, Butler and Beam still are working to establish a White Nation out in the Northwest. Not a bad idea even though the government says it is "seditious." Still, no one will ever be able to hold this viewpoint. The American trial jury system is dead!

This was the most important victory for freedom of speech in our lifetime. Freedom and Liberty are still alive and we thank God because this case proves that there are good White men and women left who believe in justice. That is all we ask for because a free open forum for our viewpoints is needed because - IN THE END WILL COME VICTORY!

The Arkansas trial is the latest, and perhaps the most important, case in a government effort to quash white supremacist groups that began in the early 1980s.

Civil-rights advocates and watchdog groups hope the trial, marking only the third time sedition charges have been prosecuted this century, will cripple an already withering white supremacist network across the country.

They hope the prosecution of three of the movement's most influential leaders — Butler, Miles and Beam — will chill the racist fires.

E.R. Fields, a Georgia retired chiropractor who heads the Committee to Repeal the Sedition Law, said his group is lobbying state lawmakers in the

South to build opposition to the sedition statute, which he said has rarely been used. Most of the men being tried in federal court here are under triple jeopardy, Fields said, being prosecuted for the same acts a third time — first in Seattle in 1985, then last year in Denver.

"Now they haul the road-traveling show to Fort Smith" for their third trial, Fields complained. But he expects the Fort Smith case to establish a precedent for the sedition law.

"If the defendants win this case, it probably won't be used again," he said.

Blasts statement

□ In a recent TV newscast, the U.S. attorney's office was said to have stated that, while Louis Beam, Robert Miles and Richard Butler may not be found guilty of seditious conspiracy, they have been financially ruined because of the enormous cost of defending themselves against the exotic charges, and that the purpose of the government would be served.

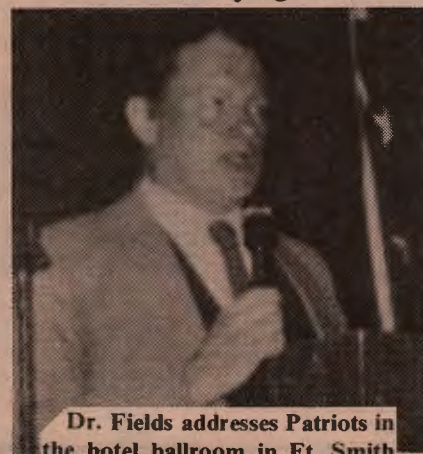
Plans A Total Success

How The Case Was Won

Ft. Smith, Arkansas is a city now famous because freedom triumphed over the "Great Sedition Trial." Here a small band of embattled Christian Patriots defeated the combined forces of the federal government, the news media and the Jewish political lobby and their many collaborators. Multi-millions were spent to gain a conviction and more newspaper articles attacking these embattled Patriots were published than any other political case in U.S. history.

Despite all this we had a fair judge and a fair jury who after hearing the evidence, (or lack of it), were able to render a just verdict of NOT GUILTY. Many different things made this victory possible. Bob Miles had Attorney Deday Rene who is one of the nation's best lawyers at cross-examination. Also, both Pastor Bob Miles and Pastor Richard Butler took the witness stand in their own defense. Under direct examination they answered every conceivable question

frankly and honestly from their own lawyers. Next, under the weathering cross-examination by the federal prosecutors they again explained all their actions, words and deeds to the satisfaction of the jury. It was clearly shown that they did not undertake any violent scheme to overthrow the U.S. Government.

The Battle For The Hearts Of The Public

Pastor Thom Robb called a conference to discuss ways to fight the sedition case at his church months before the trial. Dr. Fields attended and it was decided that in political cases the sympathy of the general public has much to do with molding attitudes which eventually affect everyone in the district. People tend to think as a unit with a general viewpoint conceived before a political trial ever begins.

If the popular attitude is that you are a "bad guy", you are likely to be found guilty in a case where the "facts are fuzzy." If the general feeling is that the rich and powerful are

persecuting people because their views run counter to official government policy - then public sympathy can affect the outcome. The overall attitude of an entire community tends to encourage a "not guilty" verdict. This is especially true when the case is coupled with the feeling that the accused are "the underdogs."

Pastor Thom Robb of the Identity Church, P.O. Box 373, Harrison, Ark. 72601 outlined an aggressive plan to reach the public with our views. He planned 15 courthouse rallies. Fortunately, radical protestors sought to disrupt the rallies by throwing objects and shouting obscenities. Robb gave many interviews to the media over a three month period. At the end of the campaign he planned a large protest parade through Ft. Smith to the courthouse the day before the trial with a mass rally on the grounds of the federal court buildings.

NRA Charges Jews Lead Fight To Ban Guns

"The American Rifleman" is America's leading pro-gun magazine and the voice of the National Rifle Association. They just carried the following article on page 30 which in part declares:

"For years, much of the established Jewish leadership in the U.S. has been reflexively banging the drum for gun control. The June 1987 American Rifleman listed seven major Jewish rabbinical and lay organizations as being among the most active participants in coalitions pushing for gun control.

These include the United Synagogue of America, the Union of American Hebrew Congregations, the American Jewish Committee and the Council of Jewish Women. No other religious body has as many groups listed or has made such a sweeping commitment to the cause.

This insistence upon denying private citizens the right to possess firearms ignores the lessons of history... (they do) not justify the American Jewish leadership's fervor for gun control."

NRA Blames Jews

The NRA lists the leading corporations which finance the "National Coalition to Ban Handguns" (NCBH). They total 39 companies of which 25 are headed by millionaire Jews including: Barry Diller, Armand Hammer, Estee Lauder, Jay Pritzker, etc. The NRA next lists 45 people who are leaders in the NCBH and some 22 are Jews. (Remember, Jews make up only 2.5% of our population!) What all this means is that if Jews and their money power were removed from the NCBH the anti-gun organization would collapse.

Israel bans Arabs from owning guns. Still, the 80,000 Jew civilians living in the Arab West bank are all urged to bear arms. In New York it is very difficult for most Christians to obtain gun permits. Yet, Jews in New York City have an easy time obtaining permits and many are armed!

"Open Housing Spies" Can Now Sue For Damages U.S. Supreme Court To Review New Threat

The Fair Housing Council of the city of Washington, D.C. sent an employee who they call a "tester" into a Maryland suburb to pretend she wanted to rent an apartment. (These people are really spies like they have in Russia who watch their neighbors!) The spy Cynthia Bryant, was turned down and then sued the apartment owner. For the first time ever the spy was granted \$25,000 in damages! The Negro Federal Judge, Walter Black, ruled that a spy can also, "suffer from the pain of discrimination." (She never really wanted to rent the apartment in the first place - it was all entrapment.)

What we have here is black tyranny over White people just as terrible as that suffered by our ancestors after the Civil War. At that time the South was occupied by the "Black Militia." Scalawags and Carpetbaggers ruled with the help of the Negro occupation army. Most Whites were denied the right to vote, but all blacks could vote. (A Black ruled Mississippi elected two Negro U.S. Senators during Reconstruction.)

Is This Going Too Far Even For The Supreme Court

Many are concerned by similar outrageous cases whereby innocent White people have been sued for: not renting to blacks, releasing them from jobs for poor performance and/or behavior, etc. This situation has become so intolerable that the U.S. Supreme Court on April 25th voted 5 to 4 to review the 1976 high court ruling which permitted such suits. This was allowed under the old 1866 Reconstruction law which was passed when the occupied Southern States could not vote on the matter. Many Constitutional experts say this alone should render that old civil rights law unenforceable.

The Atlanta Constitution was once called, "the Southern edition of the Communist Daily Worker," by the late and great Sen. Eugene Talmadge. It is now edited by the Jew Bill Kovach who was hired direct from the New York Times. On April 27, Kovach, in a lead editorial, bitterly attacked the Supreme Court's 5-to-4 vote to review the civil rights damage suits. (The 5-to-4 vote indicates this might be the resulting ruling which would ban such suits.)

Kovach wrote that the decision is "disturbing and a set-back for civil rights." He complained that it could begin a new trend to weaken the protection of minority rights. BUT, WHAT ABOUT THE PROTECTION OF MAJORITY RIGHTS!

When you hear such stories of "Open Housing Spies," it is quite easy to understand why some Right-Wing Patriots would like to set up an all-White independent nation in the Northwest as advocated by Miles, Butler and Beam! The justices ruling to review damage suits over "discrimination cases," were William Rehnquist, Byron White, Sandra O'Connor, Antonin Scalia and Anthony Kennedy.

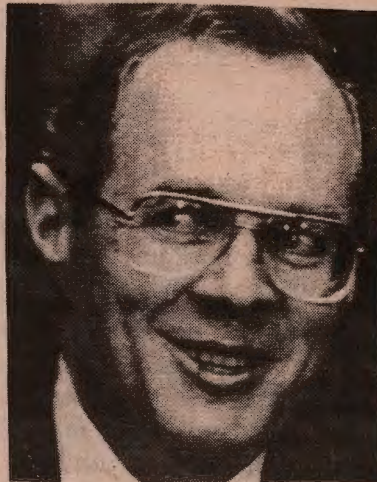
Hundreds of "Testing Spies" Coming

Dept. of Housing and Urban Development assistant secretary C. Duncan MacRae announced on April 10th that they are going to send out hundreds of "testing spies." He said that new and stronger laws are needed to force White people to sell and rent housing to the crime prone Negroes. If there was ever a time when White people needed some relief from such despotic tyranny on the part of civil rights radicals both inside and outside of government, it is now!

How To Deal With "Testing Spies"

No one with any common sense wants to rent or sell property to a crime-prone race of people. They commonly destroy rental property and lower the property values of every other poor soul who lives in the neighborhood. The way to treat such scum called "testing spies" is to write up a long and comprehensive application for all to fill out if they want to rent an apartment or home from you. Ask about past jobs, references, where do they have credit, where have they lived in the past, do they have any arrest records, etc., etc.

Tell the applicant that you are going to check out their application and choose the most desirable tenant. Then check out the applications and weed out any despicable "testing spies." This way you can legally choose the tenant of YOUR CHOICE and not the choice of the unAmerican, "Dept. of Housing and Urban Development."

WASHINGTON, April 10 (AP) — Hundreds of specially trained black, Hispanic and white couples will be sent out by the Federal Government to pretend they want to buy or rent houses or apartments, participating in the first major study of housing discrimination in a decade.

The 1979 study estimated that 27 percent of rental agents and 15 percent of house sellers discriminated against blacks. Discrimination then was defined as "failing to provide important, necessary information to rent or purchase a home."

The study concluded that blacks who inquired about four advertised houses had a 48 percent of finding discrimination in dealing with at least one house.

In the rental market, 85 percent of blacks encountered discrimination in at least one of four inquiries about apartments.

The aim is to increase enforcement against illegal discrimination, said Samuel R. Pierce, the Secretary of Housing and Urban Development. The study could also determine the need for stronger fair-housing legislation.

'Tester' Awarded \$25,000 In D.C. Housing Bias Case

A federal judge recently awarded \$25,000 in damages to a Washington, D.C., woman who he ruled had suffered racial discrimination when she attempted to rent an apartment in an outlying Maryland suburb.

U.S. District Judge Walter Black's award to Cynthia S. Bryant, a housing discrimination tester for the Fair Housing Council of Greater Washington, is one of the largest punitive awards ever issued by the court system to a housing discrimination tester.

Although Ms. Bryant—as a tester—may not have suffered as much as other applicants, "being a tester does not insulate one from the pain of discrimination," Judge Black ruled.

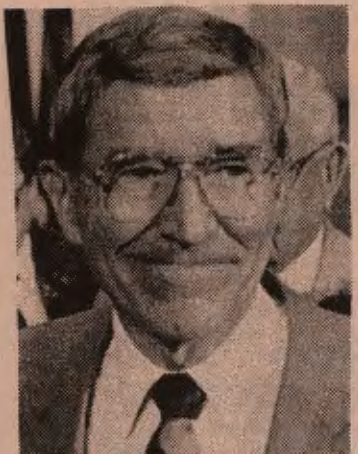
Impeached on King Anniversary

In an ironic twist of history, Arizona Gov. Evan Mecham, the man who revoked the state's celebration of the birth of Martin Luther King, Jr. in 1987, was recently impeached and removed from office on the 20th anniversary of the day King died.

"This is kind of a reaffirmation of justice in Arizona, and anytime there is justice for people I think our thoughts turn to Dr. King," said Christopher Johns, who helped organize Arizonans for a Martin Luther King, Jr. State Holiday.

Johns said Mecham's removal from office was a poetic justice, of sorts. "Evan Mecham is a 1950 political throwback," he told JET.

The King holiday committee sparked the nationwide rage which led to the ironic end of Mecham's term as governor when members called for a statewide boycott when Mecham rescinded the King holiday.

He said Acting Gov. Rose Mofford, who formerly served as secretary of state, supports the King holiday and wants the state Legislature to send her a bill to enact it. "Obviously, we've come a long way," Johns said.

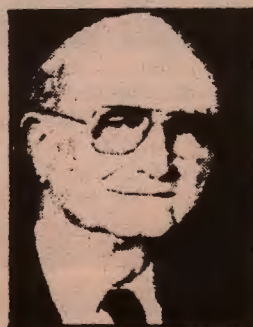

Jews Ask For Protection From Ukrainians

A warning in Toronto that Jews will pay for the conviction of John Demjanjuk as they paid for the crucifixion of Jesus has shocked and angered Canadian Jews.

The threat was attributed to Peter Jacyk, a member of the local Ukrainian community. He was quoted by the Toronto Star after a Jerusalem court found the Ukrainian-born Demjanjuk, a retired autoworker from Cleveland, guilty of war crimes, including the murder of 800,000 Jews in the Treblinka gas chambers.

Jacyk is vice president of the Canadian Charitable Committee In Aid of John Demjanjuk's Family, a Ukrainian group that has raised funds for the convicted Nazi war criminal during the 14 months he was on trial in Israel.

According to the Star, Jacyk commented on the guilty verdict, saying, "Through the 2,000 years, Jewish people paid for that — rightly or wrongly — but they did pay for that crucifixion. I believe this will have similar results in the future for this conviction" of Demjanjuk.

Frank Diamant, executive vice president of B'nai B'rith Canada, called the statement by Jacyk "outrageous and provocative."

There has been friction between the Ukrainian and Jewish communities in Canada ever since Demjanjuk went on trial in Jerusalem in February 1987. The 68-year-old Demjanjuk had been stripped of his U.S. citizenship in 1985 for falsifying his wartime activities. He became the first accused war criminal extradited to Israel for trial.

Within hours after the verdict was announced April 18 in Jerusa-

lem, a rock was hurled through a window of the Hillel House on the University of Toronto campus.

Ukrainians, who may number as many as a half-million in Canada, also are disturbed by last year's amendment to the Canadian Criminal Code, which allows Canadian courts to try suspected war criminals for crimes committed on foreign soil. Some Ukrainians and other Eastern European and Baltic ethnic groups have attributed the new measure to Jewish influence.

The Associated Press reports from Cleveland, Ohio:

John Demjanjuk's death sentence brought protests from the local Ukrainian community, which raised money for his defence. Demjanjuk lived in Cleveland since 1952.

"It's a travesty of justice," said the Rev. John Bruchok of St. Mary's Ukrainian Orthodox Church in Lorain, Ohio. Bruchok met with Demjanjuk and his family shortly before Demjanjuk was sent to Israel to stand trial.

"I saw his face. I saw the face of a gentle man who was scared," Bruchok said. "An innocent man is being executed."

A similar view was expressed by the Rev. John Nakonachny, a priest at St. Vladimir's Ukrainian Orthodox Church in Parma, the Demjanjuk family's parish. "It has been the unanimous opinion of this parish that Demjanjuk is innocent. That has been the opinion since the beginning," he said.

After the verdict, Jewish organizations in Akron, about 60 kilometres south of Cleveland, asked for additional police protection because callers were threatening local Jews.
