The Great Holocaust Trial Round II is just about over!

I have tried several times to send out some interim newsletter, written by myself, but was overtaken by the fast moving events inside and outside the courtroom. In the end, I was simply too exhausted and drained, by these many months of activity, the juggling of airline schedules, changing arrival and departure dates, the booking, delaying and re-booking of expert witnesses, journalists and Missionary Revisionists from across the seas who were flown to Toronto. They observed and reported on the inside and outside workings of the trial, its preparation and progress!

The balancing act, or the dance on eggs, which is necessary to keep men and women from many different ethnic backgrounds all working together harmoniously, and focused on the goals of the trial, took its toll in the end, even on the man with the "nerves of Krupp-Steel".

The trial proceedings had to take priority, and the friends around the world had to wait, or be satisfied with periodic mailouts of photocopies, telephone calls or "faxed" messages!

For this I apologize and ask for your understanding. I think that few people realize the strain these trials place on people such as our lawyers, our researchers, the film teams, drivers, guards and even on me, the accused.

Nuremberg

I now know and have more empathy for the victims of Allied vengeance, in the kangaroo court proceedings of Nuremberg in 1946-47-48, where torture, injustice, military defeat and the loss of many a loved one must have weighed heavily on the hearts and minds of those early "Victims of Zion". I bow my head in reverence to those who were hanged after those unfair, rigged and grotesque miscarriages of justice, still described by Allied Propagandists, as "trials"! The murders carried out pursuant to this judicial farce will remain a blot and stain on the honour of those nations in whose names these trials were held. It is no shame to be victimized after the unconditional surrender of one's country by the occupiers.

Harlan Fiske Stone of the U.S. Supreme Court referred to Nuremberg as a "high grade lynching party" run by an opportunistic Justice Jackson who, according to David Irving, wanted to become President on the back of Nuremberg. That, and Soviet Prosecutor Rudenko's presence, his hands still dripping with the blood of Stalin's many purges, clearly indicate what a hypocritical mockery of Justice Nuremberg really was.

It might have been prudent and understandable in some circles, even fashionable, to praise what happened in Nuremberg as "justice". Speaking for myself, and many people of my own generation and ethnic group, I will never accept Nuremberg as anything but a disgusting spectacle dreamed up and promoted by ghetto dwellers from Eastern Europe, who found themselves low brow, morally corrupt and inferior Europeans and Americans to be their front men. Nuremberg is a monument to Allied debasement, and Allied injustice, whatever some of the German accused might or might not have been guilty of.

Nuremberg condemned Germans for "deporting people" or "relocating" others, or for "slave labour of prisoners", while millions upon millions were driven out of their homes in many parts of Europe, with only the clothes on their backs, and the few meager belongings they could carry. They were then beaten, whipped, starved and humiliated. Millions of girls and women were brutally raped dozens of times, infected by the most horrible venereal diseases, and often driven insane by the pain and the shame.

All this took place under the eyes and in the shadows of those who sat in judgment at Nuremberg, and was known to them.

Millions of German men were held in Allied death camps on the Rhine Meadows, were thousands died like flies. Millions were shipped to Siberia, to the coal mines in France and England. Untold thousands died of thirst and malnutrition and the frequent beatings and tortures of Allied Liberators, who sat in judgment at Nuremberg over their defeated foe!

If you are looking for motivation in my struggle against the lies of WW II and the post-war mess the Allies inflicted on Europe's soul and its people with Nuremberg and their regime of terror - you have found it in the farce and crime that was Nuremberg.

Nuremberg is to me what gave birth to the Holocaust hate propaganda lie. Therefore, we cannot ever solve the hatred engendered by the Holocaust without also exposing Nuremberg for what it truly was.

So if you have been wondering why I go after those who inflicted Nuremberg on the world, it is because Nuremberg is the mother of the evil which plagues the world today.

The testimony obtained through torture, both psychological and physical, or by inducements, bedevils the history of the world today, as it did yesterday or in 1945. We have to correct the injustice committed there. to be able to make at least a start, in seeing real, honest and even remotely true justice done in cases involving W.W. II events.

All those who cannot or will not acknowledge this fact are part of the problem, and cannot ever be part of the solution, for they come to it with the prejudiced minds of the victors, not the fair minds of neutrals. much less the certain valid viewpoint of the victims. who 45 years after the war should certainly also be heard!

The rest of this newsletter will be against the background of this kind of thinking. If you cannot open your heart and your mind to this dimension, then I suggest you throw this newsletter in the garbage, for then you and I have no meeting ground.

For I am tired to see the world still divided into two camps, namely, the good guys who won in 1945 and the bad guys, evil incarnate if you believe Allied Propaganda then and now.

Speaking as a son of Germany, I know that my father and mother's generation were not the murderers. torturers or thieves whom Hollywood smears so mercilessly and incessantly in films, T.V., plays and novels. We are no better and most certainly no worse than the "Anglos" who read this English language communication, and who consume Hollywood's lies seemingly uncritically!

Now to the trial!

The Great Holocaust Trial Round II is now just about over. A succession of 24 defence witnesses and startling testimony has been heard during these, what some spectators have called, almost surreal proceedings.

The Media

Major well known media sources such as the Toronto Star, The Globe and Mail, The New York Times, The Chicago Tribune and West Germany's prestigious Der Spiegel, as well as Canadian and West German television have covered this new "20th Century Witch Trial".

Smaller regional papers like the San Francisco Chronicle, the Vancouver Sun, the Edmonton Journal, Ottawa Citizen and the Montreal Gazette have covered and discussed some aspects of the trial over the last few weeks.

The Jewish-Zionist media in Canada, the USA, West

Germany and England, have covered the trial in depth. Especially the Canadian Jewish News, house organ of the Canadian Zionist-Jewish Establishment, circulation over 50,000 copies, has covered the Holocaust Trial in great detail, and although from a Jewish vantage point, still quite fairly. They don't seem to lie for their own.

The German ethnic press in Canada and America has been almost totally remiss, censoring the trial in fact or just ignoring it altogether. The Austrian paper Deutsche Presse has at least opened its letters to the editor columns to the discussion of trial-related topics and has had some articles on the trial's progress.

The electronic media has downplayed the trial. if not outright censored it, as the CBC does. The efforts at censorship-busting by Zündel supporters have apparently not been strong and dynamic, or aggressive enough to dislodge or free the grip of Zionist terror and censorship over the major electronic media. We have been more successful with the print media.

So the trial is a trial of history, largely for history! The long list of defence witnesses and documents introduced during their testimony, clearly shows the Zündel formulated trial strategy, already apparent during the first Zündel Trial, namely, a frontal assault on the propaganda images created by Allied anti-German propaganda about the alleged Holocaust in WW II, during and after the end of hostilities in Europe, with a heavy emphasis on exposing Nuremberg and all it entailed.

Pavlov's Dogs

All the emotion-laden "pavlovian propaganda trigger terms" like "gas chambers", "gas vans", "extermination camps", "death camps", "mass shootings", "tortures", "open pit body burning", "stolen gold", "extermination through labour". etc., have all been introduced by the State through their expert's testimony and in cross-examination of our own Zundel witnesses by the Crown (State) Prosecutor.

The Zionist Establishment thought that through the introduction of the concept of judicial notice, the trial would be a short one, and that the Holocaust would not be on trial but instead, Ernst Zundel would be (for his writings, thoughts and political ideas); that goes without saying.

The 4 month trial is now over with the few breaks and time off, and the Zionist dream of a "quick execution" style trial caused by judicial notice, did not take place.

Instead, those who have attended the trial know that the Holocaust was once again on trial, even with the Crown's introduction of much peripheral materials such as a Flying Saucer book written by Ernst Zundel, and a broadcast made about Nazi Flying Saucers 13 years ago in 1975.

In the meantime, in far off West Germany, the Zionist lobby was not asleep. They managed by the usual methods to find a State Prosecutor in the town of Stuttgart to obtain an order "seizing" my postal bank-

ing account there, through which most of my German support is channelled. This will severely cut my financial support coming from Germany for an unspecified time. No reason, no judgment, no legal proceedings were made known to me before the seizure took place. I remained in the dark about this for over two weeks, while my German attorney attempted to find out why and for what reasons the state seized my funds over there once again!

In the meantime, the Zündel Holocaust Trial which is now into its critical phase with costs rapidly mounting for such items as airline flight bills from the far corners of the earth, amounting to over \$10,000 a week; for experts doing research in various archives in distant museums and archives; hotel and car rentals for witnesses doing such research, etc.

I am therefore in a bind and must appeal one more time to my non-German resident, world-wide audience of Zündel supporters, to make even greater sacrifices, to help me see the trial through to a successful conclusion, regardless of the verdict!

It would have been a terrible shame if I had had to tell potentially powerful and convincing witnesses to stay home for lack of money for their expert testimony, which hovers around the \$100 - \$200 an hour mark for some independent engineers, chemists, lab-technicians and university professors! That money has to be raised!

I have assembled an astonishingly effective team of legal advisors and a powerfully convincing stream of researchers, authors, publishers, historians, medical doctors, professors of language, cremation experts, geologists, engineers, etc. All that is needed now is the rest of the money to pay them all for testifying. Many leading revisionists devoted their time for free!

Some of the non-revisionist experts, however, have cost the defence between \$4,000 and \$5,000 to testify. One expert alone has already received almost \$37,000 for a very important study needed in our chain of evidence, and that is the amount owed only up to the present time. add witness fee!

So you can see that quite apart from the actual legal fees for attorneys, and legal secretaries, legal researchers and transcripts, there are external costs which would scare most ordinary people out of their wits. For instance: to get aerial photo enlargements and negative copies of actual U.S. and captured German aerial photos of Allied Surveillance flights over Auschwitz and other camps, cost me \$3,300 even though the expert gave his time for free - for photos, time spent at the archives, mail and print costs, as well as flights.

Ditlieb Felderer and other Witnesses

However, enough of trial interna. Now to the wonderful testimonies heard in this Canadian courtroom during the last 16 weeks. You heard about the earlier witnesses, Ditlieb Felderer, showing the court 388 magnificent slides of Auschwitz and other camps; Thies Christophersen, Auschwitz-Sonderführer with

3 his very different story of what really went on in Auschwitz where he did plant research to find a substitute for natural rubber. Witnesses like Dr. Russell Barton who was one of the first British medical personnel to move into Bergen-Belsen and who was sure that what he saw was a tragedy caused by war and not a deliberate extermination policy of Jews or anybody else!

It saw people like the Chinese professor Dr. K.T. Fann, a Marxist, testify for Ernst Zundel's freedom to speak! Only to be abused by the judge for his honesty and effort!

Jürgen Neumann, a close associate and friend of mine, testified as to my "state of mind" when the booklet first was published.

Then came Bradley Smith, media director for the Institute for Historical Review, who put on a sterling performance, being frequently witty, and devastating, saying to the Prosecutor at one time: "I think you have Zionists on the brain", another time when talking about professional Holocaust Victim Elie Wiesel, "that guy is not wrapped too tight"!

He was followed by a U.S. Intelligence veteran who had interrogated the last two German survivors of a U.S. mas murder of the 560 guards at Dachau Camp on April 29, 1945! A crime never to be punished!

Mark Weber

He was followed by Mark Weber, Revisionist Historian and considered by some as the "Faurisson of North America". He led off that week with brilliantly formulated and well documented counter-thrusts to the Crown Prosecutor's questions. He had burned the midnight oil and had roamed the libraries of Toronto in search of rebuttal evidence and to the shock and surprise of the prosecutor, he had unearthed statistical evidence about the ludicrously high figures of gold allegedly seized by the Nazis contained in the infamous Nuremberg document describing Operation Reinhardt, which sounded more like a "shake-down" by the German Security Forces of one of Europe's poorest regions, namely, Galicia, than a military operation.

If one gives any credence to the Allied-introduced typewritten document, the Germans seized more than twice as much gold from the Jews in 1944 of that poorest of regions, than all the gold mines in Canada, some 15 large mines, produced in the entire year of 1986!

This information hit the courtroom like a bomb-shell! If Mark Weber was hard pressed by the prosecution on Friday afternoon and the fatigue was telling, that Monday morning counter offensive was a sight to behold!

Prosecutor Pearson sensed that there was not much hay to be made with this witness and ended the at times gruelling, highly biased and unfair cross-examination!

The next witness was Maria Vanherwaarden, an Austrian lady formerly an inmate of Auschwitz, who had been there from December 1942 till January 1945.

Your Donation = Our Survival

She described in simple but evocative language the hardships of camp life in Auschwitz!

She was told on her way to the camp by some Gypsy women that they were all going to be gassed at Auschwitz. This so scared our witness, that when she was led into a shower room she thought that she was going to die.

However, she reported that she was very surprised to find that instead of the dreaded gas, warm and cold water came out of the shower heads. She worked in Raisko near Birkenau for nearly six months and lived in barracks next to those containing Jewish women. She reported that Jews were treated no differently from other people and in many cases held the nice jobs in the camp, such as the office jobs of Block Scribe and Block Senior.

When she was evacuated westward from Auschwitz in 1945, she was with a group of about 600 women which included numbers of Jews. At no time did she ever see evidence of mass exterminations or the elusive "belching smoke" and "horrible stench of burning flesh" which Jewish "Holocaust Survivors" so love to recount! Her evidence strongly corroborated the previous testimony of Thies Christophersen who likewise saw no belching smoke or evidence of massive gassings in or around Auschwitz I or Birkenau.

This courageous woman, who stood on the stand clutching her purse and answering in a combination of German and English because of her nervousness, will go down in history as the first inmate of a German concentration camp who had the courage and determination to publically refute the incredible lies told by so many Jewish survivors concerning these camps.

Joseph Burg

The next witness was 80 year old Joseph Burg, a Jew and long-time Zundel acquaintance, who testified in blunt terms that there never was a policy of extermination by the Nazis, there never were gas chambers and that the so-called "Final Solution" was merely a policy of emigration or deportation. Burg testified that the endless stories of gas chambers and exterminations were the product of "sick minds". He stunned the courtroom by stating that the "superficial oaths" in gentile courtrooms were not morally binding on Jews, and that 99.5% of the atrocity stories would be retracted if Jewish survivors were forced to testify under an oath given by a high rabbi in a room containing no Christian artifacts or icons.

Burg spent much of the war in an area controlled by the Germans. He stated that while the Nazis looked after the Jews in concentration camps by giving them food and shelter, the Jews in Burg's area in Transnistria were simply left to fend for themselves. If they were able to obtain food and shelter, they lived; if they couldn't, it was simply too bad and many of them died!

Burg outlined the cooperation existing between the Zionists and the Nazis during the Thirties, a long sup-

pressed historical fact, which saw apparently even Eichmann visit Jerusalem and Golda "Meier" (Meyerson) visit Nazi Germany, etc. Burg stated that once the Nazis started losing the war, the Zionists deserted Germany like "rats leaving a ship". The Zionists need pogroms, Burg went on, to frighten Jews into moving to Israel. He accused the Zionists of fomenting both WW I and II for the sole purpose of obtaining a Jewish state. The Zionists and their accomplices, Jewish Wall Street bankers, were willing, he said, to sacrifice the whole of European Jewry if that was necessary to obtain a Jewish state.

He praised Zundel for fighting for truth and for justice for his people, and stated that it would be good for Jews if there were two or three more Zundel's in the world. Burg emphasized that there would be no reconciliation between the German and Jewish people until the truth about the "Holocaust" came out.

An attempt by the judge to intimidate Burg was unsuccessful. Burg scowled at him and in a scolding voice continued with his answers. This encounter was what perhaps convinced Crown Prosecutor Pearson not to cross-examine Burg. In a dramatic gesture, Pearson stood and stated that he had no questions to ask the witness!

Dr. Gary Botting

At the end of that fateful week, Dr. Gary Botting arrived from Calgary and gave evidence concerning those parts of the booklet "Did Six Million Really Die?" which were assertions of fact and those which were assertions of opinion. Botting concluded by stating that if a person took all of those parts of the pamphlet which were opinion and pasted them together, they would constitute a fairly coherent essay. If someone took merely the factual parts, however, and set them out together, they would be meaningless and incoherent. Botting pointed out that this showed clearly that the pamphlet taken as a whole is a statement of an opinion backed up by factual assertions.

This evidence was extremely important to the defence since opinions are not captured within the terms of spreading "false news" under section 177 of the Criminal Code. Thinking is, apparently, not yet outlawed in Canada!

Dr. Botting is another courageous individual who has refused to be intimidated by the Zionist Establishment. On short notice he flew in from Calgary to testify notwithstanding that he lost his teaching position at Red Deer College as a result of testifying at the last Zundel trial in 1985. Dr. Botting is obviously a man of rare courage in an age of conformity and cowardice!

Other witnesses included Mr. T. Rudolf, 77, an ex-Security Service man in the Third Reich, who testified that the International Committee of the Red Cross was given tours of concentration camps during the war. This evidence was in direct contradiction to the testimony of Charles Biedermann, Director of the

International Tracing Service, who had earlier testified that the Red Cross had not been allowed inside the camps during the war. Mr. Rudolf based his firsthand knowledge on his experience and observations while working as a clerk-translator for the Sicherheits Dienst office in Lodz (Litzmannstadt). He also outlined the massive help the ghetto factories were to the German war effort, producing every steel helmet worn by German soldiers and millions of uniforms!

Ernst Nielsen took the stand to describe how Zundel helped him after he encountered trouble in a "Holocaust" course at the University of Toronto. Zundel and Nielsen wrote a letter protesting the fact that students were not being allowed to question the "Holocaust", were being branded "trouble-makers" if they did so, and were expelled from the university courses when they asked for documentation of wild claims, made by Jewish professors!

Ivan Lagace

During that week, the court also heard the testimony of Ivan Lagace, a crematorium operator, who explained the principles of cremation to the jury and the standard operating procedures. Lagace pointed out that even with the most modern equipment and perhaps the fastest crematory in North America, he could only cremate a body in one and a half hours at the minimum. Lagace showed plans of the Birkenau crematoria to the jury and showed that they resembled modern equipment to a remarkable degree. He described Raul Hilberg's statement in The Destruction of the European Jews that 4,400 people were cremated daily in 46 retorts in Birkenau as "ludicrous" and totally unrelated to real life.

With this testimony, one of the largest fallacies of the "Holocaust" has been devastated. Finally, after many years, a qualified person has stated clearly in a court of law that the assertions of virtually thousands of cremations a day at Auschwitz as described by largely Jewish writers and expert historians like Hilberg, as well as the many professions! survivors, who are frequently on television, was technically impossible!

This historically important witness was followed by a long time acquaintance and co-worker of mine, a fellow German Canadian, Hans Schroder, who testified to the research and worldwide correspondence being carried on by me over the years.

Udo Walendy

Then followed Udo Walendy, a prolific German political scientist and history writer, who has had a profound influence on me since the early Sixties. He outlined all the many forgeries he had discovered, in wartime atrocity photographs and other documents, either altered or forged by a team headed by a Tasmanian British Propagandist called Sefton Delmer. This man wrote a book, a form of arrogant confession, in German entitled Die Deutschen und ich, in which he

5 brags about his underhanded and filthy methods of deception, forgeries and lies, many of which still bedevil European history to this very day.

In cross-examination, the Crown Prosecutor tried his best, by insult, innuendo and outright character assassination to paint this valiant German as some unprincipled inveterate Nazi. He was subjected to the most gruelling cross-examination of the whole 4 month trial. In the end, Pearson gave up; he simply could not elicit from this brave German any more damaging statements. The government's hand-picked prosecutor, who was seen in the presence of Zionist Big Wigs and survivors at almost every break in the proceedings, thus shamelessly portrayed the government's partiality and dependence on Jewish advice.

Through Udo Walendy, the Crown brought in the most unsettling piece of writing, a booklet entitled Six Million Did Die, which was a propagandistic effort by some South African Jews to answer the world-wide impact of Harwood's little booklet, Did Six Million Really Die? Walendy did much to explain the many mistakes and flaws in the booklet. Language difficulties and poor translation hampered his efforts. Again, the Crown tried to smear him as a Nazi; still in love with Adolf Hitler, who had inculcated in me the same aberration!

Germans were clearly not entitled to be proud of their own country's heroic past and were not to be allowed to look up to their own people's leaders. The anti-Germanism in the government's spokesman was apparent and very evident.

Emil Lachout

Emil Lachout, a former Lieutenant in the Austrian Military Police Service followed. He was a former member of the Allied War Crimes Investigation Commission for Austria, which had investigated the torture of German civilian and military prisoners who had fallen victim to Allied brutality.

He was a tall, handsome and quiet man, who had signed a most unusual document in 1948 known as the "Lachout-Mueller" document, which had been circulated to the Austrian police stations in 1948, and stated that the Allied Investigation Commission had not found any execution gas chambers to kill people with in the following 13 camps and their many sub-camps, some 20 of them in Austria alone. These camps were: Bergen-Belsen, Buchenwald, Dachau, Flossenbug, Gross-Rosen, Mauthausen and its adjacent camp, Natzweiler, Neuengamme, Niederhagen (Wewelsberg), Ravensbruck, Sachsenhausen, Stutthof, Theresienstadt.

Lachout was a sensation and an extreme embarrassment for the Crown Prosecutor who was there to keep up the WW II propaganda version of Allied correctness, and Allied civilized behaviour. What he found were instead hundreds of cases of incriminating testimony and confessions obtained under psychological duress, and brutal beatings, etc.

It's liberation time

I was so glad that it was me, through my trial, who was able to finally tear away the veil of hypocrisy from these uncivilized thugs who had lorded it over their defenceless victims once they had put down their arms. The fact is that many of these criminal thugs were the same English or Americans who have been incessantly moralizing about the wonderful ways of law and order that they had brought to Europe.

Lachout revealed a naked terror not much different from the Bolshevik Revolution or the Israeli behaviour in occupied Palestine today.

The Crown was very cautious when questioning this witness, and dropped this matter like a hot potato. I was happy to have achieved vindication for all those innocent victims of Allied brutality who have not been avenged to this day.

Lachout left for Austria, where he found that he had been fired from his job as a religion teacher and ordered to submit to a psychiatric examination. All this for spilling the beans on the Allies' Reign of Terror after the war.

Dr. Robert Faurisson

Dr. Robert Faurisson from France was next, as the defence witness #19. Dr. Faurisson had imparted a great amount of knowledge to me over the years going back to 1979, when I had read his lecture to the assembled historians and revisionists at Northrop University in Los Angeles. Dr. Faurisson had been too tired from the long trip to give the lecture himself.

This was a fortunate "twist" for the defence, because this way, all the wonderful research done by this great man, the Dean of Revisionism, could now be read into the record and shown to the jury. All of Dr. Faurisson's pioneering work into the methods and safety measures necessary while gassing only one person in a U.S. gas chamber were introduced. The many photos he had taken of U.S. gas chambers were also introduced and projected on the wall for jury and public to see.

Unfortunately, much of Dr. Faurisson's time had to be spent destroying the Crown's "Red Herring Booklet", Six Million Did Die! Faurisson did a wonderful job under the circumstances. I was proud to have been the one to afford him a thorough airing of his viewpoints through my trial.

Frequently, I was choked up by his warmth, kindness, and empathy for a beaten foe! I was touched by his recounting of how he, like so many of his generation, had been stirred up into hating the Germans, and how when victory came in 1945, his father shocked him into the realization that although for him this victory was a happy event, for the Germans it would be a very different story.

All in all, to be witness to the testimony of Dr. Robert Faurisson was a privilege, an event of pure honesty of untarnished, uncompromising truth told, without fear or favour, seldom experienced by anyone in today's age of the situational ethic!

6 One would have to write an entire book to do justice to Dr. Faurisson and all he said or tried to say. His testimony was a "tour de force" of Revisionism. The world owes this French intellectual a great debt for his dedication to truth and his attention to detail!

Bill Armontrout

Defence witness number 20 was a surprise to friend and enemy alike. His name was Bill Armontrout, by profession the Warden of one of America's largest maximum security prisons for dangerous criminals.

He was also the "Gasser in Chief" of his institution, having to operate the two seat gas chamber in Missouri State Penitentiary, should executions by gas be resumed there. He surprised the court by explaining the tremendously time-consuming and difficult methods necessary to kill one prisoner by HCN using gas chamber technology of the late 1930's; about the same time and model which would have had to be used by the Germans, if they had intended to kill people by gas! This was an American idea, and only in vogue in America at that time.

Mr. Armontrout went through all the many checks and safety measures, and explained the need for powerful ventilators needed to suck the gas out of the chamber. He showed photos of the 45 foot tall gas evacuation pipe installed on top of his gas chamber.

He explained to the jury that they had to remove the guards from the guardtowers, even though they had the tall evacuation pipe in place. He also told the court that some 38 people were involved directly or indirectly in the gassing process!

Frankly, I think his slides of the massive steel doors with seals, heavy bolts, thick glass, etc., made quite clear that "gassing" someone is not an easy job or one to be taken lightly. Had the Germans gassed their "victims" in their alleged gas chambers, they would have killed themselves as well!

When asked about whom he consults when his gas chamber needs repair, he said, Fred Leuchter Engineering of Boston, Massachusetts.

Witness Number 21 was an aerial photo interpreter named Kenneth Wilson. He was asked to evaluate and comment on certain aerial photos of Auschwitz taken by the U.S. and South African Air Force reconnaissance planes during WW II.

These photos reveal a great deal of detail. What they don't show are the massive billowing smoke from crematorium chimneys or thousands of people being burned alive in burning pits by the crematoriums. There are no long lines of thousands of people lining up docilely to be "gassed".

The photos reveal in fact no unusual activity at these so-called "death camps", in spite of what the C.I.A. claimed in 1977 in some tendentious propaganda publication.

Ken Wilson explained to the jury exactly what he saw, and what was not there.

Fred Leuchter

Fred Leuchter, an American engineer from Boston was the next witness. He was witness #22, and had been commissioned by me to go behind the Iron Curtain, to visit and inspect the so-called extermination camps of Auschwitz I, Birkenau and Majdanek, to inspect all the camp facilities, but with a special eye on the alleged gas chamber installations in the camps.

Leuchter went as part of a 5 person team of engineer, draftsman, translator, video photographer and lookout.

They were to film, photograph, measure and virtually survey these gas chamber and crematorium installations there. They were to record all, to prepare exact engineering type drawings. They were furthermore to take rock and concrete samples from the walls, floors, ceiling and drains of these alleged Nazi killing centres, to have these samples flown to the U.S.A. to be analyzed by a neutral U.S. lab, which was not to be informed of where these samples came from and for what purposes the analyses was to be made!

Dr. Faurisson had found this expert through letters sent by one of my attorneys to various U.S. prisons and penitentiaries. Warden Armontrout had given us Fred Leuchter's name.

When Dr. Faurisson first visited Mr. Leuchter in Boston, we found out to our horror that he believed in the Hollywood version of the Holocaust. Dr. Faurisson called me back and asked: "What should we do?" Could we risk to work with such a man. Dr. Faurisson decided to leave some photos, maps and scientific as well as revisionist papers with Mr. Leuchter overnight.

The next day another meeting was to take place between the two men. Dr. Faurisson was not quite sure how we should proceed, and I suggested he should invite Mr. Leuchter to Toronto. Leuchter accepted and flew to meet us at our Toronto offices.

We spent a long and tiresome weekend looking at film footage and slides from Auschwitz taken by Ditlieb Felderer and Jürgen Neumann.

We looked at crematorium plans, camp maps, at books sold by the Auschwitz Museum. We looked at the scale models I had prepared which corresponded to German plans from 1943.

The engineer in him was by now very interested in an engineering problem. He said he would go, but the costs he mentioned, what with 5 flights to Poland, hotel rooms, car rentals, professional fees for himself and his draftsman, made the project financially just about impossible for me to undertake in the middle of an already very expensive trial.

Money, Money, Money

I called around to my friends for help. I begged, cajoled, stroked egos; in the end, there still was not enough money to undertake the mission. Mr. Leuchter had to go back to Boston. I just did not have the money to send him on this once in a lifetime mission.

7 I promised to call him back as soon as I could afford the trips. I spent every waking hour of the next few days, trying everything I could think of, even putting cameras to pawnbrokers, or borrowing money from banks.

These ideas soon showed themselves to be unrealizable, because with my name in the papers everyday and with headlines like "Anne Frank Diary a Hoax", "Zionists Started WW II", etc., there was no one to give me any credit.

Mission to the Scene of the Crime

In the end I decided to send Fred Leuchter and his team anyway! I was going to pay him in installments. His first bill came to almost \$17,000 and his second bill amounted to \$21,000; this together with flights, hotel and car rental bills, food, etc. I was staggering under the impact of these bills!

The mission to Poland went off without a hitch. The films were taken and so were the samples. The tests done on the samples in America produced just about the most astounding results. The delousing facility samples showed a high HCN (Zyklon B) content of 1050 mg. per Kg; the samples from all the alleged gas chambers showed either no trace of cyanide or extremely low levels below 10 mg., certainly not due to mass and frequent execution gassings! (See Graph)

In the end, Fred Leuchter prepared a hefty 192 page scientific report for me on his findings in Majdanek, Auschwitz and Birkenau. His conclusions were to be presented as expert witness testimony. We were going to use his photos and maps as well as his graphs and project them on a screen for the jury to see and evaluate.

On April the 20th, 1988, Fred Leuchter had a date with destiny. All night a team of chemists, typists, computer operators, and photocopy experts had worked like beavers to get the report done. By 9:00 a.m., 5 bound versions were ready. By 9:30 we left in our minibus to the courthouse. By 10:00 a.m., Doug Christie asked the judge to be heard in the absence of the jury. He introduced Fred Leuchter.

Panic befell the Crown and the Judge! The arguments wafted back and forth and we almost were shut out. Only after we mentioned that we had videotaped the entire procedure in Poland did the Judge suddenly change his tune. Leuchter was in!

His evidence was restricted, but at least some of it would go in, and the "Holocaust" was about to go up in "smoke".

We Make History!

For the next few hours, history was going to be made in courtroom 4-6 in the District Court in Toronto, as this American engineer, the only man still alive dealing with homicidal gas chambers and the only expert in the world, was to tell the court that in his best engineering opinion, not a single installation he had

inspected in Auschwitz, Birkenau or Majdanek was capable or would have been capable of killing massive numbers of humans in WW II or now!

That was a bombshell! The gas chamber myth had been exposed scientifically as an Allied propaganda fraud!

Panic Strikes Zionists

There was upset, panic and consternation in Jewish ranks in the spectator gallery! Leaders from the various Zionist organizations began arriving in droves. The cross-examination was short and messy! The judge refused to allow Mr. Leuchter to comment on results of the chemical analysis of the brick and mortar samples taken from the camps.

This put the defence one more time in a very difficult position. The sample test results were most important. The judge wanted the person who had done the actual analysis to testify; no one else would do!

Frantic emergency calls went to Boston during a court break in proceedings, and the owner of the lab agreed to allow his lab manager to testify for a price. He wanted \$200 U.S. an hour, from the time he left his house in Boston till he returned home. An exorbitant price even by today's standards of avarice!

The bill came to \$2,600 plus air fare, on top of the chemical analysis of \$35.00 U.S. per sample.

In the end, I bit into the bitter apple and Dr. James Roth, Ph.D. in analytical chemistry became our witness #23. He simply stated that he found either no traces or very small traces of cyanide in the rock, brick or mortar samples taken from the so-called gas chambers!

David Irving Man of the Hour!

I had been negotiating with the world-famous British historian David Irving to be a potential witness!

Now that I had the scientific Leuchter Report in my hands, I informed David Irving, who was holidaying in Florida, of its' startling revelations. He was at first stunned. I read him some of the details and then he said that he had suspected for some time that something might be terribly wrong with the standard version of the "Holocaust".

He agreed to come to Toronto and to testify on my behalf. I made the booklet Did Six Million Really Die? for which I was on trial, available to him to study it. He also got the 3rd copy of the Leuchter Report and he studied it avidly overnight after arriving in Toronto.

Next morning on April 22nd, 1988, David Irving became the defence's 24th witness. He had been mentioned before the court by the Crown Prosecutor as a historian who believed in the Holocaust. Now he strode onto the witness stand and stage of history and said that he had changed his mind.

To a silent and packed court, he declared that the Leuchter findings and testimony was an important historical event. He called it in fact a "shattering" report,

around which no future historian could get when writing about WW II history and the gas chamber allegation.

He revised the opinions he had firmly expressed in his 1977 Hitler biography Hitler's War in 13 major areas all relating to the Holocaust. He said he "believed"; today he no longer did! The Zundel Trial

World War II was plot by Zionists, witness says

World War II was a Zionist plot to make way for the foundation of the new state of Israel, a witness in defence of Ernst Zundel testified yesterday.

Joseph Burg, 80, who described himself as "anti-Zionist," said Zionists and Nazi leaders collaborated on Jewish migration from Europe to Palestine.

Leaders of "world Zionism" were "willing to sacrifice the whole of European Jewry for a Zionist country," Burg said.

"Everything had to be done to create a state of Israel and that was only possible by world war," Burg said. "Wall Street" and "Jewish large bankers" aided the war effort.

Zionists are also to blame for provoking growing hatred of Jews today, he said.

Burg, a Romanian of Jewish parentage who now lives in West Germany, said he spent the war in a concentration camp, although he said he had a pass to move freely.

He said there were "individual foreign ethnic groups" who attacked Jews, but there was no organized Nazi government attempt to exterminate Jews.

Zundel, 48, is charged with knowingly spreading false news in a pamphlet entitled Did Six Million Really Die? written by a member of Britain's National Front, a right-wing, white supremacist organization.

Burg said he was testifying on behalf of Zundel because Germans have been incorrectly blamed for murdering Jews.

"If there were another two or three Zundels it would be better for Jews as well," Burg told the jury.
